House Bill No. 5511, sponsored by Senator J. Jones, was taken up, read by title a first time and referred to the Committee on Rules.

At the hour of 3:15 o'clock p.m., pursuant to **Senate Joint Resolution No. 87**, the Chair announced the Senate stand adjourned until Wednesday, March 26, 2008, in perfunctory session.
