### **PRESENTATION OF RESOLUTIONS**

#### **SENATE RESOLUTION NO. 46**

Offered by Senators Holmes – Harmon - Wilhelmi and all Senators:  
 Mourns the death of Bolingbrook Police Officer Sava Basic, II, of Plainfield.

By unanimous consent, the foregoing resolution was referred to the Resolutions Consent Calendar.

Senator Brady offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### **SENATE RESOLUTION NO. 45**

WHEREAS, The Tenth Amendment to the Constitution of the United States specifically provides that, "The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people"; and

WHEREAS, The Tenth Amendment defines the total scope of federal power as being those powers specifically granted to it by the Constitution of the United States and nothing more; and

WHEREAS, Federalism is the constitutional division of powers between the national and state governments and is widely regarded as one of America's most valuable contributions to political science; and

WHEREAS, James Madison, the "father of the Constitution", said, "The powers delegated to the federal government are few and defined. Those which are to remain in the state governments are numerous and indefinite. The former will be exercised principally on external objects, [such] as war, peace, negotiation, and foreign commerce. ... The powers reserved to the several states will extend to all the objects which, in the ordinary course of affairs, concern the lives, liberties, and properties of the people"; and

WHEREAS, Thomas Jefferson emphasized that the states are not "subordinate" to the national government, but rather the two are "coordinate departments of one simple and integral whole. ... The one is the domestic, the other the foreign branch of the same government"; and

WHEREAS, Alexander Hamilton expressed his hope that "the people ... will always take care to preserve the constitutional equilibrium between the general and the state governments." He believed that "this balance between the national and state governments ... forms a double security to the people. If one [government] encroaches on their rights, they will find a powerful protection in the other. Indeed, they will both be prevented from overpassing their constitutional limits, by [the] certain rivalry, which will

ever subsist between them"; and

WHEREAS, The scope of power defined by the Tenth Amendment means that the federal government was created by the states specifically to be limited in its powers relative to those of the various states; and

WHEREAS, Today, the states are demonstrably treated as agents of the federal government; many federal mandates are directly in violation of the Tenth Amendment to the Constitution of the United States; and

WHEREAS, The United States Supreme Court has ruled in *New York v. United States*, 112 S. Ct. 2408 (1992), that Congress may not simply commandeer the legislative and regulatory processes of the states; and

WHEREAS, A number of proposals from previous administrations and some now being considered by the present administration and from Congress may further violate the Constitution of the United States; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we hereby claim sovereignty under the Tenth Amendment to the Constitution of the United States over all powers not otherwise enumerated and granted to the federal government by the Constitution of the United States; and be it further

RESOLVED, That this resolution serve as a notice and demand to the federal government to maintain the balance of powers established by the Constitution of the United States and to cease and desist, effective immediately, any and all mandates that are beyond the scope of its constitutionally delegated powers; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Honorable Barack Obama, President of the United States, the President of the United States Senate, the Speaker of the House of Representatives, the President pro tempore of the Senate, the Speaker of the House of Representatives of each state's legislature in the United States, and to each member of the Illinois congressional delegation.

Senator Pankau offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

#### **SENATE JOINT RESOLUTION NO. 15**

WHEREAS, The United States Supreme Court in *Olmstead v. L.C. Ex Rel. Zimring*, 119 S. Ct. 2176 (1999), held that under Title II of the Americans with Disabilities Act (ADA), States are required to provide community based treatment for persons with mental disabilities when the State's treatment professionals determine that such placement is appropriate, the affected persons do not oppose such treatment, and the placement can be reasonably accommodated, taking into account the resources available to the State and the needs of others with mental disabilities; and

WHEREAS, Title II of the ADA further states that a public entity shall administer services, programs, and activities in the most integrated setting appropriate to the needs of individuals with disabilities, defining that setting as one that enables individuals with disabilities to interact with non-disabled persons to the fullest extent possible; and

WHEREAS, Almost 10 years after the *Olmstead* decision, a report titled "The State of the States in Disabilities 2008" by the Department of Psychiatry and Coleman Institute for Cognitive Disabilities of the University of Colorado ranks the State of Illinois 40th nationally in fiscal effort for services for individuals with developmental disabilities, including all home based programs, group home, and congregate care; 43rd in State fiscal effort for community services; 47th in home and community-based waiver spending per capita; and 51st in serving persons with developmental disabilities in environments of 6 or less; and

WHEREAS, The State has not adequately invested funding for home and community-based services for individuals with developmental disabilities, and has cut funding for those services in the past 3 State fiscal year budgets; and

WHEREAS, Funding for home and community-based services does not currently meet the cost of providing those services and supports due to inflationary pressures, increased personnel costs, mandated increases in minimum wage, rising health insurance costs, and the increased cost of doing business with vendors; and

WHEREAS, Wages for community-based direct service professionals are generally at or barely above the poverty level for a single person supporting one or more children, leading to excessive turnover and undermining the availability of quality services; and

WHEREAS, "Person-centered" means that services and supports are identified and authorized to address the specific needs of each person as a result of an individualized assessment and through a person-centered planning process; and

WHEREAS, Illinois has a disproportionate number of Illinois citizens with developmental disabilities who are served in Intermediate Care Facilities for the Developmentally Disabled and State-Operated Developmental Centers (SODC); and

WHEREAS, Data shows that Illinois lags substantially behind nearly all other states in fostering the provision of services in the most integrated setting; the Illinois utilization rate for SODC services in 2009 was 18.0 individuals per 100,000 persons in the general population; the nationwide utilization rate in 2009 was 11.1 individuals per 100,000 in the general population; and

WHEREAS, The majority of other states have significantly reduced their utilization of large state-operated facilities; in order for Illinois to achieve parity with the national average by 2017, Illinois would need to serve an average of 8.9% fewer individuals in SODCs annually; and

WHEREAS, As long as the State continues to perpetuate short term measures to address crises in the system, in the long term, Illinois will perpetuate its inability to serve the growing number of individuals with developmental disabilities who are not currently receiving services; and

WHEREAS, The total budget for all services across all settings for persons with developmental disabilities falls far short of what is needed for a quality service system; and

WHEREAS, The Illinois Department of Human Services' Division of Developmental Disabilities (Division) developed and released its Strategic Plan for Fiscal Years 2011-2017 in July 2010 which aims to substantively reorient Division priorities and resources to support a truly person-centered system of services for which there is a popular mandate; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that in alignment with the Division's 7-year Strategic Plan, all children and adults with developmental disabilities living in Illinois will receive high quality services guided by a person-centered plan that maximizes individual choice and flexibility in the most integrated setting possible regardless of intensity or severity of need; and be it further

RESOLVED, That the Division's Strategic Plan will employ national utilization or funding rates as benchmarks to measure progress, and the Division will continue to monitor the Prioritization of Urgency of Need for Services (PUNS) waiting list to evaluate system-wide service needs; and be it further

RESOLVED, That Illinois will implement at least one new, outcome-based model for service delivery that improves the coordination and integration of habilitation, social, and clinical care for people with developmental disabilities; and be it further

RESOLVED, That the number of individuals living in the most integrated settings will achieve parity

with the national utilization rates so that more individuals will live in settings of 6 or less; fewer individuals will live in private intermediate care facilities for individuals with developmental disabilities; and fewer individuals will live in SODCs; and be it further

RESOLVED, That in order to ensure positive outcomes for all persons, Illinois will work to achieve parity with the average national rate of funding for developmental disability services in order to achieve the goals set forth by the Division's 7-year Strategic Plan; and be it further

RESOLVED, That more individuals with developmental disabilities will receive integrated employment services to achieve parity with the national utilization rates; and be it further

RESOLVED, That the number of people receiving Medicaid-funded Home and Community Based Services (HCBS) will achieve parity with national utilization rates; and be it further

RESOLVED, That the disparity between wages paid to State of Illinois employees and community-based direct service professionals will be reduced; and be it further

RESOLVED, That Illinois will seek to provide funding for an annual cost-of-living increase for community-based direct service employees in order to ensure that these workers receive a fair wage that allows them to support their families; and be it further

RESOLVED, That the Division will develop a comprehensive, integrated data management system that captures, aggregates, and analyzes data from various sources, allowing timely analysis of service processes and outcomes; and be it further

RESOLVED, That persons with developmental disabilities are linked to the services that best meet their needs and to promote that linkage there must be an effective service coordination system that is available to all regardless of geographic or network boundaries and available to support individuals, families, and guardians; and be it further

RESOLVED, That persons with developmental disabilities will be actively involved in policy discussions and will be respected as partners in the process, making informed choices and decisions in order to support productive and fulfilling lives; and be it further

RESOLVED, That the input from families and guardians will be respected and taken into consideration in conjunction with the wishes of the individual; and be it further

RESOLVED, That the State of Illinois recognizes that home and community providers are a vital part of healthy communities and are counted on by individuals and families and the State to support their goals and therefore should be listened to and respected; and be it further

RESOLVED, That the allocation of resources to support people with developmental disabilities will accurately reflect service demand and be a priority at all levels of government and for the citizens of Illinois and that funding for developmental disabilities services will be realigned to reflect the strategic priorities and benchmarks identified in the Division's 7-year Strategic Plan; and be it further

RESOLVED, That future budgets shall take into consideration the steps necessary to achieve the plans laid out in this joint resolution; and be it further

RESOLVED, That copies of this Resolution be sent to the Governor, the Secretary of the Department of Human Services, the Director of the Governor's Office of Management and Budget, and all members of the General Assembly.

RESOLVED, BY THE SENATE OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 2 of Article VIII of the Illinois Constitution as follows:

ARTICLE VIII  
FINANCE

SECTION 2. STATE FINANCE

(a) The Governor shall prepare and submit to the General Assembly, at a time prescribed by law, a State budget for the ensuing fiscal ~~biennium year~~. The budget shall set forth the estimated balance of funds available for appropriation at the beginning of the fiscal ~~biennium year~~, the estimated receipts, and a plan for expenditures and obligations during the fiscal ~~biennium year~~ of every department, authority, public corporation and quasi-public corporation of the State, every State college and university, and every other public agency created by the State, but not of units of local government or school districts. The budget shall also set forth the indebtedness and contingent liabilities of the State and such other information as may be required by law. Proposed expenditures shall not exceed funds estimated to be available for the fiscal ~~biennium year~~ as shown in the budget.

(b) The General Assembly by law shall make appropriations for all expenditures of public funds by the State. Appropriations for a fiscal ~~biennium year~~ shall not exceed funds estimated by the General Assembly to be available during that ~~biennium year~~.

(c) The fiscal biennium shall commence on July 1 of each odd-numbered year and end on June 30 of the ensuing odd-numbered year.

RESOLVED, BY THE SENATE OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 8.1 to Article IV of the Illinois Constitution as follows:

ARTICLE IV  
THE LEGISLATURE

SECTION 8.1. PASSAGE OF REVENUE BILLS

A bill that would result in the increase of revenue to the State by an increase of a tax on or measured by income or by an increase of a tax on or measured by the selling price of any item of tangible personal property may become law only with the concurrence of two-thirds of the members elected to each house of the General Assembly.

RESOLVED, BY THE SENATE OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article V of the Illinois Constitution by changing Sections 1, 3, 7, and 18 and by repealing Section 17 as follows:

ARTICLE V  
THE EXECUTIVE

## SECTION 1. OFFICERS

The Executive Branch shall include a Governor, Lieutenant Governor, Attorney General, Secretary of State, and ~~Comptroller of the Treasury Comptroller and Treasurer~~ elected by the electors of the State. They shall keep the public records and maintain a residence at the seat of government during their terms of office.

## SECTION 3. ELIGIBILITY

To be eligible to hold the office of Governor, Lieutenant Governor, Attorney General, Secretary of State, or ~~Comptroller of the Treasury Comptroller or Treasurer~~, a person must be a United States citizen, at least 25 years old, and a resident of this State for the three years preceding his or her election.

## SECTION 7. VACANCIES IN OTHER ELECTIVE OFFICES

If the Attorney General, Secretary of State, or ~~Comptroller of the Treasury Comptroller or Treasurer~~ fails to qualify or if ~~the his~~ office becomes vacant, the Governor shall fill the office by appointment. The appointee shall hold office until the elected officer qualifies or until a successor is elected and qualified as may be provided by law and shall not be subject to removal by the Governor. If the Lieutenant Governor fails to qualify or if ~~the his~~ office becomes vacant, it shall remain vacant until the end of the term.

~~The Comptroller, in accordance with law, shall maintain the State's central fiscal accounts, and order payments into and out of the funds held by the Treasurer.~~

SECTION 18. ~~COMPTROLLER OF THE TREASURY~~ ~~TREASURER~~ - DUTIES

The ~~Comptroller of the Treasury Treasurer~~, in accordance with law, shall (i) ~~maintain the State's central fiscal accounts, and order payments into and out of the funds held by him or her,~~ (ii) be responsible for the safekeeping and investment of monies and securities deposited with him or her, and for their disbursement upon his or her order, and (iii) have the duties and powers that may be prescribed by law of the ~~Comptroller~~.

BILL OF RIGHTS

On or before May 31, 2014, the General Assembly by law shall enact a plan for universal health care coverage that permits everyone in Illinois to obtain decent health care on a regular basis.

WHEREAS, Ronald Reagan then traveled to Hollywood to embark on a career in motion pictures, eventually starring in more than 60 films; and

WHEREAS, Ronald Reagan left acting to serve in the Second World War, eventually rising to the rank of Captain in the United States Army Air Force; and

WHEREAS, Ronald Reagan put his acting skills to use in the armed forces, helping make more than 400 training films to assist AAF pilots; and

WHEREAS, Upon returning to Hollywood, Ronald Reagan joined the Screen Actors Guild union, eventually serving six terms as president of the organization; and

WHEREAS, Ronald Reagan's role as George Gipp in the movie "Knut Rockne: All American" led to his nickname "The Gipper", which he was called for the rest of his life; and

WHEREAS, On the set of the movie "Hellcats of the Navy", Ronald Reagan met the woman who would end up being the love of his life, Nancy Davis; and

WHEREAS, Ronald Reagan was the proud father of four children - Maureen, Ron, Jr., Patti, and Michael; and

WHEREAS, Ronald Reagan served as a spokesman for General Electric; he later served as a host for the popular TV show General Electric Theater; and

WHEREAS, Ronald Reagan went on to be elected to serve as the two-time governor of California, serving from 1967 to 1975; and

WHEREAS, Ronald Reagan was elected President of the United States in 1980 - the first native-born Illinois person to reach the highest office in the land; and

WHEREAS, President Reagan's optimism and belief that the United States' best days were yet to come helped rejuvenate the American spirit; and

WHEREAS, President Reagan never mistook his political opponents for enemies, and worked with his Democratic Congress on behalf of the American people; and

WHEREAS, President Reagan's grace under pressure during his assassination attempt, with quips such as "Honey, I forgot to duck", helped console the American people during that very dark hour; and

WHEREAS, President Reagan's strong support for our national defense and his popularity among our nation's fighting men and women led to the naming of the aircraft carrier USS Ronald Reagan in his honor; and

WHEREAS, During President Reagan's presidency, the United States was respected throughout the world, and foreign relations improved with Europe, India, China, and other nations; and

WHEREAS, During the Reagan presidency, America saw years of unprecedented economic growth and prosperity; and

WHEREAS, President Reagan never forgot his Illinois roots - frequently coming back to our State to visit his boyhood home of Dixon, Eureka College, and other communities; and

WHEREAS, As president, Ronald Reagan was graced with the nickname "The Great Communicator" for his ability to convey his vision to the American people; and

WHEREAS, President Reagan's popularity among the American people led to his winning 49 states in his reelection and capturing more electoral votes than any other presidential candidate in history; and

WHEREAS, Working with national leaders and our democratic allies, President Reagan played a crucial part in ending communism in Eastern Europe and the Soviet Union; and

WHEREAS, When the reformist leader Mikhail Gorbachev took power in the Soviet Union, President Reagan worked with him to diffuse Cold War tensions; and

WHEREAS, President Reagan worked with General Secretary Gorbachev to reduce nuclear arms by concluding an agreement on the INF Treaty, which, for the first time ever, reduced the number of nuclear weapons; and

WHEREAS, President Reagan gave a famous speech in 1987 calling on Mr. Gorbachev to tear down the Berlin Wall, which did fall a little more than two years later; and

WHEREAS, By the end of the Reagan presidency, Cold War tensions between the Soviet Union and United States had dramatically decreased; and

WHEREAS, President Reagan's speech comforting the nation following the explosion of the Space Shuttle Challenger helped console a grieving nation; and

WHEREAS, President Reagan's leadership inspired many young Americans to enter public service; and

WHEREAS, President Reagan's courageous fight against Alzheimer's disease led to greater public awareness of that terrible illness; and

WHEREAS, Hundreds of landmarks, roads, and buildings have been named as a tribute to President Reagan across America, including Washington DC's Reagan Airport and Ronald Reagan Building, and Illinois' Ronald Reagan Memorial Highway; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we salute President Ronald Reagan on the 100th anniversary of his birth, thank him for the service to our country as a member of our armed forces, as a public servant, and as President, and honor him for helping to revive the American spirit.
