Senator Hutchinson offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 855

WHEREAS, The future of our nation's productivity and competitiveness in the global marketplace depends on the success of all men and women; and

WHEREAS, Women have been discriminated against in education, the workplace, and society as a whole; and

WHEREAS, Women continue to earn no more than 78 cents on the dollar compared to men; and

WHEREAS, The pay gap has been shown to start as soon as one year after college; this inequality affects not only women, but their families and society as a whole; and

WHEREAS, The pay gap between women and men has long-term effects on women's economic security; such a gap affects women's Social Security earnings, their ability to save for retirement, and their children's education; and

WHEREAS, Pay equity is closely linked to the eradication of poverty and is essential to having a highly-motivated workforce; and

WHEREAS, Equal Pay Day was originated by the National Committee on Pay Equity in 1996 as a public awareness event to illustrate the gap between men's and women's wages; the day, observed in April, symbolizes how far into the year a woman must work, on average, to earn as much as a man earned the previous year, with Tuesday being the day in which women's wages catch up to men's wages from the

previous week; because women earn less on average than men, they must work longer for the same amount of pay; this wage gap is even greater for most women of color; and

WHEREAS, Equal pay is a priority for all women and for our society at large; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate April 9, 2014 as Pay Equity Day in the State of Illinois in order to raise awareness about this endemic inequity.

Senator Mulroe offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 856

WHEREAS, Certain communities on the Northwest side of the City of Chicago (including Edison Park, Norwood Park, Jefferson Park, Gladstone Park, and Big Oaks) and surrounding suburbs (including Park Ridge, Des Plaines, Harwood Heights, Norridge, Rosemont, Niles, and Schiller Park) lay underneath the key nighttime air routes that converge over the community; this includes 5 glide paths, 2 major take-off plates, and many air routes, all of which are used after 9 p.m.; and

WHEREAS, These communities of the City of Chicago and surrounding suburbs seek a solution to the nighttime sleep interruptions that occur during the hours of 9 p.m. and 7 a.m., including the shoulder hours as well; and

WHEREAS, The Nextgen Program is currently being applied at O'Hare International Airport, where flights that used to be 5 miles apart will soon have only a 3-mile separation, times 6 east-to-west approach patterns for all inbound flights; and

WHEREAS, These communities of the City of Chicago and surrounding suburbs are experiencing higher levels of jet noise, especially during the phase 1 nighttime flight operations; and

WHEREAS, The Chicago Department of Aviation and the O'Hare Noise Compatibility Commission are tasked with implementing the Residential Sound Insulation Program, a federally-funded program to sound-insulate qualifying residential homes and schools; and

WHEREAS, H.R. 3650 (Silent Skies Act), a bill recently introduced in the United States House of Representatives, would further limit the impact of the O'Hare Modernization Plan on the affected communities by amending Title 49 of the United States Code to prohibit the operation of certain aircraft not complying with the Stage 4 Aircraft Noise Standard, an internationally-recognized certification aimed at reducing aircraft noise; and

WHEREAS, The ongoing modernization of Chicago-O'Hare International Airport, its impact on nearby residents, and the anticipated growth in airport usage all indicate the need to enact more stringent regulations and review long existing standards for the measurement, reduction, and abatement of airport noise; and

WHEREAS, The current fly quiet program needs to be re-evaluated for the purposes of instilling and sharing the primary purpose of flight and community partnership at O'Hare International Airport with all of the collar communities; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Federal Aeronautics Administration and O'Hare International Airport authorities to decrease jet noise over the communities of Northwest Chicago and surrounding suburban areas; and be it further

RESOLVED, That we urge O'Hare International Airport authorities to consider the option of spreading flights around the various runways of O'Hare International Airport in order to equally distribute the burden

of air traffic around the airport and to put more resources towards the re-testing of noise levels around the airport and the sound proofing of affected homes and schools; and be it further

RESOLVED, That we urge Congress to pass H.R. 3650 in order to combat this growing problem; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Commissioner of O'Hare International Airport, the Acting Administrator of the Federal Aeronautics Administration, and to each member of the Illinois congressional delegation.

SENATE JOINT RESOLUTION NO. 47

WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to individuals who gave their lives in service to their communities; and

WHEREAS, Brian T. Hauk was a dedicated volunteer for 15 years for the Logan Trivoli Fire Protection District; the district encompasses 87 square miles in Peoria County and, at one time, State Route 116 was the heaviest traveled 2 lane highway in the State; and

WHEREAS, Brian T. Hauk had only been Assistant Chief for 6 months when he gave his life in the line of duty on December 23, 1997 while responding to a fire call; and

WHEREAS, Brian T. Hauk was honored at the Firefighters State Memorial in Springfield in May of 1998 and, in October of 1998, at the National Fallen Firefighters Memorial in Emmitsburg, Maryland; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we designate Illinois State Route 116 as it passes through Peoria County from 10300 West Farmington Road in Hanna City to 22290 West Farmington Road in Elmwood as the Assistant Fire Chief Brian T. Hauk Memorial Highway; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name; and be it further

RESOLVED, That suitable copies of this resolution be presented to the family of Assistant Fire Chief Brian T. Hauk and the Secretary of the Department of Transportation, Ann L. Schneider.

Senator Sullivan offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 48

WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to individuals who gave their lives in service to the State; and

WHEREAS, Warren County Sheriff's Deputy George V. Darnell was killed in the line of duty on December 7, 1981 on US Route 67 north of Monmouth; and

WHEREAS, George Darnell was born on December 16, 1920 in Hull to Delbert Walter and Esther (nee Smith) Darnell; he attended school in Adams County and married Eva E. Stormer on January 21, 1942 in

Quincy; he served for 7 years with the Warren County Sheriff's Auxiliary and became a Warren County deputy sheriff in 1971; and

WHEREAS, George Darnell was a member of the Immaculate Conception Church, the Veterans of Foreign Wars Post #2301, and was a veteran of World War II; he enjoyed hunting and outdoor life; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we designate US Route 67 in Warren County, starting 7 miles north of Monmouth, ending 8 miles north of Monmouth, as the "Deputy George V. Darnell Memorial Highway"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name; and be it further

RESOLVED, That suitable copies of this resolution be presented to the family of Deputy George V. Darnell, the Warren County Sheriff's Department, and the Secretary of the Illinois Department of Transportation.

SENATE JOINT RESOLUTION NO. 49

WHEREAS, The State of Illinois needs effective and quality education for all people; and

WHEREAS, The Illinois Public Agenda for College and Career Success is the pathway to an Illinois where all residents have affordable access to high-quality educational opportunities that prepare Illinoisans for the jobs of the present and the future; and

WHEREAS, The Illinois Public Agenda for College and Career Success has documented the critical role higher education plays in economic recovery and growth, particularly in ensuring that this State has an educated workforce to meet the needs of business and industry; and

WHEREAS, By 2020, 67% of Illinois jobs will require a career certificate or college degree; and

WHEREAS, Forty-three percent of Illinois adults currently have an associate degree or higher; and

WHEREAS, By 2018, the United States economy will have jobs for 22 million people with college degrees, but a shortage of nearly 8 million people with degrees; and

WHEREAS, The pipeline of young college graduates will not be enough to meet workforce skills demands; and

WHEREAS, The State of Illinois and its higher education institutions have a responsibility for student success, including improved student retention, program completion, and graduation; and

WHEREAS, One in five United States adults has some college credits but no degree; and

WHEREAS, The Illinois Public Agenda for College and Career Success has recommended that the Board of Higher Education, in consultation with other higher education agencies, "develop a strategy to provide incentives to complete degrees, focusing on compacts between working adults and employers and on individuals with substantial college credit but no degree"; and

WHEREAS, Prior Learning Assessment is a strategy that should be considered as one way to support students' degree completion that addresses time-to-degree and college affordability barriers hindering working adults; and

WHEREAS, Prior Learning Assessment is the process by which an individual's experiential and other extra-institutional learning is assessed and evaluated for the purposes of granting college credit, certification, or advanced standing toward further education or training; and

WHEREAS, Many institutions offering Prior Learning Assessments recognize the importance of ensuring that quality standards are in place for the assessment of a student's learning that will result to the award of college credit; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that the Higher Education Prior Learning Assessment Task Force is created under the direction of the Board of Higher Education; and be it further

RESOLVED, That the Task Force shall be comprised of the following 14 members; one senator appointed by the President of the Senate; one senator appointed by the Minority Leader of the Senate; one representative appointed by the Speaker of the House of Representatives; one representative appointed by the Minority Leader of the House of Representatives; and 10 members appointed by the Board of Higher Education to represent a cross-section of the higher education community and experts in experiential learning and national collegiate testing; and be it further

RESOLVED, That the Board of Higher Education shall provide administrative support to the Task Force; and be it further

RESOLVED, That the members selected by the Board of Higher Education shall serve without compensation; and be it further

RESOLVED, That the Task Force's study shall include, but not be limited to, the following:

- (1) examining the history of Prior Learning Assessment and its impact on the adult and non-traditional learner in today's educational landscape;
- (2) examining policies and practices in other states;
- (3) determining existing Prior Learning Assessment methods being utilized among Illinois' public colleges and universities;
- (4) reviewing the quality standards necessary to adequately assess a student's learning, based upon experience, non-academic training, education, etc. that leads toward the award of college credit;
- (5) considering alternative methods to award college credit;
- (6) considering transferability of credit and student mobility;
- (7) the industry recognition of credentials earned through non-traditional means of demonstrating competency;
- (8) the importance of college and university recognition of credentials awarded by industry; and
- (9) the acceptance of Prior Learning Assessment-based credits, credentials, or degrees by licensing bodies; and be it further

RESOLVED, That the Task Force shall report its findings and recommendations to the Board of Higher Education, the Illinois Community College Board, the Illinois Student Assistance Commission, the Illinois State Board of Education, the Illinois Department of Veterans Affairs, the General Assembly, and the Governor on or before December 1, 2016; and be it further

RESOLVED, That the Task Force shall be dissolved after the submission of the report to the General Assembly and the Governor; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Governor and the chairpersons of the Board of Higher Education, the Illinois Community College Board, the Illinois Student Assistance Commission, and the Illinois State Board of Education.
