Senator Sandoval offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 993

WHEREAS, English Learners (ELs) constituted nearly 10% of all students in pre-kindergarten through grade 12 statewide in Fiscal Year 2013; and

WHEREAS, The number of ELs has grown by 33% since 2005, with an average annual growth of 4.7%; and

WHEREAS, Three hundred and ten school districts were receiving State funding to support bilingual education services for more than 200,000 students in Fiscal Year 2012; and

WHEREAS, The number of school districts that enrolled at least one English Learner student in their classroom has grown more than 50% from 2007 to 2014; and

WHEREAS, The number of counties with school districts serving at least one English Learner student in their classroom has increased from 63 in 2005 to 85 in 2012, a 21% increase; and

WHEREAS, The funding for English Learner education has been reduced by 6.9% from 2010 to 2013, but the English Learner population has grown by 7% in the same period of time; and

WHEREAS, The decline in State resources has limited school districts' ability to provide meaningful professional development opportunities for their teachers, administrators, and principals; and

WHEREAS, The reduction in funding has restricted the ability of school districts to offer supplemental language instruction before or after school; and

WHEREAS, The achievement gap between the English Learner student population and their peers is evident in reading and mathematics on the Illinois Standards Achievement Test (ISAT) from third to eighth grade; and

WHEREAS, This State recently raised the proficiency level that ELs must attain in order to transition to a general education curriculum; and

WHEREAS, Improving teaching and learning of English Learner students is fundamental to our goal of closing achievement gaps; and

WHEREAS, Data from the State Board of Education shows that children who have attained English proficiency after benefitting from State-funded bilingual education services go on to outperform non-English Learner students in reading and mathematics on the ISAT in grades 6 through 8; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the General Assembly to fully fund the State Board of Education's request for bilingual education at \$75,652,000 to support bilingual students in this State.

Senator Sandoval offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 994

WHEREAS, Advanced Placement (AP) exams measure a student's content mastery of college-level studies in specific academic disciplines; and

WHEREAS, A total of 43,835 graduates took at least one AP exam during high school in 2013, more than double the 20,968 students who took the test in 2003; and

WHEREAS, Low-income students comprised 29.3% of graduates who took AP exams in 2013, compared to only 19% in 2008 and 12.1% in 2003; and

WHEREAS, The number of low-income graduates scoring a 3 or higher nearly tripled in the last 5 years, from 1,969 or 9.7% in 2008 to 5,758 or 19.8% in 2013; and

WHEREAS, This State was able to remove the equity gap for Latino participation in AP exams in 2013; and

WHEREAS, There has been tremendous improvement in AP exam success over the past decade for traditionally underrepresented groups in this State, but there remain significant gaps in student access and success; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the General Assembly to accelerate these improved outcomes for low-income, Latino, and African-American students by increasing this State's commitment to student access and success on Advanced Placement exams.

Senator Sandoval offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 995

WHEREAS, Almost one in 10 U.S. counties has a population that consists of more than 50% minorities; and

WHEREAS, Only 6% of the national public school teaching force is Hispanic; and

WHEREAS, Only 7% of the national public school teaching force is African-American; and

WHEREAS, The communities in this State where children live and learn are growing increasingly diverse; and

WHEREAS, In 2012, 49% of this State's 2,000,000 public school students were racially and ethnically diverse, while 16.7% of this State's teachers were similarly diverse; and

WHEREAS, Providing targeted experiences and support to middle and high school educators is essential in the recruitment and retention of a diverse teaching corps; and

WHEREAS, The Diversified Educator Recruitment Program will help support increasing the number of teacher candidates from diverse populations; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the General Assembly to fund the Diversified Educator Recruitment Program to provide resources, support, and experiences to support the recruitment and retention of racially diverse teacher candidates.
