SENATE RESOLUTION NO. 88

WHEREAS, The Illinois Department of Human Services maintains a state-wide database known as PUNS, or Prioritization for Urgency of Needs for Services, that records information about individuals with developmental disabilities who are potentially in need of services; and

WHEREAS, The Department of Human Services uses the data on Prioritization for Urgency of Needs for Services to select individuals for services as funding becomes available, to develop proposals and materials for budgeting, and to plan for future needs; and

WHEREAS, Prioritization for Urgency of Needs for Services exists in order to provide assistance with service needs; and

WHEREAS, Besides adults, Prioritization for Urgency of Needs for Services is also available for children and teens with developmental disabilities who need services or support; and

WHEREAS, Prioritization for Urgency of Needs for Services is the first step toward getting services in Illinois; if individuals are not on the Prioritization for Urgency of Needs for Services list, they are not in queue for State services; and

WHEREAS, Prioritization for Urgency of Needs for Services may be under-utilized by children and their parents due to unawareness or a lack of information; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we strongly encourage the Illinois State Board of Education to work with school districts to inform all students with developmental disabilities and especially their parents that the Prioritization for Urgency of Needs for Services database is a resource that can assist them in obtaining services for their needs; and be it further

RESOLVED, That we further encourage local school districts to direct parents and students to the Illinois Department of Human Services' Prioritization for Urgency of Needs for Services website for information annually during the Individualized Education Plan process.

Senators McCarter and LaHood offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 89

WHEREAS, The members of the Illinois Senate recognize that the State Board of Education's decision to implement the Common Core State Standards was not authorized by the General Assembly; and

WHEREAS, In 2010, Illinois became one of 45 states to opt into the Common Core State Standards Initiative by accepting federal funds from the American Recovery and Reinvestment Act of 2009 and through the Race to the Top initiative of the federal government; and

WHEREAS, Over the next few years, the Common Core State Standards, which are largely untested in the United States, will substantively change the educational standards for students in Illinois, thus affecting every teacher and student in the State; and

WHEREAS, There are many unknown and significant costs associated with the Common Core State Standards and the Partnership for Assessment of Readiness for College and Careers; and

WHEREAS, The only substantive cost analysis of the implementation of the Common Core State Standards was conducted by the Pioneer Institute, a non-partisan, privately funded research organization, which estimates the financial impact for Illinois to be close to \$773 million over 7 years; and

WHEREAS, There are many school districts who lack the technology, infrastructure, and funding to create an environment for the online-standards testing required by the Partnership for Assessment of Readiness for College and Careers or the new textbooks that will be needed to teach to the Common Core State Standards; and

WHEREAS, The State Board of Education has not secured funding for schools that will need curricular, technological, and infrastructure upgrades; and

WHEREAS, The most recent data shows that over 60% of school districts are operating with a deficit, the prospect of a pension cost-shift, and other expensive unfunded mandates by the State; and

WHEREAS, It is inconceivable to require districts to incur costs to upgrade schools in their respective districts because the State Board of Education unilaterally made the decision to move to the Common Core State Standards, without counsel from school districts, without a strong statewide informational campaign about the Common Core State Standards, and without performing a cost analysis for school districts and the State; and

WHEREAS, Indiana, Oklahoma, and South Carolina have opted out of the Common Core State Standards and more than a dozen states are considering legislation to repeal involvement in Common Core; 7 Governors have also issued executive orders to reexamine, change, or delay implementation or use of Common Core; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the State Superintendent of Education and the State Board of Education to opt out of the Common Core State Standards until a Board-authorized and conducted study shows the costs associated with the Common Core State Standards and the Partnership for Assessment of Readiness for College and Careers; and be it further

RESOLVED, That the State Board of Education and General Assembly create a viable plan to provide funding to school districts that need improvements and modernizations to comply with the new Common Core State Standards and the Partnership for Assessment of Readiness for College and Careers; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the State Superintendent of Education and the State Board of Education.

SENATE RESOLUTION NO. 90

WHEREAS, Youth ages 13 to 24 accounted for an estimated 26% of all new HIV infections in the United States in 2010; this is particularly concerning as they only consist of 17% of the country's population; and

WHEREAS, Almost 60% of youth infected with HIV in the United States are unaware that they are infected; and

WHEREAS, HIV-positive youth need support for medication adherence and self-care; without these skills, the health and the lives of HIV-positive youth are in jeopardy, especially due to the difficulty of staying on a medication regimen; and

WHEREAS, HIV-positive youth need secondary prevention services to prevent the spread of the virus to others; this may include education, partner communication skills, and disclosure; and

WHEREAS, HIV-negative youth who are at risk need primary prevention services to protect themselves from HIV infection; and

WHEREAS, Many youth fear the stigma of HIV, and have experienced discrimination and isolation from friends, family, or professionals (such as doctors and teachers) if their status is known or even suspected, and they are in great need of supportive services; and

WHEREAS, The State of Illinois is responsible for the safety and wellbeing of the children who are taken into the Illinois Department of Children and Family Services (DCFS); and

WHEREAS, There are no statutes or administrative rules for DCFS to address the issue of supportive services for HIV-positive youth and young adults; and

WHEREAS, DCFS lacks a proactive program of HIV prevention information, education, and services for its wards; and

WHEREAS, DCFS should provide education for department staff, foster and adoptive parents, and private agency staff concerning HIV prevention for at-risk youth and services to those who are HIV-positive; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we call upon the Department of Children and Family Services and the Department of Public Health to collaborate and devise policy recommendations regarding HIV supportive services and prevention education for HIV positive and at-risk youth at the Department of Children and Family Services; and be it further

RESOLVED, That at least 2 representatives from these 2 departments shall work together on a report of policy recommendations, and they shall call upon the expertise developed by community-based HIV service providers, researchers, and educators as they see fit; and be it further
