HOUSE JOINT RESOLUTION NO. 2

WHEREAS, The members of the Illinois General Assembly wish to pay honor to those who dedicate their lives to the protection of the people of this State; and

WHEREAS, James Sauter served with pride as an Illinois State Trooper since July 29, 2008; he had just completed a temporary assignment in the State Police Air Operations and was recently assigned to District 15, which covers the tollways; as a cadet, he was awarded the Lifesaving Medal in October of 2008 for his actions in saving the life of a woman in a motorcycle accident; and

WHEREAS, On March 28, 2013, Trooper James Sauter was on duty in his Illinois State Police squad car when his vehicle was struck by a truck tractor semi-trailer on Interstate 294 southbound at Willow Road; and

WHEREAS, Trooper James Sauter's great bravery and sense of duty is worthy of the highest respect; it would be fitting for the members of the General Assembly to honor his life and his great sacrifice by naming the Willow Road overpass on Interstate 294 after him; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate the Willow Road overpass on Interstate 294 as the Trooper James Sauter Memorial Overpass; and be it further

RESOLVED, That the Illinois State Toll Highway Authority is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name of the Trooper James Sauter Memorial Overpass; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Board of Directors of the Illinois State Toll Highway Authority and the family of James Sauter.

WHEREAS, Throughout the years, the relocation of Route 30 has brought tremendous growth to the areas that border it; and

WHEREAS, Route 30 continues to be improved to handle the increasing traffic coming through the area and is still bringing in new development; and

WHEREAS, Mayor Paul Egan's vision continues to benefit the area's citizens to this day; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we recognize the late Mayor Paul Egan on his efforts to relocate and improve Route 30 in Aurora; and be it further
