Senator McCann offered the following Senate Resolution, which was referred to the Committee on Assignments:

**SENATE RESOLUTION NO. 1523**

WHEREAS, "In God We Trust" is the official motto of the United States of America; and

WHEREAS, The phrase appears to have originated in "The Star-Spangled Banner", written during the War of 1812; during the American Civil War, the 125th Pennsylvania Infantry for the Union Army assumed the motto as a battle cry on September 17, 1862 during the Battle of Antietam; the motto first appeared on U.S. coins in 1864; and

WHEREAS, In 1956, the United States and the Soviet Union were in the midst of the Cold War and the U.S. wished to distinguish itself from the Soviet Union, who promoted state atheism; the 84th Congress passed a joint resolution declaring "In God We Trust" as the national motto of the country, which was signed into law by President Eisenhower on July 30, 1956; and

WHEREAS, Following the September 11, 2011 terrorist attacks, many public schools across the United States posted "In God We Trust" framed posters in their libraries, cafeterias, and classrooms; and

WHEREAS, In 2006, on the 50th anniversary of its adoption, the United States Senate reaffirmed "In God We Trust" as the official national motto of the country; in 2011, the U.S. House of Representatives passed a similar resolution; and

WHEREAS, The phrase has been incorporated into many hymns and religious and patriotic songs, and continues to be used in countless areas of American life; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we reaffirm that the national motto of the United States of America is, and should continue to be, "In God We Trust" and we encourage its use by the citizens of the State of Illinois.

Senator Hunter offered the following Senate Resolution, which was referred to the Committee on Assignments:

**SENATE RESOLUTION NO. 1524**

[February 16, 2016]

WHEREAS, Grand juries have always had the responsibility of investigating, indicting, and prosecuting persons who violate the criminal laws of the State of Illinois; and

WHEREAS, In light of recent events around the country, members of the public have lost confidence in the criminal justice system and the grand jury process; and

WHEREAS, The General Assembly finds that the grand jury process utilized in this State should be reviewed to ensure the impartiality and effectiveness of the process; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Grand Jury Review Task Force is created to review the current grand jury process and suggest reforms to the General Assembly; and be it further

RESOLVED, That the Task Force shall consist of the following members:

(1) One member appointed by the President of the Senate, who shall serve as co-chairperson;

(2) One member appointed by the Senate Minority Leader, who shall serve as co-chairperson;

(3) The Director of the Illinois Criminal Justice Information Authority, or his or her designee;

(4) The Director of the Illinois Office of the State's Attorney Appellate Prosecutor, or his or her designee;

(5) The State Appellate Defender, or his or her designee;

(6) The Executive Director of the Illinois State Bar Association, or his or her designee;

(7) The President of the Chicago Bar Association, or his or her designee;

(8) The President of the American Civil Liberties Union of Illinois, or his or her designee;

(9) One law professor, appointed by the President of the Senate;

(10) One retired judge, appointed by the President of the Senate;

(11) One member representing the Chicago Innocence Project, appointed by the President of the Senate;

(12) Two members representing advocacy groups involved in criminal justice, one of which is to be appointed by the President of the Senate and one to be appointed by the Senate Minority Leader;

(13) Two members of the public, one of which is to be appointed by the President of the Senate and one to be appointed by the Senate Minority Leader; and

(14) The President of the Illinois Press Association, or his or her designee; and be it further

RESOLVED, That the Task Force shall meet regularly and hold public hearings at the call of the co-chairpersons to receive testimony regarding the grand jury process and any suggested reforms; and be it further

RESOLVED, That the Illinois Criminal Justice Information Authority shall provide administrative support and technical assistance, as well as meeting space, to the Task Force; and be it further

RESOLVED, That the Grand Jury Review Task Force shall submit a report of its findings and recommendations to the General Assembly and the Governor on or before December 31, 2016; the report shall, at a minimum, include:

(1) A summary of the current grand jury process;

(2) Any and all deficiencies discovered within the current grand jury process;

(3) Recommendations to improve the grand jury process;

(4) A recommendation advising whether grand jury proceedings shall remain closed to the public;

(5) A recommendation advising whether certain portions of grand jury proceedings should be subject to the Freedom of Information Act; and

(6) A recommendation regarding whether an expanded use of preliminary hearings would advance the same goals as the grand jury process; and be it further

RESOLVED, That the Task Force shall also work with the Legislative Reference Bureau to draft any legislation needed to implement its recommendations.

Senator Noland offered the following Senate Resolution, which was referred to the Committee on Assignments:

**SENATE RESOLUTION NO. 1525**

WHEREAS, The economic competitiveness of the United States and Illinois in the global economy requires a well-educated workforce; and

WHEREAS, Students in Illinois currently average \$28,984 in student debt upon graduation, which significantly hinders their ability to participate in the local economy; and

WHEREAS, Current and future young people in the United States and across Illinois should have the same opportunity offered to those who went to college in previous generations, including the ability to attend State colleges and universities without taking on burdensome debt; and

WHEREAS, In 2015, higher education is more important than ever because it is an essential step to entering and remaining in the middle class; and

WHEREAS, Because of the importance of higher education, the United States and state governments should expand the opportunity to pursue and attain higher education to more people than had that opportunity in the past; and

WHEREAS, Public investment in higher education pays off, as evidenced by the fact the G.I. Bill resulted in a 7-to-1 return on investment for our national economy; workers with college degrees also earn more money, pay more taxes, and rely less on government services; and

WHEREAS, Student loan debt saddles the very students who most depend on a college degree to level the economic playing field with a burden that constrains career choices and hurts the credit rating of students, prevents people from fully participating in the economy by purchasing goods and services, and threatens essential milestones of the American dream, including the purchase of a home or car, starting a family, and saving for retirement; and

WHEREAS, The Schatz-Schumer-Warren United States Senate debt-free college resolution and the Grijalva-Ellison-Clark United States House of Representatives debt-free college resolution have gained national momentum in recent months and has become central in the national dialogue around higher education; and

WHEREAS, A national goal of debt-free college would include significant federal aid to states, including Illinois; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress to enact legislation that ensures that all students have access to debt-free higher education, defined to mean having no debt upon graduation from any public institutions of higher education; increases support to states so that those states can increase investments in higher education and bring down costs for students; increases aid to students to help them cover the total cost of college attendance without taking on debt; encourages innovation by states and institutions of higher education to increase efficiency, lower costs, and enable speedy and less-costly degree completion; and reduces the burden of existing student loan debt.
