#### **SENATE RESOLUTION NO. 1532**

WHEREAS, The future of our nation's productivity and competitiveness in the global marketplace depends on the success of all men and women; and

WHEREAS, Women have been discriminated against in education, the workplace, and society as a whole; and

WHEREAS, Women continue to earn no more than 78 cents on the dollar compared to men; and

WHEREAS, The pay gap has been shown to start as soon as one year after college; this inequality affects not only women, but their families and society as a whole; and

WHEREAS, The pay gap between women and men has long-term effects on women's economic security; such a gap affects women's Social Security earnings, their ability to save for retirement, and their children's education; and

WHEREAS, Pay equity is closely linked to the eradication of poverty and is essential to having a highly-motivated workforce; and

WHEREAS, Equal Pay Day was originated by the National Committee on Pay Equity in 1996 as a public awareness event to illustrate the gap between men's and women's wages; the day, observed in April, symbolizes how far into the year a woman must work, on average, to earn as much as a man earned the previous year, with Tuesday being the day in which women's wages catch up to men's wages from the previous week; because women earn less on average than men, they must work longer for the same amount of pay; this wage gap is even greater for most women of color; and

WHEREAS, Equal pay is a priority for all women and for our society at large; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate April 12, 2016 as Pay Equity Day in the State of Illinois in order to raise awareness about this endemic inequity.

WHEREAS, Social workers daily embody this year's Social Work Month theme, "Forging Solutions Out of Challenges", by helping individuals, communities, and the larger society tackle and solve issues that confront them: and

WHEREAS, Social workers have helped this nation live up to its ideals by successfully pushing for equal rights for all, including women, African Americans, Latinos, people who are LGBTQ, and various ethnic, cultural, and religious groups; and

WHEREAS, Social workers have helped people in this nation overcome racial strife and economic and health care uncertainty by successfully advocating for initiatives such as Medicaid, unemployment insurance, workplace safety, Social Security benefits, the Civil Rights Act, the Voting Rights Act, and the Affordable Care Act; and

WHEREAS, Social workers are the largest group of mental health care providers in the United States and daily work to help people overcome depression, anxiety, substance abuse, and other disorders so they can lead more fulfilling lives; and

WHEREAS, The U.S. Department of Veterans Affairs employs more than 12,000 professional social workers; social workers help bolster our nation's security by providing support to active duty military personnel, veterans, and their families; and

WHEREAS, Thousands of child, family and school social workers across the country provide assistance to protect children and improve the social and psychological functioning of children and their families; and

WHEREAS, Social workers help children find loving homes and create new families through adoption; and

WHEREAS, Social workers in schools work with families and schools to foster future generations by ensuring students reach their full academic and personal potential; and

WHEREAS, Social workers work with older adults and their families to improve their quality of life and ability to live independently as long as possible and get access to quality mental health and health care; and

WHEREAS, Social workers have helped the United States and other nations overcome earthquakes, floods, wars, and other disasters by helping survivors get services such as food, shelter, health care, and mental health care to address stress and anxiety; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the month of March of 2016 as Social Work Month in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the National Association of Social Workers-Illinois Chapter with our sincere appreciation for their efforts.

#### SENATE JOINT RESOLUTION NO. 44

WHEREAS, Health care is a growing industry, and creating changes in the system to ensure quality care while efficiently managing the cost of the health care system is more important than ever; the use of a 24-Hour nurse hotline has been established in other states and seen positive results; it is necessary to establish a task force to research the benefits and costs of creating a 24-hour nurse hotline for all citizens of the State; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there is created the 24-Hour Nurse Hotline Task Force to study and make recommendations for the creation, operation, and usage of a 24-hour nurse hotline in the State of Illinois; and be it further

RESOLVED, The Task Force shall consist of 11 members appointed as follows:

- (1) four members, one of whom shall be appointed by each of the 4 legislative leaders;
- (2) a member of the Department of Healthcare and Family Services, nominated by the Director of Healthcare and Family Services;
- (3) a member of the Department of Public Health, nominated by the Director of Public Health;
- (4) a member of the Department of Commerce and Economic Opportunity, nominated by the Director of Commerce and Economic Opportunity;
  - (5) a representative from a statewide managed care association;
  - (6) a member of a statewide nursing association;
  - (7) a member of a statewide hospital association; and
  - (8) a member of a statewide medical association; and be it further

RESOLVED, The task force shall organize within 120 days following the appointment of a majority of its members; the members from the Department of Healthcare and Family Services and the Department of Public Health shall co-chair the Task Force and serve as liaisons to the Governor and the General Assembly; meetings of the Task Force shall be held as necessary to complete the duties of the Task Force; meetings of the Task Force shall be held in the central part of the State; and be it further

RESOLVED, That the members of the Task Force shall receive no compensation for serving as members of the Task Force; and be it further

RESOLVED, That the Task Force shall submit a report with recommendations to the Governor and General Assembly no later than December 31, 2016; and be it further

RESOLVED, That the Department of Healthcare and Family Services and the Department of Public Health shall provide administrative support to the Task Force.

WHEREAS, Cholesterol is essential to the human body's functioning; however, high LDL-C (bad cholesterol) can lead to heart disease; and

WHEREAS, There are no warning signs of high cholesterol, and the only way to find out one's total blood cholesterol is through a lipoprotein profile blood test; and

WHEREAS, Hyperlipidemia occurs when there are too many lipids in the blood, therefore causing high cholesterol and high triglycerides; and

WHEREAS, The American Heart Association recommends consulting a doctor to understand one's condition and then determining a treatment that may include healthy diet choices and exercise along with medication, depending on one's overall risk; and

WHEREAS, Cholesterol Counts is an awareness program that aims to have individuals take an active role in understanding that there is more to be done to control high cholesterol and encourages the conversation between patients and their healthcare providers; and

WHEREAS, Encouraging Illinois residents to participate in Cholesterol Counts can help monitor the overall cholesterol statistics for Illinois and provide awareness for treatment; and

WHEREAS, The Illinois Department of Public Health already encourages residents to get their blood cholesterol checked during September, which is designated as National Cholesterol Education Month; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we recognize the importance of encouraging Illinois residents to understand their cholesterol testing results and coordinate treatment with their healthcare provider; and be it further

RESOLVED, That we urge the Illinois Department of Public Health to post a link providing access to www.cholesterolcounts.com on its website under the Resources section on its Cholesterol page; and be it further

RESOLVED, That we urge the Illinois Department of Public Health to designate September 1, 2016 as Hyperlipidemia Awareness Day in the State of Illinois; and be it further
