WHEREAS, The Witzcak brothers were separated up by branch, job, and location throughout World War II but kept in close contact through letters; they had numerous opportunities to meet up when their missions allowed; Anthony Witzcak recalls this happening mostly at Pearl Harbor; and

WHEREAS, The story of the Witzcak brothers is an astonishing and humbling one of commitment to their country and their family; most families that had multiple members overseas bravely serving their country did not have them all return safely to the United States as all of the Witzcak brothers did; therefore, be it
