We also made sure, in the Floor amendments -- there were some information left out as it applies to penalties - thank you - and -- and also the -- the language -- the providing of the price list, we also came to that, I apologize. So that's what's in the two amendments. Those are the agreements that we had with the Illinois Retail Merchants

Senator Bush, is there a story behind this legislation? Did something happen that required this to be changed that you might want to share with the Body?

Thanks so much for that question. So, last year, we passed a law that repealed the tax on sanitary napkins, tampons, et cetera. In doing that bill, there were other studies out there, and -- and certainly personal experience, that shows that there are areas in the service industry where women are paying more for the same services as men. And rather than make the ultimate assumption that there is discriminatory practices, what we'd really like to do is ask those businesses to have their price lists available on those top ten items. So that, for instance - I think most women in here know - if I go to the dry cleaners and get my jacket dry-cleaned, I'm probably going to get charged between seven and ten dollars for that. If a man goes to a dry cleaner and gets a jacket cleaned, he's going to pay - and these numbers aren't

exact - but he's going to pay substantially less for that, maybe fifty percent less. Another great example is if you get a shirt cleaned. A man's shirt - and literally the only difference in a man's shirt is that their buttons are on the other side - in many cases, he's going to pay a dollar or two dollars. A woman's shirt is going to cost between three and six dollars. So if there are reasons that, you know, these services are costing them more, fine - you know, then certainly. We just want to make sure that buyers have that information, know what the pricing is, and we're making sure that we have gender equity.

Is there any further discussion? Seeing none, the question -- Senator Oberweis, for what purpose do you rise?

SENATOR OBERWEIS:

Yeah, question of the sponsor, please.

And if that's true, wouldn't the company try to take advantage of that by pricing lower products or reducing that margin to take advantage of the free market?

I'll -- I'll do my best to answer that. I'm not sure if I understood the second half of the question. Certainly, there may be reasons for some of them. Sometimes they talk about, in particular, with women's jackets that the cleaning apparatus that they use to clean them is a little bit different, because in some women's jackets there are items called darts, because we have these things on the front of us that men don't. So the jackets are a little bit different. So -- so my understanding is, with -- some of the dry cleaners have said through the years that they don't have a dummy, basically, to put a woman's jacket on. My argument would kind of be, it's not the 1950s anymore, we wear jackets too, get the right apparati {sic}. But I don't want to make the assumption, so that's why we didn't say in a bill that the prices have to be the same. We said you should have them available to customers. I should know when I go in. You post your prices for your ice cream, I'm sure, on all the flavors. I want the flavors posted. I believe that when we go in and we get our hair done or we get a -- a service that we have a right to know right up front what they're charging us for it, and if those prices are different, we have a right to ask why. So if they have a genuine reason for doing it, that's fine. You know, this is really just helping to inform and making sure that pricing is not gender biased.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Are you seeking to be recognized? Your light isn't lit, Senator Oberweis.

SENATOR OBERWEIS:

Yes, I just wanted to follow up. I'm -- I'm not objecting to companies posting prices. That sounds like a -- a reasonably good idea to me. I'm -- I'm -- I'm literally trying to understand if

there's an economic opportunity. If I understand what you're saying - I'll just make up numbers - you're saying that a drycleaning company might charge two dollars for a man's shirt and four dollars for a woman's shirt. I'm trying to understand why a creative entrepreneur wouldn't come in and start doing women's shirts for three dollars and thereby make -- take advantage of the market and -- and build a new business as a result of that.

I believe if I wanted to do that, they'd call it mandating. But I understand what you're saying, Senator. And I think that's what we are trying to do here. We're not trying to tell businesses they can't charge a different price. We're saying to businesses, but if you do, you need to post the prices.

So I believe, as a free market guy myself, I can be in support of this bill.

It tries to address two specific issues, one dealing with the practice of multiple people using one address to receive and then sell fraudulent State driver's licenses or ID cards.
