This is a very significant issue in areas where there's a high concentration of State employees, such as Springfield and Champaign-Urbana. What this bill does after amendments - and we've worked on this a lot; I appreciate the work of those on the committee - simply would allow a vendor assistance program to be created. the Central Management Services under the newest amendment. Currently, while other vendors can have their debt essentially bought out by vendor assistance programs, dentists cannot because of the -- the third party nature of those relationships. This allows a change in that and hopefully will keep more Illinois dentists in business while we work out the budget. I'd ask for an Aye vote.
