to increase rents, fees, and other charges upon tenants if the park owner has failed to correct a health or life safety violation, as defined in rules adopted by the Department of Health or the authority having jurisdiction, until the violations are cured as set forth in the inspection. Is there any discussion? Senator Righter, for what purpose do you rise?

SENATOR RIGHTER:

Will the sponsor yield, please, Mr. President?

### SENATOR RIGHTER:

Senator Bush, if -- if there is a situation whereby a landlord who has been cited for a violation and is working to correct that violation has an agreement with the tenant that I'm going to finish this and I'll have this remediated in, let's say, ninety or a hundred and eighty days, I'm going to raise your rent, and the tenant agrees to that, would they -- would they -- would that be an exception to this, or are they still prohibited from having that agreement with the tenant?

#### SENATOR BUSH:

So, I'm -- I'm -- I'm not sure if this answers your question, but this -- the municipalities are -- are -- this doesn't supersede their authorities.

Okay, as I -- maybe I'm misreading the bill, Senator Bush. As I understand the bill, we are going to, by State law, say that if a landlord has been cited for any kind of public health/public safety violation at all, regardless of the magnitude, until they correct that and the government is satisfied that they've correct that, they can't raise rent, they can't do anything that a landlord would otherwise do. Do I have the bill correct?

PRESIDING OFFICER: (SENATOR LINK)

#### SENATOR BUSH:

I would -- I would say that you do, yes.

PRESIDING OFFICER: (SENATOR LINK)

So, let's say that there has been a citation of some kind of public health code, let's say a relatively minor one, there's an understanding between the landlord and the tenant that that's going to be remediated within, let's say, thirty days and in exchange for which, or regardless of, the tenant and the landlord agree that the rent's going to go up ten dollars a month. This would prohibit that agreement. Is that correct?

#### SENATOR BUSH:

So, certainly, I am not an attorney, but I believe that's correct.

Senator, a different issue: You added an amendment that exempts the City of Chicago. Now, I don't live in the City of Chicago, but I would assume that there are a number of tenants in the City of Chicago who - I assume you would agree - are just as entitled to the kind of protection that you're putting forth in Senate Bill 569 as those in -- everywhere else in the State. Why are the City of Chicago's tenants not being protected by this? PRESIDING OFFICER: (SENATOR LINK)

So, that's a great question. I -- I appreciate it, Senator Righter. So, actually, there is only one mobile home facility -- manufactured home park in the City of Chicago and the City of Chicago believes that their -- their ordinances actually provide more -- are -- are stronger than what we are doing in this.

Senator, if -- if that's the case, then what if the City of Mattoon or the City of Charleston or the City of Champaign came to you and said, you know what, we've only got one or two mobile home parks and we don't think that they're a problem and our ordinances fit fine, would you exempt them from -- from the bill as well? PRESIDING OFFICER: (SENATOR LINK)

Senator Bush.

### SENATOR BUSH:

Well, they certainly didn't come to me. That's number one. So I can't answer without knowing the particulars. They didn't come to us and say they were opposed to the bill. And I guess secondly, what this is really about, even if there's a thirty-day time that someone is -- you know, has an agreement with a tenant that they are correcting the problem, this is really about our -- people that run these facilities don't address the issues, you know, and there's just no recourse for the people that live there, Senator. And I think most of us that have, we'll call them mobile home parks, you can call them manufactured home facility -- areas, think most of us know that. So there's a problem we're trying to fix. And this bill will continue to be worked on once it goes over to the House. I think there's certainly more work that can

The simple fact is, the tenants in that park in the City of Chicago -- if we're going to do this, if we are going from -- go to -- from Springfield say, you can't do these things unless you cure these deficiencies, if we're going to do that from Springfield and not give the municipalities the chance to deal with these issues and protect these tenants on their own, I'm not sure why we're giving the City of Chicago a pass. This is not unusual, for anyone who's been in this Chamber longer than six weeks, for the City of Chicago to come and say, you know what, we really don't need to be part of the regulatory structure that you folks decide needs to be put in place for the rest of the thirteen million inhabitants in the State. Maybe we should send a message to the City, and help Senator Bush out here, by voting this down and she can say, hey, you know what, I can't pass this bill without putting the City in it. She can strip that amendment off, Mr. President, and then we

That's a good question. And this came to us when we met with and talked to some of the interstate truck stops when they raised the issue of, currently, the interstate truck stops are limited to just five machines, and when you have a -- a hundred truckers that are there for hours at a time, it became a problem, where there are literally lines for people to use it, and these truckers aren't allowed to leave that facility, so they had to stay there. when it -- that's when the idea came to us and said these are outof-state truckers, they can't leave and go to other locations, and so why not capture those dollars. So this would go from five to up to ten, if they wanted to, at those interstate -- or at those truck stops. And they would have to meet the criteria that we set in the bill for what a truck stop is. So it's not for gas stations; it's going to be the truck stops that are near the interstates. They have to have gallonage requirements. There's also acreage requirements that are with that as well.

#### SENATOR McCARTER:

Okay. I'll ask you again. How many -- how many terminals will this increase? How -- if this is narrowly crafted, we should know where they're going to be and how many will -- added. So, how many total do we expect to be added?

We've talked to a number of the, again, the interstate truck stops, who have said they would like to have this. But, again, we don't know what that number's going to be until it's done. #### SENATOR McCARTER:

So, after all that, or the way -- I guess the way I interpret this is, at least five hundred terminals will be added. And -- and I understand this is a issue that whether you support or you don't support an expansion of gambling. I understand that. However, let me just make one comment in regards to this. You know, we're in a -- in the situation we're in, trying to balance this budget, I personally believe this is a comment on our State that we can't implement fiscal discipline to balance our budget and then we go to look towards increased revenues like this because of our situation. I think it's wrong and I urge a No vote.

### PRESIDING OFFICER: (SENATOR LINK)

Is there any further discussion? Seeing none, Senator Syverson, to close.

#### SENATOR SYVERSON:

Thank you very much. To the previous speaker's question: This is a unique way to generate revenue from out-of-state truckers that are passing through our State, that have to stay at those truck stops, and they're there and it's a chance for us to raise revenue. This is not revenue that's going to fix the State's budget; this is revenue that's going to the Capital Fund. This is revenue that's going to help build things in Illinois, so it goes to the Capital Fund, and as well as it helps those local governments increase their share at a time when local governments are struggling. So, this is a way to raise revenue, paid for by out-of-staters, not in-staters. It's revenue that would not be going to other gaming operations. These are people that cannot go

to casinos, they cannot go to bars or clubs because they have to stay at those interstate truck stops. So it's just a unique, narrowly crafted way to generate and bring out-of-state money into Illinois. And I would ask for a favorable roll call. And, again, thank you for your indulgence.
