Senate Bill 639 expands the -- offense of drug-induced homicide to include delivery of a controlled substance under the laws of another jurisdiction if the resulting death occurs in Illinois. Senate Bill 639 is also known as Evans Rushing's Law {sic} (Evan Rushing Law). This is on behalf of Senator Haine. There was an incident that the -- the drugs were delivered in Missouri, but the person died in Illinois, and in Illinois we could not prosecute because we didn't have
