But besides serving us, Ryan Albin also had, apparently, two children under the age of six. So let that be a stark reminder to all of us, the level of commitment, the level of integrity, and the level of dedication that anyone who wears the uniform has for our country, for our State, and for each of us. So, if I may, ask for a moment of silence in his honor, in his children's honor. And while we're at it, his K-9, Officer Biko, is at the veterinarian, still being treated for injuries. So maybe put in a good word for Biko's recovery as -- while we're at it. Thank you.
