Came on the job when he was twenty-one years old. I never had the pleasure of working with him, but I know so many that I've talked to in the past couple of days, they said he was truly a policeman's man, how he was outgoing, caring. As I stated, he did go up from just a PO and then up to the rank of Commander. So I would ask for a moment of silence. Thank you, Mr. President.
