This declares that Penicillium chrysogenum NRRL 1951 as the official State microbe. And you might ask, why is Illinois wanting to do an official State microbe? Well, penicillin, as we know, was -- and I -- and I teased you with this when we were going to committee -- this is pretty important, folks, really. When we

were going to committee, I held up a petri dish that had the original fungus that was discovered by Alexander Fleming in England. And I hope that I get the petri dish out here that has the original cantaloupe fungus that penicillin was actually produced by; it was produced in Peoria, Illinois. difference that it made is that -- the statistic is that in World War I, eighteen percent of the casualties in World War I were because of gangrene. By World War II, that statistic was that less than one percent of the casualties were from gangrene and it was due to this penicillin. This -- this is the actual petri dish of the original cantaloupe fungus that was -- that was able to produce mass quantities, commercial quantities of penicillin. And I think most people in Peoria understand this, but I don't think most people in Illinois understand that Peoria was the place that it was discovered. And so it's very important that we recognize this as a -- an important historical fact in part of our history in Illinois here. So I would ask for support that we declare Penicillium as the official State microbe and the only place that that can be done is Illinois and it's because of Peoria. So I'm happy to answer any questions. This is probably more than you want...(microphone cutoff)...

If individual states can start -- obviously this takes away -- this gives states the right to start regulating certain IE -- the IEPA can regulate certain rules that will have an impact on our power plants, on our energy generation. Is this really a thoughtful way to do it, state by state by state, or is this something we should leave at the federal level?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Ellman.

SENATOR ELLMAN:

This -- thank you. Thank you, Senator Plummer. I can't speak for the -- the national, but this bill is basically -- you can consider it a gag rule for Illinois. This prevents us as a State from -- proposing or doing anything as far as greenhouse gases. It doesn't have -- it doesn't change the way that we have to comply with federal law at all.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Plummer.

SENATOR PLUMMER:

Right, but what -- what it would do is it would allow us to set new standards that could potentially be unattainable by industry. Correct?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Ellman.

SENATOR ELLMAN:

Now, that's a great question. Thank you. That would be something that we could argue as a Body, but with the Kyoto Protocol Act as enacted, we can't even have that discussion.

SENATOR PLUMMER:

Well, I think there's some very good reasoning behind the fact that they don't want states going state by state by state to create this. I mean, right now, in the State of Illinois, approximately forty percent of our energy is produced by fossil fuel sources that are very plentiful in the State of Illinois. And those fossil fuel -- we -- we need baseload energy in the State of Illinois. I'm -- I'm all for the renewables; I think we need to explore everything we can. My concern, though, is, is the IEPA comes in and we set standards that are not obtainable by industry, that are financially burdensome on the people of Illinois, and we have to have baseload power and this takes away -- this creates the right -- it takes away the power from the federal government and it gives power to State government to start setting thresholds that are not obtainable. And I have serious concerns about unelected bureaucrats in the State of Illinois implementing rules that are going to impact something as important as our power supply.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Ellman.

SENATOR ELLMAN:

Thank you very much. This -- this is a -- a State bill that -- a State Act that prevents us from even having that conversation. So we've -- this is a bill that waits for the U.S. Congress to enact the Kyoto Protocol Act, which was from 1997. It was for the period of 2008 to 2012. All this says is that we can stop waiting for the U.S. Congress to enact Kyoto Protocol.

And -- and I don't think that's something we want an unelected State agency to do here in Illinois. What if every state in the country did that?

SENATOR ELLMAN:

It reinserts provisions of the bill as amended by Senate Committee Amendment No. 1 with the following changes. Am I reading the right thing? Yes, I am. Okay. Thank you. As amended, requires taxpayers of income-producing property to submit income and expense data annually to the chief county assessment officer. Though this

requirement applies only to Cook County, other counties, by resolution, may require the same filings. Under Senate Bill 1379, the assessment officer may consider this data to determine the value of these properties. If a taxpayer fails to provide this data, they can incur a penalty. Additionally, the chief county assessment officer may disclose this data, but only in a compiled and anonymized format, providing it does not disclose individual property characteristics. Any person that reveals any information received by the chief county assessment officer in any other form not authorized by law shall be deemed quilty of a Class B misdemeanor and subject to a fine not to exceed seventy-five hundred dollars. This was done specifically to make sure that the data that is collected is actually as anonymous as possible so that we can protect confidential data and get more accurate and transparent assessments at the county level. Happy to answer any questions.

PRESIDING OFFICER: (SENATOR KOEHLER)

Is there any discussion? Senator Rezin, for what purpose do you seek recognition?

SENATOR REZIN:

Thank you, Mr. President. To the bill, please.

PRESIDING OFFICER: (SENATOR KOEHLER)

To the bill.

SENATOR REZIN:

While I do commend my colleague and the sponsor of the bill, there's still many unanswered questions in this bill, so I ask my colleagues to look at the opponents that are lined up for this bill. No other state makes handing over expense data mandatory. I know that -- that the Senator had asked for a negotiation to

It doesn't do that. In fact, it specifically exempts FOIA from the data that'll be collected. Any data the office releases will be summarized and anonymized and not shown at a property level. Further, none of this data will be used to conduct property-specific assessments. It'll be used to develop true market rates by property class and geography. Finally, the assessor's office employees under this statute are held responsible for proper handling of this data, similar to the Illinois Department of Revenue's provisions for its employees'

handling of sensitive information. An employee can actually face a Class B misdemeanor and a fine of up to seventy-five hundred dollars for mishandling this data.

I understand that the Civic Federation put out a letter that made some errors in their analysis. Is that right?

It's fair to say I didn't agree with some of the analysis in the Civic Federation's letter, absolutely. The assessor's required to compile and anonymize data before disclosure and the bill has strong confidentiality provisions, including making it a criminal misdemeanor. The Civic Federation's letter also stated that making this voluntary is a viable alternative, but that isn't the case either. Show -- studies show that actually ten to twenty percent will comply, which is not enough to make use of the data.

The -- the bill is actually supported by Brookfield Properties Retail Group, which owns Water Tower Place and nearly millions of square feet of retail space across the country. They testified in support of this in the Revenue Committee and they operate properties all across the country. We're, in essence, asking for the same information that most people would be giving when they go to appeal anyway. This is to make sure that the -- the information we have at the front end is as -- is as accurate and as reflective of the market as we can possibly get to add transparency and efficiency into our assessment process, which we know has been sorely lacking for decades. So with -- I would -- I would ask for everyone's support. Thank you for that.

So we know that this is not only happening in Illinois, it happens in multiple states across the country, and we also know that in -- even in those states, like, take New York, which does assessments on every single property, every single year, as opposed to three-year turn-

arounds, which is what we do here, which means people who live in my neck of the woods who have had poorly assessed and underassessed and in some places drastically overassessed commercial property won't have another chance to try to fix the anomalies in the system for another three years, till 2023. I recognize that there were some opponents that had some issues and wanted further clarification, and that's exactly why, due to the timing on the Calendar, we need to get this to the House, so that we can continue working on this. This is one of those moments where we have a bill that requires work, where people have put in hours and hours of work to do it. We have to get it through two Chambers and we're committed to making sure that whatever it is that they come up with in terms of further clarification in the House, I will -- more than happy comply with once it comes back here to the Senate. So I ask for your favorable support, for not only my district, but for communities all across the State who will now have an option to opt in to a program for more accuracy in the one thing that drives every single one of us nuts - property taxes.
