That's all we're asking - slow down and pull over. Three fatalities in three months, you can't even say it's too much - one fatality is too much. People just need to slow down and pull over. And we're just asking that the Secretary of State include this reasonable information as a test question so that Illinois motorists -- so that Illinois motorists have top-of-mind awareness when they're approaching an emergency scene. With that in mind, this bipartisan resolution calls for the State to retain and build on an important precedent that was set in Illinois last capital plan, ten years ago, which established the Early Childhood Construction Grant Program. The program was overseen by the Capital Development Board and dedicated forty-five million dollars to brick-and-mortar early learning projects in communities with the most underserved populations of children under the age of five. Qualified applicants included both school-based and not-for-profit community-based service providers. Not surprisingly, the program was overwhelmingly overwhelmed with requests for help, totaling more than a dozen times the amount of funding available. So the resources disappeared quickly. However, the initiative did allow a lot of good work to be done, building new classrooms, renovating old ones, and providing more young children with a better start in learning in life. Early childhood needs have not diminished in Illinois, neither should our resolve to help meet them. Let's ensure we reflect these important educational needs in our next Illinois capital plan and aim to do more, preferably at a level of at least two hundred and fifty million dollars.
