Thank you, Mr. President. Senate Bill 423 amends the Unified Code of Corrections and makes a number of changes to the law related to mandatory supervised release. It represents agreement by -- between several criminal justice reform groups and law enforcement. It does a number of things, as I mentioned. I'll -- I'll highlight just a couple of them. It expands education and training credits for individuals and mandatory supervised release. This is something we want to encourage people -- people to get job training, to get educational credits, to move them on, move them out of mandatory -- mandatory supervised release and to becoming productive citizens. It establishes quarter -- quarterly reporting requirements to help with transparency. I'll explain a little bit more about that in a second. It changes the drug testing provisions in a way that aligns them with what is now the common practice. It allows for virtual reporting for MSR participants. It also removes some outdated language related to Juvenile Justice provisions, which have now been assumed by the Department of Juvenile Justice. One thing I do want to note, we found out yesterday in committee that AFSCME has some questions about the quarterly supervising reporting elements of this bill. They wanted a chance to take a look at those things and maybe adjust them by a few days. We do not have language back from them on an amendment, in that regard yet. But given the late time and dates, we want to move this bill over to the House and we're certainly willing to accept any sort of reasonable amendment from AFSCME in the House. Otherwise, I know of no opposition and I ask for the Chamber's support. Would certainly try to answer any questions you might have.

Thank you, Mr. President. House Bill 3162 amends the Police and Fire Annuity and Benefit Fund of Chicago Acts. It seeks to close what I think is a loophole in current State law that denies Chicago police officers, firefighters and paramedics the same sort of COVID protections that we extend to all other first responders and other frontline workers in the State. You may have recalled back during the height of the pandemic, the workers compensation agreed bill process was put into place and we came up with a solution to a problem we were all facing during the COVID lockdowns because we know so many of our essential workers had to go to work and in turn expose themselves to the coronavirus. We had to come up with a way to deal with that. And the way we did is we set up

what was called a rebuttable presumption in the law that assumed if you got sick, if you contracted COVID, you did so at work unless the employer could prove otherwise. This, as I said, was extended to all essential workers in the State. The one problem, the loophole, I mentioned, is Chicago firefighters, paramedics and police officers are not covered by the Illinois workers compensation law, so they did -- were not afforded these protections. This has had some pretty dramatic negative results for a number of Chicago firefighters and police officers. You may be aware that our State Comptroller, Susana Mendoza, has been at the forefront of championing for this legislation, and that's her brother, a Chicago police detective sergeant, contracted COVID while he was on the job before vaccinations were available after he worked 17 straight days, he got very sick. He was hospitalized for weeks. He lost his function of his kidneys and has suffered a whole host of maladies due to long term COVID. He -- because he's now part of the State's workers comp system, he had to apply to the Chicago Police Pension and Annuity Fund to receive benefits, and his full duty disability benefits were denied by that body. As a result of that, he is only going to get about 50 percent of his pay for I believe it's a five-year period and will lose his health insurance. This is an injustice that we have to correct. This bill will help correct that injustice by requiring the Police Pension and Annuity Board to afford him the same benefits that all other State workers are afforded who contracted coronavirus while they were on the job. And it's not just Sergeant Mendoza. There are a few dozen other police officers, firefighters, and paramedics in Chicago, who are in the same position. I ask you to help me correct this injustice by voting Yes for House Bill

3162. I'd be happy to answer any questions.

And this is a -- this is very important legislation that we move forward to protection of our families. So, I just wanted to stand and say that it's an honor to be a chief co-sponsor on this legislation and to work with the Comptroller, as well, to protect our families as they so deserve. House Bill 50 -- 1557 requires for profit music venues that have an occupancy of 1000 or more to have opioid antagonists such as Narcan on hand, to have -- and to have staff members who are sufficiently trained at administering it. Senator Plummer, on House Bill 1740.

SENATOR PLUMMER:

Mr. President, we'd like to hold this, we're still negotiating on this bill.

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Please take that bill out of the record. With leave of the Body, we're going to move down to House Bill 2040, Senator Johnson, on House Bill 2040. We'll now move to Senate Bill 2041, Senator Villanueva. I'm sorry. Take that bill out of the Order. Instead, we will move down to near the bottom of page 11 of the printed Calendar, where Senator Glowiak Hilton brings Senate Bill 2079. Senator Glowiak Hilton, on House Bill 2079. With leave of the Body, we're going to move to page 12 of your printed Calendar near the middle of the page where Senator Simmons brings House Bill 2131. Senator Simmons, on House Bill 2131. He indicates that he wishes to proceed. Mr. -- Mr. Secretary, please read that bill.

House Bill 2131, an Act concerning transportation. 3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Simmons, on House Bill 2131.

SENATOR SIMMONS:

Thank you very much, Mr. President. Ladies and Gentlemen of the Senate, HB 2131 creates the Zero Traffic Fatalities Task Force. This legislation provides that the Secretary of Transportation shall establish and convene the Task Force on or before July 1st of 2024 and submit a report to the General Assembly on or before January 1st, 2025. And that report will need to include the detailed analysis of existing practices around speed limits, reduction of speed limits, steps to eliminate vehicular pedestrian and bicycle fatalities on roads, and the impact of local bicycle and pedestrian plans. This legislation was brought forward by my new State Representative, Hoan Huynh, and is directly responsive to the outcry that we've seen in our district and in districts around the State, because there have been a number of bicycling fatalities that have been reported on by the press in recent months and recent years. So, I think this is -- this is absolutely a step in the right direction. It's really important. It'll help IDOT to inform a lot of their planning around bicycle infrastructure. And also, this is in -- in honor of Lily Shambrook, who is a constituent of mine, who was a two-year-old toddler who was killed, unfortunately in uptown last summer -- mom was biking and was hit by a truck. And then Ralph Cardenas and Lincoln Square, who was a three-year-old who was hit on a side street by another vehicle. I know of no opposition and would urge an Aye vote. Thank you.

House Bill 2145, an Act concerning State government. 3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Harris.

SENATOR HARRIS:

Thank you, Mr. President and Members of the Senate. HB 2145 directs the Illinois Department of Financial and Professional Regulation to refuse to issue or renew or suspend the professional licenses of any individual corporation or partnership or business entity, which has been found by the Workers Compensation Commission or the Department of Insurance to not have obtained workers compensation insurance coverage, filed an application for approval of a self-insured or posted bond or other security guarantee of payment as to workers comp benefits. There is no opposition and I ask for a favorable vote.

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Is there any discussion? Seeing none, the question is, shall House Bill 2145 pass. All those in favor vote, Aye. Opposed, Nay.

House Bill 2220, an Act concerning civil law. 3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Johnson, on House Bill 2220.

SENATOR JOHNSON:

Thank you, Mr. President. As you know, with pandemic and even before the pandemic, sometimes employees who work in hospitality are sometimes mistreated and sometimes abused, in a way. And so, with House Bill {sic} 220 (2220), this amends the Innkeeper Protection Act. It provides that a proprietor or manager of a hotel shall not reject a guest while they're in a hotel located -- well, this -- this is for individuals who -- there. But the bill makes sure that the manager or the proprietor are able to remove people from the hotel who are abusive to the employees. But we amended it to make sure that it was clear that it isn't going to be used to remove people who live at the hotels and will -- and reject them from staying. And then it also provides that a proprietor or manager of the hotel should not use these provisions to terminate the lease of a permanent resident without going

through the appropriate legal process required to lawfully terminate such lease. And it also provides that this Section does not limit any rights or protections, a permanent resident may have under the local, State, or federal landlord or tenants law, or housing laws. And it -- it also defines severe weather warnings when people cannot be removed. And I know of no opposition, and I encourage an Aye vote.

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Is there any discussion? Seeing none. The question is, shall House Bill 2220 pass. All those in favor vote, Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 51 Senators voting Yes, 2 voting No, and 0 voting Present. House Bill 2220, having received the constitutionally required majority, is declared passed. We'll now move to the middle of page 13 where Senator Villivalam brings House Bill 2235. Senator Villivalam, on House Bill 2235. With leave of the Body, we'll move down towards the bottom of page 13 where Senator Joyce brings House Bill 2266. Senator Joyce, on House Bill 2266. We're going to move to page 14 now of your printed Calendar House Bills 3rd Reading. Near the top of that page, Senator Johnson brings House Bill 2278. Senator Johnson, on House Bill 2278. She indicates she wishes to proceed. Mr. Secretary, please read that bill.

SECRETARY ANDERSON:

House Bill 2278, an Act concerning civil law. 3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Johnson, on House Bill 2278.

SENATOR JOHNSON:

Thank you, Mr. President. House Bill 2278 expands the State's ability to authorize the creation of environmental covenants which will establish -- which will establish land use restrictions aimed at protecting human health and the environment at large. And in doing this, House Bill 2278 brings the Illinois Uniform Environmental Covenants Act -- Act more in line with the standards that we have -- have been implemented around the nation, especially in the region. And I know of no known opposition. This is an initiative of the Illinois Environmental Protection Agency, and I encourage an Aye vote. Thank you.

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Is there any discussion? Senator Bryant, for what purpose do you seek recognition?

SENATOR BRYANT:

Thank you, Mr. President. Question of the sponsor, please. PRESIDING OFFICER: (SENATOR CUNNINGHAM)

The sponsor indicates she will yield. Senator Bryant. SENATOR BRYANT:

Thank you. There are some individuals in our caucus who've had a little bit of trouble with the EPA. So, I would ask, what is the -- what's the reason? Why do we need this or why does the IEPA need this?

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Johnson.

SENATOR JOHNSON:

Thank you. So, the -- the purpose of the Environmental Protection Agency asking us is because we believe that the current law pertaining to the Uniform Environmental Covenant Act is overly restrictive and it presents -- prevents the agency from creating

environmental covenant sites where exposure to possible contaminants need to be prevented. And then it also addresses overly restrictive aspects of the Uniform Environmental Covenants Act and brings it, as I mentioned before, more in line with the national model that we have been -- that have been adopted at numerous states, including in our region.

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Bryant.

SENATOR BRYANT:

Thank you. Do you -- do you by chance have examples of some of the sites that they're trying to protect?

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Johnson.

SENATOR JOHNSON:

Thank you, Senator. I don't have any specific examples, but I do know that there is a site in my district in North Chicago that will benefit greatly from this legislative measure.

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Bryant.

SENATOR BRYANT:

So, I noticed that there's a little bit of wording that says something to the effect of what is -- that it mentions human health environment at large. Could you define what that human health environment at large means?

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Johnson.

SENATOR JOHNSON:

Sure, just a second. Senator, can you repeat your question? PRESIDING OFFICER: (SENATOR CUNNINGHAM)

SENATOR BRYANT:

Yes. So, there is a mention in here of human health environment at large I think is the term that's used. And -- and I know that you -- this doesn't show any opposition to the bill, but the reason I'm asking about the human health environment at large is I'm a little confused about how the IEPA is going to use this. For instance, you know, this is a kind of a large, broad reaching bill that changes language for covenants. So, if you have a farm or a farm environment and there's a covenant in relation to what can be planted or where it can be planted, I've got some concerns in regard to that. So, the question is what does human health environment at large mean?

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Johnson.

SENATOR JOHNSON:

Thank you, Senator, for the question -- question. Let me give you some background information and then hopefully to address your concerns. So, the Illinois Environmental Covenant Acts allows parties conducting environmental response projects. So, for example, cleaning up a contaminated site to create these covenants to prevent exposure to contamination and provide long term protection of human health and the environment. And then I -- I do have an example for you. If groundwater contamination is presented at a site, an environmental covenant may be used to prohibit the installation and use of wells as people do not use the groundwater as a source of drinking water. And so, currently the Illinois Uniform Environmental Covenant Acts allows for the creation of environmental covenants only on a limited number of sites, i.e.

superfund sites, federal sites being remediated under the Comprehensive Environmental Response, Compensation and Liability Act. So, this limitation prevents the creation of environmental covenants at other sites where they would be useful. So, for another example, and I mentioned this just a few minutes ago, the City of North Chicago owns a hazardous -- hazardous waste landfill that would likely redevelop. However, certain levels of hazardous waste remains -- remain on the site. So, under the amendments provided by the bill, the City could create environmental covenants to help address contamination and provide long term protection. And I'm going to use this phrase again to human health and the environment.

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Bryant.

SENATOR BRYANT:

I'm really -- I'm still very uncomfortable about this. And because I think this is kind of being not slipped in by you, I don't mean it like that, but it's being, it's really broad reaching and I'm not sure that we caught it, how broad reaching this is. Honestly, this is I mean, when we're talking about groundwater contamination and so forth, this could -- we really have some farreaching issues here for farms? I hate to ask you to do this, but I -- I would ask that you would pull this so we can have some time to talk through a lot of the issues that I think that we have here, because the human health environment at large is super broad. Changing covenants for water and water contamination is a really broad reaching issue as well. This isn't just about cities. This really has the potential to have broad reaching effects for farm areas. So, I'm -- I'm asking if you'll consider that. If you won't

consider it. I don't think that I would -- I would ask my side to not support it just simply because we have too many questions. PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Johnson.

SENATOR JOHNSON:

Thank you, Senator. I understand your concern -- your concerns, and this has been vetted with the Illinois Farm Bureau. There are no concerns. And just to let you know, too, I mentioned that a number of states in our region have adopted this -- these covenants, too, and that includes Iowa, Missouri and Kentucky and to a lesser extent, Minnesota, Wisconsin, Michigan and Ohio. And although I understand your concerns, there are no concerns with the Illinois Farm Bureau. And I don't think that this -- and I do understand, just to be clear, the ramifications and I'm very comfortable moving forward with this legislative measure.

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Bryant.

SENATOR BRYANT:

Thank you for answering the questions. I still have a lot of questions on the bill. I would just say to my caucus, because we have those questions should consider strongly what you want to do about the bill. I think those questions are still lingering out there, but I do appreciate your consideration and the answer -- answers to our questions. Thank you.

Senator Villivalam, on House Bill 3149. Remaining on page 5, I'm sorry, page 18 of your printed Calendar the middle of the page Senator Koehler brings House Bill 3155. He indicates he wishes to proceed. Mr. Secretary, please read the bill.

SECRETARY ANDERSON:

House Bill 3155, an Act concerning employment. 3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Koehler.

SENATOR KOEHLER:

Yes. Thank you, Mr. President. This bill establishes a new fee structure for the Illinois Secure Choice Savings programs to cover administrative costs of the program. The legislation also clarifies the employer exemptions, and the role of the Treasurer's Office staff has in providing administrative support for the program and for the Illinois Secure Choice Savings Board. So, know no opponents. It's a request of the Illinois State Treasurer's

SENATOR PLUMMER:

The sponsor indicates he will yield. Senator Plummer.

SENATOR PLUMMER:

Senator Koehler, the Secure Choice Savings Program. What's -- what's -- what's the goal of that plan?

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Koehler.

SENATOR KOEHLER:

This is primarily aimed at the disabled community so that they can save money for the future.

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Plummer.

SENATOR PLUMMER:

So, it's aimed at the disabled community, so they save money. But it's the -- the -- the point of the plan, I think, is to keep it very low cost so that they can maximize their savings. This bill drives up the fees. And I'm curious who pays these fees? PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Senator Koehler.

SENATOR KOEHLER:

The -- the fees would -- would come out of the -- the program itself. So, the individuals -- but you're exactly right. This is a low-cost way of saving money for this community. And with --

SENATOR PLUMMER:

I just -- I find it disingenuous for us to try to create a low-cost savings plan for the disabled community, spend a lot of money marketing it, and then when people get into the program, turn around and raise fees on the disabled community for the program they got into, they thought was going to be low cost. I think the State of Illinois can find room in its budget to make sure that we keep this a low-cost savings plan for the disabled community instead of tricking people into the program and then raising their fees. I urge a No vote.

PRESIDING OFFICER: (SENATOR CUNNINGHAM)

Is there any further discussion? Seeing none. Senator Koehler, to close.

SENATOR KOEHLER:

Yes. The point of this is that this is a low-cost savings program. And if you take the -- these fees and take it from other parts of the budget, you're still talking about taxpayers' dollars. This is an important program and it's -- it's a much lower cost than any other kind of savings program out there. So, it would be a real tragedy to lose this. So, I'd encourage an Aye vote. Thank you.

House Bill 1067 amends the County Code to require a public works superintendent employee by a county board or employed by a Board of Public Works and a county to hold an engineering degree from an accredited institution or of higher learning or have at least ten years of professional management level experience in either a municipal or county public works department. House Bill 1067 also requires the Public Works Department to have at least one employee that is a professional engineer licensed under the Professional Engineering Practice Act of 1989. And this legislation takes effect upon becoming law. This is an initiative of Lake County government, and we have the support of a number of proponents, including the Illinois State Association

of County -- Counties, Illinois Association of County Board Members and many others. And there is no known opposition. And I encourage an Aye vote. Thank you.
