- Senator Knuepfer.
- 7. SENATOR KNUEPFER:
- 8. Now, this them is the money for the funding of the State's
- g. contribution for this year?
- 10. SENATOR GROEN:
- 11. That's correct.
- 12. PRESIDING OFFICER: (Senator Partee)
- 13. Senator Knuepfer. He's...light on.
- 14. SENATOR KNUEPFER:
- 15. Then I want to get to the level of funding. Ah, on what is this
- 16. level of funding based? Is there any catch-up here for all of the
- 17. unfunded liabilities? Does this presume on this basis whatever the
- 18. number is...two million, so many thousand dollars that we are in truth
- 19. meeting our obligation for this year or are we backing off again?

- Well, Mr. Chairman and to Senators Knuepfer and Mitchler, if we 22.
- tried to amortize over a forty year period the unfunded obligation 23.
- of this system, which is now a billion dollars, it would require 24.
- in excess of two hundred million dollars a year, and we just don't 25.

- PRESIDING OFFICER: (Senator Partee) 27.
- Senator Horsley. 28.
- SENATOR HORSLEY: 29.
- Well Mr. President, just to remind you of what condition we're 30.
- in, if you'll recall a gentleman by the name of Noble Lee, a very 31.
- distinguished, fine gentleman from Chicago who pointed up the very 32.
- situation we were in, and as I recall, his bill had an appropriation 33.

- for 22 million dollars and the purpose of that bill was merely to
- pay the interest on money we ain't got and I think that's the shape

- Any further grammarians desire to get into the debate,

- 9. SENATOR BRUCE:
- 10. Yes, Senator Groen, I wonder if we could answer a couple of
- 11. questions. First of all...are we not obligated to fund this at
- 1.2 to member contribution?
- 13. SENATOR GROEN:

- 14. Yes, Senator, we are, and I might add this figure does not
- 15. constitute all that's involved. There are other appropriation
- 16. bills but in answer to Senator Knuepfer's question, he asked me
- 17. whether this was the full amount ... it wasn't. Ah... he asked me

- On Task Force we had an opportunity to discuss with the Executive 24. Secretary of the downstate teacher's system and there is a bill presently 25.
- in the Legislature with a ... would a hundred and 26 million dollars be 26.
- ... Why is this bill just 2 million? It just seems to pay the current 27.
- obligations that are due next year. This is not the general appropriation 28. SENATOR GROEN: 29.
- No ... it is not. 30.
- SENATOR BRUCE: 31.
- Well, what did this fund? 32.
- SENATOR GROEN: 33.

- 1. Well, I would have to get my file, and as I say, my file is not here
- 2. on that ... on that program.
- PRESIDING OFFICER: (Senator Partee)
- Senator Gilbert.
- 5. SENATOR GILBERT:
- We are off on two different subjects completely. In other words,
- 7. the question that Senator Knuepfer and Mitchler are talking about are
- 8. the appropriations for the current downstate and Chicago Teachers Re-
- 9. tirement funds. The appropriation as I recall is 82 million dollars
- 10. for the downstate teachers and 25.4 million for the Chicago teachers.
- 11. This is an increase over what we appropriated last year of some 36
- 12. million. We are attempting to do some catching up, Senator Knuepfer,
- 13. and the amount that we are appropriating this year is more than enough
- 14. to pay the claims that are expected to be made this year. But this
- 15. bill is an entirely different matter, I am not familiar with exactly
- 16. what it is but it is not those pensions because I know those two funds.
- 17. We have talked about them in school problems commission and those bills
- 18. are 82 million and 25.4 to take care of the Chicago and downstate
- 19. appropriations.
- 20. PRESIDING OFFICER: (Senator Partee)
- 21. Senator Groen.
- 22. SENATOR GROEN:
- 23. Senator Gilbert is right in his figures, but I would add this to
- 24. that. Senator that does not begin to cover the current cost that is
- 25. involved in these ... in the funding of the two systems ... either the
- 26. Chicago system or the downstate system. I did find in the supplemental
- 27. file here, this is the appropriation for the supplemental payments and
- 28. would be an adequate figure based upon their best estimate for the cost
- 29. for this year, Senator Knuepfer. But I am glad this subject came up
- 30. because it points up a subject which I intended to talk about and will
- 31. talk about at a later time when these actual appropriation bills do come
- 32. up that are so grossly inadequate.

- 25. On this question, the yeas are 49, the mays are none. This bill
- 26. having received the constitutional majority, is declared passed. 1464
- 27. Senator Gilbert. Would Senator Walker come to the rostrum a moment please
- 28. SENATOR GILBERT:
- 29. Mr. President, I would like to bring 1464 back from Third Reading
- 30. to Second for the purpose of reconsidering the vote by which ${\mbox{\sc Amendment}}$
- 31. Number 2 was adopted for the purpose of submitting Amendment Number 3
- 32. which includes the part of Amendment Number 2 and also deletes the

- 26. Mr. President, and members of the Senate, there are presently
- 27. pending before the Senate, three bills concerning what's called
- 28. assessability education assessability. I wonder Mr.
- 29. President . . .
- 30. PRESIDING OFFICER: (Senator Partee)
- 31. Senator Rock, I'm sorry.
- 32. SENATOR ROCK:
- 33. Yes. I wonder Mr. President, if we can revert as I started to

- 1. indicate, there are three bills concerning this or related subject
- 2. matters. Senator Saperstein has one, I have two of them. I
- 3. wonder if we might revert back to 1430 and start at the first step
- 4. and then perhaps we can go through all three of these bills?
- 5. PRESIDING OFFICER: (Senator Partee)
- 6. The Chair calls 1430 Senate Bill on Third Reading. 1430,
- 7. Senator Rock.
- 8. SENATOR ROCK:
- 9. Yes. Mr. President and members of the Senate. Senate Bill
- 10. 1430 mandates an annual educational performance assessment of
- 11. public education in Illinois in order to provide information on
- 12. how well and how efficiently the public schools of this State
- 13. are serving the students that attend them, and the taxpayers
- 14. that support them. In other words, this Bill requires an annual
- 15. state educational needs assessment to determine the educational
- 16. performance and fiscal efficiency of education offered in the
- 17. Illinois public school system.
- 18. PRESIDING OFFICER: (Senator Partee)
- 19. Senator Horsley.
- 20. SENATOR HORSLEY:
- 21. A point of inquiry. Are we considering all of these three
- 22. bills now, or we going to take them one at a time?
- 23. PRESIDING OFFICER: (SENATOR PARTEE)
- 24. One at a time in sequence.
- 25. SENATOR HORSLEY:
- 26. And we're going to vote on them one at a time separately.
- 27. PRESIDING OFFICER: (SENATOR PARTEE)
- 28. Individually.
- 29. SENATOR HORSLEY:
- 30. Thank you. These are very important bills and I hope that
- 31. everybody will pay attention to what he is saying. Although I'm
- 32. agin' 'em, but I hope everybody listens to what he has to say.
- 33. SENATOR ROCK:

- Senator, I hope everybody does listen, even though you're
- 2. agin' 'em. Maybe if you listen, you wouldn't be agin' 'em.
- 3. Senate Bill 1430 gives legislative authority to develop and
- 4. implement a state educational needs assessment in order to determine
- 5. the educational performance and fiscal efficiency of the system
- 6. of education offered by the public schools of this State. At
- 7. present, as you know, there are no State guidelines or validly
- 8. established measurement criteria with which school districts can
- 9. determine the success of the educational program. This effort
- 10. to provide quality education requires some type of reasonable
- 11. standard against which a school district can compare its past
- 12. and present achievements. Senate Bill 1430 would authorize the
- 13. Superintendent of Public Instruction, with the advice of a
- 14. Citizens Advisory Committee for Assessment and Evaluation to do
- 15. the following:
- 16. To develop techniques for assessing student attributes
- 17. including students knowledge, skills and attitudes.
- 18. To field test, evaluate and revise the assessment procedures
- 19. based on valid sampling techniques and begin a State educational
- 20. assessment program on or before September 1, 1975.
- 21. Would give authority to conduct an annual state educational
- 22. assessment that would furnish annual assessment reports to the
- 23. Governor, the General Assembly and the School Problems Commission.
- 24. To assist those boards that requested district educational
- 25. assessment in interpreting the results so affirmative action may
- 26. be taken to improve local educational programs and procedures.
- 20.
- 27. This bill has the support of many educators. It has the
- 28. support of the Illinois State Chamber of Commerce:
- 29. The appropriation was in the amount of \$128,000.00. That portion
- 30. of the bill was deleted and will be offered as an amendment
- 31. to the budget of the . . . or the appropriation bill for the
- 32. Superintendent of Public Instruction. I would solicit your
- 33. favorable support for this legislation.

- PRESIDING OFFICER: (Senator Partee)
- Any further discussion? Senator Knuepfer.
- SENATOR KNUEPFER:
- 4. Yeah, I'm . . . I'm I want to say I'm . . .
- 5. PRESIDING OFFICER: (Senator Partee)
- 6. Just a minute Senator, I want to get you some order.
- 7. Gentlemen in the back there please let's have it quiet so we
- 8. can hear the gentleman. Senator Knuepfer.
- 9. SENATOR KNUEPFER:
- 10. I think the kind of thing you're attempting to do is a most
- 11. necessary kind of a thing. The only question I have is it
- 12. necessary that we legislatively mandate the Superintendent of
- 13. Public Instruction to do this? Couldn't he do this on his own
- 14. initiative?
- 15. PRESIDING OFFICER: (Senator Partee)
- 16. Senator Rock.
- 17. SENATOR ROCK:
- 18. Senator that's an excellent question and one of the first
- 19. ones that I asked the Superintendent when he presented this bill
- 20. to me. In . . . In my judgment, certainly he has the authority
- 21. to do something like this, if not this exact same thing. I think
- 22. his thinking, however, is that since in . . . whether this year or
- 23. in years to come, the legislature is going to be called on
- 24. constitutionally to fund public education to an extreme amount...
- 25. Somewhat over 50% obviously. That this kind of a program, rather
- 26. than be directed by or authorized by or postulated by a State
- 27. agency, should be a mandate of the legislature. Eight or ten
- 28. other States have this, and they all are as a result of legislative
- 29. enactment and I am sure that was his thinking.
- 30. PRESIDING OFFICER: (Senator Partee)
- 31. Any further debate? Senator Gilbert.
- 32. SENATOR GILBERT:
- 33. Well . . . the question that you asked, Senator Knuepfer,

- 1. was asked in the Education Committee and a number of other
- questions along the line, which I personally asked and I don't
- recall, maybe some of the others did, whether the Superintendent
- 4. could do this under the present legislation, whether he has the
- 5. staff and the facilities to do it. The answers that we got were
- 6. that he did not have. I personally feel that this is a step in
- 7. the right direction. I am personally going to support this
- 8. legislation.
- 9. PRESIDING OFFICER: (Senator Partee)
- Senator Latherow.
- 11. SENATOR LATHEROW:
- 12. Mr. President, I'd like to ask the same questions that I did
- 13. in Committee. Isn't this doing exactly the same thing the
- 14. Superintendent's office has been doing for some time? Haven't
- 15. they been in the system of evaluating all the school districts
- 16. and the students?
- 17. PRESIDING OFFICER: (Senator Partee)
- 18. Senator Rock.
- 19. SENATOR ROCK:
- 20. No, I'll attempt at least to give you the same answers I
- 21. gave you at that time. No, I don't think it is. This is a new
- 22. program. It calls for a real valid assessment and it calls for...
- 23. this particular bill at this stage, now calls for the Superintendent
- 24. and this Committee to get together and set up standards, criteria,
- 25. against which the performance of our school kids can be measured.
- 26. Heretofore, to my knowledge at least, there just . . . Illinois
- 27. doesn't have any.
- 28. PRESIDING OFFICER: (Senator Partee)
- 29. Senator Latherow.
- 30. SENATOR LATHEROW:
- 31. Well then in Section 1 or in number 1 on line 19, this
- 32. program of evaluation, surveys, tests and so on and questionnaires
- 33. hasn't then being conducted?

- 1. PRESIDING OFFICER: (Senator Partee)
- Senator Rock.
- 3. SENATOR ROCK:
- 4. I . . . I think there obviously has been some attempt at
- 5. least, a with the various reports and with the amount of federal
- 6. funds that come into this State to make some type of an assessment.
- 7. This calls for an in depth, all out, four square assessment of
- 8. how our kids are doing. And it calls for that by legislative
- 9. mandate and it calls for a report back to the legislature
- 10. predicates upon the fact that we are going to have to come up
- 11. with the money.
- 12. PRESIDING OFFICER: (Senator Partee)
- 13. Senator Latherow.
- 14. SENATOR LATHEROW:
- 15. You've seen reports coming from the Superintendent of Public
- 16. Instruction's office that shows how the State of Illinois stands
- 17. in comparison with those of other states and such as that?
- 18. PRESIDING OFFICER: (Senator Partee)
- 19. Senator Rock.
- 20. SENATOR ROCK:
- 21. I have seen some reports like that. This calls for an
- 22. evaluation of our state educational public school system. I
- 23. think one of your concerns is what's commonly referred to as
- 24. state-wide testing, where presumably some of the rural or
- 25. agricultural school districts would not measure up presumably
- 26. and then presumably also would suffer in the funding. That's
- 27. not at all the purpose of this, and I would like to alloy those fears.
- 28. PRESIDING OFFICER: (Senator Partee)
- 29. Senator Latherow.
- 30. SENATOR LATHEROW:
- 31. That . . . That wasn't my worry about how the agricultural
- 32. people stand up with the municipal schools, I tell you Senator,
- 33. that wasn't my worry.

- 1. PRESIDING OFFICER: (Senator Partee)
- Senator Horslev.
- 3. SENATOR HORSLEY:
- 4. Senator Rock. It's been several days since I read these bills.
- 5. I think you called them didn't you, once before and we were going
- 6. to go with them and then we didn't. At least we had something
- 7. up on them on the floor. I don't remember exactly.
- 8. PRESIDING OFFICER: (Senator Partee)
- 9. Senator Rock.
- 10 SENATOR ROCK:
- 11. Senator, what I did do was call them back to second reading
- 12. to take the appropriation off. We got into that discussion pursuant
- 13. to your asking the Chair for a ruling about whether or not a bill
- 14. could contain substantive matter and an appropriation. At that time a ...
- 15. in my judgment, I took the appropriation out of this bill. That's
- 16. when it came up.
- 17. PRESIDING OFFICER: (Senator Partee)
- 18. Senator Horsley.
- 19. SENATOR HORSLEY:
- 20. Isn't it true, Senator, that as I read the bills at that
- 21. time, that we had a \$400,000.00 appropriation which was merely
- 22. seed money to get this baby started? To buy the bottle and the
- 23. nipple and to nourish it along for a little while. Isn't there
- 24. \$400,000.00 in there? Wasn't that the amount?
- 25. SENATOR ROCK:
- 26. Senator, that's with regard to Senate Bill 1548. There is
- 27. in fact \$500,000.00. This particular bill, Senate Bill 1430,
- 28. had carried with it an appropriation of \$128,000.00. And again,
- 29. it's really to get the program started. The full assessment
- 30. program as such, will not kick in until September, 1975. But in
- 31. this intervening period, we cannot rely really on the methods
- 32. and methodology used by the other States. We have to develop
- 33. our own.

- 1. PRESIDING OFFICER: (Senator Partee)
- Senator Horsley.
- 3. SENATOR HORSLEY:
- 4. Senator when you use the words full assessment a . . . most
- 5. of us around here think you're taking about tax assessments.
- 6. You're taking about educational full assessments. Now actually
- 7. these bills provide that after the baby gets weened of it's
- 8. bottle, that we're also going to have to contribute several
- 9. million dollars to educational institutions to pay tuition,
- 10. room and board for the people who are going to be trained to
- 11. become these so-called evaluators. And also to pay for professors
- 12. and educational programs for the people who are going to do the
- 13. training. Isn't that correct?
- 14. PRESIDING OFFICER: (Senator Partee)
- 15. Senator Rock.
- 16. SENATOR ROCK:
- 17. Well Senator . . . Senator I don't know that's the fact.
- 18. Now if you have some information that I don't have, I'll
- 19. certainly take your word for it. I . . . I am not aware of that,
- 20. or of any legislation that says that.
- 21. PRESIDING OFFICER: (Senator Partee)
- 22. Senator Horsley.
- 23. SENATOR HORSLEY:
- 24. Reading . . . I am merely reading from the bill and I don't
- 25. have it in front of me now but, the bill said right in one place
- 26. that grants would be made to institutions for the purpose of
- 27. financing the program and for education of the people who would
- 28. be administering these programs. Now if you will give me a
- 29. moment, I don't know whether that's in 1430 or whether that's in
- 30. one of the other two bills, but I read it . . .
- 31. PRESIDING OFFICER: (Senator Partee)
- 32. Senator Gilbert.
- 33. SENATOR HORSLEY:

- 1. and as I recall, I read it . . .
- PRESIDING OFFICER: (Senator Partee)
- Excuse me.
- 4. SENATOR HORSLEY:
- 5. and it's on the right hand page and it's up at the top of the
- page . . .
- PRESIDING OFFICER: (Senator Partee)
- No. No. Senator Horsley.
- 9. SENATOR HORSLEY:
- on the right hand side.
- 11. PRESIDING OFFICER: (Senator Partee)
- 12. I think Senator Gilvert has an answer here. Senator Gilbert.
- 13. SENATOR GILBERT:
- 14. Senator Horsley, that is not in this bill. I think you're
- 15. confusing it with 1464. A bill which I introduced, which called
- 16. for \$200,000.00 in community education, which did allow grants to
- 17. the institution and that may be the bill that you're thinking of.
- 18. I do not believe that's in 1430, the one that we're taking about
- 19. now.
- 20. PRESIDING OFFICER: (Senator Partee)
- 21. Any further debate? Senator Bruce.
- 22. SENATOR BRUCE:
- 23. Yes. Mr. President and members of the body I rise in opposition
- 24. to this bill. Senate Bill 1430 is "a quality education bill
- 25. proposed by Superintendent Bakalis." The difference to those who
- 26. have listened to the debate and whether or not the Superintendent
- 27. can do this now or whether we must mandate him to do it is in the
- 28. dollar amount will create. I think in no other field is equal to
- 29. education in the amount of money we can create prospectively
- 30. This program will go through without any money in the bill. Then
- 31. next year you will find in the Superintendent's budget, I am sure,
- 32. a new division called the Division of Assessment or Assessment
- 33. Control. I have no idea what that program will cost, but I am

- 1. sure that it will be substantial. We created last year an Urban
- 2. Education Act, which I opposed because I said the amount this year
- 3. would be stunning. It passed last year with something in the
- 4. neighborhood of \$150,000.00. It runs over \$13,000,000.00 this
- 5. year. This is the type of program that this Legislature must be
- 6. very wary of. Is that the money to fund this will not be required
- 7. this year. It seems like we're doing a good job. We are "making
- 8. quality education available to all students in this State." But
- 9. next year when the budget comes around, many of us here will be
- 10. surprised and say no one told me how much it was going to cost.
- 11. I think we are creating a program the local boards do not desire
- 12. and it's creating a State program which will cost money that the
- 13. State citizens do not desire. We will have educationalists
- 14. running around the state assessing "quality education" whatever
- 15. that may be and spending a substantial amount of money. We are
- 16. in a funding change in Illinois. I see no reason at this point to
- 17. create a new advisory board, to create new annual reports, to
- 18. create new field tests which will be conducted by, I am sure,
- 19. State employees on the State payroll who will be getting travel,
- 20. who will be on all of our expenses for contracting out studies,
- 21. for the printing of those studies. All the ramifications of this
- 22. bill are not . . . the dollar amount is not shown. If we're going
- 23. to change the funding in Illinois and I find that this is a
- 24. strange time to be changing the assessment procedures, I would
- 25. oppose the bill and do oppose the bill for the reason of funding
- 26. and because the money that we are going to spend for this bill
- 27. is just an enormous amount of money in the years to come.
- 28. SENATOR PARTEE:
- 29. Mr. President and members of the Senate, I rise in support
- 30. of this bill. I suppose I have as much sensitiv ity as most of the
- 31. members about spending taxpayers money. I never forget that I am
- 32. one of them and I am reminded of that fact quite often when it's
- 33. time to pay my taxes. I think that this, however, is not an

- issue that we should be so overly concerned about the money
- 2. involved and the prospective money which is to be spent. I can
- 3. think of nothing more important to the future of the State of Illinois
- 4. than that the young people in our schools get a good education.
- 5. A good sound fundamental education in the grammar school and
- 6. high school is absolutely essential. We spend lots of money
- 7. around here for lots of things that are far less important over-
- 8. all to the State of Illinois than we would in this kind of a
- 9. program. The people in my district are concerned about what
- 10. their children are learning in school. The people in my district
- 11. want to know whether the teachers are doing what they are being
- 12. paid to do. The people in my district want to know if their
- 13. children are learning at their highest potential. There is no
- 14. way other than to make an assessment than by the kind of program
- 15. that this kind of legislation dictates. People ought to know
- 16. whether their children are learning, whether they're learning at
- 17. their highest potential, whether the teachers are doing every-
- 18. thing that ought to be done. An assessment is absolutely necessary.
- 19. We have assessments in all other areas of life. People are
- 20. evaluated on the basis of their competence. They are evaluated
- 21. on the basis of their production in all areas of life and
- 22. certainly in this area, we ought to know. There was a very
- 23. popular phrase a few minutes . . . a few moments ago or a few
- 24. years ago probably now, "Why Johnny can't read?", and there were
- 25. all kinds of assessments made as to why it wasn't. I can remember
- 26. my father evaluating the kind of program that I had in school.
- 27. I think parents have the right to have some scientific data
- 28. presented to them by the Superintendent of Public Instruction
- 29. as to what the status and posture of our learning process is.
- 30. I think this is one of the most essential, valuable pieces of
- 31. legislation that's been introduced in this session. I would
- 32. certainly support it and urge you to do likewise.
- 33. PRESIDING OFFICER: (Senator Laughlin)

2. SENATOR SOURS:

з. Before I get off into a parenthetical comment on this, Mr. President and Senators, I would like to state also the back row 4. is considering seriously offering an honorary seating arrangement 5. to Senator Bruce. And we are going to get a place over here for 6. you, Senator, because that's one of the most refreshing opposition 7. speeches we've had this semester. Pork is pork, however it may 8. be described. Just like a rose is a rose, according to the bard of 9. Avon. A million dollars won't produce a Phi Beta Kappa or a 10. Rhodes Scholar. Now we have some idea of what is wrong with the 11. I don't think we need a new adjunct of the educational system. 12. Department of Education. After all, Ray Page was not known for 13. being parsimonious about this kind of legislation nor is his 14. successor. One of the very purposes of the Department is to 15. ascertain just what we're talking about. Without any prod. 16. Without any encouragement. Without any legislation. Now, as 17. has been said by Senator Bruce, this will be a line item next 18. year. And after that it will be a horrendous expense. 19. some of us have told this Chamber in the past, that day care will 20. come back to haunt us when those living on Lake Shore Drive will want 21. the same care of their children. Now we're starting something 22. It will be a professor's paradise. It's like a refining here. 23. company for an oil company, that's a plumber's paradise. 24. will be an educator's paradise. Now I have my own notions of 25. why "Johnny can't read?", Senator. Because in many of what we 26. used to call the normal schools there was a time when there was 27. 80 hours of procedure and 40 hours of substance. So the history 28. teacher knew exactly how to teach history, but he couldn't put 29. Napoleon in the right century. We've had the back door to the 30. old normal schools, that's what is the trouble. Trouble number 31. two. The teachers beat the kids out the front door at 3:15. 32.

Then they decide they are going to punish the electorate when

- 1. bond issues fail, so they cut down on music and other things
- instead of cutting out the fat. With all the colonels and all the
- 3. generals are in what is sometimes called the front office crowd.
- 4. That's what is wrong. We've created a hierarchy that's come back
- 5. to haunt us. Maybe the times tables would help us a little. Maybe
- 6. the old fashioned spelling book and the Ellson Readers instead of
- 7. all this advanced foolishness. And may I close by saying that a
- 8. million dollars never cured a headache and a million dollars
- 9. never made a scholar.
- 10. PRESIDING OFFICER: (Senator Laughlin)
- 11. Senator Hynes, did you wish to be heard on this matter?
- 12. SENATOR HYNES:
- 13. Mr. President and members of the Senate I rise in support
- 14. of this legislation. I would echo the comments of Senator Partee
- 15. and I would also think frankly, the Senator from Peoria would be
- 16. among the most vociferant . . . vociferous supporters of this
- 17. legislation since it's an attempt to find out how we are spending.
- 18. 3 billion dollars a year that we spend on education in Illinois.
- 19. Combining state, federal and local sources, we spend 3 billion
- 20. dollars a year, and yet we do not effectively evaluate that
- 21. expenditure. I think this is a small sum of money to invest to
- 22. determine how the money is being spent, how our children are being
- 23. educated. What kind of results are coming from these massive
- 24. expenditures? I think it's highly desirable legislation. I
- 25. would urge all of you to support it. Also I might point out,
- 26. in the Superintendent's budget it was originally part of this
- 27. bill. The appropriation of \$125,000.00, and has been taken out
- 28. the bill and has been put separately into the Superintendent's
- 29. office appropriation.
- 30. PRESIDING OFFICER: (Senator Laughlin)
- 31. Is there any further debate? Senator Berning.
- 32. SENATOR BERNING:
- 33. Thank you Mr. President and members of the body. I recognize

- that I am perhaps going to be redundant but it does appear to me 1.
- that the office of the Superintendent of Public Instruction can 2.
- do this very thing now. The question arises in my mind is 3.
- simply if he has not, why not? This seems to me to be the basic . . 4.
- one of the basic responsibilities of that office and I am intrigued
- to find now that this department is not functioning in a manner
- that I thought was purely elemental. People in my district are 7.
- ever concerned about the mounting expenditures of our funds . . . their 8.
- funds, I might say and the initiation of any new programs are 9.

Mr. President and members of the Senate, I rise in opposition 33.

- 1. to this bill. This bill calls for a citizens advisory committee.
- 2. Now I always thought that the citizens advisory committee was the
- 3. local school board. I think the local school board should know
- whether or not the students are doing well when they receive reports
- 5. that their scholars . . . their scholarships haven't been . . .
- 6. scholarships haven't been awarded to their local schools to
- 7. their local school children. They find that they receive their
- 8. graduation certificates or diplomas and they can't find jobs because
- 9. they can't read and write. I think the school board knows that.
- 10. They know what is going on in their school district and if they
- 11. can't take . . . if they can't take heed of that, there is no
- 12. citizens advisory committee that's going to help them. To spend
- 13. this money reminds me of when I came down to the Senate and we
- 14. had \$261,000,000.00 for relief and now the last budget was
- 15. 14 hundred million dollars. This will just grow and grow and
- 16. grow, and we can't afford all this nonsense. People that have the
- 17. responsibility, have to take the responsibility. The sooner we
- 18. cut down with these extra divisions in every . . . in every
- 19. directorship or division that we have in the state, the sooner
- 20. we will be fiscally responsible and we'll get on to the business
- 21. of educating the children in the proper manner.
- 22. PRESIDING OFFICER: (Senator Laughlin)
- 23. Is there any further debate? If not, the Secretary will
- 24. call the role. Was there someone else? Did I miss someone?
- 25. I beg your pardon. Senator Rock. I'm not used to being up here,
- 26. you may close the debate.
- 27. SENATOR ROCK:
- 28. Thank you Mr. President and members of the Senate, I can
- 29. only say gentlemen that I have to echo what Senator Partee said.
- 30. I think that this is an extremely important piece of legislation
- 31. for the future. This calls for the full accountability procedures
- 32. to be effective and effected in . . . by September 1, 1975. Now
- 33. in order to do that properly, we have to begin immediately. I

- would think that everyone would support this. We are going to
- argue long and hard I am sure, as to the funds that we will
- 3. ultimately appropriate to the common school fund. I would venture

- 15. PRESIDING OFFICER: (Senator Partee)
- Senator Bruce.
- 17. SENATOR BRUCE:
- 18. Gentlemen, we are on the verge of creating probably the most
- 19. extensive shelf study that Illinois has ever made. A shelf study
- 20. is one that is done at tremendous expense and then placed upon
- 21. our shelves. I vote no.
- 22. PRESIDING OFFICER: (Senator Partee)
- 23. Continue with the roll call.
- 24. SECRETARY:
- 25. Carpentier, Carroll, Cherry, . . .
- 26. PRESIDING OFFICER: (Senator Partee)
- 27. Senator Cherry.
- 28. SENATOR CHERRY:
- 29. I notice the 18 states in the United States have already
- 30. passed similar legislation. I'm referring to the most populous
- 31. states in the union Pennsylvania, New York, New Jersey, Ohio.
- 32. I have heard many comments by people who are inquiring what are
- 33. we doing in our educational system today? Why can't some of our

- youngsters read properly? Why can't they write properly? Why
- 2. can't they devote enough time for study periods? What is happening
- 3. in our educational system where many students are turned out that
- 4. don't have basic qualifications to go on to higher education? I
- 5. think this is a good bill and I want to correct Senator Berning.
- 6. I don't know where he gets the date that this law, if passed, will
- 7. become effective in 1979. Because the bill precisely says 1972.
- 8. That's the date . . . the effective date of this act. I think
- g. it's time that we reassess our values and determine where we are
- 10. going in future education for the youngsters in our society
- 11. today. I think times have changed sufficiently and we better give
- 12. a new look and a strong look at our entire educational system and
- 13. find out what are the defects. Where we're from here in our modern
- 14. society. What new techniques are necessary? We've inovated a new
- 15. program in my district called the Magnet School. The results that
- 16. have been achieved there are absolutely amazing. I think that a
- 17. study of what is occuring there is most important by the office of
- 18. Superintendent of Public Instruction. I see nothing wrong with
- 19. this bill. I think it's a great step forward for the youngsters
- of our society and I vote ave.
- 21. PRESIDING OFFICER: (Senator Partee)
- 22. Senator Cherry votes aye. Continue the roll call.
- 23. SECRETARY:
- 24. Chew, Clarke, Collins, Coulson, . . .
- 25. PRESIDING OFFICER: (Senator Partee)
- 26. Senator Coulson.
- 27. SENATOR COULSON:
- 28. Mr. President, the new constitution under which we are now
- 29. operating provides that this new State Board of Education, except
- 30. as limited by law, may provide . . . may establish goals, determine
- 31. policies, provide for planning and evaluating education programs
- 32. and recommend financing. Now it seems to me, this is either an
- 33. attempt to statutorily enact what is already in the Constitution.

- PRESIDING OFFICER: (Senator Partee)
- Senator Knuepfer.
- 11. SENATOR KNUEPFER:
- 12. I'm afraid I don't see the devil that evidenta-ly many of my
- 13. colleagues see in the bill. I think one of the serious problems of
- 14. the Legislature and the Executive Branch in this State is that
- 15. after we've spent the money, we pay far too little attention to what
- 16. we've really done with that money. We've talked about things like
- 17. performance budgeting, and never even gotten close to them. We
- 18. haven't paid any attention to it later. This doesn't come close
- 19. to performance budgeting but it is darned important to find out what
- 20. we're doing and before we know why we're doing it. We a . . . and
- 21. this program will grow. I share many of the doubts that Senator
- 22. Bruce has about growing programs. I know they grow and I'm afraid
- 23. of them. But I think in the one area that this State needs growth
- 24. programs, it's in the area of finding out what we've done after
- 25. we've done it. And particularly in measuring what we've done and
- 26. I vote aye.
- 27. SECRETARY:
- 28. Knuppel, Kosinski, Kusibab, Latherow, Laughlin, . . .
- 29. PRESIDING OFFICER: (Senator Partee)
- 30. Senator Laughlin.
- 31. SENATOR LAUGHLIN:
- 32. Mr. President and members of the Senate, I have been trying
- 33. to listen to this debate and remember where the light switch was

- 1. when I was up there in that wrong place: At first I thought I
- 2. was going to support this bill and I've come to the conclusion that
- 3. I can't. The motive is undoubtedly the finest. Unfortunately my
- 4. wife is a school teacher teaching remedial reading takes courses
- 5. and constantly tells me how much disagreement there is among the
- 6. professors as to the proper way to teach Johnny to read. They
- 7. don't even agree completely that there is such a thing as dyslexia,
- 8. for example. Now it's one thing to set out in this statute what
- 9. we're to do and to set up rules, but if you look on page 2, it's
- 10. really sort of interesting. This says that the legislature will
- 11. enact this provision: All norm referenced testing conducted
- 12. hereunder shall constitute no more than one-third of the importance
- 13. of the total assessment and shall be administered on a sampling
- 14. basis, unless otherwise requested by any local school board. Now
- 15. none of us know what this means, let's confess it. Also, all
- 16. reported data shall take into account other characteristics which
- 17. influence student educational performance such as, and they
- 18. don't say without limitation or as limited. Such as the size of
- 19. the school district, level of financial support and other school,
- 20. community, economic and social variables. Now I tell you, ladies
- 21. and gentle . . . lady and gentlemen of the Senate, this is to
- 22. authorize the darndest experiment you ever saw. And while the
- 23. motive is excellent, and we certainly do need to improve the
- 24. quality of our education, I'm satisfied this isn't the way to do
- 25. it. I vote no.

- 29. Speak a little louder, would you.
- 30. SECRETARY:

- PRESIDING OFFICER: (Senator Partee)
- Senator Horsley votes no. Request for the call of the
- absentee.
- 4. SECRETARY:
- Arrington, Baltz, Bidwill, Chew, Clarke, Fawell, Harris, Knuppel,
- 6. Rock, Swinarski, Weaver.
- 7. PRESIDING OFFICER: (Senator Partee)
- 8. Lyons ave. Senator Rock.
- 9. SENATOR ROCK:
- 10. Mr. President, I don't think I'm recorded. I would like to
- 11. postpone consideration on this bill.
- 12. PRESIDING OFFICER: (Senator Partee)
- 13. Consideration postponed. Is 1432 in this series? Is Senator
- 14. Saperstein on the floor? Do you desire to go ahead with this one
- 15. or hold it? 1437, Senator Vadalabene. 1464, Senator Gilbert.
- 16. 1466, Senator Merritt.
- 17. SENATOR MERRITT:
- 18. Yes Mr. President and members of the Senate, 1466 is just as
- 19. the Calendar says. It is the annual appropriation Commission for
- 20. Economic Development. Itold Senator Lyons earlier that we would
- 21. hold it 'til I saw the status of the omnibus bill, if it had it
- 22. in. Now I've seen that come from the House and just for the sake
- 23. of getting this over to the House, I would appreciate a favorable
- 24. roll call. If it is in the omnibus bill, it will die over there.

- 32. Yes Senator Neistein, with your aye vote we were able to
- 33. accomplish that.

- 1. PRESIDING OFFICER: (Senator Partee)
- Senator Neistein.
- SENATOR NEISTEIN:
- You never had my aye vote. I've opposed it all the time. You
- 5. see programs on T.V., the State of Oregon, all the other states
- encouraging people to come there and they don't charge them for
- 7. asking for information about their States. Now I think it's a
- 8. mistake to have people who want to write in about Illinois and say
- 9. you have to pay a charge to find out information. You should be
- 10. giving them money for making the interest or exhibiting the interest
- 11. in the State of Illinois and I'm going to oppose this bill.
- 12. PRESIDING OFFICER: (Senator Partee)
- Senator Merritt.
- 14. SENATOR MERRITT:
- 15. Senator Neistein, you have us confused with the Department.
- 16. The Department does the charging, not the Commission.
- 17. PRESIDING OFFICER: (Senator Partee)
- 18. Any further debate? Do you care to close the debate, Senator?
- 19. Roll call.
- 20. SECRETARY:
- 21. Arrington, Baltz, Berning, Bidwill, Bruce, Carpentier, Carroll,
- 22. Cherry, Chew, Clarke, Collins, Coulson, Course, Davidson, Donnewald,
- 23. Dougherty, Egan, Fawell, Gilbert, Graham, Groen, Hall, Harris,
- 24. Horsley, Hynes, Johns, Knuepfer, Knuppel, Kosinski, Kusibab,
- 25. Latherow, Laughlin, Lyons, McBroom, McCarthy, Merritt, Mitchler,

- 30. Saperstein, aye. On that question the yeas are 40, nays are
- 31. The bill having received a constitutional majority is declared
- 32. passed. Senator Partee.
- 33. SENATOR PARTEE:

- Just two brief announcements, there is a young man here with
- a camera from Southern Illinois University, who desires to take
- 3. some photos of the Senate in session. They are stills and require
- 4. no lights. It's a requirement for a term paper in photography I
- 5. might add. I understand there is no objection to it so if you see
- 6. him here, you will know what's going on. And while I'm on my feet
- 7. let me say that one of the reasons that I think the Legislature

- 23. PRESIDENT:
- 24. 1476, Senator Saperstein. Hold. Same on 1490. 1509,
- 25. Senator Latherow. 1534, Senator Rosander. 1541, Senator Newhouse.
- 26. Senator Newhouse was on the Floor a moment ago. Oh, it's been
- 27. passed. 1546, Senator Partee.
- 28. SENATOR PARTEE:
- 29. I gave you some misinformation. I think we are almost down
- 30. now to 1561.
- 31. PRESIDENT:
- 32. Oh, I'm sorry. 1561, Senator Kosinski. 1561.
- 33. SENATOR KOSINSKI:

- Mr. President, Senators. I would like to recall Senate Bill
- 2. 1561 to Second Reading for the purpose of amending, tabling
- 3. Amendment Number 1 and Number 2 and inserting Amendment Number
- 4. 3.
- 5. PRESIDENT:
- 6. Senator Kosinski takes Senate Bill 1561 back to Second Reading
- 7. for purpose of amendment. He moves to reconsider the vote by which
- 8. Amendment Number one and two were adopted for the purpose of tabling.
- 9. All in favor of the motion to reconsider indicate by saying aye. Contrar
- 10. minded. All those in favor of the motion to table signify by saying aye.
- 11. Contrary minded. Senator Kosinski offers Amendment Number three. Do
- 12. you wish to explain the Amendment?
- 13. SENATOR KOSINSKI:
- 14. Yes, Mr. President, Senators. Amendments . . . it amends, let's
- 15. see . . . lines 2 and 3 has the wrong date in the bill and we're
- 16. changing it to March 18, 1967. It also changes the language in
- 17. which Senator Horsley disagreed in the language that was written
- 18. in the bill. The bill now reads . . . means the wife if not
- 19. legally separated whose husband was a prisoner of war or a
- 20. person missing in action after marriage or any legitimate child
- 21. born during the period of time it's father was a prisoner of war.
- 22. Then it also takes out the appropriation \$40,000 that was inserted
- 23. in the bill.
- 24. PRESIDENT:
- 25. Is there any discussion? All in favor signify by saying aye.
- 26. Contrary minded. The amendment is adopted. Do you wish to return
- 27. for passage of the bill shortly?
- 28. SENATOR KOSINSKI:
- 29. Yes, I do. Thank you Mr. President.
- 30. PRESIDENT:
- 31. 1570, Senator McCarthy.
- 32. SENATOR McCARTHY:
- 33. Mr. President, I would like to move that that be committed to

- 1. the Committee on Education.
- 2. PRESIDENT:
- 3. Motion to commit this to the Committee on Education. All
- 4. in favor signify by saying aye. Contrary minded. Motion prevails.
- 5. Senator Kosinski is recognized on 1561.
- 6. SENATOR KOSINSKI:
- 7. Mr. President, Senators. Senate Bill 1561 amends the
- 8. scholarship article of School Code and provides for scholarships
- 9. for dependents and wives of prisoners of war or persons missing
- 10. in action. It also prohibits the removal of benefits once
- 11. accrued from the dependents even though the father returns or
- 12. reported deceased. This bill is a long time coming. I feel
- 13. that the wives of prisoners of war, and missing persons, the only
- 14. income they have Senators, are the allotment checks and to bring
- 15. up and raise children on an allotment check I think is pretty
- 16. difficult. I now make a plea that you vote this bill into law
- 17. and send it down to the House and that they would concur with
- 18. our vote and have the Governor sign the bill. I appreciate a
- 19. favorable roll call at this time.
- 20. PRESIDENT:
- 21. Senator Gilbert.
- 22. SENATOR GILBERT:
- 23. Well, I opposed this bill in committee. I think that it's
- 24. a laudable cause possibly that the Senator is advocating here. But
- 25. I feel in the light of the fact that we're attempting to phase
- 26. out the scholarships instead of creating new ones, that if there
- 27. are any of these people covered by this who are in need, that they
- 28. would be covered by the application of the Scholarship Commission.
- 29. It is my understanding that the families of prisoners of war
- 30. continue to draw the same income as if the person who is a prisoner
- 31. was still serving in the service. I see no reason why we should
- 32. pick out this group of people and give them extra attention if
- 33. their income is \$7,000 or less. Almost 100% of every person who

- applies to the Scholarship Commission is given a scholarship
- grant which they do not have to pay back up to \$15,000 a year.
- 3. About 75% of the applicants received a scholarship grant. The
- 4. sub-committee of which I was a member along with Senator Hynes,
- 5. Senator Newhouse and Senator Laughlin made a detailed study. We
- 6. had representatives of Scholarship Commission before us in
- 7. Chicago and Springfield here and we went into this matter of
- 8. tuitions and scholarships. I think that we are attempting to make
- 9. everything on the basis of need. I favor that. I'm for phasing
- 10. out many of our scholarships and putting them solely on need and
- 11. giving more money to the Scholarship Commission. If we're
- 12. going to add \$40,000, I think it should be given to the Scholarship
- 13. Commission. And I feel confident that every one of these people who
- 14. is in need of a scholarship, who is covered by this bill, would
- 15. receive such a grant from the Commission.
- 16. PRESIDENT:
- 17. Senator Mitchler.
- 18. SENATOR MITCHLER:
- 19. I have a question to ask the sponsor. Senator Kosinski, do you
- 20. know approximately how many prisoners of war and missing in action
- 21. persons are from the State of Illinois at the present time?
- 22. PRESIDENT:
- 23. Senator Kosinski.
- 24. SENATOR KOSINSKI:
- 25. Yes, I have that answer, Senator. First of all I wonder if I
- 26. could answer Senator Gilbert.
- 27. PRESIDENT:
- 28. Well, Senator Kosinski is entitled to close the debate. I
- 29. think right now you're restricted to responding to Senator Mitchler.
- 30. SENATOR KOSINSKI:
- 31. The statistics that were given to me by the Illinois Veterans
- 32. Commission up to now are 49 prisoners of war missing in action in
- 33. the great State of Illinois. Not all of these are married. We would

- estimate about 75% or 36 of them are married. There are 33 1.
- dependent children of prisioners of war and missing in action. The 2.
- estimated total of wives and children are approximately 69. 3.
- 4. PRESIDENT:

- 5. Senator Mitchler.
- 6. SENATOR MITCHLER:
- Well, Mr. President, members of this Senate, we're talking 7.
- about 49 prisoners of war missing in action in the State of Illinois 8.
- and as pointed out by the Senator, 36 of these are married leaving 9.
- behind 33 dependent children. Now anything that we can do to help 10.
- the wives and this Amendment Number 3 that Senator Kosinski put on, after
- consultation with Senator Horsley and myself, protects the fact that 12.
- it's the wife not legally separated who's husband was a prisoner of
- war missing in action after the marriage or any legitimate child 14.
- born before or during the time his father was a prisoner of war. 15.
- This is little we can do for these few people of our State and I 16.
- think, when you talk about the millions of dollars that is squandered in 17.
- the saloons and all that for the people who are not making any 18.
- sacrifice and who are not working or contributing in any way but living 19.
- off the fat that this Legislature appropriates, to deny that to those 20.
- people on any grounds would be a very wrong doing. I would urge 21.
- support. 22.
- PRESIDENT: 23.
- Is there further discussion? Senator Neistein. 24.
- SENATOR NEISTEIN: 25.
- I would like to ask the sponsor, Senator Kosinski. Since you 26.
- didn't consult with me but you only consulted with Senator Horsley 27.
- and Senator Mitchler . . . what crime has an illegitimate child committed 28.
- that your bill limits the aid only to the legitimate children of the 29.
- missing of action and the prisoners of war. Why do you differentiate? 30.
- Can you explain what crime a child has committed who is born 31.
- illegitimate? 32.
- PRESIDENT: 33.

- Senator Kosinski. 1.
- SENATOR KOSINSKI: 2.
- Well the child sure didn't commit a crime. Neither did the 3.
- ones involved. I don't . . . I haven't seen my Chaplain lately 4.
- and I haven't asked him about those things. 5.
- PRESIDENT: 6.
- Senator Neistein. 7.
- 8. SENATOR NEISTEIN:
- Well, Senator Kosinski, you can think of this as levity but I 9.
- think this is a serious question and I don't see the differentiation 10.
- that you're making, with all due respect to that great patriot, 11.
- Senator Mitchler, and consulting with Senator Horsley, and I want to 12.
- know where the logic is that you limit the amendment to legitimate children
- 13. and I want to again ask you what crime an illegitimate child has committed
- that he can't have a scholarship?

PRESIDENT:

- SENATOR LYONS: 18.
- Well I would just like to point out to Senator Neistein 19.
- that one reason, I don't know that this is a fact or not, but one 20.
- reason could be that in the case of illegitimate children there might 21.
- be some difficulty in determining whether or not the male parent 22.
- actually was in a prison camp. 23.
- PRESIDENT: 24.
- Senator Soper. 25.
- SENATOR SOPER: 26.
- Mr. President, would the Senator yield to a question? 27.
- 28.
- He indicates he will. 29.
- SENATOR SOPER: 30.
- I understand that your amendment states beside illegitimate 31.
- children not being able to receive this benefit that if a woman 32.
- is separated from her husband or divorced from her husband that the 33.

- child couldn't receive benefit of this scholarship. Is that true? 1.
- 2. SENATOR KOSINSKI:
- I wouldn't know the answer, maybe my . . . 3.
- SENATOR SOPER: 4.
- Does your amendment state that if the wife is separated or 5.
- legally divorced from the prisoner of war that the child cannot 6.
- receive the benefit of the scholarship? I'm not asking about 7.
- an illegitimate child, I'm asking about a child in a broken home 8.
- 9. or a divorced home. Does your amendment say that?
- PRESIDENT: 10.
- Senator Kosinski. 11.
- SENATOR KOSINSKI: 12.
- I'll hold the bill. I've got to get more information. 13.
- PRESIDENT: 14.
- Alright, the bill will be held. 1572, Senator Rock, hold. 15.
- 1563. Senator Cherry. 16.
- SENATOR CHERRY: 17.
- Mr. President, I would move to bring this bill back to 18.
- Second Reading for the purpose of presenting an amendment. 19.
- PRESIDENT: 20.

- 1563 is brought back to Second Reading for purpose of 21.
- amendment. Can you explain your amendment. 22.
- SENATOR CHERRY: 23.
- In substance it reduces the appropriation provided for Yes. 24
- is this bill by 2 million, three hundred and thirty nine thousand 25.
- dollars. It was the concensus of the Judicial Advisory Committee 26.

- 19. Is there further discussion? Secretary will call the roll.
- 20. Just a moment. Senator Horsley.

 to me that you could purchase 20 eight cent stamps and draft a letter

- 13. of a hundred thousand dollars. It was amended down, as I find in

- 5. was introduced to provide the drivers license with a picture on
- 6. the drivers license. All law enforcement agencies, the State's
- 7. Attorneys are for it and I think Senator Mitchler hit it on the
- 8. head. Instead of spending \$40,000.00, if Senators Carpentier and

- 25. I want to explain my vote. This bill got by me before I had
- 26. an amendment prepared for it and I can't blame anybody but myself
- 27. for that and it had been recommended that it be reduced by a considerable
- 28. amount not only by the Bureau of the Budget by those who had studied
- 29. this particular project and it didn't ring a bell with me until I got
- 30. back into some of my old files and started digging into what this
- 31. Commission did, the Medical Center group going back 8, 10, as much
- 32. as 18 years ago my file goes back on them and I now find they are
- 33. spending more money to acquire less than \$25,000 in actual acquisition

- than they spent in payroll to acquire more than a million dollars
- 2. in acquisition for hospital funds. This is one Commission that
- 3. could be done without, could be completely turned over to the
- 4. Department of Public Health and we could save this entire appropria-
- 5. tion because our study of it shows that it is overstaffed, it is over-
- 6. funded, there are mot enough duties for the people that are being
- 7. paid the salaries that are being paid. For that reason, I apologize
- 8. for not having the amendment ready. I wanted to cut this amendment
- 9. down to less than one half of the amount that it provides but I'm
- 10. forced to vote no.

- 30. Senator Dougherty has moved to suspend the rules for the purpose

- Senator Horsley. 33.

- 1. SENATOR HORSLEY:
- Did you ask his Secretary to set the bill and put it on the
- 3. notice?
- 4. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Dougherty.
- 6. SENATOR DOUGHERTY:
- Senator, I do not know Senator Chew's Secretary. I've never
- 8. appeared before that Committee before.
- 9. PRESIDING OFFICER: (SENATOR ROCK)
- 10. Is there any further discussion? Secretary will call the roll.
- 11. The motion is for leave to suspend the rules for the purpose of
- 12. hearing S.B. 1589 in the Committee on Transportation, Thursday, June
- 13. 1st at 9 o'clock in the morning. Secretary will . . . Senator Berning.
- 14. SENATOR BERNING:
- 15. Well I'd like to ask a question then, perhaps the Pro Tem is

- 25. SENATOR GROEN:
- 26. Call the roll.
- 27. PRESIDING OFFICER: (SENATOR ROCK)
- 28. Senator Carpentier.
- 29. SENATOR CARPENTIER:
- 30. We just had a similar situation and its very unfortunate the
- 31. Chairman isn't here and as the Pro Tem explained I see nothing wrong
- 32. with waiving the six day notice on this matter and I think it could be
- 33. heard Thursday and then it's in Committee that we really hear testimonies

- on bills. I don't see anything wrong with that.
