Mr. Chairman, I would hope that the action I am about to take would not be misconstrued as anything other than what it really does. I'm filing a motion to discharge two bills from a committee. A committee which has not yet, mind you, voted a Do Not Pass Motion on those bills. These are the two bills that relate to the mass transportation problem in our State which are for convenience I suppose, referred to as the CTA Bills, and those bills were in the Transportation Committee yesterday and a motion was made and passed, to hold the bills in the committee. I do not say that the chairman or any person in that committee has any desire to hold them for any inordinate period of time. I'm just simply saying to the world that we are filing a motion to discharge, which motion we will not argue until it becomes necessary to argue it, but we want the world to know and particularly those people who depend on transportation of a mass nature throughout this State, that we are concerned and that we are doing everything possible to bring about a climate of travel for them and to help those agencies which provide the transportation for them. So I'm filing that motion on that basis.
