- 3. sible Amendments, that they would contact me today so that we can
- hopefully work this...work out some appropriate wording. So,
- I will call this Constitutional Amendment for passage tomorrow.
- 6. PRESIDENT:
- 7. I think it is important for the members be aware of the point
- that Senator Rock has just made. Tomorrow, on the order of
- 9. Constitutional Amendments on Third Reading, this important consid-
- 10. eration will be before us. I think the members are now on ade--
- 11. quate notice; that if they do have suggestions or changes; that
- 12. they should work on those the remainder of today and tonight, and
- 13. place them in Senator Rock's hands in advance of consideration
- 14. tomorrow so that we can orderly consider this important matter.
- 15. It is appropriate that this decision be arrived at and so far as
- 16. the sense of the Senate is concerned, this week and that if in
- 17. fact we adopt it, it should go to the House this week, so that
- 18. they will have time to consider it and take action on it in ad-
- 19. vance of the Constitutional Limitation that will require its adop-
- 20. tion prior to May 5th, I believe. On the Constitutional Amendment
- 21. consideration of six months prior to the General Election at which
- 22. the amendment would be responded to in public referendum. That
- 23. is an important matter and we are now on appropriate notice in
- 24. regard to it.
