- 22. 17 million transfer. The House in its wisdom saw fit to amend
- 23. the bill to make it a total deficiency of 67 million dollars.
- 24. That is the affect of amendment No. 1... House Amendment
- 25. No. 1 to Senate Bill 1421. At this time, Mr. President, I
- 26. would move to suspend the appropriate rule. I believe that this
- 27. matter is to lie on the Secretary's desk for a day under our

The actual cost of collection is 5. estimated to be in the neighborhood of 1.3% and we're presently 6. charging those municipalities and counties 4%. The fiscal impact 7. would be in the neighborhood of 6 million dollars. 8. PRESIDENT: 9. Senator Netsch. 10. SENATOR NETSCH: 11.
