- 4. have removed limitations completely, some time limitations that
- 5. were in the bill, for the issuance of notes and mortgages. And,
- 6. I got together with our staff and Senator Partee's staff and we
- 7. put some limitations back in again. That the...I'd a felt that
- 8. they could live with but we did not want to provide the kind of
- 9. open-ended bill with no time limitations that they had proposed.
- 10. So, the amendment that I would offer is Amendment No. 1 essen-
- 11. tially makes some time...gives them a little more time to
- 12. issue mortgages but doesn't give them an open-ended blanket
- 13. permission to do it whenever they want and I would move the
- 14. adoption of Amendment No. 1 and if anybody wants more detail on
- 15. it, I'd be happy to provide it.

- 17. Senator Knuepfer, the bill has not been read. I...I'd
- 18. really inquired whether the sponsor did want the bill called.

- 2. adopt Amendment No. 1. All in favor signify by saying Aye.
- Contrary no. The motion carries and Amendment No. 1 is adopted.

- 5. I'm sorry, I didn't see a response.

- Amendment No. 2 by Senator Partee.
- 8. PRESIDENT:
- 9. Senator Partee.
- 10. SENATOR PARTEE:
- 11. Now, this second amendment was given us by the department,
- 12. IDA. They say that they want to change the interest rate on
- 13. the notes and bonds from the current rate of 7% to 8%. They say
- 14. that the rate of 7% is not competitive in the bond market and
- 15. they have 130 million dollars in bonds due in December. And,
- 16. they need to sell new bonds to pay off those that are maturing
- 17. in December and this simply raises the rate from 7% to 8% to
- 18. make it competitive, to make them saleable. And, I'd ask for
- 19. the adoption of the amendment.
- 20. PRESIDENT:
- 21. All right. Senator Hall and then Senator Kneupfer. Senator
- 22. Hall, Harber Hall.
- 23. SENATOR HALL:
- 24. Well, Mr. President and fellow Senators, I have some
- 25. hesitancy to support several bills introduced to raise the
- 26. maximum rate on tax exempt securities from 7 to 8 percent in
- 27. this General Assembly. I recognize there is a drouth of
- 28. money and we're all competing for it from various angles and
- 29. aspects. One of the reasons there is a shortage of money is
- 30. that we in government continue to proliferate the concept of
- 31. tax free securities through the bond measures and drainage of
- 32. this drains off sizable amounts of money. So that the free
- 33. ...the free contracting for money becomes limited and where you

provide the tax exempt basis, you in effect are saying to those who hold vast amounts of money where their tax rate is 2. at 50% going in. When you offer these rates you are saying that 3. an 8% rate is the equivalent of 16% to the ordinary investor 4. and you make it very attractive and that makes the use and the 5. availability of money by the ordinary citizen all the more 6. expensive. Now, I don't know how important this is to the function of this agency but I know that there are some tax exempts being sold now at 7% and maybe we ought to consider 9. leaving it there until a more definite need is exhibited. So, 10. I...I think I will just have to oppose this on that basis at 11. this time. 12.

14. Senator McCarthy do you wish recognition? All right.

Well, I... I want to say that I support Senator Partee's

amendment. I did not include it as a part of the omnibus be-18. cause the other provisions in the amendment that I introduced 19. 20. were of a different nature. This was as well a new proposal by IDA. They came to us at the last moment and asked for this. 21. 22. I think it's got to be, I know that I don't agree with some of you on this but I...it is my own position and has been for a 23. long time that the market determines the rates nothing else and 24. if...even if you take a contrary position, I suggest that the 25. 26. problem that you may leave the Illinois Housing Development Authority with is without funds to support housing of some people 27. who need it very desperately. We did set up IDA some years ago 28. to provide housing. If it can't get money, it can't get housing 29. and nobody's going to lend IDA money at a lower rate than they 30. could get anywhere else. So, in this I certainly support what 31. Senator Partee is trying to do. 32. PRESIDENT: 33.

Senator McCarthy.

1. SENATOR McCARTHY:

- Yes, Mr. President, I don't like to speak in opposition
- 3. to an administration bill and one that's handled by my leader
- 4. but I must speak against this amendment because what we are
- 5. doing here is continuing the merry chase upwards of one set
- 6. of interest rates chasing upwards another set of interest rates.
- 7. And, it strikes me that sooner or later somebody, either indi-
- 8. vidually or some elective body, has to say stop. Now, what do
- 9. I mean by interst rates chasing each other upwards in a spiral.
- 10. I think the phrase has been defined many times by people more
- 11. expert than myself. But within the memory of a majority of
- 12. the members of the branch of this Legislature, the Senate, we
- 13. have seen, session after session, a raise in a interest rate on
- 14. a tax exempt such as this being put on. It was put on in 1969.
- 15. Senator Arrington first opposed it and finally agreed to a 1%
- 16. increase. Excuse me. Senator Arrington agreed to a 1% increase
- 17. for a period of one year and we've stepped...we've kept with that
- 18. proposition that the...any type of an increase from 6 to 7 per-
- 19. cent on the tax exempt go for a one year period only and it's
- 20. come back here for renewal each and every time so we, as elected
- 21. officials, take a hard look at it. Now, Mr. President and
- 22. Members here, we've seen this happen and that the next session
- 23. comes in...well, then they...they want other rates to go up and they
- 24. use as the basis, they say why tax exempts now are legally sale-
- 25. able at 7%, therefore, we need more on the general interest rate.
- 26. And, during the last session, Mr. Session...Mr. President, the
- 27. small loan industry used that type of argument and was able to
- 28. push through this branch of the Legislature and increase in the
- 29. small loan interest rates on the top five hundred dollars from
- 30. 12 to 18 percent. So, it strikes me that what we must bite the
- 31. bullet sooner or later. If IDA can't market their bonds, it's
- 32. too bad. If it becomes a critical matter then, of course, the
- 33. Governor can call us into extraordinary session. But we're here

- 1. to consider budgetary and appropriation and revenue matters
- 2. only. And, this matter, in my opinion, is outside of the
- 3. scope of the rules that were set down by this session, should
- 4. not be considered and should, I think, be rejected by this
- 5. Legislature at this time.
- 6. PRESIDENT:
- Is there further discussion? Senator Fawell.
- SENATOR FAWELL:
- 9. I have a question for Senator Partee. Senator, in regard
- 10. to this bill, are we talking about, basically, revenue bonds or
- 11. are we talking about general obligation tax bonds?
- 12. SENATOR PARTEE:
- 13. Yeah, no, they are general obligation bonds only to IDA,
- 14. not to the credit of the State.
- 15. SENATOR FAWELL:
- 16. But, they're supported by...by a tax levee then. Is that
- 17. right?
- 18. SENATOR PARTEE:
- 19. No, no. IDA has no taxing authority.
- 20. SENATOR FAWELL:
- 21. Well, how are the bonds...they're paid off by means of
- "22. revenue then. Is that it? The reason I ask...
- 23. SENATOR PARTEE:
- 24. Well, the person to whom the loan is made has to make the
- 25. repayment.
- 26. SENATOR FAWELL:
- 27. Well, these...this is strictly conventional...loans then...
- 28. SENATOR PARTEE:
- 29. That's correct.
- 30. SENATOR FAWELL:
- 31. I see. All right. I...I misunderstood. I...I was assuming
- 32. we were talking about either revenue or the general obligation
- 33. bonds. I do want to point this out, that every session in the

- 1. last, I think, three or four years we have consistently come back
- and had to renew and bring those...those interest rates back up.
- 3. And, I know on several occassions, we've found ourselves out of
- 4. session and Chapman and Cuttler being really deeply concerned in...
- 5. now I'm talking here about other types of interest rate, I realize,
- 6. but I think the same thing holds true here. I tend to agree, other
- 7. words, with what Senator Knuepfer has said, that the market place
- 8. does indeed set the interest rate and unless...unless it can be
- 9. shown that there is a conspiracy among lenders in regard to interest
- 10. rates which I have not found to be true. We are finding, I think
- 11. instead, that there are an awful lot of people who simply are no
- 12. longer getting mortgages and loans because of the...what truly is
- 13. artificiality right now insofar as interest rates are concerned.
- 14. My tendency would to to support...
- 15. SENATOR PARTEE:
- 16. Well, Senator, you're very right. The only reason that they're
- 17. going to eight is because of the competitiveness of the market.
- 18. The rate here has not been changed since 1967 and they have, within
- 19. that seven years, been able to continue to operate at that level.
- 20. It's now impossible and that is why they are...the request for
- 21. eight percent.
- .22. PRESIDENT:
- 23. Senator Dougherty.
- 24. SENATOR DOUGHERTY:
- 25. Mr. President and Members of the Senate, I want to join with
- 26. Senator McCarthy, as you have known for many years, we have been
- 27. the opponents of high interest rates for a long time. And, the
- 28. part of the argument of...advancement by. Senator Hall rates true
- 29. that this 8% was a...is equivalent to 16% to the private investor.
- 30. And further, I believe, that there is a conspiracy between lending
- 31. agencies to keep the interest rates high. There is no reason
- 32. why we have to pay these interest rates this high. The money
- 33.

- is available and it's here. But they're just doing what they

 did in the energy crunch. It's an excuse.
- 3. PRESIDENT:
- 4. Is there further discussion? I'm going to recognize Senator

To say that this is a departure 12. from...from what ought to be is, I think, not taken into consi-13. 14. deration the tone of this time. Now, we aren't doing this be-15. cause we want to. This interloper from Minnesota 5. 6. and Berkeley, California who was refused by the Illinois Senate 7. as Director of Corrections, was hired by the Governor of this 8. State to be his chief advisor and the Director of the Illinois Law Enforcement Commission. True to his form, his pattern 9. 10. that has been adopted by him in the past; he is saying now that 11. unless drastic changes are made in the prison systems, we 12. will experience unprecedented violence in the fortress prisons 13. of the State of Illinois. He said guards and inmates are 14. deeply alienated from each other and their operations are 15. hampered. Never in my life have I seen a peddler of violence 16. get so much press as this gentleman who is, at least, if he's not devious, his actions certainly are suspect. Destruction and 17. 18. chaos has followed this fellow from...from his outset in...in corrections. And, he's predicting violence. He predicted it in 19. 20. California and he helped with it and they had it. He is saying 21. also, so you people that are going to be contacting the taxpayers, 22. that he thinks we ought to pay a prevailing wage. He thinks we ought to end male censorship. If he'd quit causing trouble 23. 24. and find out that's been...been ended already. He wants a more 25. extensive furlough program. He wants a system of victim compen-26. sation, conjugal visits, open access area for the press, a con-27. tract system for parolees and use of adversary and appeal pro-28. cedures for parole revocation processes. The operational model of this thing is going to be studied by this thirty-five or 29. 30. forty thousand dollar a year man that was refused by this Senate on a little furlough he's going to take to Harvard University 31. this year to find out how they do it out there just before they 32.

I'm not condemning the Sun Times; they're merely reporting the

news. But, the remarks of Dr. Fogel are such that when they're

read within the confines of a state prison, as they are read,

- 1. they exacerbate a difficult situation already. These are the
- 2. kind of remarks, Mr. President and fellow Senators, that can
- 3. bring on an Attica type situation. Now, I'm not...I'm certain
- 4. in my own mind that Director Fogel has the interest of society
- 5. at large. But, when he addresses remarks like this that inflame
- 6. inmates, that polarize guards and polarize the administration,
- 7. then he is driving us to a situation that's going to cause a
- 8. tremendously difficult area in the area of corrections.
- 9. support Senator Graham's remarks. I'm absolutely appalled at...

- 32. cipal sponsor, with one exception. It does not...the current bill,
- 33. 1242, does not permit advanced payment of these...of the reim-

- 1. bursement to the mass transit carriers. The custom and the
- 2. procedure in the state throughout the existence of this program
- 3. has been one of flexibility allowing the State to make an
- 4. advance payment based upon hard data from previous quarters and
- 5. thereby enable the...the state to be of assistance in helping
- 6. with the serious problems that mass transit carriers are enduring
- 7. at the present moment. In effect, what is happening or what
- 8. would happen under this bill without the amendment that I am
- 9. offering here would be that the carriers would be obligated
- 10. to bear the loss from the reduced fare for a period possibly
- 11. as long as four months. And, in the critical situation in
- 12. which most mass transit carriers find themselves. This is a very
- 13. serious problem. This will not involve any additional monies.
- 14. It will simply allow the State to make the payment at an earlier
- 15. date. And, I would move the adoption of the amendment.

- 17. Senator Scholl.
- 18. SENATOR SCHOLL:
- 19. Mr. President and Members of the Senate, my bill is not a
- 20. give-away program and I am against this amendment. This
- 21. language was deliberately left out of both of these bills.
- "22. Evidence by admission of some of the districts of requests for
- 23. in receipts of money in excess of varifiable student passengers
- 24. resulted in some districts not being eligible for money last
- 25. year. DOT is attempting to correct abuses and requests for such
- 26. funds and the CTA has been a source of considerable difficulty
- 27. regarding students with other avenues of assistance, purchasing
- 28. of service, contracts with RTA, federal operating assistance.
- 29. The quarterly payment should be sufficient to obviate the need .
- 30. for advanced payments. Even in the CTA payments, on a quarterly

- 33. get the entire yearly allotment at the start of the year. Adjust-

- 1. ment periods would extend into the next fiscal year, if permitted.

- 18. tial period of time to be reimbursed for that service and the
- 19. State is in a much better position to enable these carriers to
- 20. avoid these day to day crises and this is one significant factor,
- 21. one significant addition, to the State's support for mass transit.
- 22. I think that it should not have been a controversial matter at
- 23. all because it has been the policy of the Department of Trans-
- 24. portation since the very beginning. And, I would ask that the
- 25. Members of this Body support this amendment.
- 26. PRESIDENT:
- Senator Conolly.

- 29. This legislation that we have provided for in this bill
- 30. provides as a pay-as-you-go proposition not payment in advance and
- 31. I think that this should not be a grant program. This should be,

- 23. SENATOR BARTULIS:
- 24. Thank you Mr. President and Members of the Senate. In rela-
- 25. tion to SB 589, the conference committee report that the House
- 26. would recede from House Amendment No. 2. And, by deleting on
- 27. line 12, on page 5, "1974", and therefore, inserting "1975".
- 28. And, I would like to have the Senate concur with the conference
- 29. committee report on SB 589.
- 30. PRESIDENT:
- 31. Is there further discussion? The question is shall the
- 32. Senate adopt the conference committee report on SB 589. Senator
- 33. Rock.

- 1. SENATOR ROCK:
- 2. Well, Mr. President, I don't...I don't mean to get too
- 3. picky, I would...I would not like to invoke rule fif...Senate
- 4. Rule 56 which concerns itself with conference reports. On the
- 5. other hand, it seems that it would not be at all untoward for
- 6. US to see a copy of it or have a little hit more evaluation
- us to see a copy of it or have a little bit more explanation
- 7. of the substance of the bill.
- 8. PRESIDENT:
- 9. Yes, Senator Rock, is your question whether Rule 56 applies
- 10. to SB 589?
- 11. SENATOR ROCK:
- 12. It was...it was not so much the question, Mr. President, it
- 13. was just the suggestion that it might. I did not mean to invoke
- 14. it, nor will I. My suggestion was that there...any time there's
- 15. a conference committee, there are usually members from both sides.

 16. I did not hear any member from this side who was on that conference
- 17. committee stand up and say this is what it did or what it should
- 18. · do...
- 19. PRESIDENT:
- 20. Well...
- 21. SENATOR ROCK:
- 22. ...or what it proports to do.
- 23. PRESIDENT:
- 24. Well, all right. Well, le...let's have the Secretary, then,
- 25. read the conference committee report and note who the signators
- 26. are. Senator Partee.
- 27. SENATOR PARTEE:
- 28. I would make the further suggestion that conference reports
- 29. really ought to be printed and put on everybody's desk. But, if
- 30. in these last moments, that is not possible, at least, I think a
- 31. copy of the conference committee report ought to be brought to...
- 32. PRESIDENT:
- 33. Your point...

- 1. SENATOR PARTEE:
- ...leadership on both sides.
- 3. PRESIDENT:
- 4. Your point...I think your point is quite valid. Yeah, do
- 5. you not have a copy of the conference committee report, Senator
- 6. Partee?
- 7. SENATOR PARTEE:
- 8. Yes, because...you know we used to have the rule, not...
- 9. sort of informally, that before we agreed it down there, it
- 10. ought to be signed by leadership on both sides.
- 11. PRESIDENT:
- 12. Yes, Senator Bartulis, I think, is bringing you a copy of
- 13. the...of the report. Let's take this bill out of the record for
- 14. now and we can proceed to some other business. Senator Bell,
- 15. do you have a matter on the Secretary's desk?
- 16. SENATOR BELL:
- 17. Yes, Mr. President and Members of the Senate, in relation
- 18. to SB 210 and the House has suggested an amendment to it. I would
- 19. suggest the Senate concur to that amendment. `It...merely makes
- 20. the bill, the thrust of the bill nondiscriminatory, so that
- there is no question in reference to...discrimination in reference
- 22. to this. If you look at the title of the bill in your Senate
- 23. Calendar, you'll see that it requires, this is certainly not
- 24. true, actually, it should be permissive. It's permissive legis-
- 25. lation for the junior colleges to provide classes in physical
- 26. education and be able to receive state funding, as in any other
- 27. course. I would ask for a favorable roll call.
- 28. PRESIDENT:
- 29. Senator Soper.
- 30. SENATOR SOPER:
- 31. Now, as we pass the bill out of here, what's the bill do
- 32. and what ... and what is the amendment...do?
- 33. PRESIDENT:

- l. Senator Bell.
- 2. SENATOR BELL:
- З. Senator, the amendment addresses itself to line 24 of the
- 4. That reads this way: "Each Junior College District may
- require physical education activity courses for credit toward 5.
- graduation or certification." The amendment goes on to say, 6.
- 7. "but such courses shall be made available on an equal and non-
- discriminatory basis to men and women." 8.
- PRESIDENT: 9.
- 10. Senator Soper.
- 11. SENATOR SOPER:
- Now, you say this is permissive? 12.
- PRESIDENT: 13.
- Senator Bell. 14.
- SENATOR BELL: 15.
- 16. That ... that is right.
- SENATOR SOPER: 17.
- 18. I...and it's...it's a credit course, providing the junior
- college wants to put it in, and...and...be funded on this course. 19.
- 20. SENATOR BELL:
- 21. The junior college has the right to determine whether they, in
- fact, want to require physical education in that particular system 22.
- towards a...the 60 hours that are necessary for...for what...for the 23.
- graduation or certification from that particular junior college 24.
- system. It's a permissive thing for that particular junior college 25.
- system. 26.

- SENATOR SOPER: 27.
- Now, Mr. President and Ladies and Gentlemen of the Senate, 28.
- recently Morton Junior College funded it's junior college and out 29. of the funding was cut the appropriation for a gymnasium.
- refused to fund a gymnasium. Now what...now what do we do to...to 31.
- fund this situation? When you bring in a bill like this now they... 32.
- they want...they want a gymnasium to be able to have this course. 33.

- Now what do we do? Will this require that the Capital Development l.
- 2. Board and the Junior College Board fund this...this project?
- SENATOR BELL: 3.
- 4. If I might reply, Mr. President.
- 5. PRESIDENT:
- 6. Proceed, Senator Bell.
- 7. SENATOR BELL:
- Well, the bill, Senator, doesn't address itself to the 8.
- 9. Capital Development Board in the funding of gymnasiums.
- ...it's my understanding the interpretation of the bill and all, 10.
- 11. that it has no bearing on that particular situation.
- SENATOR SOPER: 12.
- 13. Yes, but it comes to my mind now, suppose the ... suppose the
- 14. . students and the junior college decides that they...that they
- 15. want to have an accredited course for...for...for this...for
- 16. this type of course. And, what do we do to get...to be able to
- 17. build this? We passed...we passed a bond issue which included
- 18. our part and we wanted the three-quarter funding from the...from

- Mr. President. 25.
- 26. PRESIDENT:

- 27. Senator Bell.
- SENATOR BELL: 28.
- This is merely a concurring amendment. It's a simple amendment. 29.
- We passed the bill out of the Senate. It's been passed out of the 30.
- House and, I mean it can go to a conference committee, I suppose, if 31.
- you want to do that. All I can say is that the bill has no relation-32.
- ship to building football stadiums or fields or ... or what have you, 33.

- 1. Senator Soper, and I...be my recommendation that we roll this
- bill right now. Either vote it up or vote it down, as far as

- 4. PRESIDENT:
- Senator Rock sought recognition earlier. Senator Rock.
- 6. SENATOR ROCK:
- Thank you Mr. President. I will yield to Senator Bruce.
- 8. I think he and I...
- 9. PRESIDENT:
- 10. No, I'm...I'm...
- 11. SENATOR ROCK:
- 12. ...our comments are essentially the same.
- 13. PRESIDENT:
- 14. I'm...I'm keeping track of...of Senators in the order they
- 15. seek recognition. Senator Fawell, then Senator Buzbee, then
- 16. Senator Bruce. Senator Fawell.
- 17. SENATOR FAWELL:
- 18. Yes, Mr. President, this bill, some of you may recall, did
- 19. bring about a lot of pros and cons last year. In its initial
- 20. introduction, it was mandatory and those who are interested in
- 21. physical education courses were hopeful that it would be a man-
- 22. date that you had to have this; so many hours of credit before
- 23. one could be graduated. The compromise that was reached was
- 24. that it became discretionary for the particular junior college
- 25. district in concern, and on that basis, I think, it was rather
- 26. unanimously approved by the Senate. When it went over to the
- 27. House, the amendment that was attached there was one that simply
- 28. states that, in regard to these courses, they should not practice
- 29. sex discrimination. So, that, I think, in its present state,
- 30. it is a bill that is acceptable to both the pros and the cons
- 31. that...who felt quite deeply on this subject during the last year.
- 32. PRESIDENT:
- Senator Buzbee.

SENATOR BUZBEE:

l. Thank you Mr. President. Mr. President, I'd like to start 2. by saying that last week or the week before, when we discussed 3. this bill, I spoke in behalf of it and I made a statement at 4. that time that was not quite correct and I...I'd like to correct 5. that now. Unfortunately, I was reading from the original version 6. of the bill and not the amended version. At that time, in the 7. original version, of course, it was mandatory. It is not manda-8. tory now, As Amended, as Senator Fawell correctly pointed out. I 9. just wanted to get that point out to correct the record. As far 10. as my statements, a couple of weeks were concerned...a couple of 11. weeks ago, were concerned in response to Senator Soper's question 12. of Senator Bell, it's my understanding that these junior colleges 13. would be allowed, if they so saw fit, to require physical educa-14. tion courses, and then at that time, they would be reimbursed 15. at the same per hourly rate as other academic courses in the 16. junior college from the State. Now, if they decide, as an example, 17. if they have a...do not have any kind of an indoor physical 18. education facility, and they decide that they do want to require 19. courses, they're, naturally, only going to be able to require 20. those kinds of courses that would not require a facility. Now, 21. it may be that they'll come in and ask the...the bonding authori-22. ties to...to let them build the building, to do such as that. 23. However, at that time, I think it's...they're going to have to 24. be in line with everybody else. Just get in line and wait your 25. turn. There are all kinds of physical education courses, of course, that can and, in fact, are being taught everyday by high 26. schools and junior colleges, and...and...universities that 27. did...do...do not require indoor facilities. They might use a 28. local bowling alley. They might use local tennis courts, outdoor 29. 30. recreational fields, and so forth. So that, I think, although the question, Senator Soper, that you raised is very germane, it really 31. doesn't have anything to do with this particular bill. And, again, 32. I would...I would close by saying, on the sex discrimination thing, 33.

- 1. I know there were some hang ups on that...that only pertains
- 2. to courses, to physical education courses, it does not pertain
- 3. to who gets to play quarterback on the football team or extra-
- 4. curricular activities. And, again, it simply is beyond me, how,
- 5. in this day of the high rate of heart attacks...and...and so
- 6. forth, that when we have the Vice-President of the United States
- 7. saying, "yes, we need..." and the President of the United States,
- 8. consistently, the last three or four Presidents saying, "We need
- 9. to have our youth better physically fit," I simply don't see how
- 10. we can let this opportunity go by which simply says that the junior
- 11. colleges, that they see fit, the administration of that particular
- 12. junior college, sees fit to require physical education in their
- 13. particular college. I don't see how we can let this opportunity
- 14. go by. And, as Senator Fawell and Senator Bell both pointed out,
- 15. correctly, that we have already passed this bill. The only thing
- 16. we're really talking about now is whether we're going to concur,
- 17. I guess, on the House amendment. And...and, I think, that we...
- 18. we owe it to ourselves to vote "Yes" on this bill.
- 19. PRESIDENT:
- Senator Bruce.
- 21. SENATOR BUZBEE:
- "22. And, to our children.
- 23. SENATOR BRUCE:
- 24. Yes, I wonder if the sponsor would yield to a question.
- 25. PRESIDENT:
- 26. Indicates that he will yield. Proceed.
- 27. SENATOR BRUCE:
- 28. Senator Bell, a lot has...a lot has been said about volun-
- 29. tary action on the part of the junior colleges around the State.
- 30. If they do pass this program, does the State have the option of
- 31. not paying \$18.50 for every full-time equivalent student, or is
- 32. the State mandated to pay that cost for physical education courses
- 33. approved by the Junior College Board in the respective district?

- 1. PRESIDENT:
- Senator Bell.
- 3. SENATOR BELL:
- 4. Well, I hate to reply with a question, Senator Bruce, but
- 5. is the State mandated to pay what it's obligated to pay for an
- 6. English course or...
- 7. SENATOR BRUCE:
- 8. It...it...it certain...it certainly is, Senator Bell.
- 9. SENATOR BELL:
- 10. ...this would be under the same basis.
- 11. SENATOR BRUCE:
- 12. So, when we've been talking about voluntary, we're not talk-
- 13. ing about voluntary payment on our part. We're talking about
- 14. mandating the State of Illinois to pay every junior college
- 15. that offers an accredited physical education course. Is that
- 16. correct?
- 17. SENATOR BELL:
- 18. The same as for...English...or an education course, or...
- 19. SENATOR BRUCE:
- 20. Right. All right. That's the point we should be stressing
- 21. here...not that the fact...
- 22. SENATOR BELL:
- 23. The point was stressed last...you know...last March or April.
- 24. SENATOR BRUCE:
- 25. Well, my memory sometimes escapes me, and March was a long time.
- 26. The point I want to make to all the Members here is that we're not
- 27. talking about a voluntary payment program where the State of Illi-
- 28. nois will decide what they want to pay. We have, presently, in the
- 29. junior colleges around the State of Illinois 114,000, give or take
- 30. a few, full-time equivalent students. Now, if they were to enroll
- 31. and I would point out this, it is voluntary on the Board; however,
- 32. they may mandate it to the student. If they require every full-
- 33. time equivalent student to attend, that would cost \$2,100,000 on this

- 1. year's formula. I would apprize all of you that the formula goes
- 2. up and it will go up to about 2,500,000. This is not approved by
- 3. the Board of Higher Education. I do not think it's approved by the
- 4. Junior College Board. It is not in their budget, which I handled
- 5. last year. It is not in the budget which I'm handling this year.
- 6. I alert every Member here who has a junior college district with...
- 7. within their legislative district, that if this bill passes and the
- 8. board takes affirmative action to begin the program and they do
- 9. ask for payment from the State, which I'm positive they will, the
- 10. state aid formula says that claims will be apportioned for those
- 11. colleges that have facilities available whether on campus or off.
- 12. They will short-change every other junior college in the state
- 13. by the amount they receive through this piece of legislation and
- 14. that is undeniable. That is the effect of this bill. It does
- 15. not remain voluntary. It is mandated to the State that we pay the
- 16. bills, if they submit it, for every full-time equivalent student
- 17. who enrolls in a physical education course, which can be required
- 18. by the junior college board in that district. And that...that...
- 19. for that reason, I oppose this bill.
- 20. PRESIDENT:
- 21. Senator Mitchler.
- 22. SENATOR MITCHLER:
- 23. Mr. President, and Members of the Senate. Senator Bruce, you
- 24. are absolutely correct on...in what you point out here, and I commend
- 25. you for that. I point out that SB 210 passed the Senate on May 19th
- 26. by 34 Yeas, and 4 Nays...(Indicating a number did not express their
- 27. vote either way.)...I recall this, back at that time, and it did
- 28. pass in amendatory form. The amendment that we are working on now .
- 29. makes it permissive to enter into the program. I will speak on
- 30. that first. Instead of mandatory, by making it permissive, is just
- 31. getting your foot in the door. It's like...like the camel getting
- 32. its head under the tent, and then its feet, and then the rest of
- 33. its body, and the first thing you know, you've got the whole camel

- in the tent. And, that's exactly what, you've seen it by 1.
- 2. program after program after program. Now, I was very proud
- to be in this Senate in 1965 when we passed the Junior College 3.
- 4. Act. I've been very proud of the progress that we've made
- 5. in our various junior college programs. Junior colleges need
- 6. money. When I meet with them and I meet with them often, just
- as each and every one of you do. They need money for many, many 7.
- 8. things. But what this will lead to, and I don't get a lot of heat
- 9. from them that they really want this, only a certain segment of
- 10. the school. But, if you let this go through with a permissive,
- you're going to find that they interpret that as a mandatory. 11.
- 12. Instead of working with students in the local area so that they
- avoid the necessity of a person having high-cost housing in a 13.
- State University away from their home. You'll find that they'll 14.
- 15. be bringing into this state, from out-of-state, these high-priced
- 16. atheletes, and don't tell me they won't, because I can show you
- 17. college right now that are vying for all that publicity so
- 18. they get the baseball teams, the basketball teams. And, first
- thing you know, you'll be wanting to put that astroturf on their 19.
- 20.
- stadium floor. Now, this is a step in the wrong direction.
- not exactly what we need. They can have physical instru...physical
- ~22. education courses out there and ... and go through these motions.

- intramural activities, but, I think, that the facilities that they 23.
- build should go into things for higher learning. There's one 24.
- good thing about this amendment and that is that they've eliminated `25.
- any discrimination between sexes, as far as the sports, in...in the 26.
- colleges...the junior college program. That's something that we 27.
- battled with the Illinois High School Athletic Association for 28.
- many, many years. And, they turned their backs to us because 29.
- 30. they have the Girls' Athletic Association and that was satisfactory
- as far as they're concerned. You're seeing a great abundance of 31.
- young girls in our high school programs come up, and that's a 32.
- good thing on...with the amendment. But this idea, just because 33.

- 1. it's permissive, isn't going to get my vote. It did not get my
- 2. vote and you can check your May 10th digest, rather Senate
- 3. Journal on...and you have it right there, 34 to 6, and I'm
- 4. going to tell you to take a good look at this or you'll regret
- 5. the day you slipped this through.
- 6. PRESIDENT:
- Senator Hickey.
- 8. SENATOR HICKEY:
- 9. Of course, I'd like to be for this amendment because it's
- 10. for doing away with sex discrimination. But, since I wasn't
- 11. here on May 10th and I didn't have an opportunity to vote
- 12. against this bill. I'm going to vote against the amendment as
- 13. a vote against the bill. And, this is my reason. All education
- 14. is moving, whether we like it or not, toward free choice. Man-
- 15. datory physical education for high school age students, I think,
- 16. is a good thing. But, in junior college, the average age of the
- 17. student is very often high in the twenties and to...even to
- 18. permit the colleges, again, to mandate students to have to take
- 19. physical education, I'm opposed to. Thank you.
- 20. PRESIDENT:
- 21. Senator Bell. Senator Berning.
- 22. SENATOR BERNING:
- 23. Thank you Mr. President. I... I would like to point out to
- 24. the Members of the Body the way this appears to me. The bill as
- 25. originally passed, did mandate, actually mandate, the junior
- 26. colleges to embark on physical educational programs in order to
- 27. be qualified. This amendment, which the House has put on, strikes,
- 28. for all intents and purposes, the entire Senate Bill 210 and
- 29. replaces it with Section 216 rather than 215. And, inserts in
- 30. that section the permissive provision for physical education.
- 31. Now, we're at this point, many of us do not feel physical education
- 32. is a necessary adjunct to junior college life. Bearing in mind,
- 33. that a vast majority of those attending junior college are already

- 1. adults, attending on a part-time basis. This, then, would make
- provision only for those just out of high school, essentially,
- 3. who are full-time students. Vocational education is their
- 4. primary objective, or ought to be, only in a very limited sense
- 5. are they preparing for the senior college. Keeping that in
- 6. mind, along with the shortage of funds for junior colleges, it
- 7. would appear that the sensible procedure for this Body is to
- 8. reject this amendment, thereby, forcing it into a conference
- 9. committee, and perhaps, we can successfully eliminate any
- 10. implied requirement for physical education for funding for the
- 11. junior colleges, which is what I interpret our primary position
- 12. to be.
- 13: PRESTDENT:
- 14. Senator Bell...Senator Fawell.
- 15. SENATOR FAWELL:
- 16. There...there's just one think, I think, in all fairness
- 17. that ought to be said here. Senator Bruce was correct in a good
- 18. portion of his remarks. But, the assumption that he made, I think,
- 19. is very misleading and that is that all of the junior college dis-
- 20. tricts would immediately make physical education courses: a con-
- 21. dition precedent to graduation. And that's certainly is never
- 22. going to happen and I don't think that anybody here assumes that
- 23. it's going to happen. There are some districts that feel very
- 24. strongly that physical education courses ought to become mandatory
- 25. and ought to be a condition precedent to graduation. I think that's
- 26. important. You do not get the reimbursement Senator Bruce's talking
- 27. about here, unless it is a credit that is required in order to
- 28. graduate. And, what we are we doing at the present time is, effectively,
- 29. denying the home rule discretion of our local districts to make this
- 30. decision on their part. I think, it's very important, those of us
- 31. Who are in the Education Committee can recall, that those districts
- 32. which did quite vehemently oppose this bill, withdrew their objection.
- 33. And, as I recall, the Community College Board withdrew their objections.

1. Once it was ascertained that it was totally a discretionary 2. matter by the local junior college district. And, that was 3. ascertained, I think, all of us drew the conclusion that this 4. was not going to be any great monetary assault upon the 5. Treasury because very few of the districts indicated they were 6. interested in exercising this local authority. But, some were 7. very deeply interested in it. And, the final conclusion, in 8. compromise fashion, was that we did believe that those few 9. districts that did want to make this a condition precedent to 10. graduation ought to be allowed to do so. And, I think, in all 11. fairness, that ought to be brought forth. That certainly, you're 12. not going to have one hundred percent of the districts running 13. toward the Treasury to...on the basis that they're making this 14. a condition precedent to graduation. And, as far as Senator 15. Mitchler is stating, that this is going to bring astroturf and

ath...athletes to the junior college districts. My goodness,

so...I did want to make these few comments.
