- 10. SENATOR MCBROOM:
- 11. Yeah...yes, Mr. President, I'm ready.
- 12. PRESIDENT:
- 13. Alright. In connection with the Senate's consideration of
- 14. Amendment No. 1 to Senate Bill 1345. Senator Donnewald, is this
- 15. your amendment or Senator McBroom's?
- 16. SENATOR DONNEWALD:
- 17. This...this is the retirement amendment, of course. It
- 18. isn't mine, it is Senator McBroom's. So...

- 1. I...I might add, Mr. President, to what Mr...Senator Mc-
- 2. Broom said, it doesn't...it doesn't break it down, it just
- 3. wrecks it. This...this, of course, we object to strenuously
- 4. on this side of the aisle, and I would urge that we do have
- 5. a roll call and oppose this amendment.
- 6. PRESIDENT:
- 7. Is there further discussion? Senator McBroom.
- 8. SENATOR MCBROOM:
- 9. Well, I would simply like to say to the members on this
- 10. side of the aisle that this is one of the...this is the most
- 11. significant and most important amendment to this particular
- 12. bill. I think it's unfortunate, Mr. President, that this par-
- 13. ticular measure had to come up this late in the session. Sec-
- 14. retary Bond, I believe, in all candor, tried to operate in
- 15. good faith with our staff, but at the instruction of Governor
- 16. Walker, it was very difficult for us to get information, and
- 17. we come with an am...a bill of this magnitude this late and it
- 18. was only, I think, Friday or Saturday that we finally found
- 19. exactly what was going on, why the Secretary adamantly refused
- 20. to provide us with the information that was needed and we found
- 21. that, as we suspicioned that it emanated from the Governor's
- 22. Office. You recall my discussing it with you, Mr. President.
- 23. I move the adoption of amendment No. 2.
- 24. PRESIDENT:
- 25. Senator Knuepfer.
- 26. SENATOR KNUEPFER:
- 27. Well, I...I just wanted to say this amendment embodies,
- 28. as I see it, good planning. This is the kind of amendment that
- 29. most of...the...what this amendment does is break the budget
- 30. down in the kind of breakdown that most departments in this State
- 31. already have. And we did ask the Director of the Department..
- 32. .or the Secretary of the Department of Transportation for his
- 33. figures on the breakdown as between areas. The alternative to

- 1. this, I think, is the kind of lump sum budgeting that we have had
- 2. in the past which simply is no budgeting at all. And this kind
- 3. of an amendment does mandate some kind of planning in the div...
- 4. in the Office of Transportation. This is the planning, the best
- 5. planning we were able to get out of the Secretary's office, and
- 6. I think this is the very desirable thing from the legislative
- 7. point of view. If you want to...if you really want to be a
- 8. part of the appropriation process, then this kind of an amendment
- 9. does it. Otherwise, you're simply saying here's 500 million
- 10. dollars do with it what you wish.
- 11. PRESIDING OFFICER (SENATOR WEAVER):
- 12. Is there any further discussion? Senator McBroom moves
- 13. the adoption of Amendment No. 2 to Senate Bill 1345. Senator
- 14. Donnewald asked for a roll call. Those in favor of the amend-

- 21. the adoption of Amendment No. 4 to Senate Bill 1345. All in

- 25. Yes, amendment No. 5, Mr. President and members of the
- 26. Senate, I move the adoption of it. It's for mass transporta-
- 27. tion in downstate, Mr. President. This'll take care of bus
- 28. lines in bad...very badly needed places like Illiopolis,
- 29. Mahomet, Hoopeston. I move the adoption of it.

- 31. All in favor of adopting Amendment No. 5. Any discussion?
- 32. All in favor signify by saying Aye. Opposed Nay. Amendment No.

- 11. Amendment No. 7, Mr. President, is a million, two hundred
- 12. and sixty-nine thousand dollars. It's for Capital improve-
- 13. ments and it was requested by the department. I move the adop-

- 15. PRESIDING OFFICER (SENATOR WEAVER):
- 16. All in favor of the adoption of Amendment No. 7 to 1345
- 17. signify by saying Aye. Opposed Nay. The amendment's adopted.
- 18. Amendment No. 8. Senator McBroom.
- 19. SENATOR MCBROOM:
- 20. Amendment No. 8, Mr. President, is another reappropriation.
- 21. It amounts to over...slightly over 2 million dollars for traffic
- 22. and maintenance contracts. I move the adoption. I don't believe
- 23. there's any opposition from Senator Donnewald on this amendment
- 24. either. I move the adoption.
- 25. PRESIDING OFFICER (SENATOR WEAVER):
- 26. Is there any discussion? All in favor of adopting Amend-

SENATOR HYNES:

10. Well, it has...it has been the tradition in the appropria-11. tions process in the...in the General Assembly to appropriate 12. Federal funds and in addition to include in the bill a para-13. graph which has affectionately become known as the weasel clause, 14. which would allow a department to expend any additional Federal 15. funds that might be forthcoming in any manner consistent with 16. Federal law. By this means we hope to 28. 29. increase the accountability of the departments to the General 30. Assembly and to get some control over how much money is coming into the State and where it is...it is being spent - Federal 31.

funds that is. Every department whose budget has been affected

by this amendment has raised an objection to it on the ground

- that it reduced flexibility but that is precisely what the
- 2. appropriations process is intended to do. The Department of

- 20. ment's adopted. Senator McBroom.
- 21. SENATOR MCBROOM:
- 22. Amendment No. 3, I think one moment should be taken on this.
- 23. Senator Nimrod, it is your amendment, you're familiar with it,
- 24. you've done work on it, it has...it's 500,000 dollars to do with
- 25. the Ethics Act. Do you want to take a moment and explain where
- 26. we're going here, Senator Nimrod?
- 27. PRESIDING OFFICER (SENATOR WEAVER):
- 28. Senator Nimrod.
- 29. SENATOR NIMROD:
- 30. Yes, Mr. President and fellow Senators. This amendment is
- 31. to provide the money for implementing and beginning the...the
- 32. Campaign Disclosure Bill, which is under the direction and super-
- 33. vision of the State...State Board of Elections and it's...it was

- estimated that without the reports that were involved, without
- 2. the publishing that they would need at least 500,000 dollars to
- 3. implement this. I...I just wanted to say one thing, that if we
- 4. let these kind of bills go unchecked and we talked about the
- 5. part that pertains to reports, the publishing requirements
- 6. alone could run into millions of dollars and it was felt that
- 7. that would be taken care of and this 500,000 dollars is necessary
- 8. for that Board.
- 9. PRESIDING OFFICER (SENATOR WEAVER):
- 10. Senator Knuppel.
- 11. SENATOR KNUPPEL:
- 12. So that I fully un...understand the amendment, this is an
- 13. addition of 500,000. Is that correct, Senator Nimrod?
- 14. SENATOR NIMROD:
- 15. That's correct.
- 16. SENATOR KNUPPEL:
- 17. I predicted that ethics and all that went with it would
- 18. cost us more than had ever been stolen. You know that comes
- 19. pretty close to that 800,000 dollars they found in shoe boxes.
- 20. It took him about 30 years if he actually accumulated that in
- 21. Government to do it, and here we're going to spend 500,000
- 22. dollars in one year. All the ethics that we get are going to
- 23. cost us more than was ever stolen.
- 24. PRESIDING OFFICER (SENATOR WEAVER):
- 25. Any further discussion? Senator Davidson.
- 26. SENATOR DAVIDSON:
- 27. If you're going to talk about the cost, I think Senator
- 28. Knuppel and members of the Chamber, should be well aware this
- 29. is only part of a start-up, because the estimate given to us
- 30. in relation when we worked on this amendment was from two and
- 31. a half to 5 million dollars if the Disclosure Act passes and
- 32. depending on what state it passes in. This 500,000 dollars
- 33. is addition only if the campaign ethics disclosure starts so

- 1. they can start it up and we can rectify whatever we've got to
- 2. have in November.
- 3. PRESIDING OFFICER (SENATOR WEAVER):
- 4. Any further discussion? The question is shall Amendment
- 5. No. 3 to House Bill 2543 be adopted. All in favor signify by

- 8. SENATOR MCBROOM:
- 9. Yes. It's the legal amendment, Mr. President. I move

- 12. Is there any discussion? Senator Dougherty. Senator
- 13. Dougherty.

- 27. Yes, Mr. President. My attorney, Senator Merritt, tells
- 28. me it's absolutely constitutional and I move the adoption.
- 29. PRESIDING OFFICER (SENATOR WEAVER):
- 30. All in favor of Amendment No. 4 to House Bill 2543 signify
- 31. by saying Aye. Opposed Nay. The amendment's adopted. Any
- 32. amendments from the Floor? Third reading. Senator Donnewald
- 33. are you going to handle 2365 for Senator Johns?

SENATOR DONNEWALD: 1. 2. Yes, Mr. President... 3. SECRETARY: 4 . House Bill... 5. SENATOR DONNEWALD: 6. ... Senator Johns is not here today and I know that he has 7. an amendment that he wants to put on it and I know there are 8. several other amendments that are to be added and I wondered if 9. we could move this bill to the order of third reading with the 10. understanding that we would bring it back at the request of 11. anyone that wished...would wish to submit an amendment? 12. - 17. Yes, thank you. The...this is the legal amendment,

- 19. PRESIDING OFFICER (SENATOR WEAVER):
- 20. Is there any discussion? All in favor signify by saying
- 21. Aye. Opposed Nay. Amendment No. 3 is adopted. Amendment No.
- 22. 4.
- 23. SENATOR MCBROOM:
- 24. Yes, Mr. President, amendment...amendment No. 4 deletes
- 25. only 6,000 dollars, Mr. President, and I move the adoption
- 26. of it.
- 27. PRESIDING OFFICER (SENATOR WEAVER):
- 28. Is there any discussion? All in favor of adopting amend-
- 29. ment No. 4 signify by saying Aye. Opposed Nay. Amendment No.
- 30. 4 is adopted. Amendment No. 5.
- 31. SENATOR MCBROOM:
- 32. Yes, amendment No. 5, I believe that Senator Hynes is in
- 33. tandem with me on this amendment and it's about 100,000 dollars

- 1. for rehabilitation of the Dixon Mounds Museum. I move the
- 2. adoption, Mr. Chairman.
- 3. PRESIDING OFFICER (SENATOR WEAVER):
- 4. Is there any discussion? All in favor of adopting amend-
- 5. ment No. 5 signify by saying Aye. Opposed Nay. Amendment No.
- 6. 5 is adopted.
- 7. SECRETARY:
- 8. Amendment No. 6 Senator Donnewald.
- 9. PRESIDING OFFICER (SENATOR WEAVER):
- Senator Donnewald.
- 11. SENATOR DONNEWALD:
- 12. Yes, Mr. President and members of the Senate. Amendment
- 13. No. 6 deals with the State Geological Survey, which is under
- 14. the jurisdiction of the Regis...Department of Registration and
- 15. Education. For the last several years there has been a loss
- 16. of people when we really have an energy shortage and I think
- 17. that to add this 180...1,000 dollars to beef up that particu-
- 18. lar department is absolutely essential at this time. I would
- 19. appreciate a favorable response from all sides of the aisle.
- 20. PRESIDING OFFICER (SENATOR WEAVER):
- 21. Senator McBroom.
- 22. SENATOR MCBROOM:
- 23. Well, Mr. President and members of the Senate. In regard
- 24. to this appropriation, or request of Senator Donnewald, this
- 25. may come as a surprise to some members on this side of the
- 26. aisle and perhaps to Senator Donnewald. I do not personally
- 27. intend to oppose it, Senator Donnewald. It goes back, Mr.
- 28. President, to two years ago. It was discussed in committee when
- 29. a...when the people of the State of Illinois had a game played
- 30. With them and we read about a bare bones budget; we had a candi-

- 25. PRESIDING OFFICER (SENATOR WEAVER):
- 26. Any discussion? All in favor signify by saying Aye. Op-
- 27. posed Nay. Amendment No. 1 is adopted. Amendment No. 2. Sen-
- 28. ator McBroom.
- 29. SENATOR MCBROOM:
- 30. Yes, Mr. President, this is a reduction of about 19,000
- 31. dollars. It has to do mainly with pamphlets for the bicentennial...

- 27. Amendment 1 to Senate Bill 1249.
- 28. PRESIDING OFFICER (SENATOR WEAVER):
- 29. Is there any discussion. The question is shall amendment
- 30. No. 1 be adopted. All in favor signify by saying Aye. Opposed
- 31. Nay. Amendment No. 1 is adopted. Any further amendments?
- 32. Third reading. Senator Partee, 1290.
- 33. SENATOR PARTEE:

- Mr. President and members of the Senate. Senate Bill 1290
- 2. is a simple bill offered by Senator Harris and myself, which
- raises the salary of the Chairman of the Commission on Fair

- 16. Third reading of the bill.
- 17. PRESIDING OFFICER (SENATOR WEAVER):
- 18. Question is shall the Senate pass or...excuse me...Senator
- 19. Sours.
- 20. SENATOR SOURS:
- 21. Mr. President and Senators. I'm going to support this
- 22. bill but I think this Chamber should consider sometime the
- 23. matter of curtailing the rule making power of this Commission.
- 24. Now as of now where there, for example, is a general contractor
- 25. and 5 or 6 or 7 sub-contractors, any non-compliance by some
- 26. remote sub-contractor or supplier, sometime that goes way out.
- 27. It permeates the entire transaction. I'm going to vote for
- 28. this because I believe they...they merit and deserve an increase.
- 29. But I think this Chamber ought to bear in mind that they're
- 30. making rules that are in many instances strangulating good legal

- 4. Senate Bill 1290, having received a constitutional majority is

- . SENATOR MITCHLER:
- 8. Yes. Mr. President and members of the Senate.
- 9. PRESIDING OFFICER (SENATOR WEAVER):
- 10. Secretary will read the bill.
- 11. SECRETARY:
- 12. Senate Bill 1481.
- 13. (Secretary reads title of bill.)
- 14. Third reading of the bill.
- 15. PRESIDING OFFICER (SENATOR WEAVER):
- 16. Senator Mitchler.
- 17. SENATOR MITCHLER:
- 18. Mr. President and members of the Senate. Senate Bill 1481
- 19. is an appropriation to the Division of Waterways to conduct
- 20. emer...emergency repairs or reconstruction of the North Aurora
- 21. Dam on the Fox River. This is an old wooden dam and this dam has
- 22. ruptured about 1/4th on the east bank causing excessive flow
- 23. downstream. The bill is an emergency bill because it does in-
- 24. volve the damage to a park area that has already eaten away about 15 to
- 25. 20 feet and if it's allowed to continue to do so without emer-
- 26. gency repairs will wipe out a large number of trees on the shore-
- 27. line of this park district area. Now am I...I want to point out
- 28. that this bill is what we could term a companion bill. On your
- 29. calendar, Senate Bills Third Reading, is Senate Bill 1675.
- 30. Originally we had hoped to put this appropriation in the Division

access to the dam and then the appropriation would be made for

SENATOR PARTEE:

19. Well, from the time this bill first came over, until now,

there have been, as I understand it, some changes with reference

27. Senator Mitchler.

SENATOR MITCHLER:

Senator Partee, in the discussion last Monday in the StateOffice Building, Director Tony Dean of the Department of Con-

31. servation was present and he...there is, in progress, within the

32. administrative branch of our government to survey all of the dams

33. on the Fox River with the ul...with the ultimate goal that the

- 1. transfer would be made of any dams or properties owned by the
- 2. State of Illinois from the Division of Waterways to the De-
- 3. partment of Conservation and that it...from that time on, which
- 4. is not...that point in time is not as yet been reached. But
- 5. from that point in time the dams would be under control of the
- 6. Divis...Department of Conservation rather than, as they have

- 14. PRESIDING OFFICER (SENATOR WEAVER):
- 15. Is there any discussion? The question is shall Senate
- 16. Bill 1675 pass. Those in favor vote Aye. Those opposed
- 17. vote Nay. The voting is open. Have all voted who wish? Take
- 18. the record. On that question the Ayes are 47, the Nays are

none. Senate Bill 1675, having received the constitutional

- 20. majority, is declared passed. Senator Bruce, did you...Sena-

- 22. SENATOR BRUCE:
- 23. Yes, Mr. President, Senate Bill 1462.

- 25. Senate Bill 1462.

- 29. Senator Bruce.
- 30. SENATOR BRUCE:
- 31. Yes. This change is recommended by the auditors who review

- 12. Bonds are we talking about?
- 13. PRESIDING OFFICER (SENATOR WEAVER):
- Senator Bruce.
- 15. SENATOR BRUCE:
- 16. Senator, it would be all of the Revenue Bonds that have
- 17. been issued by the State of Illinois, it's my understanding.
- 18. The Act requires that whoever is responsible keep track of
- 19. all outstanding Revenue Bonds, who has them, maturity dates,
- 20. et cetera, et cetera, all the bond coupons and things. It is
- 21. presently done by both the State Treasurer and the Comptroller.
- 22. The auditor that reviewed the State Treasurer said that it would

- 27. Any further discussion? The question is shall Senate Bill
- 28. 1462 pass. Those in favor vote Aye. Those opposed vote Nay.
- 29. The voting is open. Have all voted who wish? Take the record.
- 30. On that question the Ayes are 48 and the Nays are none. Senate
- 31. Bill 1462, having received the constitutional majority, is de-
- 32. clared passed.
- 33. SECRETARY:

l. Senate Bill 1564. 2. (Secretary reads title of bill.) 3. Third reading of the bill. 4. PRESIDING OFFICER (SENATOR WEAVER): 5. Senator Nimrod. 6. SENATOR NIMROD: 7. Mr. President and fellow Senators. This bills provides 8. for the appointing authorities by which any directors were appointed to the RTA Board, that they have the right to re-9. move them, provided there would be a hearing and that there 10. 11. is proper notice given and also it would be considered his office will be abandoned if he does not attend the meeting 12. 13. or report in writing in four months without excuse, and I 14. would be glad to answer any questions or be happy to...ask you 15. to...for a favorable roll call. 16. PRESIDING OFFICER (SENATOR WEAVER): 17. Is there any discussion? Senator Rock. 18. SENATOR ROCK: 19. How...how does it change the existing statute? PRESIDING OFFICER (SENATOR WEAVER): 20. 21. Senator Nimrod. 22. SENATOR NIMROD: 23. The change that's required here is that no director will 24. be removed unless he has been given a copy of the charges which are against him. And, then a director, who may be removed 25. 26. from office, to have the right of judicial review of his re-27. moval by any appeal to the district court, within the county 28. for which he was appointed or resides. And...but only on the 29. grounds of an error of law and the abuse of discretion. A member shall...shall be deemed to have abandoned his office 30. if he doesn't attend meetings for four months. 31.

PRESIDING OFFICER (SENATOR WEAVER):

Senator Rock.

- SENATOR ROCK:
- Well, my...my point is, Senator, what...what are you try-
- 3. ing to get at? It says that any director may be, under the
- 4. present Act, a director may be removed from office upon the
- 5. concurrence of not less than six directors. On a formal find-
- 6. ing which I mean...which I take to mean a finding of incom-
- ?. petence, neglect of duty or malfeasance. And every one of
- 8. those findings of every administrative authority is governed
- 9. by the Administrative Review Act.
- 10. PRESIDING OFFICER (SENATOR WEAVER):
- Senator Nimrod.
- 12. SENATOR NIMROD:
- 13. Now, the difference, Senator Rock, is this. This...this
- 14. gives the right to the appointing authority to be able to
- 15. remove. Not the board...not the RTA Board themselves. Now
- 16. if the appointing authority feels that there has been any
- 17. Of these violations, which I gited have and the charges are
- 17. of these violations, which I cited here, and the charges against
- 18. him; he does have a right for review. Certainly that appointing
- 19. board should have the right to remove him for their cause.
- 20. SENATOR ROCK:
- 21. Well, I...I'm...
- 22. PRESIDING OFFICER (SENATOR WEAVER):
- 23. Senator Rock.
- 24. SENATOR ROCK:
- 25. I'm not frankly convinced of that for this reason. That
- 26. if I appoint members of a board, you claim that I, as the ap-
- 27. pointing officer, should have the right to remove my appoint-
- 28. ment. Is that right? Whereas...as your understanding is now
- 29. that only the Board has that right?
- 30. PRESIDING OFFICER (SENATOR WEAVER):
- Senator Nimrod.
- 32. SENATOR NIMROD:
- 33. It is my understanding only the Board has that right -

- 1. right now, not the appointing authority. There are no provisions
- for the appointing authority to remove anyone that they appoint.
- 3. SENATOR ROCK:
- 4. Well...
- 5. PRESIDING OFFICER (SENATOR WEAVER):
- Senator Rock.
- SENATOR ROCK:
- Assuming that that is the intent, I think you're...you
- 9. know, we are...we have a...attempted at least when we...when...
- 10. in the negotiations to structure a...a totally non-political
- 11. board, I think you're just trying to inject politics into the
- 12. workings of the board. And in addition to that, I think the
- 13. ...the...the proviso concerning abandonment has...is at best
- 14. a little harsh. Members shall be deemed to have abandoned his
- 15. office upon failure to attend any regular or...meeting of the
- 16. Board for a period of four months without excuse approved by
- 17. resolution of the Board. That, I...I think is a little much.
- 18. PRESIDING OFFICER (SENATOR WEAVER):
- 19. Senator Partee.
- 20. SENATOR PARTEE:
- 21. I'd just like to add to what Senator Rock said that if
- 22. you want a political board of the RTA, you vote for this bill,
- 23. because that's exactly what you're going to get. If you want
- 24. a Board that has some freedom of locomotion and freedom to do
- 25. what they think is right, then vote against this bill. What
- 26. he wants to do is to have those persons who appointed those
- 27. people to be able to call them at home every night and say
- 28. vote this way tomorrow or I'm going to take you off the Board.
- 29. That is not what we want, this is not what we need, we need a
- 30. Board where people have the right to make some decisions for
- 31. themselves. There are other bills here which make provision
- 32. for getting rid of a Board member who is not doing his job.
- 33. And those bills leave it up to the members of the Board who

- 1. are there with him on an every day basis, who can then make an
- 2. ...a...make the suggestions as to whether or not the person is
- 3. fulfilling a job. This is very, very...very, very backward in
- 4. thinking, it's retrospective. We're here now making people
- 5. Civil Service; we're having merit boards; and all kinds of con-
- 6. siderations, and this takes us back into the very dark ages of
- 7. old political wheeling and dealing and this is a thoroughly bad
- 8. bill.
- 9. PRESIDING OFFICER (SENATOR WEAVER):
- 10. Any further discussion? Senator Knuepfer.
- 11. SENATOR KNUEPFER:
- 12. Well, Senator Partee, I'm not convinced of that. Do you
- 13. feel, for example, that the Mayor of the City of Chicago should
- 14. not have the power to remove his appointees? Do you feel that
- 15. the Governor of this State should not have the power to remove
- 16. his appointees? I'm sure the answer is very obvious. There...
- 17. there is something in the appointment power and...and...and...
- 18. though the appointments ought to be subject to the body from
- 19. which they were appointed, and I suggest to you that this is
- 20. done everyday and done all of the time, in which appointing
- 21. authorities do have the power to remove, for cause, those whom
- 22. they appoint. Without that you could tie governments up
- 23. in...into immense difficulties, and I recognize that your
- 24. objection to the so-called political influence. That is
- 25. there; that's bound to be there. And the RTA Board was never
- 26. set up as a supreme court in which all partisan influence
- 27. is supposed to be taken away from. The RTA Board is going to
- 28. have some partisanship. Partisanship, maybe not Republican or
- 29. Democratic, but partisanship vis-a-vis the various bodies that
- 30. it serves as to whose funds go where. And I think these bodies
- 31. still have a long range abiding interest in whoever they appoint
- 32. and ought to be able to remove for cause.
- 33. PRESIDING OFFICER (SENATOR WEAVER):

Senator ... Senator Partee. l.

#### 2. SENATOR PARTEE:

3. Senator Knuepfer, I think there's a fundamental difference between the right of an appointing authority to remove a person 4. where the appointing...appointed person services, as an extension 5. of the appointing authority. That is to say, a mayor appoints a 6. 7. fire commissioner. A fire commissioner, whose job it is to carry out duties which actually belong to the mayor. He is the mayor 8. 9. of the entire city. Here, this is an appointing authority for convenience. The RTA Board is not subject to the jurisdiction 10. of a mayor. It is not subject to the jurisdiction of the County 11. 12. Board. The appointing authority is for convenience sake. Their duties are not the duties of the mayor or the County Board or 13. 14. the appointing authority. They're separate and apart. They are 15. but a conduit of putting people on the Board. Whatever they do 16. does not in any way reflect credit, creditably or uncreditably 17. on the appointing officer, and therein lay the difference. 18.

PRESIDING OFFICER (SENATOR WEAVER):

Senator Sours....or Senator Soper. 19.

# SENATOR SOPER:

20.

21. Thank you, Mr. President. Now, as I understand the RTA Board and its...in its makeup, has separate years of appointive 22. 23. power. In other words, some of the...some of the commissioners or trustees or members or directors are appointed for various 24. 25. number of years - two years, staggered years. Is that correct? 26. Somebody...somebody that knows about that? I think the Chairman 27. here of Transportation told me that. Now, if a member, if some-28. one is appointed to a Board and he's appointed at the discretion 29. or the pleasure of the appoint...appointer or the mayor, or whoever appoints him, then he would serve at the pleasure of the 30. mayor, but if he's appointed for a certain term of years I think 31. he only can be removed for cause or at the end of his term, and 32. I think you would be doing injustice to this Board to put in 33...

- a bill like this to just have the...the...appointing power 1.
- be able to take the appointment away from all of these people 2.
- 3. because of the fact that you didn't act within the pleasure
- of the appointer. So, I believe if you just leave this alone 4.
- 5. I think it would be better off.
- 6. PRESIDING OFFICER (SENATOR WEAVER):
- 7. Senator Nimrod may close debate.
- SENATOR NIMROD: 8.

- 9. I'm sorry that there seems to be some misunderstanding
- 10. in this. We are not promiscuously removing someone from of-
- fice without reason or cause. Certainly if there is no con-11.
- 12. venience factor here but I do believe that a appointing author-
- 13. ity does have the right to remove someone provided he's given
- 14. the charges and given the proper hearing. The door ought to
- not be closed. Now I think the...the important thing is here 15.
- is that there is completely, there's no provision in this Act 16.
- 17. for removing anyone who moves from one area to another. This
- bill covers that. In addition to that, I think the appointing
- 19. authority has say...has...has the right to say this. If you
- 20. are not acting in our best interest and we have appointed you
- 21. for a four-year term and we want to give you a public hearing
- 22. and we want to justify that and have you go to court, we've
- 23. certainly giving you every right to do this, and I think that
- 24. that appointing authority since this RTA is such a situation
- 25. of direct appointment, it's never been done before where suburban
- 26. legislators appoint. It's never been done before where these
- 27. collar counties have each a partial appointment in this voice.
- 28. They certainly ought to not be cut out completely if they make
- a mistake, and I would ask you to give it a favorable vote. 29.
- PRESIDING OFFICER (SENATOR WEAVER): 30.
- Question is, shall Senate Bill 1564 pass. Those in favor 31.
- 32. vote Aye. Those opposed vote Nay. The voting is open. Have
- all voted who wish? Have all voted who wish? Take the record. 33.

- 12. Senate Bill 1565 is an attempt by the City of Canton and

- 27. SENATOR SOURS:
- 28. Mr. President and Senators. I'd like to ask the sponsor
- 29. a question. If this is in any way competitive with the com-
- 30. mercial enterprise beyond the boundaries of municipality. Is
- 31. he precluded from getting in the pie in this one?
- 32. PRESIDING OFFICER (SENATOR WEAVER):
- 33. Senator Knuppel.

## SENATOR KNUPPEL:

- Well, I don't exactly understand the question. He says
- 3. beyond the city. All I know is that in this...in this area
- 4. the City of Canton is behind this project 100%. The business-
- 5. men, as well as all the banking interests and everything else.
- 6. I have not had one...one group that is opposed. Now, this will
- allow them to build commercial establishments and to rent those
- 8. for enough to retire the Revenue Bonds. Now I don't know if
- 9. that answers your question or if I understood your question.

- 11. Senator Sours.
- 12. SENATOR SOURS:
- 13. Alright, let's go back to Fulton County and we'll go...
- 14. we'll go north about 3 miles of Canton on Route 78. What
- 15. about a shopping center there, Senator? Would that be
- 16. prejudiced by this legislation? If so, why should it be?
- 17. PRESIDING OFFICER (SENATOR WEAVER):
- 18. Senator Knuppel.
- 19. SENATOR KNUPPEL:
- 20. Well, I don't... I don't know how it would be prejudiced.
- 21. Except in...in...to the one degree that...that this is carried
- 22. on for...for renewal and redevelopment areas and I don't know
- 23. that there is an area requiring redevelopment three miles north
- 24. of Canton. This is to prevent the rotted out interior of the
- 25. cities and the destroyed business districts that are occuring
- 26. in small towns that are not under...under home rule and there are
- 27. a lot of those towns between 10 and 25,000 and even smaller
- 28. where buildings are closed up, they're a hazard to health and
- 29. welfare. This is what the City of Canton and what this bill
- 30. attempts to do is to allow the commercial interests of that
- 31. community to form a corporation and to redevelop the downtown
- 32. area or any other area within the...the municipal limits.
- 33. PRESIDING OFFICER (SENATOR WEAVER):

Senator Sours.

SENATOR SOURS:

З. Well, Mr...Mr. President and Senators, I don't know what goes on in Canton and it's a nice little town, I go through it 4. quite frequently. But the City of Peoria raised about 50 5. 6. million dollars of its own money to refurbish the downtown area. They spent another 50 or 55 million on hospital facilities, mostly of their own money, and it seems to me that this principle. 8. you know, Senator, we live by principle, whether we know it or 9. 10. not. You part your hair on a certain side and so do I. put the right shoe on and the left shoe, because of habit, and 11. 12. principle is something that stays with us. Now I think this is a very dangerous principle and I say this even though a number 13. of people in my district have written me suggesting I support 14. this legislation and I say to you, I do not believe they know 15. exactly what this legislation does. I think it distinguishes 16. 17. between a business or an industry located within the confines 18. of the...the corporate limits of a municipality and is directly competitive with anybody who just happens to start his enter-19. prise or his industry or his business beyond the boundaries of 20. the municipality. For that reason, in my opinion, this is not 21. good legislation. It might help the City of Canton, but I think 22. before we got done with it in the next ten years, with all these 23. tax-free bonds, we would regret the roll call which will proba-24.

We're witnessing this all over the State. This could well be the salvation of a lot of our communities. We witnessed this all over the State. We see it in downtown Springfield here; you see buildings eroding, because they don't have the money to refurbish them or do anything about them. This is a good bill and I think it deserves our support.

- 28. we're all aware, had two separate holidays for Memorial Day.
- 29. The Federal celebrated it on Monday and we celebrated it on

- on Monday and we would celebrate it on Friday. The...my own
- 32. personal preference would be to keep Memorial Day on the 30th.
- 33. I did check with my Congressman, who is the Congressman that

l. introduced the Monday holidays bill. He informs me that there 2, ...while there is a chance that Veteran's Day could go back to 3. November 11 that there is virtually no chance at all, realis-4. tically speaking, that Memorial Day will come back to the 30th. 5. I believe that there are only four or five States in the coun-6. try that celebrate it on the 30th and I believe in two of those 7. four or five states, although I can't substantiate this, that 8. it is strictly a commemorative holiday and the States give the 9. Monday holiday as the day off. I personally have spoke and 10. have spoken consistently at Memorial Day festivities for about 11. the last ten years. This year I spoke in two places. In Fox 12. River Grove it was necessary for my friends in the American 13. Legion to bring two guys in from another town to make up a seven man firing squad. In Crystal Lake, where I spoke later on that 14. 15. day, the thing that was most noticeable about the crowds, it was 16. all women and children, with no men. On Monday, the Federal 17. holiday, I was again in Fox River Grove at a large opening of 18. a hot air balloon court and the crowd was very large but it was all husbands and wives and very small children. I'd like to put 19. 20. the families together again on Memorial Day and to rekindle the 21. spirit of this truly great American holiday. But the families 22. must be together and I think this bill and this procedure is the 23. only way that it's going to happen. PRESIDING OFFICER (SENATOR WEAVER):

SENATOR SOURS:

9. Mr. President, I wonder what the attitude of this Chamber 10. would have been 20 or 30 years ago, probably 30 years ago might 11. have been better - 1944, when the tears were still a little wet. 12. I support this and I respect Senator Mitchler. You know, on 13. our Republican track team on this side, on the high jump, we 14. would far rather have a man who could jump 7 feet than 7 men 15. who could jump 1 foot each, and I mean just that, and I've heard 16. the catcalls here today and I'm wondering - I happen to have 17. spent more than four and near five years in His late Majesty's 18. army, F.D.R., of recent memory, and you know, when time goes 19. by the muniments of memory also disappear too. We have rele-20. gated patriotic holidays to, if they're in the summer, to a 21. double header and 2 six packs, while the grass grows up to our 22. posteriors as we walk in our front yard, because we have de-23. generated into a society of bourbons glued to our televisions 24. and a holiday is just another day when we don't go down to 25. work, whatever the occupation or the employment or the profession 26. may be. Now this is sound legislation. I know some of the 27. labor organizations like to have it so they can have two or 28. three days on the weekend, but of course, that was never the 29. corporate purpose of Memorial Day. Now when Memorial Day came 30. around as promulgated by General John Logan, the tears were wet, 31. the orphans were at the celebrations, the widows and the be-

reaved parents were there too, and as I have just stated with

the passage of a hundred years of muniments of memory, sort of

- 6. Mr. President, I also have good friends who were lost in
- 7. the service of their Country in the military and I would just
- 8. like to point out, I certainly want to honor them and respect
- 9. them. I'd just like to point out that when General John A.
- 10. Logan, who by the way was from my district, when he first
- 11. promulgated Memorial Day, it was in April. The first Memorial
- 12. Day was celebrated in April. It was some four or five years
- 13. later in about 1868 or 1869 that the date was moved to May
- 14. 30th and it seems to me that we can eulogize and memorialize
- 15. our war dead any day of the year. I don't think that May 30th
- 16. has to be particularly sacred. At the same time, I don't think
- 17. that it's fair to the taxpayers of the State of Illinois to

- 18. SENATOR KNUPPEL:
- 19. Well, of course, the fact of the matter is that you don't
- 20. get one holiday you get a whole week as it has been pointed out
- 21. by Senator Buzbee. I don't know what could be more confusing
- 22. when we went to Lincoln for industrial cases on the...on the
- 23. first Monday and the State of Illinois continued to do business
- 24. as usual, but you couldn't buy a sandwich or a hamburger at
- 25. noon. Now, I...I just submit that whatever sanctity the 30th

- 2. ... Senate Bill 1650 amends the Public Meetings Act. It exempts
- 3. the...exempts from meetings the Illinois Aeronautical Board.
- 4. This bill is amended to spell out exactly what the Aeronautical
- 5. Board is exempt from holding meet...closed meetings for. Now
- 6. it is an agreed amendment. I spoke with Harber Hall and mem-
- 7. bers on the other side of the aisle and exactly what it exempts,
- 8. Ladies and Gentlemen, it exempts the Illinois Aeronautical Board
- 9. from holding closed sessions during the presentation and dis-
- 10. cussion of financial information of air carriers for the purpose

- 24. Senator Course.
- 25. SENATOR COURSE:
- 26. The necessity for the...this bill is that there's no reason
- 27. Why they have to have an open meeting when they're discussings..
- 28. discussing schedules, fares, rates, flight schedules, Cer-
- 29. tificates of Registration, if they're going to have other air
- 30. carriers sitting in on these meetings, they can gather this
- 31. information from the meetings and use it against them. That's
- 32. the only reason they want it.
- 33. PRESIDING OFFICER (SENATOR MOHR):

ı. Senator Knuepfer. 2. SENATOR KNUEPFER: 3. Well, I... I've never been to one of these meetings but I 4. ... I fail to see why fares or schedules have anything that re. 5. ..in them that intrinsically makes it desirable to keep them 6. secret. I would assume you apply for a schedule and you get 7. it or you don't get it and eventually it's public knowledge. Now what is there about these kind of provisions that has to 8. 9. be kept a secret? I can understand purchases, I can understand 10. some of the other exemptions from the Open Meetings Act, but 11. I...I simply can't understand why these cannot be discussed 12. in open meeting; what competitive position it would hurt, what 13. damage it would do. 14. PRESIDING OFFICER (SENATOR MOHR): 15. Senator Course. 16. SENATOR COURSE: 17. It's the presentation of financial information which could 18. be used by other air carriers. 19. PRESIDING OFFICER (SENATOR MOHR): 20. Senator Berning. 21. SENATOR BERNING: 22. May I ask...ask the sponsor then if there is any relation-23. ship between this kind of hearing by this Board and a Commerce Commission Hearing on a fare by one of the mass transit carriers? 24. PRESIDING OFFICER (SENATOR MOHR): 25. 26. Senator Course. 27. SENATOR COURSE: The Commerce Commission is exempt under this Act. 28. have broadened this here to...to spell out exact...exactly what 29. 30. the meetings can be closed to. That is all. And it's not as broad as the...the...what is enjoyed by the Commerce Commission. 31.

- 8. SENATOR COURSE:
- 9. Thank you, Mr. President. Senate Bill 1651 amends the
- 10. Illinois Air Carriers Act. It provides for additional penalties
- 11. not to exceed 1,000 dollars for each violation. Now what this
- 12. means, ladies and gentlemen, at the present time they can suspend
- 13. or revoke the license of an air carrier for a violation, but
- 14. there is...it may be a minor violation such as a...a pilot flies
- 15. more than the required number of hours in a week or the failure
- 16. of a carrier to report a...make a report on time. Now they think
- 17. the...to suspend or revoke the...the license of an air carrier
- 18. for this is too severe. They have suggested a...a fine, a
- 19. monetary fine of...not to exceed 1,000 dollars per violation and
- 20. a maximum of 1,000 dollars per day. Now, ladies and gentlemen,
- 21. these carriers...it's not the intent of the...the Board to put
- 22. these carriers out of business. These carriers are just barely
- 23. making it the way it is. Now a thou...a fine of a thousand
- 24. days would put them out of business, but the threat of a fine,
- 25. if it's as much as 200 dollars would make them comply. That's
- 26. what this section of the...the Act applies to. Second part of
- 27. the...the bill, it's a detailed bill and it's quite complicated.
- 28. It authorizes the Board to take action without public...prior
- 29. public notice. Now what this means, ladies and gentlemen, it
- 30. re...amends the Act to include temporary o emergency authority
- 31. by the Board without prior notice of hearing that such hearing
- 32. is...if required, be held within 30 days at the time the
- 33. temporary or emergency authority exists. In this particular in-

stance it is concerned with the legal action of a ... of a very serious mature which might occur on the part of an air carrier, which in...is in the public safety demands immediate or action by the Board. Now what this could mean is the ... an unauthorized change of equipment, an auth. . . an unauthorized suspension of service, a lapse of insurance, inability to act due to an act of God. It also provides in there that it increases from 500 dollars to 5,000 dollars the authority granted to the Board upon which they may act. Now the 500 dollars they thought was too low because if there is a change of equipment in the plane which ... which could in this day and age could very well be more than 500 dollars. If the carrier had to go to the Board every time for a change like this it would practically put them out of business. They have increased this amount to 5,000 dollars because if they. .. say in landing a plane that the landing gear collapsed, this could very well be 4,000 dollars. Now if the Board thinks that this is something that is necessary, they don't have the ... the air carrier shouldn't have to come to the Board to do this. The main reason for the 5,000 dollars is to prevent a milking of dry of these these small carriers which could very well be done by the officers if they didn't have some control. This is a good bill, ladies and gentlemen, it was recommended by the Board and I would appreciate your support. PRESIDING OFFICER (SENATOR MOHR) : Furth... Further discussion? Senator Buzbee. 1. Senator Course. 2. SENATOR COURSE: З. No. Interstate Commerce? No. 4. PRESIDING OFFICER (SENATOR MOHR): 5. Senator Buzbee. 6. SENATOR BUZBEE: 7. Well, I'm speaking specifically now as...it is my under-8. standing that there is only one airline that's domiciledin the 9. State of Illinois that...and that is the...Air Illinois. Yeah 10. I...I...that's...that's intra. I know that. But 11. would this...would this Act have the effect of allowing a 12. State Inspector to go on...to go on and say well, you may be 13. in compliance with the FAA but we don't like the way you're 14. operating your airlines, so we're going to shut you down? 15. PRESIDING OFFICER (SENATOR MOHR): 16. Senator Course. 17. SENATOR COURSE: 18. Senator Buzbee, that's not the purpose of the Board. They're 19. not in business to...to...to put somebody out of business. 20. They're to promote aviation in the State of Illinois and God 21. knows aviation needs a hand in the State of Illinois. - 19. energetic. I would just point out though that I have another
- 20. amendment and I'd like for Senator Glass to listen to this.
- 21. I recognize that 10 million dollars is probably...probably

- 30. cluding Montana and Ohio and Pennsylvania and Kentucky and
- 31. West Virginia. Kentucky has already authorized 50 million.
- 32. Now, if we go...come into this show in Washington with a 50
- 33. million dollar authorization, it gives us simply no competitive

- 1. enam...no competitive over...or advantage over Kentucky even,
- 2. and we are a much larger State; we're a much more prosperous
- 3. State; a much more popular State. And when we know that the
- 4. Federal Government sometimes relates in terms of authorization
- 5. it just seems almost unwise for us to stay in the ballpark with
- 6. a little State like Kentucky. This is not to denigrate Kentucky,
- 7. they're very fine people. But we ought to go with a hundred
- 8. million authorization which is what is in the other package and
- 9. I have such an amendment to offer. Now, I just want you to
- 10. know that before we vote on this one; that I think it ought to
- 11. be 100. The 10 million to be spent is...is the same as it is
- 12. now, but we ought to have an authorization of 100 million dollars.
- 13. PRESIDING OFFICER (SENATOR MOHR):
- 14. Senator Glass.
- 15. SENATOR GLASS:
- 16. Well, thank you Mr. President. Well, Senator Partee, I...I
- 17. know that the 100 million figure is the one the Governor has
- 18. been talking about. We haven't seen any appropriation suggested
- 19. by him for this fiscal year in any amount. We're not aware of
- 20. projects that are about to be consummated or contracts that are
- 21. about to be entered into. I don't think it's at all necessary
- 22. to...to authorize that kind of extensive bonding power which
- 23. is just double that which we're suggesting with the number of
- 24. bonds that the State is already obligated on at this time. I
- 25. would say to you that as time goes on it...it may well be that
- 26. the State should increase the authorization but I...I think it's
- 27. a little bit a loser anyway to say we're authorizing 50 million
- 28. or 100 million in bonds and then we're appropriating only 10

- 9. Mr. President, I just want to enthusiastically support stopping
- 10. at an authorization of 50 million dollars. I have been per-

- 13. for in the light of our competitive relationship with the other
- 14. States that have significant coal resources, but I would urge
- 15. the members of this side to think in terms of all of the bond

- 33. that we're in the ball game and we've got hard dollars on the

line and the 10 million dollars appropriated for fiscal '75 ÷. 2. and 50 million dollars of bond authorization is a significant. 3. ly competitive communication, coupled with the broad other 4. qualification of resources that Illinois has, to move in this 5. question of developing this great resource that we have, the 6. bituminous energy that lies beneath the ground in Illinois. 7. That in fact during fifty...fiscal '75 we'll be on board to 8. equip us to compete effectively with the other States to arrive 9. at a favorable decision. I think Senator Glass has also 10. raised one significant issue here and that is that there are 11. no hard dollars for fiscal '75 provided in any of the Governor's 12. bill...or bills, and I just don't understand that. This sub-13. sequent bill, 1660, is the only legislative proposal that pro-14. vides for hard dollars that is for...before the General Assem-15. bly for consideration now to get us moving in this important 16. program of developing this great Illinois resource that we so 17. badly need as we come...become more and more aware that our

traditional sources of energy are no longer inexhaustible.
