- 29. Senator Shapiro.
- 30. SENATOR SHAPIRO:
- 31. Mr. President and ladies and gentlemen of the Senate. Senate
- 32. Bill 1670 is a new act which requires anyone conducting experimen-
- 33. tal medical research and treating human beings in such research

to explain orally to such persons in layman's terms the possible l. effects of such experiments. It requires a written consent from 2. the persons and requires a written statement of the research to 3. 4. be filed as a public record with the Department of Public Health. 5. Just a little bit of background on this bill. It was originally introduced as House Bill 751 by State Representative Robert Hollo-6. way. It came over here last spring and has been in a sub-commit-7. 8. tee in the Senate Public Health Committee since that time. have held extensive hearings on the bill and have, basically, 9. 10. rewritten the bill which is now introduced as committee sponsored 11. as Senate Bill 1670. The bill now provides for a series of specific safeguards to protect those research subjects in the State 12. of Illinois; and the Illinois Department of Public Health will mon-13. itor these research programs. The safeguards are these: a clinical 14. 15. research may be conducted in Illinois only if that research has been approved by research review committee which is established 16. and operated according to Federal guidelines; that the principal 17. investigator is a physician or a dentist or qualified health 18. 19. scientist; and that there is compliance with all applicable Federal 20. guidelines. Anyone conducting clinical research must determine that the rights and welfare of the subject are fully protected and 21. 22. that the risks to the subject are outweighed by the benefits. A detailed requirement for informed consent is provided and it in-23. cludes the provision for explanation and language which is under-24. standable by the subject. Each research review committee must sub-25. mit to Illinois Department of Public Health detailed quarterly re-26. ports on form which are prescribed by the department. And, the 27. power is given to the Director of the Illinois Department of Public 28. Health, the Attorney General or any State's Attorney to seek an in-29. junction against unapproved clinical research. That in a nut 30. shell explains the thrust and basic requirements of the bill. 31. there are any questions, I will attempt to answer them. Other than 32. that, I would appreciate a favorable roll call. 33.

- 12. according to Federal guidelines; must be a...a mimm...a minimum
- 13. of five persons with varying backgrounds which would insure com-
- 14. plete and adequate review of the activities which will be per-
- 15. formed in any research project. These people have to be quali-
- 16. fied through maturity and experience, expertise in their particu-
- 17. lar field and diversity which to insure respect for its advice
- 18. and counsel. It must be competent and professional; identified
- 19. by names, degrees, profession, etc.; there can be no conflict of
- 20. interest of any member of the research review committee with the
- 21. particular project; and no committee shall consist entirely of a
- 22. single profession.
- 23. PRESIDING OFFICER (SENATOR GRAHAM):
- 24. Further discussion? Senator Rock.
- 25. SENATOR ROCK:
- 26. Well, it just seems to me that if we are establishing this as
- 27. the first paragraph indicates, as a matter of...a matter affecting
- 28. the public health, safety and welfare of the people in our State
- 29. but to them, in the same bill, set up a standard over which we
- 30. have no control seems to me to be less than desirable. If, in

- 31. Senator Mitchler, it applies to the 5% tax on gasoline.
- 32. Yes, totally that 100% would be allocated to that district.
- 33. SENATOR MITCHLER:

Then...then you further say that all other taxes imposed by 1. 2. the Board, but exclusive the amount for the receipts for operating expenses, 2/3rds of those taxes will remain in the district. 3. 4. Is that correct? SENATOR NIMROD: 5. 6. Senator Mitchler, yes. What it does it...it clarifies it and says the gasoline tax of 100%, and the only other tax the 7. President of the Board has any authority for doing is the park-8. 9. ing tax. There would be no other tax at this time that they could apply. But, it would be 2/3rds of any parking tax and 100% 10. of the gasoline tax would be allocated to that district. 11. PRESIDING OFFICER (SENATOR GRAHAM): 12. 13. Senator Mitchler. 14. SENATOR MITCHLER: 15. Well, why...why don't you give 100% of the parking tax also? PRESIDING OFFICER (SENATOR GRAHAM): 16. 17. Senator Nimrod. SENATOR NIMROD: 18. - 25. PRESIDING OFFICER (SENATOR GRAHAM):
- 26. Senator Netsch.
- 27. SENATOR NETSCH:
- 28. I'm not disputing that horseshoers should be competent.
- 29. Everyone should be competent in whatever his chosen occupation
- 30. is. But, why is it only the State that can insure competence
- 31. in this particular area, and why is there not some valid local
- 32. interest in the licensing and regulation of horseshoers?
- 33. PRESIDING OFFICER (SENATOR GRAHAM):

- Senator Weaver.
- SENATOR WEAVER:
- Well, I don't know of any city hall inspector or patronage
- 4. worker in City Hall that has any expertise as far as determining
- 5. whether one is capable of shoeing a horse. These...these duties
- 6. should be performed by one who is competent and examined by compe-
- tent people.
- 8. PRESIDING OFFICER (SENATOR GRAHAM):
- 9. Senator Mitchler.
- 10. SENATOR MITCHLER:
- 11. Mr. President, members of the Senate. I'd just like to
- 12. point out that Illinois in the licensing of horseshoers, is
- 13. leading all of the States and showing to them the proper way
- 14. to go because Illinois is the only State that licenses horse-
- 15. shoers.
- 16. PRESIDING OFFICER (SENATOR GRAHAM):
- 17. Any further discussion? If not, the question before the
- 18. Senate is shall Senate Bill 1531 pass. Those in favor will vo...
- 19. vote Aye. Those opposed will vote No. The voting is open.
- 20. Have all voted who wish? Have all voted who wish? Take the
- 21. record. On this question the Yeas were 28, the Nays were 27,
- 22. 4...none voting Present. And, the bill, having failed to receive
- 23. the constitutional majority, is declared lost. Senator Regner
- 24. would like to...Senator Netsch, do you want to...what do you...
- 25. is your desire on 1280?
- 26. SENATOR NETSCH:
- 27. Not yet.
- 28. PRESIDING OFFICER (SENATOR GRAHAM):
- 29. Not yet Senator Regner, what's your desire on 1326? Sena-
- 30. tor Regner wants the Senate to consider Senate Bill 1326. On the
- 31. order of consideration postponed. Senator Regner.
- 32. SENATOR REGNER:
- 33. Yes, Mr. President and members of the Senate. Senate Bill

- l. 1326 originally was introduced as a...an opt out bill for various
- 2. areas in the RTA area. It failed at that. It is now amended.
- 3. There is nothing in it referring to an opt out, but what it does is
- 4. restructures the Board to give the outlying area some voice and
- 5. some more voice in what happens in the decisions of this Board.
- 6. And, it creates a Board of five members from Chicago, three from

- 17. Thank you, Mr. President. I rise in opposition to Senate
- 18. Bill 1326, As Amended. The amendment makes this bill almost
- 19. identical to that bill, which was proposed by Senator Conolly,
- 20. Senate Bill 1488. I think after the testimony that was heard
- 21. in the Committee on Transportation, Senator Conolly and his mem-
- 22. bership saw the wisdom of letting the bill remain right where it

- does provide for a realignment of that Board after the decennial 31.
- census to again reflect one man, one vote. This amendment, this 32.
- 33. bill, simply does not do that and for that reason I oppose it.

- 1. PRESIDING OFFICER (SENATOR GRAHAM):
- Senator Bell.
- 3. SENATOR BELL:
- 4. Thank you, Mr. President, members of the Senate. You know,
- 5. I...I've constantly been hearing about the one man, one vote con-
- 6. cept in the RTA. I suppose that it's well established that that
- 7. concept is...is a governing concept at this time. But, I might
- 8. suggest to you, Senator Rock, I don't believe there's any...any
- 9. real formal opinion that...from the Supreme or otherwise that
- 10. says that in a RTA District and Regional Transit Authority that
- 11. there has to be a one man, one vote concept. And, that being...
- 12. that being a fact, then, I think, there's really no reason to not
- 13. allow the collar counties that representation that so...they so
- 14. badly...that they so badly desire. Now, to have, out of five
- 15. collar counties, only two members of the RTA Board is dispropor-
- 16. tionate to the interest of those counties as to how they voted
- 17. when their voting records were four to one, all the way to ten
- 18. to one. And while...while there's no way that I can think of that
- 19. we can make this RTA bill, a bill that the collar counties are go-
- 20. ing to want or really accept, other than the opt out. We can't
- 21. have that. This is probably the next most important principle that
- 22. we would like to have. I would certainly hope that the members
- 23. of the other side of the aisle and...and those few members on
- 24. my side of the aisle that have seen fit to impose this RTA upon

- 29. Further discussion? Senator Partee.
- 30. SENATOR PARTEE:
- 31. Well, I hadn't planned to say anything on it, because I
- 32. think What needs to be said has been said. But, what Senator Bell
- 33. just said just really propels me to say, "it depends, Senator Bell,

l. on whose ox is being gored". Now, just the other day when we were 2. considering the members of the school board, you convinced me that 3. the spirit of the law should obtain. You said, oh, sure, maybe, 4. technically you were within the bounds of the law, but the spirit 5. of the law is what we ought to be concerned with about here. Now, 6. let me say to you that the spirit of the law is the spirit as 7. enunciated in Baker versus Karr, that Tennessee case that brought 8. America into the posture where we recognize that people ought to 9. have one man, one vote and the representation ought to be fair 10. across the board. The law, as now constructed, is on a one man, 11. one vote basis. We even, out of fairness, prospective fairness 12. even, went for the amendment that said, "when the population area 13. is changed after each decennial census, the Board should be reconstructed along lines of representation as to the people in the 14. 15. various areas". And, I think, that's fair. We recognize that the 16. collar counties are growing and the cities are diminishing in popu-17. lation. But, even knowing that, we've thought that in fairness we 18. should adhere to the one man, one vote spirit. - 17. Mr. President, I've discussed with the leadership of both
- 18. sides of the aisle, the House Bill 2843 that has been assigned by
- 19. Rules Committee to Judiciary. I've talked to the Chairman of
- 20. Judiciary and the Min...Minority Spokesman. This bill provides
- 21. ...clarifies the apparent inadequacies existing in Chapter 11 of

- 26. Senator Walker, that just shows the road...the world is full

- 28. Second Reading. Senator Smith. We have...House Bills, I'm sorry.
- 29. Did you have...were you...I'll withhold that. Senator Donnewald.

- Yes, there was; my seat mate's bill.

- 6. There has been a motion by Senator Donnewald that House Bills

- Well, Mr. President, at some point in time, I understand now,

7. Senator Partee. 8. SENATOR PARTEE: 9. If I can...if I can be as calm as my colleague, I would like 10. to say to Senator Harris that I know the throws of frustration 11. which are visioned upon you as the head of this Body. I've had 12. it, and I know precisely what you are going through. But, in the 13. interest of your health and of yourself, don't permit yourself to 14. get as uptight as you are because life has a way of going on. 15. - 19. PRESIDING OFFICER (SENATOR GRAHAM):
- 20. Sen...Senator McBroom.
- 21. SENATOR MCBROOM:
- 22. Yes, maybe President Harris would yield to a...a question.
- 23. Either he or Senator Conolly. Why...pro...conceivably, Mr. Presi-
- 24. dent, the problem is, we found in our Appropriations Committee
- 25. that the Secretary of the Department of Transportation was told
- 26. by Mike Duncan to ignore our requests, both mine and our staff.
- 27 ----- bandan ee 15.022 out requests, soen wine and our starr.
- 27. Now, maybe that was the delay. Maybe Secretary Bond hadn't cleared
- 28. this bill early enough with Mr. Duncan. Do you think that's pos-
- 29. sible, Mr. President?
- 30. PRESIDING OFFICER (SENATOR GRAHAM):
- 31. President Harris.
- 32. SENATOR HARRIS:
- 33. Well, that...it's a possibility, I...

- SENATOR MCBROOM:
- 2. Thank you.
- 3. PRESIDING OFFICER (SENATOR GRAHAM):
- 4. Further discussion?
- 5. SENATOR HARRIS:
- 6. Well...
- 7. PRESIDING OFFICER (SENATOR GRAHAM):
- Senator Harris.
- 9. SENATOR HARRIS:
- Mr. President, I just want to make this comment. This bill
- 11. was introduced on the sixth of March. It came to us on the 10th
- 12. of June. It was certainly a possibility, that insofar as the
- 13. department is concerned, that it was going to be considered today.
- 14. That agency has sure got man-power to meet those responsibilities.

- 20. SENATOR SMITH:
- 21. Wait a minute. I have to see...yeah, that's right.
- 22. PRESIDING OFFICER (SENATOR WEAVER):
- 23. Senator Smith asked leave to bring House Bill 2364 back to
- 24. the order of second reading for the purpose of an amendment. Is
- 25. there leave? Leave is granted. Senator Smith.
- 26. SENATOR SMITH:
- 27. On yesterday, I offered...and the Senate adopted an amend-
- 28. ment providing some 250 thousands of dollars be drawn from the
- 29. Illinois Veterans Rehabilitation Fund. That particular effort
- 30. was successful. Now, we have learned since yesterday that in
- 31. order to satisfy Federal Audit requirements, it is necessary to
- 32. indicate that the Federal funds were, and here are the two particu-
- 33. lar words, previously appropriated. This amendment has those two

- Mr. President and ladies and gentlemen of the Senate. House 27.
- Bill 2287 is the substantive language for the Illinois State Scholar-28.
- ship and provides for the new programs that the Scholarship Commis-29.
- sion is embarking upon this year. Probably the major amendment to
- the Scholarship Commission Act is the provision this year in this 31.
- bill, 2287, for aid to part-time students. This will allow those 32.
- students who show a need and who attend colleges and universities on 33.

- a part-time basis to qualify for an...for...for financial aid. It
- 2. is estimated in FY-1975 that approximately 9700 half-time students
- 3. will qualify for a total amount of 2.9 million dollars. In addi-
- 4. tion, this year the Act will authorize fifth year entitlement. It
- 5. will be for those baccalaureate programs such as some engineering
- 6. which require an additional year beyond the four for the person to
- 7. receive their bachelor's degree. In addition, it'll also provide
- 8. aid for those students, who for one reason or another, change their
- 9. major and need to attend school an additional fifth year, and also
- 10. for those students who because of lack of certain elements of edu-
- 11. cation in their secondary education are advised to carry a minimum
- 12. full load time and because of that require five years to complete
- 13. their baccalaureate work. It is estimated that there will be an

- 6. Senator Bell, I think you will recall that a year ago there
- 7. was a bill introduced. It was a separate bill by certain Legis-
- 8. lators in the House and the Senate, concerning part-time scholar-
- 9. ships. The need for the program was described in a 1970, June re-
- 10. port of the Illinois Commission on the Financing of Higher Educa-
- 11. tion and it was documented by a 1973 study entitled, "Financial
- 12. Need of Part-Time Undergraduate Students in Selected Colleges and
- 13. Universities in Illinois". This amendment to the Scholarship Com-
- 14. mission bill has received a lot of study, in my opinion, and I think
- 15. that the program is well-justified, considering the fact that a
- 16. part-time student, who is attending an institution of higher educa-
- 17. tion, is doing it to better himself. It is...he is the student, who,

- 27. PRESIDING OFFICER (SENATOR WEAVER):
- 28. Senator Bell.
- 29. SENATOR BELL:
- 30. Let me ask this further question. Has there been any thought
- 31. or consideration of studying the impact of a part-time scholarship
- 32. program, given by the Board of Higher Education? As I understand
- 33. it, they currently have some studies on tuition and financing of

1. community colleges that's going on at this time. Might that not

2. be the proper place for...for this type of study to...to be done?

3. PRESIDING OFFICER (SENATOR WEAVER):

Senator Shapiro.

SENATOR SHAPIRO:

Well, Senator Bell, it's...it's difficult to answer your 6. 7. question. I... I do think that the... there have been proper com-8. mittees studying the problem, and I think, probably as far as 9. study is concerned, there has...there has been enough input. And, 10. it's my feeling that if a...if a full-time student qualifies who usually has financial resources for parents, so on and so forth, 11. that certainly there is a great number of part-time students who 12. 13. can qualify under the same criteria and maybe just a little bit stricter criteria than the full-time student. I... I think the 14.

problem has been studied as much as it possibly can be.

Well, thank you, Senator Shapiro. I certainly am going to

16. PRESIDING OFFICER (SENATOR WEAVER):

18. accept your answer on the basis of those questions that were 19. asked. I just find that in my mind that philosophically I'm disturbed by the increasing, or the constant increasing, and 20. 21. broadening of scholarship programs. We've increased State funding 22. to education, across the broad basis, all the way from...from the lower grades all the way up through the higher education. 23. 24. have a...just an excellent State Scholarship program as it...as it currently exists. And, while I...I...I can see the need, I 25. suppose, for the part-time student that's...that's going to the 26. community colleges to have some help, he also has the capacity of 27. working part-time. There's...well, it just seems to me that we 28. 29. can go on and on and on with ... with this type of program and it gets to be extremely costly for the State. 30.

31. PRESIDING OFFICER (SENATOR WEAVER):

32. Senator Knuepfer.

33. SENATOR KNUEPFER:

I fell asleep yesterday or was doing something else when this 2. bill came on second reading, 'cause I had an amendment to offer to 3. it relative to the part-time student. When the sponsor, Senator 4. Shapiro, found out what the amendment was, he agreed not to call 5. it back to second reading, 'cause he didn't want the amendment dis-6. In any case, let me express my problem with this bill and 7. that problem is relative to that...to the part-time student's re-8. That part-time student request is an awfully expensive way 9. of solving what should have been a fairly simple problem, and that 10. simple problem is the request of Oscar Shabitt of the City Colleges 11. of Chicago for some State funding so that they could maintain a 12. zero tuition base. I want to explain that this is the prime moti-13. vation for this bill. The Board of Higher Education then approved 14. the concept while the Scholarship Commission knew nothing about it. Now, here's what we're getting for this bill. It will mean a sub-15. sidy of from 20 to 40 dollars per student, part-time student, going 16. 17. to the College city colleges. For that price, we are going to have 18. to administratively handled, in all of the colleges in this State, 19. these kinds of requests. Not only the City College of Chicago, but 20. all of the others. And, it would have been a much less expensive and a much better bill had we met that request head on and provided 21. 22. 5, 6, 7 hundred thousand, whatever it cost. One cannot tell me that 23. it isn't going to cost 20 dollars in administrative cost to provide a 20 dollar subsidy for the college...the students going to this 24. 25. In addition, I think the fact that what the Legislature and the Scholarship Commission has as not yet faced up to, is the 26. 27. question that under Illinois law, 18 year old students are now emancipated. And, the day that that question goes to the courts of this 28. State, our whole Scholarship Commission plan escalates by, I would 29. guess, a factor of 2 or 3. Now, we heard from the Scholarship Com-30. mission that they have some suggested ways of getting around this. 31. And, I could only say if those suggested ways deceive any court in 32. this land, I would be mightily surprised. What you would be doing, 33.

- 1. and I've been able to put my proposed amendment on, the cost of
- part-time students it the equivalent of a grant of 1400 and 50
- 3. dollars to all full-time students and exempting the part-time
- 4. students. If you will take a look at most of the part-time stu-
- 5. dents, I am certain that you are going to find that most of them
- 6. are remancipated and or part-time, and consequently, are going
- 7. to be entitled to the full grants. Their parents are no longer
- 8. supporting them. And, certainly, when the Emancipation Doctrine
- 9. hits the courts. They're not going to be. I... I really think we're
- 10. opening a...I guess Pandora's box is the old one we always talk
- 11. about. But, we really solved a simple problem in a very, very dif-
- 12. ficult way that many of you are going to regret in the future. Be-
- 13. cause part-time student only means six hours, if you will note; and
- 14. six hours is not very much for students to take. I think this
- 15. ought to be considered. I am in total support of all of the other
- 16. porvisions but this part-time provision gives me immense trouble,
- 17. and I think will give you immense trouble in the future.
- 18. PRESIDING OFFICER (SENATOR WEAVER):
- 19. Senator Hynes.
- 20. SENATOR HYNES:
- 21. Mr. President, I believe this bill to be one of the most sig-
- 22. nificant that we are going to see in this session, at least in the
- 23. area of education. I think it is highly desirable. It establishes
- 24. a concept which many of us have supported over the past few years
- 25. here in the General Assembly. This approach, speaking now of the
- 26. half-time student concept, has been recommended by the Board of
- 27. Higher Education and by studies that have been done in the area.
- 28. It is not simply the answer to a peculiar local problem in the
- 29. City of Chicago, as Senator Knuepfer would indicate. It is going
- 30. to be available on a State-wide basis. The fact of the matter is
- 31. that there are many students who for financial or other personal
- 32. reasons are unable to attend school on a full-time basis. Tuition
- 33. ...tuition rates are set in line with the rates charged full-time

- 1. students at a proportionally reduced level, and many are unable
- 2. to afford this level of tuition. This bill requires that a stu-
- 3. dent be taking at least six hours which is one-half of the re-
- 4. quirement that a student must meet to be eligible for full-time
- 5. scholarship assistance. The cost of the part-time scholarship por-
- 6. tion of the bill is 2.9 million dollars. It is a budgeted item.
- 7. It has gone through the...the process now over the past two years
- 8. and, I think, most of the so-called experts in the area of Higher
- 9. Education are in accord on this question and agree that it is time
- 10. that Illinois got into this area. I think the package here is a
- 11. very good one. It increases the level, as Senator Shapiro pointed
- 12. out, to 1350, the maximum ISSC award. It extends the...the time
- 13. for qualifying to five years and it adds this very important half
- 14. time scholarship concept. And, I would urge all members to sup-
- 15. port this legislation.
- 16. PRESIDING OFFICER (SENATOR WEAVER):
- 17. Senator Saperstein.
- 18. SENATOR SAPERSTEIN:
- 19. Mr. President, thank you and ladies and gentlemen. I rose to
- 20. address the...the Chambers and, of course, Senator Hynes said
- 21. many of the things that I wanted to say. But, I want to re-
- 22. emphasize the fact this is not a new program. The first time it
- 23. was introduced in the...in the House, in 1969; it was again studied
- 24. last year when it was introduced. I think it is a good investment
- 25. and it provides equal opportunity for all students who go to
- 26. Higher Education regard...regardless of race, color, creed and
- 27. economic need. And, I think, this is the important thing to recog-
- 28. nize. It's a great contribution toward providing oppor...education-
- 29. al opportunity for our young people. I think it is incorrect for
- 30. us to provide educational opportunity only for the elite. I think
- 31. we do have to think of those students on the lower rung of the
- 32. economic ladder. We have to think of those students who do not have
- 33. support from families, who are working desperately to give them-

- selves an education. I urge your support.
- 2. PRESIDING OFFICER (SENATOR WEAVER):
- Serator Fawell.
- 4. SENATOR FAWELL:
- Well, I...I'm not sure, Mr. President, if I can add anything 5. 6. to what has been said. If ever I have ever been ambivalent about a piece of legislation this is...this is one. The...it's quite 7. correct that we're talking about a brand new concept. The idea 8. that a part-time student will be able to qualify for a scholarship. 9. 10. And, in talking to representatives of the Scholarship Commission, they have agreed that there's an entirely new criteria that has 11. to be determined in order to determine the needs of the applicant. 12. Because of the average, your part-time student is married, and 13. fully-emancipated, and at least partially supporting himself. I 14. 15. had pretty well convinced myself that I would vote for the bill, but most reluctantly. And, I think that's what I shall do, but I 16. would say to everybody in this Body, that this is one piece of 17. 18. legislation we ought to most carefully look at and see just what the Illinois Scholarship Commission does do with it. What is the 19. 20. criteria they use? I was interested in the statements made by Senator Knuepfer because he was repeating some allegations which 21. 22. have been given to my by the State Chamber of Commerce. And yet, when Mr. Beckwith testified before our Senate Education Committee, 23. 24. I don't recall him coming out with those statements. If it is true, I...I really wish it had been something that had been brought out 25. before the Education Committee, so we would have had time for re-26. buttal and some cross-examination, as it were. I think, too, that 27. 28. we have to recognize that as the private colleges and universities take more and more a share of the public dollar that, eventually, 29. the day of reckoning is going to come, and perhaps the confronta-30. tion to a degree between public and private higher educational in-31. stitutions over use of the public dollar. And, I think very, very 32. clearly our private colleges, of which I am a product both under-33.

graduate and in law school, have to recognize that they are going
 to have to bear a great deal more responsibility to serving the

to have to bear a great dear more responsibility to serving the

3. community and not be able to perform so arbitrarily and in rather

4. narrow limits in regard to the type of student they're going to
5. serve. They have to, in other words. I think, if they're going

serve. They have to, in other words, I think, if they're going to

continue to take the many, many millions they're now taking from

7. the public. There're going to have to be a lot more conscience

8. about serving all of the people, even some students who may not

9. be in the upper 10 or 25% of their high school graduating class.

10. Very...it's a tough bill. I couldn't criticize anyone who

11. votes for it or against it. I am very ambivalent and, reluctantly,

12. I...I don't suppose this is saying anything for the bill. But, I

13. probably, thus, will vote a very weak Yea for the bill.

14. PRESIDING OFFICER (SENATOR WEAVER):

15. Any further discussion? Senator Shapiro may close.

16. SENATOR SHAPIRO:

Mr. President and ladies and gentlemen of the House, sin...since 18. most of the discussion and opposition has centered around the part-19. time student, I thought possibly for the benefit of those who are 20. not in the Senate Education Committee, it would be well just to 21. describe the part-time student and I think it will relay some of 22. the fears that have been raised. The part-time student is a 25 23. year old married male with 2.05 members in the family. He is a 24. Sophomore in a baccalaureate curriculum and he takes approximately 25. 6.6 credit hours after 5 p.m. on an average of median of 2 days a

26. week and he travels approximately 8 miles one day. He attended

school last year on a full-time basis and had to drop out and go

28. part-time because of financial reasons. He picks his institution

29. because of location and curriculum. He pays his own tuition and

30. fees of 180 dollars. He works full-time and he earns between 6

31. and 8 thousand dollars. Mr. President, ladies and gentlemen of

- 12. Would the sponsor of that amendment yield to a question?
- 13. PRESIDING OFFICER (SENATOR WEAVER):
- 14. He indicates that he will, Senator.
- 15. SENATOR CONOLLY:
- 16. When do you anticipate coming in for the appropriation for
- 17. moving expen...expenditures, new furniture, and so forth, for
- 18. such a move?
- 19. PRESIDING OFFICER (SENATOR WEAVER):
- Senator Rock.
- 21. SENATOR ROCK:
- 22. There is also in Amendment No. 4 a line item for expenses
- 23. related to relocation of the commission offices to the County
- 24. of Sangamon in the amount of ten thousand dollars. The office
- 25. furniture, and so forth, that will be necessary can be right
- 26. now amply provided by the Department of General Services.
- 27. PRESIDING OFFICER (SENATOR WEAVER):
- 28. Senator Conolly.
- 29. SENATOR CONOLLY:
- 30. I would like to support the motion of Senator Glass' and,
- 31. in turn, support the motion that the operation of the Illinois
- 32. Scholarship Commission is established. It is a viable going
- 33. situation in the community, and may I point out that there...

- 1. from my understanding, there are a tremendous number of housewives
- 2. and so forth who are trained to work part-time when the work load
- 3. is high and these women come in for three hours or five hours a
- 4. day. They are trained personnel, and it's worked out very well in
- 5. the community. And, I think it would change the ... we have very lit-
- 6. tle State agencies, State employees in Lake County, and I think the
- 7. part-time basis here has worked out in the past and, I think, it
- 8. should stay in the community of Lake.
- 9. PRESIDING OFFICER (SENATOR WEAVER):
- 10. Senator...Senator Rock.
- 11. SENATOR ROCK:
- 12. Well, in response to Senator Conolly, I would like him to
- 13. point out to me any other single state agency that has its sole
- 14. office in a place other than Chicago or the Capitol City of Spring-
- 15. field. And, I would further point out that the Board of Higher Ed.
- 16. last year moved to Sangamon County, to Springfield, and it's func-
- 17. tioning about as well as it ever did, which isn't much, by the way.
- 18. PRESIDING OFFICER (SENATOR WEAVER):
- 19. Senator Glass, or Senator Knuepfer.
- 20. SENATOR KNUEPFER:
- 21. Well, it...it seems to me, and obviously I'm not from that

- 4. Well, we all know about Kentucky Fried Chicken and Lums and a

- 8. Senator Carroll.
- 9. SENATOR CARROLL:
- 10. To the best of my knowledge, not at all. We have not changed

- 13. to be franchises from the manufacturers.

- 7. Yeah, OK, Yeah, Mr. President. Amendment No. 16 will have
- 8. the effect of changing the figures in the existing Section 14, which
- 9. provides for the distribution to the counties and townships and
- 10. municipalities. Legislation elsewhere being considered, it's a
- 11. bill being handled by Senator Schaffer that was heard in Trans-
- 12. portation today, will amend the State formula on motor fuel. We've

- 25. second the municipalities and then C-ok and the 101 Downstate coun-
- 26. ties would receive thirty-one, seven, which would be...in the
- 27. bill now and this would be increased to thirty-seven, two. I urge
- 28. the adoption of Amendment 16.
- 29. PRESIDING OFFICER (SENATOR WEAVER):
- 30. Is there any discussion? All in favor of adopting Amendment
- 31. No. 16 to Senate Bill 1345 signify by saying Aye. Opposed Nay.
- 32. The amendment's adopted. For the record, I would like to say that
- 33. Amendment No. 15 was adopted to Senate Bill 1345, rather than

- 1. 1669.. Senator Hynes.
- 2. SENATOR HYNES:
- 3. Mr. President, even though the amendment has been adopted,
- 4. I...I would simply say that there is some, at least slight dis-
- 5. agreement on those percentages. But, basically, at this point

- 29. PRESIDING OFFICER (SENATOR MOHR):
- Senator Glass.
- 31 SENATOR GLASS:
- 32. Mr. President, we can take this bill first, if you wish, al-
- 33. though it...it really is in support of the other bill. And, I,

- 10. Yes, but I wish I had Senator Glass' and Senator Harris'
- 11. attention. There's another bill in this...Senator Harris and
- 12. Senator Glass...
- 13. PRESIDING OFFICER (SENATOR MOHR):
- 14. Senator Harris. Senator Glass.
- 15. SENATOR PARTEE:
- 16. Senator Harris, there is another bill in this series, 1667.
- 17. I think it is on the Secretary's Desk and should be reported
- 18. out, and moved to the order of second reading for an amendment.
- 19. And then, we could go, you know, the whole package.
- 20. PRESIDING OFFICER (SENATOR MOHR):
- 21. President Harris.
- 22. SENATOR HARRIS:
- 23. Yeah. It is a bill on this subject, but it is not in this
- 24. series. But, it has taken on significance and, it should go.
- 25. And, is it on second reading? 1667?
- 26. PRESIDING OFFICER (SENATOR MOHR):
- 27. It is on second. It was reported out of committee this
- 28. morning.
- 29. SENATOR HARRIS:
- 30. Would you...you have an amendment for it, Senator Partee?
- 31. Or, do we?
- 32. SENATOR PARTEE:
- 33. You have the amendment.

- ı. SENATOR HARRIS:
- 2. OK. And, that is the Quick-Take amendment to 1667.
- 3. PRESIDING OFFICER (SENATOR MOHR):
- 4. Correct. That's correct.
- 5. SENATOR HARRIS:
- 6. Now, Senator Glass, do you wish to proceed with 1662, or
- 7. do you want to consider the amendment to 1670...1667 first?
- 8. PRESIDING OFFICER (SENATOR MOHR):
- 9. Is that...Senator Glass.
- 10. SENATOR GLASS:
- 11. Well, Mr. President, I... I don't think it makes a bit of dif-
- 12. ference. 1667 is the Quick-Take part of this series. It is a
- 13. necessary bill. I would suggest we just go ahead with this package
- 14. now, unless Senator Partee prefers to put the amendment on now.
- 15. don't think it matters.
- 16. PRESIDING OFFICER (SENATOR MOHR):
- 17. It's on second now. It'll be on third tomorrow. We can act
- 18. on it tomorrow morning, if that's agreeable. We'll read it, Sena-
- tor Partee, with your permission after we go through these four 19.
- 20. bills. Is that all right? All right. Senator Glass.
- 21. SENATOR GLASS:

- 22. Mr. President and members of the Senate. As finally amended,
- 23. these four bills address the problem of developing Illinois Coil
- 24. and converting it into energy in a very significant way. With the
- 25. 139 billion tons of recoverable coal in Illinois, I think it's
- 26. high time this State took affirmative action to create an energy
- 27. authority, and energy legislation to address the problem.
- 28. these bills do, As Amended, is as follows: 1659 would create the
- Energy Co-ordinating Council. This council would have the power 29.
- to enter into contracts with business, industry, university and
- 31. other governments and qualified individuals to promote the develop-
- ment of coal resources. Senator Rock, a moment ago, gave you the 32.
- membership of that council, and I won't read through the...the heads 33.

- of all the departments again, but in essence, this is a...a coun cil chaired by the Lt. Governor and made up of a number of heads
- of departments of the Administration. Now, that, I think it's
- 4. important to note, that in entering into contracts for the develop-
- 5. ment of coal resources, that council does not have complete auton-
- 6. omy. But, any projects that it proposes must be approved by a
- legislative commission. Now, that legislative commission is created
- by a different bill and it's made up of eight Legislators; four
- 9. House members, four Senate members, and eight public members.
- 10. The breakdown of the Legislative members includes bipartisanship
- 11. and co-chairmen. So, I think, the...the strength of this commis-
- 12. sion is that it is bi-partisan and it is autonomous; and the Legis-
- 13. lature is a true partner with the administrative branch...the execu-
- 14. tive branch in the energy...the coal energy projects. Another con-
- 15. cern, and that...that was much debated, regarding these bills, is
- 16. the amount of bonding power. Now, I know that because of the
- 17. questioning when these bills came up several days ago, some of the
- 18. members are concerned about the amount of bonding power granted.
- 19. As Amended, there is bonding authorization by the State of Illinois
- 20. and administered by the Bureau of the Budget of 70 billion...70
- 21. million dollars. Now, that...that 70 million dollars is up from
- 22. an original 10 million which was in the bills at the outset.
- 23. Reasons for the increase, I think, primarily are to put Illinois in
- 24. a competitive position with other states in bidding for these
- 25. Federally financed energy projects. The State of Kentucky, I
- 26. think, as most of you will recall, has approved the sale of 57
- 27. million in bonds over a five year period. This will put Illinois
- 28. ahead of Kentucky. The appropriation bill, however, is for 10
- 29. million. We would appropriate only 10 million this year. We
- 30. would give the commission an opportunity to further study this im-
- 31. portant area and determine whether additional bonding power was
- 32. needed. I might say that it's a package that has had considerable
- 33. attention of many members in the Legislature, many members of the

- 1. Senate, rather, leadership on both sides. And, I think it's
- 2. finally in a position that should be acceptable to most of the
- 3. members. I'd be happy to answer any questions and would hope
- 4. that we could get a...an affirmative and a resounding vote in favor
- 5. of these four bills.
- 6. PRESIDING OFFICER (SENATOR MOHR):
- Senator Knuepfer.
- 8. SENATOR KNUEPFER:
- Well, I...I can only say that it's as an immense and a case
- 10. of over-reaction as I think I have ever seen. What you are doing
- 11. by this is capitalizing an expense that ought to come out of cur-
- 12. rent expenditures. And, if you really want to spend 70 million
- 13. dollars and face up to it, then you ought to spend it out of
- 14. General Revenue. Now, I come out of the private economy. And,
- 15. the only firms that capitalize, or say we're going to spend these
- 16. later, we're gonna pay for them later, are those firms who are
- .17. on the rocks to begin with. If this expenditure is justified for
- 18. research, then it is justified for immediate payment, and not for
- 19. saddling any future generation with. It...there is no excuse,
- 20. in my book, for bonding research projects, where the expectations
- 21. of return are zero. Whatever returns come about, will be returns
- 22. to some private agencies rather than to the State of Illinois.
- 23. Now, I can't tell you that I am totally in objection to the whole
- 24. concept; but, I am very much in objection to adding to the bonding
- 25. power...to adding to the bonding obligations of the State of Illi-
- 26. nois for a concept that I am firmly...firmly believe ought to be
- 27. paid for out of today's revenue. I guess I'm a little old-fash-
- 28. ioned in this, however, because we keep putting more and more on
- 29. the Bonding Act. And, we had a discussion with the Director of
- 30. the Bureau of the Budget, Hal Hovey, today, when he puts painting
- 31. and screens and bonds them. If we keep up, and we've done this in
- 32. three major bond issues since I've been here, we will soon have
- 33. the State of Illinois bonds selling at a very substantial discount.

- 1. There is no excuse for bonding except that the Legislature refuses
- 2. to face up to the fact that this ought to come out of General
- 3. Revenue. And, I object very violently to this kind of a concept
- 4. that suggests, in any way, that this is bondable because there
- 5. is no way of measuring how this returns to the State of Illinois.
- 6. And, some future Administrations are going to have to put an item
- 7. in their budget to repay these bonds, and they will have no income,
- 8. whatsoever, to offset these...that...those expenditures.
- 9. PRESIDING OFFICER (SENATOR MOHR):
- 10. Further discussion? The question is shall Senate Bill 1662
- 11. pass. Those in favor will vote Aye. Those opposed will vote Nay.
- 12. The voting is open. Have all voted who wish? Take the record.
- 13. On that question the Yeas are 40, the Nays are 13. Senate Bill
- 14. 1662, having received the constitutional majority, is declared
- 15. passed. The next bill will be 1659. Senate Bill 1659.
- 16. SECRETARY:
- 17. Senate Bill 1659.
- 18. (Secretary reads title of bill.)
- 19. Third reading of the bill.
- 20. PRESIDING OFFICER (SENATOR MOHR):
- 21. Senator Glass.
- 22. SENATOR GLASS:
- 23. Well, Mr. President, thank you. I think, to clarify for the
- 24. membership, we asked leave to discuss, Senate Bill 1659, 60, 61,
- 25. and 62. Because there were no amendments to 62, we voted on that
- 26. first. 1659 is the primary substantive bill which has been dis-
- 27. cussed. And, I would ask for a favorable roll call.
- 28. PRESIDING OFFICER (SENATOR MOHR):
- 29. Further discussion? Senator Knuepfer.
- 30. SENATOR KNUEPFER:
- 31. Well, on another area, I can't imagine a bill that provides
- 32. more potential for log-rolling than the concept, and I'm talking
- 33. to the package, again; I'm not talking to this specific bill, than

- the concept that provides a legislative commission to make the fi-
- nal determination on which projects will be approved and which will
- not be approved. And, I suspect, that commission ought to be made
- 4. up of all members south of Springfield.
- 5. PRESIDING OFFICER (SENATOR MOHR):
- 6. Further discussion? Senator Berning.

## 7. SENATOR BERNING:

- 8. Well, Mr. President and members of the Body. I assume that
- 9. there is more than enough support for these bills and the concept
- 10. is not objectionable; however, had this lonely Senator had just a
- 11. few minutes to consider this, I would have attempted some kind of
- 12. an amendment to assure that as proceeds develop as a result of
- 13. these activities, the State would be reimbursed. I see no justi-
- 14. fication for the State of Illinois, the taxpayers, thereof, footing
- 15. an expensive project to develop and devise a system which will reap
- 16. huge profits to some private enterprises. There ought to be, Mr.
- 17. President and members of the Body, some obligation contained with-
- 18. in this measure that whomever benefits from the processes generated
- 19. must pay some sort of licensing fee or percentage of profit back to
- 20. the State of Illinois, so that our taxpayers will be relieved of
- 21. the burden in due time, or at least be reimbursed for same.
- 22. PRESIDING OFFICER (SENATOR MOHR):
- 23. Senator Glass.

## 24. SENATOR GLASS:

- 25. Well, Mr. President, briefly, in response to the comments of
- 26. Senator Knuepfer and Senator Berning; Senator Knuepfer, the com-
- 27. mission that is contained in Senate Bill 1659 is actually a council,
- 28. the council, which we've already discussed, chaired by the
- 29. Lt. Governor, comprised of the heads of the various departments, is
- 27.
- 30. authorized to negotiate contracts. The Legislative Commission, com-
- posed of eight Legislators and eight public members, has an approval power over those contracts. So, it involves both the Executive and
- the Legislative Branch. In response to Senator Berning, it's dif-

- 1. ficult to point precisely at...at dollar benefits from this legis-
- 2. lation. However, I would only remind you that Illinois has one of
- the two, either...we are either first or second in...in recoverable
- 4. coal deposits of all the States in the United States. I think the
- 5. effects upon our economy of a successful process for mining and
- 6. selling coal are...will be enormous. The employment which will be
- provided, the new industry which will be attracted to the State of
- 8. Illinois, the...the spin-offs, the related industries; I think, are
- 9. significant. This was discussed at some length at our committee
- 10. hearings, and...and, I have no doubts that Illinois can benefit
- 11. economically and greatly from the passage of these bills. And, I
- 12. would ask, Mr. President, for a favorable roll call on Senate Bill
- 13. 1659.

- 14. PRESIDING OFFICER (SENATOR MOHR):
- 15. Further discussion? The question is shall Senate Bill 1659
- 16. pass. Those in favor will vote Aye. Those opposed will vote
- 17. Nay. And, the voting is open. Have all voted who wish? Take
- 19. Senate Bill 1659, having received the constitutional majority, is
- 20. declared passed. The Chair would point out that this bill requires

- 31. Mr. President, this is the appropriation bill. It appropriates

- 33. ask for a favorable roll call.

- 1. PRESIDING OFFICER (SENATOR MOHR):
- Further discussion? The question is shall Senate Bill 1660
- pass. Those in favor will vote Aye. Those opposed will vote Nay.
- 4. The voting is open. The Secretary will read this bill a third
- 5. time.
- 6. SECRETARY:
- Senate Bill 1660.
- 8. (Secretary reads title of bill.)
- 9. Third reading of the bill.
- 10. PRESIDING OFFICER (SENATOR MOHR):
- 11. On that question the Yeas are 45, the Nays are 11. Senate
- 12. Bill 1660, having received the constitutional majority, is de-
- 13. clared passed. Senator Latherow. The next bill will be Senate
- 14. Bill 1661.
- 15. SECRETARYL
- 16. Senate Bill 1661.
- 17. (Secretary reads title of bill.)
- 18. Third reading of the bill.
- 19. PRESIDING OFFICER (SENATOR MOHR):
- Senator Glass.
- 21. SENATOR GLASS:
- 22. Mr. President and Senators. This is the final of the four
- 23. bills...this energy bill package. This is the bill creating the
- 24. Joint Legislative Commission on Energy, composed of sixteen mem-
- 25. bers, eight from the General Assembly and eight public members.
- 26. I think we've described its function previously. But, in addi-
- 27. tion to the power to approve the energy projects, it will, it is
- 28. assigned the responsibility...the responsibilities of determining
- 29. long-range energy policies for the State. I would be happy to
- 30. answer any questions. And, if there are none, ask for a favorable
- 31. roll call.
- 32. PRESIDING OFFICER (SENATOR MOHR):
- 33. Senator Knuepfer.

- SENATOR KNUEPFER:
- I just want to speak to the concept again. Senator Sours
- 3. has from time to time referred to the convention of the nine
- 4. old men. From time to time, we have tried to take away from some
- 5. local governments some aspects of home rule on the grounds that
- 6. they were not fiscally responsible. In the last four years,
- 7. since the new Constitution has been in effect, the most irrespon-
- 8. sible body in the State of Illinois has been the Legislature in
- 9. using its bonding power. I was a supporter, and still am, of the
- 10. new Constitution. But, if you have another five years at this
- 11. rate, you are going back to a new Constitutional Convention;
- 12. back to where we were before, where we put limitations and re-
- 13. strictions on everything. This Body does not seem to have any
- 14. disicipline in terms of putting off till tomorrow those expendi-
- 15. tures which are today's expenditures and which should come out
- 16. of today's revenues.
- 17. PRESIDING OFFICER (SENATOR MOHR):
- 18. Fur...Further discussion? Secretary will read the title.
- 19. SECRETARY:
- 20. Senate Bill 1661.
- 21. (Secretary reads title of bill.)
- 22. Third reading of the bill.
- 23. PRESIDING OFFICER (SENATOR MOHR):
- 24. The question is shall Senate Bill 1661 pass. Those in favor
- 25. will...will vote Aye. Those opposed will vote Nay. The voting
- 26. is open. Have all voted who wish? Take the record. On that ques-
- 27. tion the Yeas are 43, the Nays are 8, 2 voting Present. Senate
- 28. Bill 1661, having received the constitutional majority, is de-
- 29. clared passed. On Second Reading. Senate Bill 1667.
- 30. SECRETARY:
- 31. Senate Bill 1667.
- 32. (Secretary reads title of bill.)
- 33. Second reading of the bill. No committee amendments.

- 1. PRESIDING OFFICER (SENATOR MOHR):
- Senator Partee. Amendments.
- SECRETARY:
- 4. Amendment No. 1 by Senator Partee.
- 5. PRESIDING OFFICER (SENATOR MOHR):
- 6. Senator Partee.
- 7. SENATOR PARTEE:
- 8. Amendment No. 1 to 1667 simply makes it the Energy Co-ordinat-
- 9. ing Council instead of the Illinois Coal Development Bond Act.
- 10. Now, this is the Quick-Take Amendment, which is absolutely essen-
- 11. tial if this organization is to become viable. Any questions, I'd
- 12. be happy to answer. Otherwise, I'd ask for the adoption of the
- 13. amendment.
- 14. PRESIDING OFFICER (SENATOR MOHR):
- 15. Further discussion? Senator Glass.
- 16. SENATOR GLASS:
- 17. Mr. President, as discussed earlier, this is an important
- 18. amendment to the Energy Coal Package. And, I would urge a favor-
- 19. able roll call.
- 20. PRESIDING OFFICER (SENATOR MOHR):
- Senator Knuepfer.
- 22. SENATOR KNUEPFER:
- 23. Can you give me one instance, Senator Glass, in which you
- 24. think the Quick-Take is needed? This is no small power, you
- 25. know.
- 26. PRESIDING OFFICER (SENATOR MOHR):
- Senator Partee.
- 28. SENATOR PARTEE:
- 29. In order to qualify, under the Federal guidelines and for a
- 30. Federal project, it becomes necessary to be able to prove that
- 31. you can acquire the land needed for whatever project is to be
- 32. funded by the Federal Government. If you'll look at the statute
- 33. in Kentucky, they have it. If we're going to be competitive, we

- 1. have to have it. Without Quick-Take, we will be waiting for six
- 2. or eight months in order to qualify for the projects.
- absolutely essential, Senator.
- 4. PRESIDING OFFICER (SENATOR MOHR):
- 5. Senator Knuepfer.
- 6. SENATOR KNUEPFER:
- 7. Well, I...I'm not sure I'm convinced by that. It seems to
- 8. me that it takes the Federal Government that long even to get
- 9. tuned up for one of these kinds of projects. And, I...I just
- 10. react violently to the Quick-Take power. It's a way of depriv-
- 11. ing a citizen of his right without even so much as a by-your-
- 12. leave. And, it requires, I have to be substantially persuaded,
- 13. that there is a dire and immediate nec...emergency before I'm
- 14. willing to grant this; and then, only on a very, very limited
- 15. basis. I am not persuaded that these...this meets that test.
- 16. PRESIDING OFFICER (SENATOR MOHR):
- 17. Senator Partee.
- 18. SENATOR PARTEE:
- 19. Well, Senator, it may be that it takes the Federal Government
- 20. a long time to do some things. But, I would say to you that they
- 21. require more of others than they do of themselves. And, we're the
- 22. ones who have to qualify. And, this is no new kind of power in
- 23. this State. As you know, the State has Quick-Take Powers, the
- 24. Illinois Toll Highway Authority, the St. Louis Metropolitan Area
- 25. Airport Authority, BED had it for the Particle Accelerator, the
- 26. Metropolitan Sanitary District has it, and even the North Shore
- 27. Sanitary District has it as of the present moment. So, this is
- 28. nothing new for Quick-Take Powers, and I think you understand that.
- 29. PRESIDING OFFICER (SENATOR MOHR):
- 30. Senator Sours.
- 31. SENATOR SOURS:
- 32. Mr. President and Senators. The coal to be taken or on which
- 33. the...an energy plant will be constructed has to necessarily be in

- 1. a coal field or near a coal field. Now, you don't find too much of
- 2. that in Chicago, and I tell you, Senator Partee, you can file a suit
- 3. in Peoria County right now, and I can get you a trial before Christ-
- 4. mas. i think most of us know why everything is so delayed in Chicago,
- 5. and in some of the farther down southern counties, you could file a
- 6. suit and I'll...I'll promise you you'll get a...a trial, in 60 days;
- 7. 90 days; 120 days, if the court doesn't permit the lawyers to fiddle
- 8. around in it. We don't need this any more. When you recite the...
- 9. the...the agencies that have that, that just compounds the depriva-
- 10. tion of private property.
- 11. PRESIDING OFFICER (SENATOR MOHR):
- 12. Senator Fawell.
- 13. SENATOR FAWELL:
- 14. Well, I...I can't find the bill anywhere on the calendar.
- 15. PRESIDING OFFICER (SENATOR MOHR):
- 16. Senator, this bill was reported out this morning and advanced
- 17. to the order of second reading. That's why it isn't on your calen-
- 18. dar.
- 19. SENATOR FAWELL:
- 20. Is it...is it...I don't...I don't suppose it's in the...is
- 21. it on our desks?
- 22. PRESIDING OFFICER (SENATOR MOHR):
- 23. Senator Partee.
- 24. SENATOR PARTEE:
- 25. Because it was passed out this morning, it isn't in your...on
- 26. your calendar. So, we had some copies made and they were put on
- 27. your desk about four or five hours ago. It's on your desk unless
- 28. someone has removed it.
- 29. SENATOR FAWELL:
- 30. Well, judging from the digest, though, you are amending the
- 31. Capital Development...the Capital Development Board; the basic act
- 32. of the Capital Development Board in granting...granting Quick-Take.
- 33. Let me..:

- PRESIDING OFFICER (SENATOR MOHR):
- Senator Partee.
- 3. SENATOR PARTEE:
- 4. I don't know if you have the proper bill before you. It's
- 5. 1667. This bill amends the Eminent Domain Act.
- 6. PRESIDING OFFICER (SENATOR MOHR):
- Senator Fawell.
- 8. SENATOR FAWELL:
- 9. But, apparently in the Eminent Domain Act you make reference
- 10. to the Capital Development Board Act, and apparently you're grant-
- 11. ing to the Capital Development Board Eminent Domain powers, and,
- 12. I don't think they have those powers now. Am I...
- 13. PRESIDING OFFICER (SENATOR MOHR):
- Senator Partee.
- 15. SENATOR PARTEE:
- 16. What you're reading is a bill prior to the amendment. The
- 17. bill was amended. You were sitting right there at the time it
- 18. was amended.
- 19. PRESIDING OFFICER (SENATOR MOHR):
- 20. Senator Fawell.
- 21. SENATOR FAWELL:
- 22. I don't know if...if any of us on the Floor know what's hap-
- 23. pening. I...I can only say this. If what is happening is that
- 24. you are granting to the Capital Development Board Eminent Domain
- 25. powers, I certainly would be very much against that.
- 26. PRESIDING OFFICER (SENATOR MOHR):
- 27. Senator Partee.
- 28. SENATOR PARTEE:
- 29. We are not, Sir. Yeah, I... I understand. I'm sorry you
- 30. weren't listening. You would be edified as to what's going on.
- 31. PRESIDING OFFICER (SENATOR MOHR):
- Senator Fawell.
- 33. SENATOR FAWELL:

- Sometimes it's...it's difficult to listen on the Floor.
- SENATOR PARTEE:
- I know that, and that's because there's a lot of noise and
- 4. that sort of thing. But, it happens.
- 5. SENATOR FAWELL:
- 6. I'm...I'm sorry, then, to ask a question which the
- 7. answer to which I probably should know. Very briefly then, insofar
- 8. as CDB is concerned in Eminent Domain power, what in its Amended
- 9. version does the bill do?
- 10. PRESIDING OFFICER (SENATOR MOHR):
- 11. Senator Partee.
- 12. SENATOR PARTEE:
- 13. First of all, CDB is not involved at this moment. We now
- 14. have, by the series of bills passed by Senator Glass, an Energy
- 15. Co-ordinating Council. And, the Quick-Take Powers are given to
- 16. the Energy Co-ordinating Council. Period.
- 17. PRESIDING OFFICER (SENATOR MOHR):
- 18. Further discussion? Further amendments? Third reading. All
- 19. those in favor...no, I'm sorry. All those in favor of adoption of
- 20. Amendment No. 1 to Senate... Senate Bill 1667. Request for a roll
- 21. call. President Harris.
- 22. SENATOR HARRIS:
- 23. Well, Mr. President, I just want to make this perfectly clear.
- 24. Now, let's settle down here, not get in too big of a hurry. If
- 25. there is a member in this Body that is reluctant to extend the
- 26. power of Quick-Take, it is I. I'm convinced that this is neces-
- 27. sary. And, I have carefully concluded that the amendment to the
- 28. Eminent Domain Act to include Quick-Take Power for the Energy Co-
- 29. ordinating Council, and if you will listen, this is very narrowly
- 30. drawn for the purposes specified in the Illinois Coal Development
- 31. Bond Act as enacted by the 78th General Assembly in 1974. No
- 32. more. But, we have provided for Quick-Take Power to the Energy
- 33. Co-ordinating Council for these purposes, and these purposes only.

- 1. And, I'm a real slow person to authorize Quick-Take. But, in this
- 2. problem that we all face; as the greatest energy consuming nature
- з. nation in the world, and the nation that possesses one of the
- 4. greatest energy resources that have not been conformed to uses in
- 5. 1974, and 1980, and 1990 - coal. I believe this amendment is es-
- 6. sential for us to proceed toward the development of this resource.
- 7. In competition with and in juxtaposition to our sister States that
- 8. are likewise possessed of this resource. Now, I think this amend-
- 9. ment is sound and necessary. And, I would urge its adoption.
- 10. PRESIDING OFFICER (SENATOR MOHR):
- 11. For what purpose does Senator Regner rise?
- 12. SENATOR REGNER:
- 13. Mr. President and members of the Senate. All the arguments
- 14. we've heard in favor of this Quick-Take authority for these bills
- 15. are the same arguments we heard last Fall on Eminent Domain regard-
- 16. ing the RTA. And, what have we done in the last six weeks? We've
- passed two bills regarding Eminent Domain on the RTA; changed our 17.
- 18. positions that it's really not right, and I say it's the same thing
- 19. here. We pass this bill now, or this amendment, and the bill
- 20. tomorrow. We're going to turn right around in the next couple months
- 21. and want to be amending it out.
- 22. PRESIDING OFFICER (SENATOR MOHR):
- 23. Further discussion? There's a request for a roll call on the
