You know, Mr. President, we hear a lot about the eight hour a day; 24. 25. and I'd like to point out that our staff and secretaries, this 26. is both sides of the aisle, many of them have been working almost around the clock, and I think the play from the other side 27. 28. of the rotunda is something that people should really look into. 29. I'm pointing to the leader of that group over on the other side, 30. the Speaker, and the number of leaders of the other blocks. would say, Mr. President, that it's about time that they quit 31. 32. playing this waiting game and get out of the holding pattern and

get us back to work. We could wrap this up in about six hours

l. time if people would just be a little considerate, and it makes 2. this Senator sick to see what we're doing to people that work 3. for State Government. You look at the number of people that are 4. employed here, the secretaries and the staff and the Security 5. people that are called upon to...to work 12, 18, 20 hours a day 6. and then come back here and supposed to be fresh and sharp the 7. next morning. It's just ridiculous. Most unconsiderate...or 8. inconsiderate. I would point out too, Mr. President, that it 9. costs the State, the taxpayers, the people of Illinois, 8,000 10. dollars a day just for Legislators to be down here. 11. I don't have the figures, Mr. President, on the salary or the ...the employees' payroll, but it's considerable. We have, for 12. example, in this Senate Operation approximately 150 people. Now 13. I like to work as well or probably more than most people. 14. 15. used to long hours. The hours don't bother me as long as we're 16. being productive and we certainly aren't being productive, Mr. President. I think probably what disturbs me the most is, you 17. 18. know, you read every day in the paper the last week or so that 19. there are no deals, and I would invite the press, Mr. President, 20. to go over and camp outside the Speaker's door and see who's 21. visiting him in...in these days, at great length. It's the 22. Governor of the State of Illinois, Victor de Grazia, who's 23. spending all his time in there. If Gov...the other Governor, Dan Walker, doesn't know that, and maybe he doesn't know there's 24. 25. deals going on, but I'd like... I hope that somewhere he's listen-26. ing to this message and would suggest to him that maybe he put a tag or Donald Page Moore, or somebody on Victor de Grazia, and 27. see where he spends his days. Who...you know, it's just sicken-28. ing, is about the best word that I can use, Mr. President, the 29. actions of the Speaker of the House and the Governor, and we've 30. been down here two days over the deadline of June 30th and if 31.

- Senator Graham. For what purpose Senator Graham arise?
- SENATOR GRAHAM:
- Sena...for a little interlude on a lighter tone. I know
- 4. that there is no one around here more tired than John Graham.
- 5. I got in about 116 hours last week and that's quite a few and
- 6. that was not overtime. But I would like to read this to my
- colleagues, men who are here because they're devoted, not here
- 8. because they were paid. If you'll bear with me just a moment.
- 9. A careful man I want to be for a little fellow follows me. I
- 10. do not dare to go astray for fear he'll go the self-same way.
- 11. I cannot once escape his eyes, what ere he sees me do he trys.
- 12. Like me he says he's going to be, that little chap who follows
- 13. me. He knows that I am big and fine and believes in every word
- 14. of mine. The base he must not see, that chap that follows me.
- 15. I must remember, as I go, through summer suns and winter snow,
- 16. I'm building for the years to be for the little chap that follows
- 17. me, and in connection with what Senator Howard Mohr says, which
- 18. is so seldom printed by the learned members of the media, that
- 19. many members of this General Assembly has spent their time in
- 20. Springfield performing a duty for their Country while their
- 21. family grew up without them. Thank you very much.
- 22. PRESIDING OFFICER (SENATOR WEAVER):
- 23. ...Senator Knuppel arise?
- 24. SENATOR KNUPPEL:
- 25. On a point of personal privilege. I...
- 26. PRESIDING OFFICER (SENATOR WEAVER):
- 27. State your point.
- 28. SENATOR KNUPPEL:
- 29. ...in the last eight days I think we've been here until after
- 30. midnight, or quite a ways after midnight, on four separate occasions.
- 31. On Friday we spent six hours without even turning a tap here while
- 32. things stood still. We accomplished little or nothing yesterday
- 33. except an Ethics Bill at about 12 o'clock. It's going to catch

- 1. a lot of little fish, but no big ones. I had open heart sur-
- gery. I'm not complaining, but I had open heart surgery here
- two years ago and we've.-.there's been one day out of the last
- 4. 15 we haven't worked. The doctor told me then if I wanted to
- 5. live a normal life that I should get eight hours of sleep a
- 6. night. Now I...I...I don't want to impose on any of you other
- people, but I think I have a reasonable excuse to leave. I've
- 8. been here all day. I've put in 12 or 14 hours every day for
- been here all day. I've put in 12 or 14 hours every day for
- the last 15 days. I'm going to go home and I'll come back in
- 10. the morning whenever...whenever it's the normal time. We
- 11. abuse ourselves in this Body beyond comprehension. I've made
- 12. this speech, I don't know how many times. There's no reason.
- 13. The House has gone home. There's no reason that the rest of us
- 14. shouldn't go home, get a decent night's sleep and come back in
- 15. the morning. I'm going to do it and I feel that I have a reason-
- 16. able excuse to do so, and I would ask to be excused.
- 17. PRESIDING OFFICER (SENATOR GRAHAM):
- 18. Senator Knuppel, will you please drive carefully?
- 19. Senator Weaver. Senator Weaver yields to Senator Chew.
- 20. SENATOR CHEW: :
- 21. Mr. President...
- 22. PRESIDING OFFICER (SENATOR GRAHAM):
- Very briefly, Senator.
- 24. SENATOR CHEW:
- 25. If the previous speaker must have eight hours of sleep to
- 26. be normal, I suggest we never join.
- 27. PRESIDING OFFICER (SENATOR GRAHAM):
- 28. Senator Weaver.
- 29. SENATOR WEAVER:
- 30. Mr. President. The Conference Committee on House Bill
- 31. 2772 has met and all members have signed this Conference Com-
- 32. mittee report. Now this is the Downstate Public Transportation
- 33. Act and basically this bill is very similar to Senate Bill 1618

- which has been amended in the House to conform to this 2772.
- Basically it takes care of the deficits that are being accumu-
- lated throughout downstate Illinois. The entitlement of 1/32nds
- 4. of the Sales and Use Tax collected from the area of the district
- that's available on a threshold of either 5 mils entitlement
- 6. to the total 1/32nd or 1 to 2 match on part of the 1/32nd. It
- also provides for the Rural Mass Transportation Demonstration
- 8. Project that was before this Senate last year and provides for
- 9. school districts to rent buses for the use in such Rural Demon-
- 10. stration Projects when the buses are not needed for school use.
- 11. It also includes a flat grant of 3,200,000 dollars to the bistate
- 12. system. Now the basic fund developed through the 1/32nd, other
- 13. than bistate is approximately 4.75 million dollars. This has
- 14. been amended into the DOT bill and if there's any discussion I'd
- 15. be happy to try to answer any questions, but I would move the
- 16. concurrence in the...or the adoption of the Conference Committee
- 17. report on House Bill 2772.
- 18. PRESIDING OFFICER (SENATOR GRAHAM):
- 19. Senator Kenneth Hall.
- 20. SENATOR HALL:
- 21. Thank you, Mr. President and members of the Senate.
- 22. agree wholeheartedly with Senator Weaver, the...and I would
- 23. ask a most favorable support of all members on this side.
- 24. PRESIDING OFFICER (SENATOR GRAHAM):
- 25. Senator Bob Mitchler.
- 26. SENATOR MITCHLER:
- 27. Mr. President and members of the Senate. This is the
- 28. Conference Committee report on 2772, House Bill, correct?
- 29. PRESIDING OFFICER (SENATOR GRAHAM):
- 30. That's been correctly reported by the sponsor. Yes.
- 31. SENATOR MITCHLER:
- 32. And, I believe language has been put into this bill now
- 33. that would allow school boards of any school district to rent

- l. school buses to a County Board and the County Board in turn could
- 2. rent these school buses out for various purposes and...in other
- 3. words the County Board would become involved in mass transporta-
- 4. Is that correct?
- 5. PRESIDING OFFICER (SENATOR GRAHAM):
- 6. The Senator may...can you answer that speech question? Sena-
- 7. tor Weaver.
- 8. SENATOR WEAVER:
- 9. Mr...Mr. President. Senator Mitchler, a school board can
- 10. rent these school buses for transportation in basically the
- 11. rural areas during the times that they are not needed for the
- 12. transportation of school children. This is basically a demon-
- stration program to try to provide...possibly provide mass 13.
- 14. transit to rural areas throughout the State. This is a con-
- 15. tractual situation that may or may not work. I'm not that
- familiar with what might be beneficial to many of the small 16.
- 17. rural communities, but certainly would provide the use of these
- buses while they're standing idle, if the need is there and the
- 19. County Board so determines.
- 20. PRESIDING OFFICER (SENATOR GRAHAM):
- 21. Senator Mitchler.
- 22. SENATOR MITCHLER:

- Is this is a new concept or has this concept ever been part 23.
- 24. of our State Government?
- PRESIDING OFFICER (SENATOR GRAHAM): 25.
- 26. Senator Weaver.
- SENATOR WEAVER: 27.
- 28. This is not a new concept. It has been bandied around this
- General Assembly for several years now, Senator, but has never 29.
- been really tried, and it was suggested that this be included in 30.
- what is called the Downstate Transportation Districts Bill. 31.
- PRESIDING OFFICER (SENATOR GRAHAM): 32.
- Senator Mitchler. 33.

- 2. Yes, Mr. President and members of the Senate. In fact.
- 3. this very type of program was part of a package under House
- 4. Bill 89, which was an "emergency", and I put that in quotes,
- 5. appropriation to the Chicago Transit System and other Down-
- 6. state Mass Transportation Systems, and this was sort of a...
- 7. PRESIDING OFFICER (SENATOR GRAHAM):
- 8. Senator Mitchler, you re...used up your time, so I would
- 9. suggest that you finish with your question.
- 10. SENATOR MITCHLER:
- 11. Well, maybe I ought to go home. Maybe...maybe what I
- 12. have to say isn't pertinent; maybe I ought to go home and...
- 13. PRESIDING OFFICER (SENATOR GRAHAM):
- 14. We adopted the rules, Senator.
- SENATOR MITCHLER: 15.
- Yeah. 16.
- 17. PRESIDING OFFICER (SENATOR GRAHAM):
- 18. I'm only saying that your time is up.
- SENATOR MITCHLER: 19.
- I'm just pointing out...just pointing out what is ... what 20.
- 21. is in this bill.
- PRESIDING OFFICER (SENATOR GRAHAM): 22.
- Senator Weaver. 23.
- SENATOR WEAVER: 24 -

- Senator Mitchler, let me...let me maybe clarify this just 25.
- a little bit. Don't...don't be upset, Senator Mitchler. Every-26.
- one's upset and tempers are flying a little bit. I'm trying to 27.
- This grant may...may be made pursuant to the sections 28.
- only in connection with grants from the Federal Government or 29.
- the department or agency thereof. This means the Department of 30.
- Transportation. I think it's ... I think it's necessary that we 31.
- give this a shot and see if there's any real value to this program. 32. It's always bothered me a little bit to see all these school buses

- sitting around for probably 18 hours a day, so I'm willing to go
- 2. along with it and see if it might be beneficial.
- 3. PRESIDING OFFICER (SENATOR GRAHAM):
- Senator Vadalabene.
- 5. SENATOR VADALABENE:
- 6. Yes, thank you, Mr. President and members of the Senate.
- 7. I'm a member of that Conference Committee report and I would
- 8. urge all of the members on this side of the aisle and on the
- 9. other side of the aisle to support this Conference Committee
- 10. report. It's a new program; I think that it's one that should
- 11. be given a chance; and I think it will be operable for every
- 12. one of the Downstate Mass Transit Systems, and for Senator
- 13. Mitchler, remember November.
- 14. PRESIDING OFFICER (SENATOR GRAHAM):
- 15. Senator John Davidson.
- 16. SENATOR DAVIDSON:
- 17. Mr. President and members of the Senate. I'd like to rise
- 18. in support of this Conference Committee and I think you'd better
- 19. address yourself, Senator Mitchler, to the problem that Downstate
- 20. Mass Transit Districts throughout this State have. This is a
- 21. solution to a deficit; also rural counties have a problem. I
- 22. don't know. Maybe your county's all urban, but mine isn't. It
- 23. has a Mass Transit in...in it, but we have many areas of the
- 24. County which have no possible transportation. If the County
- 25. Board, and reread the amendment, if the County Board decides to
- 26. try a pilot program, they may, they may rent the buses from the
- 27. school board and the school board may rent them if they desire.
- 28. They certainly can turn them down. Your local County Board is
- 29. the final judge and jury of whether this program is even tried
- 30. as a pilot. I urge all of us to vote for this. This is a good
- 31. program to solve a pressing need to many people throughout this
- 32. State.

- Well, Mr. President. Senator Berning, coming from a district 27.

- The deficit this year is going to approximate in the neighbor-31.

- list. Now we've addressed ourselves to the problems of the
- 3. Regional Transportation or the CTA. Now I think it's high time
- 4. that we address ourselves to the problems of Downstate Mass
- 5. Transit, the bistate. We're putting 3,200,000 dollars in the
- 6. bistate down in the East...East St. Louis...or St. Louis Metro-
- 7. politan Area. Not to suggest that we should take care of your
- 8. area, Senator Berning, and forget about the rest of downstate,
- 9. even though maybe you don't agree with the RTA or the CTA or
- 10. what have you. I think it's only fair that...consider just a

- 11. That was explained, I think, Senator Fawell, and I'm sorry

- 15. All right. Well, I...I...I merely then want to make a

- 18. You're on a point of personal privilege.
- 19. SENATOR FAWELL:
- 20. Well, no, a parliamentary inquiry.

- Senator Harris.
- 23. SENATOR HARRIS:
- 24. Now, I'm not sure that everybody was aware. Senator Harber
- 25. Hall put the motion to reconsider, didn't you, Senator Hall? And
- 26. I don't know whether you proceeded with the motion to Table or
- 27. not, but I just don't want the members of this Body not to have
- 28. a chance to raise points that they think are legitimate. Now...
- 29. PRESIDING OFFICER (SENATOR GRAHAM):
- 30. Senator Dougherty will withdraw his motion.
- 31. SENATOR HARRIS:
- 32. ...has the motion to Table...
- 33. PRESIDING OFFICER (SENATOR GRAHAM):

- Senator Harris, Senator Dougherty has withdrew his motion
- to Table. Senator Harris.
- 3. SENATOR HARRIS:
- All right. Now then the motion to reconsider is before us,
- 5. is that correct?
- 6. PRESIDING OFFICER (SENATOR GRAHAM):
- That is correct and it is debatable.
- 8. SENATOR HARRIS:
- 9. OK.
- 10. PRESIDING OFFICER (SENATOR GRAHAM):
- 11. Senator Fawell.
- 12. SENATOR FAWELL:
- 13. The...the reason I am concerned about this. Theslast I
- 14. had heard in the...and I understand that the appropriation in
- 15. regard to this bill. It's the appropriation to the Supreme
- 16. Court, and that it does include the money that would be utilized
- 17. to meet the increased payments, which were at one time contem-
- 18. plated as being necessary if the pay raise for the Judiciary
- 19. was passed. I think we all realize that that is something that
- 20. has not occurred and is not going to occur. I see no reason
- 21. whatsoever why the funds to cover the pay increases for the
- 22. Judiciary should be in the appropriation. I think that all of
- 23. us, at least a lot of us here, would rest much more assured if
- 24. that...if that were not included. Now I realize that someone
- 25. will say the substantive provisions of the law must be altered
- 26. before these expenditures can be made. I'm not quite convinced
- 27. that that is necessarily the case. The Judiciary can rise to
- 28. great heights of sophistry and perhaps being motivated by the
- 29. carrot at the end of the stick of justifying a potential pay
- 30. raise, these funds will find their way to being utilized in that
- 31. regard. I see no reason whatsoever for them being in there. I
- 32. don't know how they...I gather the Conference Committee must have
- 33. thrown them in. This Body before turned it down on the Floor of

- this Senate and once again if one just sleeps for a couple of
- minutes, it seems as though we end up with these appropriations
- somehow getting back in, and I think it's very unfortunate that
- we have to catch things in this way. Now I... I repeat, I don't
- know why we would want that appropriation in there under these
- 6. circumstances. If and when the appropriation...a raise for the
- Judiciary is necessary, we can certainly, at that time, go about
- 8. setting up a foundation in an appropriation. So I would hope
- that we would reconsider and I gather we're talking, Mr. President,
- 10. about reconsidering the...the affirmance of the concurrence of the

- 24. SENATOR FAWELL:
- 25. I see...all right...all right...well, I...I...I thus...
- 26. PRESIDING OFFICER (SENATOR GRAHAM):
- 27. Which in effect would be final passage if they did.
- 28. SENATOR FAWELL:
- Yes...well, so be it., I've said my...I've spoken my piece
- 30. and I would hope that we would reconsider.
- 31. PRESIDING OFFICER (SENATOR GRAHAM):
- 32. On the motion of Senator Hall...Senator Hall.
- 33. SENATOR HALL:

Well, I don't know how I can improve any on the message that Senator Fawell was giving. It...it...it certainly has been impressed upon me that we are not always aware of these Conference Commert...Committee reports and what they actually contain. I believe, as he believes, and I hope others believe that inasmuch as no salary recommendation in respect to the Judges, the subject of which one of these amendments address itself to, the appropriation, I believe that until that occurs, if and when, we should not approve the amendment, whichever one it was, or all of them, that made these appropriations effective. I think that's only elementary. I think it's only good Legislative procedure. The easiest thing we do in this General Assembly is to pass appropriations bills for things that we know have to have those appropriation bills. We can do that in any 5-day period very rapidly and...and do so frequently. The difficult thing is to not follow an appropriation bill with a substantive bill to substantiate the appropriation that we already approved. I pursue in my motion to reconsider.

Well the motion that's before us is the motion to reconsider the vote by which the Senate concurred, not in a Conference Committee report, so that we understand what we're talking about here, but just in House amendments to a Senate bill. - 2. I appreciate the concern that Senator Harris has for the poor and downtrodden. He's not alone in that feeling, and to 3. 4. suggest that we are not interested, I think, is very interest-5. Just a few moments ago the representatives of the Attorney General's Office was...were right here at this desk and 6. 7. they've been talking about this language and it can be changed. 8. I think they're negotiating it. You talk about the time. 9. occurs to me that if the language if not as it should be, the 10. Governor's going to amendatorially Veto it, so why can't we take one more day and do it properly, so that we don't have to 11. 12. deal with this issue again on that basis. I like the haste that's now suggested. We've been here a long time. 13. 14. been trying to get to the budget. This is a budget matter. 15. We've been trying to get to it. One more day is not going to make that much difference. As a matter of fact it'll be a great 16. 17. deal better that we take the day and do it properly, not having an amendatory Veto and have to work with this and deal with this 18. same situation again. We're quite as interested in people as you 19.

Thank you, Mr. President. In asking for concurrence of this Committee report, I just want to reiterate again very briefly the feud that is going on between the Attorney General of this State and the Governor of this State, that is holding up vital legislation for many Code departments in the State of Illinois. I don't care what agreements they reach insofar as the other departments are concerned, but I am concerned about the Department of Public Aid, because it is the only department, the only Code department in the Executive Branch of Government, where there is specifically set forth a special Attorney General's enforcement

- 1. section in the Department of Public Aid. No other department,
- no other Code department, to my knowledge, has an...an Attorney
- 3. General's Division within that department, other than the
- 4. Department of Public Aid. It seems funny to me, Mr. President,
- 5. and we've been going over the verbiage on this thing for quite
- 6. some time on this bill and other bills, that a day or two ago
- this language was acceptable and all of a sudden in the closing
- 8. days of this session when a 3/5ths vote is required, as of about
- 9. 10 or 15 minutes ago, or 5 o'clock or 6 o'clock tonight, I don't
- 10. know which, but all of a sudden this language is not acceptable.
- 11. Now if they're playing games with other Code departments, gentle-
- 12. men, play your games, but don't jeopardize the recipients of the
- 13. State of Illinois by playing games with this department, where
- 14. there is a specific authorization for an Attorney General's Di-
- 15. vision by the statute which was enacted many years ago by this
- 16. General Assembly in the Public Aid Code. I move, Mr. President,
- 17. for the concurrence...com...committee...or to concur in the
- 18. committee...concurrence committee report on Senate Bill 1559.

- Mr. President, there's one other item I think on the Secre-
- tary's Desk. The Conference Committee report on House Bill 2543.
- 9. The State Board of Elections appropriation. The Conference Com-
- 10. mittee report recommends the addition of 11,000 dollars for re-
- 11. tirement curing a mathematical error in the bill, which would
- .12. add 21,000 in amendment No. 2; the addition of 500,000 dollars
- 13. for the administration of the Campaign Disclosure Bill, that we
- 14. passed yesterday; and the legal amendment, which I would hope the
- 15. Senate would support. This is concurrence in amendments 1, 2,
- 16. and 3, and it's...at...and that the Senate recede from Senate
- 17. Amendment No. 4. I would urge the adoption of the Conference
- Committee report on House Bill 2543.
- 19. PRESIDING OFFICER (SENATOR WEAVER):
- 20. Is there any discussion? The question is shall the Senate
- 21. adopt the Conference Committee report on House Bill 2543. Those
- 22. in favor vote Aye. Those opposed vote Nay. The voting is open.
- 23. Have all voted who wish? Take the record. On that question the
- 24. Ayes are 41, the Nays are none. House Bill 2543, having received
- 25. the constitutional majority... The Senate adopts the Conference
- 26. Committee report on House Bill 2543; and the bill, having re-
- 27. ceived the required constitutional majority, is declared passed;
- 28. and the bill, having received the affirmative vote of 30...3/5ths
- of the members elected, is effective immediately upon its becom-
- 30. ing a law. Senator Harris.
- 31. SENATOR HARRIS:
- 32. Well, I'm just advised by Senator Hynes that there are a
- 33. couple of additional Conference Committee reports that we've

- 8. 2362. Senator Partee.
- 9. PRESIDING OFFICER (SENATOR WEAVER):
- Senator Partee.
- 11. SENATOR PARTEE:
- 12. In this Conference Committee report we're receding from the
- 13. three amendments...Senate amendments, yes, and I'm asking for the
- 14. adoption of the Conference Committee report.
- 15. PRESIDING OFFICER (SENATOR WEAVER):
- 16. Is there any discussion? Senator McBroom.
- 17. SENATOR MCBROOM:
- 18. Well, this is the...the appro...people are asking me what
- 19. are we doing, Senator Weaver, this is the...the Governor's Office.
- 20. We're receding from re...retirement, the Consumer Advocate and
- 21. the line item. Is that correct, Senator Partee?
- 22. SENATOR PARTEE:
- 23. That's correct.

- 5. The bill, having received the required constitutional majority, is
- 6. declared passed; and the bill, having received the affirmative
- 7. vote of 3/5ths of the members elected, is effective immediately
- upon its becoming a law. Senator McBroom.
- 9. SENATOR MCBROOM:
- 10. Senator Hynes, I...I...
- 11. PRESIDING OFFICER (SENATOR WEAVER):
- 12. You want a verification of the roll call?
