- 23. we say, concerning the viability or nonviability of the so-called
- 24. Attorney General's amendment, and there have been some discus-

sions Statewide about this question. A lot of people, particular-

ly a lot of my constituents, have been concerned about the fund-

- 27. ing of State Government and concerned that this problem with
- 28. reference to who was going to be the lawyer is something that
- 29. should be relegated to the background rather than to the forefront.
- 30. I'm given to understand we're going to now deal with those ques-
- 31.
- tions involving those particular agencies. We're only going to
- 32. offer this suggestion that so that people throughout this State
- 33. . will know that we are interested in funding those State agencies

around which there are...or there is no controversy, that perhaps 2. it might be best that we dealt with those 15 or so agencies that 3. the Attorney General alluded to in his press conference yesterday about which there is no problem with reference to the A.G. 4 . 5. amendment so that we could at least let people know that we are concerned about funding government and that we are addressing 6. 7. ourselves to those things so that there will be no payless paydays. So I'm just suggesting that we deal with those first and then 8. 9. get to those around which there has been some controversy later. 10. PRESIDENT: 11. Well, Senator, if I might just respond. There are really 12. three agencies about which there might be some controversy 13. remaining. The only State agency about which there was a criti-14.

cal time press problem was that appropriation bill dealing with 15. the appropriation for the Secretary of State, House Bill 2277. 16. That bill has now been passed. The remaining State agencies 17. really are under no great time pressure situation. Now consistent with the understanding that I think we have arrived at, it seems 18. 19. to me a more appropriate course of action to get the three that 20. ...about which there has been some controversy out of the way 21. and then proceed to the...actually I think there are more than 22. 15 others. 1. Well, Mr. President and members of the Senate. I sat here 2. and heard what Senator Partee had to say and I...I'd simply like З. to make this observation. From what I...some members of the 4. Senate say, I guess on both sides of the aisle, and the press 5. has to say, it occurs to me that the situation with which we're 6. confronted with is something that's just taken place, Mr. Presi-7. dent, in the last 3 or 4 days. The Chief Executive of the State, 8. I am sure, knew of the posture that this side of the aisle was 9. taking, namely that we didn't have 7 or 8 or 15 Attorney General's 10. for the State of Illinois, that each of us go to the polls and 11. only vote for one. That's all I've every voted for in every 12. election that I've participated in and all of a sudden people 13. seem to think that this is something that's come out of the hat-14. box and we're surprising everyone. I... I wonder why the Governor 15. didn't express his concern and as Chief Executive exert some 16. leadership and try to resolve this dilemma back in May, rather 17. than...rather than hoping that at the very end on June 30th or 18. June 29th that he and his assistants could start making deals 19. with the Legislature to accommodate himself. I...I.m really 20. shocked that Senator Partee would...would hope that we could go 21, ahead with these other agencies until this problem has been re-22. solved and this is again, Mr. President, which I have been say-23. ing ever since Dan Walker was elected Governor, it's about time 24. that he exerted some leadership as Chief Executive of this State, 25. and I...I'm sorry that the State of Illinois is saddled with a 26. Chief Executive of the type that we have. 27. PRESIDENT:

Well, I sat here quietly and heard all these charges against the Governor downstairs. I happened to serve in the Constitutional Convention and I happened to have served the Attorney General for eight years and never before, never before has the Attorney

General of this State sought such power and I...the...the Con-1. 2. stitution of the State of Illinois took effect July 1st, 1971, and not since that date has this ploy been attempted. Now for 3. 4. some reason now and...and everybody's been talking about the 5. Governor, I'm going to talk about the Attorney General. 6. be he's running for Governor. Maybe he's playing some politics 7. too. Now the leadership that ought to be displayed is right here in this Body as I said last night. I said to Hell with the 8. 9. Second Floor. I'm going to say to Hell with the Attorney Gen-10. eral's office. We are the Legislature. If we don't have the guts, the stature and the intelligence to know what the Consti-11. 12. tution says and for the first time we've got a man asking for 13. powers that never before were asked by any Attorney General, and at the Constitutional Convention Charles Young was there and 14. 15. if anybody was in that Constitutional Convention they know 16. Charles Young was the man that everything that come from the Attorney General's office was funneled through. That Consti-17. 18. tutional Convention. He spoke. He was the voice. He was the 19. oracle for Attorney General Scott and he said it was never in-20. tended, never intended that a person should have to depend on 21. somebody of the other political party to get the type of legal 22. advice he needed. I believe that any man serving this State in 23. the Executive Branch is certainly entitled to have a budget and to pay technical advisors to give him independent legal 24. 25. advice. As an attorney, I hope to God that nobody in the 26. United States ever, serving the people or as an individual, have to go to a man who is going to be their opponent two years 27. from now for an office he seeks for legal advice that may em-28. barrass him. Now come on, let's quit playing games on the 29. other side, realize that you've got a man that's running for 30. political office too, and quit condemning the Governor. There's 31. somebody over here that can throw it back. I don't even think 32.

- 17. Have all voted who wish? Take the record. On that question the
- 18. Yeas are 38, the Nays are 4, and the motion to reconsider pre-
- 19. vails. On the question... Senator Netsch.
- 20. SENATOR NETSCH:
- 21. When you reach the question I want to be heard briefly.
- 22. PRESIDENT:
- You are recognized. We are at that point in the procedure.
- 24. Senator Netsch.
- 25. SENATOR NETSCH:
- 26. Mr. President. We all realize what is taking place here
- 27. today and there is no question that the business of the State
- 28. has go to somehow continue and be completed. I concede that
- 29. part of it also. I would like to make a point, however, par-
- 30. ticularly with reference to this bill. The bill, of course,
- 31. continues to include the so-called Attorney General's amendment.
- 32. I feel just as strongly today as I did last week that this amend-
- 33. ment flies in the face of the Constitution. It is absolutely

dead wrong on the merits. In addition there are particular prol. 2. blems with respect to this agency because in my judgment, and the judgment of many other people, there is no question that the At-3. 4. torney General, if he ultimately succeeds on this, will be put in 5. a direct conflict of interest position with respect to the en-6. vironmental issues, and that also is dead wrong. I would hope 7. that, obviously the bill is going to pass with the amendment on 8. today. I would personally and publicly urge the Governor to use 9. his item veto to eliminate that portion of the bill. I think it 10. cannot be established as precedent in this State that a separate-11. ly elected independent officer is going to be able to have a ma-12. jor role in the operation and policy making of the Executive Of-13. fices of Government which are by the Constitution under the 14. Governor. I would add one additional thing with respect to the 15. EPA bill. In all of its non-wisdom, this Body has refused to 16. give back to the Environmental Protection Agency any of the 1.1 17. million dollars in regular operating funds that the Senate re-18. moved some weeks ago. Despite the fact that the House on sever-19. al occasions has said the EPA should have restored approximately 20. 900,000 dollars of the money removed, I think that is an in-21. sufficient amount for EPA to be able to do the kind of job that 22. this Body constantly carp at...carps at it for not being able to 23. do effectively and efficiently. I think that that is just as 24. wrong today as it was last week. I think it is too bad that 25. we have been blackmailed into the position where we have to pass 26. a bill that is in my judgment not a proper bill to reflect the 27. environmental commitments of this State. PRESIDENT:

SENATOR SOURS: 30.

Mr. President and Senators. I think the recent remarks 31. 32. need some kind of reply. Much of this trober...trouble, Senator Netsch, is the direct result of the incompetence and the miserable 33.

work product of what we sometimes call the Old Gentlemen's Con- . l. 2. vention which eliminated about 10 or 12 or 15 million dollars 3. and handed you and me probably the worst of the ... of the Con-4. stitutions of the 50 States. May I also say this. The Envi-5. ronmental Protective...Protection group should never be above 6. the law and the trouble you and I encounter today with bureaus 7. is bureaucrats. Some people call that progress. I...I call it retrogression. Some people think that when one would ob-8. serve a cannibal eating with a knife and fork, that's progress. 9. 10. And when we let these little people who operate these big bureaus 11. shove the citizen around with such phraseology out in the country 12. as fugitive dust and ambient dust and all that mumbo jumbo 13. hocus pocus, I say we've had enough of the bureaus. There 14. should be a centralized control which is nonexistent unless the 15. Attorney General himself and his office, which under the work 16. product of the Convention which drafted the Constitution, he 17. is the State's lawyer. Now the Environmental Protection Agency 18. is...is the State. It is not a separate entity autonomous 19. beyond control of the elected official, called the Attorney 20. General. Now I think most of us have had enough of the bureaus 21. and I've watched that bureau harrass, dangle, quibble, to the 22. point where the poor taxpayer doesn't know what he's going to 23. do. Let's take the case, for example, of the grain elevators. 24. There are some grain elevating...grain elevator companies today 25. that absolutely cannot comply with what the dreamers would like 26. because it would put them out of business. That is in the news 27. right this last week. Some grain elevators out in the country, 28. where you and I will never even get near ambient dust or fugitive 29. dust, if they were to comply with the ridiculous requirements they'd be out of business. In some cases a 100 thousand dollars 30. to take care of dust that'll never get to you or me. I say it's 31. time we put some control on that bureau and it's just, so far 32. as I'm concerned, another miserable bureau. 33.

4. Mr. President, I want you to know that I am going to vote 5. for this funding of this agency even though it still has the 6. Attorney General's amendment on it. I think this is, of course, 7. a viable part of government which has to be funded, Moreover 8. there are many, many employees who are working for this branch 9. of government, who ought to know that we go up to our responsi-10. bility of funding it so that there will be no payless paydays. 11. I have not one whit changed my position as to whether or not 12. this amendment should be on it. I have always said that it should 13. not, and I still maintain that position. . But I'm not going to 14. be a pawn on a chessboard any longer and I'm not going to try 15. to out talk the gentleman behind me, but I'm going to say...I'm 16. going to say that this is an issue that we thought we could set-17. tle on a Legislative basis. It is obvious that it is a purely 18. legal issue. The question as to whether or not the Attorney 19. General should be the Attorney for this agency is a legal question 20. purely and simply. I would hope that in the days very shortly 21. to come this issue can be crystallized and can be decided by 22. our Supreme Court. Perhaps we are right. Perhaps we are wrong. 23. I have the very strong feeling, based on 25 years of legal prac-24. tice that we're right. I've been wrong before, but I still think 25. that this is an issue, which though being legal should be and 26. will be decided by the Supreme Court. In the intervening per-27. iod we will not be wasting time, fuddling around with the question 28. of its legality or its nonlegality and we're going to fund it 29. and we're going to vote to fund it under the existing circum-30. stances which...from which we shrink, of course, but we feel a greater obligation to fund the...the agency. This is a question 31. that preponderates personal considerations. This is a question 32. that has to be settled and we're going to settle it with this

There can be justification for this kind of action and I would 12. tell you that this does not have the support in a letter 13. dated July the 1st, was signed representing 464 of the safety inspections of the American Society of Safety Engineers, re-14. 15. presenting both labor and industry, saying that this is necessary action to prevent this proposed...to prevent this proposed 16. self-inspection requirement. Now this does not have the support 17. of either the Illinois Manufacturer's Association, the Illinois 18. 19. State Chamber of Commerce, or Labor. How you can end up with 20. a bill and with an appropriation that's a 200% increase, when we said there'd be no provisions for any advancement and that 21. 22. noone can give any basis or any justification for what is being . 23. done, it certainly is beyond me. And how anyone in good conscience can vote for this is also another question. Let me 24. 25. point out one other thing. If, in fact, we are called back for a special session to provide money for Labor and Industry 26. 27. it certainly is not going to cost us a million and a half dollars, and that's what you're throwing away. I strongly urge 28. us to reconsider this. I urge you to withdraw this provision 29. and ask those in the Conference Committee in the House to re-30. consider the action by which they passed the Second Conference 31. Committee report before we embark upon a program of really, 32. possibly calling us back into a special session. I would urge
