13. stand approved.

30. Special Session is now in recess as it has been, but it's
31. official.

4. ment of Bills be discharged from the consideration of SB
5. 10 of the First Special Session and that the bill be read
6. a 2nd time and be placed on 2nd reading.

8. Senator Scholl moves to discharge the Committee on
9. Assignment of Bills from further consideration of SB 10.
10. All in favor signify by saying aye. Contrary no. Motion
11. carries. SB 10 is now on the order of 2nd reading and
12. the bill will be called for the 2nd reading.
