- .19. I refer you again Mr. President to the Webster Seventh New
- 20. Collegiate Dictionary on page...on page 629 of the first
- 21. column, bottom of the page. Permit: to let go, send, to let
- 22. through, to consent to expressly or formally, to give leave,
- 23. to authorize, to make possible. I appeal on the basis of what
- 24. the dictionary, Black's Legal Dictionary besides Webster's
- 25. Collegiate Seventh Edition, I would appeal the ruling of
- 26. the Chair.
- 27. PRESTDENT:
- 28. Senator, the definitions that you have read in my judgement
- 29. and I've listened carefully do not include within that definition
- 30. a mandated directive. The Chair rules that SB 4 is not within
- 31. the provisions of the Call. It is your right to appeal the
- 32. decisions of the Chair if you wish to pursue the matter.

Senator Donnewald, as a matter of ... direct reply to your question which is a reasonable question. I'm the person involved in the drafting of this proclamation. I was not in the Chair at the time SB 4 has been advanced in the past and I would only say to you that I would not have raised the question until the bill was under consideration at the passage stage were I to have been on the Floor now. I am presiding now, the question has directly come to me from my position as the presiding officer and not one serving on the...Floor who would raise an objection at the time of passage. If someone else were to be presiding now that of course is not the case I am presiding, this is the first time I've directly had the responsibility to raise the issue. I have now raised the issue and your relief is of course to repeal my determination. Senator Carroll.

#### SENATOR CARROLL:

Two points, a parliamentary inquiry of the Chair. 23. Mr. Chairman, I believe it's the duty of the presiding officer to rule on points of order not to make points of order in the first instance. I think it would be obligatory of this Body to have...for someone else to have raised that point to the Chair and asked the Chair for a ruling as to whether or not that was properly within the Call not for the Chair to in and of its own accord arbitrarily make such a ruling. Secondly, I believe the Chair in this instance is estoppel and the theory of estoppel from proceeding from this point in time I think the point was when the rules were waived to allow the bill to be advanced through the stages of the Chamber. I think the

time to have stopped it was at the very beginning and I

think under the theory of estoppel the Chair has precluded

from taking this action at this time.

SENATOR DONNEWALD: 28. I've already appealed the ruling of the Chair and I... 29. PRESIDENT: 30. We will get to that point when the discussion... 31. SENATOR SOPER: **3**2.

SENATOR KNUPPEL: Well I submit the interpretation of the Chair is strange 21. 22. because I think to get the interpretation which the Chair has 23. resolved here the word permit or permissive would have to have been used two times. In other words the Call would permit 24. legislation which permits and you would have to use the word 25. permit or permissive a second time before you could get the 26. 27. interpretation which you placed on the Call. PRESIDENT: 28. Senator McBroom. 29. SENATOR MCBROOM: 30. Well I would like Mr. President, members of the Senate, 31. I'd simply like to say that someone made the suggestion **32.**

or advanced the thought that no other member other than you

- 12. Senator Palmer.
- 13. SENATOR PALMER:
- 14. ... Information. According to your ruling Mr. President
- 15. is SB No. 4 of the Fourth Special Session is that on the
- 16. Calendar or is not on the Calendar?

- 18. It is on the Calendar.
- 19. SENATOR PALMER:
- 20. Well how do we deal with it?
- 21. PRESIDENT:
- 22. We are doing just that. Senator Hynes.
- 23. SENATOR HYNES:
- 24. ...Mr. President to...notwithstanding Senator McBroom's
- 25. ...McBroom's Freudian slip a few moments ago...I'd...I'd like
- 26. to point out one thing... If this ruling can be made at this
- 27. point in the proceeding at what point does the power of the
- 28. Chair cease to exist to make such a determination if the bill
- had gone to 3rd reading and called for passage, it had been
- 30. passed unanimously by this Body. Would the Chair then be in
- 31. a position to rule that it was not within the Call of the
- 32. Session and determine that it had been improperly passed if
- 33. it had been considered by the House of Representatives would

- 1. the Chair then be in a position on its own motion to make
- such a determination? It seems to me that this ruling while
- 3. it may have some significance with respect to the particular
- 4. bill opens some very serious problems for us in the future.
- 5. I think it...the problems that we have seen already pro-
- 6. cedurally in this Special Session are going to be compounded
- 7. by this ruling. There must be at some point in the legis-
- 8. lative process it seems to me some finality and this ruling
- 9. undercuts any kind of finality whatsoever. We had unanimous
- 10. consent of this Body to move the bill to...for the intro-
- 11. duction of the bill to move it to second reading without
- 12. reference and that determination by the unanimous consent of
- 13. the Body it seems to me is a clearcut determination by the
- 14. Body that it in fact is within the scope of the Call and I
- 15. would suggest that it would take a similar unanimous agreement
- 16. on the part of the Body to...to reverse that decision if
- 17. it could be reversed at all at this point. I think this...
- 18. this ruling is...is ill advised and that this...the matter
- 19. is beyond our consideration at this point. Furthermore on
- 20. the merits I think the ruling is incorrect.
- 21. PRESIDENT:
- 22. Is there further discussion? Senator Glass.
- 23. SENATOR GLASS:
- 24. Well Mr. President in brief reply... Senator Hynes I
- 25. would call his attention to Section 5...subparagraph b of
- 26. the Constitution under Article 4 on page 25...which states
- 27. that the Governor may convene a General Assembly or the
- 28. Senate alone a special session by proclamation may...may call
- 29. a special session and only business emcompanied...emcompassed
- 30. by such purpose together with any impeachments or confirmation
- 31. of appointments shall be transacted so it seems to me if we...
- 32. if we did transact any other business no matter what stage it
- 33. reached it would be not...not within the Constitutional

- 1. provision and therefore would not be valid.
- 2. PRESIDENT:
- Senator Carroll.
- 4. SENATOR CARROLL:
- 5. ...just very briefly again a point of inquiry...
- 6. Senator Glass or Senator Harris does either the Constitution
- 7. or the Chair have a dictionary under which we can operate
- 8. from as to how these terms are to be defined?
- 9. PRESIDENT:
- 10. The term has been defined by Senator Donnewald
- 11. and he failed to persuade me.
- 12. SENATOR CARROLL:
- 13. There is no dictionary for future reference so it's just
- 14. whatever feels like at the time.
- 15. PRESIDENT:
- 16. No, no, by all means no. I have evaluated this question
- 17. on several occasions from the time Senator Donnewald intro-
- 18. duced SB 4 and it is not a determination that I have arrived
- 19. at frivolously. I've discussed it with my staff, I've dis-
- 20. cussed it with the Speaker of the House who joined me in the
- 21. issuance of this proclamation and it is clearly my determination
- 22. on the basis of careful evaluation that SB 4 does not come
- 23. within the scope of the Call of the proclamation setting forth
- 24. the items that can be considered under the Call for Special
- 25. Session Four. Senator Merritt.
- 26. SENATOR MERRITT:
- 27. Mr. President, I realize you've been fair to a lot of
- 28. people that want to be on their feet speaking. I think we
- 29. have a motion before the House on the appeal by Senator Donnewald.
- 30. I move the previous question.
- 31. PRESIDENT:
- 32. Senator Donnewald has moved the previous question...
- 33. I'm sorry Senator Merritt has moved the previous question

To do so is a leap of the imagination which goes beyond all normal bounds of English construction. since English is I think the official language of this Body I am amazed at the interpretation which has been placed in the Call. I would...seem to me that the intent behind the Call may have been one thing but its expression and language in my brief stay here I've been led to believe is what counts and that construction simply cannot be drawn from the language in the Call.

### SENATOR PARTEE:

Everybody has talked about what's involved in this bill but really is involved in this bill. We've skirted the issues. We've been around the periphery of it. We've been around the circle and nobody's really gotten at the heart of it and the middle of it and the meat of it. It's a political question I think we all know that and the ruling is calculated to obviate what might be a disastrous political eventuality. The fact of the matter is this is not new kind of legislation. We had this bill in the last Session of the Legislature and I had Democrats here who were just as opposed to having a vote on this measure as you are tonight. The fact of the matter is there are many of you who consider that if there is a consolidation of elections in a nonpresidential year that your positions may be different in your counties but what you are saying by your vote to obviate a vote on this bill is that you are more personally concerned about your own future than you are about the financial question that is involved here and that... financial question is simply this county after county after county in this State are poor and desirous and needing additional

- 1. funds to bring to the people in those counties the services
- 2. which people need, demand and desire. The county where Knox
- 3. College is located for example to Galesburg that county will
- 4. save \$70,000 if there is a consolidation of elections. I
- 5. could go right down the list and tell you county for county
- 6. the large numbers of dollars that would be saved by these
- 7. counties by consolidation of election. If you choose to be
- 8. concerned about your personal futures over and above the
- The same and the post of the same of the same above the
- 10. county by county then that is your choice. I think the fact

taxpayers right to save large amounts of money county by
