- 10. Senate Bill No. 62 introduced by Senators Rock, Soper, Knuppel,
- 11. Donnewald, Graham, Partee, Davidson, Schaffer and Carroll.

- 13. PRESIDING OFFICER (SENATOR DONNEWALD):
- 14. Senator Rock.
- 15. SENATOR ROCK:
- 16. Thank you, Mr. President and Ladies and Gentlemen of the Senate.
- 17. Senate Bill 62, just introduced, is the Senior Citizens Tax Relief
- 18. Bill, which was on January 24th, vetoed by the Governor after having
- 19. passed the 78th General Assembly. The bill is identical in form.
- 17. passed the year central instance, the 222 to be accorded to
- 20. I would ask leave of the Chair to solicit co-sponsorship by any
- 21. and all members who wish to be co-sponsors. I would at this time
- -

ask for suspension of the rules so that this bill can be and will

be moved to the order of 2nd reading without reference to committee.

- 25. Senator Chew.
- 26. SENATOR CHEW:

- 27. Where . . . add me as a co-sponsor, and I also sanction
- Senator Rock's position.
- 29. PRESIDING OFFICER (SENATOR DONNEWALD):
- 30. I . . . I might suggest, if you des . . . do desire to be a
- 31. co-sponsor of the bill, to go down to the Secretary's Desk and
- 32. affix your name to that piece of legislation. Senator Harris.
- 33. SENATOR HARRIS:

- 1. Well, Mr. President, I don't want to be misunderstood.
- 2. But, honestly, I . . . I do believe this bill ought to go to com-
- 3. mittee, and I'll tell you why I think this. We are introducing
- 4. an additional Senior Citizen Tax Relief proposal today. I don't
- 5. know whether it's going to be joined in by many sponsors. I . . .
- 6. co-sponsors. . . I do know that Senator Nimrod, Senator Harber Hall,
- 7. Senator Clarke and I who have been in communication with each other
- .8. and only to that extent, and it's similar to the amendments that we
- 9. offered to 2715 which were not accepted. Now, I think there is some  $\,$
- 10. value to some public dialogue on this, and there isn't any question
- 11. but what the votes are here to pass your 79th General Assembly al-
- 12. ternative to the 78th's 2715. And there's no intention of side-
- 13. tracking or waylaying, but I just think that there might be real
- 14. purpose served to have an immediate hearing, next week, if possible,
- 15. on this bill, in the Revenue Committee and move it because there's
- 16. no question in my mind but what the . . . the 79th model of 2715
- 17. is going to pass. But I . . . I and I'm sorry that we haven't had a
- 18. chance to discuss this privately, but I . . . I would hope that
- 19. the bill could be sent to Committee along with the bill we're
- 20. going to introduce today, and by we, I'm speaking in terms of only
- 21, individuals and not any partisan identification here. I have some
- 22. dialogue on it and move it next week.
- 23. PRESIDING OFFICER (SENATOR DONNEWALD):
- 24. I think . . . the . . . to put the record straight, that we
- 25. . . the motion has been made to advance the bill to the order of
- 26. 2nd reading without reference to committee and that being in the
- 27. record, I recognize Senator Chew.
- 28. SENATOR CHEW:
- 29. Yes, Mr. President, I was about to bring that to the attention
- 30. of the honorable Senator Harris that the motion is on the Floor
- 31. to bypass committee. Senator, you have the right to introduce
- 32. any bill you want to, but the one particular bill . . . or Senator
- 33. Rock referred to, is the motion that's on the Floor to bypass

- 1. committee. And I'm sorry I can't join you, but I'll have to vote
- 2. to bypass committee.
- 3. PRESIDING OFFICER (SENATOR DONNEWALD):
- 4. Senator Rock.
- 5. SENATOR CHEW:
- 6. I'll do the same for your . .
- 7. SENATOR ROCK:
- Yes, let me say that I, personally, to my good friend Senator
- 9. Harris, apologize for not having spoken with you directly. I would
- 10. . . I would say that I . . . I wish to pursue this motion and for
- 11. this reason. If, in fact, the 78th General Assembly had had the
- 12. opportunity to react to that veto, I am convinced in my own mind,
- 13. and I'm sure you will concur, that this General Assembly would have
- 14. acted as it did at the time it passed the bill responsibly and told
- 15. the Governor just exactly where our priorities are or should be.
- 16. In my judgement, we would only be delaying what should not be delayed
- 17. by going to committee. This bill was, in fact, heard in Senator
- 18. Clarke's Revenue Committee back in June of last year. I appreciate
- 19. the fact and know that there are alternative solutions. The fact
- 20. is, this legislation did pass the General Assembly. The General
- 22. to react. Eighty percent of the membership is still here. The idea

Assembly, as constituted under the 78th, did not have an opportunity

- 23. was a good one, then, I think it's a good one now. And I . . .
- 24. sincerely, I . . . I would . . . I would ask that you not object
- 25. too strongly. I wish to pursue this motion, get it on 2nd reading
- 26. if, in fact, discussion is needed. We can have all the discussion
- 27. we need at that point. But I just think that this is of such moment
- 28. that we really ought to act and act responsibly, today.
- 29. PRESIDING OFFICER (SENATOR DONNEWALD):
- 30. Senator Nimrod.
- 31. SENATOR NIMROD:

- 32. Mr. . . . Mr. President, I think that we aren't going to gain
- 33. anything by . . . in other words, there isn't any deadline that

- 1. has to be met. There isn't going to be any money going to be re-
- 2. ceived any sooner by asking to . . . you know, go to committee
- 3. instead of bypassing. So, I think it would certainly not hinder
- 4. the program one single bit that if it were a week later or whether
- 5. it's today. But I do think that it does deserve an opportunity . .
- 6. heard in committee to see if the amendments that . . . and the
- 7. alternatives that we're proposing, might be some way of working it
- 8. out and coming up with a plan that could be even better than what
- 9. was presented in the 78th. In fact, if there was some problems
- 10. which we all concurred in that was . . . need to be some relief,
- 11. certainly, rushing back without thinking it over twice in today's
- 12. light of the economy and the monies and the things that are there,
- 13. that . . . there . . . there could be some alternatives, and I . . .
- 14. I would think it ought to go to committee, and I would object to
- 15. the building . . . bypassing the committee hearings.
- 16. PRESIDING OFFICER (SENATOR DONNEWALD):
- 17. Senator Clarke.
- 18. SENATOR CLARKE:
- 19. Mr. President, I'd just like to set the record straight.
- 20. Senator Rock mentioned about the history of this bill. The fact of
- 21. the matter is that last year, there were about four or five bills
- 22. dealing with tax relief and these were all held in the Revenue
- 23. Committee. The Lieutenant Governor did come down and make a pitch
- 24. for this bill, but there was never a hearing on this subject.
- 25. Subsequently, when we came back and passed the bill in the Fall, it
- 26. was substantially changed, prior to . . . by amendment on 2nd
- 27. reading prior to being passed. So, I really think that there is
- merit in having this subject . . . this particular legislation and
- 28. merit in having this subject... this particular registration and

this subject heard in committee before we move ahead. I don't think

- 30. it would slow it up that much.
- 31. PRESIDING OFFICER (SENATOR DONNEWALD):
- 32. Senator Partee.
- 33. SENATOR PARTEE:

           Well, the fact of the matter is, it would slow it up,
2.
      and let's just call it like it is. I recognize that you gentlemen

      also have a bill, and I promise you a careful addressment to the

      merit of that bill. It's not going to be just brought here and .

      shun it aside. You've given a lot of . . . could you hold it

      please, gentlemen? You've had . . . you've given a lot of time

      and you've given a lot of attention. You, too, are as interested

      in this subject matter as we are. We were hopeful that if we could

      something that need not be said about the work and value of that
12.
      suggestion that I think you all understand. We certainly don't
13.
      mean to pre-empt this legislative field, but this is a bill that
      passed overwhelmingly in both Houses, which all of us understand,
14.
      which all of us have addressed ourselves to all of its components,
15.
16.
      we know what it's about. It's been around a long time, and to bring
      it back to committee seems to me to be without purpose. Now, I
17.
18.
      would just appeal to your reason, your judgement, and your logic,
19.
      and say to you that this motion ought to carry to move this bill to
20.
      2nd reading without reference to committee with the understanding
21.
      that any bill you or anyone else proffers in this subject will also
      be thoroughly and carefully analyzed and will be addressed on a
22.
23.
      basis of reasonableness without any kind of political look-see.
      Now, I just would hope that we can move this bill today, and I
24.
      promise you, we will look at any bill anyone else offers with the
25.
      same kind of addressment that we've given to this bill in the other
26.
      Legislature. Eighty percent of the members here who voted on this
27.
      bill before. I think this bill passed forty-three to three, or
28.
      something like that. So, to take it back to the committee, to me,
29.
      seems to be without purpose, and I would assure you that it is not
30.
      meant to pre-empt you in offering other packages of legislation in
31.
      this area.

PRESIDING OFFICER (SENATOR DONNEWALD):

- SENATOR EGAN:
- 3. Yes, Mr. President, thank you. As one of those who did not
- 4. vote on the bill in the last Session, let me suggest that I
- 5. followed it very carefully and when I go home, I'm going to have
- 6. many, many senior citizens asking me what I . . . I have done about
- 7. the . . . the relief, and I want to tell you that if I don't . . .
- 8. if . . . if I don't urge that this go onto 2nd reading, I'll be
- 9. afraid to go home.
- 10. PRESIDING OFFICER (SENATOR DONNEWALD):
- Senator Knuppel.
- 12. SENATOR KNUPPEL:
- 13. Mr. Chairman and members of this Body, I think that most of
- 14. the things that need to be said have already been said. However,
- 15. from the very time I entered the Constitutional Convention, I've
- 16. been a strong advocate of doing away with the sales tax on food
- 17. and drugs. About eighty some percent of that money, with the
- 18. respect to older people, is nothing but recycled money anyway that's
- 19. collected, redistributed and collected in a form of supplemental
- 20. payments, social security and otherwise. This bill can be approved
- 21. on, I'm sure, on 2nd reading without going to hearings. It was
- 22. discussed fully on the Floor. Senator Netsch suggested an improve-
- 23. ment that might be offered as an amendment, nevertheless, this
- 24. is action that we owe our older people. Today, we're faced with
- 25. a recession on one hand and climbing inflation on the other. We're
- 26. told on the one hand that we don't have the thirty-four million if
- 27. that's what it takes to pay these people some refund to make their
- 28. . . . help them meet the cost of living. While on the other hand,
- 29. we're being solicited to support a four and one-half billion dollar
- 30. bond issue for future indedtedness. I said before, when we were
- 31. in the earlier Session, that I would speak every time the op-
- 32. portunity offered on legislation that was non-inflationary,
- 33. expenditures that were non-inflationary, expenditures that would

fight the recession. We're told, and the Republicans on the
1.
     other side of the aisle ought to be one hundred percent with us
2.
     on this, we're told by our President that he wants to get money
3.
     back into circulation for people and . . . on the lower part of
4.
5.
      their income, the first ten thousand dollars or so, in the form
     of a refund. Now, it'll be some time before that money's forth-
6.
     coming. If we're going to give any kind of a shot to the economy,
7.
      now is the time to do it. We can move now and we can do some
. 8 .
      good where we move at the end of the Session. We'll . . . we'll
9.
      be relatively ineffectual as compared to what we can do now.
10.
      These people have earned, over generations, our support, our desire
11.
      to do something for them. If there's one regressionary tax that
12.
      recess . . . recessive tax, regressive tax in the State of Illinois,
13.
      it's the sales tax, and certainly, we should be giving it back in
14.
      the form of rebates to older people. I would suggest that we move
15.
      it to 2nd reading. If someone has a . . . an intelligent, a com-
16.
      prehensive suggestion to improve on this legislation, you've all
17.
      had a look at it, and there is no reason that we couldn't prepare
18.
      whatever amendments need to be made and do them promptly. I
19.
      suggest that it's the benefit of this Body to move this . . . this
20.
      legislation to 2nd reading today without reference.

- 4. Is there further debate? This . . . this will take thirty
- votes for the bypassing of the majority of those elected for the 5.
- suspension of the rules. The question is . . . Senator Hynes. 6.
- SENATOR HYNES: 7.
- 8. Mr. President, it seems to me that we are engaging here in . .
- in a practice which has brought some criticism to the legislative 9.
- 10. process in the past on account that it is inefficient and dupli-
- cative and does not bring about the kind of result that the people 11.
- of this State would like to see. We went through extensive debate 12.
- on this measure on more than one occasion during the last Session 13.
- of the General Assembly. There has been extensive debate since 14.
- that time in the news media, among the members of this Body. This 15.
- is the same bill which we considered last year which passed both 16.
- Houses overwhelmingly, and I believe that it is clearly the desire 17.
- of the majority of the members here that the bill will ultimately 18.
- become the law again. And I see no reason to refer it for addi-19.
- tional committee hearings. First of all, the committees are not
- yet fully operative, the testimony that will be taken will duplicate 21.
- what we heard in the last Session. The members of this Body, I

think, are in a position to ask whatever questions they will

- 22.
- here on the Floor. This is not final passage of the bill, it 24.
- simply moves it one step along in the legislative process. It still 25.
- has to go through the House of Representatives. There will be an 26.
- opportunity tomorrow to further debate the bill, to offer suggestions 27.
- for change and improvement. Frankly, I believe the bill has been 28.
- amended to incorporate all of the suggestions and recommendations 29.
- of Senator Harris, in particular. And I believe that was done in 30.
- the . . . in the closing days of the last Session. So, I really 31.
- question what the request for a committee hearing is about. 32.
- 33. think we ought to move this bill and put it into effect. It has

- 1. been delayed too long already, and I think the time for action is
- 2. right now.
- 3. PRESIDING OFFICER (SENATOR DONNEWALD):
- 4. Senator Carroll.
- 5. SENATOR CARROLL:
- 6. Yes, thank you, Mr. President. I, too, rise to support this
- 7. motion to place the bill on the order of 2nd reading at this time.
- 8. I think we've all seen what has happened in the last few days in
- 9. the news medias of this State, and I know we all felt overwhelmingly
- 10. the last Session that the senior citizens of this State needed some
- 11. type of tax relief, especially because of the economy conditions that
- 12. we are all facing today. I think this General Assembly should
- 13. take the same type of action that the last General Assembly had
- 14. taken, and I know that we will. If any of you had watched, at
- 15. least the television that we saw up in Chicago, where the people
- 16. at Chelsea House and the other senior citizen housing institutions,
- 17. where they interviewed those people and talked of the commitment
- 18. that they thought they had from government in Illinois. Maybe it's
- 19. not our fault that that legislation is not law today. Maybe it's
- 20. not, and we know it's not the members of the General Assembly, when
- 21. anyway impeded that necessary economic measure. But we do know
- 22. that we, as government as a whole, are taken as accountable to those
- 23. senior citizens. Now, I look over those who have been appointed to
- 24. the Revenue Committee, and I assume that's the committee that this
- 25. bill would go to, and all of those members that served here last
- 26. term, all of those members on the committee are familiar with the
- 27. debates pro and con, all of those members are familiar with the need
- 28. that this legislation presents to those senior citizens. I think
- 29. we all made a commitment to those people. I think the newer members
- 30. made that commitment during their campaign. I think the sitting
- 31. members made the commitment by their vote last time on the
- 32. Floor of this Chamber. I see no reason to delay the moving
- 33. of this bill to 2nd reading to allow for amendments at that

- I know we'll be debating the final form that this bill 1.
- takes, but I don't think it's fair to those who have helped 2.
- this society for so many years to delay that process by even 3.
- a week or two weeks. If they expected the monies to start 4.
- flowing, had the Governor signed the bill last week, and I 5.
- think we should do all within our power to move that process 6.
- 7. along as quickly as we can. Thank you.
- 8. PRESIDING OFFICER (SENATOR DONNEWALD):
- 9. Senator Harris.
- 10. SENATOR HARRIS:

- Mr. President, I'd like to make a suggestion to Senator 11.
- Rock and Senator Partee and all of those who are interested 12.
- in seeing this bill progress without delay. Would it make 13.
- sense for us to move this bill today, and I assume to move it 14.
- again tomorrow, with the understanding that on 3rd reading, and 15.
- I see no violation of any rule in a . . . an immediate analysis 16.
- to schedule on Tuesday morning, when we're scheduled to be here, 17.
- a Committee of the Whole, on this bill. Now, let's be realistic.
- There is some opportunity for some personality identification in 19.
- such a hearing. And also, an opportunity for those who have 20.
- constructive communication to us, to lay it before us in a 21.
- Committee of the Whole posture. And we, then, could act on the 22.
- bill subsequent to the adjournment of that committee hearing on 23.
- Tuesday morning and take up our regular work so that there would 24.
- be no delay, but there would be, in fact, an opportunity for 25.
- evaluation of it. Seems to me that that might make some sense 26.
- and that's really the only point that I was raising. I think you 27.
- will recall that in my opening remarks, it was to recognize that 28. the votes were here to pass this, comfortably, but I thought that
- . . . that review in some opportunity, in some form, ought to be 30.
- obtained. Now, is that a reasonable suggestion? 31.

- 21. It appears that it would be, and it should have an immediate

- 24. Would . . . would you . . . would you like to use an amend-
- 25. ment I have prepared?
- 26. SENATOR ROCK:
- .27. I'm . . . I'm having an awful lot of trouble seeing you
- 28. with the blinds open.
- 29. PRESIDENT:
- 30. Senator Rock moves that the bill be returned to the order
- 31. of 2nd reading, and Senator Harris is offering Amendment No. 1.
- 32. Read the Amendment.
- 33. SENATOR HARRIS:

- 1. I just want to explain that this just provides that the bill
