### 1. SENATOR NUDELMAN:

- Mr. President, Ladies and Gentlemen of the Senate, this is an
- 3. anti-red lining bill which would require any bank or savings and
- 4. loan association in the State of Illinois seeking the deposit of
- 5. funds from the State Treasurer to affirm that they would not reject
- 6. mortgage loans based on location within the area they serve, and
- 7. secondly, that they would make funds available for low and moderate
- 8. income housing. This may not be a perfect answer, but at least, it's
- 9. a start, and I think if it should prove workable, it can be...im-
- 10. plemented to make it more workable, and if it's not workable, then it
- 11. has hurt no one. And I would suggest, request rather, favorable
- 12. votes on this bill, and I'll be willing to answer any questions.
- 13. PRESIDENT:
- 14. Any further discussion? Senator Soper.
- 15. SENATOR SOPER:
- 16. Would the Senator answer a few questions? Senator, who makes
- 17. the determination what is low...low cost housing and who's to make
- 18. the determination what...whether or not this organization or this
- 19. savings and loan has precluded loans in certain districts, on what
- 20. basis would that be?
- 21. SENATOR NUDELMAN:
- 22. Well, personally I would suggest that what...what constitututes
- 23. low cost housing would be based on two elements. One would be the
- 24. rate of inflation, and second, would be the type of housing extent
- 25. in the area covered by the bank. I would suggest that the State
- 26. Treasurer would be the one that could request a report from the
- 27. various banks concerned from time to time to discover what they,
- 28. in fact, are doing. But this is a pledge, a certification by the
- 29. officer of the bank that they would not engage in these practices.
- 30. PRESIDENT:
- 31. Senator Soper.
- 32. SENATOR SOPER:
- 33. Now...
- 34. PRESIDENT:

- ı. One minute, Senator Soper. Will the members be in your
- 2. seats or hold your voices down please. Senator Soper.
- 3. SENATOR SOPER:
- 4. Now, it comes to my mind that...that an institution that takes
- 5. the depositor's money, pledges...to that depositor that he will...
- 6. he will invest that money on a...on a responsible basis. In other
- 7. words, if he makes a loan, he'll make a loan where...where he feels
- 8. that the income or the interest will be paid and that the loan will
- 9. be repaid. Now, it comes to my mind that if you force someone to
- 10. make loans in...places where they feel are to people that will not
- 11. repay those loans, and the ... and the Treasurer has... has the ... op-
- 12. portunity or the...or the right to not deposit money in this savings
- 13. and loan or in this bank, because the fact that he...he could say
- 14. well, you...you're...you don't go into this neighborhood, therefore,
- 15. you won't get any of our money. And now you've got to make a choice
- whether or not that...whether the bank has the responsibility to 16.
- 17. its depositors or not.
- 18. PRESIDENT:

- 19. Senator Wooten. Senator Nudelman.
- 20. SENATOR NUDELMAN:
- 21. In response to that, Senator, I would suggest that nothing in
- 22. this bill requires a bank or savings and loan to make unsafe loans.
- All it says is that we will not prohibit loans or not stop making 23.
- loans in any area merely because of the area. The size, the type, 24.
- the...that the...the structure, is certainly considered and the 25.
- ability, the ability of the person seeking the loan is the prime 26.
- problem. If the...if the borrower is not qualified for a loan, 27.
- nothing in this bill makes any bank or savings and loan, and I
- wouldn't want that. Nothing in this bill makes any bank or savings
- and loan give such a party a loan, and I would suggest, Senator, 30.
- that the charter, the charter of any bank or savings and loan in
- this State requires that that bank and savings and loan services 32.
- the area in which it is located. That is a prerequisite to 33.
- So that getting a...to getting a charter in the first instance. 34.

- 1. if a bank or savings and loan doesn't service its...its...its
- 2. area, then...then of course, it's not even living up to its charter,
- 3. let alone this...this proposed legislation. I certainly
- 4. wouldn't want any bank or savings and loan, and I have not suggested
- 5. it in this legislation, to be required to make unsafe or unreasonable
- 6. loans The the only requirement is that it not it not negatively
- 6. loans. The...the only requirement is that it not, it not, negatively
- 7. include any area where it...where it's not going to make loans
- 8. automatically. If a person in any area, including my neighborhood
- 9. where I live, for example, is able...to pay back a loan, that per-
- 10. son should get that loan, and I think that's only reasonable, and
- 11. I think that it's reasonable to require that by law. As far as the
- 12. other element, that...that also is a requirement, that's part of,
- 13. particularly, the part of the...of the requirement of the savings
- 14. and loan and the bank that they do service, the people in their com-
- 15. munities, and if the people in their communities are in the low or
- 16. moderate income brackets and make that kind of a request for that
- •
- 17. kind of housing, they should be accommodated if they are able to pay.
- 18. And that's the crux, if they are able to pay.
- 19. PRESIDENT:
- Senator Soper.
- 21. SENATOR SOPER:
  - 22. The only thing I wanted to...have you state and you've stated,
- 23. in other words that the...the Treasurer can't make the determination
- $\cdot$
- 24. for the savings and loan, whether the loan is justifiable or safe
- 25. or is repayable. Thank you very much.
- 26. PRESIDENT:

- Senator Knuppel.
- 28. SENATOR KNUPPEL:
- 29. Well, members of the Body and Mr. President, my concern about
- 30. this bill is that it...that it isn't...it isn't strong enough. It'
- .
- 31. ...it's a meaningless amount of words, verbiage, mishmash, because
- 32. it has no means for enforcement, it leaves open to the bank, just
- as counsel has...or just as the Senator has said, the opportunity
- 34. to make those loans only which they want to make. And it leaves,

- 1. I assume, without any restrictions for hearing or otherwise with
- 2. the Treasurer of the State of Illinois the right to determine whether
- 3. or not the person has arbitrarily refused to make a loan. I feel
- 4. that that is nothing more or less than...than unnecessary verbiage
- 5. added to the statutes, it violates due process and provides for
- 6. no hearing procedure like the old bill on financial responsibility.
- 7. I can't support the legislation because I think it's so poorly
- 8. drafted that it will be held unconstitutional if anything ever arises
- 9. on it and because the language is just words that really mean nothing
- 10. and that it's a false hope for those people who think this will
- 11. stop red lining. It's a meaningless bill, and I would just suggest
- 12. that every member of this Body read it, look at it, and see what
- 13. it really does, if anything, and I'm sure it does nothing.
- 14. PRESIDENT:
- 15. Senator Netsch.
- 16. SENATOR NETSCH:
- 17. Mr. President, could I ask the sponsor one question? Would
- 18. he yield for a question? Senator Nudelman, what is the coverage
- 19. of the bill in terms of who would have to make this pledge? There
- 20. ...the problem has arisen, as you know, with respect to proposed
- 21. red lining legislation in the past, as to whether or not we would
- 22. have the right to compel a federally chartered savings and loan,
- 23. a federally chartered savings and loan or a federally chartered
- 24. bank to comply with our attempts to get at the red lining practice.
- 25. Would you, just for the record, explain how that is resolved in your
- 26. bill?
- 27. PRESIDENT:
- Senator Nudelman.
- 29. SENATOR NUDELMAN:
- 30. The party making the pledge would be the president of the bank,
- 31. and as in answer to your second question, Senator, there is no com-
- 32. pelling here if the bank doesn't want to get money, deposit it, by
- 33. the Treasurer, it doesn't have to make this pledge. This is not

- controlling a...a federally chartered bank or savings and loan.
- It's merely saying that if you want a deposit of money from the
- 3. State of Illinois, you must sign this pledge, and I don't believe
- 4. that that is in anyway interfering with the Federal prerogatives.
- 5. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Netsch.
- 7. SENATOR NETSCH:
- 8. So that if a federally chartered savings and loan or bank wanted
- 9. to apply for the right to take State deposits, it probably could
- 10. validly be required to file this pledge. Is that right?
- 11. PRESIDING OFFICER: (SENATOR ROCK)
- 12. Senator Nudelman.
- 13. SENATOR NUDELMAN:
- 14. I'm sure that's the case, Senator.
- 15. PRESIDING OFFICER: (SENATOR ROCK)
- 16. Senator Netsch.
- 17. SENATOR NETSCH:
- 18. Just a last comment, I agree with what I think Senator Nudelman
- 19. said at the beginning, that it is a mild form of attack on the red
- 20. lining practice, but at least it is a first step, and it seems to
- 21. me on that basis that it is very worthwhile and extremely important
- 22. to many communities around this State, perhaps not...perhaps most
