PERFUNCTORY SESSION

APRIL 7, 1976

1 PRESIDING OFFICER: (SENATOR BRUCE)

2 The hour of noon having arrived, the Senate will come  
3 to order. Prayer by Reverend Douglas DeGraaf.

4 REVEREND DeGRAFF:

5 (Prayer by Reverend DeGraaf)

6 PRESIDING OFFICER: (SENATOR BRUCE)

7 Reading of the Journal. Senator Wooten.

8 SENATOR WOOTEN:

9 I move that reading and approval of the Journals of Wed-  
10 nesday, March 31st, 1976, Thursday, April 1st, 1976, Friday,  
11 April 2nd, 1976, Monday, April 5th, 1976 and Tuesday, April  
12 6th, 1976 be postponed pending arrival of the printed Journals.

13 PRESIDING OFFICER: (SENATOR BRUCE)

14 All in favor say Aye. Ayes have it. The motion is carried.  
15 Introduction of bills.

16 SECRETARY:

17 Senate Bill 1686 through 1693.

18 PRESIDING OFFICER: (SENATOR BRUCE)

19 Rules Committee. Any further business to come before  
20 the Senate? Senator Mitchler.

21 SENATOR MITCHLER:

22 Mr. President, I'd rise on a point of personal privilege.

23 PRESIDING OFFICER: (SENATOR BRUCE)

24 State your point.

25 SENATOR MITCHLER:

26 In the President's Gallery is the wife of the Pastor of  
27 our church, the Fourth Street United Methodist Church of Aurora,  
28 Adeline DeGraaf and with me on the Senate Floor is Reverend  
29 Douglas DeGraaf. I would like to introduce them to the Senate.

30 PRESIDING OFFICER: (SENATOR BRUCE)

31 Senator Graham.

32 SENATOR GRAHAM:

33 Mr. President, I notice that the Senator from Oswego does

1 this with great regularity. He always, and I can understand  
2 why he does, fail to introduce the most important member of  
3 the Mitchler family, Helen is in the gallery, too. And I'd  
4 be...I'd be afraid too if I were you.

5 PRESIDING OFFICER: (SENATOR BRUCE)

6 Senator Graham, I thought you were to stand to indicate  
7 your regret to the fact that Senator Mitchler does not have  
8 a resolution to introduce today.

9 SENATOR GRAHAM:

10 No, I was glad.

11 PRESIDING OFFICER: (SENATOR BRUCE)

12 Oh, you were glad...

13 SENATOR GRAHAM:

14 I was glad...

15 PRESIDING OFFICER: (SENATOR BRUCE)

16 ...I'm sorry. Some of us was regretful that he did not  
17 have a resolution for us to read for the Reverend and his wife.  
18 Introduction of bills.

19 SECRETARY:

20 Senate Bill 1694.

21 PRESIDING OFFICER: (SENATOR BRUCE)

22 Rules Committee. Any further business to come before the  
23 Senate? Senator Partee.

24 SENATOR PARTEE:

25 I understand that the Adjournment Resolution has not yet  
26 come over from the House. In that event I suppose we should  
27 recess until after it does, and then we could come back in,  
28 accept it, and ask leave to accept the Adjournment Resolution  
29 when it comes over, and we could at that time, then, finalize  
30 this Session until Monday.

31 PRESIDING OFFICER: (SENATOR BRUCE)

32 You are moving then that we recess subject to call of the  
33 Chair for the purpose of adopting Adjournment Resolution. All...

1 SENATOR PARTEE:

2 That's right.

3 PRESIDING OFFICER: (SENATOR BRUCE)

4 ...in favor say Aye. Opposed Nay. The Senate stands  
5 in recess subject to call of the Chair. Senator Rock.

6 SENATOR ROCK:

7 Yeah, two things. I think the membership was interested  
8 in knowing how the Adjournment Resolution proposed...proposes  
9 to read. It will be noon on Monday for us to come back. Ad-  
10 ditionally, I'm told by a member from the other side that yes-  
11 terday the Journal might inaccurately reflect that Senate Bill  
12 1629 was, in fact, reported out of the Rules Committee and  
13 assigned to the Committee on Judiciary. There was some ques-  
14 tion whether it was 27 or 29. I would like the record to re-  
15 flect, and ask leave of this Body to change the record if, in  
16 fact, it's in error. But, the right bill is 1629, which...

17 PRESIDING OFFICER: (SENATOR BRUCE)

18 That would...that would be the report of the Rules Com-  
19 mittee.

20 SENATOR ROCK:

21 And the Assignment of Bills Committee, assigning the  
22 bill to the Committee on Judiciary.

23 PRESIDING OFFICER: (SENATOR BRUCE)

24 I'm informed by the Secretary that the record is correct,  
25 stand correct. Any further business? Senate stands in recess.

26 (Recess)

27 (After Recess)

28 PRESIDENT:

29 The Senate will come to order. Message from the House.

30 SECRETARY:

31 A Message from the House by Mr. O'Brien, Clerk.

32 Mr. President - I am directed to inform the Senate  
33 that the House of Representatives has adopted the following  
34 Joint Resolution in the adoption of which I am asked...I'm  
35 instructed to ask the concurrence of the Senate, to-wit:

1 House Joint Resolution 86.

2 (Secretary reads HJR 86)

3 PRESIDENT:

4 You heard the motion. All in favor say Aye. Opposed  
5 Nay. The motion carries. Senator Graham, I would like to  
6 point out to you, that you and I are more concerned about  
7 order in this place than anyone here, and when you and I  
8 are here there is perfect order. Senator Graham.

9 SENATOR GRAHAM:

10 (Inaudible)...might work it out so you and I would  
11 be the only ones here, and then we'll have order. I should  
12 like to suggest to you, Senator, and to the Secretary or who-  
13 ever is in charge of these items that...I think in lieu of  
14 not having our playboy card to get in the door, that when  
15 the Senate is reconvening, as we did just now, that our door-  
16 men should be alerted to have this door over here open, too.

17 PRESIDENT:

18 You're quite right, Senator, and that will be done.

19 SENATOR GRAHAM:

20 If that could be imparted to them we'd appreciate it,  
21 I'm sure.

22 PRESIDENT:

23 Thank you. Any further business to come before the Senate?  
24 Senate stands adjourned until noon Monday, April 12th, 1976.
