- 25. Johns.
- 26. SECRETARY:
- 27. Senate Bill 58.
- 28. (Secretary reads title of bill)
- 29. 3rd reading of the bill.
- 30. SENATOR JOHNS:
- 31. I have held this bill at the request of Senator Nimrod up till
- 32. this point...
- 33. PRESIDENT:

- Just one minute, Senator...just one minute, Senator.
- 2. SENATOR JOHNS:
- 3. ...it's a civil defense bill...bill.
- 4. PRESIDENT:
- 5. Will the members be in their seats. Senator Johns.
- 6. SENATOR JOHNS:
- 7. Again, I'd like to repeat that I have offered the courtesy to
- 8. my colleague, Senator Nimrod. I've held this bill. He just gave me
- 9. the signal to go ahead with it. It amends the Law Enforcement Officers
- 10. and Firemens Compensation Act. It provides compensation for civil
- 11. defense workers and civil air patrol members killed in the line of
- 12. duty. It would be effective immediately, and I would appreciate a
- 13. favorable roll call.
- 14. PRESIDENT:
- 15. Any further discussion? The question is shall Senate Bill 58
- 16. Pass? Those in favor will vote Aye. Those opposed will vote Nay.
- 17. The voting is open. Have all voted who wish? Take the record.
- 18. On that question the...the Ayes are 41, the Nays are 1. This bill,
- 19. Senate Bill 58, having received a constitutional majority is declared
- 20. passed. Senate Bill 61...for what purpose does Senator Buzbee
- 21. arise?
- 22. SENATOR BUZBEE:
- 23. Mr. President, I'd like the...the...printed Journal to show...
- 24. or the recorded Journal rather, that I was off the Floor at the time
- 25. that vote was taken, but had I been on the Floor I would have voted
- 26. in the affirmative.
- 27. PRESIDENT:
- 28. The record will so show. Senate...and Senator Carroll also.
- 29. The same off the Floor motion. Senate Bill 61, Senator Latherow.
- 30. SECRETARY:
- 31. Senate Bill 61.
- 32. (Secretary reads title of bill)
- 33. 3rd reading of the bill.

- 1. PRESIDENT:
- Senator Latherow.
- 3. SENATOR LATHEROW:
- 4. Thank you, Mr. President and members of the Senate. This bill
- 5. came about due to a lot of the problem that arised in the areas where
- 6. deer hunting has been taking place. Last year when many of those
- 7. people who wanted to hunt in the local area were land owners there
- 8. and were turned down for that particular county. Well, in order to
- 9. try to compensate some of those people who became real irritated and
- 10. said well, if I can't get a license to hunt like everybody else I'll
- 11. just close my farm to hunting. I came in with this piece of legisla-
- 12. tion to help take care of them. This is a very simple piece of legisla-
- 13. tion, it merely says that local county residents will be given a seven
- 14. day advantage, at least a seven day advantage, for application of
- 15. licenses. I think then if they fail to get them in on time and get
- 16. taken care of they know who's fault it is. So, I'd be glad to answer
- 17. any question, Mr. President.
- 18. PRESIDENT:
- 19. Senator Savickas.
- 20. SENATOR SAVICKAS:
- 21. Well, Mr. President and members of the Senate, I would rise in
- 22. opposition to this particular piece of legislation. What it effec-
- 23. tively does is cut out the more populous counties that do not have the
- 24. ability to go out deer hunting and hunting, and give the advantage to
- 25. those counties where the people are less populous and have all this
- 26. ability. What they want to do is say all of you in Cook County and
- 27. DuPage County, you can't come down and hunt here because we are first,
- 28. the deer belongs to us, we live here, and we've got the first choice.
- 29.I think this is ... this is for the whole State of Illinois. The people
- 30.in Chicago, Cook County and DuPage County shouldn't be punished
- 31.because they do not live in a...in a area where the deer run free.
- 32. There would be very few hunters in Chicago or Cook County if we...if
- 33.we had...subscribed to this philosophy. I think this is the State

- 1. of Illinois, everyone should be treated equally. That if you're
- 2. in Carroll County or Macoupin County or Cook County, that the
- 3. State law says this is the date to apply for the license, this is
- 4. the date for everybody in the State of Illinois to apply.
- 5. PRESIDENT:
- 6. Senator Mitchler.
- 7. SENATOR MITCHLER:
- 8. Well, I'd...
- 9. PRESIDENT:
- 10. ...do you, oh...
- 11. SENATOR MITCHLER:
- 12. ...just like to ask the sponsor...
- 13. PRESIDENT:
- 14. ...just a moment...one moment...Senator, you want to
- 15. answer them individually, or wait, cause there's several persons who
- 16. want to talk and I thought you might want to...all right. Senator
- 17. Mitchler.
- 18. SENATOR MITCHLER:
- 19. Well, I'd just like to ask the sponsor if this would restrict any
- 20. of the Senators in their deer hunting in the City of Chicago. D-E-A-R.
- 21. PRESIDENT:
- 22. Senator Welsh. Senator Welsh? Senator Egan.
- 23. SENATOR EGAN:
- 24. Yes, Mr. Speaker and Senator Latherow, it...it occurs to me being
- 25. from Cook County where we don't have any kind of a deer...well, there...
- 26. there...there is no hunting deer in Cook County. We do have a deer
- 27. population there, but it occurs to me that all of us in Cook County that
- 28. have to wait seven days for a permit, that will eliminate some permits to
- 29. the heavier more populated counties, which is really a discrimination
- 30. against us who will support wildlife in Illinois and at the same time
- 31. suffer from the consequence of...of what the inequity I think...that is
- 32. created. Now, I would...I would think Senator, that it would be fairer
- 33. to restrict, if you will in this fashion, or...give preference to

- people who have permission to hunt on someone's private property, and
- maybe they should be allowed to give...to obtain their permits first
- rather than the way you're doing it here. Now, Senator Ozinga, I notice,
- 4. is a cosponsor on the bill. Obviously, he doesn't go deer hunting.
- 5. But I've got a lot of pals and a lot of constituents that hunt deer
- 6. and provide a lot of money for the conservation of wildlife in Illinois,
- and they're from Cook County. Senator, I,..I fail to see any fair
- ${\bf 8.}$   $\,$  aspect of this bill, and I would urge anyone who is from a...a more
- 9. metropolitan area, such as in Cook and those downstate, that this
- 10. is totally unfair to us. And if you...if you were rather to have the
- 11. discrimination for people who have permits to hunt on private property
- 12. I could see the equity there, but this is totally unfair to Cook
- 13. County and to the more populated areas downstate, and consequently I'm
- 14. going to have to oppose it, Senator.
- 15. PRESIDENT:
- 16. Senator Knuppel.
- 17. SENATOR KNUPPEL:
- 18. This is a humane bill, Gentlemen. First of all, I'm afraid a
- 19. lot of those people from Cook County might not know the difference
- 20. between a deer and a cow. At least that's been the experience of
- 21. the downstate farmers and it's humane for the cattle population, so
- 22. you have beef and keep the cost of...of beef down on the market for
- the consumer. And secondly, it's humane for those people who come
- 23. the consumer. And secondly, it's humane for those people who come
- 24. out of Chicago to hunt, because we have the kind of situation we had
- 25. last year where they don't...the farmers downstate, the people down-
- 26. state don't get permits, they're going to start shooting those people
- 27. from Chicago just like they shoot each other up there. And we want
- 28. to protect them, we don't want that to happen. Secondly, Senator
- 29. Egan says it's unfair, but you know those deer live out there in those
- 30. blackjack timber, they come out and eat my crops all year, and hell,
- 31. I ought to get first shot after that, you know. And then what's left...
- 32. they...they get to shoot what's left, I ought to get first shot after
- 33. I feed them for them. That's not discriminating, I raise them for

- ı. you, you know. And I don't get any payment for all the corn and grass
- 2. and beans and everything else they eat and water they drink. So I think
- з. the guy that raised them ought to get first shot anyway, you know, kinda
- 4. like the old dog used to get first bite, but I do like the one sugges-
- 5. tion that you made. I...I think they ought to...ought to make it seven
- 6. days preference for those people who live in the downstate counties
- 7. and then another seven days for those people that have a place to
- 8. hunt. And...and I would agree with you on this and then let the other
- 9. people who don't have a place to hunt, and who don't have any deer and
- 10. don't feed any deer, give them that after fourteen days. Thank you.
- 11. PRESIDENT:
- 12. Will the members be in their seats, and will the persons not
- 13. entitled to the Floor, please leave the Floor? I'm just...it's a
- little frustrating to not be able to hear them. I'm glad I don't 14.
- 15. have a deer rifle up here. Senator Howard Mohr.
- 16. SENATOR MOHR:
- 17. Yes, Mr. President, I wonder if the sponsor would yield.
- 18. PRESIDENT:
- 19. He indicates he will.
- 20. SENATOR MOHR:

- 21. Senator, I share the same concern to a point that Senator Knuppel
- raised, or the point that he raised, with regard to a fellow that owns 22.
- a farm and...and feeds deer and cattle all year long, he should have a 23.
- right, I agree with that. I know of instances where people owned farms
- that happen to live in the metropolitan Chicago area that can't get 25.
- a permit to bring their own families on because when they apply they 26.
- are always too late, and I personally have been trying to get applica-27.
- tions for one family that own property in Senator Roe's area, and... 28.
- they've been...just haven't been successful for about six years. 29.
- wonder if there's some relief that we might be able to give to a 30.
- ...a land owner that lives outside of the...the county. 31.
- PRESIDENT: 32.
- Senator Latherow. 33.

### SENATOR LATHEROW:

- 1. I spent a little time talking to the director and he showed me
- 2. a copy of...some of the regulations that he's coming up with, and
- 3. this will allow a farm owner and members of his family, regardless
- 4. of where he lives, to obtain an...outside...if not living outside the
- 5. State of Illinois. If he's living in the State of Illinois, he and
- 6. the members of his family can each and everyone get a five dollar permit
- 7. to hunt on his own property.
- 8. PRESIDENT:
- 9. Senator...Senator Mohr.
- 10. SENATOR MOHR:
- 11. Well, I appreciate hearing that, I think that whole...whole process
- 12. should be looked at and reworked. I'm personally still not satisfied.
- 13. PRESIDENT:
- 14. Senator Johns.
- 15. SENATOR JOHNS:
- 16. Ladies and Gentlemen of the Senate, Lady and Gentlemen of the
- 17. Senate, I served the region, the 59th district and we have the highest
- 18. deer population, d-double-e-r, in the State of Illinois. And on the
- 19. first premise, I would probably may have even joined Senator Latherow
- 20. in this endeavor and then now I've got to admit that we love the
- 21. money, the income, that my colleagues from the North come to Pope
- 22. County and to southern Illinois to hunt deer. We love the hospitality
- 23. that you...you bring with you...in packages sometimes, but I can't go
- 24. for this bill because it would really be a little discriminatory. I
- 25. would tell you that we have a beautiful deer festival down in Pope
- 26. County, and in a little town of fifteen hundred people we have fifteen
- 27. thousand crowd into that community, beautiful parade, and so I'm really
- 28. giving you a pitch to tell you that that bill that you voted on yester-
- 29. day, that Little Saline River Lake, that's what changed me. Thank you

- 31. Senator Welsh.
- 32. SENATOR WELSH:
- A question for the sponsor.

- Mr. President, I think that this is a bad bill for...for the 26.

- SENATOR SOMMER: 31.

PRESIDENT:

- Would the sponsor yield for a question? 32.
- 34. Senator Latherow indicates he'll yield.

- 1. SENATOR SOMMER:
- Senator Latherow, as you know, when you go hunting deer, you
- 3. have to check them in at a check in point and down in the county in
- 4. my district a couple years...ago, a couple of hunters came in and they
- 5. had a donkey strapped onto the car, this is true, and they went to
- 6. the check out point and...they had that happen. About two years ago,
- 7. our local sheriff gave permission for some hunters to come on to the
- 8. property and they shot a man's prize goat. Will your bill prevent this
- 9. sort of activity?
- 10. PRESIDENT:
- 11. Senator Latherow.
- 12. SENATOR LATHEROW:
- 13. Well I might approve the elimination of a few goats, but keep
- 14. all those donkeys around. We like them down there.
- 15. PRESIDENT:
- 16. Any further discussion? The question is shall...oh yes, Senator
- 17. Latherow may close the debate.
- 18. SENATOR LATHEROW:
- 19. Well, Mr. President, thank you. I had a couple of questions, or
- 20. statements mentioned that I'd like to clarify. I might say...Senator
- 21. Egan, in relationship to the man we call deer slayer Ozinga, that I
- 22. ran four deer by him last fall before he could finally hit one of them,
- 23. and he did get the first deer that the group of us were hunting...to-

- 25. of these rural people who have property and as Senator Knuppel said,

- and every member present to bear in mind that the effects of this bill 28.
- reaches back to the disasters that we experienced here in the State of 29.
- Illinois in the earlier part of last year, nineteen hundred seventy-30.
- four. It is estimated that in order to fund this bill the sum of one 31. million five hundred thousand dollars will be necessary. The Federal 32.
- law provides and the Federal Government has agreed to pay three-forths 33.

- 1. of that amount of one million, one hundred and twenty five thousand
- 2. dollars of the total, one million, five hundred thousand. Under the
- 3. Federal law, the State in which a disaster area has been declared, pays
- 4. the remaining one-forth. And that of course means that the State of
- 5. Illinois has been assessed at three hundred seventy-five thousand
