Yes, Mr. President, Amendment No. 3 restores some eighty-

some of the others that we thought were double budgeted were, in fact, not double budgeted. So, what we're doing is, we're

- 11 Yes, I think Senator Harris has an amendment he wants
- 12 to offer, Mr. President, before...
- 13 PRESIDENT:
- 14 We're just trying to determine. There's an amendment
- here...may I see it, please...with...without a name. Is it
- 16 ...your amendment relates to page 1, line 13 and page 1,
- 17 line 15, Senator Harris? And, yes...fine....fine. This is
- 18 your amendment, then? Fine. This is Amendment No. 4. Senator
- 19 Harris.
- 20 SENATOR HARRIS:
- Thank you, Mr. President. This amendment is an increase
- 22 amendment, and I am somewhat reluctant in the light of our
- 23 severe circumstance, to be in favor of any increases, but I
- 24 do want to call real serious attention of the membership to
- 25 this proposal. The Department of Insurance is that agency
- of State Government that really stands between the entire con-
- 27 suming part of our twelve million people in Illinois and the
- 28 increasing demand requirement to be insured. The departments
- 29 activities and obligations have been increasing and the need
- 30 for it to be equipped with truly professional people to en-
- 31 gage in the examination of the companies licensed here in
- 32 Illinois just cannot be over emphasized, and through several
- 33 years of very narrow response to their staff needs on the

professional level, they've reached an extremely severe situa-2 tion with respect to the ability of them to really do their 3 job. Now, I've discussed this situation with the director and with the assistant director, two really professional 5 people, and this amendment would provide for an increase in the appropriation by an amount of a hundred fifty-four thou-7 sand seven hundred thirty-three dollars. It would provide in the course of fiscal '77, not on a full twelve month basis, g but as they could recruit these people for some fifty-seven 10 thousand dollars in the course of the full twelve month period. 11 Five additional actuarial examiners and three insurance com-12 pany examiners for an amount of thirty thousand six hundred 13 dollars and two insurance performance examiners in the amount 14 of twenty-two thousand eight hundred, and then the provision 15 for the stenographic backup that these professionals would 16 need an -additional twenty-seven thousand dollars for a total 17 of a hundred fifty-four thousand seven hundred thirty-three 18 dollars. Now, I just urge you to anticipate the fact that 19 the critical situation that the department now finds itself 20 in of really not adequately having on board the kind of pro-21 fessional capability to do its job to protect the insurance 22 consuming public in Illinois, and there are, I do not suggest 23 at all that there are any companies that are in difficulty, 24 but there are many that are marginal, and if the department 25 is really going to be equipped with the people and the personnel 26 to red flag those problems they've just got to have the authori-27 zation to recruit adequately these professionals. And I would 28 move, I would be happy to respond to any questions, and I would 29 move the adoption of Amendment No. 4. 30 PRESIDENT:

SENATOR HYNES:

members of the Senate, I rise in opposition

- ı. to this amendment. The...particularly in view of the amend-2. ment that Senator Buzbee has just offered and which was adopt-3. ed by this Body, which restored roughly about fifty percent 4. of the amount that had been cut in the Appropriations Com-5. mittee. We recognized during the committee hearing that there 6. was a possible error in our computations and ... and we looked into 7. that matter and, in fact, determined that we were in error, 8. and we've restored that money which leaves the reduction at 9. this point at about eighty thousand dollars. The...in the 10. budget itself we have made allowance to permit the depart-11. ment to fill seven vacant positions which have been vacant 12. for some period of time in the current year's budget and we 13. are, also, allowing some of the additional new positions that 14. were requested, so that a total of twelve, counting vacancies 15. and new positions, twelve new employees will be permitted, 16. and we feel that under the...the current situation that this 1-7. is a desirable limitation on the growth of the...of the De-18. partment of Insurance. I think that it will allow the depart-19. ment to meet its responsibilities and I believe that the bud-20. get in its present condition should be supported by this Assem-21. bly. I might also add that the department did not request these 22. additional positions. This goes far beyond the posture the 23. budget was in when it was approved by the Bureau of the Budget 24. and printed in the budget document and introduced into the 25. General Assembly. So, I do not think we ought to be in the posi-26. tion of adding this amount of money in the current fiscal year
- and I, therefore, would oppose the amendment.

32. impressed with Senator Harris' presentation championing to move
33. the cause for the insurance industry or the insurance department,

I could see the ı. need for help, but I just read in this last week's newspaper 2. where we have one of the insurance department 3. employees sitting at a desk for a whole year collecting twenty thousand 4. dollars, no telephone, no work, no business. It's obvious 5. that the department is not in such a critical need for help 6. as the good Senator expresses, and if they were, this one man 7. would be put to work to do something for twenty thousand 8. dollars a year if it was just to relieve another investigator 9. to go out in the field and relieve somebody or assign to duties. 10. I would oppose any...adoption of any increase in this budget 11. until we find out why this department could afford to pay 12. twenty some odd thousand dollars for a man to sit in an empty 13. office, an empty desk and without even a telephone to contact 14. anybody, and yet they say they need money. It...it just isn't 15. ... I just can't conceive of the need for this money in this 16. department. 17. PRESIDING OFFICER: (SENATOR ROCK) 18. Any further discussion? Senator Harris, do you wish to 19. close the debate on Amendment No. 4? 20. SENATOR HARRIS: 21. Thank you, Mr. President. I just close by saying that 22. I sincerely believe this important safeguard agency between 23. the needs of our twelve million people and the requirement that 24. it have the professional people fully authorized by us to do 25. the job that it really should be doing. The department is still 26. under the headcount authorized in both fiscal '74 and fiscal 27. '75 even with the bill in the form it is prior to the offering 28. of this amendment. - 24. appropriation covers two or three different things. One is, it
- 25. covers bills that are legitimately owed from FY '75 to vendors
- 26. and it also covered the transfer of State funds to other agencies
- 27. of the State for the payment of such things as telephone bills
 - 28. to the Department of General Services and so forth. So, what
 - 29. we deleted in committee was that portion that simply stays
 - 30. within the State Treasury, but goes from one department to another.
 - 31. We, also, deleted some...about one hundred and fifty-two thou-
 - 32. sand dollars that goes to outside vendors, and what I'm doing
 - 33. now with this amendment is restoring that one hundred and fifty-two

1. thousand dollars that goes to outside vendors. Now, these 2. vendors are...there are four of them. I don't know all four 3. of them but two of them...one of them is...McDonnel Douglas 4. and the other is the IBM Corporation, bills that are legiti-5. mately owed from FY '75. Now, these bills are...were not 6. paid by the E...EDP revolving funds and so we want to re-7. store that one hundred and fifty-two thousand dollars for 8. those vendors. Then, we do one other thing with this amend-9. ment. Keep in mind that this is a supplemental for bills 10. owed in FY '75, but now we're adding another thirty-seven 11. dollars also for a deficiency in FY '76 for the payment of 12. sheriff's fees for conveying prisoners, and yesterday in 13. meeting with the director I asked him if...wasn't there some-14. way they could accurately project how much sheriff fees they 15. were going to have to pay during a fiscal year, and he said 16. "not really", because although this money is legitimately 17. owed to various county sheriffs they...the sheriffs have to 18. put in the claim for it. Sometimes they fail to put in their 19. claim and if they do fail to put in the claim, of course, 20. they're not paid. But, then it also depends on where they're 21. conveying prisoners from and if they're having to...say, trans-22. port from Cook County to Menard. That's a lot of...lot of 23. mileage and it cost more money to do that, so the thirty-seven 24. thousand will be added for deficiency for sheriffs fees for 25. FY '76. And I would move the adoption of this Amendment No. 26. 2.

of times they say where does our lottery money go, and that's
just about what lottery would. brings in for a year to the State,

- 32. million dollar ceiling on the Civic Center legislation and
- 33. You'll be in here next year bringing it up, because already

- 1. you obligated seventy-eight million dollars and over that
- 2. on that. I'm not trying to defeat that bill, but I'm just
- 3. pointing out that this bonded indebtedness is something
- 4. that took Mayor Beam and his whole gang in New York City
- down the drain, and I think Senator Hynes is pointing out
- 6. some very interesting objections to passage of this. No
- 7. matter how much it's needed, have you got the money, and
- 8. the answer to that is "no" unless you're willing to vote
- 9. for an increase in the Income Tax or the State Sales Tax.
- 10. PRESIDENT:
- 11. Senator Rock.
- 12. SENATOR ROCK:
- 13. Thank you, Mr. President, Ladies and Gentlemen of
- 14. the Senate, and I have a suggestion. I do not, for one,
- 15. I can appreciate Senator Hynes concern. This morning,
- 16. as most of the membership will recall, we had the Capital
- 17. Development Board bills in the Senate Appropriations Com-
- 18. mittee, and I might point out that the reappropriations for
- 19. this purpose for the school bonding purpose are some two
- 20. hundred million dollars and the Board is talking in the
- 21. neighborhood of somewhere about a ninety million dollar lapse.
- 22. Now, it seems to me the more rational course of action would
- 23. be to re-refer Senate Bill 1737 back to the Appropriations
- 24. Committee so it can be considered with those five or six other
- 25. Capital bills that are currently there. We are going to have

- 28. Bond Board. They are overextended in some and under extended

- 30. itself to that, but to let a bill like this with this kind of
- 31. ramification get out kind of unfettered I think is a mistake.
- 32. We could...and so, Mr. President, for that reason I would move
- 33. that Senate Bill 1737 be re-referred to the Committee on Appropriations

- for action by the subcommittee next week. 1.
- PRESIDENT: 2.
- Senator Davidson, do you want to respond? 3.
- SENATOR DAVIDSON: 4.

Why don't I take it out of the record and hold 6. it here and let it be...the idea be considered in subcommittee 7. when we're debating the whole issue and the bill is here and 8. if we come to a just decision what we want to do with it, we 9. can continue with it. - SENATOR ROCK:
- 4. Now, back to the point. I... I am going to pursue my

- Senator...Senator Bruce.
- 9. SENATOR BRUCE:
- 10. Well, if the motion to re...re-refer...
- 11. PRESIDENT:
- 12. Just a moment, Senator Davidson has said he can solve

- 15. Mr. President, as discretion is the better part of valor

- 27. I would like to call this bill back to the order of 2nd
 - 28. reading for the purpose of an amendment to be offered by
 - 29. Senator Moore, Don Moore.
 - 30. PRESIDENT:
 - 31. Is leave granted? Senate Bill 1789 is now on the order
 - 32. of 2nd reading and the Chair recognizes Senator Don Moore
 - 33. for Amendment No. 3.

- 1. SENATOR MOORE:
- 2. Thank you, Mr. President and members of the Senate.
- 3. Amendment No. 3 to Senate Bill 1789 adds this language.
- 4. It deals with the section allowing the condemnation of
- 5. property by the Chicago Regional Port District. The language
- 6. is exceedingly broad and after discussing the matter with
- 7. Senator Dougherty it is apparent that it is only his intention
- 8. to have this condemnation within the corporate limits of the
- 9. City of Chicago, so what Amendment No. 3 does, Mr. President
- 10. and members of the Senate, it allows the condemnation of the
- 11. property lying within a half of mile of the Calumet River
- 12. or Lake Calumet, which is wholly within the corporate limits
- 13. of the City of Chicago. This will remove some objections
- 14. that we in the suburban area have. I know of no objection
- 15. to it. I believe the amendment is agreeable with Senator
- 16. Dougherty, and if there is no discussion I would move for
- 17. the adoption of Amendment No. 3 to Senate Bill 1789.
- 18. PRESIDENT:
- 19. Any further discussion? Senator Netsch.
- 20. SENATOR NETSCH:
- 21. Senator Moore, we do not have copies of this amendment,
- 22. and since it's a fairly intricate and important bill I think
- 23. we should have copies of it so that we can look at it very
- 24. carefully. Apparently, they were not distributed.

- 26. Senator Don Moore.
- 27. SENATOR MOORE:
- 28. It's a very short amendment, Mr. President. If the
- 29. Secretary would read the amendment. It's only a couple of
- 30. lines long, I'm sure you could follow it, Senator Netsch.

- 32. The Secretary will read the amendment.
- 33. SECRETARY:

- 1. (Secretary reads Amendment No. 3)
- 2. PRESIDENT:
- 3. Any further discussion? Senator Bruce.
- SENATOR BRUCE:
- Well, I would just say that Senator Netsch's point is
- 6. well taken. I... can't flip my bill open and read it and
- 7. I think that if a Senator requests that the motion...that
- 8. an amendment be distributed, that we have a chance to read
- 9. it. I don't know how it fits in the entire paragraph or
- 10. how it fits into the concept of the bill. I think it's just
- 11. as we get into late hours here that it's important that we
- have a chance to review amendments and how they fit into
- 13. the entire bill not just one paragraph.

- 15. Senator Dougherty.
- 16. SENATOR DOUGHERTY:
- 17. Well, frankly, I think this is a delaying tactic. This
- bill is vitally necessary to the City of Chicago. Senator
- 19. Netsch's opposition to the bill is well known. I think she's
- 20. lacking the knowledge of it never having been there. I ask
- 21. the adoption of this amendment: There's no need to print it.
- 22. It's comparably simple.
- 23. PRESIDENT:
- 24. Senator Ozinga.
- 25. SENATOR OZINGA:
- 26. Thank you, Mr. President. This amendment we've gone
- 27. over pretty thoroughly and just by reading the statement it
- 28. needs no further explanation, which now reads after amended
- 29. and also any and all real property lying within a half of
- 30. mile of the Calumet River or Lake Calumet and the whole of
- 31. any parcel of real estate, real property adjacent to such
- 32. river or lake which is wholly within the corporate limits of
- 33. the City of Chicago even though part of such parcel may be

- 1. more than a half a mile from such river or lake. Now, we
- 2. in the country towns were a little bit skeptical and a little
- 3. bit worried about giving the Port authorities the right to
- 4. condemn land which is out along the...the Sag...Canal. There-
- 5. fore, we insisted upon this amendment. This was our objection

- 14. Now, Mr. Senator...Mr. President, after this...

- 3. (Secretary reads title of bill)
- A PRESIDENT:
- 5 Senator Rock.
- 6. SENATOR ROCK:
- 7. Thank you, Mr. President, Ladies and Gentlemen of
- 8. the Senate. Senate Bill 18...
- 9. PRESIDENT:
- 10. Just...just a moment. Let's read...let's read it again.
- 3rd reading of the bill, please.
- 12. SECRETARY:
- 13. Senate Bill 1868.
- 14. (Secretary reads title of bill)
- 15. 3rd reading of the bill.
- 16. PRESIDENT:
- 17. Senator Rock.
- 18. SENATOR ROCK:
- 19. Thank you, Mr. President, Ladies and Gentlemen of
- 20. the Senate. Senate Bill 1868 is the FY '77 appropriation

2. (Secretary reads title of bill)

- 3rd reading of the bill.
- 4. PRESIDENT:
- Senator Dougherty.
- 6. SENATOR DOUGHERTY:
- 7. Thank you, Mr. President. Members of the Senate, I've
- 8. spoken long and loud on my sponsorship of this bill. This
- 9. bill is vitally necessary to the economy of the State of
- 10. Illinois. It will not be fully implemented until we get
- 11. this bill out of the House, and I've been reasonably assured
- 12. that we...the bill will be accepted by the House. The time
- 13. is of the element and it will be...take a couple of years
- 14. before we can fully implement it. If there are any changes
- 15. necessary it can be done in the future. However, this is
- 16. necessary and as I have said before I understand that the
- 17. Federal Government is interested in this bill to reason,

 - 30. Senator Dougherty, what is the total wealth of the Chicago
 - 31. Port District and from whence did the wealth come?
 - 32. PRESIDENT:
 - 33. Senator Dougherty.

SENATOR DOUGHERTY:

2. Let me tell you this, Senator, they...the original 3. wealth of the Chicago Port District was covered by a twenty-4. four million dollar bond issue. It was approved by this 5. Assembly which I handled many years ago. The...we have re-6. duced the bond indebtedness by some eight or ten million 7. dollars. It is paid for out of revenues, from the operations 8. of the Port District itself. Now, I have no way, because 9. we all know what the property escalation has been in the last 10. few years, but I would say the property which is wholly owned 11. by the Port District, which is protected by the indentured 12. bond issue, it would be maybe two...two and a half times that. 13. I would say that in all honesty. I couldn't deny it, but 14. remember this, every inch of property within the Chicago 15. Regional Port District was given to the Port District by 16. council action of the City Council back in 1955 and it expounded 17. twenty-three hundred acres of land is what it comprised of 18. The City of Chicago gave this to the Port District by action 19. of the City Council, so I can see no reason why there should 20. be any objection of this bill, which is going to improve the 21. economy of our State.

SENATOR FAWELL:

All right. The...but, there's, but there are no State tax funds that have been utilized here?

PRESIDENT:

Senator Dougherty.

SENATOR DOUGHERTY:

There are no tax funds involved at any time nor ever has there ever been, and the Regional Port District is the only port district in the State of Illinois that operates without any subsidy of any kind. Waukegan...every other port district

- gets some sort of a state subsidy in some way. We have never
- received it and never wanted it.
- 3. PRESIDENT:
- Senator Fawell.
- 5. SENATOR FAWELL:
- 6. Just...just one other point. I don't know if this is
- 7. a...these are contrary statements or not, but on the Amend-
- 8. ment on page 7 in the new wording where in effect it creates
- 9. a power of appointment of five board members from the City
- 10. of Chicago and four from the Governor. It has this wording
- 11. any member of the board no longer...who no longer lives
- 12. within such area, which now would be the City of Chicago,
- 13. who give vacancy that would exist which shall be filled by
- 14. appointment. But, then, in the next paragraph it states
- 15. that it is the intention of this amendatory act of 1976
- 16. that hereafter five members will be appointed by the Mayor

- 4. Any further discussion? Senator Fawell, had you finished?
- 5. SENATOR FAWELL:
- I don't...I'm not trying to cause any problems here,
- 7. really. I'm just saying that it...it appears to me, that as a...
- 8. looking at it as a lawyer, I'd be absolutely nonplused as
- 9. to what that does mean, because in the first paragraph you're
- 10. saying that if you do not live in the area a vacancy exists
- 11. and yet in the next paragraph you're...you're saying that

- 21. I would prefer if this bill passed that it go over to the House
- 22. and if there's ambiguity contained therein, it can be done in
- 23. the House. I...if I'm fortunate passing this bill I will re-
- 24. fer it to the House membership.
- 25. PRESIDENT:
- Senator Netsch.
- 27. SENATOR NETSCH:
 - 28. Mr. President and Senator Dougherty, this is not a question
 - 29. but a statement, and I just want to make it clear that as the
 - 30. saying often goes, it is nothing personal in my objection to
 - 31. the bill, but I... I still do not understand two things, one,
 - 32. why it is so much of an emergency that this bill was voted out
- 33. of Rules Committee and is being passed under our restricted agenda

- and I really don't feel that I've ever gotten a good ex-
- planation of that and I certainly do not understand why
- 3. the emergency rest primarily in turning the control of
- 4. the Chicago Port District over to the Mayor of Chicago,

- board district can have split precincts, and this, you know,
- 5. by splitting the precints I think it would eliminate the
- 6. problem and it would make it much easier to put these county
- board districts in...in...in the district where, you know,
- 8. would eliminate the confusion. People now are not aware of
- 9. which county board district they're in. When they have...
- when they vote they have to go in to...to their polling
- 11. place and where there are voting machines there has to be
- 12. two separate voting machines. One for a person in one dis-
- 13. trict and another for the people in the other district. It
- 14. makes it very confusing for the election judges and also
- 15. where the precincts are over 800 they have to...in fact, where
- 16. they're over 600 they have to hire an extra 5 tally judges,
- 17. so I cannot see where it would cost any more money, but it

- 19. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 20. The Chair has been advised by the Secretary that this
- 21. is, in fact, Amendment No. 2 and not Amendment No. 4 as I had
- 22. previously announced. Senator...Senator Kenneth Hall.
- 23. SENATOR HALL:
- 24. Would the sponsor yield for a question?
- 25. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 26. He indicates he will.
- 27. SENATOR HALL:
 - 28. On this...
 - 29. PRESIDING OFFICER: (SENATOR DONNEWALD)
 - Of the amendment.
 - 31. SENATOR HALL:
 - 32. On...yes. On...I'm looking at this amendment just was
 - 33. dropped on my desk. Now, in my district we have a Board of

- 1. Elections. We have a number of precincts that will be more
- 2. than one...eight hundred. Now, is this changing? Would that
- 3. affect my district?
- 4. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 5. Senator Joyce..
- 6. SENATOR JOYCE:
- Yes, I believe it would.
- 8. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 9. Senator Kenneth Hall.
- 10. SENATOR HALL:
- 11. Well, then, I don't know, Senator, you're dropping some-
- 12. thing here now that you had a chance to check with your people
- 13. but I haven't had a chance to check with mine back home. I...
- 14. I'm concerned. I'd like to talk to...to my county clerk and
- 15. my Board of Elections, because this means that we have a num-
- 16. ber of precincts who are over a thousand, and this would
- 17. really create a problem for us down there, so I wish you would
- 18. hold this until we can get a chance to look at this.
- 19. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 20. Senator Partee.
- 21. SENATOR PARTEE:
- 22. Well, I thought we were going to move this, but why don't
- 23. we put the amendment on and then hold the bill till next week
- 24. so that everybody gets a chance to see what the final impact
- 25. of the bill is. I've been in touch with the County, the County
- 26. Clerks Association, and they're very, very anxious for this
- 27. bill, because it does, in fact, save a lot of money by being
- 28. able to appoint these...appoint these vacancies rather than
- 29. have special elections and we're anxious to get moving with
- 30. it, and...no, I'm speaking on the amendment at the moment, but
- 31. I...I think...just a moment, please, please. I am...I'd like
- 32. to give you my full attention. I can't do that while I'm talking.
- 33. Now, I want to tell you that this may make some difference to

- 1. many members, of course it might, so why don't we put the

- 12. to ask for clarification. It was my understanding of Senator
- 13. Joyce's explanation that he...he said that the amendment would
- 14. require that precincts be split after they reached 800. It
- 15. was my understanding of the law that that is already the law,
- 16. that they're supposed to be split. Maybe he could clarify
- 17. that point.
- 18. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 19. Senator Joyce.
- 20. SENATOR JOYCE:
- 21. Yes, but the problem is the law gets very vague when
- 22. it's dealing with voting machines. Whether they have been
- 23. studying them, whether they have purchased voting machines.
- 24. There's a separate section in the statutes dealing with this
- 25. and it, you know, for instance, we have had voting machines,
- 26. I think, for three years now and...and there's still pre-
- 27. cincts over, you know, well over a thousand up to fifteen
- 28. hundred, and this would clarify that where...it...it would
- 29. do away with that vagueness.
- 30. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 31. Senator Schaffer.
- 32. SENATOR SCHAFFER:
- 33. I'm sorry, Senator Joyce, I'm looking at the amendment

- 1. and I...I don't see the section and...and if you would kindly
- 2. point out where it specifically mandates all precincts be
- split at 800.
- 4. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 5. Senator Joyce.
- SENATOR JOYCE:
- 7. In fact, it doesn't...there isn't any new wording to it.
- 8. All it does is eliminate the part on page 1 from line 18 to
- 9. on page 2, line 5, and then it says the next June after they
- 10. have reached 800 that they would...they should be split.
- 11. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 12. Senator Schaffer.
- 13. SENATOR SCHAFFER:
- 14. Well, then it doesn't specifically mandate the precincts
- 15. be cut at 800. It doesn't change the law.
- 16. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 17. Senator Joyce.
- 18. SENATOR JOYCE:
- 19. No, it doesn't change the law. The law already says
- 20. that precincts shall be split at 800, but it gets vague and
- 21. when it starts dealing with the voting machines.
- 22. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 23. Senator Philip.
- 24. SENATOR PHILIP:
- 25. Thank you, Mr. President, I'd just like to make this
- 26. observation, and I think the law is very clear in my judge-
- 27. ment. The law says when a precinct has over 600 registered
 - 28. voters you may split that precinct. When the precinct be-
 - 29. comes over 800 and that means 801, you shall split...split
 - 30. that precinct. Now, what happens is, in some counties the
 - 31. county clerk or the Election Commission do not follow the law.
 - 32. They do not split the precincts. Now, I don't know how, even
 - 33. if you say mandate or shall, they just don't do it, and I

1. don't know how you can force counties clerks and Election 2. Commissions into splitting precincts. Now, in regards to з. your other problem, we had the same problem when we had 4 . reapportionment in 1970. I had one precinct in my legisla-5. tive district that had three...was put into three legisla-6. tive districts, and so when voters would come in there they 7. would really be confused, they didn't know who their State 8. Senator was or who their State Representative was. We had 9. to have three sets of ballots, three sets of precincts 10. maps, three sets of judges and it was a complete disaster. 11. At the next...before the next election our commission came 12. in and they changed the borders of that precinct and they 13. put that precinct wholly within my legislative district. 14. Any county election commission can do that, the county clerk 15. can do that. They have the authority right now and why we're 16. fooling around with this amendment and this bill I simply do 17. not understand.

18. PRESIDING OFFICER: (SENATOR DONNEWALD)

19. Senator Wooten. Oh, just a moment. Do you wish to re20. spond, Senator Joyce?

The reason we're fooling around with it...with it is because they refuse to do it, and we're trying to just say "look, this is what you've got to do, don't split the precincts and confuse the voters." It's a very simple thing.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Senator Philip.

SENATOR PHILIP:

Well, I just don't see how you can force the election commission or the county clerk into splitting precincts, if they don't want to do it. Now, there isn't any penalty and... and I don't know how you're going to force them into doing it. Now, my...my election commission always splits precincts. We

- 1. don't have a...we didn't split a precinct that wasn't over
- 2. 800, everytime we have, and we have taken care of all those
- 3. problems where the precincts overlap, county board districts
- 4. and legislative district. It's a mechanical simple thing
- 5. that that election commission does and will do, but if they
- 6. don't want to do it, there's no way of forcing them into
- 7. splitting precincts or changing precinct boundaries. That's
- 8. how simple it is. No matter what your amendment does or what
- g. your bill does.
- 10. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 11. Senator Wooten.
- 12. SENATOR WOOTEN:
- 13. The richness of the english language is perhpas giving
- 14. us some problems. At least I was having difficulty distin-
- 15. guishing what kind of splitting we're discussing. It seems
- 16. to me the bill...this amendment does one thing clearly. It says you
- can't take an existing precinct, put part of it in one
- county board district and part in another. I think that's
- 19. good. It also takes out the fudge language that county clerks
- 20. use to delay splitting precincts. If you look on page five,
- 21. I believe it is, provisions of this section apply to all
- 22. precincts including those where voting machines or electronic
- 23. voting systems are used, and it cuts out all of the language
- 24. the county clerks have used to justify dilatory tactics in
- 25. splitting precincts which have grown too large, so the amend-
- 26. ment accomplishes two good things. Things, I think, which
- 27 conscientious county clerks, well run political organizations
 - 28. already do, but because of all offices are filled by human
 - 29. beings doesn't mean that everybody does the proper thing willingly,
 - 30. and this amendment makes it crystal clear what can and cannot
 - 31. be done.
- 32. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 33. Is there further discussion? The question is, shall...just.

- 1. a moment. Senator Davidson.
- 2. SENATOR DAVIDSON:
- Well, and most of the argument has been covered, but
- 4. there's one thing, if this amendment goes on and Senator
- 5. Philip spoke that there is no way to mandate, but if Senator
- 6. Joyce's amendment goes on as is, you're mandating that eleven
- 7. or twelve or thirteen counties in this State which have split
- precincts within a county board district, that they're going
- 9. to reapportionment their county board. Now, if they want
- 10. to, if they don't want to there is nothing you can do to .
- 11. solve it. More importantly with the census not coming up
- 12. till 1980 and you have any growth in your county at all
- 13. the 1970 census is then incorrect. You're, therefore, go-
- 14. ing to make this county board or the election commission
- 15. which has to correct this error or change these precincts
- 16. subject to suit, because the percentage of number of voters
- 17. to the one man, one vote in each district, therefore, would
- 18. be in jeopardy. I think rather than put this amendment on
- 19. I would suggest to Senator Joyce that he hold the amendment
- 20. until we get everything worked out, because you're really
- 21. saving...you're not losing a day, you're not gaining a day.
- 22. Let's get this thing worked out and do it correctly before
- 23. we put an amendment on and have to reconsider and take it
- 24. off and et cetera. It...this amendment as presented is going
- 25. to create problems for many...not going to create any problems
- 26. in my district, cause I don't have any split precincts in the
- 27. county board district, but it's going to create a problem
- 28. in those other twelve or thirteen counties that you've already
- 29. heard from.
- 30. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 31. Is there further discussion? The question is, shall
