- 28. Senate. This is the annual appropriation for FY '77 for the
- 29. Office of State Treasurer of a hundred and fifty-three million
- 30. three hundred and ninety-one thousand for the ordinary and
- 31. contingent expenses for payment of fees and bonds and coupon
- 32. redemptions, for inheritance tax refunds and for payments of
- 33. principal and interest on bond indebtedness. Of this amount

- twenty-eight thousand one hundred and fifty is appropriated
- to meet the ordinary and contingent expenses of the Illinois
- 3. State Board of Investments. The Senate Appropriation Committee
- 4. reduced this appropriation by four thousand five hundred in
- 5. personal service in order to the lower step in merit increases.
- 6. Consequently, this appropriation is now a hundred and fifty-two
- million eight hundred and eighty-six thousand four hundred
- dollars. I'd ask your most favorable support of this bill.
- PRESIDENT:

- 12. Yes, Mr. President. Senator Hall, could I ask you a

- 14. as extended in House Bill 3559, and I urge support of the members
- 15. of the Senate.

- 18. SENATOR GLASS:
- 19. Thank you, Mr. President and Ladies and Gentlemen. I would
- 20. just like to echo Senator Moore's support. When this bill was a
- 21. Senate bill, I believe I voted Present on it, and the questions
- 22. I had of...have been largely answered to, and I think paramount
- 23. in my consideration on the bill is that most of this work that
- 24. ... of which the Federal funds will be used that these local funds
- 25. will match is work that has to be done by...by local...throughout
- 26. ...local communities in Cook County to meet Federal EPA standards.
- 27. I don't think there's much choice on the matter, and I...I think
- 28 it's essential that we get about this work and also support this
- legislation.
- 30. PRESIDENT:
- 31. Senator Buzbee.
- 32. SENATOR BUZBEE:
- 33. Mr. President, when this bill came before the Senate in the form

- ...in the version of a Senate Bill, I voted No on it. That ı.
- was before, I might add, Mr. President, that I found out that 2.
- this interceptor line ran all the way to SIU in Carbondale and in 3.
- Edwardsville. When...when ...when that became apparent to me, 4.
- I... I understood the error of my ways, and today I'm planning 5.
- to support this bill, Mr. President. 6.
- PRESIDENT: 7.
- Senator, are you saying that its parochial features appeal 8.
- to you? 9.
- SENATOR BUZBEE: 10.
- Yes, definitely. 11.
- PRESIDENT: 12.
- Any further discussion? Senator Fawell. 13.
- SENATOR FAWELL: 14.
- I...I just wanted to know the three percent of the assessed 15.
- valuation amounts to a total bond issued of non-referendum for 16.

- In closing, Mr. President, I would just say that out of 32.
- that eight hundred million, three hundred and fifty has already been 33.

- 15. PRESIDENT:
- Senator Glass.
- 17. SENATOR GLASS:
- 18. Thank you, Mr. President and Ladies and Gentlemen, in
- 19. this bicentennial year, I would urge the attention of the Body
- 20. to this bill. It is a bill that...
- 21. PRESIDENT:
- 22. Gentlemen, right here, could we move a little bit, and
- 23. may the gentleman have your attention. Senator Glass.
- 24. SENATOR GLASS:
- 25. Thank you, Mr. President. It is the bill that would help
- 26. Illinois preserve some of its historical heritage and I commend
- 27. it to all of you. I explained it the other day, and I think
- 28. there was some misunderstanding, so let me make a couple of
- 29. things clear. First, there is no condemnation powers in the bill.
- 30. There's no infringement of property rights. What the bills does
- 31. is allow a council, which is in existance today, to nominate
- 32. historic sites. Those sites are then approved or disapproved
- 33. by the Director of Conservation who makes the final selection

- 1. of historic sites. Once a site is, in fact, a historic site
- 2. in Illinois, the consequences are simply that before that site
- 3. can be demolished, a grace period of up to a hundred and twenty days
- 4. exists, wherein individuals interested in preserving the site
- 5. may arrange to do so. I would be glad to answer any questions.
- 6. I have amended it to meet the objection of Senator Mitchler, who
- 7. isn't on the Floor, but I have discussed it with him. I believe
- 8. he has no further objection, and I would urge a favorable roll call.
- 9. PRESIDENT:
- 10. Any further discussion? The question is, shall House Bill
- 11. 37...pardon me...Senator Hickey, did you desire recognition? Senator
- 12. Hickey.
- 13. SENATOR HICKEY:
- 14. Yes, Mr. President. I'd simply like to say that I think
- 15. that this is a very good bill. If this had been on the books back
- 16. a few years ago, I would have been able to have saved a very important
- 17. historical building in my area, and I urge a Yes vote on this.
- 18. PRESIDENT:
- 19. Senator Latherow.
- 20. SENATOR LATHEROW:
- 21. Mr. President and members, I only rise to clear my throat
- 22. and vote Present.
- 23. PRESIDENT:
- 24. Any further discussion? The question is, shall House Bill
- 25. 3797 pass? Those in favor vote Aye. Opposed Nay. The voting
- 26. is open. Have all voted who wish? What about the board? Have
- 27. all voted who wish? Take the record. On this question, the
- 28. Ayes are 48, the Nays are 1, with 2 Voting Present. House Bill
- 29. 3797 having received a constitutional majority is declared passed.
- 30. For what purpose does Senator Chew arise?
- 31. SENATOR CHEW:
- 32. ... I rise to ask a question, Mr. President.
- 33. PRESIDENT:

- State your question.
- SENATOR CHEW:
- I noticed that the board is malfunctioning. I don't know
- 4. whether it's manually or automatic, and I am accustomed to watching
- 5. the board very carefully and as we vote, the number increases,
- 6. or the numbers increase, and on the last couple of votes we had,
- 7. we don't get a total until you have asked has all voted who
- 8. wish? Could you give me some corrections on that, and maybe
- 9. we need to join and call in a electrican, or an astronaut or
- 10. something?
- 11. PRESIDENT:
- 12. Well, let me say to you, Senator, that the board is not
- 13. malfunctioning. There are several ways that the board may be
- 14. operated, and we are just exhibiting those this morning.
- 15. SENATOR CHEW:
- 16. Did you get leave of the Senate to exhibit the board in
- 17. that order?
- 18. PRESIDENT:
- It is not necessary, Senator.
- 20. SENATOR CHEW:
- 21. I assume your authority as the President gives you that
- 22. broad power to get us all in suspense.
- 23. PRESIDENT:
- 24. Not is...not...not authority, prerogative is the word.
- 25. SENATOR CHEW:
- 26. Well, whatever it is, would you change it back to what you've
- 27. been doing?
- 28. PRESIDENT:
- 29. In other words, you like the old system. I just wanted to
- 30. show you what the board could...how it could be done. That's all.
- 31. SENATOR CHEW:
- 32. Does it have a brain that could vote me when I'm absent?
- 33. PRESIDENT:

- Only if there's fight somewhere. ... House Bill 3818, 1.
- Senator Bruce is not here. Senate Bill... House Bill 3820. 2.
- Senator Joyce. 3.
- SENATOR JOYCE: 4.
- Yes, I'd like to move that bill back to 2nd reading for 5.
- the purpose of two amendments. 6.
- PRESIDENT: 7.
- Is leave granted? Leave is granted. House Bill 3820 8.
- is now on the order of 2nd reading and Senator Joyce is 9.
- recognized. 10.
- SENATOR JOYCE: 11.
- Senator Regner had an amendment that he gave to me yester-12.
- day. 13.

- Yes, Mr. President and members of the Senate. What this 18.

- 2. SENATOR ROCK:
- 3. Thank you, Mr. President, Ladies and Gentlemen of the
- 4. Senate. Amendment No. 4 would add eight-five thousand five hundred
- 5. dollars for an appropriation to carry out the purposes of Senate
- 6. Bill 1950, which this Body acted upon yesterday and we expect
- 7. favorable action by the House, and it is...it is the appropriation
- 8. to handle those hazardous materials and emergencies. I would
- 9. move its adoption.
- 10. PRESIDENT:
- 11. Any discussion? Senator Hynes, what was the question?
- 12. SENATOR HYNES:
- 13. 2nd reading. Should be on 2nd.
- 14. PRESIDENT:
- 15. Senator Harris.
- 16. SENATOR HARRIS:
- 17. Now, this bill is an appropriation to the Fire Protection
- 18. Personnel Standards and Education Commission. Do I understand,
- 19. then, that by means of this amendment, we are mandating that
- 20. State agency to perform the responsibilty of the private carriers
- 21. of the State to identify vehicles which would be carrying radioactive
- 22. materials? Is...is that the purpose of this amendment?
- 23. PRESIDENT:
- 24. Senator Rock.
- 25. SENATOR ROCK:
- 26. No, the...there are two parts to the bill, Senator.
- 27. The other is for the ordinary and contingent expenses of the
- 28. emergency services and disaster agency, and in order to effectively
- 29. carry out the provisions of Senate Bill 1950, obviously prospective
- 30. upon its passage and approval by the House and Governor respectively,
- 31. the...an additional eighty-five thousand five hundred dollars will
- 32. be necessary.
- 33. PRESIDENT:

- Senator Harris.
- SENATOR HARRIS:
- And...and what...all right. I'm sorry. I, in...in looking
- 4. at the Calendar, I... I recognize now that this is a... combination
- 5. appropriation to...to two State agencies. Now, will the emergency
- 6. services disaster agency be the agency to identify vehicles
- operated by private carriers that are transporting radioactive
- 8. materials? Will that be the agency required to implement the
- 9. provisions of Senate Bill 1950?
- 10. PRESIDENT:
- Senator Rock.
- 12. SENATOR ROCK:
- 13. A qualified, "yes." As I understood the debate on 1950,
- 14. this is the agency that has that responsibility. I do not think,
- 15. however, if I recall the testimony, and perhaps Senator Latherow
- 16. or...or Senator Partee who its sponsor, I...I don't think it was
- 17. concerned with radioactive material.
- 18. PRESIDENT:
- Senator Harris.
- 20. SENATOR HARRIS:
- 21. Well, it's my understanding that there...there is a special
- 22. difference between hazardous materials, which encompasses all
- 23. kinds of classifications meeting that definition and then, a...a
- 24. special and limited kind of material that is radioactive and it
- 25. was my understanding that...that this amendment...applies only
- 26. to radioactive materials, and my point is that I can envision
- 27. the difficulty and the complexity of the marking of such materials
- 28. by a State agency having the responsibility to go into private
- 29. carrier property and having this responsibility before public
- 30. transportation by private carrier, vehicles and conveyances before
- 31. they can move. It just seems to me that the thrust of this is is
- 32. unrealistic. That the answer ought to be or the solution ought
- 33. to be, that the burden be placed on the carriers to so identify who

- 1. who thereby can coordinate the scheduling and the movement of
- 2. their conveyances. I...I...and okay.
- 3. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Rock.
- 5. SENATOR ROCK:
- 6. Well, I...I think the point you make with respect to the
- 7. radioactivity problem is a correct one, and there was some
- 8. discussion, as I recall, when...when the passage of Senate Bill
- 9. 1950 was under discussion. The amendment, however, which I
- 10. have offered it...it is not correct to characterize that amendment
- 11. for the purpose of any...any activity with respect to radioactive
- 12. material. No, that is not the purpose of the amendment. The
- 13. purpose of the amendment is to provide to the Emergency Service
- 14. and Disaster Agency, eighty-five thousand five hundred dollars
- 15. to carry out the provisions of Senate Bill 1950. Period.
- 16. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 17. Is there further discussion? Senator Harris.
- 18. SENATOR HARRIS:

- 19. Well, I...I...I am really troubled by the language here,
- 20. and...and I don't quite understand. I just can't see how this
- 21. limited number of people are going to implement Senate Bill 1950.
- 22. I...and the...the language here is that the following named sums
- 23. or so much thereof as maybe necessary respectively for the objects
- 24. and purposes," and then those specific line items from line 10 through
- 25. 17 are appropriated to carry out the purposes of Senate Bill 1950,
- 26. enacted by the 79th General Assembly, and then we identify the
- 27. title of Senate Bill 1950. Now, I am really troubled about...
- 28. what comes through to me as a result of the creation of these
- 29. employees in the administration of Senate Bill 1950, my under-
- 31. if it becomes law, will be placed on the parriers, and...and that's

standing was that the burden for the effect of Senate Bill 1950,

- 32. the way it ought to be. I hope we're not opening up a bureaucracy
- 33. of which I think these provisions are going to be woefully in-

- 1. adequate. That's my concern. I'm not trying in any way to...
- 2. to be negative here. I just...I'm raising what I think are points
- 3. that we ought to be taking a look at now for an important and
- 4. major new program.
- 5. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Partee.
- 7. SENATOR PARTEE:
- 8. Well, Senator, I think that your fears are ungrounded.
- 9. You, see, in setting it up on this basis, there are only about
- 10. sox employees needed. There's a planner who plans the regulations.
- 11. There are four dispatchers. Those...that means people who answer
- 12. the phone and dispatch the other agencies to the site of the
- 13. problem, and one clerk steno. You have to remember that all
- 14. they do is that; they're not involved in enforcement. Emforcement
- 15. comes through the agencies that are involved. Not, it does not place
- 16. any burden on the industry which is not already there. See these
- 17. laws are in conformity with already existing Federal laws. So
- 18. this is all that is needed, and we're not trying to start any
- 19. large bureaucracy, but this is needed for that limited purpose.
- 20. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 21. Senator Harris.
- 22. SENATOR HARRIS:
- 23. Well, I...okay, then I would just raise this question in
- 24. your...as a result of your reference to a planner. Is not Senate
- 25. Bill 1950 going to put into operation, with respect to the State
- 26. of Illinois, the existing Federal plan for the regulation of hazardous
- 27. substances being transported within Illinois?
- 28. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 29. Senator Partee.
- 30. SENATOR PARTEE:
- 31. Yes, I think Senator Latherow's amendment addressed a part
- 32. of that, but the difference, Senator, is the Federal regulations
- 33. relate to transitory things. The State regulations will be affixed

- 1. to those things which are stationary. See the stationary objects
- 2. will be the subject matter of State regulation, and that's where
- 3. you have the planner come in. You know, bulk storage areas and
- 4 areas of that sort.
- 5. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Harris.
- 7. SENATOR HARRIS:
- 8. And is not that responsibility under the purview of the
- 9. Environmental Protection Agency?
- 10. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Partee.
- 12. SENATOR HARRIS:
- 13. Fixed...fixed location...hazardous substance responsibility?
- 14. SENATOR PARTEE:
- 15. For the most part, yes, but there will be some exceptions
- 16. that aren't within the purview of the EPA, but it would be under
- 17. the purview of some other division of government which are a part
- 18. of 1950.
- 19. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 20. Is there further discussion...
- 21. SENATOR PARTEE:
- 22. See now, fertilizer, for example, that would come under
- 23. the Agriculture Department, you see.
- 24. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 25. ...is there further discussion? Senator Glass.
- 26. SENATOR GLASS:
- 27. I would like to ask Senator Partee a quesion, if I may.
- 28. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 29. Indicates he'll yield.
- 30. SENATOR GLASS:
- 31. Senator Partee, as long as we're on this subject, maybe
- 32. you could clarify one other question that was running through
- 33. my mind. I'm looking at this bill and the amendment and recalling

- 1. our committee hearing on Senate Bill 1950 and recall asking
- 2. Director Jones whether there would have to be some technical
- 3. personnel retained by his office in order to formulate regulations,
- 4. and I assume...he answered that there would...I assume that all
- 5. of that expense is something that would be a separate appropriation
- 6. through his office and maybe you could expand that...your
- 7. discussion of that to indicate what costs are involved there and
- 8. if they relate at all to this bill.

- 10. Well, I'm not sure I understand your question but there is
- 11. technical expertise in each of the divisions that make up the
- 12. ...the...the board, and those technical people already on board

- 15. is not with the agency. Let me...let me just repeat that. The

- 31. administration for the appellate judges research project for the
- 32. Fourth District, and I'd moves its adoption.

- SENATOR KOSINSKI: 2.
- Mr. President, I move to Table this Amendment. 3.
- PRESIDING OFFICER: (SENATOR DONNEWALD) 4.

- speaking about forty-seven thousand dollars. This is a project 20.
- similar to that which the First Appellate District has had in 21.
- operation for some three years. Our cost up...up in the First 22.
- Apellate District, I think, is about a hundred and eighty 23.
- thousand dollars. The project is extremely worthwhile in that 24.
- it has assisted greatly in the reduction of the backlog in the 25.
- appellate court. Not too many years ago, it used to take nine 26.
- and ten and eleven and twelve months to obtain an opinion out of 27.
- the appellate court. That has significantly has been cut back 28.
- and cut back due in large measure, not only to the additional 29.
- judges which we created and...and placed in the First District, 30. but because of the work of this...research project. It acts as
- kind of a screening device for the judges and I think is a 32.
- project very worthwhile. The Fourth and Fifth Appellate Districts 33.

- 1. are, in fact, becoming more and more busy. Their caseload has
- 2. increased dramatically, and I think in fairness to our friends
- 3. in southern Illinois, we should allow this program to commence
- 4. and to continue, and for that reason, I rise in opposition to
- 5. Amendment No. 5.
