- 27. SENATOR DAVIDSON:
  - 28. I was out of the Chamber over at the House on a bill
- 29. when you took House Bills, 2nd reading. Could we revert that
- 30. order and move 3841 to 3rd reading, please?
- 31. PRESIDENT:
- 32. Just as soon as I can determine what we're going to do
- 33. with this one.

- 1. SENATOR DAVIDSON:
- 2. Okay.
- 3. PRESIDENT:
- 4. Then I'll get to you. Senator Kosinski, you want to
- 5. go with 1650?
- 6. SENATOR KOSINSKI:
- 7. Yes.
- 8. PRESIDENT:
- 9. All right. Take 1650 out of the record. I'm sorry.
- 10. It's Senate Bill 1795, Senator Kosinski. Senator Kosinski.
- 11. SENATOR KOSINSKI:
- 12. Mr. President and members of the Senate. I wish to
- 13. concur on Amendment No. 6 on the Judiciary appropriation.
- 14. PRESIDENT:
- 15. Any discussion? Senator Kosinski moves that the
- 16. Senate concur in House Amendment No. 6 to Senate Bill 1795.
- 17. Senator Soper.
- 18. SENATOR SOPER:
- 19: Well, all I know is that House Amendment No. 6, what does
- 20. it do? Senator Kosinski. Senator Kosinski.
- 21. SENATOR KOSINSKI:
- 22. The staff isn't available. I'm waiting for them.
- 23. PRESIDENT:
- 24. Senator Regner, maybe he knows. Senator Regner.
- 25. SENATOR REGNER:
- 26. Yes, it's a...it's really just technical wordage changes
- 27. on the fifty percent amendment that Senator Partee has been
- 28. putting on. Some of the wordage was wrong and it was changed
- 29. and there is no dollar amount affected.
- 30. PRESIDENT:
- 31. Senator...the question is, shall the Senate concur
- 32. in House Amendment No. 6 to Senate Bill 1795? Those in favor
- 33. vote Aye. Opposed vote Nay. The voting is open. Have all

- 1. voted who wish? Take the record. On that question the
- 2. Ayes are 39, the Nays are 1 with none Voting Present.
- 3. The Senate does concur in House Amendment No. 6 to Senate
- 4. Bill 1795. And the bill having received the required constitutional
- 5. majority is declared passed. Now, is there leave to revert

- 15. Any amendments from the Floor? 3rd reading. For what
- 16. purpose does Senator Schaffer arise?
- 17. SENATOR SCHAFFER:
- 18. Mr. President, I don't know if there's a lull here,
- 19. I had a motion I was trying to make just before we adjourned
- 20. to discharge a bill from committee. I don't believe it's
- 21. controversial.
- 22. PRESIDENT:
- Senator Schaffer is recognized.
- 24. SENATOR SCHAFFER:
- 25. There is in the Revenue Committee, House Bill 3918
- 26. sponsored by Representative Geo-Karis involving park districts
- 27. abilities to lease or enter into agreements to lease tennis
- 28. courts, et cetera, with other governmental units. I don't
- 29. believe the bill is controversial. It cleared the Rules
- 30. Committee too late to make the last Revenue Committee meeting.
- 31. I've talked to Senator Carroll and Senator Nimrod and I believe
- 32. everyone has been checked out and that we do have permission
- 33. to move the bill from the order of...from the Revenue Committee to

- 2nd reading.
- PRESIDENT:
- Senator Nimrod and Senator Carroll have approved it,
- 4. I don't think you have any problems. You heard the motion.
- 5. All in favor say Aye. Opposed Nay. Ayes have it. The
- 6. motion carries. Senate Bill...back to the order of Secretary's
- 7. Desk on the Order of Concurrences on page seven. Senate Bill
- 8. 1935, Senator Hynes. Secretary's Desk on the Order of Nonconcurrences.
- 9. Page seven. House Bill 2804, Senator Vadalabene. House
- 10. Bill 3858, Senator Knuppel. 3858. Do you desire to make a
- 11. formal motion, Senator? Would you turn on Senator Knuppel's
- 12. mike, please?
- 13. SENATOR KNUPPEL:
- 14. Mr. Chairman, we do not intend to recede from the amendments
- 15. to House Bill 3858 and would respectfully request a Conference
- 16. Committee on it.
- 17. PRESIDENT:
- 18. Senator Knuppel moves that the Senate refuse to recede
- 19. from the adoption of Amendments numbered 1,2,3, and 4 on
- 20. House Bill 3858 and that a Conference Committee be appointed.
- 21. All those in favor say Aye. Opposed Nay. The Ayes have it
- 22. and the Secretary shall so inform the House. Senator Rock.
- 23. Senate Bills on 3rd reading. Senate Bill 1749, Senator
- 24. Philip. Senate Bill 1766, Senator Lemke. Senate Bill 2014,
- 25. Senator Savickas. Going to hold it. Senate Bill 2015, Senator Donnewald.
- 26. Read the bill.
- 27. SECRETARY:
  - 28. Senate Bill 2015.
  - 29. (Secretary reads title of bill)
  - 30. 3rd reading of the bill.
  - 31. PRESIDENT:
  - Senator Donnewald.
  - 33. SENATOR DONNEWALD:

- 1. Well, Mr. President and members of the Senate, this
- does exactly what the Calendar says, it vacates a highway
- 3. easement on, not old Route 40 but old, old Route 40 and I think
- 4. the fellow is paying too much. I would ask for a favorable roll
- 5. call.
- 6. PRESIDENT:
- 7. Any discussion? The question is, shall Senate Bill 2015
- 8. pass? Those in favor vote Aye. Opposed will vote Nay. The
- 9. voting is open. Have all voted who wish? Take the record.
- 10. On this question the Ayes are 44, the Nays are none with none
- 11. Voting Present. House Bill...Senate Bill 2015 having received
- 12. a constitutional majority is declared passed. House Bills
- 13. on 3rd reading. House Bill 1304, Senator Davidson. Read
- 14. the bill.
- 15. SECRETARY:
- 16. House Bill 1304.
- 17. (Secretary reads title of bill)
- 18. 3rd reading of the bill.
- 19. PRESIDENT:
- 20. Senator Davidson.
- 21. SENATOR DAVIDSON:
- 22. Mr. President and members of the Senate. This is a bill
- 23. that the Department of Conservation requested because the old
- 24. law had either a union, ex-union veteran or his son. There was
- 25. some dissension about whether the descendent could come on true.
- 26. We amended this bill so it is a descendent and I know no opposition
- 27. to the bill. Appreciate a favorable roll call.
  - 28. PRESIDENT:
  - 29. Senator Morris.
- 30. SENATOR MORRIS:
- 31. Thank you, Mr. President. Would the sponsor yield
- 32. to a question?
- 33. PRESIDENT:

- 2. SENATOR MORRIS:

ı.

- Why...why does it have to be a descendent of an ex-union
- 4. soldier? That was over a hundred years ago and I think we're...
- we're kind of acting silly.

He indicates he'll yield.

- 6. PRESIDENT:
- Senator Davidson.
- 8. SENATOR DAVIDSON:
- 9. Very simple, Senator Morris. The Lincoln National
- 10. Monument Association, when they transferred the monument and
- 11. grounds and all the property to the State of Illinois, there
- 12. was a signed agreement between the State of Illinois and this
- 13. National Association that the custodian would be either an
- 14. ex-union...Illinois ex-union veteran or his son. Now, there
- 15. is some description...these...Department of Conservation removed
- 16. that entirely and the Senate Committee... Senator Smith and
- 17. Senator Newhouse asked for it to be a descendent of an ex-Illinois
- 18. union veteran. I think it's only right. There's plenty of
- 19. descendents around, You may be one. I know members in this
- 20. Senate are, myself included. ...fact I can claim either side
- 21. since I had relation on both sides of the war. I...they agreed
- 22. to the amendment. Appreciate a favorable roll call.
- 23. PRESIDENT:
- 24. Senator Morris.
- 25. SENATOR MORRIS:
- 26. Doctor Davidson, are there any minorities who are Illinois
- 27. veterans or descendents of veterans of the union war?
- 28. PRESIDENT:
- 29. Senator Davidson.
- 30. SENATOR DAVIDSON:
- 31. Yes, there is. As you very well know if you read your
- 32. Civil War history, Senator Morris. There was a regiment composed
- 33. of black, colored, whatever you want to call us. You're talking

- 1. about minorities, you also had some Spanish speaking veterans
- 2. of the Civil War from the State of Illinois.
- 3. PRESIDENT:
- 4. Senator...pardon me. Senator Morris.
- 5. SENATOR MORRIS:
- 6. I...I guess you got us, but it's really silly. I don't...
- 7. PRESIDENT:
- Senator Howard Mohr.
- 9. SENATOR MOHR:
- Like I was telling you the other day, Mr. President.
- 11. that Senator Davidson covers all of the bases.
- 12. PRESIDENT:
- Senator Shapiro.
- 14. SENATOR SHAPIRO:
- 15. Well, Mr. President, since Senator Mohr made his remark
- 16. and I noted that the sponsor of this bill claims relatives on both
- 17. sides of the conflict, I think it's a good reason to defeat the
- 18. bill.
- 19. PRESTDENT:
- Senator Knuppel. Senator Mitchler.
- 21. SENATOR MITCHLER:
- 22. Well, Mr. President and members of the Senate.
- 23. I'd ask you on this Saturday when you're rather in few in numbers
- 24. and you're getting into the frivolous activity again that you
- 25. watch your remarks and don't try to refer to something that is
- 26. sacred to the living memory of those men and women, whether they
- 27. be minority or majority, whoever they might be, that sacrificed
- 28. their lives to give you the Nation in which you enjoy today.
- 29. In the history of this Nation honors those that have gone
- 30. before and this monument that we have out in Oak Ridge Cemetery
- 31. in the City of Springfield, the capital of this State, is a
- 32. monument to one of the greatest living Americans that we have
- 33. ever had, regardless of what his party or what ...we honor him

- 1. because of his beliefs and for what he stood and what we
- 2. talk about on February 12th, which is Lincoln's Birthday,
- 3. which we honor in this State of Illinois, although throughout
- 4. other areas in the Nation, they try to put it on a Monday
- 5. so that they can have sales in the retail stores and they
- 6. can have vacations. But, I take you...not to take this silly
- and I resent those remarks, Senator Morris, that this is silly.
- 8. This is very serious. You're talking about a memorial and the
- 9. keeping up of that memorial and the reverence to a great man,
- 10. Abraham Lincoln. And the founding fathers in those that
- 11. dedicated that particular memorial wanted it kept by descendents
- 12. of those who fought and gave their lives for the wonderful country
- 13. that you live in and enjoy today. And don't take it lightly
- 14. and I mean that.
- 15. PRESIDENT:
- 16. Senator Morris.
- 17. SENATOR MORRIS:
- 18. On a point of personal privilege. Senator Mitchler,
- 19. I think your response has been extremely silly to this. There
- 20. are a lot of people who are veterans who fought in World War
- 21. I and World War II and in Viet Nam and in Korea who should have the
- 22. same rights to work at that monument as anyone else. There's
- 23. a lot of people who came to this country after 1860 who
- 24. should have those same rights. If they would be willing to accept
- 25. an amendment to make this any veteran who fought for the American
- 26. or the United States Army, Navy, or any military branch, it will
- 27. be acceptable. But, I think this is an elitist and I think
- 28. it's an discriminatory practice and I will vote No.
- 29. PRESIDENT:
- Senator Lemke.
- 31. SENATOR LEMKE:
  - 32. I, in some respects, thought this was a good idea. But,
  - 33. now I read it. I've been reading it and had a problem with it.
- 34. We are setting up a classification of a...of an employee that's

- 1. a custodian, who is a public thing. We are limiting that that
- 2. custodian can only be from a certain class of people, that's
- 3. descendents of the Revolutionary War. Well, anybody here
- 4. that wasn't here at the time of the Revolution wouldn't be able
- 5. to serve and that means my ancestors would never be able to be  $% \left\{ 1,2,\ldots ,n\right\}$
- 6. a custodian if they wanted to be. And I don't agree with this.
- 7. This is an elite classification. It's done exclusively for the
- 8. Daughters of the American Revolution. And I'm telling you this,
- 9. there's people that came here in the 1890's that spilled their
- 10. blood in World War I, World War II, Korea, and Viet Nam that have
- 11. just as... right as being a custodian of this monument as any-
- 12. body that was in the Revolutionary War. This is the ones that
- 13. fought for the freedom, just as well as anybody else. There's
- 14. no certain veteran of any war that's any better than anybody
- 15. else. We're all in the same category and we fight for freedom
- 16. of this country. And I ask for a resistance of this bill until
- 17. it's amended to classify it; that has to be any veteran and not
- 18. just one veteran of some particular war.
- 19. PRESIDENT:
- 20. I have all of you on the list. Senator Graham is next.
- 21. ...you all.
- 22. SENATOR GRAHAM:
- 23. Mr. President and members of the Senate, I had one
- 24. observation. I was called upon yesterday in a formal request...
- 25. will you leave of Gene for a minute? Hey, snakebit. Will
- 26. you get Senator Johns over on the other side of the aisle?
- 27. PRESIDENT:
- 28. Just a moment.
- 29. SENATOR GRAHAM:
- 30. I was asked by a...
- 31. PRESIDENT:
- 32. Just a moment, just a moment. This is a serious discussion on
- 33. Americanism. May we have some order. Senator Graham.

- SENATOR GRAHAM:
- I respect everybody's right to express themselves with
- 3. regard to being an American.
- 4. PRESIDENT:
- Just a minute. Just a minute. Senator Nudelman and...
- 6. please. Could we have some order.
- SENATOR GRAHAM:
- And I was in one of those little scuffles too for about
- 9. four years, but an organization at home asked me if I could
- 10. make a little speech on the 3rd of July. They're going to
- 11. have a little parade early so we avoid the rush. I have my
- 12. notes here. I didn't know what I was going to say, but I'm
- 13. going to come up with the best mixed up Fourth of July speech
- 14. anybody had...has ever had and I'm trying...will you fellows
- 15. talk a little more slowly so I can get it all down, please?
- 16. PRESIDENT:
- 17. Senator Soper is next.
- 18. SENATOR SOPER:
- 19. Well, I don't know how the...the Revolutionary War
- 20. got into this thing. I thought we were talking about...Lemke
- 21. this is the War between the States. That happened a little
- 22. after that. Our founding fathers and all that sort of thing,
- 23. you know. Masaryk wasn't here at that time, either. Neither
- 24. was Benes, or the few other Bohemians, but we're talking
- 25. about a monument that was given to the State of Illinois and given
- 26. to our custody by a...by an organization and if you received
- 27. a piece of land from somebody and there was a reverter clause
- 28. in it and you didn't abide by it, the land would go back to the
- 29. original donor. That's what we're talking about. And we're
- 30. talking about something that now...the...the original Act says
- ·31. it'll be a veteran of the...of the War between the States
- 32. or his son. Now, they say that they...there's very few sons that
- 33. are alive, they can't find any. Now, if you don't pass this
- 34. bill, there will be no custodian. That's that simple. So let's,

- 1. you know, we've got a lot of important things around here and
- 2. if you want to vote one way or another vote that way. But,
- 3. let's not...we've got a little bit of time and this seems like
- 4. everybody got up on the wrong side of the bed. I move the
- 5. previous question.
- 6. PRESIDENT:
- Well, now Senator, Senator Ozinga, Senator Nimrod, and
- 8. Senator Schaffer had asked to speak on this matter. Oh, you
- 9. want to hold the motion till they have a chance. And, incidentally
- 10. Senator, you have a minute left. Senator Soper.
- 11. SENATOR SOPER:
- 12. I see that you've put me on the Democratic clock today.
- - 14. PRESIDENT:
  - 15. Senator Ozinga.
- 16. SENATOR OZINGA:
- 17. At the time when I sought recognition, I didn't think
- 18. there was anybody else on the list. And at that time, all I-
- 19. was going to say is that big wars are made over small, frivolous
- 20. statements that were unintentional in inception, I'm sure. I
- 21. believe we're all Americans and I was about to move the previous
- 22. question way back when there was nobody else on the list.
- 23. PRESIDENT:
- 24. Sometimes wars get started by the use of some words, Senator.
- Senator Nimrod.
- 26. SENATOR NIMROD:
- 27. Last...last night, Mr. President, I went to the Mini
- 28. Opera here in Springfield and saw "1776". I think it kind of
- 29. puts me in the thought for this morning that this country
- 30. is built on traditions and heritage and I've been involved in
- 31. the Polish parades, Puerto Rican parades. You name them...you name them
- 32. and they're there and this is what makes our country great. I see
- 33. nothing wrong with preserving some of the heritage and some of the
- 34. customs that we look to. If we destroy everything that exists

- 1. here that is brought about by our history, there won't be
- 2. much for our children to learn from us and I want them to
- 3. know that there was a Civil War, that there was a Revolutionary
- 4. War, that there was the War of 1812 and what they were for and
- 5. what it was all about. And if we destroy that, we won't know
- 6. that General Pulaski was here. We won't be able to have
- 7. special designated areas about this thing. Now, all I can
- 8. tell you is that I see nothing wrong with this. It adds
- 9. a little custom and tradition, and there's nothing wrong with
- 10. that. We ought to be proud of it. Regardless of what our
- 11. heritage is and what our nationality is, we're all Americans,
- 12. and we ought to have the right to preserve that particular
- 13. heritage. I'll fight for each of you just as I want you to fight
- 14. for me. And when we're Americans and we stand by side by side,
- 15. we also relate our friendships and our heritage and this
- 16. ought to be a part of it.
- 17. PRESIDENT:
- 18. Senator Schaffer.
- 19. SENATOR SCHAFFER:
- 20. Well, I think a couple of points have not been mentioned
- 21. in the debate. One, I suspect that at least by marriage,
- 22. Senator Lemke, that virtually eighty-five percent of the
- 23. population in this State probably qualifies, at least if their
- 24. families have been in the State any length of time. And two,
- 25. I think we should all remember who built the Lincoln Tomb.
- 26. There was some taxpayer money in it, but by and large, most of
- 27. it was money raised by the Grand Army of the Republic, the Civil
  - 28. War Veterans. And consequently, the State of Illinois did
  - 29. enter into this agreement which I believe is a good tradition.
  - 30. I will say, though, that I...I'm...will probably have to declare
  - 31. a personal conflict of interest since I am the great-grandson of
  - 32. a Civil War veteran from Illinois who fought with great distinction
  - 33. and then operated a...and drove a stage line between Waukegan

- 1. and Joliet without government subsidy, the last successful
- 2. mass transit in that area until he met with a tragic end
- 3. which we could go into in another bill. I do think the bill
- does have merit and I do think these traditions are desirable
- 5. to repeat and I think this bill should be passed and after
- 6. I seek legal council on my conflict of interest, if I can legally
- vote for it, I certainly intend to.
- 8. PRESTDENT:
- 9. Senator Rock.
- 10. SENATOR ROCK:
- 11. Thank you, Mr. President. Question of the sponsor
- 12. if he will vield.
- 13. PRESIDENT:
- 14. He indicates he'll yield.
- 15. SENATOR ROCK:
- 16. Senator, as I understood the bill when introduced
- 17. at the request of the Department of Conservation, it was their
- 18. feeling that all these kinds of qualifying clauses were, in fact,
- 19. unconstitutional and should be deleted from the bill and that's
- 20. the way the bill came over from the House. By virtue of your
- 21. Amendment No. 1 you have put this qualification concerning
- 22. the descendent of an ex-union soldier back into the bill. My
- 23. question is, why?
  - 24. PRESIDENT:
  - 25. Senator Davidson.
  - 26. SENATOR DAVIDSON:
  - 27. Yes, in the Senate committee Senator Newhouse and Senator
- 28. Fred Smith ask that it be put in. Department of Conservation
- 29. wrote a letter to Senator Newhouse as Chairman of the committee
- 30. saying they agreed with the wording of putting descendent, an
- 31. ex-Illinois union veteran back in. This would now let any child,
- 32. man or woman be a custodian. This was...they acquiesced to the
- 33. request and they agreed to it in the letter. They didn't say

- 1. they were happy with it, but they agreed with it.
- 2. PRESIDENT:
- Senator Rock.
- 4. SENATOR ROCK:
- Well, if you're speaking about a letter that...which
- 6. I have a copy, I don't read it that way. It seems to me
- 7. the letter I'm reading from a file that we have, a letter
- 8. of June 14 addressed to the Honorable Richard Newhouse from
- 9. the Director of the Department of Conservation, in fact, calls
- 10. in to question the constitutionality of the employment requirement.
- 11. And it does not say...it says, "the Department of Conservation
- 12. agrees that an important qualification for the job of
- 13. custodian at Lincoln's Tomb should be a deep respect for
- 14. Lincoln and his accomplishments. We would prefer," the
- 15. letter continues, "that the number of people we can draw
- 16. from for this position not be limited by this extraordinary
- 17. qualification." That's what the letter says.
- 18. PRESIDENT:
- 19. Senator Davidson.
- 20. SENATOR DAVIDSON:
- 21. That could very well be.... If the Department who asked me
- 22. to handle this bill would have been so kind as to gave me a
- 23. copy of the letter, I would know more about it, but since they
- 24. sent the letter to Senator Newhouse and the only way I finally
- 25. got a...even a look at the letter was a copy which I got
- 26. day before yesterday when I asked for clarification in relation
- 27. to this contract, I might have been more receptive, but they
- 28. may or may not like it, since we did enter into a contract when
- 29. this was donated and they can't find the contract. They did
- 30. find the deed, but all the historical facts...local historians
- 31. of the custodians said this contract was indeed signed. I don't
- 32. think we, by law, can obligate a contract which was entered into.
- 33. PRESIDENT:

- Senator Rock.
- 2. SENATOR ROCK:
- Well, I just wanted to point out that that was, in fact,
- 4. the reason as you gave for putting on Amendment No. 1,
- 5. that there was reportedly a contract a number of years ago
- 6. which contained some reversionary language and if, in fact,
- 7. the custodian was not a member of that group, namely a descendent
- 8. of the union soldier, that there was a possibility of some
- 9. reversionary interest. It appears, however, that absent the
- 10. contract, this amendment is totally unnecessary. And my
- 11. suggestion to move this thing along would be to take House Bill
- 12. 1304 back to the order of 2nd, Table your amendment, and let's
- 13. move the bill out.
- 14. PRESIDENT:
- 15. Senator Davidson.
- 16. SENATOR DAVIDSON:
- 17. Well, Senator Rock, I happen to feel very strongly about
- 18. being a descendent of an ex-union veteran since the people who did
- 19. transfer this property in toto to the State and if...if the Department
- 20. feels otherwise and if it is unconstitutional then they can
- 21. find out by a law suit. I either voted up or down with the amendment
- 22. as it is. The Department asked for it.
- 23. PRESIDENT:
- 24. The question is...just a moment. For what purpose does
- 25. Senator Latherow arise?
- 26. SENATOR LATHEROW:
- 27. Well, Mr. President...
- 28. PRESIDENT:
- 29. Just a moment. Just a moment.
- 30. SENATOR LATHEROW:
- 31. I would say just for a point of personal privilege for
- 32. the people in the balcony, now watch real closely when we have
- 33. a hundred million dollar bill come in here and see how fast it goes.

- 1. PRESIDENT:
- Question is, shall House Bill 1304 pass? Those in favor
- 3. will vote Aye. Opposed Nay. The voting is open. Have
- 4. all voted who wish? Take the record. On this question the
- 5. Ayes are 26, the Nays are 9 with 10 Voting Present. House
- 6. Bill 1304 having failed to receive a constitutional majority
- 7. is declared lost. House Bill 3036, Senator Dougherty.
- 8. House Bill 3061, Senator Clarke. House Bill 3061. Pardon me?
- 9. Senator Clarke is recognized.
- 10. SENATOR CLARKE:
- 11. Well, Mr....Mr. Chairman, Senator Rock had filed a motion
- 12. regarding this bill. And I think he's entitled to call that
- 13. motion...
- 14. PRESIDENT:
- 15. Yes...
- 16. SENATOR CLARKE:
- 17. ...prior to the bill being heard.
- 18. PRESIDENT:
- 19. ...at the time you are going to call the bill. Are
- 20. you going to call the bill, now?
- 21. SENATOR CLARKE:
- 22. If he is interested in filing...calling the motion, I...
- 23. you know, when the order of motions come up, why, I'd like
- 24. to have them do it today. I'd appreciate it.
- 25. PRESIDENT:
- 26. That motion is a motion which can be filed and heard
- 27. just prior to calling the bill. Yes. Senator Rock.
- 28. SENATOR ROCK:
- Yes, my understanding of that type of motion under the...
- 30. under our rules is that it...it really isn't of necessity dealt
- 31. with on the order of motions. It's kind of...runs with the bill
- 32. and when you decide that you wish to move the bill, that motion
- 33. takes precedence over any amendment or any other action. So, if

- 1. you're ready to go, I'm ready to go.
- 2. PRESIDENT:
- Senator Clarke.
- 4. SENATOR CLARKE:
- 5. Well, then let's wait because I was not prepared. I
- 6. thought...I thought that would come, you know, at the end of the
- 7. business tomorrow, today, or so forth.
- 8. PRESIDENT:
- 9. No, they come in tandem. House Bill 3099, Senator Carroll.
- 10. Read the bill.
- 11. SECRETARY:
- 12. House Bill 3099.
- 13. (Secretary reads title of bill)
- 14. 3rd reading of the bill.
- 15. PRESIDENT:
- 16. Senator Carroll.
- 17. SENATOR CARROLL:
- 18. Thank you, Mr. President. House Bill 3099 with this
- 19. amendment deals with the Community College Act and allows
- 20. the community colleges to lease from the Public Building
- 21. Commissions rather than to buy. This...we've done this before
- 22. in the legislature on bond council, Chapman and Cutler in the
- 23. recent issue in some banks in Chicago indicated that the Statutes
- 24. were defective and asked for corrective legislation. This leg-
- 25. islation would correct what they alleged to be a defect in our
- 26. statutory authority and I would ask for a favorable roll call.
- · 27. PRESIDENT:
  - 28. Any further discussion? Senator Berning.
  - 29. SENATOR BERNING:
  - 30. Thank you, Mr. President. I'd like to ask the sponsor
  - 31. a question since we have before us not a bill as the Calendar:
  - 32. indicates there is no relationship whatsoever, of course, since
  - 33. the bill has...since the amendment struck the entire contents
  - 34. of the bill. My question has to do with page two, Senator Carroll.

- 1. When a lease entered into without making a previous appropriation
- 2. for the expense thereby incurred, what...what provision is there
- 3. then for entering...for covering the costs of such a lease?
- 4. Does that not have to be included in the appropriation and in the
- 5. ...in the budget of the junior college?
- 6. PRESIDENT:
- Senator Carroll.
- 8. SENATOR CARROLL:
- 9. Yes, Senator Berning, it is my understanding that what
- 10. that provision means is that you don't have to appropriate
- 11. prior to entering into a lease, which would be a occurrence
- 12. as I understand it, that happens with the state or other
- 13. taxing body, that what happens is that they enter into a lease
- 14. and each year make an annual appropriation for payment of
- 15. rent.
- 16. PRESIDENT:
- 17. Senator Berning.
- 18. SENATOR BERNING:
- 19. Then are you saying that a junior college may enter into
- 20. an agreement for leasing and we are committed then to cover
- 21. that with the next year's appropriation. In other words,
- 22. are we being obligated and having no choice whatsoever,
- 23. simply by passing a...an amendment to a bill which says
- 24. a lease may be entered into without making a previous
- 25. appropriation?
- 26. PRESIDENT:
- 27. Senator Carroll.
- 28. SENATOR CARROLL:
- 29. It is my understanding that that does not obligate we,
- 30. the General Assembly. It is my understanding that where this
- 31. says the lease may be entered into without previous appropriation
- 32. as you go on, it says that the Public Building Commission
- 33. with the Public Building Commission, such expenses shall be

- included in the annual budget of the board of the...meaning
- the board of the community college annually during the term
- of the lease. This is...this is how they do it when they're
- 4. leasing property. They have to appropriate annually for the
- rental.
- 6. PRESIDENT:
- Senator Berning.
- 8. SENATOR BERNING:
- Perhaps I'm unduly concerned, but my interpretation
- 10. is that the appropriation is after the fact and where does
- 11. the money come, actually it comes from us, from the legislature
- 12. and we are obligated to cover an agreement that is entered
- 13. into willingly without any prior authorization by means
- of an appropriation.
- 15. PRESIDENT:
- 16. Senator Soper.
- 17. SENATOR SOPER:
- 18. Senator Carroll, what junior college or district or
- 19. what community college wants...wants this?
- 20. PRESIDENT:
- 21. Senator Carroll.
- 22. SENATOR CARROLL:
- 23. Chicago area junior colleges.
- 24. PRESIDENT:
- 25. Senator Soper.
- 26. SENATOR SOPER:
- 27. What are they committed to?
- 28. PRESIDENT:
- 29. Senator Carroll.
- 30. SENATOR CARROLL:
- I...I don't understand the question, Senator Soper.
- 32. PRESIDENT:
- Senator Soper.

- 1. SENATOR SOPER:
- Well, you want to...you want to change the law or you
- 3. want to make the law so that these junior college...this junior
- 4. college district is committed to some leases. Is that...is
- 5. that...and you want the payment for these?
- 6. PRESIDENT:
- Senator Carroll.
- 8. SENATOR CARROLL:
- 9. No, Senator Soper, it is my understanding that this
- 10. ...this comes about because of an opinion of Chapman and Cutler
- 11. Bond Council who said that in a recent issue of bonds for
- 12. the community colleges and for the Public Building Commissions,
- 13. there was statutory absence of the appropriate type of
- 14. authorization for them to enter into these leases. This legislation
- 15. ... this language is to clarify what the intent of the legislature
- 16. had been. And Chapman and Cutler advised that we make the
- 17. clarifying language in the Statutes. Again, in an attempt
- 18. to answer Senator Berning, it is my understanding that they
- 19. enter into these leases and annually appropriate rents as
- 20. does any department of State government.
- 21. PRESIDENT:
- 22. Senator Soper.
- 23. SENATOR SOPER:
- 24. Well, in other words, the junior college...this junior
- 25. college could lease this building and...and use its bonding
- 26. power to pay...to pay for the...pay for the rental, huh?
- 27. Is that it?
- 28. PRESIDENT:
- 29. Senator Carroll.
- 30. SENATOR CARROLL:
- 31. I understood it to be that they were leasing the building
- 32. through annual appropriation rather than having to buy a building
- 33. and at the Public Building Authority is the one who actually

- has the bond issue to construct the building. That's my understanding.
- 2. Senator.
- 3. PRESIDENT:
- Senator Glass.
- 5. SENATOR GLASS:
- Senator Carroll, I noticed this...this amendment came
- by way of really changing the purpose of a bill that dealt
- originally with the eligibility of board members for community
- 9. college districts. So, it is apparently a last minute effort
- 10. to get something in that, and I take...accept your statement
- 11. that it's as a result of Chapman and Cutler's opinion as bond
- 12. council, but I'm wondering, it appears also that this would...
- 13. would enable the community colleges to bypass the Capital
- 14. Development Board. And I wonder if that's a good policy
- 15. and...and if you're aware of that. Other words, in doing this
- 16. they would be able to work...they would be able to contract
- 17. directly with the Public Building Commission and it seems to me
- 18. otherwise for new buildings, they would have to go through
- 19. CDB.
- 20. PRESIDENT:
- 21. Senator Carroll.
- 22. SENATOR CARROLL:
- 23. Again, Senator Glass, this is a lease, rather than
- 24. construction which CDB would be involved in and again, I am
- 25. led to believe that this is an existing authority without the
- 26. appropriate language requested by bond council, not a new
- 27. concept we are adding.
- 28. PRESIDENT:
- 29. Senator Glass.
- 30. SENATOR GLASS:
- 31. Well, I...perhaps you're right. I...I 'm sorry this didn't
- 32. get a committee hearing because the notes we have indicate
- 33. that the city colleges of Chicago want the Public Building Commission

- to build them buildings and lease...lease those buildings to
- them and it just seems to me this is something novel and...and
- 3. a little bit of an evasion of the CDB purpose. I... I would
- 4. just like to know more about the reason behind it.
- 5. PRESIDENT:
- 6. Any further discussion? Senator Carroll may close
- 7. the debate.
- 8. SENATOR CARROLL:
- 9. Thank you, Mr. President. I don't know that there
- 10. is a problem with it. This is supposed to be an existing authority
- 11. that they have had and bond council for the bonding had indicated
- 12. that it needed corrective language. There is a problem with
- 13. it, you know, we can give you a chance to check it out.
- 14. If that's what you're asking, if not, I would ask for a favorable
- 15. roll call.
- 16. PRESIDENT:
- 17. Question is, shall House Bill 3099 pass? Those in
- 18. favor will vote Aye. Opposed Nay. The voting is open. Have
- 19. all voted who wish? Take the record. A request for postponed
- 20. consideration. Put the bill on postponed consideration.
- 21. House Bill 3197, Senator Shapiro. We skipped over 3124. That's
- 22. on by mistake. That bill was re-referred yesterday. House
- 23. Bill 3202, Senator Hynes. House Bill 3208. Read the bill.
- 24. SECRETARY:
- 25. House Bill 3208.
- 26. (Secretary reads title of bill)
- 27. 3rd reading of the bill.
  - 28. PRESIDENT:
  - 29. Senator Rock.
  - 30. SENATOR ROCK:
  - 31. Thank you, Mr. President, Ladies and Gentlemen of the Senate.
  - 32. You will recall that last Session, we did provide for bonding
  - 33. authority for the purpose of building specialized living centers.

- 1. We are back this year with House Bill 3208 to allow that
- same bondability with respect to the durable equipment that is
- 3. necessary to be placed within these centers. I know of no
- 4. objection to the bill. It...it merely allows them to bond
- 5. this kind of equipment the same as they are bonding the
- 6. actual building into which the equipment will be placed.
- 7. PRESIDENT:
- 8. Any further discussion? Senator Nimrod.
- 9. SENATOR NIMROD:
- Yes, Mr. President. A question...Senator Rock.
- 11. Senator Rock, on this durable equipment, is it defined to
- 12. be any kind of life to the equipment or is it...is it the
- 13. expendable type or doesit have a ten year life or twenty
- 14. year life or...most of these buildings and bondings always
- 15. been twenty-five year life on it. I've no objection to the
- 16. equipment but I'm just wondering if there's some definition
- 17. there which will at least define it so it doesn't end up
- 18. being items that disappear in one or two years.
- 19. PRESIDENT:
- 20. Senator Rock.
- 21. SENATOR ROCK:
- 22. Yes, thank you, Mr. President. Senator, if you'll look
- 23. at Section 2.06 of the bill, it attempts at least, to define
- 24. durable, moveable equipment as all items of initial equipment
- 25. other than built-in equipment which are necessary and appropriate
- 26. for the functioning of this or a particular facility. Such
- 27. equipment shall have by this statutory definition an extended
- 28. useful life, not to be consumed in use and have an identity
- 29. and function which will not be lost through an incorporation
- 30. into a more complex unit.
- 31. PRESIDENT:
- 32. Any further discussion? The question is, shall House Bill
- 33. 3208 pass? Those in favor will vote Aye. Opposed Nay. The voting

- 1. is open. Have all voted who wish? Have all voted who wish?
- 2. Take the record. On this question the Ayes are 39, the Nays
- 3. are 10 with 2 Voting Present. House Bill 3208, having
- 4. received a constitutional majority is declared passed. House
- 5. Bill 3222, Senator Rock. House...oh, Senator Rock is recognized.
- 6. SENATOR ROCK:
- 7. Thank you, Mr. President, Ladies and Gentlemen of the Senate.
- 8. I would just call the membership's attention to House Bill 3222.
- 9. It has to do with requiring the department to improve their
- 10. contractural agreements with the voluntary private sector
- 11. providing child welfare services. I am sure that most of the
- 12. membership will, over the weekend, be hearing from their
- 13. care associations in their respective districts. I wish to
- 14. let the membership know that I intend to call this bill for
- 15. passage on Monday, but I would ask that everybody take a look
- 16. at it and get some feedback from your districts.
- 17. PRESIDENT:
- 18. House Bill 3318, Senator Daley. For what purpose
- 19. does Senator Bloom arise?
- 20. SENATOR BLOOM:
- 21. Thank you, Mr. President. I don't have 3222 in my
- 22. bill book.
- 23. PRESIDENT:
- 24. 3222? Sergeant-at-Arms, would you see that the gentleman
- 25. has a copy of House Bill 3222? 3222. 3318. I thought yesterday
- 26. we removed Senator Daley and put Senator Lemke on, but it
- 27. still...the printer didn't do it. 3318, Senator Lemke.
- 28. Senator Lemke. Senator Lemke. 3318.
- 29. SENATOR LEMKE:
- 30. Harber Hall came over. He had something...he wanted
- 31. me to bring it back to 2nd for amendment. I don't know...has
- 32. any amendments been filed?
- 33. PRESIDENT:

- 18. SECRETARY:
- 19. Amendment No....
- 20. SENATOR HARBER HALL:
- 21. On page one.
- 22. SECRETARY:
- 23. Amend amendment to House Bill 3318 on page one by deleting
- 24. lines thirty and thirty-one and inserting in lieu thereof, the
- 25. following.
- 26. SENATOR HARBER HALL:
- 27. Yes, Mr. President and Ladies and Gentlemen of the Senate.
- 28. This minimum wage...
- 29. PRESIDENT:
- 30. Are there any copies? Some members have asked for copies.
- 31. Are there any copies available?
- 32. SENATOR HARBER HALL:
- 33. No, I believe Senator Lemke probably has the only one. I'd

- 1. be glad to get some printed up, distributed. They're relatively...
- 2. PRESIDENT:
- 3. Explain it while it's being distributed.
- 4. SENATOR HARBER HALL:
- 5. I appreciate Senator Lemke's giving me the opportunity to...
- 6. to address these proposed amendments. I wonder if we could
- 7. go on to the next order of business and come back to this
- 8. while I have copies made for the members.
- 9. PRESIDENT:
- Senator Lemke.
- 11. SENATOR LEMKE:
- 12. Whatever he wants to do. Just so we come back to it.

  - 32. Mr. President and members of the Senate. House Bill 3787
  - 33. does exactly what it says on the Calendar there. The funding

- 5. I...I think Senator Philip had an amendment to this particular
- 6. bill.
- 7. PRESIDENT:
- Senator Philip.
- 9. SECRETARY:
- 10. Amendment No. 2 offered by Senator Philip.
- 11. SENATOR PHILIP:
- 12. Thank you, Mr. President and Ladies and Gentlemen
- 13. of the Senate. What this amendment does is delete all the funds
- 14. for this agency. And let me briefly explain what this agency
- 15. allegedly is supposed to do. This agency has been in effect
- 16. since 1973, questioning the Director of that agency, says
- 17. they do not have a plan nor have they picked up a abandoned
- 18. automobile and what they are supposed to do and what their
- 19. responsibility is they are supposed to pick up abandoned cars
- 20. on the highways and have them recycled. Well, they have been
- 21. in operation since 1973. Number one, they do not have a plan,

- 28. is needless, useless, as I say, they haven't picked up a car,
- 29. ever picked up a car and they've been in operation since 1973,
- 30. there are like six employees and I just think it's a waste of
- 31. taxpayers money and time and I would move the adoption of Amendment
- 32. No. 1.
- 33. PRESIDENT:

- 1. Senator Bruce.
- 2. SENATOR BRUCE:
- Yes, I resist the amendment. We're talking about a total
- 4. of two employees. They are presently involved during this
- 5. coming fiscal year making programs and implementing the...the
- 6. requirements for vehicle recycling. They have...the board which is
- 7. involved in this has five members, Secretary of State, Secretary of
- 8. Transportation, Department...Director of the Department of Law
- 9. Enforcement, Superintendent of State Police and others. They have
- 10. been involved for some time trying to develop rules and regulations
- 11. for handling abandoned automobiles in Illinois. They have indicated
- 12. to me that next year is the year that they will finally come
- 13. forth with the rules and regulations. They asked for one hundred
- 14. and twenty-five thousand dollars. That has been cut by more than
- 15. half to fifty-seven thousand three hundred and thirteen dollars.
- 16. I think that we have...they have sufficient warning that if things
- 17. don't occur next year, we're going to take a, even deeper cut. They've
- 18. come from a hundred and twenty-five thousand down to fifty-
- 19. seven thousand. I think that's warning enough to them that
- 20. it's time to get the rules and regulations drafted.
- 21. PRESIDENT:
- 22. Any further discussion? Senator Roe.
- 23. SENATOR ROE:
- 24. Will the sponsor yield?
- 25. PRESIDENT:
- 26. He indicates he'll yield.
- 27. SENATOR ROE:
- 28. Senator Philip, is this the Flat Car Act?
- 29. PRESIDENT:
- 30. Senator Philip.
- 31. SENATOR PHILIP:
- 32. It certainly is.
- 33. PRESIDENT:

- Any further discussion? Oh, Senator Roe.
- 2. SENATOR ROE:
- 3. Does it have anything to do with the Flat Dog Act?
- 4. PRESIDENT:
- Senator Philip.
- SENATOR PHILIP:
- 7. If it does, I'm completely unaware of it.
- 8. PRESIDENT:
- 9. Senator Roe.
- 10. SENATOR ROE:
- 11. That's fortunate because the Flat Dog Act was a bad Act.
- 12. PRESIDENT:
- 13. Any...Senator Bruce.
- 14. SENATOR BRUCE:
- 15. Yes, I would just point out that they have the administrative
- 16. control over the purchase of these automobiles which the fund
- 17. now that they have is six million eight hundred and fifteen
- 18. thousand dollars for purchasing and disposing of recycled
- 19. vehicles. If we do not fund them, the six million eight
- 20. could not be spent as far as I...the way I read the Statute,
- 21. they are designated as the group to authorize expenditures and
- 22. so if...if someone did develop a recycling program next year,
- 23. the money would be locked up.

- 25. Senator Regner.
- 26. SENATOR REGNER:
- 27. Sponsor yield to a question?
- 28. PRESIDENT:
- 29. He indicates he'll yield.
- 30. SENATOR REGNER:
- 31. Senator Philip, doesn't the Secretary of State's Office
- 32. already have this authority as far as the recycling and abandoned
- 33. vehicles?

- 1. PRESIDENT:
- Senator Philip.
- 3. SENATOR PHILIP:
- 4. I believe that is correct. I would say this that the
- 5. State Police, the City Police and the County Sheriff have the
- 6. authority now to pick up abandoned cars and they do it in
- 7. my county now. In my judgement most counties can pass a resolution
- 8. in regard to this and do it on the county level. And I just
- 9. don't see any need for a State-wide agency to pick up abandoned
- 10. cars.

- 12. Any...Senator Regner.
- 13. SENATOR REGNER:
- 14. Well, I'm in total agreement with Senator Philip
- 15. and just as an added note, when the Director of this agency
- 16. was before the Appropriations Committee, he was questioned

- 31. Senator Kenneth Hall.
- 32. SENATOR KENNETH HALL:
- 33. Thank you, Mr. President and members of the Senate.
- 34. House Bill 3821 is the annual appropriation for the ordinary and

- 1. contingent expenses of the Human Relation Commission and the
- 2. Industrial Commission. Now, there was an amendment just put on
- 3. by Senator Lemke which was the result of the staffs on both
- 4. sides and in conjunction with the Industrial Commission and it's

- 17. (Secretary reads title of bill)
- 18. 3rd reading of the bill.
- 19. PRESIDENT:
- 20. Senator Rock.
- 21. SENATOR ROCK:
- 22. Thank you, Mr. President, Ladies and Gentlemen of the
- 23. Senate. House Bill 3825 is incorrectly described on the Calendar.
- 24. It says, increases by fifteen the number of associate judges
- 25. authorized for the first Judical Circuit which is the county
- 26. of Cook, of course. House Bill 3825 creates no new positions.
- 27. It is a correction in the Statutory formula to correct an error when
- 28. we failed to do that last year when we authorized thirty new circuit
- 29. judges. Without this bill, if you read the two Statutory Acts
- 30. together, we could, in fact, lose fifteen associate judges

- 11. Senator Newhouse.
- 12. SENATOR NEWHOUSE:
- 13. Thank you, Mr. President and members. If I could have
- 14. your attention for a moment. This bill does do some things.
- 15. I want you to know exactly what it does. This bill was asked
- 16. for by some constitutents who were in this position. They are
- 17. constituents who paid medical expenses and were reimbursed for those
- 18. medical expenses from their third party payer in the subsequent
- 19. year. By some freak of Illinois law, they were taxed on the
- reimbursement of those payments. In other words, they had spent
- 21. money, gotten those monies back and were taxed on the monies
- 22. that they got back. It was not income. Now, this bill is intended
- 23. to cure that situation. There was a good deal of discussion
- 24. of this bill in committee and it not only excludes that specific
- 25. item, but there are several other items that are excluded by
- 26. virtue of this bill, let me read you what they are. They
- 27. are alimony pay, they are charitable contributions, they are
- 28. taxes paid, they are interest paid, they are non-business casualty
- 29. losses, medical expenses, investors expenses, child care expenses,
- 30. and union dues. It is my understanding that the Department
- 31. says that they will lose about a million dollars if this bill
- 32. passes. The Department did not show up in committee to discuss
- 33. this bill at all. If there are a million dollars involved, there

- 1. are a million dollars that do not belong to the government but rather
- 2. belong to taxpayers. And I would suggest to this Body
- 3. that we do not want to be in a position of suckering taxpayers
- 4. or of suffering unwarranted windfalls to the government.
- 5. I'm sure that we want all legitimate taxes to be paid, I'm
- 6. sure on the other hand that this Body does not want to have
- 7. in the coffers of the State of Illinois, taxes that do not
- 8. belong to the State by virtue of any legitimate claim. I would
- 9. solicit a favorable roll call on this bill and be happy to
- 10. answer any questions.
- 11. PRESIDENT:

- 12. Senator Bruce.
- 13. SENATOR BRUCE:
- 14. Well, this bill was heard the last day that the Committee
- 15. on Revenue met. It, perhaps, is not fair to say that the Department
- 16. of Revenue did not testify. They were present. The bill was
- 17. called one time and did not get out of committee, then was
- 18.
- hastily called without further testimony and then moved out 19.
- of the committee. I think the Committee on Revenue would 20.
- have allowed testimony but it was late in the day. The Session
- had already begun. The bill came out. I would allert the 22.
- membership to this particular piece of legislation. I would 23.
- call it the Income Tax Reform Act of 1976. It does make
- 24. substantial changes in deductions allowed to Illinois taxpayers.
- 25. The figure has been used that one million dollar loss would
- 26. occur. That one million dollar loss is related only to the
- 27. possible deduction of medical expenses, it does not relate to the
- 28. other matters, taxes paid, and non-business casualty losses.
- 29. No one has yet given us a figure to what those additional losses.
- 30. The bill originated because a young lady had problems with deducting
- 31. or having to include medical reimbursement in a...in a...in taxing
- 32. year one she claimed a deduction for medical expenses.
- 33. year number two she received a reimbursement. Under the Illinois

- 10-40 Form, she was not able to treat that reimbursement
- other than as income, for which she's paid two and a half
- 3. percent. The problem, she says, is we don't allow that deduction.
- 4. There are ways of handling that under the Federal system,
- 5. either by filing a Form 2106 or your Schedules A,B, or C.
- 6. Her complaint is that that is a procedure known only to
- 7. sophisticated taxpayers. I would say that that is not our
- 8. problem. The income tax laws are complex and those who wish
- to receive their deductions are going to have to know
- 10. how to use the system. And I...I...I think this bill has
- 11. merit. But, I think it ought to be re-referred to the Committee,
- 12. we ought to take a very serious look, have the department
- 13. testify. I have no idea what casualty...non-business casualty
- 14. losses would mean to the State of Illinois. But, I can tell
- 15. you that we have a tremendous amount of non-casualty...non-
- 16. business casualty losses, home fires, where you're reimbursed.
- 17. Those are deductible and the reimbursement for those after
- 18. a hundred dollar limitation is removed are deductible on...on
- 19. your Form 10-40's. But, you...you get into some real problems
- 20. in Illinois if you're going to allow that to be deducted on
- 21. our forms. There's going to be a tremendous loss, I think,
- 22. on your non-business casualty. In addition, I don't know what
- 23. the impact is of additional taxes paid after the close of books
- 24. on a given taxing year. Again, we had no testimony indicating
- 25. the Department's testimony in written form was that we would lose
- 26. one million dollars on medical expenses alone. The point
- 27. is that you do not need to lose your deduction for medical
- 28. expenses...
- 29. PRESIDENT:
- 30. Time has expired, Senator.
- 31. SENATOR BRUCE:
- 32. ...if...if you file the proper forms. And this opens
- 33. up the Illinois Income Tax to some very serious assaults.

- 1. PRESIDENT:
- Senator Bell. Senator Glass.
- SENATOR GLASS:
- No, I...I would just echo the sentiments of Senator
- 5. Bruce. I think Section 1-11 of the Internal Revenue Code
- to which this section applies as has been pointed out by the
- 7. sponsor, also, is much broader and includes many more deductions
- than the problem of the individual taxpayer he mentioned and I
- 9. certainly think for that reason, that we ought not to pass the bill
- 10. PRESIDENT:
- 11. Any further discussion? Senator Nimrod.
- 12. SENATOR NIMROD:
- 13. Yeah, I've...Mr. President, I've spoken with Senator
- 14. Newhouse on this and I've tried to find someway that I can
- 15. accept it because I see...I certainly see the problem and we did
- 16. discuss this at length in Revenue, but I don't believe that
- 17. we've had enough time to really look into the ramifications on this
- 18. and I think that there are some thirty-five to forty percent
- 19. of the people that do itemize on their income taxes and at least
- 20. those people, those thirty-five or forty who do itemize, I think
- 21. have enough knowledge and...and certainly facilities available for them
- 22. to adjust with these losses. I think it's something that we should
- 23. address ourselves to, but I'd hate to be one whose going to
- 24. be saying, let's take away and spoil our...our present income
- 25. tax report form allowing for deductions. I know it's not a direct
- 26. deduction, but it..isn't a direct deduction. We do have a good
- 27. income tax right now. I think we can straighten out this
- 28. problem...we have a chance to look at it after we've had a chance
- 29. to study it in committee. I...I'm just very reluctant to tamper
- with our income tax as it stands today.
- 31. PRESIDENT:
- 32. Any further discussion? Senator Newhouse may close the
- 33. debate.

- SENATOR NEWHOUSE:
- Thank you, Mr. President. Contrary to popular belief
- 4. I do believe that this State does have a responsibility to the
- 5. taxpayer and they have a responsibility not to make it complicated
- 6. for people to get their money back that they're do. I think
- 7. that we do have a...a responsibility to make the forms
- 8. procedures as simple as possible. I have here in my hand a letter
- 9. from a Walter W. Went of Crystal Lake which was written to
- 10. Representative Skinner on the other side...over at the House.
- 11. "This note is to inform you that I paid income tax amounted to
- 12. thirty-four dollars and two cents under protest. This portion of the
- 13. total tax represents a tax on thirteen hundred and sixty dollars
- 14. and sixty-four cents which was medicare reimbursement for medical
- 15. expenses." I don't believe that those who are on fixed incomes and
- 16. do not have lawyers, who do not understand the very complicated
- 17. laws of the...of the tax procedures ought to be penalized
- 18. unfairly. It seems to be a completely an unfair procedure and
- 19. we ought to square it away. If there are some problems relating
- 20. to this bill, the Department has not talked to me. I did not
- 21. know they were there at the time. They have given me no suggestions
- 22. as to how to cure this problem. This problem ought to be cured.
- 23. It ought to be cured now. I solicit your favorable support.

  - 6. 3318, could we have that on...be read?
  - 7. PRESIDENT:
  - We've had intervening business.
  - SENATOR LEMKE:
  - 10. ...voted on?
  - 11. PRESIDENT:
  - 12. We can indeed. On the order of 3rd reading, on your
  - 13. Calendar, page three. House Bill 3318. Read the bill.
  - 14. SECRETARY:
  - 15. House Bill 3318.
  - 16. (Secretary reads title of bill)
  - .17. 3rd reading of the bill.
  - 18. PRESIDENT:
  - Senator Lemke.
  - 20. SENATOR LEMKE:
  - 21. I ask for a favorable vote on this bill.
  - 22. PRESIDENT:
  - 23. The question is, shall House Bill...post...post the
  - 24. number. Post the number, Mr. Secretary. Senator Smith.
  - 25. SENATOR SMITH:
  - 26. I merely want to say that I've remained here until
  - 27. the very last minute to yet have an opportunity to get started
  - 28. toward the airport to meet my wife, who is returning. I'm grateful
  - 29. for the fact that during the discussion with reference to this
  - 30. bill, that the bill was not trampled upon too much. I take it that
  - 31. members here, your memory is as retentive as is mine. So happened
  - 32. that Illinois was the last industrial state, large
  - 33. industrial state to enact the Minimum Wage Act. At the time that

- ı. I brought this bill before the Body, all sorts of arguments
- 2. made, the time was not right, you'd close down the businesses,
- 3. they have moved from the State, none of which has happened.
- 4. Saying that conditions as such, I may not be here much longer,
- 5. in fact, I know I won't be, but I want to thank members on
- 6. that side of the aisle for the fact that you didn't decimate
- 7. this bill overly much and as I stand here, I recall when I
- 8. caused this bill to be enacted into law and I want to thank
- 9.
- two men, one of whom I don't see, the Minority Leader, Senator
- 10. Harris, and you, my friend, Senator Knuppel. You sat over
- 11. there at that time. You aided me much. We had twenty-six
- 12. votes only, and it seemed that even though the very clouds and
- 13. the condition...atmospheric conditions were against us. But,
- 14. you, Sir, and Senator Harris came to my rescue and Illinois became
- 15. the last large industrial State to enact the Minimum Wage Law.

- 20. The question is, shall House Bill 3318 pass? Those
  - in favor will vote Aye. Opposed will vote Nay. The voting is
- Have all voted who wish? Take the record. On that question
- 23. the Ayes are 45, the Nays are none with 10 Voting Present.
- 24. House Bill 3318 having received a constitutional majority is
- 25. declared passed. For what purpose does Senator Demuzio
- 26. arise?
- 27. SENATOR DEMUZIO:
- 28. You want to go to House Bill 3403, the conservation appropriation.
- 29. There's a couple of amendments that, I think Senator Fawell
- 30. and Senator Johns would like to offer, so like to have leave of the
- 31.
- Body to go to that order of business.
- 32. PRESIDENT:
- 33. Is there leave? Leave is granted. House Bills on 3rd reading,
- page three of your Calendar, House Bill 3403. Leave has been granted 34.

- 1. to move the bill back to 2nd reading for the purpose of an
- 2. amendment. Please. Now, I wish you would...Gentlemen and Ladies,
- 3. there is a...an announcement that should be made with reference
- 4. to this bill that I want you all to know about. Mr. Secretary.
- 5. SECRETARY:
- In the House of Representatives, Enrolling and Engrossing,
- 7. they adopted two amendments, both relating to the same section
- 8. so they figured in Enrolling and Engrossing that one deleted
- 9. the other which wasn't the case and they had to bring us over
- 10. a new bill. That bill has been inserted into our cover bill
- 11. here and the one amendment that was not included at the time
- 12. was a seventy-five thousand dollar appropriation.
- 13. PRESIDENT:
- 14. So, we're asking leave to substitute the corrected
- 15. bill for the one with the error. Is there leave? Leave
- 16. is granted. Now, any amendments on 3403? Could the Secretary
- 17. have the attention? 3403. ...amendments?
- 18. SECRETARY:
- 19. Amendment No. 6 offered by Senator Johns.
- 20. PRESIDENT:
- 21. Senator Johns.
- 22. SENATOR JOHNS:
- 23. Mr. President and colleagues. The amendment basically
- 24. asks for thirteen thousand dollars or so much thereof as may be
- 25. necessary to be appropriate to the Department of Conservation
- 26. for the maintenance and operation of the Cairo Custom House
- 27. in Cairo, Illinois. Now, if I may have your attention, Gentlemen.
- 28. PRESIDENT:
- 29. Just a moment. Just a moment. Now, let me first dispel
- 30. a rumor and the rumor is that we're going to break for lunch. We
- 31. are not going to break for lunch and if we can just keep moving
- 32. along, you can get home a great deal earlier. Now, we're on
- 33. Amendment No. 6, Senator Johns has the Floor.

- 1. SENATOR JOHNS:
- What I'm trying to do here is preserve the Cairo Custom
- 3. House. It's a architecturally significant and has been so
- 4. designated by the National Trust for the Historic Preservation
- 5. and is listed on the National Register of Historic Places.
- 6. Gentlemen, it's a very, very beautiful building. We're trying
- 7. to preserve it. It is the last one in the United States.
- 8. It's connected...constructed in about 1868 to 1871. We're
- 9. trying to utilize thirteen thousand dollars for this preservation.
- 10. I would appreciate a favorable roll call on this amendment.
- 11. PRESIDENT:
- 12. Senator Weaver.
- 13. SENATOR WEAVER:
- 14. Thank you, Mr. President. Senator Johns, does Department
- .15. of Conservation of the State of Illinois own this building?
- 16. PRESIDENT:
- 17. Senator Johns.
- 18. SENATOR JOHNS:
- 19. I don't believe that they do. No, Sir.
- 20. PRESIDENT:
- 21. Senator Weaver.
- 22. SENATOR WEAVER:
- 23. Well, I'm sure that the Department of Conservation
- 24. has plenty of projects that they own and facilities they own that
- 25. they need to put money in. We cut about 8.8 million out of this
- 26. budget and this was one of the projects we cut. And I don't
- 27. see any sense of restoring this thirteen thousand dollars to
- 28. repair something that the State of Illinois doesn't own.
- 29. PRESIDENT:
- Senator Johns.
- 31. SENATOR JOHNS:
- 32. I personally disagree. I think it's a bargain for the
- 33. people of Illinois. Thirteen thousand dollars to me is a minimum of what

- we should be asking for the preservation of a beautifully
- designed building that is a treasure that we'll...we'll
- miss for years if we let it deteriorate and I ask my colleagues
- for a favorable roll call on this amendment.
- 5. PRESIDENT:
- Senator Soper.
- 7. SENATOR SOPER:
- 8. Well, Mr. President, you know, we've got this budget
- 9. and we've done a lot of things for...for Senator Johns. We
- 10. give him fifteen cents on the coal and...and two cents or
- 11. one cent that they had, we've taken all the profit out of selling
- 12. coal in our territory to all our...to all our utilities. We've
- 13. taken the tax from Cook County and the City of Chicago and we
- 14. let it stay down this County. If they can't raise thirteen
- 15. thousand dollars down there with all the money that they've got
- 16. now, you know, if it's such a wonderful place, I'll bet
- 17. if they hold a picnic or a tea or have one of those socials
- 18. that you had, bring a...bring a plate or bring a dish, I think
- 19. they could raise that money and we keep on with these things
- 20. so...we just don't have the money. It's thirteen thousand here,
- 21. a hundred thousand here, two hundred thousand there, five million
- 22. here, three million there, where you going to get this? I don't
- 23. mind doing things for...for the Senators from other districts
- 24. but, you...you come to this well too often, you know. You
- 25. got your...you've got your hand in that...in that bucket all the
- 26. time and I can't even get near it to spit in it to find
- 27. out what's in it.
- 28. PRESIDENT:
- Senator Rock.
- 30. SENATOR ROCK:
- Thank you, Mr. President, Ladies and Gentlemen of the Senate.
- 32. I think in explanation and I am rising in opposition to Amendment
- 33. No. 6. By virtue of Amendment No. 3 which I offered in the committee,

- 1. this thirteen thousand dollar request was, in fact,
  - deleted and it was deleted at the request or because the
  - Department opposed it on the grounds as stated by Senator
  - 4. Weaver that the Department nor the State does not own the
  - Custom House and there is a real question about the legality
  - 6. of spending money for the...for this purpose on land...on land
  - 7. and a building not owned by the State. For that reason, I would
  - 8. oppose it.
  - 9. PRESIDENT:
- 10. Any further discussion? Senator Johns may close the debate.
- 11. The question is on the adoption of Amendment No. 6. Those in
- 12. favor will say Aye. Opposed Nay. In the opinion of the Chair,
- 13. the Nays have it. Amendment No. 6 fails. Any further amendments?
- 14. SECRETARY:
- 15. Amendment No. 7 offered by Senator Fawell.
- 16. PRESIDENT:
- 17. Senator Fawell.
- 18. SENATOR FAWELL:
- 19. Actually, Mr. President, I believe that this is the amendment
- 20. that was put on in the House. This is for the Prairie Path,
- 21. seventy-five thousand dollars, so I think there's no need then
- 22. for this amendment. Is that correct, Mr. Secretary?
- 23. SECRETARY:
- 24. Yes, this would be the amendment that they had replaced
- 25. in Enrolling and Engrossing, so...
- 26. SENATOR FAWELL:
- 27. So, that is now on the bill?
- 28. SECRETARY:
- 29. That's right.
- 30. SENATOR FAWELL:
- 31. Right. I would then withdraw this Amendment No. 7.
- 32. PRESIDENT:
- 33. Senator Demuzio, did you have a statement that you wanted to

- make concerning on a ...further amendment?
- 2. SENATOR DEMUZIO:
- Yes, Senator Harris has spoken to me and I think
- 4. he's spoken to you, Mr. President, about this problem with the
- 5. Enrolling and...problem that we have and I think it's the judgement of
- 6. all those concerned that there be another amendment drafted to
- 7. be clear that this bill clearly passes in the proper form
- 8. so I will take it back to 3rd and hold it there and later on
- 9. this afternoon, when the amendment is drafted, we'll bring it
- 10. back and correct it.
- 11. PRESIDENT:
- 12. The bill will now go to 3rd with the understanding that
- 13. it will be brought back to 2nd reading for the purpose of
- 14. an amendment that will absolutely clarify the error made in the
- 15. House so that the bill will not in any way be jeopardized by
- 16. any procedural activity. The bill goes back to 3rd reading.
- 17. On the order of Concurrences on the Secretary's Desk, page
- 18. six of your Calendar, Senate Bill 1498, Senator Hynes. Senate
- 19. Bill 1500, Senator Lane. Senate Bill 1600, Senator Hickey.
- 20. ... Senator Netsch's bill. I'm sorry. Senator Netsch on Senate
- 21. Bill 1600. It's House Amendment No, 1, isn't it, Senator Netsch?
- 22. SENATOR NETSCH:
- 23. Yes, it is, Mr. President.
- 24. PRESIDENT:
- 25. You are recognized.
- 26. SENATOR NETSCH:
- 27. I would move that the Senate concur with House Amendment
- 28. No. 1 to Senate Bill 1600 and this would constitute final
- 29. action on this bill which is the annual appropriation for all
- 30. of the environmental agencies. House Amendment No. 1...I beg
- 31. your pardon. I beg your pardon. Let me start over again.
- 32. I still move that the Senate concur with House Amendment No. 1
- 33. to Senate Bill 1600 which is the annual appropriation for the

- 1. Department of Revenue. The House Amendment No. 1 is in effect
- a fifty percent amendment on the instant lottery. It would
- 3. allow the instant lottery, for which there are two provided in the
- 4. bill, to occur only one in the first half of the annual...

- 10. Any further discussion? The question is, shall the Senate
- 11. concur in House Amendment No. 1 to Senate Bill 1600? Those
- 12. in favor vote Aye. Opposed Nay. The voting is open. This is
- 13. final action. Have all voted who wish? Take the record.
- 14. One moment, Senator. On this question the Ayes are 46, the
- 15. Nays are 3 with none Voting Present. The Senate does concur
- 16. in House Amendment No. 1 to Senate Bill 1600 and the bill
- 17. having received the required constitutional majority is
- 18. declared passed. For what purpose does Senator Bell arise?
- 19. SENATOR BELL:
- Mr. President, I imadvertently pushed the wrong button,
- 21. I intended to vote No on Senate Bill 1600.
- 22. PRESIDENT:
- 23. Let the record show your intention. Senate Bill 1603,
- 24. Senator Bruce. Senate Bill 1637, Senator Hynes.
- 25. SENATOR HYNES:
- 26. Mr. President, the House added one amendment to this
- 27. bill which added sixty-five thousand dollars to finance the
- 28. Legislative Intern Program, which I think the membership is
- 29. familiar with and I would move that the Senate concur in the House
- Amendment.
- 31. PRESIDENT:
- 32. Any further discussion? The question is, shall the...
- Senator Savickas.

- 1. SENATOR SAVICKAS:
- Well, yes, Mr. President and members of the Senate.
- 3. This is the same program that last year we took out. Now, they're
- 4. coming in through the back door again trying to put it back in.
- 5. I just would like to appraise the membership that last year we
- 6. saw fit to remove this program.
- 7. PRESIDENT:
- 8. Any further discussion? The question is shall the
- 9. Senate concur in House Amendment No. 5 to Senate Bill 1637?
- 10. Those in favor will vote Aye. Opposed will vote Nay. The
- 11. voting is open. Have all voted who wish? Take the record.
- 12. On that question the Ayes are 29, the Nays are 23. The Senate
- 13. does not concur in Amendment No. 5 to Senate Bill 1637 and the
- 14. Secretary will so inform the House. Senate Bill 1650, Senator
- 15. Bruce. We're getting close. All right. Senate Bill 1684.
- 16. Senator Brady. Senate Bill 7...no, 1935, Senator Hynes.
- 17. Senator Hynes.
- 18. SENATOR HYNES:
- 19. Excuse me. 1935, I would move that the Senate not
- 20. concur in House Amendments 1, 3, 4, 5, 10, 11, 12, and 16.
- 21. PRESIDENT:
- 22. Any discussion? Senator Hynes moves that the Senate
- 23. nonconcur in House Amendments numbered 1, 3, 4, 5, 10, 11, 12
- 24. and 16. All those in favor say Aye. Opposed Nay. The Ayes have
- 25. it. The motion carries and the Secretary shall so inform the
- 26. House. Senator Brady. Yes. Leave is granted to go back to
- 27. Senate Bill 1684. Senator Brady.
- 28. SENATOR BRADY:
- 29. I...Mr. President, I move that the Senate concur in House
- 30. Amendments No. 1 and 4 to Senate Bill 1684.
- 31. PRESIDENT:
- 32. ...further discussion? Senator Brady moves concurrence
- 33. with House Amendments numbered 1 and 4 to Senate Bill 1684.

- 1. All in favor will vote Aye. Opposed will vote Nay. The
- 2. voting is open. Have all voted who wish? Take the record.
- On this question the Ayes are 48, the Nays are 1 with 4
- 4. Voting Present. The Senate does concur in House Amendments
- 5. numbered 1 and 4 to Senate Bill 1684 and the bill having received
- the required constitutional majority, is declared passed.
- 7. Senator Rock, did you indicate you had some bills on 3rd you
- 8. wanted to come back to?
- 9. SENATOR ROCK:
- 10. Well, I...I have been informed that, as I said, 3222
- 11. I will call on Monday and I've been informed that 3652 and 53
- 12. also are not yet back from the printers. So, in deference

- 14. PRESIDENT:
- 15. Senator Mitchler.
- 16. SENATOR MITCHLER:
- 17. Mr. President and members of the Senate, I...like to
- 18. acknowledge on the Floor of the Senate, one of our colleagues
- 19. from the other rotunda, Representative Dave Jones who has had
- 20. yery serious surgery in the hempital and it a rice to have him
- very serious surgery in the hospital and it's nice to have him

  21. back Hole a great legislator
- back. He's a great legislator.
- 22. PRESIDENT:
- 23. He is indeed. On the order of House Bills on 3rd reading,
- 24. page three of your Calendar, House Bill 3629, Senator Sommer.
- 25. Read the bill. ...me. Is there leave to bring 3629 back to the
- 26. order of 2nd reading for the purpose of an amendment? Leave
- 27. is granted. House Bill 3629 is now on the order of 2nd reading.
- 28. Senator Sommer is recognized.
- 29. SENATOR SOMMER:
- 30. Mr. President and members...
- 31. SECRETARY:
- Amendment No....Amendment No. 1 offered by Senator Sommer.
- 33. SENATOR SOMMER:

1. Mr. President and members, the amendment does the following, 2. it requires that this land be used for park recreational or . 3. related purposes where the land comes back to the State of 4. Illinois. Secondarily, it deletes the hold-harmless clause 5. that's in the bill that I don't think is necessary and, in fact, 6. the Park Board will not accept this land with that in there and 7. that's all it does. 8. PRESIDENT: 9. Senator Knuppel. 10. SENATOR KNUPPEL: 11. Well, I... I don't quite understand that. I've talked 12. to our staff with respect to taking out the save harmless. - 19. PRESIDENT:
- 20. Senator Knuppel.
- 21. SENATOR KNUPPEL:
- Well, based on the message that I have from staff, I'd
- 23. like for...and Senator Sommer's and I have always gotten along
- 24. well. I see no reason that we can't talk about this, but this
- 25. is the first time that...that I thought the Park Board had
- 26. voted by a two to one margin that they would accept the property
- 27. of a lot of misgivings about the State buying property and giving

- 33. not in real good shape right now. So...no, it's not. So,...okay

- 1. the bill...started at three hundred and ninety-five million and
- we have cut 11.5 million and added Federal funds of two to
- three million so any questions that I can answer, I'll be
- 4. glad to try.
- 5. PRESIDENT:
- He's indicated it's going into a Conference Committee.
- 7. Is there any further discussion? The question is, shall
- House Bill 3377 pass? Those in favor will vote Aye.
- 9. Opposed will vote Nay. The voting is open. Have all voted
- 10. who wish? Take the record. On that question, the Ayes
- 11. are 50, the Nays are 3 with no one...none Voting Present.
- 12. House Bill 3377 having received a constitutional majority,
- 13. is declared passed. Senator Berning.
- 14. SENATOR BERNING:
- 15. Thank you, Mr. President. Inasmuch as our normal
- 16. procedure is to accept or reject Conference Committee Reports
- 17. without our being able to express our feelings, interpretations,
- 18. and reactions to a given item, my question is this, in this
- 19. particular instance, will we have the opportunity to explore
- 20. a little more in depth than a perfunctory yes or no?
- 21. PRESIDENT:
- 22. I maybe don't understand your question, Senator, but
- 23. Conference Committee Reports are fully debatable.
- 24. SENATOR BERNING:
- 25. Thank you.
- 26. PRESIDENT:
- 27. Is there leave to go to the order of Senate Bills on
- 28. 3rd reading? Senate Bills on...leave is granted. Senate Bills
- 29. on 3rd reading. Senate Bill 1766 on page two of your Calendar.
- 30. Senator Lemke. Read the bill. Just a moment. Just a moment.
- 31. Senator Lemke. You want that bill? Okay. 1766. Read the bill.
- 32. SECRETARY:
- 33. Senate Bill 1766.

- 1. (Secretary reads title of bill)
- 2. 3rd reading of the bill.
- 3. PRESIDENT:
- 4. Senator Lemke.
- 5. SENATOR LEMKE:
- 6. This is a bill to legalize something that people
- 7. are doing now and I ask for a favorable roll call.
- 8. PRESTDENT:
- 9. Any further discussion? Senator Glass.
- 10. SENATOR GLASS:
- 11. I wonder if the Senator would describe what it is that
- 12. is being legalized, Mr. President.
- 13. PRESIDENT:

- 14. Senator Lemke.
- 15. SENATOR LEMKE:
- We're legalizing raffle and chances for civic, religious,
- charitable, social, fraternal, scouting, labor, business. 18.
- 19.

a not-for-profit corporations which are charitable in aspects.

- They use the money. They need it to...to function, to pay their
- 20. real estate taxes and also further their programs.
- 21. PRESIDENT:
- 22. Senator Glass.
- 23. SENATOR GLASS:
- 24. Well, Mr. President, Ladies and Gentlemen, I would
- 25. point out that this is another attempt to legalize another
- 26. form of gambling in the State...the State has been moving
- 27. far too much in that direction and I would strongly oppose
- 28. passage of this bill.
- 29. PRESIDENT:

- 30. Senator Mitchler.
- SENATOR MITCHLER:
- 32. Mr. President and members of the Senate. I believe
- 33. many of you have been contacted by the representatives of many

- 1. of our civic, fraternal, veterans organizations and they
- 2. have expressed to you a desire to have this legislation.
- Those persons contacting you, I do not believe, represent
- 4. the people of the State of Illinois and to what they're doing.
- 5. They're doing it with a special interest in mind. Stop
- 6. and think now of what we have in the State of Illinois and
- 7. what we would have if we turned Illinois into a Nevada.
- 8. We all know that there are raffles, there are chances, and
- this type of thing goes on today. Some areas, they say, well,
- 10. the sheriff or the mayor comes in and he shuts them down. They
- 11. stop it, they don't allow it. Well, that's the feeling of the
- 12. people in that area. Now, I don't think that we, as a General
- 13. Assembly, should legalize this type of gambling in our civic.
- 14. fraternal, and veterans organizations. To do so would be no
- 15. problem with the legitimate civic, fraternal, veterans and
- 16. other organizations who would operate these gambling and chance
- 17. and raffles. But, there are not all the goodie goodies, and
- 18. you'd be opening up the State of Illinois into an area
- 19. that would be taking money from the people that can least afford
- 20. and that's not what you want to do. Because once you legalize
- 21. this, you open the door. And I'm going to ask you even in
- 22. defiance of the solicitation that you have had from those that
- 23. say they represent these organizations, I'm going to ask you
- 24. to give a negative vote on this and Senator Lemke, it's nothing
- 25. against you as sponsor of the bill. I know you're sincere
- 26. about it, but for the people of the State, I think it's a
- 27. direction in the wrong way.
- 28. PRESIDENT:
- 29. Senator Nimrod.
- 30. SENATOR NIMROD:
- 31. Yes, Mr. President and fellow Senators, this is the
- 32. bill...was heard in the Revenue Committee and there were several
- 33. questions that were brought up that I still feel are unanswered

- 1. and I would like to take this time here just to point out 2. a few of the things I think that we ought to be aware of 3. when we start to continue voting for this bill. First 4. of all, this bill would add overhead costs which presently 5. do not exist. If...example is, if a group wanted to hold 6. a raffle once a year they would have to spend fifty dollars 7. for a license, then contribute ten percent of their gross 8. proceeds to the State. The bill adds administrative costs 9. to the Department and I think it also, if we'd look at it, 10. it prohibits minors from being involved and it restricts 11. the conducting of raffles to one location, but I think that 12. particular provision was amended. This would mean, in fact, 13. that this bill is being passed for a specific purpose. 14. eliminates the girl scouts and the boy scouts and the little 15. league from being involved in...in chances...in selling chances. 16. It formalizes and make it...makes it totally illegal for them 17. to conduct any chances and forces a crackdown by those agencies 18. to stop them from doing it. We are really putting the emphasis 19. into the wrong places in trying to attack this bill. 20. bill did not have a chance to look in all the problems that 21. it presents. It's going to cost money for the Department. 22. I asked them how much it would cost to make an inspection, 23. it cost them more money to make the inspection than it does to 24. license it, they said fifty dollars. Now, when they say it was 25. fifty dollars an inspection, you know it's got to end up to be 26. more than that. So, in fact, what we're doing is not really 27. providing any revenue for the State. We're taking away the 28. chance for the sale of this from the minors from the...from 29. the groups that we really are talking about helping and 30. we're providing this opportunity for some of the more professional 31. groups. I don't know and I'm not sure how far this goes and what

professionals getting into the whole game of chances. Certainly,

it legalizes, but I think this also introduces a means of

32.

- 1. punchboards and all these others are going to become rampant...
- 2. be available under the guise of an individual. I think we...we
- 3. do not have to rush into this law. There's no immediate
- 4. emergency and I would hope that we would reject this law at this
- 5. time and ask that this bill be sent back to committee so we
- 6. have a chance to study it and a chance to look at these kind
- 7. of ramifications. It is unwise for us to take these steps. It
- provides another means for gambling, inviting professionalism
- 9. into the whole field and on top of that, I think we are doing
- 10. a disservice to the service organizations, to are minors and certainly
- 11. we're introducing some legalizing gambling and I think we
- 12. are taking some very serious acts as far as I am personally
- 13. concerned and I think we're doing...taking some immoral actions.
- 14. PRESIDENT:
- 15. Any further discussion? Senator Lemke may close the
- 16. debate. Oh,...
- 17. SENATOR LEMKE:
- 18. I...
- 19. PRESIDENT:
- ...pardon me, I'm sorry. Just a moment. Senator
- 21. Harber Hall. I'm sorry. Senator Hall. Harber Hall.
- 22. SENATOR HARBER HALL:
- 23. I was interested in the argument that Senator Nimrod
- 24. brought up and I'd just like to make a couple of remarks
- 25. about it. He suggested that we have plenty of time here to study
- 26. raffles and chances. I would like to remind the Body that in the
- 27. case of bingo which was the first effort into gambling that
- 28. we made approximately six years ago, bingo had been introduced
- 29. so many times that the perennial sponsor of the bill was referred to
- 30. as "Bingo Bill." It finally did pass...get enough votes to pass
- 31. and since that time, we've put in the lottery, we've got parimutuel
- 32. betting at the State Fair, we've got mutual racing and I...I
- 33. just think that Senator Lemke ought to have...give us time enough

- 1. to study this and maybe in eight or ten or twenty years we
- can refer to him as "Raffles Lemke". I... I think the bill
- 3. has had some trouble and somehow it's back before us again
- 4. here. Let's give it a couple more years and...and look at it then.
- 5. PRESIDENT:
- Senator Hall, you're...just to keep the record straight,
- 7. policy passed over in the House...couple of days ago Senator
- 8. Davidson.
- 9. SENATOR DAVIDSON:
- Just to keep the record straight, there is no
- 11. parimutuel betting at the State Fairgrounds.
- 12. PRESIDENT:
- 13. Any further discussion? Senator Lemke may close
- 14. the debate.
- 15. SENATOR LEMKE:
- 16. I heard statements that those people that have contacted people
- 17. that don't speak for their organizations, it's my understanding
- 18. the VFW has adopted this in the State convention as one
- 19. of their major things, so I think those people that contacted you
- 20. from the VFW ... and I understand that the American Legion
- 21. is also adopting it, the Moose, the Elks, and most of the groups
- 22. including any fraternal organization down to the Shriners.
- 23. We're doing this to...we're doing this to a basis to raise
- 24. charitable funds and we're asking for it. Now, you heard about
- 25. a couple years, this bill has been introduced several years.
- 26. It's been introduced at the same time the first bingo bill
- 27. was introduced and those bills were introduced over twenty
- 28. years ago by Representative Fary so...and Representative Murphy
- 29. and Janczak and was brought over here by Howard Mohr in the
- 30. Senate and bingo was passed. But, the raffles bill was also
- 31. introduced and has been studied and the Department has amended
- 32. the bill to correct the administrative problems with it and I
- 33. think it's a good bill and I think it's a bill that will help

- 1. charities, it will help people and besides all the proceeds
- 2. from this bill will go into the common school fund and therefore
- 3. will help our school children. I ask for a favorable vote.
- 4. PRESIDENT:
- 5. The question is, shall Senate Bill 1766 pass? Those in
- 6. favor will vote Aye. Opposed Nay. The voting is open.
- 7. Have all voted who wish? Take the record. Postponed Consideration
- g. is requested. Place the bill on Postponed Consideration.
- g. For what purpose does Senator Philip arise?
- 10. SENATOR PHILIP:
- 11. Thank you, Mr. President. Perhaps somebody overlooked
- 12. a bill before that. If we're on that place on the Calendar.

- 11. Yes, to either call a Constitutional Convention, or

- 13. prohibit deficit spending except for emergency situations.

- 15. Senator Rock.
- 16. SENATOR ROCK:
- 1.7. Well, I...I presume that the...he certainly has the
- 18. right to introduce the resolution and have it read or whatever,
- 19. but if we're going to try...if he intends to try to move it
- 20. without reference to committee, at that point, I'm going to
- 21. interpose an objection. I am in full and complete sympathy
- 22. with the idea and I, too, have spoken with...this movement is...
- 23. is being helped along by the National Taxpayers Union and in
- 24. particular, a member of the State Senate from the State of

- Well, Senator Harber Hall has indicated he expects it
- 3. to go to Executive, is that right, Senator? Senator Harber
- 4. Hall.
- 5. SENATOR HARBER HALL:
- 6. Yes, that's very true, Mr. President. I have talked to the
- Majority Leader about this and what he has stated, he has
- privately stated to me and to some extent I agree with him.
- 9. I have no intention to moving the resolution, but I would like
- 10. to suggest that the Executive Committee sometime between now
- 11. and some later Fall Session might have a hearing on this
- 12. matter. I can tell the Body that today, at least nine states
- 13. have passed a similar resolution, almost identical resolution
- 14. that would qualify for a Constitutional Convention. Other
- 15. states have passed resolutions that do not go as far as this one,

- 15. SENATOR DOUGHERTY:
- 16. Now, may I ask to have Senator Nudelman explain this

- 19. Senator Nudelman. You've done pretty well over the years,
- 20. Senator, not being a lawyer, but go ahead. Senator Nudleman.

- 30. No, I don't think so. This is on the Calendar on page
- 31. seven, House Joint Resolution 43, offered by Representative Giglio,
- 32. relates to permitted witnesses under Federal law and before
- 33. grand juries, et cetera. Senator Rock.

- SENATOR ROCK:
- I...I'm reading from the Digest at page twelve
- hundred and sixty-six. Well, maybe...maybe that is...maybe that
- is correct. That may be the Constitutional Amendment Section.
- 5. If you look at page twelve sixty-six it shows Totten states
- 6. the General Assembly make application to the Congress to call
- a convention.
- 8. PRESIDENT:
- Well, I think twelve fifty-one is a page that divides
- 10. that resolution. Twelve fifty-one... House Joint Resolutions
- 11. and Constitutional Amendments and I think there is a separate
- 12. section for House Joint Resolutions period. Well, no.
- 13. Just a...just a moment. I think there is.
- 14. SENATOR ROCK:
- 15. Yes, you are correct. It's...it would be...it would show
- 16. on the Digest at page twelve eighty, of Volume Two.
- 17. PRESIDENT:
- 18. That's correct.
- 19. SENATOR ROCK:
- 20. All right, I apoligize for the interruption, Senator...
- 21. PRESIDENT:
- That's quite all right,...
- 23. SENATOR ROCK:
- 24. ...Nudelman.
- 25. PRESIDENT:
- 26. ...Senator, we appreciate your alertness. Senator
- 27. Nudleman.
- 28. SENATOR NUDLEMAN:

....

- 29. Thank you, Mr. President, Ladies and Gentlemen of the Senate.
- 30. House Joint Resolution 43 is simple and is contained in one line,
- 31. "Be it resolved by the House of Representatives, et cetera,
- 32. that we memorialize the Congress of the United States to amend
- 33. the Federal laws to permit witnesses to be represented by and to
- 34. consult with council in the Grand Jury Room while the witness is

- 1. giving testimony before the Grand Jury." That's the summon
- 2. substance of the resolution. As you will recall, during the
- 3. calendar year 1975, we had a goodly number of Grand Jury
- 4. bills here relating to the Statutes of the State of Illinois
- 5. and we broadened the protection given people who appear before
- 6. the Grand Jury so that now the Statute of Illinois reads as
- 7. follows: "Any person subpoenaed who is already charged with
- 8. an offense or against whom the State's Attorney is seeking a
- 9. bill of indictment, shall have the right to be accompanied
- 10. by council who shall advise him of his rights during the
- 11. proceedings but may not participate in any other way before
- 12. any testimony is given by such a person, et cetera." Now,
- 13. the...the practice, at least, in...in our district of the
- 14. Federal Court is that when a witness is invited or subpoenaed
- 15. before the Grand Jury, he is allowed to bring a lawyer with him.
- 16. The practice is that the lawyer sits outside the Grand Jury
- 17. Room. A question is asked of the witness, and if his lawyer is
- 18. sufficiently sophisticated and if the witness is sufficiently
- 19. sophisticated, the witness writes down the question, respectfully
- 20. asks permission to consult with his lawyer. This is granted.
- 21. The witness goes out of the Grand Jury Room, consults with
- 22. his lawyer and comes back and answers the question or invokes
- 23. his fifth amendment rights. I think a much simpler and substant...
- 24. a...a...a simpler procedure and there would be a substantive
- 25. change, but it would add to the right and dignity of the proceeding
- 26. if that type of a witness were permitted to have his lawyer
- 27. sit in with him to consult with him to the extent that it is
- 28. permitted in...by our legislation in the State of Illinois and I
- 29. would urge your favorable consideration of this resolution and

- 29. Thank you Mr. President and members of the Senate.
- 30. This is the appropriation for the Department of Conservation
- 31. and it has had a great deal of surgery. I think we reduced
- 32. the appropriation by somewhere in the area of around over...a little
- 33. over eight million dollars. Senator Palmer is about to ask what the

- 1. total appropriation is and I'm about to tell him that I...that
- 2. I don't know at this point because there have been so many
- 3. amendments, Senator Palmer. Therefore, I move that...ask
- 4. for a favorable roll call.
- 5. PRESIDING OFFICER: (SENATOR ROCK)
- 6. Any discussion? Senator Palmer.
- 7. SENATOR PALMER:
- 8. I would like the sponsor to yield for a question.
- 9. PRESIDING OFFICER: (SENATOR ROCK)
- 10. Indicates he will yield. Senator Palmer.
- 11. SENATOR PALMER:
- 12. Cause I have some people in my district that are concerned.
- 13. Would Senator McCarthy please sit down? Thank you. Thank you.
- 14. Now, you...you have a cut in this here. You mentioned some surgery
- 15. here. Now, there is a...a cut, I believe of a seven hundred
- 16. and ten thousand dollars for the acquisition of some acreage
- 17. for the Bald Eagles Refuge. Is that still cut?
- 18. PRESIDING OFFICER: (SENATOR ROCK)
- 19. Senator Demuzio.
- 20. SENATOR DEMUZIO:
- 21. Yes, Sir. That is correct.
- 22. PRESIDING OFFICER: (SENATOR ROCK)
- 23. Senator Palmer.
- 24. SENATOR PALMER:
- 25. People in my district would like to know what's going to happen
- 26. to those eagles, those bald headed eagles.
- 27. PRESIDING OFFICER: (SENATOR ROCK)
- 28. Senator Demuzio.
- 29. SENATOR DEMUZIO:
- 30. Well, I'm sure that they can take that up in January
- 31. when your seccessor comes down here, Senator Palmer.
- 32. PRESIDING OFFICER: (SENATOR ROCK)
- 33. Senator Palmer.

- 1. SENATOR PALMER:
- You made no effort to restore those funds?
- 3. PRESIDING OFFICER: (SENATOR ROCK)
- 4. Senator Demuzio.
- 5. SENATOR DEMUZIO:
- 6. I did the best that I could with the Appropriation Committee
- but apparently they were not sympathetic to the bald eagles.
- 8. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Palmer.
- 10. SENATOR PALMER:
- 11. The item I see here is that there was a deletion of a
- 12. hundred thousand dollars where they abandoned the project
- 13. to dredge a ditch in Union County. Now, where is Union
- 14. County and what's going to happen to that ditch in case
- 15. I drive by there, I don't want to get into that ditch.
- 16. PRESIDING OFFICER: (SENATOR ROCK)
- 17. Senator Demuzio.
- 18. SENATOR DEMUZIO:
- 19. That ditch, Senator Palmer, to my knowledge, does not
- 20. belong to the State of Illinois. Union County is in Southern
- 21. Illinois and if you come down, we have bald eagles down there,
- 22. too.
- 23. PRESIDING OFFICER: (SENATOR ROCK)
- 24. Further discussion? Senator Latherow.
- 25. SENATOR LATHEROW:
- Well, Mr. Preisdent, I just wanted to tell Senator Palmer
- 27. that that bald eagle's roost is in my home county and they've...
- 28. they had a little problem proving to me that that was worth
- 29. seven hundred thousand dollars in that area, Senator, and
- I couldn't get real enthused about it myself.
- 31. PRESIDING OFFICER: (SENATOR ROCK)
- 32. Further discussion? Senator Demuzio may close the debate.
- 33. SENATOR DEMUZIO:

- I just have one final comment and that is next year
- in January, Senator Palmer, we'll see if we can put enough
- 3. money in the appropriation for hair pieces for all the bald
- eagles. Ask for a favorable roll call.
- 5. PRESIDING OFFICER: (SENATOR ROCK)
- 6. Question is shall House Bill 3403 pass? Those in favor
  - will vote Aye. Those opposed will vote Nay. The voting
  - is open. Have all voted who wish? Take the record.
  - On that question the Ayes are 50, the Nays are 2, 1 Voting
- 10. Present. House Bill 3403 having received a constitutional
- 11. majority is declared passed. Does anyone wish to call
- 12. one of the already filed Conference Committee Reports?
- 13. Senator, we'll try to take them in the order as they are...as
- 14. they were filed, if that's acceptable. Senator Glass, on
- 15. House Bill...Conference Committee Report on House Bill 3850.
- 16. The list has been passed out. I understand the reports have
- 17. been passed out.
- 18. SENATOR GLASS:

- 19. Thank you, Mr. President, Ladies and Gentlemen.
  - PRESIDING OFFICER: (SENATOR ROCK)
- 21. 50, Mr. Secretary.
- 22. SENATOR GLASS:
- 23. This...
  - PRESIDING OFFICER: (SENATOR ROCK)
- 25. Senator Glass.
- 26. SENATOR GLASS:
- 27. Thank you, Mr. President. This...this bill made some language
- 28. changes in the School Code relative to educational tours to
- 29. cure some problems of...with obtaining insurance. The...there was
- 30. one amendment which was not concurred in by the House, but with
- 31. the addition of a few words, this language has been corrected
- 32. and I would move for approval of this report.
- 33. PRESIDING OFFICER: (SENATOR ROCK)

- Any discussion? Senator Bruce.
- SENATOR BRUCE:
- 3. Not having 3850, is this the bill that relates to
- 4. construction of homes by students in vocational programs?
- 5. Okay. I just...thank you.
- 6. PRESIDING OFFICER: (SENATOR ROCK)
- 7. Any further discussion? The question is, shall the
- 8. Senate adopt the Conference Committee Report on House

- You're request is in order. Senator Johns, will you
- 5. explain Amendment No....House Amendment No. 5 in which we
- 6. are concurring by virtue of this report?
- SENATOR JOHNS:
- 8. House Amendment No. 5 was the amendment that was
- 9. debated about the hundred thousand dollars for the Jackson -
- 10. Union County Port Authority. There's some question about
- 11. the substantive bill, it was passed here yesterday. The
- Jackson Union County Port Bill was passed yesterday.
- 13. The hundred thousand dollars is for the initial seed money
- 14. for that. I discussed this Conference Committee Report with
- 15. Senator Weaver and I told him that I would move for its
- 16. adoption. He agreed that I should go ahead.
- 17. PRESIDING OFFICER: (SENATOR ROCK)
- 18. Further discussion? Senator Weaver.
- 19. SENATOR WEAVER:
- 20. I was just wondering, Senator Johns, why your
- 21. port district was worth a hundred thousand and Senator Hall's
- wasn't worth anything.
- 23. PRESIDING OFFICER: (SENATOR ROCK)
- 24. Senator Johns.
- 25. SENATOR WEAVER:
- 26. Fifty thousand, I guess. Yours is worth twice as much
- 27. as Senator Kenneth Hall's.
- 28. PRESIDING OFFICER: (SENATOR ROCK)
- 29. Senator Johns.
- 30. SENATOR JOHNS:
- 31. I...I talked this over with Senator Hall. I've talked
- 32. this over with the Conference Committee Members and they all
- 33. agreed that this was the initial money required to establish the

- 1. port. I had no problems with their agreement so I moved
- ahead with the Conference Committee Report.
- 3. PRESIDING OFFICER: (SENATOR ROCK)
- 4. Senator...further discussion? Senator Graham.
- 5. SENATOR GRAHAM:
- 6. I just wondered what prairie they're going to have that
- 7. port district in. Did you say pork bill or port bill?
- Pork, I understand.
- 9. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Latherow.
- 11. SENATOR LATHEROW:
- 12. Well, I just thought, maybe, Mr. President, I could
- 13. answer Senator Weaver's question. I think the river is larger
- 14. down there. They have to make it bigger.
- 15. PRESIDING OFFICER: (SENATOR ROCK)
- 16. Senator Knuppel.
- 17. SENATOR KNUPPEL:
- Just so I know what we're voting on, is this the port
- district that...that Senator Buzbee handled here yesterday,
- 20. the creation of this? And I was under the impression then
- 21. when I voted for it that it wasn't going to cost anything.
- 22. Now, this is a hundred thousand dollars it's going to cost?
- 23. PRESIDING OFFICER: (SENATOR ROCK)
- 24. Senator Johns.
- 25. SENATOR JOHNS:
- 26. That's correct. That's the money, sought in the original
- 27. appropriation for the implementation of the port.
- 28. PRESIDING OFFICER: (SENATOR ROCK)
- 29. Senator Buzbee.
- 30. SENATOR BUZBEE:
- Well, Mr. President, so there will be no misunderstanding,
- 32. Senator Knuppel, yesterday when my bill was under discussion,
- 33. Senator Weaver specifically asked me about the State's cost

- ı. on this project and I, at that time, said and it's been
- 2. discussed three or four times before that here on this Floor,
- 3. that there was a one hundred thousand dollar appropriation
- 4. on Senator John's bill, the Department of Business and
- 5. Economic Development and it was very plainly stated at that
- 6. time and so I don't want anybody to think that we were
- 7. trying to mislead them.
- 8. PRESIDING OFFICER: (SENATOR ROCK)
- 9. Any further discussion? Senator Johns may close the
- 10. debate.
- 11. SENATOR JOHNS:
- 12. I might add, Senator Knuppel, that yesterday I rose
- 13. in support of Senator Buzbee's Bill and I also indicated at
- 14. that time of this appropriation.
- 15. PRESIDING OFFICER: (SENATOR ROCK)
- · 16. All right. The question is, shall the Senate adopt the
- 17. Conference Committee Report on Senate Bill 1620? Those
- 18. in favor will vote Aye. Those opposed will vote Nay. The
- 19. voting is open. Have all voted who wish? Take the record.
- 20. On that question the Ayes are 37, the Nays are 11, none Voting

  - 28. What happened here is the bill went back over to the House...
  - 29. or we passed it and the House put on an appropriation for
  - 30. forty some thousand dollars for candlelight tours after the Sound
- 31. and Light Show at the Old Capitol Building. We objected to that.
  - 32. The bill went back and they cut the candles out so that the...so that
- 33. the only money involved in this now is additional money for the

20. Senator Harris.

21. SENATOR HARRIS:

22. Well, how can the House assume that that was not final

action on their part.

24. PRESIDENT:

25. Well, I don't think that's the question, Senator. Even

26. if they did assume it and it was not final action, then you would

27.

be bound by what the final action was. If it was...if it had,

28. in fact, been final action ...

29. SENATOR HARRIS:

30. Well,...

31. PRESIDENT:

32. ...then it would be subject to the question you raised.

33. SENATOR HARRIS:

- Well, I...I want to tell you something, I think this is
- 2. an alarming precedent, I really do. And I'm not going to be
- 3. party to it. If...if...if, in fact, this is a bond authorizing
- 4. bill, and we pass it with three-fifths vote and do not amend
- 5. it, it's obviously infirm because the two Houses have not
- provided that special constitutional requirement for debt
- authorization, it seems to me.
- 8. PRESIDENT:
- You're absolutely right, if we don't amend it.
- 10. SENATOR HARRIS:
- 11. Well, you know, I just...I just think we are wrong to
- 12. add any dignity to something that is wrong in the first place.
- 13. And the House has taken an infirm act with respect to communicating
- 14. this bill to us to increase the debt authorization of this agency
- 15. without the three-fifths vote required. I just... I don't want to
- 16. be a party to that. I think it's an improper act on the part of

- 29. Well, Mr. President, I just think this bill is improperly
- 30. before us. I...and I'm...I'm as sincere as I can be about this and
- 31. all this is, is the invitation to serious questions of litigation
- 32. with respect to it and we don't put a three fifths vote on it.
- 33. the bill is a...it is just a nullity. And I don't want to be a
- 34. party to the progress of this bill in a knowing way that that's where
