- 9. something like six thousand people within the Chicago metropolitan
- 10. region right now who are looking to put boats into the water and
- 11. there's a shortage. Chicago has got a waiting list quite long
- 12. and so does Waukegan, so yes, it is for the entire regional
- 13. area.

- 7. which we can act. I have 3392 which is the Department of Children
- 8. and Family Services. Senator Netsch has a noncontroversial one
- 9. which we might establish some kind of roll call on, that's House
- 10. Bill 2736.
- 11. PRESIDENT:
- 12. Will the members be in their seats?
- 13. SECRETARY:
- 14. Second Conference Committee Report on House Bill 2736.
- 15. PRESIDENT:
- 16. Senator Netsch.
- 17. SENATOR NETSCH:
- 18. Thank you, Mr. President. I would move adoption of the
- 19. Second Conference Committee Report on House Bill 2736, for a
- 20. noncontroversial bill, I must say this one has had a tortuous
- 21. history. What happened was that after the First Conference
- 22. Committee Report, one member of the House asked us please to remove
- 23. the provisions which changed the election code to reflect the fact
- 24. that our six months residency requirement is unconstitutional
- 25. under the United States Supreme Court decision of Dunn versus
- 26. Bradstreet. We could not persuade that member of the House that the
- 27. Supreme Court opinion was indeed applicable also to the State
- 28. of Illinois, and rather than create a huge furor in the House at this
- 29. stage, when they have enough of those to go around, we decided
- 30. simply to take those sections out and to put the bill back in the
- 31. form where it includes basically only two things, the original
- 32. purely revisory provisions making changes that reflect changes in the
- 33. Judicial Article of the Constitution and a second section which does

- 1. reflect the provisions of the Federal Overseas Voting
- 2. Rights Act. We felt it was necessary still to include those
 - 3. because there are some procedural provisions which ought to be
 - 4. applicable for the election this November and we did not want
 - 5. that to pass by. So, in the meantime, we have removed all of
 - 6. the reference...we have removed from the Conference Committee
 - 7. Report those provisions which attempted to comply our law with
 - the Federal law on durational residency requirements for voting.
- 9. It's too bad. It just means we'll simply have to come back
- 10. next year and clean up the Statutes. But, was better to do that...
- 11. PRESIDENT:
- 12. Well, just...just a moment. Just a moment. Will all not
- 13. entitled to the Floor, please leave the Floor? Go right ahead,
- Senator.
- 15. SENATOR NETSCH:
- 16. In any event, I think it is too bad to have to forego
- 17. this opportunity to clean up the Statutes before November
- 18. but it is not worth a three and a half or four hour haranque
- 19. in the House and so we have backed down. Senator Davidson has
- 20. been a participant in this from the beginning. We both agreed
- 21. here as well as the House sponsors, that this was the better
- 22. course to take. The bill, now, does only those two things,
- 23. the purely revisory aspects and the conformance of our law to the
- 24. Federal Overseas Voting Rights Act. I would move adoption
- 25. of the Second Conference Committee Report on House Bill 2736.
- 26. PRESIDENT:
- 27. Any further discussion? At a convenient time the Chair
- 28. would like to have a citation to that decision. The question is
- 29. shall the Senate adopt the Conference Committee Report on House
- 30. Bill 2736? Those in favor vote Aye. Opposed Nay. The voting
- 31. is open. Have all voted who wish? Take the record. On that
- 32. question the Ayes are 44, the Nays are none with none Voting
- 33. Present. The Senate does adopt the Second Conference Committee

- 1. Report on House Bill 2736 and the bill having received the
- 2. required constitutional majority...three-fifths majority, is
 - declared passed. Senate Bill 1608, Senator Knuppel.
 - 4. SENATOR KNUPPEL:
 - 5. Mr. President, when the Senate Bill 1608 went to the
 - 6. House, there were four amendments adopted, No. 1, No. 2,
 - 7. No. 4, and No. 8. The bill returns in that posture and at this
 - 8. time, I would move that the...that the Senate accede to the
 - 9. four amendments which did increase by some amount restorations
- 10. in the original appropriation for the Department of General
- 11. Services. The first amendment was a technical amendment to correct
- 12. a...an amendment in our own amendment...the Senate amendment
- 13. which was designed to restore twenty-one thousand dollars, but in
- 14. fact, went in the wrong direction and took off an additional
- 15. forty-nine thousand so that this now will add seventy thousand
- 16. dollars which has been and is to be used for some kind of a
- 17. garage situation. The Amendment No. 2 is...affects a transfer
- 18. of MID Service Bureau from the Department of Finance to the Department
- 19 of General Services, No. 4 restores eight thousand dollars
- 20. to the equipment line in the Procurement Division and No. 8 restores
- 21. funding for...for Vehicle Information Management System which
- 22. was cut out by the Senate. I have secured assurances from
- 23. those people connected with the...the Department of General
- 24. Services that the money restored will not be used to replace
- 25. jobs that have...that were cut by the Senate Appropriations
- 26. Committee. This is about all I can say about this matter. I think
- 27. in this status and this state of affairs that we should accept
- 28. and accede to the amendments placed on this appropriation in the
- 29. House and I would move for a favorable roll call.

- 31. Any further discussion? The question is shall the Senate
- 32 concur in Amendments Numbered 1, 2, 4, and 8 to Senate Bill
- 33. 1608? Those in favor vote Aye. Opposed will vote Nay. The

- 3. Voting Present. The Senate does concur in Amendments No. 1, 2,
- 4. 4, and 8 to Senate Bill 1608 and the bill having received the
- 5. required constitutional majority, is declared passed. Let
- 6. the record show that it had the three-fifths required vote.
- 7. Senate Bill 1936, Senator Rock. You want 3392 first?
- 8. SENATOR ROCK:
- 9. No. 3411.
- 10. PRESIDENT:
- 11. All right...Senate Bill...take 1936 out of the record.
- 12. House Bill 3411, Senator Buzbee.
- 13. SENATOR BUZBEE:
- 14. Yes, Mr. President. This is the annual appropriation for the
- 15. Department of Local Government Affairs. We had some problems in
- 16. the House in their refusing to concur in our amendment which put in
- 17. money for...some...grants...NIPS and SIPC and they have now
- 18. concurred in our amendment and I would move for adoption.
- 19. PRESIDENT:
- 20. Any further discussion? The question is shall the...shall the
- 21. Senate adopt the First Conference Committee Report on House Bill
- 22. 3411? Those in favor will vote Aye. Opposed Nay. The voting is
- 23. open. Have all voted who wish? Take the record. On this question
- 24. the Ayes are 47, the Nays are none. The Senate...and none Voting
- 25. Present. The Senate does adopt the First Conference Committee
- 26. Report on House Bill 3411 and the bill having received the required
- 27. three-fifths constitutional majority is declared passed. House
- 28. Bill 3403, Senator Demuzio.
- 29. SENATOR DEMUZIO:
- 30. Thank you, Mr. President, members of the Senate. House Bill
- 31. 3403 on Postponed Consideration is the appropriation bill for the
- 32. Department of Conservation. Very briefly, the...in the Conference
- 33. Committee we reduced the land and historic sites by an additional
- 34. forty-five thousand dollars, put back forty thousand dollars in

- 1. law enforcement. In Amendment No. 3...we restored one hundred
- 2. thousand dollars to drain...to dredge the drainage ditch in Union
- 3. County, a hundred and ten thousand or a hundred thousand to purchase
- 4. land in Hamilton County, two hundred and fifty thousand dollars for
- 5. a lake in Crawford County, deleted thirteen thousand for the main-
- 6. tenance of the Carroll Custom House, deleted the Seven Mile Lake and
- 7. restored the little Saline Lake. And basically, that is...that is
- 8. it. I move to adopt the First Conference Committee Report.
- 9. PRESIDENT:
- 10. Any further discussion? The question is shall the Senate adopt
- 11. the First Conference Committee Report on House Bill 3403? Those in
- 12. favor vote Aye. Opposed Nay. The voting is open. Have all voted
- 13. who wish? Take the record. Senator Harris.
- 14. SENATOR HARRIS:
- 15. Should...would it be improper for me to say that Jim Helfrich
- 16. can go back to his office now?
- 17. PRESIDENT:
- 18. On this question the Ayes are 46, the Nays are none with 2
- 19. Voting Present. The Senate does adopt the First Conference
- 20. Committee Report on House Bill 3403 and the bill having received
- 21. the required three-fifths constitutional majority is declared
- 22. passed. Senate Bill...Senate Bill 1739, Senator Regner.
- 23. SENATOR REGNER:
- 24. Mr. President and members of the Senate. Senate Bill
- 25. 1739 started out in the Senate here as a simple little bill
- 26. to resolve a potential problem in the acquiring of...of for
- 27. self insurance of State owned vehicles that the State couldn't
- 28. purchase commercial insurance. Went out of the Senate 56 to
- 29. nothing, came back from the House with a five page amendment
- 30. on that I didn't understand very well, moved to nonconcur and a
- 31. Conference Committee was appointed. I went to the Conference
- 32. Committee. Senators Carroll, Senator Glass, Senator Palmer,
- 33. Representatives Epton, Representative Berman were there, with
- 34. staffs of Saul Morris and David Epstein and the Director of the

- 1. Department of Finance, Elliot Epstein was there. I sat through
- 2. the meeting for about ten minutes with all these distinguished
- lawyers, didn't have the foggiest notion of what they were
- 4. talking about and I looked at the makeup of the committee and
- 5. I said to myself, I don't have the...any right at all to be in
- 6. this group, especially being a poor German butcher boy. So,
- 7. I appointed Senator Howard Carroll as my council and I went
- 8. to the Conference Committee on Mental Health. I do want to move
- 9. to adopt this Conference Committee Report, but if there are
- 10. any questions of the five page Conference Committee Report,
- 11. I would wish they would be asked of Senator Howard Carroll.

- Any further discussion? Senator Harber Hall.

- Yeah, Epstein, Berman, Epton, Palmer and the other Epstein.

- 15. few changes...very minimal changes to it. This deals with
- :6. the idea of the State becoming a self-insurer and what we have
- .:. said is that the Director of the Department of Finance has
- 19. the power to authorize settlements of claims against the State up
- ;; to a hundred thousand. We have provided for up to two million
- 1). in coverage where a State employee is sued and the State is
- ::. indemnifying that employee, between a hundred thousand and two
- ::. million, it will take the cosignature of the Governor to settle
- ... any claims. This provides, therefore, that when people are sued
- in the regular court system as opposed to the Court of Claims,

- the State now has the power to self-insure. They've 1.
- found that they are paying an excessive amount of premiums 2.
- when the loss factor was only about thirty percent of the premium 3.
- dollars. It is presumed that this will save the State several 4.
- thousands of dollars each year. 5.

- 20. PRESIDENT:
- 21. Is leave granted?
- 22. SENATOR MOHR:
- 23. ...on his desk.
- 24. PRESIDENT:
- 25. Leave is not granted. Senator Mohr.
- 26. SENATOR MOHR:
- You're going to call one more bill and then we're going home?
- 28. Is that...
- 29. PRESIDENT:
- 30. I'm going to ask if there's any further business to come before
- 31. the Senate.
- 32 SENATOR MOHR:
- 33. Well, I have...have an option, Mr. President, to make a motion

- to adjourn or hear this bill. I think we'll...we'll hear the
- 2. bill and then see what happens.
 - 3. PRESIDENT:
 - 4. Very good. Senate Bill 1932, Senator Egan. Try it again.
 - 5. Try it again. Go to another mike. Take Senator Chew's mike.
 - 6. SENATOR EGAN:
- 7. Thank you, Mr. President and Senator Mohr and fellow
- 8. members. Senate Bill 1932 has amendments from the House, numbers
- 9. 1, 3, 4, 6, 7, 8, 9, 10, 14, 15, 18, 19, 20, 21, and 24 and
- Section 27 was added which is technical in nature. It changes
- 11. the...the fund for some expenditures for the Secretary of
- 12. States Office from General Revenue to the Capital Development
- 13. Bond Fund. It contains, also, Section 28 which is an addition
- 14. of two million ninety-five thousand twenty-four dollars to the
- 15. college board of...for distribution for the senior courses
- 16. in the community colleges. Section 29 adds five thousand for
- 17. funding the already existing Legislative Advisory Committee
- 18. to the Regional Transportation Authority. Section 30
- 19. adds fifty thousand to the Fair Employment Practices Act for
- 20. investigation and...and Section 31 adds seventy thousand dollars
- 21. to the...it changes the...the appropriation for the Commission
- 22. on Economic Development from sixty thousand to a total of seventy
- 23. thousand dollars and because the House amendments have been on
- 24. for some time I'll briefly explain them, but I think that I would
- 25. rather I ask questions but I'll briefly explain all of them.
- 26. Number one, deleted many of the commissions that were resting in
- 27. the Rules Committee in the House and we funded for one dollar
- 28. having not passed through the Rules Committee, we have deleted
- 29. them from the bill. It changes township government laws from
- 30. fifteen to ten. Sudden Infant Death Syndrome Study Commission from
- 31. six to four five...four thousand five hundred that...House
- 32. Committee number three add...adds sixty-five thousand dollars for
- 33. alterations at the Dirksen Parkway Computer Site. Number four

- adds a hundred thousand to Mines and Minerals which was 1.
- not in the original bill. Number six appropriates one...one... . 2.
 - one thousand two hundred dollars for services rendered by Mr. 3.
 - Wavne Eckus in 1974 State Fair from the Agricultural Premium 4.
- 5. Number seven deletes the Space Needs Commission which passed
- out as an individual bill from both Houses. Number eight is a 6.
- police training board amendment to allow them to spend Federal 7.
- funds. Number nine corrects an error providing that the money 8.
- for the State Fair would come from Agricultural Premium rather 9.
- than the General Revenue Fund. Number ten appropriates twenty 10.
- thousand five hundred dollars to the Recreation Council and 11.
- ...well, the rest are...are...well,...Mr. President and members 12.
- of the Senate, there...there so few, let me finish. And the number 13.
- fourteen is twelve thousand five hundred for the Commission on 14.
- Urban Education. Number fifteen is the deletion of the General 15.
- Assembly Retirement System because it passed in a separate bill. 16.
- Number eighteen increases twenty to twenty-five the appropriation 17.
- for the Commission on the Uniformity of Legislation. Nineteen 18.
- puts in Motor Vehicle Laws Commission, that ninety-four thousand 19. dollars which was inadvertantly omitted. Number twenty reduces the
- appropriation of the State's Attorney Study Commission by eighteen 21.
- thousand eight hundred dollars and finally, number twenty-one 22.
- appropriates fifty thousand to the Department of Registration and 23.
- Education and I move the adoption, Mr. President and members of the 24.
- Senate, of the Conference Committee Report on Senate Bill 1932. 25.
- PRESIDENT: 26.

- Any further discussions? Senator Mohr. 27.
- SENATOR MOHR: 28.
- Normally, Mr. President, this might be a good bill, but under 29.
- the circumstances, I think it's a bad bill and I would encourage 30.
- our members to vote No or abstain from voting. 31.
- PRESIDING OFFICER: (SENATOR DONNEWALD) 32.
- Senator Partee. 33.

- 1. SENATOR PARTEE:
- 2. Well, Mr. President and members of the Senate, in the
 - 3. waning hours, I guess it's politics as usual, but I will tell
 - 4. you, if you want to take the credit for killing this bill, sobeit.
- 5. But, just be prepared to tell the members of the...General
- Assembly Retirement System that you killed their appropriation,
- tell the Legislative Council and its service unit that by
- 8. withholding your votes, you killed it. Tell the Legislative
- 9. Information System that they get no money. The Legislative
- 10. Investigative Commission, tell the Legislative Reference Bureau
- 11. that you just under these circumstances, didn't want to pass this
- 12. bill, and the Commission on Economic Development and the
- 13. Commission on Children and the one on Intergovernmental Cooperation.
- 14. Tell the Cities, Villages and Towns Problems Commission and the
- 15. County Problems Commission that the bill is no good this time.
- 16. The Data Information Systems, the Economic and Fiscal Commission,
- 17. the Electronic Funds Transfer Commission, the Energy Resources
- 18. Commission, the Judicial Advisory Council, the Legislative Advisory
- 19. Council on Public Aid, the Pension Laws Commission, the School
- 20. Problems Commission, the State Property Insurance Commission,
- 21. the Transportation Study Commission, the Mental Health and
- 22. Developmental Disabilities Commission, the State Employees
- 23. Insurance Commission, the Water Resources Commission, the Real
- 24. Property Laws Commission, the Public Utilities Commission, the
- 25. Insurance Laws Study Commission, the Labor Laws Commission,
- 26. the Aggregate Mining Commission, the Sudden Death Infant...the Atomic
- 27. Energy Commission, and Model School for the Deaf and Hard of Hearing,
- 28. the Space Needs Commission, your own commission you're killing,
- 29. the Revenue Study Commission, the Agricultural Economic Fair
- Commission, and divers and sundry others, you tell them
- 31. that under these circumstances because you couldn't run a resolution
- 32. twice that you ran yesterday and because you couldn't agree on any
- 33. procedure for that, tell those many, many people that politics

- dictated that they should not have funding for their commissions
- 2. next year. Now, I know that the problem...what the problem is
- 3. and I know that momentarily there is a bit of pique and a bit
- 4. of frustration, you made your point on the question of the RTA.
- 5. We just can't run the same thing day in and day out and the votes
- aren't here to do what you desire to do. We don't always agree,
- 7. but we try to be reasonable, but we have to be reasonable in
- 8. the context of the futuristic planning of this State. And to let
- 9. this bill go down for that kind of a reason, is really beneath
- 10. ...beneath the gentleman who has made the motion. He's a fine
- 11. gentleman who ordinarily is on balance and doesn't get upset,
- 12. but I'll tell you, if it goes down, we're going to put the votes
- 13. on here to pass it and if you are persuasive to others many of whom
- 14. are involved with their own commissions, then sobeit.
- 15. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 16. Is there further discussion? Senator Howard Mohr.
- 17. SENATOR MOHR:
- 18. Mr. President, many of those commissions that were named,
- 19. if they weren't funded, we wouldn't lose a thing. We would gain.
- 20. I'm prepared to tell the people anybody that takes the time to call
- 21. me, or write me or any members of this Body why I'm taking this
- 22. action, it's just not me. I think it's most members
- 23. on this side of the aisle, but that will be determined when we
- 24. take the roll call. Anytime you can't get a resolution considered
- 25. or passed, Senator, for something as important as the RTA, covering
- 26. six counties of this great State, there is something wrong. I don't
- 27. know who is hiding what, but maybe we'll find out. Now, I would...
- 28. I would say...
- 29. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Just...just a moment.
- 31. SENATOR MOHR:
- 32. ...Mr. President, that if there's any...
- 33. PRESIDING OFFICER: (SENATOR DONNEWALD)

- Senator Partee, for what purpose do you arise?
- . 2. SENATOR PARTEE:
- 3. Well, I...there's a very great difference in saying that
- 4. you can't get a resolution called and you can't get it passed.
- 5. Nobody has ever been denied the right to get a resolution
- 6. called. Getting it passed is not within the province of the
- 7. Chair.

- PRESIDING OFFICER: (SENATOR DONNEWALD)
- 9. Senator Howard Mohr.
- 10. SENATOR MOHR:
- I was just denied that opportunity. I wanted that resolution
- 12. called this evening and I was denied that opportunity. I admit
- 13. that it failed last night and it failed like the Senate Bill
- 14. 1977, Senator, because of your timing and your maneuvering this
- 15. Senate Body waiting till Senator Graham left and was followed to the
- 16. hospital to make sure he was in the hospital and we'd come up
- 17. with twenty-nine votes. I'll tell the people that. I'm prepared
- 18. to tell the people that you failed to recognize the problem in the
- 19. six county area, so when they call me, I'm going to refer them
- 20. to you when I get through talking to them. Now, let's
- 21. take the roll call.
- 22. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Rock.
- 24. SENATOR ROCK:
- 25. Well, just in response to that, as I indicated yesterday
- 26. and will again indicate, that there is a statutorily mandated
- 27. committee to do exactly what your resolution would have a
- 28. special committee do. When we were, in fact, considering Senate
- 29. Bill, I think it was 27, some years ago, we definitely put
- 30. that in for that purpose. Upon the creation of the RTA there
- 31. was also created this study committee bipartisan, both Houses,
- . 32. three Democrats and three Republicans from each House so that
 - 33. it's a twelve member continuing legislative committee to do

- exactly what this special resolution attempts to do. 1. So, I
- don't think your characterization is quite fair. . 2.
 - PRESIDING OFFICER: (SENATOR DONNEWALD) 3.
 - Senator Egan. 4.
 - 5. SENATOR EGAN:
 - I might add to that, Mr. President and members of the 6.
- Senate, that this bill which you are urging people not to vote 7.
- on, Senator Mohr, contains an appropriation for that already 8.
- legislatively enacted group and it's...it's in a sum which will 9.
- allow them to function. 10.
- PRESIDING OFFICER: (SENATOR DONNEWALD) 11.
- Senator Howard Mohr. 12.
- SENATOR MOHR: 13.
- That's fine. They won't need the money because they don't 14.
- meet. 15.

- PRESIDING OFFICER: (SENATOR DONNEWALD) 16.
- Senator Nimrod. 17.
- SENATOR NIMROD: 18.
- Yes, Mr. President and fellow Senators. In line with this 19.
- you know, reasonable people should always be able to find a 20.
- reasonable solution. And I've had a resolution sitting on the 21.
- desk since yesterday and I can concur in what Senator Rock has 22.
- said and I agree that that commission ought to have a right to... the committee ought to have a right to meet and should have
- its direction and should be able to make its report. And I support
- that. But I...maybe what we have here is an issue that needs 26.
- and one that Senator Rock is suggesting. So, my commission...my 28.

to have two committees. One that Senator Howard Mohr is suggesting

- resolution provides for both. Now, you're going to say, well, 29.

 - PRESIDING OFFICER: (SENATOR DONNEWALD)
 - g. Senator.
- 9. SENATOR NIMROD:
- 10. ...and it makes a...
- 11. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 12. Just a moment. Senator Bloom, for what purpose do
- 13. you arise?
- 14. SENATOR BLOOM:
- Point of order.
- 16. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 17. State your point.
- 18. SENATOR BLOOM:
- 19. Is...is this germane to the bill?
- 20. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 21. Not really.
- 22. SENATOR BLOOM:
- 23. Well, I'd like him to confine his...
- 24. PRESDING OFFICER: (SENATOR DONNEWALD)
- 25. Senator Nimrod will confine his remarks to the...
- 26. SENATOR NIMROD:
- 27. Well, anything...
- 28. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 29. ...matter at hand.
- 30. SENATOR NIMROD:
- 31. ...that would help the bill to pass and evidently, it seems
- 32. that there is the resolution on the RTA was what is preventing
- 33. this bill from passing and certainly if you offer a solution, that

- ...that people can expect, I would like to have some reaction
- 2. from Senator Rock whether or not he might accept this kind of a
- proposal since it does accept his particular amendment yesterday
- and it also takes care of Senator Howard Mohr. I was just
- 5. wondering what Senator Rock's reaction would be to this.
- 6. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Rock.
- 8. SENATOR ROCK:
- It was communicated to me that it was Senator Mohr's
- resolution or nothing.
- 11. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Nimrod.
- 13. SENATOR NIMROD:
- 14. Well, let's...let's ignore that request of communication.
- 15. I'm sending a new communication to you. How would you react...
- 16. how would you react to the new amendment which...which was
- 17. presented on the Floor today...which includes...which includes
- 18. yours, Senator Rock?
- 19. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Just a moment. Just a moment. Just a moment. Now, we're
- 21. going to...there are several people that wish to speak to this.
- 22. Please, please gentlemen, ladies, confine yourself to the matter
- 23. at hand. Senator Nimrod.
- 24. SENATOR NIMROD:
- 25. Yeah, can I ask Senator Rock if he can answer the question?
- 26. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 27. Senator Rock.
- 28. SENATOR ROCK: ..
- 29. Well, I...I suggested an amendment yesterday which was
- 30. summarily turned down and at this point in time, frankly, at
- 31. 6:00 o'clock in the evening on July 2nd, Senator Mohr had
- 32. communicated to me earlier it was his resolution or none. My frank

- 1. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 2. Senator Carroll.
 - 3. SENATOR CARROLL:
 - 4. My point of order, Mr. Chairman...Mr. President, was that
 - 5. we are dealing with a piece of legislation that involves State
 - 6. government and the appropriations to certain specific agencies
 - 7. and I would ask the members to confine their remarks to whether
 - g. or not they want to fund the government. Thank you.
 - 9. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 10. The point is well taken. Senator Schaffer.
- 11. SENATOR SCHAFFER:
- 12. Senator Egan, does this bill include the entire budget of
- 13. the Legislative Council?
- 14. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 15. Senator Egan.
- 16. SENATOR EGAN:
- i7. Yes.
- 18. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 19. Senator Schaffer.
- 20. SENATOR SCHAFFER:
- 21. Wonderful.
- 22. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 23. The question is shall the Senate adopt the Conference
- 24. Committee Report No. 1 on Senate Bill 1932? Those in favor
- 25. vote Aye. Those opposed Nay. The voting is open. Have all those
- 26. voted who wish? Have all those voted who wish? Take the
- 27. record. On that question the Ayes are 26, the Nays are 5, 5
- 28. Voting Present. The Conference Committee Report is not adopted,
- 29. and the Secretary shall so inform the House. Senator Hynes.
- 30. SENATOR HYNES:
- 31. Mr. President, I, in view of that last vote, I have to alter
- 32. what I was going say, but I was going to mention that the...as a
- 33. result of the appropriations process this year, we have passed a

- budget in the...in the vicinity of ten billion dollars and the
- 2. total General Revenue Fund appropriation in excess of the budget
- 3. are fifty-five...or were fifty-five million dollars, which I think
- 4. is, frankly, a...a demonstration of the responsibility that has
- been exercised by the members of this Body throughout this year.
- 6. With the action on the last bill, that has been reduced to forty-
- seven million dollars over budget and I think we owe ourselves
- 8. a congratulations and I think we can go home and safe in the
- knowledge that we've now saved another eight million dollars
- 10. for the taxpayers of this State.
- 11. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Rock.
- 13. SENATOR ROCK:
- 14. Yes, I would just point out that the House has, in fact,
- 15. adjourned until November the 17th, before I move, pursuant
- 16. to our adjournment resolution, I wish you would recognize
- 17. Senator Harris.
- 18. SENATOR HARRIS:
- 19. Thank you, Mr. President. Might I have about a five minute
- 20. recess, no more than five minutes, please, Mr. Chairman...
- 21. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 22. Senator Harris requests that and I think we've always
- 23. granted that to either side, so the Senate will stand at ease
- 24. for five minutes or so. Senator Bruce, for what purpose do you
- 25. arise?
- 26. SENATOR BRUCE:
- 27. Just for the purpose of...of announcements, Mr. Chairman.
- 28. Many of us knew Larry Reinold who was a lobbyist for the American
- 29. Federation of State County Municipal Employees. His wife had
- 30. a serious illness which occured in Florida. He has not been
- 31. here for two weeks and I was asked to announce that his wife
- 32. passed away last evening, in Florida, and those of you who
- 33. wish to send cards or condolences, may send it to Pascarella

- 1. Funeral Home, 7 Carlson Street, Everett, Massachusetts.
- . 2. Thank you.
 - 3. PRESIDING OFFICER: (SENATOR DONNEWALD)
 - 4. Senator Weaver wishes to announce that there is a Conference...
 - 5. excuse me. we'll stand at ease.
 - 6. PRESIDENT:
 - 7. Is there leave for Channel Three and Channel Twenty to
 - 8. make television pictures? Leave is granted. For what purpose
 - 9. does Senator Mitchler arise?
- 10. SENATOR MITCHLER:
- 11. Mr. President, may I ask at...a point of inquiry of the
- 12. Chair?
- 13. PRESIDENT:
- 14. Would you hold it just one minute, Senator?
- 15. SENATOR MITCHLER:
- 16. I'll be glad to.
- 17. PRESIDENT:
- 18. Senator Mitchler, may I see you a moment, please, here on the
- 19. podium? ...did you seek recognition? ...Mitchler.
- 20. SENATOR MITCHLER:
- 21. Yes, Mr. President, a point of inquiry of the Chair.
- 22. On the...
- 23. PRESIDENT:
- 24. State your point.
- 25. SENATOR MITCHLER:
- On the Senate Bill 1932, the First Conference Committee
- 27. Report, having failed to receive the constitutional number
- 28. of votes to pass, if that bill were to be brought back for consideration,
- 29. could a motion to bring that bill back for reconsideration
- 30. be made by a member of this Senate who cast a Present vote?
- 31. PRESIDENT:
- 32. The answer is Yes. The prevailing side on a motion which
- 33. is lost...on a bill which was lost, are votes which were either
- 34. in the negative or Present. So, either a negative vote or a Present

- vote was a vote on the prevailing side and either could make
- 2. a motion for reconsideration. Senator Mohr.
 - SENATOR MITCHLER:
 - 4. Mr. President, when we reconvene, if you would be kind
 - 5. enough to recognize me at the proper time for the purpose of
 - making a motion.
- 7. PRESIDENT:
- Senator Howard Mohr.
- 9. SENATOR MOHR:
- 10. Mr. President, I would suggest that you look at Rule 51.
- 11. · PRESIDENT:
- 12. Yes, Senator, I'm looking at the rule.
- 13. SENATOR MOHR:
- 14. Maybe you ought to read it to us, Mr. Senator.
- 15. PRESIDENT:
- 16. Sure.
- 17. SENATOR MOHR:
- 18. Mr. President.
- 19. PRESIDENT:
- 20. Rule 51. "If a bill shall fail to pass on account of not
- 21. having received the constitutional majority, any Senator having
- 22. voted in the megative shall have a right to move a reconsideration."
- 23. It says, "any Senator who voted in the negative may have a right
- 24. to move a reconsideration," which is not exclusive of the right
- 25. of a member who voted Present. Now, Senator...Senator Howard
- 26. Carroll.
- 27. SENATOR CARROLL:
- 28. Thank you, Mr. President. By way of parliamentary inquiry,
- 29. however, that says a bill. And we are dealing with a Conference
- 30. Committee Report and if you look at Rule 49, 49 says, "a
- 31. question once having been put and carried in the affirmative
- 32. and negative, it shall be in order for any member on the prevailing
- 33. side to move that same, the following...the same or the following
- 34. legislative day." I would submit to the Chair that this is not a

- bill before us but a Conference Committee Report and therefore,
- 2. we would have to look at Rule 49 which talks in terms of the
 - question having been put.
 - 4. PRESIDENT:
- 5. There is that recognized difference between a bill and a
- 6. Conference Committee Report and the 51 does, in fact, relate
- 7. to bills whereas 51...49 relates to questions being put.
- 8. Senator Howard Mohr.
- 9. SENATOR MOHR:
- Mr. President, what are we voting on?
- 11. PRESIDENT:
- 12. We have...we're not voting on anything at the moment.
- 13. SENATOR MOHR:
- 14. When Senator Mitchler makes his motion, we'll be voting on
- 15. a Senate Bill?
- 16. PRESIDENT:
- 17. No. When Senator or...Mitchler or whoever makes a motion...
- 18. makes a motion to reconsider the vote by which the Conference
- 19. Committee Report was not adopted, that would be the first
- 20. question on which we would vote. ... Howard Mohr.
- 21. SENATOR MOHR:
- 22. Well, Mr. President, we're playing games here. The...it's
- 23. a Senate Bill that we're talking about for...coming up for final
- 24. passage. I submit that that's a bill. And I submit that Present
- 25. does not mean negative, but...well, I'll...I'll just hold that
- 26. last remark, that I was about to...
- 27. PRESIDENT:
 - 28. Any other Senator desire recognition? Senator Mitchler.
 - 29. SENATOR MITCHLER:
 - 30. Are we back in Session now?
 - 31. PRESIDENT:
- 32. We are, indeed.
 - 33. SENATOR MITCHLER:
 - 34. Oh, all right. Mr. President, having voted on the prevailing

- 1. side and having cast a Present vote on the question of adopting
- 2. the First Conference Committee Report to Senate Bill 1932, I
- 3. do now move that the First Conference Committee Report to Senate
- 4. Bill 1932 be reconsidered.
- 5. PRESIDENT:
- 6. The motion is in order. You've heard the motion. All in
- 7. favor say Aye. Opposed Nay. The Ayes have it. The Conference
- 8. Committee Report is on the order of reconsideration. You're asking
- 9. for a roll call? Fine. ... Yes... the question is on the reconsider-
- 10. ation...no that hasn't...there's a roll call requested on that
- 11. question. A roll call was...was requested on the last roll...on
- 12. the last motion we took, the motion of Senator Mitchler's to
- 13. reconsider the vote by which Senate Bill 1932 lost...the Conference
- 14. Committee Report was not adopted. So, the question is, shall...
- 15. just a moment, Sir. We have already voted, Sir. This is the
- 16. roll call that was requested by Senator Schaffer. Now, all in
- 17. favor of reconsidering the vote by which Conference Committee
- 18. Report 1 on Senate Bill 1932 lost will vote Aye. Opposed will
- 19. vote Nay. The voting is open. Howard Mohr.
- 20. SENATOR MOHR:
- 21. I didn't appreciate or think that was a fair ruling on
- 22. Senate Rule 51. I'd ask you from time to time, we use the
- 23. Roberts Rules of Orders, I'd suggest that you turn to page 265,
- 24. number 36 under "Reconsider" and it states there, Mr. President,
- 25. it can, "be made only by a member who voted with the prevailing

- 27. one who voted Aye. That was not Senator Mitchler.
- 28. PRESIDENT:
- 29. Well, Senator, the Rule 49 does not strictly...51 does
- 30. not strictly apply to Conference Committee Reports. A more
- 31. pertinent section of the rules was Rule 49 which Senator Howard
- 32. Carroll sited. But, I did rule that a negative vote...a Present
- 33. vote was not...was on the prevailing side and as a consequence,

- the person would have the right to make it. Have all voted who wish?
- Let me...let me take this record, please. Have all voted who
 - 3. wish on this question? Take the record. Majority of those voting.
 - 4. Take the record. On this question the Ayes are 32, the Nays
 - 5. are 4 with 1 Voting Present. ...question the Ayes are 32, the
 - 6. Nays are 4 with 1 Voting Present. The bill...the Conference
 - 7. Committee Report 1 to Senate Bill 1932 is reconsidered. Verification
 - 8. is requested. Would the members...you want the affirmative votes,
- g. is that right? A verification of the affirmative votes is requested.
- 10. Will the members please be in their seats?
- 11. SECRETARY:
- 12. Brady, Bruce, Buzbee, Carroll, D'Arco, Daley, Davidson,
- 13. Demuzio, Donnewald, Dougherty, Egan, Kenneth Hall, Hickey,
- 14. Hynes, Johns, Joyce, Knuppel, Kosinski, Lane, Lemke, Merritt,
- 15. Mitchler, Netsch, Newhouse, Nimrod, Palmer, Rock, Shapiro,
- 16. Vadalabene, Welsh, Wooten, Mr. President.
- 17. PRESIDENT:
- 18. Senator Vadalabene on the Floor? Take him off the roll.
- 19. Senator Buzbee on the Floor? Yes, he's here. Senator Dougherty
- 20. on the Floor? Take him off the roll call. Senator Joyce
- 21. is here. Bruce is here. Roll call has been verified. On that
- question the Ayes are 30, the Nays are 4 with 1 Voting Present.
- 23. The roll call is verified. Now, we're on the question of the
- 24. adoption of a Conference Committee Report 1 of Senate Bill 1932.
- 25. Any discussion? Senator Howard Mohr.
- 26. SENATOR MOHR:
- 27. Think...think we all...all have a copy of that. I don't
- 28. have one on my desk. I don't know if anybody else does, but I'd
- 29. like to take the time to go through that. I think it...personally
- 30. I think it might be of some interest.
- 31. PRESIDENT:
- 32. Would you please give the Senator a copy? I thought...think
- 33. it has been heretofore distributed. See that he gets a copy.

- 1. Any further discussion? Senator Weaver.
- 2. SENATOR WEAVER:
- 3. Mr. President, might we have a few minutes for a Republican
- 4. caucus, please?
- 5. PRESIDENT:
- 6. We've never denied it, to anyone who asks. Any indication
- 7. of the time? Our...our members are really getting antsie.
- 8. SENATOR WEAVER:
- Hopefully within about fifteen minutes.
- 10. PRESIDENT:
- 11. Please. Senator Hall, for what purpose do you arise?
- 12. SENATOR HALL:

- 13. I just wanted to know if the President was going to provide

- 16. I went on a diet the 1st of July and I'd suggest you do the

- 18. SENATOR EGAN:

PRESIDENT:

- 19. By way of explanation, Mr. President.
- 20. PRESIDENT:
- 21. Make it short, please.
- 22. SENATOR EGAN:
- 23. Well, I inadvertantly failed to tell the Body that Senate
- 24. Amendment 24 was also included in the...in the package of amendments
- 25. and I failed to explain that. So, I thought I better do that so
- 26. that we'd all understand entirely the...the bill.
- 27. PRESIDENT:
- 28. Senator, I...you want to make...make the motion.
- 29. SENATOR EGAN:

Bill 1932.

- 30. Yes, Mr. President and members of the Senate, I move that
- 31. the Senate concur in the Conference Committee Report on Senate
- 33. PRESIDENT:

32.

34. Any discussion? Senator Berning.

- 1. SENATOR BERNING:
- 2. Thank you, Mr. President. I, in all honesty, hesitate
- 3. to rise. However...as you have learned, Mr. President, it's
- 4. nice to have friends. The resolution which was asked for
- 5. was not a matter of great moment or State of Illinois shaking
- 6. significance, but it did provide a vehicle for a very...meaningful
- 7. activity and I personally regret that the wisdom of this
- 8. Senate was to deny Senator Mohr passage of that resolution.
- 9. PRESIDENT:
- 10. Any further discussion? Senator Schaffer.
- 11. SENATOR SCHAFFER:
- 12. Mr. President, I hesitate not in the least. We're going
- 13. to have a roll call here in a few minutes. I think a No vote
- 14. is defensible on two grounds. One, on the bill. I can justify
- 15. my No vote without any problem a dozen different ways. Two,
- 16. on the denial of a simple resolution calling for a committee,
- 17. a meaningful committee to look into the RTA. I want to know...
- 18. I want this Senate to know because I said it yesterday and I still
- 19. don't think you've got the message but there are those in this Body
- 20. who feel strong enough about RTA to pick this State up and shake
- 21. it if we can.
- 22. PRESIDENT:
- 23. Senator will confine his remarks to the bill under
- 24. consideration. This is not germane but I'm not going to cut
- 25. you off. Continue.
- 26. SENATOR SCHAFFER:
- 27. I appreciate that, Mr. President. I've always tried to keep
- 28. my remarks pertinent and germane. I'm explaining, if you will,
- 29. a little ramification on this bill. I think the message is simple.
- 30. Give us justice on the RTA or be prepared for trouble and a lot
- 31. of opposition from this point forward. Not only from those four
- 32. suburban board members who, God bless them, have had the guts
- 33. so far to stand up to the people they represent. But, also
- 34. from those of us from the collar counties and the suburbs.

- Going to have a roll call a few minutes from now and it's 1.
- going to be on the RTA question and we're going to see how many 2.
- pussycats we've got and how many tigers. 3.
- PRESIDENT: 4.
- Any further discussion? Senator Mitchler. 5.
- SENATOR MITCHLER: 6.
- I want to just make, Mr. President and members of the Senate, 7.
- one comment on the Conference Committee Report specifically, 8.
- Senate Bill 1932 that we're voting on. Really, there's 9.
- probably only about three, and I'd expand it to maybe four, 10.
- items in this bill that are appropriated for that are absolutely 11.
- what I would consider necessary for the function of our government. 12.
- All the rest are what we get every year, but we've had this 13.
- Omnibus Commission Bill for many, many Sessions and we've 14.
- always had to sort of swallow it, because it's got something 15.
- in it for everybody. It's a...bigger than any creek bill or anything 16.
- that comes out. And things get slipped in and I hope you all have 17.
- a copy so you know what...what you're voting on as far as the 18.
- ...the various commissions. I've communicated to the Senate 19.
- Appropriations Minority representation on Appropriations Committee, 20.
- my feelings about even some commissions that I serve on about some 21.
- things in there that I dislike, the salaries of the employees 22.
- and that...that I think is a ripoff on the taxpayer. But, there's... 23.
- you've got to get it going and let this be the warning on this 24.
- type of bill that you don't ever get into to put in all the appropriation 25.
- bills for all the agencies, code departments, and commissions into
- 26.
- one omnibus bill that I heard breathed out at the start of this 27.
- Session. Lord help the taxpayer if that ever happens, but we've 28.
- swallowed this every year and really the percentage that's involved 29. here to the cost to State government is minuscule. And I can vote
- 30.
- for it and I'm going to vote for it tonight so that we don't have 31.
 - to be called back into a Special Session or something because that's 32.
 - exactly what would have to happen because you would stop government 33.

- if you didn't pass this.
- , 2. PRESIDENT:
 - 3. Any further discussion before Senator Egan closes debate?
 - Senator Harris.
 - 5. SENATOR HARRIS:
- 6. Thank you, Mr. President. Mr. President, I will perhaps
- 7. stray somewhat from the matter before us. I will do my best
- to stay reasonably close to the mark. We have before us, now,
- 9. the bill appropriating to various commissions of State government
- 10. many of which are essential, essential to State government, many
- 11. of which are less than superfluous. But, also before us is
- 12. an issue of prime significance to the twelve million people of
- 13. Illinois. Mr. President, two years ago, I was the President.
- 14. Mr. President, two years ago, seeking to accept my responsibility
- 15. to legislate on behalf of all of the people of Illinois, I believe
- 16. I was critical to the enactment of the Regional Transportation
- 17. Authority Act. For years, legislation such as that, legislation
- 18. that would assist mass transportation has passed the other Chamber
- 19. of the Illinois General Assembly. But, in 1973, by joining
- 20. agressively as the President and the persuader of many men on
- 21. my side of the aisle, we created the Regional Transportation
- 22. Authority. It's had a little over a year to function. An
- 23. important commitment of State funds that otherwise would be
- 24. available for our other State purposes is now appropriated by mandate
- 25. in the overall result of that work by the 78th General Assembly.
- 26. And, Mr. President, I'm proud of the leadership role that I took
- 27. in the creation of the Authority. This Session of the General
- 28. Assembly there have been made on several occasions, attempts
- 29. to remedy what have begun to be appreciated as infirmities
- 30. in the Act. We have not succeeded in any of those legislative
- proposals to repair. Yesterday, a largely innocuous request
- 32. was made of this Chamber to structure a committee of the Senate
- 33. to study the Regional Transportation Authority for several reasons.

- 1. And let me be the first to acknowledge that the structure
- 2. of the committee itself was one whose membership might be
 - 3. questioned with respect to their viewpoint. The form of that
 - 4. resolution provided for seven members. It would have been
 - 5. my responsibility to appoint two. I will say no more about
- 6. it except to say that those among you from within the City
- 7. of Chicago and those among you who have no great interest in
- 8. the Regional Transportation Authority joined in the frustration
- 9. of the adoption of that resolution. And I recognize that a
- 10. counter proposal was offered. On many occasions, on really
- 11. important issues, reasonable people of differing viewpoints
- 12. can ultimately conclude that they can't agree. So today,
- 13. we are in the posture of being at the very end of a long
- 14. and arduous Session, at the very end of two hard weeks of work,
- 15. to most important of all, fund the essential operations of
- 16. State government. There are a tremendous number of people in
- 17. Illinois who are not persuaded today, that our conclusion of two
- 18. years ago was wise. There are many...there are many who believe
- 19. that our conclusion of two years ago was so unwise that the
- 20. entire Act should be scrapped. I'm not among those. I am
- 21. among those who believes that steps should continue to be taken
- 22. to evaluate our product. To determine whether the aspirations
- 23. of some eighteen months ago are, in fact, being met, realized,
- 24. or not being met. The request yesterday was not, well, in relation
- 25. to the importance of this bill, and the importance of the
- 26. resolution itself, do not equate. This bill could be concluded by
- 27. those who resist any change to the RTA that the resolution was not
- 28. important. But, I must say to you, Mr. President, that that
- 29. resolution really is important. And, Mr. President, it cannot
- 30. escape anyones notice that I am a candidate for a constitutional office
- 31. of Illinois. And one of the things about which I am most proud,
- 32. has been, as I look back on over twenty-one years of service, my
- 33. willingness to meet responsibility. I suggest, Mr. President, that

- 1. the full responsibility of this Senate has not been met when
- . 2. we asked for a somewhat innocuous resolution concerning
 - 3. an issue whose importance is major. And we asked to take a look
 - 4. at the structure and function and operation of the Regional
 - Transportation Authority. Mr. President, between now and
- 6. November 2nd our two great major parties will take to the
- people of Illinois, what they believe to be the important issues
- 8. in the campaign to determine who will lead the Executive Department
- 9. of Illinois for the next two years. I'm personally sad about the
- 10. fact that I will not be here in this Chamber continuing the
- ll. service that I do love, attempting to work out the difficult
- 12. questions and the important solutions that serve a majority
- 13. of the people of Illinois. Mr. President, I am... I am truly
- 14. sad about the fact that we were not given that option yesterday
- 15. to take a look at the operation of the RTA. And as I visited
- 16. with you privately tonight, my conclusion was that for us to wrap
- 17. together an evaluation of the Regional Transportation Authority
- 18. by a committee of this House, and the passage of a major
- 19. appropriation bill of Illinois was unwise and a mistake. And,
- 20. Mr. President, since I communicated that to you, I have honestly
- 21. searched my soul to determine what is the wiser course of action.
- 22. And, Mr. President, I've had tremendous conflicts involved in the
- 23. determination of my conclusion. A man with whom I have served
- 24. for some ten years and a man for whom I have the personal love
- 25. as that of a brother to a brother, is the focal point of that
- 26. resolution. And I know it will be difficult for the people of
- 27. Illinois to judge my conclusion as anything other than an abandonment
- 28. of responsibility for a commitment to political expediency.
- 29. But, Mr. President, that is not my conclusion. My conclusion is
- 30. that with respect or that is not the basis on which I have made
- 31. my conclusion. My conclusion is, Mr. President, that the twelve
- 32. million people of Illinois, in fact, do need to have a dispassionate
- 33. evenhanded view to evaluate that importance agency of the
- 34. State government, the Regional Transportation Authority. The

- 1. opportunity for that is probably gone for the remainder of this
- 2. Session. At least, until after the election. Mr. President,
 - 3. I am committed to the principle that it never hurts to look
 - 4. at a question carefully and with candor. Mr. President,
 - 5. thus far this evening, I have refrained from voting, but I
 - 6. determine that the people of Illinois, in fact, want me to
- 7. communicate to them that important questions between now and
- 8. November 2nd have to be viewed with candor and dispassionate
- evaluation. Thank you, Mr. President.
- 10. PRESIDENT:
- 11. The question...Senator Howard Mohr.
- 12. SENATOR MOHR:
- 13. Yes, Mr. President. This really isn't easy to get us into
- 14. this kind of position. I'm not really that kind of a person.
- 15. There are people in this Body that would keep us here for
- 16. indefinite periods, people...a person in the House, for example,
- 17. that delights in this kind of activity, I don't. To me this is
- 18. a matter of principle. It's really what it's all about. I, too,
- 19. was a part of the members on both sides of the aisle and both
- 20. sides...both Houses that put the RTA together. I still think
- 21. it's something that we have to have. I still think it is something
- 22. that has to be looked at. And, all that we are asking that resolution,
- 23. Mr. President, was for seven members of this Body to look at the
- 24. RTA. Just look at it. Obviously, there is something wrong when
- 25. the budget has not been adopted; when four members fail to agree
- 26. on adopting a budget. It kind of leads me to believe there's
- 27. something wrong. Privately, members of your side of the aisle have
- 28. told me that I am right, that they do have problems with the
- 29. RTA, but they couldn't publically state that, and I can appreciate
- 30. that. I apologize for keeping the members here as long as we have
- 31. and two people, Mr. President, know you and Senator Harris know
- 32. that if anybody has a reason to be home, it is me and should have
- 33. been home almost a week ago or five days ago. But, I am here and
- 34. I would stay here until hell freezes over when it comes to such a

matter. I proposed earlier this evening that we consider this 1. resolution. Senator Rock told me that we're not going to get . 2. into that. And I suggested that we had another bill to hear 3. and I didn't think it would pass, and he said, well, then, 4. sobeit, let's go home. We'll determine that very shortly, 5. Mr. President, whether we will pass or not and either way 6. will we...we will be going home. It's interesting to see 7. members of this Body that when there's matters of great concern 8. for their district, they stand up and shout and holler and 9. do all that is necessary to get their district taken care of, 10. and I commend them for it, that's what they're here for. 11. I would suggest to the members on the other side of the aisle 12. that are outside of the Chicago area, to start looking and start 13. questioning some of the problems that we have in Cook County. 14. I also find it amusing, Mr. President, the ruling that was 15. made here earlier this evening, which in my opinion, was 16. a bad ruling, but I certainly can't argue that point when it's 17. been ruled by the Presiding Officer who has the gavel and interprets 18. the rules as he sees fit from day to day. And I would 19. suggest, Mr. President, that that really isn't a way to...to rule 20. if you are an elected official or have other asperations. 21. I would point out on the last roll call that I verified, I missed 22. Senator Knuppel, so don't push his button this time, cause 23. we'll be watching for him. To take a stand as many people do, 24. not always popular, but I commend the suburban board members 25. of the RTA for standing up what they think is right. They want to 26. get some recognition, they want to...not recognition, they want 27. to be heard on the problems that they're having with the RTA 28. and they can't be heard, and I think this Body owes it to them 29.

to support those members and get on with the proper running of a

good RTA. And it's guite interesting to see after that ruling

by a member that voted Present, that has sounded off ever since

the RTA was founded condemning it, could never say enough bad things

- about it, but we all have to go back to our districts,
- 2. Mr. President, and tell the people why we vote a certain way.
 - 3. And that's one press release that I'm going to be watching
 - 4. for. I'd like to know how that's going to be explained. In this,
 - 5. there is some talk about bringing us back here for a Special
 - 6. Session. The press will say that will cost money. True, it
 - 7. will, but I think if we really look at the bill before us,
- 8. we could have our Special Session, cut out some of the special
- commissions in here that aren't really worthy, if we would admit,
- 10. and I think we could end up saving some money. But, a study
- 11. of some of these commissions might prove very, very interesting.
- 12. And I think that that should probably be done. In the...
- 13. PRESIDING OFFICER: (SENATOR ROCK)
- Your time is up, Senator.
- 15. SENATOR MOHR:
- 16. ...bill...I will conclude, in the bill, Senator Partee
- 17. mentioned, all the people that I would be held accountable to.
- 18. He failed to mention, Mr. President, that I would hear from the
- 19. people concerned about FEPC for fifty thousand dollars, which is
- 20. the last entry on the two page list of commissions. That came in
- 21. late in the day for fifty thousand dollars. I will answer
- 22. to those people, Senator Partee. I would conclude right now,
- 23. Senator, in saying that we had a healthy caucus. Fortunately
- 24. or unfortunately, we don't make the determinations that
- 25. you people on the other side of the aisle do. Our people are
- 26. free to vote their conviction. I know this will be argued, but
- 27. if we look at the record, you'll know what I mean. There is no
- 28. caucus position on this and I have stated to our membership they
- only ones that would have to come down that...are...would be those

could vote any way they want and really in a Special Session, the

- 30. only ones that would have to come down that...are...would be those
- 31. that would have a very special interest. Thank you, Mr. President.
- 32. PRESIDING OFFICER: (SENATOR ROCK)
- 33. Senator Partee.

SENATOR PARTEE:

1. I'd first like to disabuse Senator Mohr of the thought 2. that I control them over here. I'll tell you, I don't. 3. The Illinois Legislature, the Senate, is composed on this side of 4. thirty-three prima donnas and your humble servant. Now, I 5. could start off with some sort of flippant remarks like saying that now 6. it isn't so, that this issue, as Senator Schaffer said, had 7. united the party in light of what Senator Mohr said about 8. Senator Mitchler. And I could talk about how much it's 9. costing today to stay here which was the big theme yesterday. 10. But, this is a very serious question. I said here yesterday 11. that a look at the operation of the RTA is required. I opened 12. with that statement yesterday. I said that this is an agency 13. which, as I read in the papers, has from time to time had, from 14. the press reportings, many, many problems. It's survival, 15. essential agency for the transportational needs of people 16. in that area and I also said that every branch of governmental 17. activity ought to be run competently. I said that yesterday, 18. I'm repeating it today, and I will say it tomorrow. But, this is 19. an issue, which in my judgement, which entails very, very large 20. dollars, has many political ramifications, and any look or 21. investigation ought to be made outside of the political 22. arena by self-effacing politicians and not by self-effacing 23. politicians and people who are there to grind their own axes. 24. I would suggest to you, Mr. President, that I am as of this moment, 25. making myself available to Senator Harris, Senator Schaffer, 26. Senator Mohr, Senator Morris in his absence and to any other 27. person who is interested in really bringing about an investigation 28. of competence and not one of political structuring. That's a 29. large organization and the people who look at it and who investigate it, 30. should be thoroughly knowledgeable people in the field and have 31. skills in management, fiscal expertise, and they should know 32.

a great deal about transportation. Yesterday, we offered a

substitute motion. Since we were not going to have people

- 1. with expertise in transportation, in fiscal management and
- 2. did have...not have the skills really required to take the
- 3. look at this kind of an operation, I thought the least we ought
- 4. to do is to go with the legislative Body that has already been
- 5. structured. And we offered that. And that was denied. So
- 6. I'm saying to you today, that this is like the song, bigger than
- 7. the two of us. It's larger than the Democratic party and
- 8. larger than the Republican party in this context. It is an issue
- 9. which ought to be looked at carefully, nonpolitically. It
- 10. affects the lives of a lot of people. I object not to the
- 11. look at this agency; I think it ought to be looked at. Wha
- 12. I object to is the methodology suggested by politicans running
- 13. for office in those particular areas who would be more
- 14. concerned about posturizing themselves and getting in the paper
- 15. and on television they would...than they would be about doing the
- 16. ...the job required, if per chance, they had the personal
- 17. capability to do so. As about my rulings, I don't need to defend
- 18. them. I'll compare them with the rulings of anybody who ever
- 19. held a gavel in this House. I have a book of rulings that took
- 20. place the last two years. It will surprise you. I can show
- 21. you where we catalogued them, where on one day it's this way,
- 22. one day it's the next. I'm not trying to defend it. No, that's
- 23. history. My records are written. But, I say to you that God
- 24. as my judge, I would make every ruling consistent with what...
- 25. what my mind tells me the facts are, and the interpretation that
- 26. should be. So, in closing, let me say to you, that I am ready
- 27. Tuesday morning, to sit down with you, anywhere, and help to structure
- 28. a blue ribbon committee of knowledgeable people, nonpoliticians,
- 29. who in this period between now and the November election, can do
- 30. a job for us and for the people. Thank you.
- 31. PRESIDING OFFICER: (SENATOR ROCK)
- 32. Senator Latherow.
- 33. SENATOR LATHEROW:

- Thank you, Mr. President and I wonder if it's all right ı.
- if I say something about Senate Bill 1932. . 2.
 - PRESIDING OFFICER: (SENATOR ROCK) 3.
 - That would be a pleasant change. Thank you, Senator. 4.
 - SENATOR LATHEROW: 5.
 - I've sat here...I've sat here and thought about a lot 6.
 - of sayings that I've heard in my time. And, as I mentioned to some 7.
 - people a while ago, you don't make many mistakes looking back, 8.
 - you know. And I think when we look at what we're really talking 9.
- about here tonight as what we knew was going to come for several 10.
- days, we've waited for it, we knew it was going to be this 11.

- PRESIDING OFFICER: (SENATOR ROCK) 22.
- Senator Latherow has moved the previous question. All 23.
- those in favor signify by saying Aye. All those opposed. 24.
- The Ayes have it. Senator Egan to close. 25.
