

- 12. Senator Smith, Chairman of the Committee on Public
- 13. Health, Welfare and Corrections, reports out House Bill
- 14. 2506 with the recommendation Do Pass as Amended.
- 15. PRESIDENT:
- 16. Senator Kosinski.
- 17. SENATOR KOSINSKI:
- 18. Mr. President and members of the Senate. I would now
- 19. like to ask the suspension of the rules and have the bill
- 20. read for the second time.
- 21. PRESIDENT:
- You have heard Senator Kosinski's motion to suspend the
- 23. rules for the purpose of having House Bill 2506 read a second
- 24. time. All those in favor signify by saying Aye. Opposed.
- 25. The Ayes have it. The rules are suspended. On the Order of
- 26. 2nd reading, House Bill 2506. Read the bill, Mr. Secretary.
- 27. SECRETARY:
- 28. House Bill 2506.
- 29. (Secretary reads title of bill)
- 30. 2nd reading of the bill. Committee on Public Health, Welfare
- 31. and Corrections offers two amendments.
- 32. PRESIDENT:
- 33. Senator Kosinski, are you prepared to explain the amendments?

- SENATOR KOSINSKI:
- Yes, Mr. President and members of the Senate. Senate
- 3. Amendment 1 makes a technical change in the bill to compensate
- 4. for its delayed enactment because the legislation cannot be
- 5. passed before March...before March 1st, 1978. Compliance
- 6. by the Department of Registration and Education and the establish-
- 7. ment of the Review Board and review of the applications would
- 8. be...would be virtually impossible. Applicants for the renewal
- 9. could not meet the original deadline specified in the bill as
- 10. they were stated in the version which passed the House March
- 11. 1st, 1978. Deadlines are extended by the amendment till
- 12. October 1st, 1978. The amendment also inserts the immediate
- 13. effective date clause. Senate Amendment No. 2 clarifies
- 14. the intent of the bill to provide that only fully licensed
- 15. physicians serve on the new limited License Review Board.
- 16. The amendment expressly prohibits limited licensees from
- 17. being members. Thank you, Mr. President.
- 18. PRESIDENT:
- 19. Is there any discussion? If not, Senator Kosinski moves
- 20. the adoption of Amendment No. 1. All those in favor signify
- 21. by saying Aye. Opposed. The Ayes have it, the amendment is
- 22. adopted. Senator Kosinski moves the adoption of Amendment
- 23. No. 2. Is there any discussion? If not, all those in favor
- 24. signify by saying Aye. Opposed. The Ayes have it. Amendment
- 25. No. 2 is adopted. Any further amendments?
- 26. SECRETARY:

- 29. Any amendments from the Floor? Senator Shapiro. For
- 30. what purpose do you arise?
- 31. SENATOR SHAPIRO:
- 32. Mr. President I...I just want to raise the question that
- should the administration change their mind on the...on the

- 1. bill, that we'd be able to bring it back to 2nd reading
- 2. for further amendments because there's going to be a
- 3. problem involved with that March 1st and October 1st. How...
- 4. how you pick up the lapsed time in there.
- 5. PRESIDENT:
- 6. Senator Kosinski indicates that he is willing to bring
- 7. the bill back for further amendments if that is desired.
- 8. Are there any further amendments?
- 9. SECRETARY:
- No further amendments.

- 12. 3rd reading. Introduction of bills.

- 24. might suggest that the Senate stand in recess so that the

- On a point of personal privilege, Mr. President. Before

- 11. Senator...Senator Savickas has moved to suspend the rules

- 5. For what purpose does Senator Kosinski arise?
- 6. SENATOR KOSINSKI:
- 7. Mr...Mr. President and members of the Senate. This is
- 8. an unusual resolution and it's not in the same class of other
- 9. resolutions. This is one that is regarding the Chicago Daily
- 10. News and I would like to read this resolution if I may have
- 11. your permission and the Body.
- 12. PRESIDENT:
- 13. Would you take that resolution out of the pile.
- 14. SECRETARY:
- 15. Senate Resolution 2...295 then will be Senators, introduced
- 16. by or offered by Senator Mitchler and all Senators. It's
- 17. congratulatory.
- 18. Senate Resolution 297 offered by Senator Lane and Hynes.
- 19. It's congratulatory. Senate Resolution 298 offered by Senator
- 20. Lane and Hynes and it's congratulatory. And Senate Resolution
- 21. 299 offered by Senator Kosinski and all Senators.
- 22 PRESIDENT:
- Senator Kosinski, did you have a comment to make on Senate
- 24. Resolution 299?
- 25 SENATOR KOSINSKI:
- 26. If...if I may, Mr. President, to read it and it'll take
- 27. me about a minute and a half. As you know I'm a pretty
- fast reader, but I think being a former news...
- 29. PRESIDENT:
- 30. Right. Right. Senator, Senator, if you wish to have it
- read, then let's adopt the other resolutions. We'll come
- back to this one. Senator Rock, do you have a motion with
- respect to these other Congratulatory Resolutions? Senator

- 1. Rock. The Congratulatory Resolutions?
- SENATOR ROCK:
- 3. Yes, I would move, Mr. President to suspend the appropriate
- 4. rule so that these Congratulatory Resolutions can and should
- 5. be immediately considered and adopted.
- 6. PRESIDENT:
- You've heard the motion. Senator Rock moves to suspend.
- 8. the rules for the purpose of the immediate consideration and
- 9. adoption of the resolutions just read by the Secretary. All
- 10. those in favor signify by saying Aye. Opposed. The Ayes
- 11. have it. The rules are suspended. Senator Rock moves the
- 12. adoption of the resolutions. All those in favor signify by
- 13. saying Aye. Opposed. The Ayes have it. The resolution...
- 14. resolutions are adopted. Senator Kosinski has asked leave
- 15. to have Resolution 299 read by the Secretary. Is leave
- 16. granted? Leave is granted. Mr. Secretary read...read the
- 17. resolution.
- 18. SECRETARY:
- 19. Senate Resolution 299 offered by Senator Kosinski and
- 20. all Senators.
- 21. (Secretary reads SR 299)
- 22. PRESIDENT:
- 23. Senator Kosinski.
- 24. SENATOR KOSINSKI:
- 25. Mr. President, it results in double sorrow because I
- 26. used to be a newspaper carrier in carrying the...newspaper,
- 27. Chicago Daily News and the American and also the Polish Daily
- 28. News. Mr. President, I now move for the suspension of the
- 29. rules and the immediate adoption of the resolution.
- 30. PRESIDENT:
- 31. Senator Kosinski moves for the suspension of the rules
- 32. for the immediate consideration and adoption of the
- 33. resolution. All those in favor signify by saying Aye.



- Opposed. The Ayes have it. The rules are suspended. Senator
- 2. Kosinski moves for the adoption of the resolution. All those
- 3. in favor signify by saying Aye. Opposed. The Ayes have it.
- 4. The resolution is adopted. ...
- 5. SECRETARY:
- 6. Senate Resolution No. 300 offered by Senator Mitchler,
- 7. Carroll, Berman and all Senators.
- 8. PRESIDENT:
- 9. Senator Mitchler.
- 10. SENATOR MITCHLER:
- 11. Yes, first of all, Mr. Secretary, if you would show Senator
- 12. Nimrod as the second sponsor along with Senator Berman. Mr.
- 13. President and members of the Senate, this is a little different
- 14. than a regular Congratulatory Resolution. The copies have
- 15. been placed on your desk. But what this resolution does, it
- 16. condemns the planned Nazi demonstration in Skokie and we condemn
- 17. the hatred and prejudice which the American Nazi Party epitomizes
- 18. and that we condemn the planned abuse of the sacred rites
- 19. guaranteed to all by the United States Constitution. And this
- 20. further resolves that we encourage the American Nazi Party to
- 21. desist in their planned demonstration and that we encourage.
- 22. the local government in Skokie to continue to search for ways
- 23. to prevent the demonstration in view of the damage to human
- 24. life and property that is sure to occur as a result of this
- 25. demonstration if it is held. A suitable copy of this
- 26. preamble will be presented to the village officials of the
- 27. Village of Skokie for acceptance on behalf of the Village
- 28. of Skokie. Mr. President, I would move that the rule be
- 29. suspended and that this resolution be considered immediately
- 30. and its adoption.
- 31. PRESIDENT:
- 32. ... Senator Mitchler. What purpose does Senator Egan
- 33. arise?

- 1. SENATOR EGAN:
- 2. Yes, thank you Mr. President. I...because of part of
- 3. that area is in my district, I'd like to know more about
- 4. this resolution, Senator Mitchler. I have not had an
- 5. opportunity to read it, although I've had it long enough, but
- 6. I've been too busy to read it. Would you explain it a little
- 7. more carefully so that I may understand it. I'm sure that
- 8. I...it's...
- 9. PRESIDENT:
- 10. Senator Mitchler.
- 11. SENATOR MITCHLER:
- 12. Yes, Senator Egan, I'll be very glad to go into detail.
- 13. I just...read the resolving clause. It has a number of
- 14. whereas clauses, but it alludes to the American Nazi Party
- 15. planning a demonstration in Skokie, Illinois, which is the
- 16. home of many of the survivors of the concentration camps of
- Nazi Germany of World War II and is in the heart of the
- 18. Jewish population of the State of Illinois. Now this planned
- 19. demonstration contravenes the true spirit of America in the
- 20. Constitution which stands for the creation of the home
- where all races and creeds are urged to live in peace and
- 22. harmony. America has been the haven for the persecuted
- 23. since the colonial period and many people sacrificed themselves
- 24. in the great effort to suppress the scourge of Nazism during
- 25. World War II and to free those peoples oppressed by its yoke.
- 26. And while the Constitution guarantees free speech, this right
- 27 ... is a limited one, it does not extend to purposes which
- 28. result in the incitement of riot and violence. The proposed
- 29. demonstration in Skokie will be an abuse of that right of
- 30. free speech and a deliberate effort at the provacation of
- 31. persecution. And therefore, this Body is resolving that
- 32. the Nazi party, the American Nazi Party desist in their
- 33. planned demonstration and we encourage the local government

- 1. in Skokie to continue to search ways to prevent the demon-
- 2. stration in view of the damage to the human life and property
- 3. that's certainly to occur if that demonstration is held. A
- 4. copy of the resolution would be presented to the village
- 5. officials of the Village of Skokie for acceptance on behalf
- 6. of the Village of Skokie.
- PRESIDENT:
- Senator Rock.
- 9. SENATOR ROCK:
- 10. Thank you, Mr. President. I suggest, Mr. President, that
- 11. this resolution should be properly referred to the Executive
- 12. Committee for a couple of reasons. One, the last resolving
- 13. clause encourages the Nazi Party to desist from an action,
- 14. and yet a suitable copy of this preamble and resolution is
- 15. not presented to them. I happen to think the...the village
- 16. officials of Skokie are well aware of this matter. They
- 17. do not need a resolution from us. Now, this has been a
- 18. subject of some quite great controversy regarding First
- 19. Amendment rights and I think it would be better served,
- 20. this Body would be better served, to have this matter heard
- 21. in the Executive Committee.
- 22. PRESIDENT:
- 23. Senator Mitchler, what is your pleasure?
- 24. SENATOR MITCHLER:
- 25. Well I...I have no objection...I...I don't see what...
- 26. what really would be resolved, Senator Rock, by having this
- 27. held until April 5th or there on until the Executive Committee
- 28. meets. The...the planned march would be over with. This is
- 29. just a demonstration of thought. I... I know of no objection
- 30. to it. I can't see where the Executive Committee would...would
- 31. vote down this resolution. It would ultimately pass and so
- 32. I would ask for immediate consideration and suspension of the rules
- 33. and adoption. And I also would ask for permissions to join

- 1. myself, Senator Berman, Senator Carroll, Senator Nimrod, who
- 2. are the lead sponsors to have all Senators join a sponsorship
- of this resolution.
- 4. PRESIDENT:
- 5. Senator Mitchler has asked leave to have all Senators
- 6. shown as...there seems to be some, all right, I...I would suggest
- 7. then any Senator wishing to be shown as a cosponsor of the
- 8. resolution should so and come down to the desk and so inform
- 9. the Secretary. Senator Mitchler, you're persisting in your...
- 10. your motion to suspend the rules? Senator Egan.
- 11. SENATOR EGAN:
- 12. Well, I don't know, what's the answer, I...
- 13. PRESIDENT:
- 14. There's a momentary pause, Senator Egan. Did you...
- 15. SENATOR EGAN:
- 16. I'd like to ask a question if he's going to persist.
- 17. PRESIDENT:
- 18. Senator Mitchler.
- 19. SENATOR MITCHLER:
- 20. What is the question?
- 21. PRESIDENT:
- 22. Are you...you intend to pursue your Motion to Suspend
- 23. the Rules?
- 24. SENATOR MITCHLER:
- 25. Well I...
- 26. PRESIDENT:
- 27. If we're not going forward with...with the matter today,
- 28. Senator Mitchler, it ought...we ought not to have any more
- 29. discussion. If you are going forward, then I think the
- 30. questions are in order.
- 31. SENATOR MITCHLER:
- 32. Put...put the question to the Body.
- 33. PRESIDENT:

- All right. Senator Egan has a question of the sponsor.
- Senator Egan.
- 3. SENATOR EGAN:
- 4. Yes, in the last where...whereas clause, you recite that
- 5. the proposed demonstration in Skokie will be an abuse of
- 6. the right of free speech and a deliberate effort of provocation
- 7. and persecution. Now what I want to know, Senator Mitchler, is
- 8. if, do you stand with those who believe that the right of free.
- 9. speech is not absolute and do you stand with those who believe
- 10. that the right...because the right of free speech is not
- 11. absolute, that the demonstration of the swastika among the
- 12. marchers would be offensive to the constitutional guarantee
- 13. and consequently, not protected by it?
- 14. PRESIDENT:
- 15. Senator Mitchler.
- 16. SENATOR MITCHLER:
- 17. You know that I'm a firm believer in the right of free
- 18. speech and all that goes with it. I am fully aware of the
- 19. court decision that would allow the American Nazi Party to
- 20. display their emblem and conduct this march. But as in the
- 21. fourth whereas clause of this resolution, it is pointed out
- 22. and I quote, "while the Constitution guarantees free speech,
- 23. this right is a limited one and does not extend to purposes
- 24. which result in the incitement to riot and violences." I
- 25. also believe in that, Senator Egan.
- 26. PRESIDENT:
- 27. Senator Egan.
- 28. SENATOR EGAN:
- 29. Well now let's...let...let, just a minute, now hold on
- 30. just a minute. I think it's important enought to discover
- 31. the meaning of the resolution and if the resolution says
- 32. that the constitutional right of free speech is not absolute.
- 33. And that what the Nazi Party intends to do is not protected

- 1. by the Constitution, then I want to support it, because I
- believe in the dissenting opinion in the State Supreme
- 3. Court case. And then I'll support the resolution. If that
- 4. is not what it says, then let's know what we're voting
- 5. on.
- 6. PRESIDENT:
- Senator Mitchler.
- 8. SENATOR MITCHLER:
- 9. Well, Senator Egan, I see nothing in the resolution that
- 10. would allude to your fear. And I say that sincerely, because
- 11. this does not say that they cannot have this right. There's
- 12. nothing in here that...that points it out. Now the...the
- 13. right to free speech is...is not just a...a right to...to
- 14. speak at all, in other words, the courts have pointed out,
- 15. you cannot shout fire in a theatre. Free speech is quaranteed
- 16. under the Constitution. But as pointed out in here, now this
- 17. does not say that this would prohibit them from conducting
- 18. the march. It just points out that...that we feel that it's...
- 19. it's a planned demonstration that incites hatred and prejudice
- 20. which the American Nazi Party epitomizes, and that we condemn
- 21. those types of activities. And I think for ... I can't see any
- 22. objection to this...this type of thing in all sincerity and
- 23. I...and I appreciate and recognize your...your question whether
- 24. the resolution goes farther than when I presented it to you.
- 25. And in my opinion it does not and I don't see where you should
- 26. have any fear, Senator Egan.
- 27. PRESIDENT:
- 28. Senator Berman.
- 29. SENATOR BERMAN:
- 30. Thank you, Mr. President. I stand in support of Senator
- 31. Mitchler's motion to waive the rules and for immediate
- 32. consideration. As a comment to Senator Egan, I've read this
- 33. carefully. I am...I've read it with a very critical eye

- 1. because it's an...in an area that I am very sensitive about
- 2. in consideration of the area of free speech. I think it is
- 3. well worded and I think it is in line with the dissent
- 4. the Supreme Court opinion and I agree also with the dissent.
- 5. I think that the majority opinion was insensitive to the
- 6. actual effect of the brown...brown shirts and the goose-
- 7. stepping and the swastika, the affect that those images
- 8. will have on the freedom, on the psychic image, on the
- 9. mental health of the residents that have, of Skokie, and
- 10. of other parts of our State, that have experienced the
- 11. terrible experiences of the concentration camps. I...many
- 12. of us may feel that the resolution doesn't even go far
- 13. enough. But I think it has been phrased carefully. I
- 14. think it is in recognition of our first amendment liberties
- 15. and yet, in my own opinion, just as one does not have the
- 16. right to yell fire in a crowded theatre, I do not believe
- 17. the Nazi's have the right to march with the swastikas in
- 18. Skokie. And therefore I stand in support of the motion
- 19. to waive the rules and for immediate consideration, adoption,
- 20. of this resolution.
- 21. PRESIDENT:
- 22. Senator Rhoads.
- 23. SENATOR RHOADS:
- 24. Senator Mitchler, is this controversy still at this
- 25. moment a matter of pending litigation or has that litigation
- 26. been resolved?
- 27. PRESIDENT:
- 28. Senator Mitchler.
- 29. SENATOR MITCHLER:
- 30. To my knowledge, Senator Rhoads, that litigation has been
- 31. resolved.
- 32. PRESIDENT:
- 33. Senator Rhoads.
- 34. SENATOR RHOADS:

26. SENATOR BUZBEE:

Thank you, Mr. President. This, of course, is one of those kind of issues could very easily be interpreted as the General Assembly or the Senate's being pro-Jewish or pro-Nazi, which, of course, it absolutely is not. It's... there's not one person in this Body that is advocating a pro-Nazi stance, I'm absolutely sure of that. But it is a very complicated issue. And again it was my understanding

- we kind of had a...I was just checking the rule book, it's 1. 2. not in the rules, but...that I can find anyhow, but we kind of had a gentlemen and ladies agreement that in a hurried 3. 4. situation like this we only would take congratulatory type resolutions. Other resolutions of...of more serious impact 5. or perhaps of some controversy, would be considered by the 6. Executive Committee. Now, quite frankly, we're going to 7. be back here on the 5th of April. This march is not due 8. to take place, I believe, until the 19th. I would like to 9. see the Executive Committee give due consideration to this 10. and maybe we'll all vote unanimously for it, I don't know. 11. But goodness, Senator Mitchler, you've...you've laid this 12. on our desk. It is, as Senator Egan has pointed out, the 13. question of...of the First Amendment, the freedom of speech 14. is...is...is arisen here and I think that those members of 15. the Executive Committee ought to give due deliberation to 16. this resolution before this Body as a whole has asked to 17.
- 19. in Skokie either. But I do think that we ought to give
- 20. additional consideration through the...through the standard

- Well, I take it then that the final whereas clause

- 34. Senator Ozinga.

- 1. SENATOR OZINGA:
- I've listened to both sides of this story and I was just...
- 3. it was just called to my attention just a few minutes ago that
- 4. Senate Resolution No. 97 which passed this Body on...was intro-
- 5. duced into this Body and put on the Consent Calendar on
- 6. April 21st, 1977 and an identical resolution was passed on
- 7. April 22nd. Now I think this is a duplication and at that
- 8. time there was not nearly as much controversy regarding this
- 9. subject matter. So I would respectfully suggest that it
- 10. does go to the Executive Committee.

- 12. Senator Harber Hall.
- 13. SENATOR HARBER HALL:
- 14. Well, I...I was prepared to vote in favor of the
- 15. immediate consideration and the passage of the resolution p_{ij}
- 16. but Senator Egan has instituted a question with which I
- 17. disagree with because I support the majority in the Supreme
- 18. Court Case...affecting this and so by his stating on the
- 19. Floor that the last whereas clause should be interpreted
- 20. as a dissention from the majority in the Supreme Court case.
- 21. He places me in the unfortunate position of disagreeing at
- 22. least with him. And if it's the interpretation of others,
- 23. them I would have to vote against it, but I would make this
- 24. additional statement in regard to the resolution. It seems
- 25. to me that the distinguished Body in the State Senate to
- 26. take any action regarding a small band of ridiculous demon-
- 27. strators whatever their philosophic approach to government

3. SENATOR NIMROD:

4. Yes, Mr. President and fellow Senators, I can't let this 5. subject come up without at least saying something on the 6. Floor since I am very vitally involved and concerned about 7. it since the President of the B'nai Brith of the Survivors 8. of the Holocaust is a very personal friend and one I've 9. been working with very closely. And as was indicated 10. certainly we did take some action in...in April on Senate 11. Resolution 97. But I do want us to know this is a real 12. problem and it is going to cause some concerns in the 13. coming month. And whatever this Body wants to do, it's 14. something that's of great, great concern to every American 15. and I think that we ought to be aware that there are some 16. real fears of...of the things that can happen. I know that many of the officials in Skokie and many of the leaders 17. within the Jewish community and...and certainly those who 18. are involved, the leaders within the survivals group, 19. and are...are planned .. making plans now to have some sort 20. of demonstration. I would hope that would certainly be 21. one that all Americans can join in rather than something 22. as ridiculous as that which we seemed to have preoccupied 23. the Supreme Court. I would hope that we could resolve 24. this reasonably and that we do understand what we're 25. voting on. I certainly am opposed to their presentation 26. and their appearance in the Village of Skokie and of making 27. a direct confrontation to those two or three thousand survivors 28. and claiming that it's...it's the right, the First Amendment. 29. I can tell you first of all, there will be bloodshed and 30. there will be a confrontation if this is allowed to continue. 31. And I think whatever actions take from there, have to be that 32.

which we have to do in the right spirit of the American way.

- 1. I am very concerned about it. I think it's a serious thing
- 2. that we're embarking upon and that we ought to be sure of
- 3. what we're doing. I support the concept of the resolution
- 4. and if it comes to a vote, I will support it.
- 5. PRESIDENT:
- 6. Senator Shapiro.
- 7. SENATOR SHAPIRO:
- 8. Well Mr. President and Ladies and Gentlemen of the
- 9. Senate. I think what the point that a lot of you may be
- 10. missing is that a group that has been...that have been
- 11. victims of persecution do not understand delay, legal jargon,
- 12. moral arguments about why this resolution should be passed
- 13. or...or not passed. I personally think it's a good resolution
- 14. and this Senate should pass it and not sit down here and
- 15. fiddle while these people mentally are burning. If it does
- 16. nothing else, it will give aid and comfort to a small group
- 17. who are victims of persecution thirty and forty years ago
- 18. and I think the Senate ought to get about its business
- 19. and pass the resolution. There's nothing wrong with it.

- 21. Senator D'Arco.
- 22. SENATOR D'ARCO:
- 23. I remember when Martin Luther King marched in Cicero
- 24. and there was a big ado about then, there was much throwing
- 25. of rocks and debris around and it was a very dangerous
- 26. volatile situation. But I don't think anybody in the liberal
- 27. environment was saying at that time that he should be denied
- 28. that right to march in Cicero for whatever cause he thought
- 29. was just and right at that particular time. And I think as
- 30. soon as we start making distinctions about whether a group
- 31. has a right to march in a particular area as opposed to
- 32. another group not having a right to march because one
- 33. groups cause is right and the other groups cause is not right,

l. we get into a very fuzzy area, that I for one, am not able 2. to pinpoint it to what is right and what is not right. And 3. I think the First Amendment right to free speech is there for 4. that particular reason. That we as individuals can't make 5. that decision as to what we think is right or what we think 6. is not right. So I would rather see this resolution go to 7. Exec, have it heard and come back and vote on it. Thank you.

8. PRESIDENT:

9. Senator Carroll.

SENATOR CARROLL:

11. Thank you, Mr. President and Ladies and Gentlemen of the 12. Senate. While we seem to have had an enlightened debate 13. on the Floor of the Senate today on this resolution, which 14. in my opinion would thereby now obviate the need of this resolution to go to committee, since we have functioned 15. as a Committee of the Whole and because of some of the 16. 17. comments made. I think that my rising is now in total 18. support of the resolution. Not only as a cosponsor, as I had originally indicated, with no opposition, to a 19. 20. full hearing. But I think some points must be made. There is a difference of opinion on what the First Amend-21. ment means. We all recognize that. It has been tried in 22. 23. the courts. It is my understanding and hope that the Village of Skokie will be appealing that decision in the 24. Federal Courts. So that the opinion rendered by the 25. 26. Illinois Supreme Court and the Federal District Court is not the final word of the law in the land on what is the 27. rights of the people to free speech and to peaceably assemble 28. and to have their own libery protected. What you're asking 29. though is not only the six million who died, who happened to 30. have been Jewish, what about the six to ten million who weren't 31. Jewish, who also died during the holocaust of World War II. 32. Ask anyone who has been to any of these camps. Ask anyone

- 1. who served in the Armed Services who saw the results of these
- 2. camps. About the eighteen to twenty-five million people, Jew
- 3. and non-Jew alike, who died as a result of the activities of
- 4. what was then the Nazi Party of Germany. What we're really
- 5. saying here, we have asked these people who came to our land,
- 6. the survivors of the holocaust, Jew and non-Jew alike.
- 7. And we have met with the priests and ministers of Skokie.
- 8. The mayor of Skokie and other village officials who happened
- 9. to be non-Jews. Ask these people who were told once, oh,
- 10. ignore them, let them march, let them walk around, they don't
- 11. mean anything, and who then lost their families and were
- 12. lucky enough to come to this country and start new families and
- 13. you're asking them again to ignore that which they ignored
- 14. thirty and forty years ago, with the same assurances, the
- 15. same assurances that they received thirty and forty years
- 16. ago, so that their second families and their minds possibly
- 17. could be destroyed again. They were sure in the 30's
- 18. that the goose step meant nothing, that the Nazi Party was
- 19. nothing, would not be a...a form of terror to them. They
- 20. were sure of that when they were captured. You're asking
- 21. them again to turn their backs. They won't. We should not
- 22. either. I think we have the obligation now to say, as
- 23. Senator Mitchler has said to the Village of Skokie, we
- 24. stand behind your administration in attempting to protect
- 25. all of the seventy thousand residents of Skokie and all of
- 26. the people of the State of Illinois in saying there is a
- 27. right to peaceably live. Live without terror. Live without
- 28. fear. Yes, there's a right to redress your grievance. Yes,
- 29. there's a right to peaceably assemble, but there is some
- 30. limits on free speech where the obvious intent is to incite
- 31. a riot. I think we, as the elected people of the State of
- 32. Illinois, have to speak on this issue and have to speak now
- 33. and I would urge adoption of the resolution.

1. PRESIDENT:

- Senator Mitchler has moved for the suspension of the
- 3. rules for the immediate consideration of Senate Resolution 300.
- 4. All those in favor...Senator Rock.
- 5. SENATOR ROCK:
- 6. Well, Mr. President, I persist in my suggestion. I think
- 7. the proper place to hear the debate is in the Committee on
- 8. Executive. We do, in fact...we are, in fact, involved with
- 9. the rights under the First Amendment. And while I certainly
- 10. will stand in disagreement with Senator Carroll and certainly
- 11. not the feelings of those persons involved. The fact of the
- 12. matter is that the Supreme Court of our State has ruled that
- 13. these persons are well within their rights to have this kind
- 14. of demonstration. And to adopt this at this time without
- 15. the kind of hearing that should and could be had under not
