33. Mr. President, I request the same permission and I have

1. PRESIDING OFFICER: (SENATOR BRUCE)
2. Senator Bowers and Senator Walsh. Is there
3. leave? Leave is granted. ...purpose does Senator
4. Graham arise?
5. SENATOR GRAHAM:
6. I would like to make a request of Senators Rock,
7. Daley, and Walsh. Senators Rock, Daley and Walsh,
8. could you meet in my office after we adjourn for a couple
9. of minutes, please? Thank you.
10. PRESIDING OFFICER: (SENATOR BRUCE)
11. ...purpose does Senator Vadalabene arise?
12. SENATOR VADALABENE:
13. Yes, Mr. President, just a point of information,
14. I've been wanting to ask this question for some time and
15. it has nothing to do with the...or the Senators who just
16. got on these bills, this involves me personally. I would
17. like to know when someone gets up on the Floor of the
18. Senate, and says I want to be on Senate Bill so and so,
19. does he have to ask the sponsor before he can do that or
20. can he do it just on his own?
21. PRESIDING OFFICER: (SENATOR BRUCE)
22. It has always been a courtesy, Senator Vadalabene,
23. but I don't believe our rules reflect that you have to have
24. permission of the sponsor. Senator Vadalabene.
25. SENATOR VADALABENE:
26. Well, I noticed you...you always ask, do I have leave.
27. You're asking leave of the entire Body, or are you asking
28. leave of the sponsor?
29. PRESIDING OFFICER: (SENATOR BRUCE)
30. Well, it's always been a courtesy of the Presiding
31. Officer to ask leave of the Body to add a...add a member.
32. Again, that is a courtesy extended to the Body, not
33. necessarily within our rules. Senator Vadalabene.
34. SENATOR VADALABENE:

1. Yes. So that anyone can get on your bill without
2. permission and it's just a general statement by you,
3. can I have leave by who is ever presiding, right?

4. PRESIDING OFFICER: (SENATOR BRUCE)

5. That has been the general procedure. But, we also...
6. most of the Senators will ask the sponsor and then ask
7. leave on the Floor to be added as a cosponsor.

8. SENATOR VADALABENE:

9. Well, it would be...

10. PRESIDING OFFICER: (SENATOR BRUCE)

11. Senator Vadalabene.

12. SENATOR VADALABENE:

13. ...most embarrassing if the...the person or the Senator
14. who asked to get on the bill, would be very embarrassing
15. to the sponsor to say No after he's already had leave.
16. And I thought I would make this observation.

17. PRESIDING OFFICER: (SENATOR BRUCE)

18. To my knowledge, Senator Vadalabene, there's never
19. one...never has anyone asked to be removed as a cosponsor,
20. so we usually don't have an objection. Senator Harber
21. Hall.

22. SENATOR HARBER HALL:

23. Well, I could correct the President in reflecting back
24. a few years ago, when I and twenty-two other House members
25. asked to be removed as cosponsors of the Equal Rights
26. Amendment.

27. PRESIDING OFFICER: (SENATOR BRUCE)

28. That occurred in the House and there's many strange
29. things happen over there. Senator Regner.

30. SENATOR REGNER:

31. Yes, Mr. President and members of the Senate, I have
32. checked with the sponsor of Senate Bills 214, 215, 216,
33. would like to ask leave to be added as a cosponsor.

12. Senator Harber Hall.
13. SENATOR HARBER HALL:
14. Mr. President and fellow Senators, particularly
15. the new Senators who may not have had the opportunity
16. to meet or to know especially Tec Clarke. I was Tec's
17. seatmate for the past four years and more importantly than
18. that I had the privilege to serve with him on two committees
19. and the Legislative Audit Commission of which he was the
20. Chairman. All of us recognize good work, even those of us
21. who do not always produce good work, we certainly recognize
22. it in others and Tec Clarke, to me, represents the
23. personification of good, hard, honest legislative work
24. every day and whether in Session or whether
25. at home in his home district, here was a good legislator.
26. Now, having retired from this Body I just want you to support
27. this resolution and recall Tec Clarke and the good work
28. he did. Thank you, Mr. President.

1. adopted. Senator Hynes. Senator Hynes. On the order

10. PRESIDING OFFICER: (SENATOR BRUCE)

11. Senator Hynes.

12. SENATOR HYNES:

13. Mr. President and members of the Senate. It gives me
14. a great deal of pleasure to introduce and sponsor this
15. resolution because it pays, I think, a fitting tribute
16. to our senior colleague, Senator Fred Smith, a warm
17. human being, a man that we all love, a man that I consider
18. a very close, personal friend. I think that those of us
19. who have worked with Senator Smith are well aware of his
20. qualities, of his concern for people, of his concern for
21. the legislative process, of his integrity, of his ability,
22. but I think most of all, we admire and respect Senator
23. Smith for his human qualities, for the compassion and
24. concern that he shows for everyone that he meets from the
25. highest to the lowest, from the average citizen in this
26. State to the Governor of this State. I think Senator
27. Fred Smith is someone that we can all emulate and someone
28. that we can all be proud of. His accomplishments over these
29. many years would take hours to describe. His role in the
30. successful passage of FEPC legislation and the improvements
31. in the...in that...in initial legislation, I think, by them-
32. selves, are a justification for the tribute we are paying
33. here, but he has done things in other areas of equal

1. significance. He has been concerned about State government.
2. He has spent thirty-four years and is now in his thirty-
3. fifth year as a member of this Body. It is a record of
4. accomplishment and achievement that I doubt very much
5. if any other member of the Senate will achieve. I really
6. think it...that he stands as the Babe Ruth of the legislative
7. process. He is a man that I think is a, in one sense of the
8. word, what we would all strive to be. And I am very
9. pleased to offer this resolution and to move its adoption.

10. PRESIDING OFFICER: (SENATOR BRUCE)

11. Senator Ozinga.

12. SENATOR OZINGA:

13. Mr. President, members of the Senate. I would be
14. remiss if I didn't take the opportunity to say just a word
15. or two about my favorite colleague. Senator Smith and I,
16. I feel that I have probably worked with him longer than
17. anybody else on this Floor. Having worked together
18. for the last twenty-one years, sometimes with, sometimes
19. in opposition to, but at all times, friendly. There's
20. one question that I raised in my mind when I heard that
21. resolution. I believe the resolution says that he has been
22. honored for the length of service. I wondered if that
23. might be remiss and it should be the length of his speeches.
24. As you all know, Smitty, endeared calling him that,
25. I've always liked to call him Smitty, because he smokes
26. those big, black cigars that will drive you closer than
27. nearer, but he has always been, as has been said,
28. a champion of human rights. We have gone down the line
29. together. I have been blessed to have been channeled
30. in Mental Health and I could always count on having the
31. Senator right at my side to champion those propositions
32. that came up and from both sides of the aisle, I know that
33. we wish him well. Not to end his career, as sometimes these

1. resolutions say, but may his next birthday be at the
2. Fourth of July, really be a popping success. I...

3. PRESIDING OFFICER: (SENATOR BRUCE)

4. Senator...

5. SENATOR OZINGA:

6. I believe that no man on this Floor earns better
7. or more accreditation than what this resolution does and I
8. am more than happy to join in its presentation.

9. PRESIDING OFFICER: (SENATOR BRUCE)

10. Senator Chew.

11. SENATOR CHEW:

12. Thank you, Mr. President. Fred Smith is a man that
13. really lives in a house by the side of the road and he's
14. a friend to mankind. I suppose many glowing things could
15. come from many of us about the good or the long time of
16. service that he has given and the devotion that he has to his
17. family. But, I've had the honor of sort of being coached by
18. Fred and if I have been given any bad advice, I've
19. accepted that as it was good, it's the kind of confidence
20. and respect that I've had for him. I recall when he
21. suffered a tragedy in his family. I had the privilege
22. of being at his side, both day and night, giving of myself
23. to one that truly deserved it. I occasionally go to his
24. home and his lovely wife is busy trying to make her guests
25. comfortable. In his community, just to see him walk down
26. King Drive, the people still come out of their homes to greet
27. him. It could have been different because they could
28. have gone back into their homes to avoid him. But, his
29. reputation over the many years say to the people that he
30. is the kind of person that they enjoy knowing. Mr.
31. President, just think of thirty-five years of public
32. service as an elected official is longer than many of us
33. that are here are old. I recall when I got out of school

1. I suppose it was during the era where you sought out men
2. that were doing things and I knew that Fred Smith was
3. allied with the late honorable Congressman William L.
4. Dawson whom I had a great deal of respect for. And back
5. in those days, they were like twins. They were
6. constantly together doing things for the people of not only
7. Illinois, but the United States. Fred, it's a pleasure
8. to...to know you. I hope we can know each other for
9. many years to come. I don't think you will fade away
10. because your services are so necessary. If I can
11. in any way come near to the time of service you've given
12. and if I can either accumulate and try and maintain
13. the integrity in which you've shown, I think I will have
14. emanated a man who was always my idol. You are seldom
15. equal and really you never excelled. Thank you.

16. PRESIDING OFFICER: (SENATOR BRUCE)

17. Senator Graham.

18. SENATOR GRAHAM:

19. Mr. President, after following Senator Chew, there's not
20. much more to be said. I am glad to know that he's still
21. in the age bracket of thirty-five. I compliment him for that.
22. Some eighteen years ago, I came to the Illinois State Senate.
23. Those were the days when the freshmen Senators had to spend
24. about six weeks around here before they told them where
25. the bathroom was and some of the gentlemen of the Senate
26. that were here then, Senator Fred, and you remember
27. them well, were the finest people on God's green earth.
28. Full of...hearts full of compassion, understanding,
29. kindness and a willingness to help a young legislator who
30. had just, prior to being sworn in during a campaign, had
31. conceived the idea that he had all of the problems of the
32. State solved, if he didn't, he would find out the answers
33. soon. When we arrived here, we found out that wasn't true.
34. And we depended upon men like Fred Smith, Dick McBroom,

1. T. Mac Downing. Those great giants who were willing to
2. talk to us as men, regardless of party affiliation
3. and to try to help us in our new careers so that we could
4. become effective legislators, respected by our colleagues
5. and by our constituents. Fred Smith was one of those
6. men. I had many problems, legislatively, with Fred Smith.
7. He and I wound up on the opposite sides of several issues.
8. Our debates were quite animated at some times. Our
9. sincerity was never challenged by one to another. I
10. respected his position and knew of his dedication. He
11. respected my position and knew of my motivation. Through
12. the years I presume as age takes over and youth and vigor
13. seems to leave, we sort of mellow to a great extent.
14. And when the record of this legislator is written
15. and when the names of those great men on the other side and
16. on this side of the aisle are included in that record,
17. among those names will certainly be the name of the
18. gentleman from Chicago, Senator Fred Smith. My life will
19. have always have been better for having known him and known
20. of his concern for my health and many other problems that he
21. and I have shared together. Senator Fred, God bless you.

22. PRESIDING OFFICER: (SENATOR BRUCE)

23. Senator Shapiro.

24. SENATOR SHAPIRO:

25. Well, Senator Smith, I just want you to know that
26. this side of the aisle joins in extending our wholehearted
27. congratulations. There has been much said here today and a lot
28. more that could be said, but believe me, I think a little
29. has to be said because your actions over the years probably
30. speak louder than any of the words stated here today.
31. I think that's well evidenced by the fact that you have been
32. returned by your constituents time after time to serve them
33. in the General Assembly and it speaks well to the fact that

1. you have served your party and your colleagues and your
2. constituents to the point where they have no quarrel with
3. your tenure here in the General Assembly. I think I can
4. speak for everyone on this side of the aisle in telling our
5. newer members and our freshmen members that you have a lot of
6. good advice to offer them, if they only seek it from you.
7. And in closing, again, our heartiest congratulations.

8. PRESIDING OFFICER: (SENATOR BRUCE)

9. Senator Carroll.

10. SENATOR CARROLL:

11. Thank you, Mr. President and members of the Senate.
12. As a member of that class that was born during the time
13. that Senator Smith sought and received the accolades of the
14. public to begin his service in the Legislature, I wish to
15. join entirely. I am a member of that class unlike some
16. of the prior spokesmen to join in this resolution and to add
17. just a few brief comments to those so well made already.
18. Having served here in the Senate, I have learned that
19. longevity isn't always a great thing. In this case, I think
20. all of us agree that it's clearly the greatest thing.
21. We have spoken of Fred as our Dean. We now make this
22. an official action. And I think, at least I feel, that
23. I join in this for three basic reasons. Fred and his wife
24. have shown us through their family life style what it means to
25. have respect, what it means to have a commitment, and what
26. it means to be charitable. I think he and his...as he refers
27. to her as his lovely bride, have shown us throughout their
28. whole life both in their service in the Legislature and I say
29. their service, and in their service to their community and to
30. their faith what it is to have respect, to have commitment
31. and to be charitable. I join in those here who wish to
32. emulate those qualities and to wish him many, many more years
33. of the health and strength to serve, not only the people of his

1. district, but of the State of Illinois. Thank you.

2. PRESIDING OFFICER: (SENATOR BRUCE)

3. Senator Vadalabene.

4. SENATOR VADALABENE:

5. Yes, thank you, Mr. President and members of the
6. Senate. I think I feel sort of obligated to mention
7. something about our honoree who is being honored today
8. by our colleagues on the Floor of the Senate. I served
9. on committees with Senator Smith. I have been on
10. commissions with Senator Smith and I've traveled up
11. and down the State on different assignments where Senator
12. Smith attended. He has the respect and the admiration
13. of people all over the State of Illinois. I've never
14. witnessed anything in my life. I've tried to pattern
15. myself a little bit after our colleague and you know at
16. times I seem to get my neck a little out of joint and who
17. comes to me to quiet me down, but Senator Fred Smith. He not
18. only quiets me down, but he reports to me that I'm doing
19. better from time to time. So, I have referred to him for
20. the past four years, Mr. President and members of the
21. Senate, as Mr. Chairman of all of us and I really respect
22. and love the man. And God bless him. Thank you,
23. very much.

24. PRESIDING OFFICER: (SENATOR BRUCE)

25. Senator Maragos.

26. SENATOR MARAGOS:

27. Mr. Speaker...correction. Mr. President and members
28. of the Senate, you can see by my opening remark and error
29. at that time that I'm a neophyte in the Senate and I think
30. I can speak for the freshmen class, since I've had the
31. privilege of being an office mate of Senator Smith's for
32. four or five months and also to know him through the eyes
33. of a man who, if he were alive, would have praised him highly

1. and that is my predecessor in office, Senator Daniel
2. Dougherty. I could say without any equivocation that Senator
3. Dan, who was a classmate, if I may use the term, of Senator
4. Smith, who shared the offices together for many years
5. often talk about Senator Fred Smith in the highest terms.
6. He respected him very highly. And since I've had the
7. opportunity to serve and know Fred Smith, I echo his remarks
8. and his pride and his justification and thinking of him
9. as one of our outstanding Senators and Mr. Dean, it
10. gives me pleasure to say a few words on your behalf today.

11. PRESIDING OFFICER: (SENATOR BRUCE)

12. Senator Hynes asks leave of the Body for suspension of the
13. rules and the immediate consideration and adoption of the
14. resolution. Is there leave? Leave is granted. Senator
15. Hynes moves the adoption of the resolution, Senate Resolution
16. No. 49. All in favor say Aye. Opposed Nay. The Ayes
17. have it. Congratulations, Senator Smith. Senator Smith.
18. SENATOR SMITH:

19. Mr. President and Ladies and Gentlemen of the Senate.
20. Senator Ozinga, I pledge you and the membership here I will
21. not talk longer than two minutes, at the very most. The
22. only reason I rise, Mr. President, is for the reason that
23. I believe that you of this Body having heard as I did, the
24. remarks of those who have preceded me on the Floor,
25. would consider me to be altogether devoid of human feelings
26. and human emotions. Did I not acknowledge here and now
27. publically what your words and your actions of this day
28. will mean to the people of my ethnic group. I recall, Mr.
29. President, as I stand here, that years ago after I had
30. succeeded, you had one member of my ethnic group in here
31. at that time. We didn't have the advantages that you have
32. now, those of my people who have come here in subsequent
33. years. As Senator Graham intimated as soon as the prayer

1. had ended, and may I hasten to add that if the minister
2. prayed too long, he didn't come back because we were
3. anxious at that time to get at each others throats
4. presenting our views with regards to the matters
5. then and there before this Body. So, I say I recall years
6. ago after that legislation had passed this Body, I was at
7. my seat and tears were falling down my cheeks. Subsequent,
8. thereto, the then Assistant Leader of the Republican party
9. on the last night of the Session offered a resolution
10. with regards to the attempted services of this, your
11. humble servant. That resolution is hanging on the walls
12. together with many, many others in what we are pleased
13. to call the Smith minor living room in Chicago. I should
14. publically thank my old pal, Senator Chew, for the
15. kindly reference to what happened, the tragedy,
16. when my son, one of the finest lads ever to walk the streets
17. of the City of Chicago was shot and killed. I wish you
18. hadn't mentioned it, Chew, I wish you had not. But,
19. I look over this Body and I see sitting way back over there
20. Senator Soper. You will recall, Senator Mohr who used
21. to sit here, Senator Clarke. I didn't get it who it was,
22. but somebody offered a resolution prior to this one relating
23. to the passage of Senator Clarke and others came to my
24. home. Their presence there softened the blow, if it's
25. possible to ever to soften the blow like that and I passed
26. that. I thank those who have made kindly reference to my
27. wife. She is somewhere on the highway now enroute
28. here. I had hoped when I got on that train and did recall
29. that when I was a lad down in Tennessee...I'm not forgetting
30. the two minutes, Senator. That's a minute and a half now,
31. isn't it? When I was a lad down in the hills of east
32. Tennessee, they used to bring out a little phampton which they
33. called the slow train through Arkansas. If they were writing

1. today, they would write about the slow train in the
2. State of Illinois. I boarded that train about eight
3. o'clock this morning and got off here at the station,
4. was surprised to see little David who stands back there with
5. my very capable secretary, waiting to escort me here to
6. these Chambers. As I said, my wife is somewhere on Route
7. 66 or 55 enroute here together with my cousin, another
8. fine young man, a businessman, one of the most successful
9. of the younger generation in the City of Chicago. I could
10. wish that she had been here, gentlemen, and had I known
11. that this was to happen, she would have been here. We work
12. as a team, as has been intimated here and that wherever
13. civilized man is, that girl has been. She's rendered a great
14. service to humanity. Her husband, in his quiet way, is
15. trying to make a worthwhile contribution. I don't know
16. how many of you know that I write a little poetry and I
17. remember once when Bill Dawson, to whom someone made
18. reference here, was it you, Chew, made reference and I
19. may tell you why this occasion arose, later. But while
20. waiting for him, I wrote my resolve to live as gently
21. as I can, to be no matter where, a man, to take what comes
22. of good or ill and cling to faith and honor still. To
23. live undaunted, unafraid of any step that I have made.
24. To be without pretense or sham exactly what Chicago thinks
25. I am. I'm grateful to each of those of you who have seen
26. fit to participate here in these kindly remarks. To others
27. who did not, you, too, have my kindest felicitations.
28. I thank you, I thank you, I thank you.

29. PRESIDING OFFICER: (SENATOR BRUCE)

30. Senator Johns, you had an announcement.

31. SENATOR JOHNS:

32. Yes, I do, Mr. President. I'd just like to remind the
33. Senators of the Democratic party that there is a caucus at

1. 10:15 tomorrow morning. 10:15. Thank you, again, Mr.

2. President. In the President's office.

3. PRESIDING OFFICER: (SENATOR BRUCE)

4. Senator Smith.

5. SENATOR SMITH:

6. Mr. President, I have talked with my leader on this

7. side and I know that I bespeak the sentiments of the

8. Minority Leader because he is a party to what I am about

9. to say. I...I ask or move that we return to Senate

10. Bills on 2nd reading for the purpose of calling Senate

11. Bill 61. I should like to have that bill advanced to 3rd reading.

12. PRESIDING OFFICER: (SENATOR BRUCE)

13. Is there leave to return to the order of Senate

14. Bills, 2nd reading? Leave is granted. Senate Bill 61,

15. on the order of 2nd reading. Read the bill, Mr. Secretary.

16. SECRETARY:

17. Senate Bill 61.

18. (Secretary reads title of bill)

19. 2nd reading of the bill. No committee amendments.

20. PRESIDING OFFICER: (SENATOR BRUCE)
