- 18. The...they were Senate Bills 33, 101, 108, 120,
- 19. 302, and then House Bill 49, I would have voted...let the
- 20. record show that I would have voted Yes if I were on the
- 21. Floor yesterday.
- 22. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 23. The record will so show. Senate Bills, 2nd reading.
- Senate Bill 100, Senator Knuppel. Senate Bill 164, Senator
- Hickey. Senate Bill 166, Senator Regner. Call the bill.

- 27. Senate Bill 166.
- 28. (Secretary reads title of bill)
- 29. 2nd reading of the bill. Committee on Transportation
- 30. offers one amendment.
- 31. PRESIDING OFFICER: (SENATOR KENNETH HALL)

- 18. Yes, Mr. President. I'd like to withdraw that
- 19. amendment. That was prepared by our staffs and we found
- 20. errors in it and I just sent another amendment up that
- 21. clarifies the whole thing.
- 22. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 23. Senator, will you explain this amendment? Wait a
- 24. minute, Senator. Just a moment. Could we have a little
- 25. order, please, or a whole lot of order. Go ahead, Senator.

- 27. Okay, the one I just sent up there, what it does, it
- 28. incorporates Committee Amendment No. 1 which just reversed
- 29. the order that the bill was presented in. It has the
- 30. explanation or description of headset receivers in the
- 31. first paragraph rather than at the end which is the
- 32. normal order for legislation. And then it also further defines
- 33. the term "headset receivers." There was some question
- 34. in committee that it was talking about ear plugs and such and

- 1. this totally defines the description of headset receivers
- 2. and it was prepared in conjunction with both staffs,
- 3. Republican and Democrat and I would now move the adoption
- 4. of Amendment No. 2 to Senate Bill 166.
- 5. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 6. Senate will be at ease just a moment. Is there any
- 7. further discussion for Amendment No. 2 to Senate Bill 166.
- 8. before adoption? All those in favor of the adoption of the amendment say
- 9. Aye. Opposed. The Ayes have it. And Amendment No. 2
- 10. is adopted. 3rd reading. Senator Hickey, would you like

- 32. SENATOR MOORE:
- 33. Thank you, Mr. President, members of the Senate.

- 1. Senate Bill 62...Senate Bill 62 and 63, the Synopsis
- 2. correctly describes what they do. Senate Bill 62
- 3. authorizes the Capitol Development Board to convey a
- ten foot strip of land on either side of a sewer that
- 5. connects to the Grissom Junior High School in Tinley Park.
- 6. to the village of Tinley Park so that the village can
- properly maintain the sewer. There's no cost involved
- to the State. This project was done all at one time
- 9. and it's for that reason that we are now trying to get
- 10. a easement now for a sewer and the following bill which
- 11. is a thirty-three foot strip of land for a road. If there
- 12. are no questions, Mr. President, I move for a favorable
- 13. roll call on Senate Bill 62.
- 14. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 15. Any further discussion? The question is shall Senate
- 16. Bill 62 pass. Those in favor vote Aye. Those opposed
- 17. vote Nay. The voting is open. Have all voted who wish?
- 18. Take the record. On that question, the Ayes are 54,
- 19. the Nays are none, those Voting Present are none and the
- 20. members...and five members are recorded absent. Senate Bill
- 21. 62 having received the constitutional majority is declared
- 22. passed. Senate Bill 63, Senator Moore.
- 23. SECRETARY:
- 24. Senate Bill 63.
- 25. (Secretary reads title of bill)
- 3rd reading of the bill.
- 27. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 28. Senator Moore.
- 29. SENATOR MOORE:
- 30. Thank you, Mr. President, members of the Senate.
- 31. Senate Bill 63 authorizes the Capitol Development Board to
- 32. convey a thirty-three foot strip of land adjacent to a road
- 33. now serving the Kirby School in the village of Tinely Park

- 1. to the village of Tinley Park. This road is going to be
- 2. improved at the...at no cost to the State. The village will
- 3. put in the road. It will maintain it. I know of no
- 4. objection to the bill and I'd appreciate a favorable roll call.
- 5. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 6. Any further discussion? The question is shall
- 7. Senate Bill 63 pass. Those in favor vote Aye. Those
- 8. opposed vote Nay. The voting is open. Take the record.
- 9. Have all voted who wish? Take the record. On that question,
- 10. the Ayes are 52, the Nays are none, those...none Voting
- 11. Present. Senate Bill 63, having received the constitutional
- 12. majority is declared passed. Senate Bill 93, Senator
- 13. Donnewald. Read the bill.
- 14. SECRETARY:
- 15. Senate Bill 93.
- 16. (Secretary meads title of bill)
- 17. 3rd reading of the bill.
- 18. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 19. Senator Donnewald.
- 20. SENATOR DONNEWALD:
- 21. Yes, Mr. President. Senate Bill 93 is...it just adds
- 22. coal and coal testholes to the section which refers to the
- 23. application for drilling holes. You presently have to have
- 24. a permit to drill water wells, oil wells and so on
- 25. but you do not have to have a permit to drill a test
- 26. core hole for coal. This merely adds coal to the list
- 27. that I have enumerated and the permit would be applicable
- 28. to drilling test core holes for coal. I would ask your
- favorable support. The Department requested this legislation.
- 30. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 31. Any further discussion? The question is shall Senate
- 32. Bill 93 pass. Those in favor vote Aye. Those opposed
- 33. vote Nay. The voting is open. Have all voted who wish?

- 1. Take the record. On that question, the Ayes are 54, the
- Nays are none, none Voting Present. Senate Bill 93
- having received the constitutional majority is declared
- 4. passed. Senate Bill 99, Senator Knuppel. Senator Knuppel.
- 5. Senate Bill 182, Senator Davidson. Call the bill.
- 6. SECRETARY:
- 7. Senate Bill 182.
- (Secretary meads title of bill)
- 9. 3rd reading of the bill.
- 10. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- Senator Davidson.
- 12. SENATOR DAVIDSON:
- 13. Mr. President, members of the Senate, this bill
- 14. allows the Water and Sewer districts, which are not part
- 15. of a municipality and voluntary opportunity participate
- 16. in the Illinois Municipal Retirement Fund. It has the
- 17. favorable support of the Pension Laws Commission. I'll
- 18. answer any questions. Appreciate a favorable vote.
- 19. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 20. Any further discussion? The question is shall Senate
- 21. Bill 182 pass. Those in favor vote Aye. Those opposed
- 22. vote Nay. The voting is open. Have all voted who wish?
- Take the record. On that question, the Ayes are 45,
- 24. the Nays are 4, 2 Voting Present. Senate Bill 182, having
- 25. received the constitutional majority, is declared passed.
- 26. Senate Bill 198, Senator Grotberg. Read the bill.
- 27. SECRETARY:
- 28. Senate Bill 198.
- 29. (Secretary reads title of bill)
- 30. 3rd reading of the bill.
- 31. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- Senator Grotberg.
- 33. SENATOR GROTBERG:

- 1. Thank you, Mr. President, Ladies and Gentlemen of the
- Senate. Senate Bill 198 does exactly as the Synopsis
- suggests in the case of the County Zoning Act, it requires
- that the zoning notices be published in a newspaper
- 5. closest to where the zoning matter is, rather than in a
- 6. newspaper of general circulation at a larger level. I
- 7. simply states, shall be published in general circulation
- in the newspaper within a township or road district
- 9. where the land affected is located and then if there's
- 10. no newspaper there, it escalates to a general circulation
- 11. in the county where it's located. I would ask for a favorable
- roll call, answer any questions.
- 13. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 14. Any further discussion? Senator Maragos.
- 15. SENATOR MARAGOS:
- 16. Will the sponsor yield to a question, please?
- 17. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 18. The sponsor indicates he will yield, Senator.
- 19. SENATOR MARAGOS:
- Senator Grotberg, how does this differ from the present
- 21. Statute, I don't have the Statute in front of me. What is
- 22. the...how does it change it?
- 23. SENATOR GROTBERG:
- 24. The present law states that the notice requirements
- 25. of zoning shall be in four conspicuous places, you know,
- 26. post...nail them to the school house door for one thing,
- 27. and this changes that to a publication factor rather
- 28. than the posting of the notices.
- 29. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- Senator Maragos.
- 31. SENATOR MARAGOS:
- 32. Well, aren't there other requirements that the
- 33. present law states before any hearings can be held on

- these variations? Don't they have to notify the 1.
- adjoining property owners? 2.
- PRESIDING OFFICER: (SENATOR KENNETH HALL) 3.
- 4. Senator Grotberg.
- SENATOR GROTBERG: 5.
- Yes, it's a new...it presently states as a newspaper 6.
- of general circulation in the county. This starts at a 7.
- smaller unit of government in the case of a local weekly 8.
- paper, et cetera. 9.
- PRESIDING OFFICER: (SENATOR KENNETH HALL) 10.
- Senator Maragos. 11.
- SENATOR MARAGOS: 12.
- What confuses me, Mr. President and members of the 13.
- Senate, is the fact that most of the zoning requirements 14.
- ... notice requirements of the zoning statutes today, 15.
- state that you have to give the adjoining owners notice 16.
- by certified mail or registered mail and those are the ones 17.
- who are immediately concerned. Now, is this the additional 18.
- notice to municipalities or is it an additional notice to 19.
- the public at large? 20.
- PRESIDING OFFICER: (SENATOR KENNETH HALL) 21.
- Senator Grotberg. 22.
- SENATOR GROTBERG: 23.
- This amends only the county zoning processes. 24.

counties, Senator Maragos, and has nothing...the meetings

- bill is on municipalities. This has only to do with the 25.
- 26.
- of the Zoning Commission on the matter at hand. It has 27.
- nothing to do with notifying the neighbors by registered 28.
- mail, et cetera. 29.
- PRESIDING OFFICER: (SENATOR KENNETH HALL) 30.
- Senator Maragos. 31.
- SENATOR MARAGOS: 32.
- Why...why is this requirement even needed if the 33.
- 34. adjoining property owners and the adjoining municipalities

- 1. are informed, why do we need this additional requirement,
- that's why I'm asking.
- 3. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 4. Senator Grotberg.
- 5. SENATOR GROTBERG:
- 6. This requirement is needed because there's a tendency
- 7. for instance, in my district, it's possible now in Kane
- 8. County to run a zoning notice of something in St. Charles,
- 9. out of the Aurora...Senator Maragos, it is legal to run a
- 10. notice about St. Charles, fifteen miles away, in the
- 11. Aurora newspaper whereas this would mandate it to the
- 12. newspaper closer to the action, the St. Charles newspaper.
- 13. It would be where more people read it.
- 14. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 15. Senator Maragos.
- 16. SENATOR MARAGOS:
- 17. I don't want to be...make it a point but there's
- 18. a lot of other questions here: that by making this
- 19. requirement does this in any way also include home
- 20. rule units and other municipalities have to abide by this.
- 21. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 22. Senator Grotberg.
- 23. SENATOR MARAGOS:
- 24. Even though it...
- 25. SENATOR GROTBERG:
- 26. We...we did not strike the home rule clause. We,
- 27. in fact, we put it back in in committee for the counties.
- 28. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 29. Senator Maragos.
- 30. SENATOR MARAGOS:
- 31. Yeah, the reason why I'm asking because I'm
- 32. sorry, I wasn't here when this was on 2nd reading yesterday,
- 33. evidently, but my concern is that this may put additional
- 34. burdens on the bodies or the...the county boards that

- are hearing these zonings when there are adequate
- requirements, I know in the Cook county which I'm
- 3. familiar with, and I don't know whether this is needed.
- 4. Now, if you feel that it's needed outside of Cook county,
- 5. then I have no objection, but I don't know whether
- Cook county itself will be affected by this.
- 7. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- Senator Grotberg.
- 9. SENATOR GROTBERG:
- 10. As I stated, we restored in the language the home
- 11. rule provision by amendment on 2nd reading.
- 12. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 13. Any further discussion? Senator Wooten.
- 14. SENATOR WOOTEN:
- 15. Thank you, Mr. President. If the sponsor would
- 16. yield for a question.
- 17. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 18. He indicates he will yield.
- 19. SENATOR WOOTEN:
- 20. Senator, just to clarify, I read through the bill while
- 21. the discussion was going on and I am assuming that I am
- 22. correct in saying that all you have done is change the
- 23. notice from posting in four public places to publishing
- 24. in a newspaper, Senator?
- 25. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 26. Senator Grotberg.
- 27. SENATOR GROTBERG:
- 28. We did two things. We deleted the posting in four
- 29. public places...
- 30. SENATOR WOOTEN:
- 31. All right.
- 32. SENATOR GROTBERG:
- 33. ...and went to publication in the newspaper closest to

- the zoning matter. 1.
- PRESIDING OFFICER: (SENATOR KENNETH HALL) 2.
- Senator Wooten. 3.
- SENATOR WOOTEN: 4.
- I would think the elimination of the posting 5.
- is a perfectly acceptable thing. I...might be some 6.
- quibble about which paper you would chose, but you 7.
- are not adding an additional requirement, in other 8.
- words, you have to post in the newspaper, you have to 9.
- post in four public places. This simply says it will be 10.
- the closest newspaper and eliminate the four public 11.
- postings, is that correct? 12.
- PRESIDING OFFICER: (SENATOR KENNETH HALL) 13.
- Senator Grotberg. 14.
- SENATOR GROTBERG: 15.
- You stated the exact purpose of the bill, Senator. 16.
- PRESIDING OFFICER: (SENATOR KENNETH HALL) 17.
- Any further discussion? Senator Bower. 18.
- SENATOR BOWERS: 19.
- Mr. President, would the sponsor yield to a question? 20.
- PRESIDING OFFICER: (SENATOR KENNETH HALL) 21.
- Wait just a minute. Let's have a little order, please. 22.
- He indicates he will, Senator. 23.
- SENATOR BOWERS: 24.
- Senator Grotberg, you've explained, it seems to me, 25.
- half of the bill, but the provision on page five which says 26.
- that any time the Zoning Board shall consider any matter 27.
- referred to it apparently under the Administrative Review 28. Procedure, there has to be a notice...a notice published.
- 29. Now, that's totally new language and I take it that
- requirement has neverobeen there before, is that correct? 30.
- 31.
- I'm speaking to page five, now. 32.
- SENATOR GROTBERG: 33.

- Give me a moment to read it too, will you, Senator
- 2. Bower. Right.
- 3. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 4. Senator Bower.
- 5. SENATOR BOWERS:
- 6. So that if I make a...an application for a building
- 7. permit and the Building Department turns me down and
- I appeal that decision, that's now going to require
- 9. publication in a newspaper, is that correct?
- 10. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- Senator Grotberg.
- 12. SENATOR GROTBERG:
- 13. That's correct.
- 14. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- Senator Bower.
- 16. SENATOR BOWERS:
- 17. Then, it would appear to me that you might as
- 18. well publish then, everytime I apply for a building
- 19. permit. It seems that this is going to be a rather
- 20. onerous requirement in terms of publication in that
- 21. ...that I question whether or not it's necessary and I'm
- 22. just wondering, what is the example that makes this
- 23. kind of a requirement necessary?
- 24. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- Senator Grotberg.
- 26. SENATOR GROTBERG:
- 27. I think the example is that the traditional strong
- 28. role of the Board of Appeals in a county brings this kind of
- 29. a matter into the publication area for...for the public's
- 30. right to know.
- 31. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 32. Senator Bower.
- 33. SENATOR BOWERS:

- 1. Well, Mr. President, I certainly have no objection
- 2. to publishing every time we're talking about rezoning
- 3. or anything that's going to seriously affect any of the
- 4. surrounding property owners. I think that's a valid requirement
- 5. but many times there is in the Zoning Board of Appeals
- 6. jurisdiction certain appeals processes which are minimal
- 7. in nature. For instance, if the building commissioner
- decides that the...let's say, the rafters need to be six
- 9. inches instead of two inches, or something of that nature,
- 10. the...the general administrative procedure of relief to
- 11. the applicant is an appeal and the appeal process
- 12. goes to the Zoning Board of Appeals. Now, we're going
- 13. to say that we have to publish so I know what's going to
- 14. happen, everytime I want to appeal, there's going to be a
- 15. hundred or two hundred dollar fee attached to it to pay
- 16. for the publication cost. And this seems to me to be
- 17. directed against the small property owner and I'm opposed
- 18. to it. Thank you.
- 19. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 20. Is there any further discussion? Would you like to call...
- 21. close, Senator Grotberg?
- 22. SENATOR GROTBERG:
- 23. Mr. President, I would like to close saying that these
- 24. bills are the result of the work of the Illinois
- 25. Press Association and they have worked long and hard trying
- 26. to create a public right to know situation regarding
- 27. zoning matters and bringing them closer to the people and
- 28. I think that as this legislative Body's prerogative and
- 29. responsibility to let the people know through every legal
- 30. course that we can. And I move...encourage an Aye vote
- 31. on this bill.
- 32. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 33. The question is shall Senate Bill 198 pass.

- 1. Those in favor vote Aye. Those opposed vote Nay.
- 2. The voting is open. Have all voted who wish? Senator
- 3. Grotberg. Have all voted who wish? Take the record.
- 4. On that question the Ayes are 43, the Nays are none,
- 5. 9...none Voting Present. Senate Bill 198 having
- 6. received a constitutional majority, is declared passed.
- 7. Senator Donnewald. Senator Donnewald.
- 8. SENATOR DONNEWALD:
- 9. Yes, Mr. President. I wonder, our rules provide
- 10. that we're not allowed to introduce; anybody from anywhere,
- 11. is that right or wrong? Well, I'd like to introduce...
- 12. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 13. Who is...introduce, Senator?
- 14. SENATOR DONNEWALD:
- 15. ...I'd like to...the people that are not supposed
- 16. to be introduced are immediately in back of me from
- 17. Bond County Democratic Women's Club. Would they please
- 18. rise and be recognized.
- 19. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 20. Would the ...would the people please rise and be
- 21. recognized by the Senate. Senator Mitchler.
- 22. SENATOR MITCHLER:
- 23. Yes, Mr. President and members of the Senate. Sitting
- 24. with the Democratic women from Senator Donnewald's county,
- 25. in his district and hoping to influence them, are the
- 26. Kendall County Farm Bureau Women's Group and you know that's
- 27. the tiger county as far as Republicanism is concerned and
- 28. they're here to witness Senator Grotberg pass his first
- 29. bill. Would the ladies from Kendall County Farm Bureau
- 30. please stand.
- 31. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 32. Would you please stand...
- 33. SENATOR MITCHLER:

- These are Republicans.
- 2. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- ...and be recognized by the Senate.
- 4. SENATOR MITCHLER:
- 5. And Mr. President, as long as you have been so kind
- 6. to give the microphone, in the President's gallery,
- 7. is the Blazek family from Batavia, Illinois. Would they
- 8. please stand and be recognized.
- 9. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 10. Would you please stand and be recognized. Senate
- 11. Bill 199, Senator Grotberg.
- 12. SECRETARY:
- 13. Senate Bill 199.
- 14. (Secretary reads title of bill)
- 15. 3rd reading of the bill.
- 16. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 17. Senator Grotberg.
- 18. SENATOR GROTBERG:
- 19. This does the same thing for municipalities, Ladies
- 20. and Gentlemen, Mr. President. I would just take the same
- 21. roll call.
- 22. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 23. Any further discussion? The question is shall Senate
- 24. Bill 199 pass. Those in favor vote Aye. Those opposed
- 25. vote Nay. The voting is open. Have all voted who wish?
- 26. Have all voted who wish? Take the record. On that question
- 27. the Ayes are 40, the Nays are 12, none Voting Present.
- 28. Senate Bill 199, having received a constitutional majority
- 29. is declared passed. Senate Bill 201, Senator Bruce.
- 30. Read the bill.
- 31. SECRETARY:
- 32. Senate Bill 201.
- 33. (Secretary reads title of bill)

- 1. 3rd reading of the bill.
- 2. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- Senator Bruce.
- 4. SENATOR BRUCE:
- 5. Thank you, Mr. President. Senate Bill 201 corrects
- 6. a small problem that has developed with the office of the
- 7. new Comptroller relative to office expenditures. There
- are some number of us who are interested in the outcome
- 9. of this legislation. It will allow a member who is a
- 10. member of, in this particular interest, a member of the
- 11. 79th General Assembly and the 80th General Assembly to
- 12. encumber or spend the total twelve thousand dollars
- 13. for your office account within the fiscal year. It would
- 14. still make the restriction of six thousand in the first
- 15. six months, but it will allow you to encumber or spend
- 16. the full twelve thousand in a twelve month or fiscal year
- 17. period. If there are any questions, otherwise, I would

- 23. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 24. He indicates he will.
- 25. SENATOR RHOADS:
- 26. Senator Bruce, as I understand this affects House members
- 27. coming over to the Senate and vise versa?
- 28. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 29. Senator Bruce.
- 30. SENATOR BRUCE:
- 31. Well, that is my understanding. I hope it is eventually
- 32. the Comptroller's understanding. I had some degree of
- 33. difficulty making sense out of this whole matter, but

- 1. they say that this will solve the problem. I hope that
- it does.
- 3. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 4. Any further discussion? The question is shall Senate
- 5. Bill 201 pass. Those in favor vote Aye. Those opposed
- 6. vote Nay. The voting is open. Have all voted who wish?
- 7. Take the record. On that question the Ayes are 53,
- 8. the Nays are 1, none Voting Present. Senate Bill 201,
- 9. having received a constitutional majority, is declared
- 10. passed. Senate Bill 219, Senator Netsch.
- 11. Senate Bill 280, Senator Morris. Call the bill.
- 12. SECRETARY:
- Senate Bill 280.
- 14. (Secretary reads title of bill)
- 15. 3rd reading of the bill.
- 16. PRESIDENT:
- 17. Senator Morris.
- 18. SENATOR MORRIS:
- 19. Thank you very much, Senator Hynes. This bill deals
- 20. with a problem that has come up this past year. As you'll
- 21. recall, last year, we passed legislation granting special
- 22. hunting and fishing license fees and free camping to senior
- 23. citizens. The problem is in Illinois, we grant those
- 24. benefits to all senior citizens regardless of where they
- 25. reside. Many other states don't offer those benefits and this
- 26. proposal would make the benefits in Illinois reciprocal
- 27. to people from out of state. An example might be that I could
- 28. use, is last August, we had two thousand, six hundred
- 29. senior citizens camp in our state parks. Under our laws
- 30. they were able to camp free. That cost the State of Illinois
- 31. approximately forty thousand dollars for the month of August
- 32. and overall last summer we lost about a hundred and eighty
- 33. thousand dollars. This bill would say that senior citizens

- 1. from Illinois would receive the benefits of free camping
- 2. and receive the benefits of the benefits in hunting and
- 3. fishing licenses, but senior citizens from other states
- 4. would have to pay the fee that their state charges our
- 5. senior citizens or pay full fee according to Illinois.
- 6. I'll answer any questions you might have and I'd
- 7. appreciate a favorable roll call.
- 8. PRESIDENT:
- Senator Ozinga.
- 10. SENATOR OZINGA:
- 11. Yeah. Would the sponsor yield to a question?
- 12. PRESIDENT:
- He indicates that he will yield.
- 14. SENATOR OZINGA:
- 15. How will this affect reciprocity with other states
- 16. surrounding us?
- 17. SENATOR MORRIS:
- 18. At this time, Wisconsin charges full fare to
- 19. senior citizens from Illinois. Indiana and Kentucky and
- 20. Missouri as I understand it, do not give the free benefits
- 21. that our state has. What this bill would say that either
- 22. they will give benefits equal to Illinois or people from
- 23. their state will pay the full fare when they come into
- 24. Illinois. Hopefully, it will motivate the Legislatures
- 25. in the other state to grant benefits similar to ours. If they
- 26. don't their senior citizens will begin to put pressure
- 27. on them to give the benefits that we give. I don't think
- 28. it's fair for the taxpayers of Illinois to subsidize
- 29. this type of benefit for people from Wisconsin when in fact,
- 30. people from Wisconsin won't give our senior citizens a
- 31. similar break.
- 32. PRESIDENT:
- 33. Is there any further discussion? Senator Savickas.

- ı. SENATOR SAVICKAS:
- Yes, Senator Morris, wasn't this part of a proposal 2.
- from the Economic Development Commission at one time to 3.
- promote tourism in the State of Illinois? 4.
- 5. PRESIDENT:
- 6. Senator Morris.
- 7. SENATOR MORRIS:
- Not that I'm aware of, Senator Savickas. Last year 8.
- it was a proposal that came from some legislators on the 9.
- hunting and fishing licenses and the camping bill was introduced 10.
- by some House members from, I believe, I can't remember 11.
- Decatur, I think John Dunn and I had a bill in the Senate 12.
- that gave half price, but it wasn't proposed by the 13.
- people from Business and Economic and they didn't testify 14.
- for or against the bills last year or this bill this year. 15.
- 16. PRESIDENT:
- Further discussion? Senator Lemke. 17.
- SENATOR LEMKE: 18.
- This...wasn't this bill...didn't this bill come out 19.
- of there because I think this was a Governor's...Governor 20.
- Walker's bill and they proposed it and the sponsors of it 21.
- was my running mate, Representative Terzich and we held 22.
- that bill up here and the Governor insisted he wanted it 23.
- and we passed it out as it is. And this is to create tourism. 24.
- I...I mean this is a type of bill that sometimes creates 25.
- problems. We're taking some benefits away from senior 26.
- citizens and...and we could deny them some benefits they 27. might receive someplace else. And I don't know if we can
 - do this. 29.

- PRESIDENT: 30.
- Senator Harber Hall. 31.
- SENATOR HALL: 32.
- Well, you know, we have compassion for those on fixed 33.

- 1. incomes and those in the retired status, over sixty-five
- and now we're saying that if they live out of the state
- 3. we lose some of that compassion. I...I question that a little
- 4. bit and also the fact that if they want to come to Illinois
- 5. and enjoy our parks they probably are bringing their
- 6. families and spend money here, which increases
- 7. our sales tax and we benefit in that way. I think to drive
- 8. them out by saying we're not giving you...we're not
- 9. extending to you the courtesy and the privilege that we
- 10. do other people of your like situation, I think may be wrong.
- 11. PRESIDENT:
- 12. For what purpose does Senator Morris arise?
- 13. SENATOR MORRIS:
- 14. I...I think that there's been a misunderstanding of the
- 15. bill. You know, I put in the bill last year and it wasn't
- 16. put in by Economic and Fiscal, it wasn't...or by Business
- 17. and Economic Development. It was put in by Bill Morris and
- 18. a group of other people. As for the...the compassion
- 19. for people from other states I can sympathize with that.
- 20. But, when a senior citizen from Illinois takes his
- 21. or her camper into Wisconsin or into Missouri or into any
- 22. other state, they pay full fare. And yet, when people
- 23. come in from other states to our state, they don't pay
- 24. full fare. We're losing a hundred and fifty to two hundred
- 25. thousand dollars a year income because of that, number
- 26. one, and number two as Senator Johns has pointed to a
- 27. problem in his district where Illinois residents or non-
- 28. senior citizens who would pay full fare cannot get into the
- 29. parks because all of the camping spaces are taken because
- 30. of out-of-state senior citizens who will come to this
- 31. state and use the benefits. The fact that in August
- 32. we drew twenty-six hundred senior citizens from other
- 33. states, I think, points to that. And I'd like to point

- 1. out Senator Hall, you're a cosponsor of the bill.
- 2. PRESIDENT:
- Senator Schaffer.
- 4. SENATOR SCHAFFER:
- I'm not sure if I'm a cosponsor of the bill, Senator
- 6. Morris, but if I'm not, I'd like to have leave to have
- 7. my name added. I have a district that borders the Wisconsin
- 8. line and my residents have been very upset about the fact
- 9. that we have graciously offered these benefits to Wisconsinites
- 10. and that they have not reciprocated and I think fair is fair
- 11. and I think this is a good bill and I would suggest that
- 12. there are probably a lot of people, particularly, in the
- 13. northern part of the state in the Chicagoland area who
- 14. feel very strongly about it because they go up to Wisconsin
- 15. and they aren't...they don't get similar treatment as
- 16. we give the people from Wisconsin. I'd like to urge
- 17. support of this bill and I hope it does pass.

- 19. PRESIDENT:
- 20. Senator Carroll.
- 21. SENATOR CARROLL:
- 22. Thank you, Mr. President, members of the Senate.
- 23. House Bill 24 is a supplemental appropriation to DOT to
- 24. pay to the RTA. This is at the agreed figure of what will
- 25. be in the Public Transportation Fund which is a special
- 26. distributive fund. As you will recall, we reduced the
- 27. appropriation last year based on a lack of anticipated
- 28. revenues. We have found the money is now there and available
- 29. to be appropriated and this is money basically used for
- 30. suburban transportation carriage. I'd be willing to answer reasonable
- 31. questions and would ask for a favorable roll call.
- 32. PRESIDENT:
- 33. Is there any discussion? Senator Berning.

SENATOR BERNING:

- Thank you, Mr. President, members of the Senate.
- 3. This, House Bill 24, seeks to replace dollars for the RTA
- 4. which this Body in its wisdom elected to remove from the
- budget last year partly from a conviction that they did
- 6. not need the dollars and also from a conviction that if one
- 7. of our obligations, namely to schools, were to be
- 8. subjected to an arbitrary curtailment of full entitlement
- g. at approximately six percentage points, other obligations
- 10. and namely the RTA should be subjected to the same type
- 11. of equal treatment. Mr. President and members of the Senate,
- 12. I submit to you that the RTA in spite of its protestations
- 13. of carrying out its obligation, has not in any way
- 14. provided additional mass transportation in the County
- 15. of Lake. It has failed repeatedly to respond to the
- 16. inquiries, yes, the requests and the demands for some
- 17. kind of action from the citizens of the 32nd district.
- 18. And I say to you, Ladies and Gentlemen of the Senate,
- 19. there isn't anything that can be said to justify granting
- 20. additional allocations of dollars to that body at this
- 21. time. I would respectfully request that the Senate
- 22. reconfirm its position of last June and deny this request
- 23. for supplemental appropriation.
- 24. PRESIDENT:
- 25. Senator Schaffer.
- 26. SENATOR SCHAFFER:
- 27. Well, I'd just like to echo Senator Berning's comments.
- 28. I will restrain myself from saying anything about the RTA
- 29. and it's lack of operation in my particular legislative
- 30. district or the rather strong feelings that you all know I
- 31. have on the RTA. This Body, individually and collectively,
- 32. has repeatedly talked about priorities. And I think most of us
- 33. have arrived at the conclusion that education should be the

- 1. number one priority in this State and yet we choose to
- 2. fully fund the RTA while only funding education at about
- 3. eighty-seven percent. It's my impression that if the RTA
- 4. was denied this money, if this money was transferred into the
- 5. Education Fund as would be possible, by the way, if legislation
- 6. now pending in the House was successful, that we would
- 7. really be keeping faith with the education community
- 8. in this State. How can we go back to our districts in
- 9. Peoria and Cary and Olney and the other parts of
- 10. the downstate and suburban areas and say that we have
- 11. made education a first priority when, in fact, we have not.
- 12. When in fact, we have funded the RTA for every dollar
- 13. they could find a garbage can to throw it in and yet we have
- 14. not chosen to fund education. I suggest to you that this money
- 15. would be better spent on education. I suggest to you that
- 16. the legislative vehicles to make that possible are at hand
- 17. and I would suggest to you that now is the opportunity
- 18. to put up or shut up. If you're telling the people in
- 19. your district that education is your first priority, there
- 20. is no way you can in all honesty, vote for this bill.
- 21. PRESIDENT:
- 22. Senator Hickey.
- 23. SENATOR HICKEY:
- 24. Mr. President, would the sponsor yield for a question?
- 25. PRESIDENT:
- 26. He indicates that he will yield.
- 27. SENATOR HICKEY:
- 28. I would like to ask if this was in the Governor's
- 29. budget, it seems difficult for me to entertain the idea
- 30. of this bill out of context.
- 31. PRESIDENT:
- 32. Senator Carroll.
- 33. SENATOR CARROLL:

- 1. Yes, in answer to the Senators question, it's
- my understanding that it is. This is a special allocation
- 3. fund. Money is not usable for any other purpose. It's
- 4. a matter of distributing what comes into the fund which
- is three thirty-seconds of the sales tax plus fourteen dollars
- 6. of each annual and seven dollars of each semi-annual
- 7. motor vehicle registration fee. So, it is my understanding
- 8. that these figures are thereby allocated in the budget.
- 9. PRESIDENT:
- Senator Soper.
- 11. SENATOR SOPER:
- 12. Thank you, Mr. President. With the explanation that
- 13. Senator Carroll just made to Senator Hickey, I...I don't
- 14. see any reason that we can't support this. I... I rise
- 15. in support. Our people need transportation. If there
- 16. was any way to say that we could give the schools more money,
- 17. I'm for that. But we have a certain budget, we have certain
- 18. allocations, we've made allocations. We've made
- 19. a determination by this Body and as to how this money
- 20. was to be raised and how it was to be spent, this is not
- 21. any supplemental, this is a part of money that's coming
- 22. from something we've already designated for this one
- 23. purpose and you can get up and you can talk about the money
- 24. should be used elsewhere, there are about fifty other
- 25. places we can use the money. But, once money is allocated
- 26. for certain purpose, I don't think we can change that
- 27. purpose and we're not going to help education by keeping this
- 28. from transportation. If the citizens in my district wouldn't
- 29. have transportation, I withHeld this money from them and if you...
- 30. the Burlington riders and the Northwestern riders and the
- 31. ...and the bus riders throughout the county and the collar
- 32. counties, I think they would be less appreciative if we took
- 33. money that was allocated to them and we took it and held it from

- 1. them and held it in a fund could be used for nothing else.
- 2. Now, I understand there...we have a lot of Senators here
- 3. that don't come from Cook County or don't come from the
- 4. collar counties, but with the understanding that this
- 5. money can't be used for anything else, I think it would
- 6. be foolish not to support something or give the...that
- 7. institution or that...or that purpose the rightful
- 8. amount that's due to them so, Ladies and Gentlemen,
- 9. if you're not from the collar counties and if you're
- 10. not from the...if you're not from Cook County, I want
- 11. you to realize that when you have a transportation
- 12. problem in your district, you need roads. If we said,
- 13. well, there's a road fund and the money is in the road
- 14. fund, but we're not going to give you that money, it
- 15. can't be used anyplace else but because you're from
- 16. another county and not from the county I come from, we're
- 17. going to withhold it from you. I don't think it would be
- 18. fair and I don't think it's fair now to withhold this
- 19. money from the RTA. It can't be used for anything else.
- 20. Thank you.
- 21. PRESIDENT:
- 22. Senator Morris.
- 23. SENATOR MORRIS:
- 24. Thank you very much, Mr. President. Senator Soper
- 25. makes a very good argument. To continue the unfair situation
- 26. which is known as the Regional Transportation Authority.
- 27. I'd like everyone to realize that this amount of money
- 28. when it goes to the RTA is then distributed by the RTA
- 29. Board and the line that this is for suburban transportation
- 30. is baloney. The fact of the matter is, about seventy-
- 31. five percent of the money that the RTA spends goes to
- 32. benefit the Chicago Transit Authority. Those of us in the
- 33. collar counties who put in anywhere from about two million
- 34. dollars a year in small McHenry County to as much as twelve

- 1. to fourteen million dollars a year to this fund from
- 2. DuPage County and about six million in my county will get
- 3. back nickels and dimes and a quarter if we're fortunate.
- 4. I think that as long as you want to continue an unfair
- 5. distribution of funds within the RTA region, you ought to
- 6. go ahead and vote for this. But, the fact of the matter
- 7. is until we can get the RTA Board to be responsive to the
- 8. transportation needs in all of the region, and not just
- 9. the small area known as the City of Chicago and some
- 10. of the immediate suburbs, then we ought not to approve
- 11. this money and let this bill sit on this Senate Table
- 12. for a few weeks and let us sit down with legislators
- 13. who are in support of the legislation and see if we can
- 14. design a new formula for distribution because, yes the
- 15. people in Lake County and Kane County and Will
- 16. County do need transportation. But, our people are
- 17. sick and tired of putting in five and six million dollars
- 18. a year to this fund and getting back less than a half
- 19. a million dollars a year. That is not a good investment
- 20. and a vote for this bill is a vote to continue that kind
- 21. of unfairness on several million people who live in the
- 22. collar counties of Illinois. And also, it votes to punish
- 23. those people by getting downstate votes for an unfair
- 24. situation. I would appreciate if this bill would fall less
- 25. than thirty votes today and I would be happy and I'm sure
- 26. Senator Schaffer would be and Senator Berning to sit down
- 27. with Senator Carroll and anyone else interested and redesign
- 28. a formula for distribution of RTA funds which would be fair
- 29. to all communities involved and I solicit a No vote on this bill.
- 30. PRESIDENT:
- Senator Mitchler.
- 32. SENATOR MITCHLER:
- 33. Mr. President and members of the Senate. I would hope

- 1. that the colleagues in the Senate will appreciate the
- dissatisfaction that the people in the six county area
- 3. that is served by the Regional Transportation Authority
- 4. have for the operation of that RTA program. Now, this is
- 5. a six county area in Northeastern Illinois. And I want
- 6. to remind you that when the referendum vote was taken,
- 7. the five collar counties of Lake, Will, Kane, McHenry,
- 8. and DuPage and suburban Cook County overwhelmingly
- 9. voted in opposition to the creation of the RTA Act.
- 10. This does not mean that they are anti-public and mass
- 11. transportation. But, they realized in the formation
- 12. of this Act extensive powers were given to an RTA
- 13. board that was appointed. And a board not necessarily
- 14. representative of the entire area on equal basis.
- 15. They recognized that that board was given taxing power,
- 16. power to tax for parking and power to put a five percent
- 17. tax on gasoline purchases and use. Their shuddering up
- 18. there, members of the Senate, their shaking for fear
- 19. that that appointed board is going to impose a five percent
- 20. gasoline tax. Now, that's not a five cent a gallon, that's
- 21. five percent, five cents on every dollar that is paid into
- 22. the gasoline stations in the six county area. Up in the
- 23. northern part, they are shuddering and shaking because of the
- 24. fear of competition with Wisconsin and also over into
- 25. Indiana and then to the counties ourside of the RTA area.
- 26. Now, what they get for the money that's going into the RTA
- 27. is unfair. I voted in support many bills...
- 28. PRESIDENT:
- 29. For what purpose does Senator Donnewald arise?
- 30. SENATOR MITCHLER:
- 31. ...have given...
- 32. PRESIDENT:
- Excuse me, Senator.

SENATOR DONNEWALD:

- 2. May I...point of order. Is the clock not working
- 3. up there, Mr. President?
- 4. PRESIDENT:

1.

- 5. Suddenly the clock is in operation. Senator Mitchler,
- 6. would you conclude your remarks.
- 7. SENATOR MITCHLER:
- The people of the area are really concerned. None
- 9. of my friends in Chicago...let me explain. My vote
- 10. has been cast many times to provide the CTA with
- 11. reimbursement for transporting children, school children,
- 12. as we have the transportation fund downstate. I've gone
- 13. along with the unreduced rates for licenses, for motor
- 14. fuel tax, but when you want to give a handout to an
- 15. incapable board that Pikarsky and Company up there, I wouldn't
- 16. trust any of them including those that represent the
- 17. collar counties that are on the board. Now, their spending
- 18. money like it's going out of style. And to give them
- 19. sixteen million dollars more it will go down the drain.
- 20. Why, in the fact of over a hundred million dollar deficit
- 21. budget, they had the audicity to hire a new man at sixty
- 22. thousand dollars a year, ten thousand dollars more than the
- 23. Governor of the State of Illinois gets. Give salary increases
- 24. of seventy-five hundred dollars per to the executives of the
- 25. RTA employees. Seventy-seven thousand dollars in increased
- 26. wages for them. The Chairman of the RTA Board draws a salary of
- 27. seventy-two thousand five hundred. He was relieved of his
- 28. chief executive officers responsibilities and all he is now
- 29. is the chairman of that board where the board members get
- 30. twenty-five thousand. Until they clean up that mess, don't
- 31. give them any more money, Senators. Work out a forumla,
- 32. as Senator Morris pointed out so that it's distributed and that
- RTA Board is run properly. I'm not against mass transportation

- 1. but, I'm against squandering the money and you downstate
- 2. Senators outside of the RTA area, I plead with you, don't
- 3. take the tax dollars out of the General Fund and the
- 4. Transportation Fund and have it squandered up there in that
- 5. six county area. You need it downstate for your own
- 6. areas.
- 7. PRESIDENT:
- Senator Rhoads.
- 9. SENATOR RHOADS:
- 10. Mr. President, one correction to the previous
- 11. speaker. Chairman Pikarsky told the suburban legislators
- 12. in DuPage County about a month ago that his salary will be
- 13. going to eighty-two thousand within a few months. The
- 14. district that I represent, the west suburban six district
- 15. is about seventy-five percent in suburban Cook and about
- 16. twenty-five percent in DuPage County. With all due
- 17. respect to the Senate sponsor, this is the first
- 18. opportunity that we're going to have to send whatever
- 19. message we can to the RTA for as one previous speaker
- 20. put it, a lack of responsiveness. Just last September
- when I was campaigning for office, was not an incumbent,
- 22. but a candidate, I started receiving heavy mail in opposition
- 23. to the RTA's proposed reclassification scheme for the
- 24. Burlington Northern Railroad, a zone classification for
- 25. fare systems. We have the president's of local villages
- 26. testify against the plan. They got nowhere. It's just another
- 27. example of the RTA just plain not caring what the basic
- 28. laws of economics are in terms of trying to run an efficient
- 29. operation. So, I certainly will join some of the other
- 30. speakers in voting No.
- 31. PRESIDENT:
- 32. Is there any further discussion? If not, Senator
- 33. Carroll may close the debate.

ı. Thank you, Mr. President. Now that we've gotten 2. into our more than annual respeeching on RTA, let's go back 3. to the issue and the issue is how much money is available 4. on a predetermined formula that has been in the law to 5. distribute to an RTA which board members include, which 6. board members include, members of the collar counties, 7. members of suburban areas who apparently do not listen 8. to elected officials whom they have elected, Senators who 9. they are supporting and have supported in the past 10. and I think that is a communication problem between the 11. members who have risen to speak and the board members 12. who represent them. But, this is part of a comprehensive 13. ...comprehensive statewide transportation plan that was 14. developed by the General Assembly, that includes, if you're 15. talking comprehensive plans, includes monies coming 16. from the road funds in other areas of this state for 17. transportation needs such as senior citizens, et cetera. 18. monies for areas like Springfield, Champaign, Rockford, 19. East St. Louis, everywhere where there's mass transportation. 20. All this is is the allocation of the monies that are in 21. the fund for this year which are specifically statutorily 22. earmarked for this purpose and this purpose only. And 23. that is the allocation of the sixteen million dollars 24. there:from the three-thirty-seconds of the sales tax 25. and from the seven and fourteen dollars from the registration 26. fees. It's just that simple. This is a predetermined 27. policy. It is the appropriation of the monies needed and I 28. might add that within the RTA and these are internal 29. problems, something like thirty-seven cents of every 30. suburban commuter ride is subsidized by the RTA whereas 31. only seventeen cents of every CTA ride is subsidized

by the RTA. Now, I know the percentages are different.

- 1. But if you want parity, the dollars should be the same.
- 2. The point is, this money is for this purpose and I would
- 3. ask for a favorable roll call.
- 4. PRESIDENT:
- 5. The question is shall House Bill 24 pass. Those
- 6. in favor will vote Aye. Those opposed will vote
