SENATOR LEMKE:

- 1. This is a simple resolution. I think it's long overdo.
- 2. This calls for the election of the Superintendent of Public
- 3. ... Instruction, to put it back in the same realm it was in
- 4. before. I think the people in the State of Illinois should
- 5. have the right to vote on who's going to put programs forth
- 6. to educate their children. I think it's very vital and I
- 7. ask for a favorable vote.
- 8. PRESIDENT:
- 9. Senator Glass.
- 10. SENATOR GLASS:
- 11. Well, thank you, Mr. President, Ladies and Gentlemen.
- 12. I rise to oppose this amendment. It's a major change in the
- 13. structure of the administrative department of the State and
- 14. would undo something that was done by the people in
- 15. adopting our new Constitution, putting back to them the
- 16. question of whether to make the State Superintendent
- 17. elective. I think it was a wise move to take that office out
- 18. of the political arena. I think...with regard to some of
- 19. our members it may represent a slap in the face at the
- 20. present superintendent. I think if that is the case, there
- 21. are other ways of approaching that problem in making that
- 22. office more responsive. And perhaps the fact that this
- 23. amendment is coming up for a vote will accomplish just that.
- 24. But I think it's a bad idea that we should retain the present
- 25. system and I would urge a No vote.
- 26. PRESIDENT:
- 27. Is there any further discussion? Senator Knuppel.
- 28. SENATOR KNUPPEL:
- 29. Mr. President, I proposed and supported the appointive
- 30. Superintendent of Public Instruction and the State-wide
- 31. School Board in the Constitutional Convention. I think the
- 32. education of our children deserves more that a happenstance
- as to who may be the best politician in the State of Illinois

- 1. running for that office. I don't think that it's run maybe
- 2. that much better than it was, but it hasn't had that long in...
- 3. in its formation and in its operation. Certainly we've had
- 4. some very bad Superintendents of Public Instruction under the
- 5. elected method and I for one don't want my childen or my grand-
- 6. children's education to be dependent upon who happens to be
- 7. running for Governor or who happens to have the best political
- 8. machine in any given year or who...happens to have the most
- 9. attractive slate of candidates. I think that this is one
- 10. thing that ought to be more objective than...than to have the
- 11. Superintendent of Public Instruction elected followed by the
- 12. spoils system of the...the people who win getting the jobs.
- 13. Now you can say all you want to say about the code and everything,
- 14. but if you've got a young man that's passed the test and he
- 15. happens to be a Democrat, I'll guarantee you he's not apt
- 16. to get a job on the Highway Department if somebody else is
- 17. a Republican has passed that same test. I don't want my
- 18. people in the Department of Education nor the superintendent to
- 19. be chosen on a political basis and I'm as political as anyone
- 20. else. I...I think there are certain things and I don't think
- 21. it makes a lot of difference who it is that's scooping dead
- 22. cats up off the highway, but that's under the code. I do think
- 23. it makes a hell of a lot of difference who's in the schoolroom
- 24. teaching my child. I agree with Anita Bryant in that respect
- 25. anyway. Not in all the others, but that in that respect I
- 26. care who's in that classroom or who's over those people that
- 27. are in that classroom. And I think it would be a step backward
- 28. instead of forward to put the...the office back in the realm
- 29. and in the...in the category of a political office.
- 30. PRESIDENT:
- 31. Is there any...Senator Berman.
- 32. SENATOR BERMAN:
- 33. Thank you, Mr. President. I rise in opposition to this

- 1. Senate Joint Resolution. I'm a product of the political
- 2. process and all of us are. I think, however, that the political
- 3. process as it interplays with education has to be very delicate.
- 4. I think that what we find now is that we do have a political
- 5. input to the question of education and I think it should be...
- 6. there should be one. And that is through the pressures of the
- 7. Legislature, our action on budgets, our action on substantive
- 8. bills dealing with education. I think the response of the
- 9. school districts and the constituents to the committees, both
- 10. of Appropriation and to the Elementary and Secondary Education
- 11. Committees, does bring politics into play in the...the educational
- 12. picture. However, I think that when we make the office itself
- 13. totally political then I think we've gone past the area of
- 14. proper waiting of politics and administration. And I think that
- , 15. the balance that we have today is a good one. I think if anything
  - 16. we should perhaps exert a greater influence, but through the
  - 17. Legislative and Executive process, but not through the elective
  - 18. office of the State Superintendent. I think that we should
  - 19. take a greater interest as the General Assembly in the operation
  - 20. of that office, but through as a Legislator and not as political
  - 21. operatives in that office. Therefore, I think that we should
  - 22. maintain it as the Constitution and the existing Statutes
  - 23. provide, namely a...a Board of Education and an appointed
  - 24. superintendent, I'm going to vote No on this resolution.
  - 25. PRESIDENT:
  - 26. Senator Soper.
  - 27. SENATOR SOPER:
  - 28. Thank you, Mr. President. Members of the Senate, it always
  - 29. amazes me when some of our members get up and tell us that the
  - 30. people shouldn't be able to determine what we do in the schoolroom.
  - 31. That it's better if it was some bureaucracy that picked someone
  - 32. they do as they damn please after they get in there. And that
  - 33. the people can't...can't do these things. That the people are

- 1. insensitive, not knowledgeable, and that the people shouldn't
- 2. be able to vote to determine who should be the head and what
- 3. they should do. Now if we think that that's the case, why
- 4. don't we have a nice king and then we don't have to have a
- 5. Legislature, we don't have to have Senators, we don't have
- 6. to have Representatives, I wouldn't make Rock the king because
- 7. he hasn't been reformed, he moved to the suburbs and he hasn't
- 8. become genteel. But anyway we'll say this, that if we're going
- 9. to...if we're going to say that the people shouldn't have the
- 10. vote to do these things then let's take all the vote away
- 11. from the people, everything, and say we know better what should
- 12. happen to you and let's make the Legislature permanent and
- 13. ...let's...let's make a good king permanent and forget about
- 14. the people. I think that's wrong. You can say all you want
- 15. about politics and say that politics...politics is a business,
- 16. it's a business of the people. And when you say that the
- 17. school superintendent isn't in politics, well you certainly don't
- 18. know what you're talking about. It's politics of the lowest
- 19. grade, because he doesn't listen to the Legislators, he doesn't
- 20. listen to the people. So it's about time we went back and let
- 21. the people decide who should be in that office and I think they'll
- 22. do a hell of a good job. Thank you.
- 23. PRESIDENT:
- 24. Senator Wooten.
- 25. SENATOR WOOTEN:
- 26. Thank you, Mr. President. I would simply like to remind
- 27. my colleagues that we are only going to be able to offer
- 28. amendments to three articles of the Constitution on the ballot
- 29. and I would hope that we would pass out of this Chamber
- 30. precisely the three, no more than three, that this Chamber
- 31. thinks appropriate. I happen to think that this is not a
- 32. bad one. I believe that there is much wisdom in what Senator
- 33. Soper has said about relying on the people. You know as

- 1. tough as politics gets in this Chamber, it is nowhere as
- 2. tough and as vicious as it can sometimes get in education.
- 3. I might also point out that it's a great thing to have that
- 4. final arbitration with the people. When you talk about,
- 5. for example, the politics of a corporation, if the guy is
- 6. down on you there you're dead, but here you can also
- 7. appeal to the people. I don't think it'll make a sub-
- 8. stantive change in many things that the Board of Education
- 9. does, the Department of Education does. But I simply
- 10. believe the people will be more secure knowing that they
- 11. can or feel more secure knowing they can name that person.
- 12. And please let's stop apologizing for the fact that politics
- 13. is in it, that's our profession, it's an honorable profession.
- 14. We should never be ashamed to stand before the people and ask
- 15. for their approval. And that applies to education no less than
- 16. to all other legitimate fields of government. So I think
- 17. this resolution ought to be supported.
- 18. PRESIDENT:
- 19. Senator...Mitchler.
- 20. SENATOR MITCHLER:
- 21. Mr. President and members of the Senate. I too rise in
- 22. support of Senate Joint Resolution of the Constitutional
- 23. Amendment 31. Previously when we had an elected Superintendent
- 24. of Public Instruction we did indeed have the input of the
- 25. people into that office. Not only into the Superintendent
- 26. of Public Instruction, but also into the staff of that office.
- 27. Under the new Constitution of 1970 we now have an appointed
- 28. State Board of Education, we have an appointed Superintendent
- 29. of Education. These people are not responsive and have not,
- 30. in the time that I have watched them, been responsive to the
- 31. people. Particularly so have they not been responsive to
- 32. the Legislature. In fact, on many occasions I have watched
- 33. the arrogance of that office displayed to the members of

2.
      of the elected offices. I remember when we used to have
 3.
      the Legislative Budgetary Commission. And the budget of
4.
      the State was developed by members of the Illinois General
5.
      Assembly who worked into the wee hours of the morning. Now
6.
      you have the Bureau of the Budget, people we don't even
7.
      know, the people back home don't even know. Not elected,
8.
      not responsible to anybody. You used to have the Secretary
9.
      of State's office through the Index Division handle the
10.
      election process in the State of Illinois. Now you have
11.
      the State Board of Election and you know all the chaos
12.
      that that has created. You don't know what they're doing
13.
      over there and neither do I. They operate separate entirely
14.
      from the people themselves. Now government is getting that
15.
      way and I remind you of a speech made by the Chairman of
16.
      United
               States Steel in the City of Joliet when they had
17.
      United States Steel Day and honored that great industry in
18.
    the City of Joliet. And he told at the banquet that night,
19.
      he said, you'd better wake up, you're being governed not
20.
      by laws, but by rules and regulations made by people you don't
21.
      even know, you never elected to office. And that's why I
22.
      want to see this office returned back to the people. And
23.
      as Senator Soper said so eloquently, what's so stupid about
24.
      the people, they elected you and I. I think the people can
      make their choices wisely. And putting all of this authority
25.
26.
      into the Executive Branch of government and delegating
27.
      all that authority to Federal Congress so it can come out of
      HEW and all the mandatory rules and regulations, that's what's
28.
29.
      causing the chaos. Put it back to somebody that's responsible
      to the people, that wants to run for reelection and you'll
30.
      find out that the budget drops. And in closing I might say
31.
      that the present Superintendent of Education has a salary
32.
      greater than that of the Governor of the State of Illinois
33.

- 1. and he flouts that in his contract and stands there with
- arrogance to let everybody know it too. Vote and support
- 3. this. It's for the good of the people.
- 4. PRESTDENT:
- 5. Senator Knuppel.
- 6. SENATOR KNUPPEL:
- 7. Well, I'm just amazed, I don't know what in the hell I
- 8. had to do with the Democratic candidates we got on the
- 9. Democratic ticket this time and I don't know what anybody
- 10. from downstate is going to have to say on the Democratic...
- 11. in the Democratic Party anymore, so what difference does
- 12. it make. The best two speeches or the best three speeches
- 13. I've heard in favor of it were Mitchler, Lemke and Soper.
- 14. PRESIDENT:
- 15. Senator Lemke may close the debate.
- 16. SENATOR LEMKE:
- 17. Well, I don't know what Senator Knuppel is referring to.
- 18. Constituents voted for him, too. But I'm sick and tired of
- 19. when we come down here and as soon as you go get a college
- 20. education you become a Doctor of Education, you tell the
- 21. people that are farmers and didn't have the opportunity
- 22. to go to school, hey, fellow, I got a better education than
- 23. you and I should decide the destiny of your children and
- 24. who you don't count. You got nothing to say about this thing.
- 25. We don't want you around. We want an education. Well these
- 26. same educators to me, forget where they come from. They
- 27. forget where they come from. They forget that their fathers
- 28. worked in factories or their grandfathers or they farmed.
- 29. They're up there in the elite in their own world, their
- 30. own realm. We, in this State, have a fellow that not even...
- 31. born and bred in Illinois. He wasn't even a resident of
- 32. Illinois. At least if you can have a guy elected as a
- 33. State Superintendent of Public Instruction, he is going to
- 34. be a resident of this State and is going to know something

- 1. about the people that make up this State. And I'm sick
- 2. and tired of listening to this stuff and saying politics are
- 3. dirty. I'm telling you this that neither party, whether
- 4. it be Republican or Democrat, are going to put up a
- 5. Superintendent of Public Instruction that's not qualified
- 6. in the same realm as their present Superintendent of Public
- 7. Instruction. But I think the people who pay the taxes
- 8. should decide who should lead the education programs in
- 9. the State and go forward. I have seen in the last year of
- 10. educational programs that not...that aren't improving
- 11. our children in this State, but education programs where
- 12. our slipping compared to the other states in this country.
- 13. We have people that have to read third grade that are in
- 14. eighth. It's sickening sight, but yet they can spend
- 15. million dollars on other social programs, but they can't
- 16. educate people to do the basics, read, write and add.
- 17. It's a shame when you see kids get out of high school and go
- 18. on to college and end up taking a math exam and end up
- 19. getting a thirty-seven out of a hundred. It's ridiculous
- 20. to see people. I fought all my life to get through school
- 21. because of an improper education. As far as...as far as
- 22. English...I want to tell you this that there's nothing
- 23. wrong with running for election. I run, just like everybody
- 24. else here runs. The Governor runs. And this present
- 25. superintendent...let's look at it, he's from Massachusetts,
- 26. what does he know about the problems of Illinois, he's not
- 27. even from...he doesn't know anything about the people here.
- 28. He's first learning about them and, you know, this is...this
- 29. is the job where we pay him more than the Governor and we
- 30. say you learn...we...it's a...a learn on the job program,
- 31. that's what happening here. So I ask for a favorable
- 32. vote on this resolution. I think it's a very important, it
- 33. is vital to the education of the children of this State.

- PRESIDENT:
- For what purpose does Senator Rock arise?
- 3. SENATOR ROCK:
- Thank you, Mr. President. Parliamentary inquiry.
- 5. PRESIDENT:
- State your inquiry.
- 7. SENATOR ROCK:
- 8. How many votes are required for the adoption of Senate
- 9. Joint Resolution 31?
- 10. PRESIDENT:
- 11. Under Section II of Article 14, a three-fifths vote of
- 12. the Senate is required, so thirty-six affirmative votes
- 13. will be required for passage and approval of this amendment.
- 14. The question is shall Senate Joint Resolution 31 be passed
- 15. and approved. Those in favor will vote Aye. Those opposed
- 16. will vote Nay. The voting is open. Have all voted who wish?
- 17. Have all voted who wish? Take the record. On that question
- 18. ...on that question the Ayes are 36, the Nays are 18. None
- 19. Voting Present. Senate Joint Resolution 31 having received
- 20. the required three-fifths constitutional majority is
- 21. declared passed and approved. For what purpose does Senator
- 22. Bowers arise?
- 23. SENATOR BOWERS:
- 24. Well, Mr. President, I was trying to help my seatmate
- 25. and get his key unlocked and somebody moved mine from No
- 26. to Not Voting somehow. I voted No before I stood up and
- 27. I'd like to...
- 28. PRESIDENT:
- 29. The record will so show.
- 30. SENATOR BOWERS:
- 31. ...let the record show that.
- 32. PRESIDENT:
- 33. Senator Hall.
- 34. SENATOR Hall:

- Verification of the affirmative votes.
- 2. PRESIDENT:
- 3. Senator Hall has requested a verification of the
- 4. affirmative votes. The affirmative votes will be verified.
- 5. The Secretary will please read the affirmative votes.
- 6. SECRETARY:
- 7. The following voted in the affirmative: Berning, Bloom,

- 13. PRESIDENT:
- 14. There has been no one taken from the roll calls yet,
- 15. Senator Lemke. Senator Hall, do you wish...do you wish to
- 16. question the presence of any member? The roll call has been
- 17. verified. On that question the Ayes are 36, the Nays are 18,
- 18. none Voting Present. Senate Joint Resolution 31 having
- 19. received the required three-fifths constitutional majority
- 20. is declared passed and approved. What purpose does Senator
- 21. Johns arise?
- 22. SENATOR JOHNS:
- 23. Having voted on the affirmative side I move to reconsider
- 24. the vote from which I was cast.
