- 9. Mr. President I am directed to inform the
- 10. Senate the House of Representatives refused to concur with the
- 11. Senate in the adoption of their amendment to a bill with the
- 12. following title: House Bill 1468.
- 13. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 14. Rules. Senator Hynes.
- 15. SENATOR HYNES:
- 16. Mr. President and members of the Senate. I rise for
- 17. the purpose of making a motion with respect to Rule 5 dealing
- 18. with the introduction of bills. Friday was our deadline for
- 19. the introduction of bills and I'm happy to report that all
- 20. went well with one minor exception. It seems that through a
- 21. misunderstanding four bills that had been completed were in
- 22. the Reference Bureau on time and out of the Reference Bureau
- 23. on time were brought up five minutes after the Session had
- 24. closed. Due to a misunderstanding these bills, I believe,
- 25. should be introduced and we should allow them to be
- 26. introduced into this Body and there...the Rules Committee
- 27. this morning discussed the matter and felt that it would not
- 28. violate the spirit of the deadlines that we adopted. And I,
- 29. therefore, intend in just a moment to make a motion to suspend
- 30. the rules so that they can be introduced and referred to the
- 31. Rules Committee. But it is also our joint agreement that this
- 32. will be the only exception and that there are extenuating
- 33. circumstances involved here that make it a matter of fairness

- 1. that we allow this. So Mr. President I would, therefore,
- 2. move to waive Rule 5 for the purpose of...allowing the
- 3. introduction of the four bills on the Secretary's Desk
- 4. presented by Senator Lane and to then have those bills

- 20. The Senate will come to order. Is there leave to go
- 21. to the Order of the Secretary's Desk for resolutions? Leave
- 22. is granted. Resolutions...Harber Hall on the Floor? Senator
- 23. Harber Hall, is Senate Resolution 211...did you wish to have
- 24. that considered at this time? Senator Berning. Senate
- 25. Resolution 211. Senate Resolution 283, Senator Hynes. Did
- 26. you have an amendment? Senator Hynes is recognized.

- 28. Mr. President, I would simply like to have this called

- 4. to Senate Resolution 283. Is there discussion? All in favor
- 5. say Aye. Opposed Nay. The Ayes have it and...amendment is
- 6. adopted. Further amendments?
- 7. SECRETARY:
- 8. No further amendments.
- 9. PRESIDING OFFICER: (SENATOR BRUCE)
- 10. Senator Hynes, did you wish to consider that resolution
- 11. at this time? Senate Resolution 300. Senator Mitchler. Senator
- 12. Mitchler is recognized. Could Senator Schaffer and...
- 13. SENATOR MITCHLER:
- 14. Mr. President, there's a...a committee amendment to
- 15. Senate Resolution No. 300 and I would like to just briefly
- 16. explain it. It adds on the distribution of the amendment in
- 17. addition to the Village of Skokie officials to the president
- 18. of the Illinois Chapter of the National Socialist Party of
- 19. America. I move for adoption of the amendment. Committee
- 20. amendment.
- 21. PRESIDING OFFICER: (SENATOR BRUCE)
- 22. You've heard the motion to adopt the Committee Amendment
- 23. No. 1 to Senate Resolution 300. Is there discussion? All in
- 24. favor say Aye. Opposed Nay. The Ayes have it. The amendment
- 25. is adopted. Further amendments?
- 26. SECRETARY:
- 27. No further amendments.
- 28. PRESIDING OFFICER: (SENATOR BRUCE)
- 29. Senator Mitchler, did you wish to consider that amendment...
- 30. SENATOR MITCHLER:
- Yeah.
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- 33. ...at this time. Senator Mitchler is recognized on Senate

- 1. Resolution 300.
- 2. SENATOR MITCHLER:
- 3. Mr. President and members of the Senate. Senate
- 4. Resolution No. 300 that has been voted out of the Executive
- 5. Committee resolves that the Senate condemns the planned Nazi
- 6. demonstration in Skokie and that we condemn the hatred and
- 7. prejudice which the American Nazi Party epitomizes and that
- 8. we condemn the planned abuse of the sacred rights guaranteed
- 9. to all by the United States Constitution. It further resolves
- 10. that we encourage the American Nazi Party to desist in their
- 11. planned demonstration and encourage the local government in
- 12. Skokie to continue to search for ways to prevent the demonstration
- 13. in view of the damage to human life and property that is sure to
- 14. occur as a result of the demonstration, if held. A copy of the
- 15. resolution would be sent to the village officials of the Village
- 16. of Skokie and to the... President of the Illinois Chapter of the
- 17. National Socialist Party of America. Mr. President, I move for
- 18. adoption of Senate Resolution 300.
- 19. PRESIDING OFFICER: (SENATOR BRUCE)
- 20. ... Senator Mitchler has moved the...the adoption of
- 21. Senate Resolution 300. Is there discussion? Senator, they...
- 22. they are on the Calendar. This is not on the Consent Calendar.
- 23. Is there discussion? On the motion to adopt. All in favor
- 24. say Aye. Opposed Nay. The Ayes have it. The resolution is
- 25. adopted. Is Senator Berman on the Floor? Senator Lemke is
- 26. not on the Floor. Senator Berning, SJR 55 on Secretary of
- 27. Transportation. Did you wish to have that considered at this
- 28. time? Would a page please take the amendment from Senator
- 29. Berning and bring it to the Secretary's Desk?
- 30. SECRETARY:
- 31. Amendment No. 1 offered by Senator Berning.
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- 33. Senator Berning is recognized for the purpose of

- 1. explaining the amendment.
- SENATOR BERNING:
- 3. The amendment, Mr. Chairman and members of the Senate...
- 4. PRESIDING OFFICER: (SENATOR BRUCE)
- 5. Excuse me, Senator Berning. Could we have some order
- 6. please. Senator Berning.
- 7. SENATOR BERNING:
- 8. The amendment simply changes the reporting date from
- 9. that contained in the original resolution, which is April 1
- 10. now expired to October 1, 1978. I would like to have that
- 11. amendment adopted and then the resolution considered, Mr.
- 12. President.
- 13. PRESIDING OFFICER: (SENATOR BRUCE)
- 14. Senator Berning has moved the adoption of Amendment
- 15. No. 1. Is there discussion? All in favor say Aye. Opposed
- 16. Nay. The Ayes have it. The amendment is adopted. Further
- 17. amendments.
- 18. SECRETARY:
- 19. No further amendments.
- 20. PRESIDING OFFICER: (SENATOR BRUCE)
- 21. Senator Berning, you wish to take this up at this time?
- 22. Would you please briefly explain the resolution?
- 23. SENATOR BERNING:
- 24. Yes, Mr. President and members of the Senate. Each and
- 25. every one of us daily as we drive down the highway can't help
- 26. but be impressed with the fact that the fifty-five mile an hour
- 27. speed limit is something that is not universally observed. As
- 28. a matter of fact, I think it's safe to say that ninety-five
- 29. percent of...ninety-five percent of the operators of our motor
- 30. vehicles are lawbreakers. That in itself is unfortunate and it
- 31. appears to me that the time has come to review the advantages,
- 32. if any, as well as the disadvantages, both economic and personal,
- 33. which this fifty-five mile an hour speed limit imposes. So

- 1. Senate...Joint Resolution 55 asks the Director of the Department
- of Transportation and the Director of the Department of Business
- 3. and Economic Development to conduct a joint investigation into
- 4. the effect of the fifty-five mile an hour speed limit in Illinois,
- 5. including its effectiveness, the economic impact and report
- 6. back to the Senate and that's all it does, Mr. President.
- 7. PRESIDING OFFICER: (SENATOR BRUCE)
- 8. Is there discussion? Senator Grotberg.
- 9. SENATOR GROTBERG:
- 10. Will the sponsor yield?
- 11. PRESIDING OFFICER: (SENATOR BRUCE)
- 12. Indicates he will yield. Senator Grotberg.
- 13. SENATOR GROTBERG:
- 14. Senator Berning, assuming that they've studied and done
- 15. all of these things, what possible impact could they have on a
- 16. Federal law?
- 17. PRESIDING OFFICER: (SENATOR BRUCE)
- 18. Senator Berning.
- 19. SENATOR BERNING:
- 20. Senator, you may not recall but there is no Federal law.
- 21. The fifty-five mile an hour is a club that is utilized as a
- 22. threat to withhold Federal funding for essentially interstate
- 23. highway construction. That's for all intents and purposes
- 24. completed here in Illinois and I submit might not have any
- 25. impact at all for us. But this is what the Director of the
- 26. Department of Transportation as well as the Department of
- 27. Economic and...BED would determine for us. That's part of the
- 28. objective of the resolution.
- 29. PRESIDING OFFICER: (SENATOR BRUCE)
- 30. Senator Grotberg.
- 31. SENATOR GROTBERG:
- 32. Well, that...it may be in your district that all of the
- 33. Federal highway money is gone, but it still accounts for about

- 1. fifty to seventy-five and some cases ninety cents on the dollar
- 2. of everything that's going on in my district through the Depart-
- 3. ment of Transportation. It seems to me that this is the first I've
- 4. heard of this resolution, Senator and it'll cost money to do it...
- Well, thanks for everything.
- 6. SENATOR BERNING:
- 7. Okay.
- 8. PRESIDING OFFICER: (SENATOR BRUCE)
- 9. Is there further discussion? Senator Berning may close
- 10. the debate. Senator Kenneth Hall. Senator Hall, I saw your
- 11. light, but you were off the Floor.
- 12. SENATOR KENNETH HALL:
- 13. Yeah.
- 14. PRESIDING OFFICER: (SENATOR BRUCE)
- 15. Senator Kenneth Hall.
- 16. SENATOR KENNETH HALL:
- 17. Will the sponsor yield to a question?
- 18. PRESIDING OFFICER: (SENATOR BRUCE)
- 19. Indicates he will yield. Senator Hall.
- 20. SENATOR KENNETH HALL:
- 21. Senator, I'm sorry...Did I understand you correctly to
- 22. say that there was no law passed on this, that...Would you
- 23. rephrase that again, please?
- 24. PRESIDING OFFICER: (SENATOR BRUCE)
- 25. Senator Berning.
- 26. SENATOR BERNING:
- 27. The question was whether there's Federal law. Senator
- 28. we do have "yes" in Illinois. The fifty-five mile an hour
- 29. speed limit and its objective was to control you and me and
- 30. other drivers so that the fifty-five mile an hour limit would
- 31. help the State of Illinois qualify for Federal funding and it's
- 32. my understanding that the regulations for the distribution
- 33. of Federal money indicates that a state must have this law, but

- there is no Federal law to the best of my unstanding. Now,
- whether or not we are accomplishing the objectives or any or
- 3. all of the objectives is what I would like to have these two
- gentlemen from these departments determine for us so that we
- 5. may then decide to either reaffirm our commitment to the
- 6. fifty-five mile an hour and you and I observe it or perhaps,
- let's get rid of it.
- 8. PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Kenneth Hall.
- 10. SENATOR KENNETH HALL:
- 11. Well, Senator...if I can remember correctly when this
- 12. came up I was on the Transportation Committee. My understanding
- 13. was that if a state did not comply that the Federal Government
- 14. would withdraw the money that they're drawing from the Federal
- 15. Government. Now, if your resolution passes or if they find
- 16. out this is not accomplishing what it... Are you advocating
- 17. that we lose this money that's coming to the state by this
- 18. resolution?
- 19. PRESIDING OFFICER: (SENATOR BRUCE)
- 20. Senator Berning.
- 21. SENATOR BERNING:
- 22. Senator, I'm not advocating that we lose any money or
- 23. that we give up anything. You may recall that it didn't cause
- 24. us to lose any money when we eliminated the Helmet Act. I happen
- 25. to believe that the Federal Government would not withhold monies
- 26. from the State of Illinois. But that would be one of the things
- 27. that would be the end result of the report and recommendation
- 28. by the directors of these...two departments.
- 29. PRESIDING OFFICER: (SENATOR BRUCE)
- 30. Senator Kenneth Hall.
- 31. SENATOR KENNETH HALL:
- 32. Well, I'm just trying to get a clarification of this.
- 33. In other words, if I read this correctly now. You're asking

- 1. if this does not do what it's intended to do, then you're saying
- 2. that we either do away with the fifty-five mile an hour speed limit,
- 3. which will and you...are you under the impression that the
- 4. Federal Government will allow the State of Illinois to do it
- 5. when everybody else has to comply with it without losing
- 6. Federal funds?
- 7. PRESIDING OFFICER: (SENATOR BRUCE)
- 8. Senator Berning and the gentleman's time has expired.
- 9. SENATOR BERNING:
- 10. Senator, all I am suggesting is that we review the matter.
- 11. I am not saying that we ought to abandon the fifty-five mile an
- 12. hour at this point. But let's have some additional information
- 13. in order to make a determination. It's a pure and simple fact
- 14. that most people are not abiding by the law and I just would
- 15. suggest that perhaps, if a toll or record were kept of all of
- 16. the members of this General Assembly we would find that most if
- 17. not all are violators and why should we be if it's producing
- 18. no good. I'd like to know that it is producing some good, this
- 19. fifty-five mile an hour speed limit and whether we would be
- 20. penalized if we did eliminate it. That's what I hope to find
- 21. out by this simple little investigation. It costs us nothing
- 22. and imposes no mandate on us.
- 23. PRESIDING OFFICER: (SENATOR BRUCE)
- 24. Senator Graham.
- 25. SENATOR GRAHAM:
- 26. Just two things. First of all, on a point of personal
- 27. privilege. I'd like to introduce...
- 28. PRESIDING OFFICER: (SENATOR BRUCE)
- 29. State your point, Senator.
- 30. SENATOR GRAHAM:
- 31. ...to the Senate, Doctor and Mrs. Hess from Elgin. Roger
- 32. and Mary, will you stand and be recognized...
- 33. PRESIDING OFFICER: (SENATOR BRUCE)

- 1. Would you please stand and be recognized by the Senate.
- SENATOR GRAHAM:
- 3. Secondly of all, Mr. President, it seems like if this
- 4. sort of a resolution...is going to precipitate a lot of
- 5. argument, don't we have a committee to handle that?
- 6. PRESIDING OFFICER: (SENATOR BRUCE)
- 7. Yes, Senator. Further discussion? Senator Ozinga.
- 8. SENATOR OZINGA:
- 9. Mr. President, I'm a little fearful of this resolution
- 10. for two reasons. Number one, we know what the answers going to
- 11. be before we even ask the question because they are going to
- 12. eulogize what a great thing it is to have so many less deaths
- 13. and so much this and so much that, which will be just a lot
- 14. of rhetoric. But, secondly, this might might arise the ire
- 15. of the state troopers to the extent when I go fifty-six miles
- 16. an hour I might get pinched.
- 17. PRESIDING OFFICER: (SENATOR BRUCE)
- 18. Senator Graham.
- 19. SENATOR GRAHAM:
- 20. I...I'm not going to break a rules and I won't do it
- 21. to ask that the Senate please recognize Miss Savoy and her
- 22. class from Barrington in the gallery behind the President.
- 23. Have them please stand and be recognized.
- 24. PRESIDING OFFICER: (SENATOR BRUCE)
- 25. Would the class please...please stand and be recognized.
- 26. PRESIDING OFFICER: (SENATOR BRUCE)
- 27. And thank you, Senator Graham for not breaking our rules.
- 28. Is there further debate on this matter? Senator Mitchler.
- 29. SENATOR MITCHLER:
- 30. Just a quick question of the sponsor...What type of
- 31. clout do you have with the Secretary of the Senate to have this
- 32. Senate Joint Resolution No. 55? ·
- 33. PRESIDING OFFICER: (SENATOR BRUCE)

- Senator Berning.
- SENATOR BERNING:
- 3. That was part of the strategy. It affects the fifty-five
- 4. mile an hour speed limit and primarily effects highway fifty-
- 5. five. And sixty-five...
- 6. PRESIDING OFFICER: (SENATOR BRUCE)
- Senators...
- 8. SENATOR BERNING:
- 9. As...as one parting comment...
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 11. Well, Senator Berning...just to answer his question. Now
- 12. if we may go on with the debate. In fact introduce...
- 13. SENATOR BERNING:
- 14. Oh, I thought that was it, Sir.
- 15. PRESIDING OFFICER: (SENATOR BRUCE)
- 16. No, Senator Soper is seeking recognition. Senator Soper.
- 17. SENATOR SOPER:

- 18. I think we've heard enough of this gem. I move the
- 19. previous question.
- 20. PRESIDING OFFICER: (SENATOR BRUCE)
- 21. Senator Soper has moved the previous question. Is there...
- 22. is there debate on the motion. All in favor say Aye. Opposed
- 23. Nay. That question is on the main motion. Senator Berning has
- 24. moved that the adoption of Senate Joint Resolution 55. All in
- 26. call. The question is on the adoption of Senate Joint Resolution

favor say Aye. Opposed Nay. There's been a request for a roll

- 27. 55. Those in favor vote Aye. Those opposed vote Nay. The
- 28. voting is open. Have all voted who wish? (Machine cutoff)
- 29. voted who wish? Take the record. On that question the Ayes are
- 30. 32, the Nays are 19 and 1 Voting Present. Senate Joint Resolution
- 31. having received the majority of those voting on the issue is
- 32. declared passed. Senator Harber Hall on SJR 59. Did you wish
- 33. to have that heard today, Senator Hall? Senator Harber Hall is

- 1. recognized. Gentlemen and Ladies, can we...can we have some
- 2. order please. Senator Harber Hall.
- 3. SENATOR HARBER HALL:
- 4. Mr. President and fellow Senators. Senate Joint
- 5. Resolution 59 memorializes the Congress to enact legislation
- 6. that will better help the states enforce tax statutes that
- 7. have joint coordination with the Federal. Right now we are
- 8. not, for example, in Illinois permitted to audit returns of the
- 9. Federal returns to compare those with our own Revenue Statutes
- 10. so that we get the same results and the same relative income
- 11. from the revenue involved because of Federal Statutes prohibiting
- 12. people from access to those records. I would point out that
- 13. the Auditor General is under strict...and his...all his
- 14. personnel are...under strict statutory confidentiality
- 15. restrictions the same as Federal employees are. So, I think
- 16. this is a good bill. It's been requested by the Audit
- 17. Commission and the Auditor General and I would like to send
- 18. this over to the House for their ratification, too.
- 19. PRESIDING OFFICER: (SENATOR BRUCE)
- 20. Is there discussion? Senator Knuppel.
- SENATOR KNUPPEL:
- This is a...invades the confidentiality of the IRS. The...
- 23. that is the Internal Revenue Service return that you file for
- 24. whom? How wide a group of people?
- 25. PRESIDING OFFICER: (SENATOR BRUCE)
- 26. Senator Harber Hall.
- 27. SENATOR HARBER HALL:
- No one would have access to those records except through
- 29. the audit process and only the audit...Auditor General and his
- staff would have access to those records. And only where
- necessary by specific statutory revenue requirements of this
- 32. state that have coordination possibilities with the Federal:
- 33. PRESIDING OFFICER: (SENATOR BRUCE)

- Senator Knuppel.
- 2. SENATOR KNUPPEL:
- 3. Well then the only people that it really deals with is...
- 4. is probably state officials because the Auditor General wouldn't
- 5. be auditing the average non-official citizen in the State of
- 6. Illinois. Is that correct?
- 7. PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Harber Hall.
- 9. SENATOR HARBER HALL:
- 10. No, that is not exactly correct. For example, in the
- 11. audit of cigarette taxes, for example, that...that...there
- 12. would be occasion to audit the...the returns of companies...
- 13. doing business in...in Illinois and show that the Department
- 14. of Revenue's records of collection of revenue corresponds with
- 15. the income tax records of the IRS. And only in that audit
- 16. would...would that exchange be permitted. But there are many
- 17. others, of course. There...there are other areas in the
- 18. Statutes in other taxes that the same might apply. But I
- 19. just give the cigarette as an example.
- 20. PRESIDING OFFICER: (SENATOR BRUCE)
- 21. Senator Knuppel.
- 22. SENATOR KNUPPEL:
- 23. Well, I personally feel that after the Watergate
- 24. situation that...and the audits that were prompted by likes
- 25. or dislikes of your political enemies that this is a very
- 26. dangerous procedure, even though it is only for the Auditor
- 27. General. I don't think that was the purpose of creating
- 28. the Auditor General's Office and I personally would...would
- 29. oppose any further breakdown of the confidentiality that I
- 30, have in my income tax return. I think it's bad enough that
- 31. we have to file as many reports and you have almost have...
- 32. have to have an accountant now to keep up with the ethics
- 33. legislation. But I don't see why the Auditor General should have

- 1. any right to audit my Federal income tax and further breakdown
- 2. that confidentiality. Next time it will be somebody else and some-
- 3. body else. I...I'm going to have to vote against it.
- 4. PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Daley.
- 6. SENATOR DALEY:
- 7. Will the sponsor yield to a few...
- 8. PRESIDING OFFICER: (SENATOR BRUCE)
- Indicates he will yield.
- 10. SENATOR DALEY:
- 11. ...questions.
- 12. PRESIDING OFFICER: (SENATOR BRUCE)
- 13. Senator Daley.
- 14. SENATOR DALEY:
- 15. Senator, I had a bill last year which provided written
- 16. notice to any Illinois taxpayer whereby the Federal Government
- 17. is coming in and looking at their returns. Will this give the
- 18. Illinois taxpayer the right to some notice that a Federal agency
- 19. is looking at their tax returns?
- 20. PRESIDING OFFICER: (SENATOR BRUCE)
- 21. Senator Harber Hall.
- 22. SENATOR HARBER HALL:
- 23. Well, the Federal agency has...already has that. This
- 24. would be a state agency. I recall your bill and I recognize
- 25. what you're trying to do. This...this wouldn't pertain to...
- 26. to that. It...it enables...it doesn't give any additional
- 27. warning. It couldn't because the warning you or the twelve
- 28. day notice that you were asking for, as I recall it, would
- 29. only apply to the Internal Revenue system. This provides that
- 30. through our audit required in the Constitution and supplemented
- 31. by Statutes that we, right now, cannot really perform the
- 32. required function of...of the audit if we can't take the records
- 33. submitted by the Department of Revenue and audit them against

- 1. soemthing. And we cannot audit them against the reports of the
- 2. IRS. We can audit them against other things, but we can't
- 3. compare them with the...the IRS at the present time because of
- 4. the Federal Statutes. But to answer your question, it wouldn't
- 5. change as that.
- 6. PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Daley.
- 8. SENATOR DALEY:
- 9. Yeah, but what you...you're trying to do is to look at
- 10. someone's Federal return. Correct? Without giving any notice
- 11. whatsoever. I... I again I put my bill in it. Last year it
- 12. was victorious in the House and the Senate and the Governor
- 13. vetoed the bill. It passed the Senate but, of course, the House
- 14. stalled the bill. Again I put the bill in and I firmly believe
- 15. that taxpayers should have a right to a notice whatever agency,
- 16. a...a township, a city, a county, a state or the Federal
- 17. Government who looks into someone's return. They should have a
- 18. notice that state agencies are looking at their returns and...
- 19. and I oppose this resolution.
- 20. PRESIDING OFFICER: (SENATOR BRUCE)
- 21. Is there further discussion? Senator Nimrod.
- 22. SENATOR NIMROD:
- 23. Yes, Mr. President, a question to the sponsor.
- 24. PRESIDING OFFICER: (SENATOR BRUCE)
- 25. Indicates he will yield.
- 26. SENATOR NIMROD:
- 27. Does this mean that the Department of Revenue already
- 28. has this means of exchanging information within the state?
- 29. Do they not?
- 30. PRESIDING OFFICER: (SENATOR BRUCE)
- 31. Senator Harber Hall.
- 32. SENATOR HARBER HALL:
- 33. Yes. The Illinois Department of Revenue presently has

- 1. access to Federal income tax returns, as you know. They are
- 2. all qualified through...confidentiality of the Statutes to
- treat this in strict confidence as the same as the Federal
- 4. IRS personnel have. This would expand that availability
- 5. of records to our Auditor General who has a...a very small
- 6. staff, but they are very necessary in the proper audit of
- 7. state funds and all state agencies. They cannot properly,
- 8. at this time, audit the Illinois Department of Revenue because
- 9. there's nothing to check against.
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 11. Senator Nimrod.
- 12. SENATOR NIMROD:
- 13. Yes. Well, thank you, Senator Hall. The...the reason
- 14. I asked that question is then we should not have any concern,
- 15. or fear is, that this information on our personal income tax
- 16. is going to be expanded because it's already there for the
- 17. Department of Revenue in that area and what this is doing
- 18. is giving the...the Auditor General the powers on his investigations
- 19. to make some comparisons that...in fact the incomes that are
- 20. reported Federally and State-wide, are in fact, in balance. And
- 21. it seems to me that this would be a proper extension.
- 22. PRESIDING OFFICER: (SENATOR BRUCE)
- 23. Further discussion? Senator Graham.
- 24. SENATOR GRAHAM:
- 25. Mr. President and members of the Senate. This resolution
- 26. is, in fact, a product of the Legislative Audit Commission and
- 27. is...was bipartisanly supported in that commission and after
- 28. some hearings and some discussion it was thought by the
- 29. Legislative Audit Commission that this was a good proposition
- 30. and so as we start debating the pros and cons of it, debating
- 31. with fellows: who have put in a lot of time on it realizing the
- 32. complications of it and realizing it is not as bad as a lot of
- 33. people think it might be. I just want you to know that the

- 1. Legislative Audit Commission recommends this to you and so do
- 2. I.
- 3. PRESIDING OFFICER: (SENATOR BRUCE)
- 4. Is there further discussion? Question is on the adoption
- 5. of Senate Joint Resolution 59. All in favor say Aye. Opposed
- 6. Nay. There's been a request for a roll call. Roll call is on
- 7. the adoption of Senate Joint Resolution 59. Those in favor will
- 8. vote Aye. Those opposed will vote Nay. The voting is open.
- 9. Have all voted who wish? Have all voted who wish? Take the
- 10. record. On that question, the Ayes are 24, the Nays are 22.
- 11. 1 Voting Present. Senate Joint Resolution 59 is declared
- 12. adopted. For what purpose does Senator Bower arise? Senator
- 13. Bower.
- 14. SENATOR BOWER:
- 15. Point of personal privilege.
- 16. PRESIDING OFFICER: (SENATOR BRUCE)
- 17. State your point, Senator.
- 18. SENATOR BOWER:
- 19. I'd like to like Senator Graham and not violate the rules,
- 20. but we have from our district one of the finest commissioners
- 21. that ever graced the Illinois Commerce Commission and I'd like
- 22. to introduce Commissioner Helen Schmitt in the Presidents
- 23. gallery, Mr. President.
- 24. PRESIDING OFFICER: (SENATOR BRUCE)
- Would she please stand and be recognized. Senator Hynes,
- 26. announcements?
- 27. SENATOR HYNES:
- 28. Mr. President and members of the Senate two announcements.
- 29. First, there will be a meeting of the Rules Committee in the
- 30. President's Office at 11:00 a.m. tomorrow morning. Rules Committee
- 31. meeting at 11:00 a.m. and secondly, since our deadline for
- 32. introduction of bills was last Friday and the deadline for
- 33.. committee action is fast approaching we will have some administrative

- 1. problems in getting out notices of committee meetings for next
- 2. week and therefore, the joint leadership has decided that the
- 3. best way to expedite the committee hearings next week is to waive
- 4. in part the Six Day Notice requirement for posting. So that any
- 5. notice that is sent out by Friday of this week will be effective
- 6. for purposes of committee hearings next week. Therefore, the
- 7. committees will post the notices of bills as soon as they are
- 8. ready, of course, but if they are posted by Friday on the
- 9. board and...and the notices are mailed out that will be effective.
- 10. So I, therefore, Mr. President move to suspend the rules for the
- 11. purpose of waiving the Six Day Notice requirement for the
- 12. committee hearings next week to the extent that the notices will
- 13. be timely if, in fact, they are sent out and...and posted by
- 14. Friday of this week.
- 15. PRESIDING OFFICER: (SENATOR BRUCE)
- 16. You've heard the motion. Is there discussion? Is there
- 17. leave? Leave is granted. Senator Carroll.
- 18. SENATOR CARROLL:
- 19. Thank you, Mr. President. By way of announcement
- 20. Appropriations I will meet immediately after adjournment in
- 21. Room 212. Appropriations I in Room 212 immediately.
- 22. PRESIDING OFFICER: (SENATOR BRUCE)
- 23. Senator Johns.
- 24. SENATOR JOHNS:
- 25. Mr. President, as Chairman of the Democratic caucus I
- 26. want to call all the Democratic Senators together tomorrow
- 27. morning at 10:00 o'clock. 212. That's following...Sir. That's
- 28. immediately...Sir. Didn't you hear me? All right. Ten o'clock
- 29. tomorrow morning, Room 212. Democratic caucus. That's following
- 30. the Prayer Breakfast. Right, Senator Davidson?
- 31. SENATOR DAVIDSON:
- 32. Okay.
- 33. SENATOR JOHNS:
- 34. Ten o'clock.

- 1. PRESIDING OFFICER: (SENATOR BRUCE)
- Democratic caucus. Ten o'clock. Room 212. Senator
- 3. Donnewald for what purpose do you seek recognition?
- 4. SENATOR DONNEWALD:
- 5. Yes, Mr. President, I'd like to have leave of the
- 6. Body to re-refer Senate Bill 1483 from Appropriations II
- 7. to Appropriations I.
- 8. PRESIDING OFFICER: (SENATOR BRUCE)
- 9. Is there leave? Leave is granted. Senator Davidson
- 10. for what purpose do you arise?
- 11. SENATOR DAVIDSON:
- 12. Yes, purpose of announcement, Mr. President. I want
- 13. to remind all the members of the Senate who are going to
- 14. the Governor's Prayer Breakfast tomorrow morning. It is
- 15. tomorrow morning. Holiday Inn East at 7:45 a.m. And if
- 16. you don't have tickets, don't come. We're sold out.
- 17. PRESIDING OFFICER: (SENATOR BRUCE)
- 18. Further announcements. Senator Berning.
- 19. SENATOR BERNING:
- 20. Mr. President, I'd like to ask leave of the Body to
- 21. be shown as a cosponsor of Senate Bill 1865.
- 22. PRESIDING OFFICER: (SENATOR BRUCE)
- 23. Is there leave? Leave is granted. Further announcements?
- 24. Resolutions.
- 25. SECRETARY:
- 26. (Machine cutoff) Resolution 24...24...324 offered by
- 27. Senator Harber Hall. It's congratulatory.
