- 33. Mitchler. Just a moment. Senate Bill 320, Senator

- 1. Vadalabene. Senator Vadalabene do you wish to call the bill?
- 2. SENATOR VADALABENE:
- No, Mr. President. What I wanted to ask you was,
- 4. I have Senate Bill 1203 that was advanced to 3rd
- today and these bills have to be heard together,
- so, I'll just hold it for another day.
- 7. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 8. Senate Bill 323. Senator Bowers. Senator
- 9. Philip. Just a moment. As to Senate Bill 323,

- 18. Thank you, Mr. President. The bill does
- 19. exactly what the heading says. It's the
- 20. appropriation for the ordinary and contingent
- 21. expenses of the Dangerous Drugs Commission. There
- 22. was an amendment that reduced the appropriation
- 23. by some twenty some thousand dollars that...twenty-
- 24. four thousand dollars presented at the committee
- 25. by Senator Regner. That was a reduction based
- 26. upon the loan of a...of an investigator that
- 27. the committee felt wasn't needed and I would
- 28. appreciate support of the Senate.

- 10. Senator Philip.
- 11. SENATOR PHILIP:
- 12. Thank you, Mr. President and Ladies and
- 13. Gentlemen of the Senate. Senate Bill 324 as
- amended, appropriates four million, four hundred
- 15. and forty-two thousand, five hundred dollars
- 16. for the ordinary and contingency expense of
- 17. the Department of Insurance beginning July
- 18. 1. The amendment simply did two things. First
- 19. of all, it took two hundred thousand dollars
- 20. from contractual service and made it a separate
- 21. line item. Secondly, it decreased the request
- 22. for equipment by seventeen thousand, five hundred.

- 5. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Rupp.
- 7. SENATOR RUPP:
- Yes Sir, Mr. President.
- 9. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 10. You'll get used to that.
- 11. SENATOR RUPP:
- 12. This is the first time...the first time I've
- 13. had folks from my district in the President's
- 14. gallery. I would like to have them...
- 15. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Please stand and be recognized.
- 17. SENATOR RUPP:
- 18. These are the ladies from the Christian County
- 19. Farm Bureau.
- 20. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 21. Please stand and be recognized.
- 22. Now for the bill.
- 23. SENATOR RUPP:
- 24. It's the first time I've had people in the
- 25. audience here and in the gallery and they're...right.

- 10. to say was to bring it back to 2nd for purpose

- 12. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 13. We've got it marked. He's going to have that opportunity.
- 14. Senator Rhoads, you wish to move that bill back
- 15. to the Order of 2nd reading?

- 17. That's correct. I promised Senator Buzbee I would.

- 27. There were no committee amendments. I offered
- 28. no amendments.
- 29. SECRETARY:
- 30. I...I have an amendment here with Senator Rhoads'
- name on it. It apparently must be Senator Buzbee.
- 32. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 33. Correct it, Mr. Secretary. Senator Buzbee.

SECRETARY:

- Amendment No. 1 offered by Senator Buzbee.
- SENATOR: BUZBEE:
- This amendment deletes eighty-nine thousand
- 5. seven hundred twenty-one dollars from the
- 6. Department of Military and Naval Affairs. This
- 7. would take away the money for the operation of the
- 8. Naval Militia... Naval Militia Armory which is
- 9. situated on the Outer Drive in Chicago on the
- 10. Z curve. Those of you who have driven that
- 11. know about where it is. It's my understanding
- 12. that the City of Chicago is in the process of
- 13. straightening out that Z curve. It's
- 14. also...and so that armory will not be needed. The
- 15. Naval Militia, of course, has not been used in
- 16. the State of Illinois since 1935. These folks
- 17. that belong to the Naval Militia are all naval
- 18. reservists and as such, they are paid by the
- 19. United States Navy and that is a very worthy cause
- 20. that they function in...in that respect. However,
- 21. when it comes to the naval branch of the Illinois
- 22. State Government, it's been a long time since
- 23. Michigan has been mad enough at us to attempt
- 24. an amphibious warfare against us and so, we
- 25. don't really have need of this eighty-nine
- 26. thousand dollars which we're spending
- 27. every year to keep a few people in...in a billet
- 28. that's called the Naval Militia. It's not like
- 29. the National Guard. The National Guard, of course,
- 30. in Illinois, is called up quite frequently for
- 31. duties here in the State and as such, they are paid
- 32. for that by the State Government. These people have
- 33. no duties and so I see no reason to spend the

- 1. eight-nine thousand dollars every year and that's
- why I offer this amendment.

- Senator Rock.
- 5. SENATOR ROCK:
- 6. Thank you, Mr. President, Ladies and Gentlemen
- 7. of the Senate. I rise in opposition to Amendment
- 8. No. 1. The Naval Armory in the City of Chicago,
- 9. I think, should not be a subject of concern to
- 10. the Senator from Carbondale and I would hope
- 11. that everybody would oppose Amendment No. 1.
- 12. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 13. Just a moment. There are...Senator Graham
- is next.
- 15. SENATOR GRAHAM:
- 16. Mr. President, members of the Senate. I
- 17. would like to ask the Senator from Carbondale a
- 18. couple of questions.
- 19. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 20. He indicates he will yield.
- 21. SENATOR GRAHAM:
- 22. First of all, haven't you former Marines got
- 23. through fighting with the Navy yet?
- 24. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Buzbee.
- 26. SENATOR BUZBEE:
- 27. Senator Graham, I'm...I'm glad you asked
- 28. that question, because as a matter-of-fact,
- 29. that very point was brought up by some of these
- 30. folks who belong to the Naval Militia, to my...
- 31. to my ex-commanding officer in the reserve unit
- 32. when I have drilled at Glenview and this has got absolutely
- 33. nothing to do with the traditional Navy Marine

- 1. fight. I am very much in favor of the continuation of
- 2. the United States Naval Reserve Program and am
- 3. supportive of that. This is the Illinois State
- 4. Naval Militia. And we just don't have anything
- 5. to patrol in Illinois. You know, our coast line
- 6. is secure and Michigan isn't mad at us so...not
- 7. that mad. So, it's really got nothing to do,
- 8. Senator Graham. I'm really glad you brought the
- question up, because it's really got nothing
- 10. to do with the traditional tongue-in-cheek fight
- 11. between the Navy and the Marines.
- 12. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 13. Now, are you sorry you answered the question?
- Senator...Senator Graham.
- 15. SENATOR GRAHAM:
- 16. I just...I want to make another statement and
- 17. please don't answer this, Senator Buzbee.
- 18. First of all, if Chicago's coastline was as
- 19. secure as Carbondale's, I could understand
- 20. your attitude. I want to remind you that I think
- 21. it's time, though, that you quit picking on the
- 22. Navy, because when they took me overseas in World
- 23. War II, we fellows...the Air Force, they told us
- 24. that you fellows in the Marines were the
- 25. seagoing bellhops and I guess that battle is still
- 26. going on. Thank you, very much.
- 27. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 28. Senator Maragos.
- 29. SENATOR MARAGOS:
- 30. I would like to ask the sponsor of the amendment
- 31. whether there might be cause for the militia to
- 32. go down the Mississippi River to protect us from
- 33. Missouri now that the Air Force is going to be taken

- 1. away from us.
- PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Buzbee.
- 4. SENATOR BUZBEE:
- 5. We always have the National Guard for that,
- 6. Senator, and...so we can call them out for that.
- 7. In fact, that may become necessary at some point.
- 8. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Savickas.
- 10. SENATOR SAVICKAS:
- 11. Well, I would just like to remind Senator
- 12. Buzbee that since 1935 no ships have been sunk
- 13. on Lake Michigan so I think this is an item
- 14. that we should take in consideration.
- 15 PRESIDING OFFICER: (SENATOR DONNEWALD)
- 16. I see we're honored to have the Lieutenant
- 17. Governor in our midst on the right side of the
- 18. aisle. To my right. Senator Vadalabene.
- 19. Senator...Senator Buzbee's mike. Governor.
- 20. LIEUTENANT GOVERNOR O'NEAL:
- 21. Senator Graham, I love you dearly, but I'm
- 22. a Marine and I want you to watch that.
- 23. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 24. Senator Vadalabene.
- 25. SENATOR VADALABENE:
- Yes, thank you, Mr. President. The Marine
- 27. doesn't bother me, neither does Senator Buzbee.
- 28. I just want to remind Senator Graham that Carbondale
- 29. is not as secure as he thinks it is. Don't forget,
- 30. there's S.I.U., Edwardsville.
- 31. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 32. Is there further debate? The question is shall
- 33. Amendment...just a moment. Senator Buzbee, do you

- wish to close the debate?
- 2. SENATOR BUZBEE:
- 3. Well, Mr. President, we've had a lot of fun
- 4. and frivolity and I certainly take it in the spirit
- 5. of which it's intended. However, I would like to
- emphasize that I am quite serious about this and
- 7. I'm not trying to become involved in the City
- 8. of Chicago's affairs. I know much better than to
- 9. do that except to say this is eighty-nine
- 10. thousand dollars of state money for something

- there was a conflict of interest under Section
- 25. V of the Housing Authority Act. Because of this
- 26. decision, several hard working, sensitive,
- 27. articulate tenant commissions were forced to
- 28. resign from the Board of the Local Housing Authority
- and because of this decision, local authorities are
- 30. absolutely barred from having voting tenant members
- 31. of the commission. Now, if a city mayor, village
- 32. president, or county board chairman are present,
- 33. wishes to appoint a tenant of the Local Housing Authority

- 1. Commission, he or she should be allowed to do so.

- I have...I ask the law firm to prepare a statement
- 2. for me and they have, which runs five pages in length. It
- 3. includes appearances in both New York and Illinois. There
- 4. were cross complaints filed. They were retained by the
- 5. Attorney General directly. As you know the Department of
- 6. Personnel does not choose their counsel. That is choosen
- 7. by the Attorney General. There was some discussion...we
- 8. recovered two hundred andthirty-five thousand dollars.
- 9. There was some discussion that we would pay their legal
- 10. fees out of that. It was the commission's advice and the
- 11. Department of Personnel so that we would have a clear
- 12. record of how much was recovered and how much was paid
- 13. that we would submit vouchers and pay it directly and
- 14. the two hundred and thirty-five thousand dollars was
- 15. returned to the General Fund of the State Treasury.
- 16. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Knuppel.
- 18. SENATOR KNUPPEL:
- 19. Can you determine from that bill what the usual
- 20. and customary charges per hour were levied by that
- 21. firm was or were?
- 22. PRESIDING OFFICER: (SENATOR ROCK)
- 23. Senator Bruce.
- 24. SENATOR BRUCE:
- 25. No, Senator Knuppel I cannot. All...all they have is
- 26. the numbers of appearances starting with January 30th, 1974
- 27. through their final appearance before United States Judge
- 28. Richard Austin, I believe, and the fact that they had
- 29. prepared motions, filing motions, production of documents,
- 30. motion to strike certain paragraphs, they appeared before
- 31. Judge Healy, motions and so forth, telephone calls, corres-
- 32. pondence and office...office conferences, long distance
- 33. telephone calls, twenty-seven dollars and seventy-seventy
- 34. cents.

- 1. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Knuppel.
- 3. SENATOR KNUPPEL:
- Well I'm...I'm real concerned because when I went with
- 5. the Attorney General in 1961:there was some very inflated
- 6. bills that were being rendered by lawyers to that office
- 7. and at that time the Attorney General adopted some...some
- 8. . charge schedules as to what would be paid for legal services
- 9. rendered. I thought I heard the name of Leroy Sandquist in
- 10. there someplace too, I think he's in the General Assembly
- 11. now is he not.
- 12. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Bruce.
- 14. SENATOR BRUCE:
- 15. That is...yes.
- 16. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Knuppel.
- 18. SENATOR KNUPPEL:
- 19. I...I know and you know that there are routine or
- 20. customary charges depending on the experience of an
- 21. attorney and the nature of the proceedings at an hourly
- 22. rate and that today for example even in probate fees and
- 23. closing since the Goldfarb case that there ought to be it
- 24. seems to me something more specific than just a general
- 25. bill. It ought to outline at least the number of hours
- 26. spent on each appearance and so forth. Just to put a
- 27. bill and say I appeared in court and that's two hundred
- 28. dollars, you might have been there three minutes, you
- 29. might have been there with five other things and...and
- 30. feel that we're entitled at least to know something more
- 31. than just a flat out six thousand dollars or whatever it
- 32. is as the number of hours spent on these things. I'm
- 33. sure that they have carefully itemized the telephone bills

- 1. and so forth, but I have a lot of misgivings about a bill
- 2. that comes in here that doesn't say what the hourly charges
- 3. were for the lawyers involved in this day and age we're
- 4. living in.
- 5. PRESIDING OFFICER: (SENATOR ROCK)
- 6. Any further discussion? Senator Weaver.
- 7. SENATOR WEAVER:
- Question, sponsor.
- 9. PRESIDING OFFICER: (SENATOR ROCK)
- Indicates he will yield. Senator Weaver.
- 11. SENATOR WEAVER:
- 12. Senator Bruce, did you state that the Court of
- 13. Claims refused to hear this case?
- 14. PRESIDING OFFICER: (SENATOR ROCK)
- 15. Senator Bruce.
- 16. SENATOR BRUCE:
- 17. No, I did not state that.
- 18. PRESIDING OFFICER: (SENATOR ROCK)
- 19. Senator Weaver.
- 20. SENATOR WEAVER:
- 21. This one of those...one of the areas where the
- 22. Court of Claims should consider these and . . and put it.
- 23. in their annual appropriation.
- 24. PRESIDING OFFICER: (SENATOR ROCK)
- 25. Senator Bruce.
- 26. SENATOR BRUCE:
- 27. Well there...there would be no appropriation against
- 28. which they could run. The claim, Court of Claims, often
- 29. times deal with contracts where there's over-runs where
- 30. they can take a look and see where the claim is justified.
- 31. There would be no record except that the letter of the
- 32. Attorney General retaining the firm to represent the
- 33. State of Illinois. There is no appropriation, it's a
- 34. professional services contract and there wouldn't there

- 1. would be no line item for it.
- 2. PRESIDING OFFICER: (SENATOR ROCK)
- Further...Senator Weaver.
- 4. SENATOR WEAVER:
- 5. That's not to say that there couldn't be a line
- 6. item put in this year's appropriation to pay this claim.
- 7. If they so judge that...is that true?
- 8. PRESIDING OFFICER: (SENATOR ROCK)
- 9. Senator Bruce.
- 10. SENATOR BRUCE:
- 11. That would be possible. It was the determination
- 12. of the Department of Personnel and the Group Insurance
- 13. Advisory Commission after consulting with several
- 14. individuals that it would be more appropriate to pay
- 15. them directly. We could have put it in the Department
- 16. of Personnel bill. It was my feeling that we ought to
- 17. run it as an individual appropriation. They did return
- 18. two hundred and thirty-five thousand dollars in good
- 19. faith in their professional efforts. That's what was
- 20. returned. We have paid them all of the twenty-one thousand
- 21. dollar fee except this six thousand. There's never been
- 22. a question by the Attorney General or the Department of
- 23. Personnel that the money is due and owing. It is an
- 24. inadvertent act by the Attorney General that he did not
- 25. inform them that they should bill on a fiscal basis and
- 26. I find it hard to rationalize saying to that firm, now
- 27. having retained you as our attorney, sue us to get your
- 28. fee. It just doesn't seem to be reasonable.
- 29. PRESIDING OFFICER: (SENATOR ROCK)
- 30. Any further discussion? All right the question...
- 31. you wish to close Senator Bruce? All right. The question
- 32. is shall Senate Bill 488 pass. Those in favor will vote
- 33. Aye. Those opposed will vote Nay. The voting is open.

- 1. Have all voted who wish? Have all voted who wish? Take
- 2. the record. On that questio the Ayes are 33, the Nays
- 3. are 1, 7 Voting Present. Senate Bill 488 having received
- 4. the constitutional majority is declared passed. We are
- 5. at this point I am led to believe constrained to retire
- 6. to our respective committees. Senator Hynes.
- 7. SENATOR HYNES:
- 8. Mr. President could we stand at ease for just
- 9. one moment till we get some information.
- 10. PRESIDING OFFICER: (SENATOR ROCK)
- 11. Senator Savickas.
- 12. SENATOR SAVICKAS:
- 13. At this time Mr. President I'd make a motion on
- 14. the move to discharge the committee of Labor and Commerce
- 15. from further consideration of Senate Bill 1072 and that
- 16. the bill be re-referred to the Committee on Local Government.
- 17. It's a an annexation or easement bill.
- 18. PRESIDING OFFICER: (SENATOR ROCK)
- 19. All right. Senator Savickas has moved to discharge
- 20. the Committee on Labor and Commerce from further consider-
- 21. ation of Senate Bill 1072 for the purpose of re-referral
- 22. to the Committee on Local Government. All those in
- 23. favor signify by saying Aye. All those opposed. The Ayes
- 24. have it. So ordered. Senator Walsh.
- 25. SENATOR WALSH:
- 26. Mr. President and members of the Senate. I would
- 27. make a similiar motion to discharge the Committee on
- 28. Elections from further consideration of Senate Bill 1162
- 29. with the hope that that bill be committed to the committee
- 30. on Higher Education. It deals with the Public Community
- 31. College Act. I have discussed this with Chairman Kosinski
- 32. and Hickey.
- 33. PRESIDING OFFICER: (SENATOR ROCK)

- All right. Senator Walsh has moved to discharge the
- Committee on Elections and Reapportionment from further
- 3. consideration of Senate Bill 1162 for the purpose of re-referral
- 4. to the Committee on Higher Education. All those in favor
- 5. signify by saying Aye. All those opposed. The Ayes have
- 6. it. So ordered. Senator Hynes.
- 7. SENATOR HYNES:
- 8. Mr. President I...I would ask that with respect to
- 9. these motions that the Chairman of the Committee on
- 10. Assignment of Bills be talked to about them and I don't
- 11. think that was the case in the prior one. Otherwise
- 12. we're going to have chaos out here on the Floor. So I
- 13. would ask that with respect to all future motions of that
- nature that they be cleared with the chairman.
- 15. PRESIDING OFFICER: (SENATOR ROCK)
- 16. That request is in order and will be recognized.
- 17. Senator Harber Hall.
- 18. SENATOR HALL:
- 19. Mr. President I'd like leave of the Senate for the
- 20. purpose of discharging Judiciary II in respect to Senate
- 21. Bill 579 for the purpose of Tabling this.
- 22. PRESIDING OFFICER: (SENATOR ROCK)
- 23. Senator Harber Hall has moved to discharge the com-
- 24. mittee on Judiciary II from further consideration of
- 25. Senate Bill 579. Those in favor signify by saying Aye.
- 26. Those opposed. The Ayes have it. The bill is discharged.
- 27. Senator Hall now moves to Table Senate Bill 579. All those
- 28. in favor signify by saying Aye. All those opposed. The
- 29. Ayes have it. The bill is Tabled. Senator Harber Hall.
- 30. SENATOR HALL:
- 31. I'd ask leave of the Body to have my name shown
- 32. as joint sponsor of Senate Bill 512. I've checked with
- the other principal sponsor of 512.

- 1. PRESIDING OFFICER: (SENATOR ROCK)
- You have heard the request. Is leave granted for
- 3. Senator Hall to be shown as cosponsor of Senate Bill 512.
- 4. Leave is granted. So ordered. Senator Berman.
- 5. SENATOR BERMAN:
- 6. Thank you Mr. President. On the Order of 2nd
- 7. reading appears Senate Bill 284. Through some error
- 8. Senator Walsh is shown as the principal sponsor. I
- 9. would ask that the Secretary's office show that I
- am the principal sponsor of Senate Bill 284.
- 11. PRESIDING OFFICER: (SENATOR ROCK)
- 12. It will be noted and corrected. Thank you
- 13. Senator Berman. Senator Don Moore.
- 14. SENATOR MOORE:
- 15. Thank you Mr. President. I would unanimous consent
- 16. to be shown as a cosponsor of Senate Bill 1310. I've talked
- 17. to the chief sponsor, Senator Maragos, he has no objection.
- 18. PRESIDING OFFICER: (SENATOR ROCK)
- 19. All right. You've heard the request. Is leave
- 20. granted? So ordered. Senator Wooten.
- 21. SENATOR WOOTEN:
- 22. Mr. President I would like to ask leave of the Body
- 23. to have Senate Bill 376 discharged from the Committee on
- 24. Local Government for the purpose of Tabling.
- 25. PRESIDING OFFICER: (SENATOR ROCK)
- 26. Senator Wooten has moved to discharge the Committee
- 27. on Local Government from further consideration of Senate
- 28. Bill 376. Those in favor signify by saying Aye. Those
- 29. opposed. The Ayes have it. The bill is discharged. Senator
- 30. Wooten now moves to Table Senate Bill 376. All those in
- 31. favor signify by saying Aye. All those opposed. The
- 32. Ayes have it. The bill is Tabled. Senator Demuzio.
- 33. SENATOR DEMUZIO:

- Well, Mr. President, if I might have Senator Shapiro's
- attention. This morning in the Finanche and Credit Regulations
- 3. Committee we had agreed to recess till four o'clock this
- 4. afternoon for the purpose of hearing a package of bills.
- 5. Well, we find ourselves now in the posture that we do not have
- 6. a place to have that hearing so I see no other alternative but to
- 7. hold the bills over until next week. And I've also talked
- 8. to Senator Washington and he has no objections. We cannot...
- g. so for the purposes of...for the announcement the Finance
- 10. and Credit Regulations Committee will meet next week and the
- 11. bills will be heard then.
- 12. PRESIDING OFFICER: (SENATOR ROCK)
- 13. All right. Further discussion? Further business
- 14. to come before the Senate. Senator Koskinski.
- 15. SENATOR KOSINSKI:
- 16. Mr. President and members of the Senate. I'd like
- 17. to have leave of the Body to have Senate Bills 768, 162,
- 18. 285, and 291 heard in the Senate Election Reapportionment
- 19. Committee this afternoon, at one-thirty in Room A-1. That
- 20. is with the other bills. These are all primary bills that
- 21. have been heard before the subcommittee and now we will
- 22. dispose of them one way or another.
- 23. PRESIDING OFFICER: (SENATOR ROCK)
- You heard the request. Is leave granted? So ordered.
- 25. Senator Lemke.
- 26. SENATOR LEMKE:
- 27. I rise to make a motion to have a bill taken from
- 28. Revenue, Senate Bill 719 and put into Judiciary I where
- 29. it should originally have been. I talked to Senator
- 30. Donnewald and he is in "agreeance" it should be a Judiciary
- 31. bill.
- 32. PRESIDING OFFICER: (SENATOR ROCK)
- 33. All right. Senator Lemke has moved to discharge

- 1. the Committee on Revenue from further consideration of
- Senate Bill 719 for the purpose of re-referral to Judiciary I.
- 3. All those in favor signify by saying Aye. All those opposed.
- 4. The Ayes have it. So ordered. Senator Harber Hall.
- 5. SENATOR HALL:
- Mr. President my hearings a little bad these days,
- 7. I just... ask the Body to make a motion in regard to
- 8. Senate Bill 579.
- 9. PRESIDING OFFICER: (SENATOR ROCK)
- 10. 579, that is correct.
- 11. SENATOR HALL:
- 12. And it...that was not in Judiciary, it's 599. So
- 13. we've taken the wrong action on the wrong bill. I would
- 14. now move Mr. President...
- 15. PRESIDING OFFICER: (SENATOR ROCK)
- 16. We have to reconsider the...
- 17. SENATOR HALL:
- 18. Reconsider the...
- 19. PRESIDING OFFICER: (SENATOR ROCK)
- 20. ...vote by which Senate Bill 579 was Tabled.
- 21. SENATOR HALL:
- 22. Was Tabled.
- 23. PRESIDING OFFICER: (SENATOR ROCK)
- 24. All right. All those in favor signify by saying
- 25. Aye. All those opposed. The Ayes have it. The vote
- 26. is reconsidered. Senator Harber Hall now moves to re-
- 27. commit Senate Bill 579 to...
- 28. SENATOR HALL:
- 29. No, it's on the Order of...it was reported out
- 30. today. It's should be on the Order of 2nd tomorrow.
- 31. PRESIDING OFFICER: (SENATOR ROCK)
- 32. All right. To recommit it to the Order from
- 33. which it was taken. So ordered. What's the bill now

- 1. you wish to Table.
- 2. SENATOR HARBER HALL:
- Senate Bill 599.
- 4. PRESIDING OFFICER: (SENATOR ROCK)
- 5. In which committee Sir?
- SENATOR HARBER HALL:
- 7. In Finance.
- 8. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Harber Hall has moved to discharge the
- 10. Committee on Finance from further consideration of Senate
- 11. Bill 599 for the purpose of Tabling. All those in favor
- 12. signify by saying Aye. All those opposed. The Ayes have
- 13. it. The bill is discharged. Senator Harber Hall now moves
- 14. to Table Senate Bill 599. All those in favor signify by
- 15. saying Aye. All those opposed. The Ayes have it. The
- 16. bill is Tabled. Any further business to come before the
- 17. Senate? Resolutions.
- 18. SECRETARY:
- 19. Senate Resolution 103 offered by Senators Regner
- 20. and Glass.
- 21. PRESIDING OFFICER: (SENATOR ROCK)
- 22. Executive.
- 23. SECRETARY:
- 24. Senate Joint Resolution 39, constitutional amend-
- 25. ment offered by Senators Soper, Guidice, Rhoads and others.
- 26. PRESIDING OFFICER: (SENATOR ROCK)
- 27. Executive. Any further business to come before
- 28. the Senate. Senator Bruce.
- 29. SENATOR BRUCE:
- Yes, Mr. President, I would want the Journal to
- 31. reflect that Senator Sangmeister is absent due to illness
- 32. and I would also like to...
- PRESIDING OFFICER: (SENATOR ROCK)

- As is Senator Egan. Thank you.
- 2. SENATOR BRUCE:
- Senator Egan also. And I would also like to
- 4. discharge the Committee on Executive Appointments and
- 5. Administration from further consideration of Senate Bill
- 1118 so that I might Table that bill.
- 7. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Bruce has moved to...to discharge the Com-
- 9. mittee on Executive Appointments from further consideration
- 10. of Senate Bill 1118 for the purpose of Tabling. All those
- ll. in favor signify by saying Aye. All those opposed. The
- 12. Ayes have it. The bill is discharged. Senator Bruce now
- 13. moves to Table Senate Bill 1118. All those in favor
- 14. signify by saying Aye. All those opposed. The Ayes have
- 15. it the bill is Tabled. Any further business to come before
- 16. the Senate. Senator Philip.
- 17. SENATOR PHILIP:
- 18. Thank you Mr. President. I have a House Joint
- 19. Resolution 21 on the Secretary's Desk that I'd like to
- 20. call if I'm in order.
- 21. PRESIDING OFFICER: (SENATOR ROCK)
- 22. Well, the hour of one thirty having arrived, we're
- 23. going to committee immediately. That having been said if
- 24. there's no further business to come before the Senate, Senator
- 25. Hynes moves that the Senate stand adjourned until Wednesday,
