- 28. It's going to be handled by Senator Maragos.
- 29. PRESIDING OFFICER: (SENATOR BRUCE)
- 30. Senator Maragos is recognized.
- 31. SENATOR MARAGOS:
- 32. Mr. President and members of the Senate. I respectfully
- 33. ask that the rules be suspended for immediate consideration

- 1. and reading of House Joint Resolution Constitutional
- 2. Amendment 21. This matter has been heard previously
- 3. by the Senate. It's the same subject matter which is
- 4. House...Senate Joint Resolution Constitutional Amendment
- 5. 29 which is now over in the House. And I ask for immediate
- 6. suspension of the rules.
- 7. PRESIDING OFFICER: (SENATOR BRUCE)
- 8. The motion is to suspend the rules and...and that
- 9. the resolution not be referred to the Committee on
- 10. Executive. Is there discussion? All in favor say Aye.
- 11. Opposed Nay. The Ayes have it. Senator Maragos.
- 12. SENATOR MARAGOS:
- 13. Now, Mr. President and members of the Senate, I respectfully
- 14. ask that the House Joint Resolution Constitutional Amendment
- 15. 21 be read for the first time.
- 16. PRESIDING OFFICER: (SENATOR BRUCE)
- 17. Is there...is there leave? Senator Hynes is recognized.
- 18. SENATOR HYNES:
- 19. Mr. President, before putting that question, there is
- 20. an identical resolution that will be coming over and
- 21. the same motion will be made. If we could just hold them
- 22. and read both of them one after another?
- 23. You have the other one, also? No,...you...I don't...Mr.
- 24. Secretary, you talking about House Joint Resolution 20?
- 25. That is not the identical resolution. There is another
- 26. one coming. And while there is...so if we could follow that
- 27. procedure when both are here, we'll read both of them.
- 28. We have...it is now on the Order of 1st reading, is it not?
- 29. PRESIDING OFFICER: (SENATOR BRUCE)
- 30. It is on the Order...and Senator Maragos, would you
- 31. withdraw your motion until such time as the other resolution
- 32. catches up with it? Senator Maragos.
- 33. SENATOR MARAGOS:

- Yes, if that's the wish of the Chair, I'll be glad to.
- 2. PRESIDING OFFICER: (SENATOR BRUCE)
- 3. The motion is withdrawn. The resolution is on the
- 4. Order of 1st reading. It has not been read yet today.
- 5. The rules have been suspended. It was not referred to
- 6. Executive Committee and is before the Body. For what
- 7. purpose does Senator Harber Hall arise?
- 8. SENATOR HARBER HALL:
- 9. That matter is now resolved, or...
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- Senator...yes, Senator, it's on the Order of 1st
- reading. It has not yet been read a first time.
- 13. SENATOR HARBER HALL:
- Well, Mr. President, in respect to House Joint
- Resolution 15, Constitutional Amendment, this resolution
- proposes to abolish the Board of...State Board of Education
- and have an elective Superintendent of Public Instruction.
- This House Joint Resolution was in the Executive Committee
- on the last day that the committee met last week and
- the sponsor could not be present...the House sponsor and the
- bill was not heard. However, the same matter was heard and
- passed through that committee and passed this Body earlier
- as a Senate Joint Resolution. For that reason, Mr. President, 23.
- I would ask leave of the Body to discharge committee in respect
- to HJR 15 and have it placed on the Order of 2nd reading. 25.
- I have spoken to the Chairman and Vice-Chairman of the
- $$\operatorname{\mathtt{Executive}}$$  Committee and I believe they would agree that this 27.
- process would be suitable.
- PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Rock is recognized.
- SENATOR ROCK:
- Only for the purpose, Mr. President, of objecting.
- It's scheduled for Executive tomorrow. We'll all be in Executive 33.

- 1. tomorrow and it can be heard.
- 2. PRESIDING OFFICER: (SENATOR BRUCE)
- 3. The motion is for the suspension of the rules...or for the
- 4. discharge of the Executive Committee from further consideration.
- 5. Senator Hall. Senator Harber Hall, can you give us the number
- 6. again, Senator?
- 7. SENATOR HARBER HALL:
- 8. HJR 15 CA.
- 9. PRESIDING OFFICER: (SENATOR BRUCE)
- 10. HJR 15...the motion...
- 11. SENATOR HARBER HALL:
- 12. I would...I would point out to Senator Rock, that
- 13. if it were heard tomorrow, that the time left remaining
- 14. to pass the Senate, there wouldn't be...there wouldn't
- 15. be sufficient time left since it has to be read three
- 16. times...three days.
- 17. PRESIDING OFFICER: (SENATOR BRUCE)
- 18. The motion is to discharge and Senators Berning,
- 19. Wooten, Netsch and Hynes have sought recognition.
- 20. Senator Berning. Senator Wooten. Senator Netsch.
- 21. SENATOR NETSCH:
- 22. Yes, I...I...you may have described briefly what the
- 23. subject matter was, Senator Hall, but I'm not sure
- 24. that everyone was paying attention. Would you kindly...and...
- 25. and while I...I'll put a second question to you. I'm still
- 26. not clear why you did not call it last week. As I understand
- 27. it, there was an opportunity to do that.
- 28. PRESIDING OFFICER: (SENATOR BRUCE)
- 29. Senator Harber Hall.
- 30. SENATOR HARBER HALL:
- 31. Well, thank you. I'll respond to both of those. First of all,
- 32. I will repeat that the House sponsor could not be present
- 33. at the committee hearing. As you recall, the committee hearing

- 1. was quite late in the day and the House sponsor had to
- 2. be somewhere else and couldn't be present to speak for his bill.
- 3. The...in respect to the explanation of the bill...or the
- 4. resolution, I think the Senator from Evanston could do a much
- 5. better job of describing what's in it, but briefly,
- 6. it removes the Superintendent of Public...Office of Education
- 7. from an appointed position to one of election and eliminates
- 8. the State Board of Education. The...I think everyone is
- 9. probably familiar with that since everyone who was present
- 10. voted one way or the other on the previous Senate Joint
- 11. Resolution that did pass this Body.
- 12. PRESIDING OFFICER: (SENATOR BRUCE)
- 13. Senator Netsch. Excuse me, Senator. May we have some
- 14. order. Can we clear the aisles? Senator Netsch.
- 15. SENATOR NETSCH:
- 16. Yes, well, one of the things that I was confused about,
- 17. Senator Hall, was that since the Senate had previously
- 18. considered a proposal which was, as I understand it, substantially
- 19. similar if not identical, why it was necessary for the House
- 20. sponsor to be there to present something which everyone was
- 21. already familiar with. I...it seems to me that...that part of the
- 22. problem is one that...that this Body created for itself by
- 23. the...some of the time schedules it set with respect to
- 24. three readings and all that sort of thing and I...I think we
- 25. have had our opportunity on this issue. The...the...I disagreed
- 26. With it, by the way, of course. I voted against the proposal
- 27. which you well know and it seems to me that since that proposal
- 28. is still over in the House, that we ought to let the House
- 29. respond to it in any way that it chooses, but that we ought
- 30. not to further confuse the rules by bringing this out without
- 31. the appropriate hearing.
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- 33. Senator Harber Hall.

## SENATOR HARBER HALL:

- Well, of course, there are many...there are many items
- 3. of legislation that concern the individual two Houses at
- 4. approximately the same time. In other words, duplication
- 5. of legislation. This is not an exception to that and certainly,
- 6. Senator, you would...you would acknowledge that there
- 7. is some pride of authorship in most legislation and I think
- 8. it's only reasonable to expect that the...the author of a
- 9. House...Resolution of Constitutional proportions and import
- 10. would like to be present at the Senate hearing, particularly
- when it's controversial as you are trying to make it now.
- 12. PRESIDING OFFICER: (SENATOR BRUCE)
- Senator, your time has nearly expired. Senator Netsch,
- do you have further questions? Senator Hynes. Senator
- Wooten.
- SENATOR WOOTEN:
- Yes, Mr. President. I am not going to oppose
- this motion to discharge because it seems to me I have 18.
- backed an awful lot of people, Senator Netsch and others, in
- trying to discharge bills from various committees.
- One of the reasons is that my vote in this had nothing to do
- with the present Superintendent. It's just that I
- think that position ought to be an elective one regardless
- of who is in it and unfortunately, Senator Hall did not
- take the opportunity last week, but I think principally
- because he, as many others in this Chamber, was 26.
- not really aware of the pressure of time. So, unless
- this whole business is just to be a gesture, we have 28.
- to discharge committee and...and get moving on it or it
- will be strictly an academic proposal. I think it's 30.
- too serious to be treated that way, so I will certainly

- 4. Well, I...I appreciate the fact that the sponsor has

- 6. fact is, it's before the committee and the last one should
- 7. not have gotten out of committee and I will try my best to hold
- 8. this one in and I would hope that it would stay in committee.
- 9. PRESIDING OFFICER: (SENATOR BRUCE)
- 10. Senator Buzbee.
- 11. SENATOR BUZBEE:
- Well, I...that...that clears the air considerably.
- If one is opposed, one is opposed. But, the fact of the
  - matter is that there were thirty-six people in this Body who,
- about three weeks ago, decided that this was a good concept
- and...and even though I understand the wording in this one
- is a little bit different than the wording in the other one,
- it is, in fact, the same concept. And I think we ought
- to go ahead and...and get this out, give the Body a chance
- to vote on it, give the voters a chance to vote on it.
- I'm constantly amazed at the editorial rath that has come 21.
- down on the heads of the lowly legislators because we
- conniving, dirty, rotten politicians are standing here and we
- don't know what we're doing, according to some of the press 24.
- editorily, and I happen to think we do. I happen to think the 25.
- majority of the peole in this State want the opportunity 26.
- to vote on this and then we'll just wait and see come 27.
- November if they agree with what some of us feel. I think we  $28. \ \ \,$
- ought to go ahead and...and give this Body a chance to...to 29.
- vote it up or down on this particular resolution and go ahead and 30.
- bypass committee so we can have the proper amount of time and
- meet the...meet the constitutional deadline requirements.

- 12. in their community. They both live on farms and they
- 13. are studying agriculture at the University of Illinois.
- 14. I wonder if they would please rise and be recognized by the
