- 30. two amendments were adopted, it was re-referred to a committee
- 31. and...and then the Committee on Pensions, Veterans Affairs has
- 32. another amendment, which is Amendment No. 3 which you...
- 33. PRESIDING OFFICER: (SENATOR DONNEWALD)

- 3. Amendment No. 3 simply provides that a person who's
- 4. had service rendered before 1941 as a Special Corporation
- 5. Counsel of the Chicago Welfare Administration, would be
- 6. able to credit that service into the Chicago Pension Fund.
- 7. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 8. Is there discussion? The question is shall Amendment
- 9. No. 3 to Senate Bill 554 be adopted. Senator Grotberg.
- 10. SENATOR GROTBERG:
- 11. Question of the sponsor.
- 12. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 13. Indicates he'll respond.
- 14. SENATOR GROTBERG:
- 15. Senator D'Arco, is this an amendment for one particular
- 16. person? Is that what I inferred in your last statement, a
- 17. corporation counsel for some unit of government?
- 18. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 19. Senator D'Arco.
- 20. SENATOR D'ARCO:
- 21. Corporation Counsel for the City of Chicago.
- 22. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 23. Senator Grotberg.
- 24. SENATOR GROTBERG:
- 25. This amendment then is for him, in particular, to
- $_{26}.$ grandfather him in or grandfather him out or...can you
- 27. explain a little about it, Senator?
- 28. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 29. Senator D'Arco.
- 30. SENATOR D'ARCO:
- 31. It applies to all employees who are special assistants
- 32, to the Corporation Counsel, when in fact, they...they were
- 33. on a contractual basis with the Corporation Counsel and
- 34. subsequently after 1941 were hired as a salary employee.

- 1. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Grotberg.
- 3. SENATOR GROTBERG:
- 4. Well then...you're giving...you're granting time for
- 5. contractual employees, ... previously served, before going
- 6. on the payroll, they were contractual.
- 7. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator D'Arco.
- 9. SENATOR D'ARCO:
- 10. This was before the Corporation Counsel came into
- 11. existence with the City of Chicago and the city hired
- 12. them on a contractual basis and when the Corporation
- 13. Counsel Office was formed, then they became salaried
- 14. employees and they're simply asking for the service
- 15. rendered prior to that time, which they are entitled
- 16. to.
- 17. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 18. Senator Grotberg.
- 19. SENATOR GROTBERG:
- 20. I think that we're entering into a...a grey area
- 21. on the pension system treating something like this by
- $_{\mbox{22.}}$ amendment, with due credit to the sponsor, I just wonder
- 23. if...if somehow we could hear the...the fiscal impact
- 24. of it. The...the...time, if we took all of our old
- 25. contractual employees, one at a time, and granted them,
- 26. do they have to buy their way in and things like that?
- 27. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 28. Senator D'Arco.
- 29. SENATOR D'ARCO:
- 30. Of course, they...they would have to contribute their
- 31 portion as well as the city's portion of the contribution,
- 32. plus the fact that the fiscal impact is minimal if...if
- 33. nonexistent, because there aren't that many involved. The

- 1. Pension Laws Commission did, in fact, endorse this bill and
- are behind it.
- 3. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Grotberg.
- 5. SENATOR GROTBERG:
- 6. Only I would like to see a roll call on this amendment.
- 7. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 8. Senator Soper.
- 9. SENATOR SOPER:
- Thank you, Mr. President. Senator D'Arco...
- 11. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 12. Senator D'Arco, you wish to respond?
- 13. SENATOR SOPER:
- 14. Did I hear you say that the...there was no Corporation
- 15. Counsel's Office before 1941...
- 16. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 17. Senator D'Arco.
- 18. SENATOR SOPER:
- 19. ...in the City of Chicago?
- 20. SENATOR D'ARCO:
- 21. No, the employees of...of the office were, in effect,
- 22. contractual employees by that time, that's what I said.
- 23. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 24. Senator Soper.
- 25. SENATOR SOPER:
- 26. Well, you know, that's what you said, but that's not
- 27. how it sounded. I...I think this is...this is a bad amend-
- 28. ment. This...this covers a lot of bases. Now, who do you
- 29. want this for? This is something special for somebody,
- 30. you going to open pandora's box. Yeah, what's his name.
- 31. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 32. Senator D'Arco.
- 33. SENATOR D'ARCO:

- I'm sorry you said that, I really am.
- 2. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Soper.
- 4. SENATOR SOPER:
- 5. I...I didn't get the answer. I...if his name is sorry
- 6. you said that, is that his name? Well this is...we need a roll
- 7. call on this. If you do this you're going...well what the
- 8. hell she's talking about it, it's bad.
- 9. PRESIDING : OFFICER; (SENATOR DONNEWALD)
- 10. Is there further discussion? Senator Egan.
- 11. SENATOR EGAN:
- 12. Yes, to...Mr. President, thank you. To edify the...the
- 13. gracious gentleman from Cicero, let me just point out that
- 14. there is no cost impact to the bill. It does not affect
- 15. the...the Municipal Employment Retirement Fund, which is a
- 16. ...a...a trust for those city employees, only within the
- 17. confines of the City of Chicago. It has nothing to do
- 18. whatsoever with Cicero. And it affects one individual
- 19. who worked for that municipality in a category that was not
- 20. covered. We're asking that he be put into that category to
- 21. the exclusion of everyone else, side...besides himself.
- 22. It is not, as it were, Senator, pandora's box.
- 23. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 24. Senator Soper.
- 25. SENATOR SOPER:
- 26. But now, that same individual can take that municipal...
- 27. that municipal time and come into the Legislature and take that
- 28. all together, understand. They give him eight more years in
- 29. here. Now where is he now, he's in the House or is he in the
- 30. Senate?
- 31. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 32. Senator Egan.
- 33. SENATOR EGAN:

- 1. He is in neither. He is in neither or neither or either.
- 2. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Soper.
- 4. SENATOR SOPER:
- 5. Well, when he comes around, he can come in there and
- 6. get that eight years, I know that.
- 7. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 8. Is there further discussion? The question is shall
- Amendment No. 3...Senator Berning.
- 10. SENATOR BERNING:
- 11. Mr. President, there is another amendment there. This
- 12. is an agreed amendment...
- 13. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 14. We're considering...we're considering Amendment No. 3,
- 15. Senator. There'll be a chance for...
- 16. SENATOR BERNING!
- 17. I beg your pardon.
- 18. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 19. The question is shall Amendment No. 3 be adopted to
- 20. Senate Bill 554? There is a request for a roll call. Those
- 21. in favor indicate by voting Aye. Those opposed Nay. The
- 22. voting is open. ...those voted who wish? Take the record.
- 23. On that question the Ayes are 28, the Nays are 19. Amendment
- 24. No. 3 to Senate Bill 554 is adopted. Are there further amend-
- 25. ments?
- 26. SECRETARY:
- No further committee amendments.
- 28. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 29. Are there amendments from the Floor?
- 30. SECRETARY:
- 31. Amendment No. 4 offered by Senator Berning.
- 32. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 33. Senator Berning.

- 1. SENATOR BERNING:
- Thank you, Mr. President and members of the Senate.
- 3. Amendment No. 4 was agreed upon in committee. What it does
- 4. is reduce to fifty percent of the time served the amount
- 5. which may be claimed for the pension credit and also provides
- 6. for the employee as well as employer share of the contribution.
- 7. I move for the adoption of Amendment No. 4.
- 8. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 9. Is there further discussion? The question is shall
- 10. Amendment No. 4 to Senate Bill 554 be adopted. Those in favor
- 11. indicate by saying Aye. Those opposed? The Ayes have it. Amend-
- 12. ment No. 4 is adopted. Are there further amendments?
- 13. SECRETARY:
- 14. No further amendments.
- 15. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 16. 3rd reading. Senate Bill 1434, Senator Demuzio.
- 17. Senate Bill 1540, Senator Hickey. Senate Bill 1541.
- 18. Senate Bill 1555, Senator Lane. Senate Bill 1605, Senator
- 19. Rock. 1605 on 2nd reading. Senate Bill 1617, Senator
- 20. Davidson. Read the bill, Mr. Secretary.
- 21. SECRETARY:
- 22. Senate Bill 1617.
- 23. (Secretary reads title of bill)
- 24. 2nd reading of the bill. No committee amendments.
- 25. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 26. Are there amendments from the Floor? Senator Knuppel.
- 27. SENATOR KNUPPEL:
- 28. Well, I don't have any amendments, but I hope Johnny
- 29. Davidson will notice that this is an increase of some twenty
- 30, percent in the exemption, so that when we come to the pay
- 31. raise bill that if it's twenty percent, he'll understand.
- 32. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 33. Are there further amendments?

- 3. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 4. 3rd reading. Senate Bill 1690, Senator Collins. Senator
- 5. Collins. Senate Bill 1691, Senator Leonard. Senate Bill 1711,
- 6. Senator Shapiro. Senate Bill 1725, Senator Philip. Senator
- 7. Philip. Senate Bill 1727, Senator Walsh. Senate Bill 1775,
- 8. Senator Berman. Senate Bill 1793, Senator Egan. Senate Bill
- 9. 1794, Senator Berman. Senator Buzbee. I understand that the...
- 10. there is a request for a fiscal note which has not been
- 11. fulfilled. Believe you better consult the Secretary, just a
- 12. moment. Senator Mitchler made...Senator...Senator Buzbee,
- 13. Senator Mitchler made that request. Senate Bill 1817, Senator
- 14. Leonard. Senate Bill 1819, Senator Lane. Senate Bill 1820,
- 15. Senator Egan. Senator Egan. There is a request for a fiscal
- 16. note so we'll proceed with Senate Bill 1827, Senator Graham.
- 17. Senate Bill 1850, Senator D'Arco. There is a request for
- 18. a fiscal note on 1850 which we'll have to pass. Senate
- 19. Bill 1873, Senator Lane. Senate Bill 1876, Senator Lane.
- 20. Senate Bills on 3rd reading. Senate Bill 237, Senator Nimrod.
- 21. Senate Bill 238...oh, Senate Bill 237, read the bill, Mr.
- 22. Secretary. Senator Vadalabene.
- 23. SENATOR VADALABENE:
- Just a matter of information.
- 25. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 26. For what purpose do you arise?
- 27. SENATOR VADALABENE:
- 28. Just for a matter of information. Are you going to start
- 29. all over everyday on 3rd reading or are you going to start where
- 30. you left off the day...the time before?
- PRESIDING OFFICER: (SENATOR DONNEWALD)
- Well, at this time, there are rather few Senate Bills on
- 33. 3rd Senator, we...we could employ that practice. Do we have

- 1. leave of the Body. Just a moment. Do we have leave of the
- Body to continue where we had broken off? All right, leave
- 3. is not granted. Read the bill...read Senate...Senator
- 4. Nimrod.
- 5. SENATOR NIMROD:
- Yes, Mr. President, could we discuss 237 and 238 together
- since they go... and then we can vote on them individually,
- 8. but...
- 9. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 10. Do we have leave? Leave is granted. Senate Bill 237.
- 11. Read the bill, Mr. Secretary.
- 12. SECRETARY:
- 13. Senate Bill 237.
- 14. (Secretary reads title of bill)
- 15. 3rd reading of the bill.
- 16. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 17. Senator Nimrod.
- 18. SENATOR NIMROD:
- 19. Yes, Mr. President and Ladies and Gentlemen of the
- 20. Senate. These bills deal with the subject which has certainly
- 21. captured a great of time and effort throughout the States in
- 22. the field of education. And that is on the subject of minimal
- 23. competency testing. Rather than pursue the course of...of
- 24. nunning into the pitfalls that many of the other states have
- 25. been involved in and to get involved in some very expensive
- 26. programs through the resolution which we passed in this Senate,
- 27. Senate Resolution 180, last year at the direction of the committees
- 28. on education, both higher and second elementary, we did get some
- 29. reports from both the State Board of Education and the Board of
- 30. Higher Education records and information that led to two further
- 31. hearings...
- 32. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 33. Just a minute, Senator. This is Tuesday, the first day of

- 1. the Session and there is a overabundance of noise. There's
- 2. noise pollution in the Senate. Would the members please be
- 3. in their seats. Would all unauthorized personnel remove
- 4. themselves. Mr. Sergeant-at-Arms. Proceed.
- 5. SENATOR NIMROD:
- 6. Thank you, Mr. Chairman, Mr. President. Would...with
- 7. the two hearings that were scheduled, both in Chicago and
- 8. Springfield, after extensive discussion over the past
- 9. year, we have come up with a compromised bill that I believe
- 10. will certainly meet the requirements and satisfaction of
- 11. all concerned, both those of us who are taxpayers and the
- 12. concerns we've had about minimal competency testing. Remedial
- 13. courses being given at the university level and the fact that
- 14. some of the apprehension that was certainly aroused by the
- 15. local school boards and by the teachers and by the teacher
- 16. unions. I think that this program that has come up on 237
- 17. and 238 has come as a result of both Senator Berman and
- 18. Senator Hickey's committees cooperating and giving us a
- 19. chance to reach an agreement with both the State Board of
- 20. Education and the Higher Board of Education and what we
- 21. have done is that the State Board of Education will prepare
- 22. procedures and materials and encourage and assist the
- 23. local school districts to develop minimal competency testing
- 24. program. These...these particular programs are developed
- 25. by December the 15th of this year and they are to report to
- the General Assembly their recommendations and any suggested
- 27. legislation by June 30th, 1980. And what we're doing, is, in
- fact, offering assistance to the local school districts in
- 29. helping them to get in line to a program by 1980 so that
- we can address this subject if needed at that time to
- school boards, the local boards do not meet them. As far as
- the Higher Board of Higher Education is concerned, what they
- will do is again prepare a report to us so that those reports 33.

- 1. will come to us simultaneously to the Legislature by
- 2. June 30th, 1980, so that we can address ourselves. I believe
- 3. this is a good compromise and a good solution to the program.
- 4. Be happy to answer any questions. If not, I would ask for
- 5. a favorable roll call.
- 6. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 7. Just a moment. Do we have leave to film the proceedings?
- 8. Leave...leave is granted. Senator Kenneth Hall.
- 9. SENATOR KENNETH HALL:
- 10. Would the sponsor yield to...for a question?
- 11. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 12. He indicates he will.
- 13. SENATOR KENNETH HALL:
- 14. Senator, did he get leave...I should ask the President
- 15. first. Did he get leave to discuss both bills at the same
- 16. time?
- 17. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 18. He did indeed, Senator.
- 19. SENATOR KENNETH HALL:
- 20. Senator, you're saying that you have worked this out
- with the State Board and the Board of Higher Ed. Now, I
- 22. have a note here from the superintendents in my area and
- 23. they are asking me to hold this because it says you should
- 24. leave testing to the local school districts. Now, why are
- 25. you taking that away from them?
- 26. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 27. Senator Nimrod.
- 28. SENATOR NIMROD:
- Yes, Senator Hall, that will in its original form
- 30. did exactly what you said. However, the Local School
- Board Association...others have supported this now that
- 32. we've amended it. We do not take this away from the local
- school districts. We leave this with the local school

- 1. districts. It is not in the hands of the State. It...the
- local school boards will, in fact, set up their own program.
- 3. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Hall...Kenneth, that is.
- 5. SENATOR KENNETH HALL:
- I...I'm satisfied as long as he's taken...
- 7. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Hickey.
- 9. SENATOR HICKEY:
- 10. Are we on? Yeah. I...I don't know...I didn't hear
- 11. the very first part of the discussion and so I'm not sure
- 12. whether Senator Nimrod told you, but we held two whole
- 13. days of hearings on these two bills. One day in Springfield
- 14. and one day in Chicago so this is not...he is quite correct
- 15. when he says we worked this out with both education boards,
- 16. but we also worked it out with the input of school districts
- 17. and individuals from all over the State of Illinois. And
- 18. we found lots of evidence of ... of mandated State-wide testing
- 19. in other states absolutely falling flat on its face. It
- 20. hasn't worked the way people thought it would work and we
- 21. found real enthusiasm for the way that these two bills of
- 22. Senator Nimrod's have been worked out, that is encouraging
- 23. and assiting local areas to use testing and after all, the
- 24. testing is not an end in itself, it's the general improvement
- 25. of all of elementary and secondary education. And this...this
- 26. simply assists the local areas in doing the testing with that
- 27. aim and goal in mind and then reporting back to IOE and they
- 28. reporting back to the Legislature to see if the real goal is
- 29. being achieved, that is the improvement of education in general.
- 30. And then, as Senator Nimrod said, for the...for the Board of
- 31. Higher Education, eventually we would hope not to need any
- 32. remedial education, certainly in the universities. But
- 33. moving it now into the community colleges and later hopefully

- 1. being able to abandon it. But here again, the thing is to
- 2. report back to the General Assembly the progress in these
- 3. directions and I asked for wholehearted support from
- 4. this side of the aisle for these two bills.
- 5. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 6. Senator Grotberg.
- 7. SENATOR GROTBERG:
- 8. Question of the sponsor or Mr. Nimrod, sir.
- 9. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 10. Indicates he'll yield.
- 11. SENATOR GROTBERG:
- 12. I'm very much a part of...of Senate Bill 3...237, but
- 13. on 238, Senator, we at first were going to mandate a little
- 14. program for Office of Education on designing the competency
- 15. testing. Is that correct?
- 16. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 17. Senator Nimrod.
- 18. SENATOR NIMROD:
- 19. We are giving them, the...the State Board of Education,
- 20. the responsibility of setting up a program and that program
- 21. then can, for the State, and then they will assist. It
- 22. says the materials to encourage and assist local school
- 23. districts has no mandating provision, whatsoever. It
- 24. asks them, however, to...they have to be given the responsi-
- 25. bility in order to be able to assist someone else. And that's
- 26. the only reason that part is there.
- 27. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 28. Senator Grotberg.
- 29. SENATOR GROTBERG:
- 30. Well, to Senate Bill 238 then, Mr. President, it seems
- 31. to me that that's the only damn reason that the board exists
- 32. if to help public schools with reading and writing and
- 33. arithmetic. And this is an exercise in futility of
- 34. tickling their fancies about helping the local schools with

- 1. reading and writing and arthmetic tests and some bureaucratic
- 2. device will be discovered now to...to regurgitate all the
- 3. research that's been done for the last hundred years. It's
- 4. all done. All they have to do is issue a...a memo on the
- 5. subject, but we will not find an excuse to...to increase
- 6. that department some more and...the 238 bothers me because
- 7. it doesn't do anything, Senators Hickey and Nimrod. Although
- 8. I sat in on the committee meeting here in Springfield in
- 9. the House, or in the Senate, I did not attend the testimonies,
- 10. but I have been warned by local boards not to mandate any-
- 11. thing. This does not mandate it, but, in fact, does nothing.
- 12. So I'm a hundred percent in support of 237. 238 just bothers
- 13. me to that degree. Thank you.
- 14. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 15. Senator Knuppel. Senator Collins.
- 16. SENATOR COLLINS:
- 17. Mr. President, a question to the sponsor.
- 18. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 19. He indicates he'll yield.
- 20. SENATOR COLLINS:
- 21. Senator...Nimrod, does 237, has 237 been changed also
- 22. to set up guidelines...only?
- 23. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 24. Senator Nimrod.
- 25. SENATOR NIMROD:
- 26. Yes, Senator Collins.
- 27. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 28. Is there further discussion? Senator Mitchler.
- 29. SENATOR MITCHLER:
- 30. Very briefly, Mr. President and members of the Senate.
- 31. What is the genesis of this bill, Senator Nimrod? Who...who
- 32. asked for this bill?
- 33. PRESIDING OFFICER: (SENATOR DONNEWALD)

- Senator Nimrod.
- 2. SENATOR NIMROD:
- Senator Mitchler, the minimal competency testing is
- 4. presently being considered and been voted on in twenty-
- 5. eight of the fifty states already and fourteen of them
- 6. are being...considering it now. It's probably the most
- 7. controversial issue in education since Sputnik. And I
- 8. think that it is...is one area that has cost many states
- 9. millions of dollars, not only in programs that they set
- 10. up without taking advantage of the information that's there.
- 11. And secondly, that we find ourselves today in Illinois
- 12. having remedial courses at the university level and we
- 13. find that universities are saying that anywhere from ten
- 14. to twenty percent of their students who are entering the
- 15. universities cannot read, write or compute. On these
- 16. basis certainly, it is certainly our duty and our necessity
- 17. for us to address this subject. And the reason this...who
- 18. wants this, is that certainly the taxpayers of this State.
- 19. are concerned about the two...over two billion dollars that we're
- 20. spending on education and still finding that we have to
- 21. have reading, writing and arithmetic classes and courses
- 22. at the university level nad that, in fact, we find that even
- 23. within the Chicago system and others, they've taken the
- 24. initiative themselves to set up these tests and say not
- 25. only should...it not be the high school level but they've
- 26. gone down to the eighth grade level and said that this
- 27. is where it should begin. I think this is a good first
- 28. step and it's certainly needed by everyone in the State
- 29. of Illinois.
- 30. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 31. Senator Mitchler.
- 32. SENATOR MITCHLER:
- 33. Senator Nimrod..if this legislation is passed and

- 1. put into effect, what time limit do you estimate before you
- 2. will reverse this very serious and costly problem that
- 3. you point out. How many years, as a result of this legisla-
- 4. tion will you correct this so that our students qualify
- 5. when they graduate from high school for entrance into
- 6. colleges? What's the time limit?
- 7. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Nimrod.
- 9. SENATOR NIMROD:
- 10. I would be hopeful, Senator Mitchell, that as a
- 11. result of these bills that by June 30th, 1980 most of the
- 12. elementary and secondary schools of the high school
- 13. level will have instituted their own voluntary programs
- 14. that will meet these particular problems. I would say
- 15. that in discussion with Dr. Ferman, he estimates and
- 16. has reported that as a result of this legislation that
- 17. they are immediately going to begin to take and make
- 18. sure that the universities, the public universities
- 19. and colleges, begin to concentrate this particular effort
- 20. into the community college system. And that within two
- 21. years they will be reporting to us, but they would hope
- 22. that all classes of the remedial courses would be dis-
- 23. continued, I think if I'm quoting him correctly, in less
- 24. than five years and that there would be no longer any
- 25. courses at the university level.
- 26. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 27. Senator Mitchler.
- 28. SENATOR MITCHLER:
- Then my...my final question to you, and I want to
- 30. thank you for your complete explanation of those, Senator
- 31. Nimrod. What is the estimated cost to put this program
- 32. through?
- 33. PRESIDING OFFICER: (SENATOR DONNEWALD)

- Senator Nimrod.
- 2. SENATOR NIMROD:
- 3. Yes, the procedure, Senator Mitchler, that we are
- 4. taking here because of the voluntary system and since

- Is there discussion? The question is shall Senate
- $\,$ Bill 238 pass. Those in favor indicate by voting Aye.
- Those opposed Nay. The voting is open. Have all those

- 1. voted who wish? Take the record. On that question the
- 2. Ayes are 53, the Nays are 4. Senate Bill 238, having
- 3. received the constitutional majority is declared passed.
- 4. Senator Demuzio, for what purpose do you arise?
- 5. SENATOR DEMUZIO:
- 6. Mr. President, I'd just like to ask, where might
- 7. I be able to find the bills that...that are on 3rd
- 8. reading? They are not on my desk and I don't see them
- 9. on any of the other Legislators desk. Where's the bill
- 10. book?
- 11. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 12. Senator, they are... I see you have found one. Senator
- 13. Hynes.
- 14. PRESIDING OFFICER: (SENATOR ROCK)
- 15. Senator Hynes.
- 16. SENATOR HYNES:
- 17. Yeah, Mr. President and members of the Senate. A
- 18. number of members have been inquiring about our schedule
- 19. and I thought I would outline what our plan is for this
- 20. week. And I would like to indicate at the beginning that
- 21. you ought to keep open the possibility of being here
- 22. on Friday. And I say that because if we do not move bills

- 22. Well, thank you, Mr. President, Ladies and Gentlemen.
- 23. This bill in its present form gives the Cook County Forest
- 24. Preserve District certain new powers. And I want to...it
- 25. grants each district the authority to make transfers from
- 26. one appropriation to another within the same fund after
- 27. the adoption of their annual appropriation ordinance. Downstate
- 28. forest preserve districts already have this power, but they
- 29. can only do it by a two-thirds vote. Cook County Forest

SENATOR MARAGOS: 9. Mr. President and members of the Senate. Senate Bill 10. 1436 merely corrects an error in the bill that was passed 11. last fall and signed by the Governor in that it...omitted 12. to refer to Section 5 as to payments under Section 32 13 to contractors. - Senator Guidice.
- 8. SENATOR GUIDICE:
- 9. Thank you, Mr. President, members of the Senate.
- 10. 1468 deals with a red-lining insurance. Last year, we
- 11. passed three very important bills regarding red-lining.
- 12. One dealt with the geographical area, one with proper
- 13. notification to the public and three of the reasons
- 14. for the cancellation. Well, that went into effect. Immediately there-
- 15. after the insurance companies found another way of doing

- 19. ways we try to stop these companies from doing this, the more
- 20. things they come up with to avoid writing in these areas.
- 21. The protection is needed. The people in my district, the people
- 22. in the city, the people throughout the State want to buy and
- 23. be able to purchase insurance and yet now we have the companies
- 24. pulling out and saying well, we don't have an agent in this
- 25. area anymore. Well, this bill will prevent that. They will
- 26. have an agent or a broker, if there is a company doing business
- 27. in Illinois, to make available that insurance in these areas.
- 28. And I ask your support in this bill.
- 29. PRESIDING OFFICER: (SENATOR ROCK)
- 30. Is there any discussion? Senator Soper.
- 31. SENATOR SOPER:
- Yeah, Senator Guidice.
- 33. PRESIDING OFFICER: (SENATOR ROCK)

- Sponsor indicates he will yield. Senator Soper.
- 2. SENATOR SOPER:
- Is this the only thing this bill does, or does it concern
- 4. itself with the differential in...in...in premiums?
- 5. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Guidice.
- 7. SENATOR GUIDICE:
- This is the only thing the bill does, Senator.
- 9. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Soper.
- 11. SENATOR SOPER:
- 12. In other words, you don't say if there's a history of
- 13. great loss by...by theft or...or a collision in a certain
- 14. district that...that the premium has to be the same as that
- 15. in the district where there's less criminal activity and so forth?
- 16. PRESIDING OFFICER: (SENATOR ROCK)
- 17. Senator Guidice.
- 18. SENATOR GUIDICE:
- 19. That's correct. They...the insurance company can
- 20. write and charge accordingly. But at least let them
- 21. write.
- 22. PRESIDING OFFICER: (SENATOR ROCK)
- 23. Senator Soper.
- 24. SENATOR SOPER:
- 25. Now, does this take in...concern all...all insurance
- 26. companies that write in the State of Illinois or just those
- 27. that did write in that district and now they haven't got a
- 28. representative, that they must write in that district?
- 29. Is that what this says?
- 30. PRESIDING OFFICER: (SENATOR ROCK)
- 31. Senator Guidice.
- 32. SENATOR GUIDICE:
- 33. The case in point, Senator, regarding myself. I was insured

- by West Bend Insurance Company of Wisconsin and they were
- 2. writing throughout the State of Illinois. Now they indicated,
- 3. well, we no longer write in Cook County and the agent is
- 4. gone, there's no broker to do business in this particular area.
- 5. And this is the way they avoid writing in the area.
- 6. PRESIDING OFFICER: (SENATOR ROCK)
- 7. Senator...
- 8. SENATOR GUIDICE:
- 9. Now, I was willing to pay my premium and I did
- 10. pay my premium. I haven't had a chargeable accident
- 11. since I've been driving and they canceled me on this kind
- 12 of a...on this basis.
- 13. PRESIDING OFFICER: (SENATOR ROCK)
- 14. Senator Soper.
- 15. SENATOR SOPER:
- 16. Well, I appreciate your situation, but in other words,
- 17. if this company no longer writes in Illinois, then you're
- 18. going to make them write in Illinois because they wrote
- 19. your policy?
- 20. PRESIDING OFFICER: (SENATOR ROCK)
- 21. Senator Guidice.
- 22. SENATOR GUIDICE:
- 23. Senator Soper, the bill is clear that if they are
- 24. Writing in the State of Illinois, if they are writing in the
- 25. State of Illinois.
- 26. PRESIDING OFFICER: (SENATOR ROCK)
- 27. Senator Soper.
- 28. SENATOR SOPER:
- 29. Well, I...I feel for you because I had insured a farm up
- in Wisconsin on the borderline there with USF and G
- 31. and they said, we no longer write in Wisconsin and one month
- after they canceled the insurance, the barn burned and you know,
- it's one of those things. So...and I was insured with them

- 1. for twenty years, so I just wondered how this worked out,
- I suppose I couldn't go back after these guys from
- 3. Wisconsin, but I...I'll go along with you.
- 4. PRESIDING OFFICER: (SENATOR ROCK):
- 5. Any further discussion? The question is shall Senate
- 6. Bill 1468 pass. Those in favor will vote Aye. Those opposed
- 7. will vote Nay. The voting is open. Have all voted who wish?
- 8. Have all voted who wish? Take the record. On that question
- 9. the Ayes are 51, the Nays are none, 5 Voting Present.
- 10. Senate Bill 1468 having received a constitutional majority
- 11. is declared passed. Senator Maragos, for what purpose
- 12. do you arise?
- 13. SENATOR MARAGOS:
- 14. Inadvertently, I was off the Floor at the time.
- 15. Senate Bill 1468 was being considered and if I were present,
- 16. I would have voted in favor of it.
- 17. PRESIDING OFFICER: (SENATOR ROCK)
- 18. Your record will so...so show. Senator Demuzio, 69.
- 19. On the Order of Senate Bills, 3rd reading, Senate Bill
- 20. 1469. Read the bill, Mr. Secretary.
- 21. SECRETARY:
- 22. Senate Bill 1469.
- 23. (Secretary reads title of bill)
- 24. 3rd reading of the bill.
- 25. PRESIDING OFFICER: (SENATOR ROCK)
- 26. Senator Demuzio.
- 27. SENATOR DEMUZIO:
- 28. Well, thank you, Mr. President and members of the Senate.
- 29. This bill indeed would appropriate twenty-five thousand dollars
- 30. to the Illinois State Museum to conduct a feasibility
- 31. study of establishing the Coster Archaeological site as a
- 32. Site to...to be preserved. And the amendment that was put on the
- 33. bill, originally the appropriation was being made to the

- ...directly to the museum, the Illinois State Museum.
- 2. The Department of Registration and Education, being under the
- 3. jurisdiction of the Illinois State Museum, it is the reason
- 4. why it was changed. The Illinois Foundation for Archaeology...
- Archaeological will determine the feasibility...to determine
- 6. the feasibility of preserving this site in Greene County.
- 7. Last week, I passed out to the members of the Senate, a
- 8. packet of material pertinent to this particular site
- 9. and I want the members of the Senate to...to realize that
- 10. this site is regarded by...by national archaeologists
- 11. as one of the most important examples of culture and
- 12. early civilization in North America. And that in 1977,
- 13. over forty thousand people had visited the site and it's
- 14. anticipated over sixty thousand will visit the site this year.
- 15. Senate...the facts about the Coster site, and I will read
- 16. some excerpts from Professor Stuart Struever's statement
- 17. that I passed out last week, that the site has been inhabited
- 18. by man for over eighty-five hundred years and that it is
- 19. named for Ted Coster, who owns the dig, was founded and managed
- 20. by Northwestern University School of Archaeology. It's located
- 21. in Greene County and has permanent teaching and research
- 22. facilities in the Village of Kampsville in Calhoun County.
- 23. Dr. Struever indicates that Coster is one of the most
- 24. important archaeological sites ever uncovered in North
- 25. American and the importance of this site stems from several
- 26. characteristics that are seldom found together in one
- 27. archaeological site in the United States. The three points
- 28. that he makes that first the site contains the remains
- 29. of at least fourteen distinct prehistoric indian cultures.
- 30. And for any archaeological site in the western hemisphere, this
- 31. is an exceedingly long span of human occupation. The second...
- 32. the second point is that the site is rare among the archaeological
- 33. sites in North America because of the quality of artifact

- 1. preservation and the third reason is the site is so unusual
- as that because after each of the village was abandoned...
- 3. each of the villages...enough mudslides occurred that
- 4. the ruin was covered by a thick blanket of soil and
- 5. protected it from the disturbance by later groups.
- 6. So, the Coster site is indeed important because of the fact
- 7. that...I'll be happy to answer any questions.
- 8. PRESIDING OFFICER: (SENATOR ROCK)
- 9. Is there any discussion? Senator Sommer.
- 10. SENATOR SOMMER:
- 11. Mr. President and members. This is an unbudgeted item,
- 12. but I happen to personally think it's worthy of consideration
- 13. and passage by this Body. It's better than buying it.
- 14. I think we should study and determine whether the State of
- 15. Illinois would like to acquire this extremely valuable site.
- 16. The people involved are the most reputable people we have
- 17. in this State and it's Senator Demuzio's only good
- 18. appropriation bill this year.
- 19. PRESIDING OFFICER: (SENATOR ROCK)
- 20. Senator Regner.
- 21. SENATOR REGNER:
- 22. Just a question of the sponsor.
- 23. PRESIDING OFFICER: (SENATOR ROCK)
- 24. Sponsor indicates he will yield. Senator Regner.
- 25. SENATOR REGNER:
- 26. Senator Demuzio, what I was wondering if the thing is
- 27. all that great, what you just read there and Senator Netsch
- 28. helped you so well on the various wordage. If it's all that
- 29. good, why don't we just give them twenty-five thousand dollars
- 30. to start digging instead of studying it some more?
- 31. PRESIDING OFFICER: (SENATOR ROCK)
- 32. Senator Demuzio.
- 33. SENATOR DEMUZIO:

- Senator Regner, the...the facts are that the dig is
- currently being financed by private contributions throughout
- 3. the United States. In 1978..late 1978, early 1979, those
- 4. private donations and the...will run out and the dig
- 5. will, therefore, have to cease operation. If the reason
- 6. and the rationale behind the study is to ascertain and
- 7. determine the importance of this site to other sites
- 8. in North America to really determine whether or not we ought
- 9. to proceed with the actuality of purchasing that ground for
- 10. historical and educational purposes in the State.
- 11. PRESIDING OFFICER: (SENATOR ROCK)
- 12. Senator Regner.
- 13. SENATOR REGNER:
- 14. I...I know several other members would like to know this
- 15. also. You said it's being financed by private funds. How
- 16. much of the private funds been available so far and how
- 17. much have they spent using private funds at this time?
- 18. PRESIDING OFFICER: (SENATOR ROCK)
- 19. Senator Demuzio.
- 20. SENATOR DEMUZIO:
- 21. I don't know the exact answer to that, but I am told
- 22. by Professor Struever, substantial. As a matter of fact, he
- 23. was just out west...in the western states and also in the
- 24. eastern states seeking contributions from various organizations
- 25. and companies to complete the dig this year.
- 26. I'm not suggesting that the end of the...the dig in
- 27. 1978 1979 that the State of Illinois finance the dig any
- $_{28.}$ further. That is not the purpose nor the suggestion of this bill.
- 29. PRESIDING OFFICER: (SENATOR ROCK)
- 30. Senator Regner.
- 31. SENATOR REGNER:
- You know, the word substantial is kicked around here pretty
- 33. good. To me and my checking account five hundred dollars is

- 1. substantial. But some of these agencies come in and...
- ten or fifteen million dollars isn't substantial. That's
- 3. why I was wondering what the exact dollar was.
- 4. PRESIDING OFFICER: (SENATOR ROCK)
- 5. Senator Demuzio.
- 6. SENATOR DEMUZIO:
- Well, under your definition, I would suggest that
- 8. five hundred dollars is substantial and agree with you.
- 9. PRESIDING OFFICER: (SENATOR ROCK)
- 10. Further discussion? Senator Soper.
- 11. SENATOR SOPER:
- 12. Thank you, Mr. President. Senator Demuzio, answer
- 13. a few questions, please? You know, this is a well
- 14. advertised dig, as you call it, and I think everybody...
- 15. I think the Governor knows about it and I think the...the
- 16. society knows about it. What are you going to spend
- 17. twenty-five thousand dollars on a feasibility study, what...
- 18. how are you going to spend twenty-five thousand? Just a
- 19. letter will do it with some of the clippings...these people
- 20. that have donate...donated money to this thing? What do we
- 21. have to spend twenty-five thousand dollars for?
- 22. PRESIDING OFFICER: (SENATOR ROCK)
- 23. Senator Demuzio.
- 24. SENATOR DEMUZIO:
- Well, the...the purpose of the study, and I will
- 26. explain first of all, the twenty-five thousand dollar figure
- 27. was not just an arbitrary figure that someone drummed up.
- That figure was determined by the Illinois Department of
- 29. Conservation. And the Department of Conservation not having
- the area of expertise to study this particular matter, it was
- determined that it be conducted by the Illinois State Museum
- under the Department of Registration and Education. The
- reason that we're having the study is to determine just 33.

- 1. exactly, you know, how important that it really is in order
- 2. for us to proceed with the possibility of purchasing that
- 3. site for the...the people of the State of Illinois. And
- 4. as a...as a practical matter, I wouldn't...wouldn't want to
- 5. come into this General Assembly and simply put a bill in to
- 6. buy that land...to buy that particular dig and I'm not talking
- 7. about any tillable acres, I might add, just out of the clear
- 8. blue sky. I think it has to be determined if...if it indeed
- 9. is worth preserving.
- 10. PRESIDING OFFICER: (SENATOR ROCK)
- 11. Senator Soper.
- 12. SENATOR SOPER:
- 13. I see here that this request is not part of the Governor's
- budget. And still you say the...the Department of
- 15. Conservation is the one that suggested twenty-five thousand
- 16. dollars to you.
- 17. PRESIDING OFFICER: (SENATOR ROCK)
- 18. That is a question, I take it.
- 19. SENATOR SOPER:
- 20. Yeah.
- 21. PRESIDING OFFICER: (SENATOR ROCK)
- 22. Senator Demuzio.
- SENATOR DEMUZIO:
- The...about six months ago, we ran this whole project by
- 25. the Department of Conservation for them to come up with a
- 26. cost that would determine but not be restricted to land
- 27. acquisition, public assessibility, interpretive programming,
- 28. capital development improvements, public support and continuative
- 29. research work with emphasis on laboratory assessment of the
- 30. historical productivity. That is all spelled out in the bill.
- 31. And therefore, it was...we only asked them what their estimate
- 32. would be if those...if those criteria were met. That is where
- 33. the twenty-five thousand dollar figure came from.

- 1. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Soper.
- 3. SENATOR SOPER:
- 4. I don't want to belabor this, but who have you got in
- 5. mind that's going to make this feasibility study beside the
- 6. people that have already been digging in this place and
- 7. will have reports on how...how wonderful it is or how necessary
- 8. it is for the people of the State of Illinois and the people of the world
- 9. ... to keep this and for us to buy it? Who beside them?
- 10. PRESIDING OFFICER: (SENATOR ROCK)
- 11. Senator Demuzio.
- 12. SENATOR DEMUZIO:
- 13. It will...the study will be conducted by the Foundation of
- 14. Illinois Archaeology. And that association was formed in 1956
- 15. as an Illinois not-for-profit corporation for the purpose
- 16. of conducting archaeological education research programs in
- 17. the State of Illinois. The original name was the
- 18. Archaeological Research, Incorporated and it was changed in
- 19. 1970 to a Foundation for...to the Foundation for Illinois
- 20. Archaeological. The Foundation is governed by a nine
- 21. member board of professional, academics and public members
- 22. elected by the Foundation membership throughout the State
- of Illinois. They include James Brown, Professor of
- 24. Archaeological at Northwestern University, Bruce McMillan,
- Director of the Illinois State Museum, Stuart Struever
- from Northwestern University, Howard Winters from New
- 27. York University, Mrs. Robert Jacob from Winnetka, a Magus
- 28. from Alton, a Mr. Anthony Ryerson from Chicago, Robert
- 29. Lemmon from Winnetka and Paul...Mrs. Paul Harper from
- Lake Forest. The Foundation operates a permanent archaeological
- research and training center with thirty-six buildings,
- 32. including laboratories, dormatories for student interns and a
- museum and library and most of those are in the Mississippi 33.

- 1. Valley in my district.
- PRESIDING OFFICER: (SENATOR ROCK)
- 3. Further discussion? Senator Maragos.
- 4. SENATOR MARAGOS:
- 5. I'd like to ask the sponsor some questions.
- 6. PRESIDING OFFICER: (SENATOR ROCK)
- 7. Indicates he will yield. Senator Maragos.
- 8. SENATOR MARAGOS:
- 9. Are you in any way, degrading the project when you take
- 10. it from archaeological to historical?
- 11. PRESIDING OFFICER: (SENATOR ROCK)
- 12. Senator Demuzio.
- 13. SENATOR MARAGOS:
- 14. Because isn't archaeological an older site than historical?
- 15. SENATOR DEMUZIO:
- 16. On the amendment, the historical aspects have been...
- 17. have been taken out.
- 18. PRESIDING OFFICER: (SENATOR ROCK)
- 19. Senator Maragos.
- 20. SENATOR MARAGOS:
- 21. In all seriousness, though, has it...don't you think
- 22. as a Legislature, we should also consider this important fact
- 23. that we have many museums in our State, the Field Museum
- 24. and many others, who should become involved in this site rather
- 25. than spending money in some other countries. I think they should
- 26. start...because a lot of...much of their funds come from
- 27. the State and I would suggest that we put in the form of
- 28. a resolution as a follow-up on this particular study, that
- 29. We put as a resolution that...that the museums and the experts in the
- 30. area who are from the various universities and museums in the
- 31. State of Illinois proceed and make these studies and also
- 32. give it some funding because I know as sure as shooting...
- 33. after we get the study, they're going to recommend

- 1. that the State take it over, partially, if not fully,
- 2. But I think we could lighten the load of the State
- 3. if we recommend that these museums and these other universities
- 4. who...they go throughout the world, Egypt, Greece, Turkey,
- 5. Italy and every place else, why can't they start at home
- 6. because I think this project is worthy of it. And I recommend
- 7. that to you at that time.
- 8. PRESIDING OFFICER: (SENATOR ROCK)
- 9. Further discussion? Senator Mitchler. All right.
- 10. Any further dicussion? Senator Soper for the second and
- 11. hopefully last time.
- SENATOR SOPER:
- 13. Well, you cut me off. I wanted to ask one question,
- that's all. After he got through...
- 15. PRESIDING OFFICER: (SENATOR ROCK)
- 16. Sponsor indicates he will yield. Senator Soper.
- 17. SENATOR SOPER:
- 18. You told me all about the people that know all about
- this, what...what do they have to research? Why do
- 20. they need twenty-five thousand? All they've got to do is
- 21. Write a letter and say that they know what it's all about,
- that's all. That's what I want to say.
- PRESIDING OFFICER: (SENATOR ROCK)
- Senator Demuzio.
- SENATOR SOPER:
- That's all. Don't answer it again, you take four minutes
- of my three minute time.
- PRESIDING OFFICER: (SENATOR ROCK)
- Further discussion? Senator Demuzio may close the debate.
- SENATOR DEMUZIO:
- No, I just ask for a favorable roll call. I think it is
- an important project and I would ask for your favorable support.
- PRESIDING OFFICER: (SENATOR ROCK)

- The record will so reflect. On the Order of Senate
- 15. Bills, 3rd reading, Senate Bill 1472. Read the bill,
- 16. Mr. Secretary.
- 17. SECRETARY:
- Senate Bill 1472.
- 19. (Secretary reads title of bill)
- 20. 3rd reading of the bill.
- 21. PRESIDING OFFICER: (SENATOR ROCK)
- 22. Senator Vadalabene.
- 23. SENATOR VADALABENE:
- Yes, thank you, Mr. President and members of the Senate.
- Senate Bill 1472 amended, creates an Advisory Council on
- Economic Development. This new council is necessary to SWIMP
- Act of which I am Legislative Chairman, in order for
- them to establish an economic development district under
- 29. U.S. Economic Development Administration. Once having
- established an economic development district, then SWIMP Act
- would be eligible for ten percent bonus grant money
- from the Federal Government which...which would be an amount 32.
- of approximately five hundred thousand dollars and I would 33.

- PRESIDING OFFICER: (SENATOR ROCK)
- 3. Is there any discussion? The question is shall Senate
- 4. Bill 1472 pass. Those in favor will vote Aye. Those
- 5. opposed will vote Nay. The voting is open. Have all
- 6. voted who wish? Have all voted who wish? Have all voted who
- 7. wish? Take the record. On that question the Ayes are
- 8. 44, the Nays are 4, 4 Voting Present. Senate Bill 1472
- 9. having received a constitutional majority is declared passed.
- 10. Senator Weaver. Senator Egan, 1514. On the Order of Senate
- 11. Bills, 3rd reading, Senate Bill 1514. Read the bill,
- 12. Mr. Secretary.
- 13. SECRETARY:
- 14. Senate Bill 1514.
- 15. (Secretary reads title of bill)
- 16. 3rd reading of the bill.
- 17. PRESIDING OFFICER: (SENATOR ROCK)
- 18. Senator Egan.
- 19. SENATOR EGAN:
- 20. Thank you, Mr. President and members of the Senate.
- This is the annual appropriation for the much loved and
- 22. endeared Illinois Public and Pension...Public Employee
- $\,$ Pension Laws Commission. It is the same request as last
- 24. Year. There was no opposition to the bill in the
- 25. committee and I would ask for your favorable consideration.
- PRESIDING OFFICER: (SENATOR ROCK)
- 27. Is there any discussion? The question is shall Senate
- 28. Bill 1514 pass. Those in favor will vote Aye. Those
- 29. opposed will vote Nay. The voting is open. Have all voted
- who wish? Have all voted who wish? Take the record. On
- that question the Ayes are 54, the Nays are 2, 2...none
- Voting Present. Senate Bill 1514 having received a constitutional
- majority is declared passed. Senator Guidice, 1515. Senator

- 1. Bowers, 1528. On the Order of Senate Bills, 3rd reading,
- 2. Senate Bill 1528. Read the bill, Mr. Secretary.
- 3. SECRETARY:
- 4. Senate Bill 1528.
- 5. (Secretary reads title of bill)
- 6. 3rd reading of the bill.
- 7. PRESIDING OFFICER: (SENATOR ROCK)
- 8. Senator Bowers.
- 9. SENATOR BOWERS:
- 10. Thank you, Mr. President. In my district, we have
- 11. a park district that has a Federal grant of approximately
- 12. a half a million dollars for the acquisition of territory
- 13. that lies immediately outside of the park district.
- 14. This bill is...was introduced to give the park district
- 15. the power of eminent domain outside of their boundaries.
- 16. As originally introduced, it was two miles. There was some
- 17. opposition within the committee. We reduced it to one
- 18. mile and we also limited it to counties of over four
- 19. hundred thousand. Therefore, as it presently exists, it's
- 20. limited to DuPage and Cook County only. In addition to that,
- 21. Senator Guidice has...I guess Senator Daley offered the
- amendment. There was an amendment put on which would increase
- to eighty acres the territory which could be annexed
- unilaterally by the district. The present limitation is
- 25. sixty acres of property that is surrounded by one or more
- districts in a river or lake or whatever that language all
- 27. adds up to. Senator Knuppel then...became a Christmas tree
- bill, incidently, Senator Knuppel then introduced an amendment
- which would permit downstate park districts to introduce
- revenue bonds for the operation of airports. Those districts
- which operated airports could issue revenue bonds for that
- purpose. I know of...well, I...I shouldn't say that. I think
- there is probably some opposition. I would appreciate a favorable 33.

- 1. roll call.
- PRESIDING OFFICER: (SENATOR ROCK)
- Is there any discussion? Senator Sangmeister.
- 4. SENATOR SANGMEISTER:
- 5. Will the sponsor yield for one question?
- 6. PRESIDING OFFICER: (SENATOR ROCK)
- Indicates he will yield. Senator Sangmeister.
- 8. SENATOR SANGMEISTER:
- Senator Bowers, when you opened your remarks,
- 10. you said that this park district had property that they
- 11. could acquire with Federal money immediately outside the
- 12. park district. Do you mean immediately outside and
- 13. adjacent to it?
- 14. PRESIDING OFFICER: (SENATOR ROCK)
- 15. Senator Bowers.
- 16. SENATOR BOWERS:
- 17. No, Senator Sangmeister, I'm not sure of the total
- 18. distance. I...incidently, this was given to me by
- 19. Senator Fawell...former Senator Fawell and the two
- 20. miles was originally put in because that's the power
- 21. that municipalities have today. That is all municipal
- 22. cities and villages, have the power to...of eminent;
- 23. domain within two miles outside their own districts.
- 24. So, that was the original genesis of the two miles.
- 25. When the opposition developed, I asked them to run a
- 26. check and he said that the one mile would encompass
- 27. all of the property so, we reduced it to one mile.
- 28. I'm not sure we could reduce it anything less than that
- 29. and still get all of the property that's under consideration
- 30. at the present time.
- 31. PRESIDING OFFICER: (SENATOR ROCK)
- 32. Senator Sangmeister.
- 33. SENATOR SANGMEISTER:

Well, the reason for the question was that I can see a

- 1. park district wanting to annex property that is immediately
- adjacent and just outside the boundaries of the district but
- 3. when you start going a mile outside of your park district,
- 4. I'm not so sure the taxpayers are getting that great of
- 5. return or that they'll be able to use that property. Maybe
- 6. they will, maybe they won't, but your explanation does...
- 7. I understand your explanation.
- 8. PRESIDING OFFICER: (SENATOR ROCK)
- 9. Further discussion? Senator Soper.
- 10. SENATOR SOPER:
- 11. Thank you, Mr. President. Senator Bowers, I remember
- 12. this gem, and I think Senator Sangmeister brought the point up.
- 13. In other words, this will not be contiguous to any park
- 14. district that...property that you own at this time?
- 15. PRESIDING OFFICER: (SENATOR ROCK)
- 16. Senator Bowers.
- 17. SENATOR BOWERS:
- 18. That is correct.
- 19. PRESIDING OFFICER: (SENATOR ROCK)
- 20. Senator Soper.
- 21. SENATOR SOPER:
- 22. And this is...this is, I think...first...first instance,
- 23. if I remember properly, they want to...they want to create
- 24. a golf course out there, but at the same time, they want
- 25. to have a beer license or something for...or liquor license
- out for that golf course. Now you're within one mile
- and outside of your own...outside your own territory and you
- 28. want to, by eminent domain, put a golf course or something
- out in somebody else's property where all the guys can go
- and throw around their bottles, that's what it looks like to me.
- PRESIDING OFFICER: (SENATOR ROCK)
- Further discussion? Senator Rhoads.
- SENATOR RHOADS:

- Question of the sponsor.
- PRESIDING OFFICER: (SENATOR ROCK)
- Indicates he will yield. Senator Rhoads,
- 4. SENATOR RHOADS:
- Senator Bowers, first of all, how much money is involved
- 6. in the Federal grant?
- 7. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Bowers.
- 9. SENATOR BOWERS:
- 10. Half a million dollars. A little over five hundred thousand.
- 11. PRESIDING OFFICER: (SENATOR ROCK)
- 12. Senator Rhoads. Senator Rhoads.
- 13. SENATOR RHOADS:
- 14. Does the present law permit annexation of noncontiguous
- 15. territory and if so, what is the distance?
- 16. PRESIDING OFFICER: (SENATOR ROCK)
- 17. Senator Bowers.
- 18. SENATOR BOWERS:
- 19. Well, number one, we're not talking about annexation.
- 20. We're talking about acquisition of the fee title.
- 21. Number two, as far as annexation is concerned, it has to be
- 22. contiguous. There is no proposal at all for that.
- 23. Number three, they can already own the property within
- 24. any limitation outside of their own boundaries. This just
- 25. adds the power of eminent domain.
- 26. PRESIDING OFFICER: (SENATOR ROCK)
- 27. Senator Rhoads. Further discussion? Senator Kenneth Hall.
- 28. SENATOR KENNETH HALL:
- 29. Will the sponsor yield to a question?
- 30. PRESIDING OFFICER: (SENATOR ROCK)
- 31. Sponsor indicates he will yield. Senator Hall.
- 32. SENATOR KENNETH HALL:
- 33. Senator, one part of the question I was going to ask you has

- 1. been answered since this is...we're not talking about
- 2. contiguous property. Now, did you say that it's going to
- 3. just affect DuPage and some other...did you...did you make
- 4. that statement?
- 5. PRESIDING OFFICER: (SENATOR ROCK)
- 6. Senator Bowers.
- 7. SENATOR BOWERS:
- 8. Some smaller county to the east of DuPage, yes Sir.
- 9. DuPage and Cook County only, Senator.
- 10. PRESIDING OFFICER: (SENATOR ROCK)
- 11. Further discussion? Senator Berning.
- 12. SENATOR BERNING:
- 13. The original bill states population of four hundred
- 14. thousand and over. Is that still in there?
- 15. Well, Senator, after this next census, that includes my
- 16. county and my county has consistently been in opposition to
- 17. annexations of sizable parcels of property, whether it's to the
- 18. municipality, park district or any other. And I see that
- 19. this is being increased from sixty acres to eighty acres.
- 20. I originally opposed the sixty acres. I opposed even ten
- 21. acres. I...I believe that we are extending the prerogatives
- of, in this case, a park district far and away beyond
- what they were originally intended to be. I remember Senator
- Fawell repeatedly introducing this legislation or something
- very similar to it, and in my opinion, there isn't anything
- to...to justify authorizing annexation outside of the
- immediate boundary of a district. Adjacent to it is one thing,
- same thing.
- PRESIDING OFFICER: (SENATOR ROCK)
- Further discussion? Senator Johns.
- SENATOR JOHNS:
- Senator Bowers, would you explain the fourth amendment? Is there

- really a backdoor referendum in this and explain if you will,
- 2. please.

- PRESIDING OFFICER: (SENATOR ROCK)
- Senator Bowers.
- 5. SENATOR BOWERS:
- Yes. There is...the amendment was offered by Senator
- 7. Knuppel. It permits those districts that operate an
- 8. airport downstate to issue revenue bonds only, not general
- 9. obligation bonds, but revenue bonds for the purpose of
- 10. continuing the operation of that airport. It does have a
- 11. backdoor referendum provision in it.
- 12. PRESIDING OFFICER: (SENATOR ROCK)
- 13. Senator Johns. No, all right. Any further discussion?
- 14. Senator Rhoads. Senator Rhoads.
- 15. SENATOR RHOADS:
- 16. Thank you, Mr. President. One further question.
- 17. I realize it's a second time. Senator Bowers, what is it
- 18. about the Federal grant that requires the eminent domain
- 19. provision here?
- 20. PRESIDING OFFICER: (SENATOR ROCK)
- 21. Senator Bowers.
- 22. SENATOR BOWERS:
- 23. There is nothing about the Federal grant that requires
- 24. eminent domain other than the fact that the Federal
- 25. grant is for a specific limited piece of property. That
- 26. particular piece of property happens to be located outside
- 27. the district and without the power of eminent domain, they're
- 28. kind of at the mercy as far as price is concerned.
- 29. That's the only problem.
- 30. PRESIDING OFFICER: (SENATOR ROCK)
- 31. Is there any further discussion? Senator Bowers, do you
- 32. wish to close the debate?
- 33. SENATOR BOWERS:

- Only to...only to clarify something that Senator
- Berning brought up. Number one, park districts can already
- 3. acquire property outside of their district with no limitation,
- 4. so, as far as the first section is concerned, we're not talking
- 5. about anything new as far as acquisition. We are talking
- 6. about eminent domain, however. As far as the eighty
- acres is concerned, if I said that that applies to four
- 8. hundred thousand counties only, then I think I'm mistaken.
- 9. I think the eighty acre provision that Senator Guidice
- 10. put on this bill, would apply throughout the State of Illinois
- 11. and I'd like to correct that for the record because I think
- 12. Senator Berning was under the impression that the
- 13. eighty acre provision which was not part of the original bill,
- but that it applied only to counties over four hundred thousand,
- 15. that's simply not true. With that, I would ask for a favorable
- 16. roll call.
- 17. PRESIDING OFFICER: (SENATOR ROCK)
- 18. The question is shall Senate Bill 1528 pass. Those
- 19. in favor will vote Aye. Those opposed will vote Nay. The
- 20. voting is open. Have all voted who wish? Have all voted
- 21. who wish? Take the record. On that question the Ayes are 35,
- 22. the Nays are 17, 1 Voting Present. Senate Bill 1528
- having received a constitutional majority is declared passed.
- Senator D'Arco, for what purpose do you arise?
- SENATOR D'ARCO:
- Point of personal privilege, Mr. President.
- PRESIDING OFFICER: (SENATOR ROCK)
- 28. State your point, Sir.
- SENATOR D'ARCO:
- In the gallery behind me are the students from Reese
- Elementary School which is in my district and I would please
- ask that they stand and be recognized by the Senate.
- PRESIDING OFFICER: (SENATOR ROCK)

- which have been excluded by administrative fiat for the
- last forty years. The present administration, in an attempt
- to...to assess these...Attorney General's opinion that they
- 4. could be assessed. It would be a very difficult burden
- 5. at the present time, particularly in central Illinois,
- 6. where many of these coops were severely injured by the
- 7. ice storm and had to borrow as much as three and six million
- 8. dollars. And additional tax now extended against them,
- 9. would be passed onto the consumer and would be an additional

- 4. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Berning.
- 6. SENATOR BERNING:
- 7. Thank you, Mr. President. Senate... Amendment No. 4
- 8. to Senate Bill 571 is essentially the same as Amendment No. 3
- 9. but includes the provision for the annuitant to pay the employer
- 10. contribution. This is in conformity with the normal practice
- 11. and was in agreement with the decision in the Senate Committee
- 12. and I therefore move for adoption of Amendment No. 4.
- 13. PRESIDING OFFICER: (SENATOR ROCK)
- 14. Senator Berning has moved the adoption of Amendment No. 4
- 15. to Senate Bill 571. All right. The sponsor has asked that the
- 16. whole matter be taken out of the record. Take it out of the
- 17. record. ... Bruce. Senator Bruce, for what purpose do you arise?
- 18. SENATOR BRUCE:
- 19. Yes, we earlier today passed Senate Bill 1835 and two
- 20. amendments have been brought up by the Reference Bureau which
- 21. are...one is technical and one is substantive. I'd like to
- 22. move to reconsider the vote by which Senate Bill 1835 passed
- 23. and have it placed back on the Order of 3rd reading so we
- 24. can adopt those amendments tomorrow.
- 25. PRESIDING OFFICER: (SENATOR ROCK)
- 26. Senator Bruce has moved to reconsider the vote by which
- 27. Senate Bill 1835 was passed. Senator Walsh.
- 28. SENATOR WALSH:
- 29. Well, I wonder if you would explain the bill and as it
- 30. passed and the amendments and how it would change the bill.
- 31. PRESIDING OFFICER: (SENATOR ROCK)
- 32. Senator Bruce.
- 33. SENATOR BRUCE:

1. Right. The bill dealt with annuitants who were in our

- 2. State Employee Group Insurance Program. The amendment has
- 3. been brought up by the Reference Bureau would clarify that
- 4. in some more detail similiar to a House Bill which is being
- 5. sponsored by Representative McClain and they feel...they
- 6. feel safer with that language. The 2nd Amendment would to
- 7. be include...just as I was passing, Senator Weaver asked
- 8. whether or not the amendment on Cooperative Extension
- 9. individuals were...was in, I thought it was, it is not.
- 10. And that would add those people in... Cooperative Extension.
- 11. We've had some difficulity with the Federal Government on
- 12. reimbursement of Federally Funded State Employees and this
- 13. would include those individuals within our definition and
- 14. make sure that we can get the money from the Federal
- 15. Government put into the Insurance State Employee Group
- 16. Insurance Fund within the State Treasury. And so rather
- 17. than put those amendments on the House, I thought it would
- 18. be wiser to do that here and then send it to the House where
- 19. we don't have to come back again. You'll have another chance,
- 20. Senator Walsh, to vote on it.
- 21. PRESIDING OFFICER: (SENATOR ROCK)
- 22. All right. Senator Bruce has moved to reconsider the
- 23. vote by which Senate Bill 1835 was passed. We will need a
- 24. record vote. Those in favor of the Motion to Reconsider will
- 25. vote Aye. Those opposed will vote Nay. The voting is open.
- 26. Have all voted who wish? Take the record. On that question
- 27. the Ayes are 44, the Nays are none, none Voting Present. The
- 28. vote is reconsidered. Senate Bill 1835 will be ordered back
- 29. to the Order of 3rd reading. Further business to come before
- 30. the Senate. Senator Carroll.
