- 9. House Bill 975.
- 10. (Secretary reads title of bill)
- 11. 1st reading of the bill.
- 12. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 13. Senator Hynes. The hour of 12:45 having arrived, we will

- 18. SENATOR LANE:
- 19. Thank you, Mr. President, members of the Senate.
- 20. I move to discharge the Committee on Labor and Commerce and
- 21. place...to place on the Order of 2nd reading House Bill
- 22. 869. This legislation has been pending for a decade. During
- 23. that time, collective bargaining for school employees
- 24. has become a way of life in school district after school district.
- 25. Teachers and boards have kept pace with reality. But
- we have not. New contracts are signed by the score each year
- 27. but we have yet to give these contracts the security of
- 28. State mandate or regulatory machinery. Impasses and strikes
- 29. come and go.
- PRESIDING OFFICER: (SENATOR DONNEWALD)
- Just...just a moment, Senator. We're on a very
- important issue, Ladies and Gentlemen of the Senate. I
- don't think we should continue until we do have order.

- 1. No, please. There will be no demonstrations from the gallery.
- Now, just a moment. Will the Sergeant-at-Arms clear
- 3. all unauthorized personnel from the Floor? Senator Lane.
- 4. SENATOR LANE:
- 5. Thank you, very much, Mr. President. Impasses and
- 6. strikes come and go but we have not attempted to provide
- 7. a State education employment board to oversee crisis and
- 8. work to seek resolution of crises before strikes occur.
- 9. The teachers and boards are ready to and have been.
- 10. The public is ready and waiting. Now, let's get a move
- 11. on and step into the real world by passing this long
- 12. overdue legislation onto the Senate floor. I move the
- 13. motion.
- 14. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 15. Is there further discussion? Senator Savickas.
- 16. SENATOR SAVICKAS:
- 17. Yes, Mr. President and members of the Senate. I rise
- 18. in opposition to this motion. We have about a dozen collective
- 19. bargaining bills in committee waiting for a subcommittee
- 20. to hear them and at this time, I think it would be inappropriate
- 21. for us to discharge one or two bills and leave the others
- 22. in committee for hearings. I think it would be best
- 23. to hear them all collectively and to try and work out something
- 24. that's good for everybody in the State of Illinois for
- 25. collective bargaining. So, at this time, I oppose this motion
- 26. or any other motion to discharge the Labor Committee.
- 27. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 28. Senator Johns.
- 29. SENATOR JOHNS:
- 30. Mr. President, I rise in support of this motion to
- 31. discharge. We studied this question long enough. First,
- 32. public employees bargaining bill was introduced over
- 33. thirty years ago and we're still studying the question.

- 1. Teachers deserve and need a better bargaining position ...
- 2. a bargaining bill. There is no major industrial state
- 3. except Illinois which does not have a bargaining
- 4. Statute for teachers and or public employees. Our
- 5. neighbors to the east, Indiana, to the west Iowa, to the
- 6. north, Michigan, Wisconsin, all have statutes. In fact,
- 7. nearly thirty states have statutes on the subject of
- 8. collective bargaining. I've been a long time proponent
- 9. of this bill and I ask you, must the law always follow
- 10. the practice. Nearly two-thirds of the teachers of
- 11. Illinois bargain under some arrangement but because
- 12. there are no rules governing the current practice,
- 13. we have a hodgepodge of conflicting practices that
- 14. exist. The Statute would bring order out of chaos.
- 15. It is a need not only for which the time has come,
- 16. but is long, long overdue and I urge support of this
- 17. motion to discharge.
- 18. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 19. Senator Regner.
- 20. SENATOR REGNER:
- 21. Question for the sponsor.
- 22. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 23. He indicates he will yield.
- 24. SENATOR REGNER:
- 25. Senator Lane, I am curious about something and what
- 26. I'm wondering is, is the IEA going to make a contribution
- 27. to the State of Illinois to clean up the mess they made
- 28. in the rotunda this morning?
- 29. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 30. Well...Senator Lane. That doesn't pertain to the issue...
- 31. SENATOR LANE:
- 32. I didn't have...I didn't have time to go around...
- 33. PRESIDING OFFICER: (SENATOR DONNEWALD)

- ...at hand, Senator.
- SENATOR LANE:
- 3. ...looking for any messes, so I really wouldn't
- 4. be able to answer that.
- 5. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 6. Senator Regner.
- 7. SENATOR REGNER:
- 8. Well, I think it's very apparent that they're
- 9. totally inconsiderate of the taxpayers of the State of
- 10. Illinois and the mess they made out with the balloons
- 11. out there, all up in the dome and it's going to take
- 12. taxpayer's money to clean it up and I think that's where
- 13. the money should go since they'll get that opportunity.
- 14. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 15. I might advise the members of the Body that there
- 16. are a number of Senators that wish to address this issue
- and they're fast increasing. The next is Senator Glass.
- 18. SENATOR GLASS:
- 19. Thank you, Mr. President, Ladies and Gentlemen of
- 20. the Senate. As Senator Lane and I think Senator Johns
- 21. indicated, this bill is...bills of this type have been
- 22. pending for a long time and they've never passed. There
- 23. are a lot of problems with this bill. As Senator Savickas
- 24. has stated, this is one of a number of collective bargaining
- 25. bills that are in a subcommittee. I think the primary defect
- 26. in this bill is that it affects teachers only. It is...
- 27. it is only one section of the public employment sector
- 28. that would receive bargaining rights by law under this bill.
- 29. And if we do have legislation in this area, in my judgment
- 30. and in the experience of other states, it should apply
- 31. to all public employees on the same basis. That is, I think,
- 32. the only reasonable way to approach the problem. The bill also,
- 33. Ladies and Gentlemen of the Senate, permits teachers to strike.

- 1. And I don't know how this Body feels about that, but as
- 2. representatives of the public and the taxpayers, I think it's
- 3. wrong for public employees to strike under any circumstances
- 4. and this bill would specifically permit that. Finally
- 5. and without going through all of the provisions in the bill,
- 6. let me just make this observation. None of the legislation
- 7. introduced in this Session is the product of a balanced
- 8. approach. Negotiations between the school boards and the
- 9. teachers or management and labor in any respect, they are all
- 10. slanted entirely in favor of one side or the other.
- 11. There has really been no attempt in this State, unfortunately,
- 12. to come up with a balanced, fair collective bargaining
- 13. bill. This one is no different than the others. I'm
- 14. afraid what it would do instead of provide labor stability
- 15. in Illinois, it would provide more unrest and more strikes.
- 16. And I think I know whereof I speak and I would like to close
- 17. my comments, Mr. President, with a few facts that I think this
- 18. Body may be interested in. The...when ...when we say that
- 19. a collective bargaining bill will stop strikes, if anybody
- 20. thinks that's true, just listen to these figures.
- 21. In the State of California there were three years...in the
- 22. three years before legislation, there were two public
- 23. employees strikes. But in the...in the ten years since
- 24. that State has had collective bargaining legislation, there
- 25. have been one hundred twenty-nine public employees' strikes.
- 26. In the State of Michigan, in the seven years before their
- 27. collective bargaining legislation, there was one public
- 28. employee strike, but in the six years after that legislation,
- 29. there have been two hundred ninety strikes. In New Jersey,
- 30. ten years before the legislation, there were thirty-one
- 31. strikes and in merely three years after the legislation,
- 32. sixty-two strikes. The State of New York in the nine
- 33. years before the legislation, thirty-seven strikes, but in

eleven strikes. 2. PRESIDING OFFICER: (SENATOR DONNEWALD) Just...just a moment. For what purpose do you 4. arise, Senator D'Arco? 5. SENATOR D'ARCO: 6. Mr. President, I know there are many speakers 7. that wish to speak on this bill. Are we using the timer? 8. PRESIDING OFFICER: (SENATOR DONNEWALD) 9. We are using the timer and I was going to advise ... 10. SENATOR D'ARCO: 11. ...been flashing... 12. PRESIDING OFFICER: (SENATOR DONNEWALD) 13. ... Senator Glass that his time had expired. He has two 14. seconds. Senator Glass. 15. SENATOR GLASS: 16. I was on my last sentence, Mr. President and it 17. is Pennsylvania and the ten years before collective bargaining 18. legislation, there were twenty-three strikes, but in the 19. three years after one hundred forty-one strikes. 20. I urge the defeat of the motion. 21. PRESIDING OFFICER: (SENATOR DONNEWALD) 22. Senator Schaffer. 23. SENATOR SCHAFFER: 24. Mr. President, I, like Senator Glass, perhaps, have 25. some reservations about the bill, not the concept, but I think 26. we should put the bill before us. I think the Governor 27. of this State is for this concept. I've talked to him on 28. several occasions about this bill. I think he'd like 29. to have it on his desk and he'd like to have it there in good 30. form, but we need a vehicle and this is a vehicle. It should 31. come out. Thisis an important enough issue for this General 32. Assembly to consider this year cause the taxpayers of this State 33. need legislation of this type to regulate employee disputes, 34.

- 2. This bill, if it's handled properly, will solve a lot of
- 3. problems, not only for educators, but also for the taxpayers
- 4. and we should put it before us and not hide from it.
- 5. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 6. Senator Knuppel.
- SENATOR KNUPPET.:
- 8. Mr. President and members of the Body. We've been
- 9. dealing with collective bargaining in one form or another
- 10. ever since I came here in 1971. Unfortunately, even in the
- 11. labor sector, too many bills get bottled up in labor and
- 12. never see the day of light...light of day. I had bills in
- 13. there with respect to the Workmen's Compensation law that
- 14. never got out. I...I can't rely on the promise that these
- 15. bills will be heard. I... I don't think that...that this is
- 16. what will happen. This is a vehicle. I agree with Senator
- 17. Schaffer. If...if I really sincerely thought that these
- 18. bills would be debated, would be worked over, amended
- 19. and brought out, I would agree one hundred percent that
- 20. that's the place it should be done. But it's not going
- 21. to be done there. It wasn't done with other labor legislation,
- 22. whether you're on labor's side or whether you're on industry's
- 23. side. What we had was the resulting bill here that was
- 24. a hybrid of Republicans and people who had no experience
- 25. at all in handling Workmen's Compensation cases. That's
- 26. what this may turn out to be. These people in the balconies
- 27. and in this building today and the teachers have heard for
- 28. seven years that old you say, promises, promises, promises.
- 29. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 30. Senator Davidson.
- 31. SENATOR DAVIDSON:
- 32. Yes, Mr. Chairman, members of the Committee...excuse
- 33. me, members of the Senate. I'd like to rise in support of

bargaining bills for teachers in 1973 as a freshman 2. who did not see the light of day being held in committee 3. cause we're going to work on it, being a cosponsor again 4. in '75. More importantly, we need something for both 5. the teachers and their representatives and the school boards 6. and their representatives to be able to have some 7. guidelines to negotiate within that framework. Now, it's 8. a jungle. It's a zoo. Each school board...each school 9. board association group, each teacher group have to try 10. to make their own guidelines. There's nothing to operate 11. under to direct a way or a fact finding or a guideline 12. wherein the end result a strike might be necessary 13. and most of these is particularly in the bill that I had 14. which is still in committee. If they ever got to strike 15. which is very impossible, not...improbable, not impossible, 16. the public would know who was not negotiating in good 17. faith and that's one of the things we need to know 18. cause now we know both sides have been quilty and not 19. negotiating in good faith. Nobody in this argument either 20. side is lily pure. Both have had their faults, both 21. have had their good points. I urge a Yes vote on this 22. discharge motion so we can take this problem up before us. 23. PRESIDING OFFICER: (SENATOR DONNEWALD) 24. Senator Mitchler. 25. SENATOR MITCHLER: 26. Mr. President and members of the Senate. I believe 27. we're deviating a little bit from the motion that has been 28. made. The motion is to discharge the Senate Labor and 29. Commerce Committe from hearing this bill, Senate...House 30. Bill 869. Now, this is not an uncommon motion in this 31.

Body or the other Body across the rotunda, but there's

always a reason when this Body supports such motion. Now,

- 1. I have spoken with the chairman of that committee, members
- 2. of the committee, and it is my understanding that the committee
- 3. has placed a number of bills relating to collective
- 4. bargaining for public employees into a working subcommittee.
- 5. This subcommittee is to continue the analysis of this
- 6. type of legislation which is completely new legislation
- 7. to the State of Illinois. Yes, it has been heard before,
- 8. but to date, we have not enacted legislation that will
- 9. create public employee collective bargaining. I served
- 10. for ten years on the committee that is now...has these
- 11. bills before it. This is the first year that I have not
- 12. served on that committee. I respect the work of that
- 13. committee, as I do other committees and for me to discharge
- 14. that committee from their responsibilities and their
- 15. deliberation on many bills relating to this very important
- 16. subject matter would be taking it away from them, their
- 17. responsibility and my saying to them, we had better discuss
- 18. it on the Floor. That is the primary vote that you are
- 19. going to cast now, whether or not the Senate Labor and
- 20. Commerce Committee is properly considering the bill that
- 21. was placed before it by the Committee on Assignment of Bills.
- 22. I say to you that the committee is functioning. I have
- 23. counseled with them on many occasions during this Session
- 24. as to what they're doing with the many bills they have had
- 25. in there because I've received many letters, both pro and con
- 26. on this subject. I'm fully aware of what they're doing.
- 27. I have greatest respect for each and every member on that
- 28. committee and I see no reason I should distrust their
- 29. responsibility and their loyality to do a good job.
- 30. That is what you are voting on, not the bill itself.
- 31. When that bill comes out of the committee or any of those
- 32. bills, however and whatever form they come out on, then
- 33. and only then will you debate on the merits of the situation

- 1. of collective bargaining for public employees, whether
- 2. it be garbage collectors, whether it be teachers, whether
- 3. it be policemen or firemen or...
- 4. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator...
- 6. SENATOR MITCHLER:
- 7. ...whatever it may be. So, I urge you to support
- 8. the chairman of the committee when he asks for a negative
- 9. vote to allow the committee to further deliberate on these
- 10. important bills that they are considering.
- 11. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 12. Senator Buzbee.
- 13. SENATOR BUZBEE:
- 14. Thank you, Mr. President. Mr. President, it's
- 15. very strange to me that we talk about the sacredness
- 16. of the committee system around here. I didn't hear Senator
- 17. Mitchler give that same speech when we discharged the
- 18. Senator Labor and Commerce Committee on...when
- 19. we were talking about Workmen's Comp and Unemployment Comp
- 20. bills. He didn't think the committee system was so
- 21. sacred at that time, felt that perhaps there were enough
- 22. people on this Floor that felt that was a good idea that
- 23. we went ahead and discharged the committee and got it out
- 24. on the Floor so we could discuss the whole issue because
- 25. Labor and Commerce Committee didn't want to let the bill out.
- 26. Now, that's what we're really talking about here is whether
- 27. Labor and Commerce wants to let the bill out. They obviously
- 28. do not. We've had this concept for about thirty-five
- 29. years now. Nothing has come about out of...come out of it
- 30. yet and there simply are some of us on this Floor who know that
- 31. that bill will never come out of the Labor and Commerce Committee
- 32. and so we are going to go ahead and extract it from that
- 33. committee if we have sufficient votes today. There's nothing

- 1. sacred about the committee system. It's not even mentioned
- 2. in the Constitution of the State of Illinois or the United
- 3. States as far as I know and it's something that we have
- 4. created, we can undo or do it whichever way we decide to do.
- 5. Weekly, in this Legislative Body, committees are discharged
- 6. from the consideration...from further consideration and we
- 7. put it on the Floor where are..where sufficient members
- 8. can have their own input. Now, Senator Glass' arguments
- 9. perhaps were good ones. I don't know. Quite frankly,
- 10. I have not read this bill yet. I do not intend to until I
- 11. see if it gets out on the Floor or not. Then, I'm going
- 12. to take my time to read the bill. If it gets out on the
- 13. Floor, perhaps we ought to amend...amend it. Perhaps
- 14. it does go too far. But there's nothing wrong with our
- 15. letting it out on the Floor today. The irony, of course,
- 16. of all of this is, that we have some opposition from...
- 17. from some of the friends of labor, particularly those who
- 18. reside in the City of Chicago. The irony of this
- 19. is that the City of Chicago has collective bargaining
- 20. for their teachers. That's all we're asking for downstate
- 21. teachers and so I think this is a good motion. It gives
- 22. us all an opportunity to decide what should go into the bill,
- 23. what should be taken out of it and hopefully if we get
- 24. thirty votes today, why we'll all have that chance for
- 25. input. Thank you.
- 26. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Harber Hall.
 - 28. SENATOR HARBER HALL:
 - 29. Mr. President, I'm somewhat concerned about this
 - 30. motion this morning. We've debated collective bargaining
 - 31. as has been pointed out several times already in this debate
 - 32. for many, many years and we have not chosen to pass a
 - 33. collective bargaining in Illinois and now here with the
 - 34. demonstration of a thousand teachers down here and they're

- my friends, I know them personally and I like them, but to...
- 2. under the pressure of that type of lobbying to call for a
- 3. motion at this time, seems to me to be giving into mass
- 4. lobbying technique. I think we have to watch that, particularly
- 5. in this Body. We are having a meeting Friday, a day
- 6. after tomorrow at 1:30 in the committee at which this bill
- 7. and many others will be discussed and if that...after that
- 8. time if nothing has come out, that would be a more
- 9. appropriate time if one...we're going to call such a motion
- 10. and I would suggest that we permit the committee to...and
- 11. give it every opportunity to try and select a bill, if that's
- 12. their will, and pass that bill out and if not, make such
- 13. a motion at a later time.
- 14. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 15. Senator Ozinga. Senator Newhouse.
- 16. SENATOR NEWHOUSE:
- 17. Thank you, Mr. President. Mr. President, the issue
- 18. of collective bargaining is here and it's not going to go
- 19. away. The fact is that we're going to have to deal with it
- 20. one way or another at some point and the question is, what
- 21. interest ought to be served by a collective bargaining bill?
- 22. There are those who contend that in the bargaining that takes
- 23. place to date, there is unfair advantage exerted by both
- 24. sides. If that's true, that's unfortunate. If that's
- 25. true, then the need for this bill emerges before us here today.
- 26. Many of us, and I'm one of them, would like to deal with
- 27. this question. And for that reason, I will vote to discharge
- 28. committee today. I think this year, we ought to consider it.
- 29. Because I am voting for this bill today, does not necessarily
- 30. mean I will vote for it at passage stage without amendments.
- 31. I am for a collective bargaining bill. I think there
- 32. ought to be one. I am opposed to State sanctioned strikes.
- 33. I understand the need for a strike as a weapon. I understand

- also the rationale of having some kind of negotiating
 sessions that are binding, arbitration that perhaps is
- 3. binding. I would see that as a preference over the use
- 4. of the strike as a tool. However, if those who
- 5. are involved see that they must use the ultimate weapon,
- 6. then sobeit. But that then must be their decision, a
- 7. decision with which they are prepared to live. For the
- 8. State to sanction such a position, would seem to me to be
- g. an unconscionable betrayal of the trust of the public,
- 10. whom we are charged with serving. I would hope that then
- 11. before this bill comes up for...to the final passage
- 12. stage, that something can be worked out to satisfy what
- 13. I see as a serious flaw. But today I would hope that the
- 14. bill comes out to the Floor where there can be debate, where
- 15. there can be amendment...necessary, where there can be
- 16. some kind of an agreement and that we do wind up with a
- 17. bill for public employees at least for the teachers' sector.
- 18. That, I see, is opening the door and I would hope that it
- 19. would be so.
- 20. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 21. Senator Wooten.
- 22. SENATOR WOOTEN:
- Thank you, Mr. President. First of all, I would like
- 24. to comment briefly on Senator Glass' figures and statistics.
- 25. I believe they reflect more a growing unrest in this whole
- 26. sector than in anything else. I think we like to delude our-
- 27. selves that quite often the laws that we pass really determine
- 28. social behavior and that simply is not the case. But I'm
- 29. supporting this discharge motion because I am a Democrat
- 30. and because I do believe in what's...is sometimes referred to
- 31. as that little man. It's interesting that when we address
- 32. the subject of Workmen's Compensation and cut at the monied
- 33. nexus at the center of labor between the legal profession and

- 1. labor leaders, there was a scream and an outcry. But when
- we attempt to deal with collective bargaining, which addresses
- 3. the rights of constituent members, then it suddenly isn't so
- 4. important. I would like to recommend this to my friends
- 5. on the Republican side for a very practical reason. This
- discharge motion presents itself to me as an opportunity
- to put forth collective bargaining but I offer it to you
- 8. as an emancipation for the Republican Party.
- 9. How many times have you been forced to vote for odious
- 10. measures under the threat that if you don't do it, we're
- 11. going to bring collective bargaining out of committee.
- 12. Well, I'll tell you, my friends, if we get rid of this
- 13. thirty years Sword of Damocles over your head, once and for
- 14. all then you can vote a bit more freely in this Chamber.
- 15. Let's get it out of committee. Let's put it on the books.
- 16. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 17. Senator Bruce.
- 18. SENATOR BRUCE:
- 19. Thank you, Mr. President and members of the Senate.
- 20. I was just talking to Senator Savickas and he said he
- 21. agrees with everything that Senator Wooten has said, so...
- 22. we are on a motion to discharge House Bill 869
- 23. and the next motion that will be before this Body is on
- 24. House Bill 2205. Those bills are similar and it's interesting
- 25. that the House continues to send us several bills, several
- 26. alternatives on collective bargaining to which we never
- 27. respond. I hear sponsors say, well, we ought not have
- 28. everyone in one bill. We ought to have...have teachers
- 29. and firemen and policemen and all in separate bills.
- 30. In the seven years I've been here, I've seen separate pieces
- 31. of legislation put on...in for each particular category
- 32. of public employee and I'm told, then, well, we don't want to
- 33. have a bill for teachers or firemen or policemen or State

- 1. employees. What we ought to have is a comprehensive bill
- 2. and so each of the seven years, I've seen comprehensive
- 3. bills put in and then the cry being said, well,
- 4. we don't want to have a comprehensive bill. What we ought
- 5. to have is a bill for the policemen, the firemen, the teachers,
- 6. the State employees and nurses and all the other public
- 7. employees. So, I think that argument is certainly getting
- 8. tiresome for me and I wish that someone would find a new
- 9. one. Every year since 1947, we have put in a bill to...
- 10. regulate and allow public employee collective bargaining
- 11. and every year since 1947 those bills have died.
- 12. Several gentlemen in this Chamber have sponsored collective
- 13. bargaining bills. Senator Harris, Senator Rock, Senator
- 14. Davidson, Senator McCarthy, Senator Lane, Senator Demuzio
- 15. and others have introduced legislation and each time
- 16. the Senate Labor Committee has refused to let out a single
- 17. bill without some sort of motion to discharge. Now, let's
- 18. be serious. These bills won't be heard in committee.
- 19. They won't be heard. And if they are heard, it is certainly
- 20. an issue that has been studied to death. We are in a time
- 21. of graduation speeches and I'm reminded of the fact that
- 22. a hearing on these bills would be similar to a graduation
- 23. speech. Much is said but little is heard. That's exactly
- 24. what would happen in the Labor Committee even if a hearing
- 25. did...did occur in those committees. There would be a lot
- 26. of testimony, a lot of going around the State of Illinois
- 27. and in conclusion, the committee would do nothing. I served
- 28. two years on one of those public employee subcommittees and
- 29. we had hearings throughout the State of Illinois and
- 30. Chicago and downstate. I thought we had a very comprehensive
- 31. bill. It was the first two years I was here and I thought
- 32. we were down to serious business. Then I found that we weren't
- 33. going to pass any bill. The idea was to muddy the water to do

- a lot of shuffling around and finally, if we shuffled
- long enough, no one would realize that we weren't going to
- 3. do anything. I don't often seek to discharge a bill from
- 4. committee but the treatment of school teachers in the State
- 5. of Illinois require that this Body take some action.
- 6. That the bill be discharged so that each and everyone of us
- will have a chance to review it, amend it and make our
- 8. decision on the matter. Illinois is only one of two industrial
- 9. states along with Ohio that has refused to allow teachers
- 10. to organize and bargain collectively. Now, the Governor
- 11. is in favor. In his campaign for election he said, "for
- 12. too long Illinois citizens including children in school
- 13. and public employees, have suffered for the lack...
- 14. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 15. Senator...
- 16. SENATOR BRUCE:
- 17. ...of a comprehensive, sensible and meaningful
- 18. collective bargaining bill."
- 19. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 20. Your time...
- 21. SENATOR BRUCE:
- 22. "I shall sign such a collective bargaining bill
- 23. if it contains...realistic and effective impass procedures."
- 24. In conclusion, Mr. President, I would point out that the
- 25. platform of the Democratic Party also states, that an
- 26. enactment of a public employee labor relations Act with
- 27. protection of the rights of public employees and protection
- 28. of the rights of the public. Those things in mind, Mr.
- 29. President and members of the Senate, I rise in favor of
- 30. the discharge motion on 869 and will likewise rise in
- 31. favor of the discharge motion on 2205.
- 32. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 33. Senator Hickey.

- 1. SENATOR HICKEY:
- Thank you, Mr. President and members of the Senate.
- 3. I haven't been here seven years to see this thing drag
- 4. on and on but I have been here three and I can tell you that
- 5. when I first came, it was one of the...one of the many shocks
- 6. that I suffered. I simply couldn't believe it when I saw
- 7. Democrats voting against collective bargaining. Now,
- 8. this is not just a Republican issue or a Democratic
- 9. issue, either one. The Republicans can do as they like
- 10. about this. I'm very pleased to hear several of them
- 11. say today that they are for...for the discharge motion and I hope
- 12. that they'll be for the bill once it's in proper shape.
- 13. But certainly for Democrats to take a position against
- 14. collective bargaining, I, as a member of that party, really
- 15. find very, very embarrassing. I have seen this bill.
- 16. I've read this bill, I've gone over it carefully. There
- 17. are a few minor changes that I think need to be made in it
- 18. and I want to offer those changes on the Floor, but
- 19. principally, I want us to get this out, get working with
- 20. it and I want to say that I think that this is a little
- 21. like the old saying about justice, that justice delayed
- 22. is justice denied so is collective bargaining and something
- 23. for the teachers who are here today, I don't think they want
- 24. us to study this so long that they receive collective
- 25. bargaining posthumously. Let's get it out on the Floor.
- 26. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 27. Senator Kenneth Hall.
- 28. SENATOR HALL:
- 29. Thank you, Mr. President and Ladies and Gentlemen
- 30. of the Senate. You know, that you find out after you've
- 31. been here a while that the many things that you run into...
- 32. I've always been supportive of collective bargaining
- 33. and I just happen to be one of the legislators that have

- 1. two unions that represent the teachers in my area.
- 2. So, now, I get a letter...this...at the eleventh hour
- 3. from the Executive Secretary of the IFT saying that they're
- 4. opposed to this because the IEA is discriminating against them.
- 5. You know that it really creates a problem for you at times
- 6. and I just happen to have about eighty percent of my
- 7. teachers are IFT's. But I've been a strong supporter
- 8. of collective bargaining so you know what you do and I don't
- 9. need to tell you fellow legislators how you are .
- 10. sometimes like a cat on a hot tin roof, you stand on one
- foot and you stand on the other. I'm going to support
- this. I'm going to vote to discharge this committee.
- But I'd like to serve notice on both groups that they
- should get together. They shouldn't be fighting one another
- down here, because they end up putting legislators in the
- middle. Now, it's just not right for them to come here,
- tell us all along that they're for something and then when
- you find at the eleventh hour that you find there is a
- division. This creates a serious problem for you. But
- I'm committed to collective bargaining and I'm going to 20.
- vote to discharge this committee.
- PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Washington.
- SENATOR WASHINGTON:
- Mr. President and members of the Senate, I, too,
- ...I share Senator Hickey's concern about the posture
- of the Democratic Party, my party for all my adult
- life in relationship to its attitude toward collective 28.
- bargaining. And I would be of the feeling, the impression 29.
- of my party would take a posture which would no way 30.
- would give anyone the impression that they were opposed to $31. \ \ \,$
- collective bargaining. But I can understand if some 32.
- members of my party are opposed to it. What I cannot understand 33.

- 1. is that any of them would attempt to frustrate
- 2. our attempts to have a full flown debate on the merits
- 3. of this bill. I'm not going to comment on the philosophy
- 4. of the merits because based on twelve years of association
- 5. with most of you down here, I have a feeling that most
- 6. people know how they're going to vote on the bill
- 7. before it gets out committee, which is another reason
- 8. why we shouldn't waste time with a subcommittee. But
- 9. as Senator Bruce said, and as Senator Buzbee said,
- 10. the committee system is not sacrosanct, it's not cast
- 11. in stone. And we have rules for discharge just to take
- 12. care of such situation as this. When there is a state of
- 13. readiness on the part of a substantial number of the
- 14. members of a body to discuss the merits of an issue, I think
- 15. the rules provide that they should do so. I'm going to
- 16. support the motion to discharge. I'm not that conversant
- 17. with the details of this bill, but I want to make it very
- 18. clear that I support collective bargaining for public employees
- 19. and I think it's a travesty on justice and common sense
- 20. that we, in the State of Illinois, have not addressed ourselves
- 21. affirmatively to that question before now. And all we're
- 22. doing by vacilating is creating unrest among government
- 23. employees. This thing must be brought to rest. A roll call
- 24. is necessary. Teachers and others must know where they
- 25. stand in relationship to their rights to bargain collectively
- 26. in this State. I think each party and each member of each
- 27. party should go on record for or against. I'm not concerned
- 28. or I'm not turned off by virtue of the fact that there
- 29 are teachers down here. They belong here. We're dealing
- 30. with their business and they have a perfect right to be here.
- 31. I would suggest to them that they come every day and sit in the
- 32. balcony and go to the committees and find out where these
- 33. legislators, particularly in my party, which profess to be for
- 34. the working man, where they stand on this issue. I would like

- 1. to see a roll call on it. I'm getting sick and tired of
- 2. my party posturing as a supporter of the employee and the
- 3. poor man and then invidiously and incidiously cutting the
- 4. legs out from under him in such bills as this. I would
- $_{5}$. like to see a roll call and I would suggest to all you
- 6. in the balcony, bring your mothers, bring your fathers,
- 7. bring your daughters and your sons and see just what
- 8. they're doing down here with your rights. I'm going
- 9. to support this motion to discharge.
- 10. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 11. Senator Demuzio.
- 12. SENATOR DEMUZIO:
- 13. Well, thank you, Mr. President and members of the
- 14. Senate. I will certainly be brief. I believe
- 15. that my two and a half years that I've been in the Senate
- 16. that I've only supported one discharge motion that I could
- 17. recall and it, too, was collective bargaining. And I'm
- 18. going to support this motion today on House Bill 869
- 19. specifically because I think it is a State-wide issue. It is
- 20. an issue that needs to be discussed and debated by the full
- 21. Senate, not just by the Labor and Commerce Committee. I heard
- 22. Senator Mitchler say a few minutes ago that they have a
- 23. working subcommittee in the Labor and Commerce Committee.
- 24. It's been in a working subcommittee for over thirty years
- and today is the time that we need to have this bill debated,
- 26. bring it out to the Floor and decide for ourselves what
- 27. ought to be a matter of public policy as far as collective
- 28. bargaining is concerned. Say to Senator Harber Hall who
- 29. indicated a few minutes ago that he had friends that were
- 30. in the teaching profession in education. If you believe in
- 31. the same philosophy and the same principals that they believe
- 32. in then you shouldn't have any problems in voting for this
- 33. discharge motion. This issue needs to be directed to the full

- 1. Senate, needs to be on the Floor, can certainly be compromised.
- 2. The Governor said he would, in fact, sign a meaningful
- 3. collective bargaining bill. It is not a partisan
- 4. issue. It's one that we can as men and women, sit down
- 5. and compromise and send a bill to the Governor that he
- 6. will agree with that will benefit all of the working
- 7. men and women in education and I urge your support.
- 8. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 9. Senator Chew.
- 10. SENATOR CHEW:
- 11. Thank you, Jesus. I think when...when individuals
- 12. have a right to say and a right to do that all mankind
- 13. with degrees of decency can come together on any issue
- 14. that's beneficial to the masses. The teachers teach
- 15. our children. They collect a paycheck. We, over the
- 16. years, have held, more or less, public employees in
- 17. hostage. We say, you can't do this and we can't
- 18. to that. There's a possibility that we are really
- 19. impeding on their freedoms. They spend years in school,
- 20. they go back and get advanced degrees. They are the mothers
- 21. and fathers of our children when we are out working
- 22. trying to keep them where they are. They ought to have it,
- 23. we're going to give it to them. If we don't, we're going
- 24. to have problems. I want to give the Governor any bill
- 25. that he wants on his desk pertaining to this issue.
- 26. Let him select the one he wants to sign. I'm going to
- 27. support the Governor in this. If the other committees,
- 28. subcommittees or rhetoric have other bills...let us get
- 29. them out too, but let's pass them on to the Governor.
- 30. The teachers are here. They've been here before. We
- 31. don't need to have them coming back. They're only
- 32. asking us as their lawmakers, to represent them properly
- 33. and get the hell out of this political issue that we are

- 1. holding, hoarding, failing to negotiate simply because it's
- 2. a political issue and I don't think we ought to have
- 3. politics so involved in the rights of people and I am going
- 4. to support the discharge motion and I don't care who likes
- 5. it or who doesn't like it.
- 6. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 7. Is there further debate? Senator Lane. Senator
- 8. Vadalabene.
- 9. SENATOR VADALABENE:
- 10. Yes, what has been said already would be sort of
- 11. superfluous for me to repeat. However, I just want to say
- 12. that I'm going to support the motion to discharge the committee
- 13. in regard to the collective bargaining bill.
- 14. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 15. Is there further debate? Senator Rhoads.
- 16. SENATOR RHOADS:
- Just very briefly, Mr. President. I see some
- 18. buttons around here that say "IEA asks why not?"
- 19. If any member of this Chamber is familiar with what's
- 20. gone on in the State of New Jersey, in the last eighteen
- 21. months, the gangster type tacticts that have been used by
- 22. NJEA against teachers who dared to resist their tacticts,
- 23. that's why not.
- 24. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 25. Is there further debate? Senator Berning, number
- 26. twenty two.
- 27. SENATOR BERNING:
- 28. Thank you, Mr. President and members of the Senate.
- 29. I want to emphasize that in my opinion, this is not a
- 30. political issue and I agree with Senator Chew that it ought
- 31. not to be. There isn't anything that I see that makes it
- 32. a political issue. It's an issue that is right or wrong.
- 33. The citizens from whom I have heard in my district overwhelmingly

- 1. oppose collective bargaining for any, I repeat, any public
- 2. employee. It isn't a question of rights for collective
- bargaining or rights for strike for public employees.
- These rights were withheld long ago and were recognized
- as the prevailing prerogative of the public when anybody
- 6. sought employment and took a job, whether it was in the
- 7. Highway Department or as a teacher. There is nothing, I
- 8. repeat, there is nothing that can justify collective
- 9. bargaining and the right to strike. The deplorable aspect
- 10. of what has been occurring with strikes periodically
- 11. is that these very people who are requesting, yes, even
- 12. demanding they be granted the right to collective bargain,
- 13. and to strike, have all too frequently participated
- 14. illegally in strikes and yes, they are the ones who set
- 15. the standards and the patterns for the young people for whom
- 16. they so willingly say to us, provide us with more and more
- 17. so that we can justify our commitment to quality education.
- 18. There seems to me to be a paradox in these positions.
- 19. And Mr. President, I repeat, the preponderance of
- 20. John and Jane Q. Citizen from whom I hear, insist collective
- 21. bargaining should not be granted to public employees.
- 22. Thank you.
- 23. PRESIDING OFFICER: (SENATOR ROCK)
- 24. Any further discussion? Senator Lane may close the
- 25. debate.
- 26. SENATOR LANE:
- 27. Thank you, Mr. President. As has been shown, this
- 28. issue...this issue is most controversial, critical and
- 29. extremely important. I don't believe it should be supressed
- 30. any longer. I move to discharge committee.
- 31. PRESIDING OFFICER: (SENATOR ROCK)
- 32. Senator Lane has moved to discharge the Committee on
- 33. Labor and Commerce from further consideration of House Bill

- 1. 869. Thirty affirmative votes are required. Those in
- 2. favor will vote Aye. Those opposed will vote Nay. The
- 3. voting is open. Have all voted who wish? Have all voted
- 4. who wish? Take the record. On that question, the Ayes
- 5. 27, the Nays are 12, 4 Voting Present. The motion fails.
- 6. Further Motions in Writing.
- 7. SECRETARY:
- 8. Senator Bruce has a Motion in Writing on House
- 9. Bill 2205 Moves to discharge the Committee on Labor and
- 10. Commerce and place on the Order of 2nd reading.
- 11. PRESIDING OFFICER: (SENATOR ROCK)
- 12. All right. Ladies and Gentlemen, the business before
- 13. the Body is Senator Bruce's motion to discharge 2205,
- 14. Mr. Secretary. Senator Bruce.
- 15. SENATOR BRUCE:
- 16. Thank you, Mr. President and members of the Senate.
- 17. We have before us, now, House Bill 2205 which I mentioned
- 18. was similar in nature to House Bill 869, but perhaps we
- 19. ought to review what is before us for consideration.
- 20. It would establish a three member employ...Education
- 21. Employment Relations Board, all appointed by the Governor
- 22. and approved by this Body. They would have six year
- 23. terms and a staff. They would certify public employee
- 24. bargaining organizations, as exclusive bargaining agents.
- 25. They would conduct elections, clarify definitions
- 26. of bargaining units. It would apply to all school
- 27. districts in the State of Illinois including community
- 28. colleges and senior institutions. It would exclude from
- 29. its coverage elected officials, board members, management
- $_{
 m 30.}$ employees, administrators and personnel having access to
- . 31. confidential records of the employer. On the scope of
 - 32. bargaining, they could do what is allowed under National
 - 33. Labor Relations Act, that is the right to bargain collectively

on salaries, working conditions and working hours. l. grievance procedure is not mandated by 2205, but must 2. be negotiated into the contract. Mediation is required, 3. fact finding may be utilized. Binding arbitration is not 4. within the confines of 2205, but each of the parties 5. may mutually agree to its use so that questions concerning 6. the contract and language might be resolved by an outside 7. impartial party. On strikes, there are four requirements. 8. At least sixty days must have expired from the commencement 9. of negotiations. All mediation procedures must have been 10. utilized and exhausted. Fact finding must have been 11. completed. A five day advanced notice must be given before 12. a strike can be had and additionally, no...no contract 13. can be in effect. Employers are given the right to seek 14. injunctions, if the strike becomes a clear and present 15. danger. It sets forth unfair labor practices for both the 16. employer and the employee and gives the Judiciary 17. of this State the right to review all the decisions 18. of the Education Employment Relations Board. I think this 19. is a model bill. Perhaps it ought to apply to all 20. public employees in the State of Illinois but the decision 21. was this year to go with the bill that only applied to 22. teachers. And I think the bill before you and 2205 23. is a commendable bill and should be acted on by this Body 24. and I would move that it be discharged from further 25. consideration by the Senate Labor and...Senate Labor and 26. Commerce Committee. 27. PRESIDING OFFICER: (SENATOR ROCK) 28. Any discussion? Senator Savickas. 29. SENATOR SAVICKAS: 30. I would move that this bill should receive the 31. same vote that the other one did and if there's leave 32.

of this Assembly for the same roll call, I'm sure it would

33.

- 1. save us a lot of time.
- PRESIDING OFFICER: (SENATOR ROCK)
