29. II, Senator Netsch's committee. I'd like to make a motion to
30. discharge Judiciary II from further consideration of House
31. Bill 1915 and place House Bill 1915 on the Order of 2nd reading.

28. What's up, Senator Grotberg?
29. SENATOR GROTBORG:
30. I think this is the bill that Senator Vadalabene has
31. an amendment for.
32. PRESIDING OFFICER: (SENATOR JOHNS)
33. Well, let's see where he is. Senator Vadalabene, he's

2. SENATOR GROTBORG:

3. Am I correct, Senator?

4. PRESIDING OFFICER: (SENATOR JOHNS)

5. ...he's recognized. Is that correct? It's up here.

6. All right. Senator Vadalabene is recognized to explain

7. his amendment. Is it No. 1, Mr. Secretary? On House Bill

8. 1097. Wait a minute, Senator Grotborg. Now, you just wait

9. just a moment. Now, we couldn't here you. I'll recognize

10. you. Now, tell us what you want to tell us, okay.

11. SENATOR GROTBORG:

12. I...I just don't want to delay the proceedings while we're

13. looking for...if you'll take it out of the record for a moment

14. and come back to it, I'd appreciate it.

15. PRESIDING OFFICER: (SENATOR JOHNS)

16. I think we're...is that...is that what you want, Senator

17. Sam? Take it out of the record. Okay. Take...House Bill

18. 1097 out of the record. Now, we'll move on. House Bill 1105, \

19. I think, Mr. Secretary. Senator Collins. Senator Collins,

20. do you want that read? She does. Okay.

23. (Secretary reads title of bill)

24. 2nd reading of the bill. The Committee on Insurance and

25. Licensed Activities offers one amendment.

26. PRESIDING OFFICER: (SENATOR JOHNS)

27. Senator Collins is recognized.

28. SENATOR COLLINS:

29. Committee Amendment No. 1 is designed to provide protection

30. to the employer and the employee in reference to information

31. gathered and submitted to the Department of...of Registration

32. and Education pertaining to the competency of any employee.

33. It...merely states that the employer must sign an affidavit

1. stating that the information to the best of his knowledge is
2. accurate information, and I move for the adoption of the
3. amendment.

4. PRESIDING OFFICER: (SENATOR JOHNS)

5. Any questions on the amendment? She moves the adoption
6. of Amendment No. 1 to House Bill 1105. All those in favor
7. say Aye. All those opposed say Aye. The amendment is
8. adopted. Mr. Secretary.

9. SECRETARY:

10. No further committee amendments.

11. PRESIDING OFFICER: (SENATOR JOHNS)

12. Any further amendments from the Floor? Senator Soper
13. has indicated he has one. Senator Soper. He's not here to
14. present it. 3rd reading, Mr. Secretary. House Bill 1108, Senator
15. Nimrod. Senator John Nimrod, are you listening, Sir. The
16. Chair recognizes Senator Rock first.

17. SENATOR ROCK:

18. Thank you, Mr. President. If...if...if 1105 is to be
19. moved, it should be moved with the understanding that there
20. is an amendment pending. As...our file indicates that there
21. was an agreed...an amendment agreed to in...in the committee.

22. PRESIDING OFFICER: (SENATOR JOHNS)

23. The Chair assumes, Senator Rock, that Senator Soper probably
24. dropped his amendment, but I'll accept your explanation and
25. we'll work on that basis. Senator Collins is recognized.

26. SENATOR COLLINS:

27. I was going to respond to Senator Rock. Although the
28. committee did accept the bill with the amendment, but he did
29. indicate that he would draft the amendment and with my...my
30. approval, they would put the amendment on, and we talked about it.
31. He said he would drop the amendment prior to...

32. PRESIDING OFFICER: (SENATOR JOHNS)

33. Senator Rock, did you hear that explanation. You see why

1. I assumed what I did. No action by his part, I dropped the
2. amendment. Now, we go back to Senator Nimrod on House Bill
3. 1108. He wishes the bill read. Mr. Secretary, please do so.

5. House Bill...House Bill 1108

6. (Secretary reads title of bill)

7. 2nd reading of the bill. No committee amendments.

8. PRESIDING OFFICER: (SENATOR JOHNS)

15. Mr. Secretary. Pardon me, Mr. Secretary. Pardon me,
16. everybody...just a moment. Recognize Senator Smith.

17. SENATOR SMITH:

18. In committee, Senator Hall promised very definitely that
19. he would present an amendment to this bill. We are opposed
20. to the advancing of this bill without compliance with the
21. agreement.

22. PRESIDING OFFICER: (SENATOR JOHNS)

23. May I tell, Senator Smith, that we have indications
24. that there will be an amendment placed on the bill, Sir. We
25. are in the process of...Mr...no committee amendment...

26. SENATOR SMITH:

27. No, no...

28. PRESIDING OFFICER: (SENATOR JOHNS)

29. But there's an indication...

30. SENATOR SMITH:

31. ...no, no. He himself. I objected to the bill as did
32. the committee, and the good Senator promised specifically that
33. he would offer an amendment on 2nd reading taking the City of

1. Chicago out.

2. PRESIDING OFFICER: (SENATOR JOHNS)

3. I see a notation here...

4. SENATOR SMITH:

5. Omitting...

6. PRESIDING OFFICER: (SENATOR JOHNS)

7. ...on my Calendar, Mr...Senator Smith, that there will be

8. an amendment offered from the Floor. That's what I wanted to

9. tell you.

10. SENATOR SMITH:

11. I don't know where that information came from...

12. PRESIDING OFFICER: (SENATOR JOHNS)

13. Let's take that one from the record, and you two kind

14. Senators work it out. Okay. House Bill 1183, Senator Vadalabene.

15. Read the bill, Mr. Secretary.

16. SECRETARY:

17. House Bill 1183

18. (Secretary reads title of bill)

19. 2nd reading of the bill. No committee amendments.

20. PRESIDING OFFICER: (SENATOR JOHNS)

12. Any amendments from the Floor? 3rd reading. House Bill
13. 1229, Senator Rhoads. Is he on the Floor? Right here. Move
14. it, Mr. Secretary.
15. SECRETARY:
16. House Bill 1229
17. (Secretary reads title of bill)
18. 2nd reading of the bill. No committee amendments.
19. PRESIDING OFFICER: (SENATOR JOHNS)
20. Any amendments from the Floor? 3rd reading. House Bill
21. 1240, Senator Rock. I was trying to make out some notations
22. here on that one, Senator. Okay. 1275, Senator Guidice.
23. Read the bill, Mr. Secretary.

27. 2nd reading of the bill. No committee amendments.
28. PRESIDING OFFICER: (SENATOR JOHNS)

30. Bill 1277, Senator. She wishes the bill, Mr. Secretary.

33. (Secretary reads title of bill)

1. 2nd reading of the bill. The Committee on Higher Education
2. offers one amendment.
3. PRESIDING OFFICER: (SENATOR JOHNS)
4. Senator Hickey, would you explain the amendment please.
5. SENATOR HICKEY:
6. This amendment...well, the bill in the first place extends
7. this matching grants to two year colleges and private universities,
8. and then there will be matching funds from the State for these
9. and the amendment simply says that the total grants provided
10. to private institutions shall not exceed one-fifth of the
11. amount appropriated for this purpose...
12. PRESIDING OFFICER: (SENATOR JOHNS)
13. Senator Hickey, the Chair wishes...
14. SENATOR HICKEY:
15. ...what...
16. PRESIDING OFFICER: (SENATOR JOHNS)
17. ...to tell you that the Secretary has some...
18. SENATOR HICKEY:
19. ...I'm sorry...
20. PRESIDING OFFICER: (SENATOR JOHNS)
21. ...conflict here.
22. SECRETARY:
23. The committee amendment, Senator Hickey, is merely the
24. effective date of it. This is...
25. SENATOR HICKEY:
26. Oh, okay...
27. SECRETARY:
28. ...the committee amendment.
29. SENATOR HICKEY:
30. ...I'm sorry. I'm talking about Amendment No. 2.
31. PRESIDING OFFICER: (SENATOR JOHNS)
32. Amendment No. 2...
33. SENATOR HICKEY:

1. All right, then let's adopt 1 first.
2. PRESIDING OFFICER: (SENATOR JOHNS)
3. All right. Now, you want to explain Amendment No. 1.
4. You moved for the adoption of Amendment No. 1 of which is the
5. effective date. All those in favor say Aye. All those opposed
6. say Nay. The amendment is adopted. Now, we go to Amendment
7. No. 2. Senator Hickey.

9. And Amendment No. 2 simply...since the private colleges
10. are now in this, Amendment No. 2 makes a proportion that can
11. go to private colleges exactly the same as the proportion
12. of the FTE students in private universities compared to those

4. Terry McKim of Mendota, and to just say a few brief words, Brad
5. Whitehead, the newly elected Governor of 1977 Premier Boys
6. State, Brad Whitehead of Monticello, Senator Harber Hall's
7. district.

8. BRAD WHITEHEAD:

9. (remarks by Brad Whitehead)

10. SENATOR MITCHLER:

11. Thank you. And Mr. President, there is a resolution on
12. the Secretary's Desk commending and congratulating the
13. American Legion and these fine young men for their achievement
14. in attaining their offices, and I, at this time, would ask for
15. suspension of the rules and immediate consideration and
16. adoption of this resolution number...resolution...Senate
17. Resolution No. 186.

18. PRESIDING OFFICER: (SENATOR JOHNS)

19. You heard the motion by Senator Mitchler for the suspension
20. of the rules and immediate adoption...suspension of the rules.
21. All those in favor say Aye. All those opposed say Nay. Now,
22. Senator Mitchler moves the adoption of the Senate Resolution
23. ...186. All those in favor say Aye. All those opposed say
24. Nay. ...The resolution is adopted. The Chair wishes to recognize
25. two on the board, Senator D'Arco, then Vadalabene, then Lane.
26. Senator D'Arco.

27. SENATOR D'ARCO:

28. Mr. President, I would like to make a motion at this
29. time to suspend the rules and place House Bill 2219 on the
30. Order of 2nd reading without reference to committee. I discuss-
31. ed this bill with the Minority spokesman in Pensions and with
32. the chairman of the committee and with the Chairman of the

9. Yes, thank you, Mr. President and members of the Senate.

13. PRESIDING OFFICER: (SENATOR JOHNS)

14. The Chair is going to have to recognize the President,
15. Senator Tom Hynes, concerning matters like this.

16. SENATOR HYNES:

17. Mr. President, Senator Vadalabene, we were going to move
18. off the Order of 2nd reading because it...it is past the hour

22. PRESIDING OFFICER: (SENATOR JOHNS)

23. Senator Lane, does that take care of your problem, also?

26. PRESIDING OFFICER: (SENATOR JOHNS)

27. Well, I can understand why. Now, Senator Hynes, would you
28. be kind enough again...

29. SENATOR HYNES:

30. I was simply saying...suggesting that we leave the Order
31. of 2nd reading and clean up any remaining business we have so
32. that the members can get to committees which were scheduled to
33. start about three or four minutes ago...

1. PRESIDING OFFICER: (SENATOR JOHNS)

2. Senator Lane...

3. SENATOR HYNES:

4. ..and then we hold these 2nd reading...any amendments on
5. 2nd reading until Monday. We can finish up the rest of the list.

6. PRESIDING OFFICER: (SENATOR JOHNS)

7. Senator Lane still wishes to be recognized.

8. SENATOR LANE:

9. Thank you, Mr. President. I'd like to make a motion to
10. discharge the Committee on Transportation with House Bill 1835
11. and have it re-referred to Labor and Commerce this afternoon,
12. to waive the Six Day Notice.

13. PRESIDING OFFICER: (SENATOR JOHNS)

14. You've heard the motion to discharge. All those in favor

16. Senator Netsch.

17. SENATOR NETSCH:

18. Thank you, Mr. President. I wonder if I might seek leave
