- 23. Judicial System in the amount of fifty-four million dollars.

- 25. a favorable roll call.

- 10. Well, thank you, Mr. President. I gathered the same
- 11. information from one other bill that I voted no on, that
- 12. was 2843. Seems to me that in light of what appears to
- 13. be straightened financial circumstances for the State
- 14. of Illinois and a growing animosity on the part of the
- 15. electorate over the increasing cost of government at all
- 16. levels to arbitrarily in...grant salary increases every
- 17. year, is indefensible. We are not only precluding
- 18. any attempt at controlling government spending, but we
- 19. are really contributing to the inflationary spiral.
- 20. Ladies and Gentlemen of the Senate, if we did not get
- 21. any message whatsoever from the California referendum,
- 22. we ought to recognize that even in Illinois our fellow
- 23. citizens are tired of the ever escalating government
- 24. spending. We defend our position in additional appropria-
- 25. tions by the recognition that our instate income escalates
- 26. by about a half a billion dollars a year. But did it
- 27. ever occur to us to attempt to conserve that or even half
- 28. of it, rather than continually to appropriate every
- 29. available dime. Mr. President, I want the record to show
- 30. that I am voting Nay in protest on the appropriations which
- 31. contained the 5.5 salary increase.

- 11. This is not the East St. Louis Airport Authority.
- 12. This is a Columbia-Waterloo. This is Governor Thompson's
- 13. bill. This is Governor Thompson's yellow folder and I
- 14. would appreciate a...a favorable vote.

- 16. Senator Regner.
- 17. SENATOR REGNER:
- I would just like to thank Senator Vadalabene for
- taking that yellow folder, because we couldn't sell it
- on this side for a sponsor.

- 30. These are just the...annual appropriation bill for
- 31. the Human Relations Commission and the chickee-back 2979.
- 32. And add on FEPC. Ask for a favorable roll call.

- Thank you, Mr. President. I wonder if the sponsor

- 2. What was the five hundred thousand in the Arts Council
- 3. designated for which was eliminated?

- 7. Yes, Senator Hickey, there was some seven hundred
- g, thousand that was asked for, an increase in grants, and
- that amount was reduced down to three hundred thousand.
- 10. And also the ethnic appropriation of two hundred thousand
- 11. was reduced by eighteen thousand, five hundred.

- 14. SENATOR HICKEY:
- 15. Is it more than...is the total more than last year?
- 16. Thank you.
- 17. PRESIDENT:
- 18. Senator Mitchler.
- 19. SENATOR MITCHLER:
- Oh, Mr. President and members of the Senate. I'd
- 21. point out again, if...if the time comes when we decide
- 22. we are going to start being conservative and reducing
- 23. the cost of State government, this is one area that
- 24. I think we can start in. It's about a two...about a
- 25. three million dollar appropriation and I notice that
- 26. You have in there for about...almost a million dollars
- 27. in to the Illinois Arts Council Trust Fund and that's
- 28. a program to enhance the culutural environment in
- 29. Illinois. We've got many universities, we've got local
- areas, a lot of this can be done by grants from local
- 31. volunteer organizations. But this started out a few
- years ago with a twenty-five thousand or fifty-thousand
- dollar appropriation. It's now up to about three million 33.

- 1. and it's a haven for all of these people that like to gather
- 2. and get in their tuxedos and meet and display their arts
- 3. and this would be one of the areas that we could cut down.
- A It can be done in the private sector by people that are
- 5. interested and got the money and want...want to promote
- 6. these arts and that...not have the State of Illinois get
- 7 involved in it.

- for the Dangerous Drug Commission and also the Liquor 25.
- Control Commission. The Liquor Control Commission 26.
- appropriation is five hundred and thirty-six thousand
- and the Dangerous Drug with the two committee amendments 28.
- and the Floor amendment would be 11.7 million. They're 29.
- both dangerous drugs, yes, Senator Weaver. Any questions?

- 3. in committee and that is to put the Liquor Control Commission
- 4. into the Department of Law Enforcement. They rely on the
- 5. Department of Law Enforcement a great deal to carry out
- 6. their duties and the feeling of the committee was that
- 7. they should be included in Law Enforcement, however, it
- 8. would take statutory language to do that and Senator
- 9. Carroll and myself intend next year to introduce legisla-
- 10. tion to Statutorily put the Liquor Commission in the
- 11. Department of Law Enforcement, but it has to be separate
- 12. this year yet because of the language in the Statutes.
- 13. PRESIDENT:
- 14. Senator Schaffer.
- 15. SENATOR SCHAFFER:
- 16. Mr. President, the...I'm going to oppose this particular
- 17. appropriation because of the Dangerous Drugs Commissions
- 18. absolute unwillingness to do anything in the suburban area.
- 19. They seem to totally ignore the drug problems in a large part
- 20. of this State and until they recognize that there are drug
- 21. problems everywhere, I don't feel inclined to recognize
- 22. their appropriation.
- 23. PRESIDENT:
- 24. Is there any further discussion? If not, the question
- 25. is shall House Bill 3077 pass. Those in favor will vote
- 26. Aye. Those opposed will vote Nay. The voting is open.

- 15. expenses of the State Comptroller in Fiscal '79 and I ask
- 16. for its adoption.

- 18. Is there any discussion? If not...Senator Berning.

- Just want to make the same inquiry. Does this have
- 21. the 5.5 salary increase?

- 14. for a favorable roll call.

- 16. Is there any discussion? If not, the question is shall
- 17. House Bill 3368 pass. Those in favor will vote Aye. Those
- 18. opposed will vote Nay. The voting is open. Have all voted

- (Secretary reads title of bill)
- 3. 3rd reading of the bill.
- 4. PRESIDENT:
- 5. Senator Guidice.
- 6. SENATOR GUIDICE:
- 7. Thank you, Mr. President and members of the Senate.
- g. The House Bill 384 does exactly what the Calendar showed that
- 9. provides that resolutions, motions...ordinances returned
- 10. to City Council by the Mayor must be considered at the
- 11. next regular meeting of the council. There's also an
- 12. amendment and I would yield to Senator Berning to explain
- 13. that part of the amendment which is the other part of the
- 14. bill.
- 15. PRESIDENT:
- 16. Senator Berning.
- 17. SENATOR BERNING:
- 18. Thank you, Mr. President. The bill as amended...
- 19. the bill as amended accommodates one little village in
- 20. Lake County which by referendum sometime back established
- 21. a two year term for its board members. The very next
- 22. year by referendum they sought to change that and elect
- 23. their members for the usual four year terms, however,
- 24. they have not been able to do so because of the existing
- 25. Statute, which restricts them and consequently at this
- 26. time they are electing one trustee, one year, and five
- 27. at the following election. And all this amendment does
- 28. is allow them to phase in the election of three trustees
- 29. at every other election.

- 31. Senator Kenneth Hall.
- 32. SENATOR KENNETH HALL:
- Would the sponsor yield for a question?

- 26. Senator Glass.
- 27. SENATOR GLASS:
- Well I...I question the wisdom of that. There may be
- 29. several people on the bus drinking, at least they ought to
- be responsible for their own acts. And...and I gather from 30.
- what you said, they wouldn't be. So I would therefore urge 31.

- House Bill 2684.
- 3. (Secretary reads title of bill)
- 4. 2nd reading of the bill. The Committee on Elementary and
- 5. Secondary Education offers one amendment.
- 6. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 7. Senator Collins.
- 8 SENATOR COLLINS:
- 9. Mr. President, I will yield to Senator Clewis to
- 10. explain that amendment. He...amendment.
- 11. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 12. Senator Clewis. Senator Clewis.
- 13. SENATOR CLEWIS:
- Mr. President and members of the Senate. This
- 15. amendment clears up a problem with the...in the Chicago
- 16. Board of Education in terms of the proceeds from the
- 17. sale or the profit...profits that come in for any school
- 18. owned land. Up until last Session these proceeds had
- 19. to go into a special land trust. There was a bill passed
- and inadvertently the language of the bill said...on the
- effective date of this bill that the proceeds that were

- 1. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 2. Are there amendments from the Floor?
- 3. SECRETARY: ·
- 4. Amendment No. 2 offered by Senator Philip.
- 5. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 6. Senator Philip.
- 7. SENATOR PHILIP:
- 8. Thank you, Mr. President and Ladies and Gentlemen of
- 9. the Senate. Senate Amendment No. 2 to House Bill 2684
- 10. amends the life safety section of the School Code. Provides
- 11. that when a levy for the purpose may only be made when all
- 12. alterations have been approved by the regional superintendent
- 13. and the State superintendent. As you're probably aware, after
- 14. Our Lady of the Angel fire in Chicago that we in the General
- 15. Assembly passed a tax that would allow a one half of one
- 16. percent for safety and fire, which I think was a good idea.
- 17. Unfortunately some of the schools had been misusing this
- 18. half of one percent fund. And I'll give you some examples:
- 19. Evanston Township High School, two hundred and twenty-five
- 20. thousand dollars to replace cinder running tax, nineteen
- thousand dollars to resurface six tennis courts; Kirsh
- 22. High School, Harvey, six thousand to enlarge the school
- 23. kitchen; Thornton High School, a hundred and ten thousand,
- 24. three hundred dollars to install a new floor in the field
- 25. house; ... Evergreen Park High School, fifty thousand for
- 26. dimmer equipment in the auditorium; I could go on and on
- 27. and on. All this merely does is tighten it up and it
- 28. makes it a little more difficult for them to receive the
- 29. funds.
- 30. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 31. Is there discussion? Senator Berman.
- 32. SENATOR BERMAN:
- Thank you, Mr. President. I rise in opposition to the

- 1. amendment. I think that the amendment is in response to
- 2. a Chicago Tribune article that was published and in a
- 3. typical attempt to highlight some unusual situations that
- 4. pinpointed some of the abuses that may have, in fact, occurred
- 5. in the use of these funds. But I think that what we are doing
- 6. here is throwing the baby out with the bath water in response
- 7. to the Tribune article. First of all, I would point out that
- 8. the present law allows the use of these funds for three purposes.
- 9. One, the safety of school children from fire, number two, for
- 10. the protection and safety of the environment and three for
- 11. energy conservation purposes. Those are in the existing...
- 12. language of the Statute. The tightening up language only
- 13. refers to the protection from fire and for the Environmental
- 14. Protection Act. It leaves out the wording for energy
- 15. conservation purposes and I think that it is technically
- 16. defective. But beyond that, I understand what Representative
- 17. ...what Senator Philip is trying to do and I think that perhaps
- 18. we ought to take a close look at some of the areas that some
- 19. of this money has been spent. Regrettably, I think, that we
- 20. don't have the time or is this the method in which to address
- 21. those things. I would suggest rather that Senator Philip
- 22. allow the...perhaps the, a subcommittee of the Senate Elementary
- 23. and Secondary Education Committee to take a look because I
- 24. think in some ways the language in the existing Statute should
- 25. be loosened up and in other ways it ought to be tightened up.
- 26. Because there are Life Safety Code expenditures that have
- 27. been made that are for Life and Safety Code requirements that
- 28. probably don't fall within the strict language of this Statute.
- 29. There are many safety requirements that are beyond just the
- 30. safety of children from fire. There can be many other areas
- 31. that proper use of Life Safety Code money ought to be spent
- 32. and neither the existing Statute nor Senator Philip's amend-
- 33. ment addresses that and I think also we ought to call on the

- 1. carpet some of the superintendents that perhaps have gone
- 2. far beyond what the proper use of this money is. But I
- 3. think that we ought to be given a more timely and a greater
- 4. ability to take a look and see just what should be done
- 5. again in line with the intent of this section and that is
- 6. the safety of children. So I would urge a defeat of this
- 7. amendment, but not a defeat in order to brush it under
- 8. the rug, but rather a defeat to take a proper look at
- q this area of concern.
- 10. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 11. Senator Buzbee.
- 12. SENATOR BUZBEE:
- 13. Thank you, Mr. President. I agree with Senator Berman.
- 14. This is...a...a problem that perhaps should be addressed
- 15. at some point in the future, however I think that we're
- 16. being very hasty about...because this is in...in...
- 17. reaction, a reaction to one story that appeared in the
- 18. Chicago Tribune about some school boards...a very limited
- 19. number of school boards that have practiced some abuse
- 20. of this. Those school boards are going to have to
- 21. answer to their voters for that abuse and I would submit
- 22. that we ought to address this question at some point later
- 23. on in the future and defeat this amendment at this time.
- 24. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 25. Senator Hynes.
- 26. SENATOR HYNES:
- 27. Mr. President and members of the Senate. It was our
- 28. thought that today because of the...the nature of the, not
- 29. only the...the day, but the Session itself and we do have
- a few members absent that it would be limited to those
- 31. matters that were relatively noncontroversial and that
- 32. goes for 2nd reading, we've been discussing concurrences.
- 33. I would ask the sponsor of the amendment, take it out of

- 1. the record and that the sponsor of the bill hold the bill
- 2. on 2nd reading and we can...we can go to it tomorrow when
- 3. we have a full complement here. And I...and I would ask
- 4. any other sponsors of bills or amendments that are going
- 5. to generate a...a great deal of controversy to hold those
- 6. until tomorrow. But I do caution the membership that
- 7. tomorrow will be the last day for 2nd reading of Senate
- 8. ... of House Bills rather and therefore they will have to
- 9. be moved tomorrow and we will be in Session all day
- 10. tomorrow, as late as it takes to...to get the work done.
- 11. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 12. Take the bill out of the record. Senator Hickey.
- 13. SENATOR HICKEY:
- Mr. President, I'd like to ask the sponsor to...to
- 15. put the amendment on our desks before tomorrow.
- 16. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 17. What...just a moment. The bill is...is...is remaining
- 18. on the Order of 2nd reading with one amendment adopted and
- 19. that is the posture of the bill and it is, it's not being
- 20. considered anymore, but Senator Philip, do we still want
- 21. to talk about it.
- 22. SENATOR PHILIP:
- 23. No...no, Mr. President, but I just might remind Senator
- 24. Hickey that when Senator Collins said she was going to call
- 25. the bill maybe a week ago, I did pass out an amendment to
- 26. every member of this Senate. So the amendment has been
- 27. passed on. I'm sorry if...if it's still not... I'll be

- No...no, that's...we'll have to leave it on the Order

- 5. Hickey. Read the bill, Mr. Secretary.
- 6. SECRETARY:
- 7. House Bill 2818.
- 8. (Secretary reads title of bill)
- 9. 2nd reading of the bill. No committee amendments.
- 10. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 11. Senator Hickey.
- 12 SENATOR HICKEY:
- 13. There is a Floor amendment which you have there.
- 14. Oh, okay.
- 15. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 16 Are there amendments from the Floor?
- 17. SECRETARY:
- Amendment No. 1 offered by Senator Hickey.
- 19. SENATOR HICKEY:
- 20. Thank you. This bill simply deletes references to
- 21. full fare cash value and inserts in lieu thereof equalized
- 22. assessed value in the Public Community College Act and

- 5. 1475, Senator Sangmeister. Senate Bill 1523, Senator Regner.
- 6. Senate... Senator Shapiro, you wish to proceed with this?
- 7. Senate Bill 1527. Senate...Senator Shapiro.
- 8. SENATOR SHAPIRO:
- 9. Mr. President and Ladies and Gentlemen of the Senate.
- 10. Senate Bill 1527 is the annual appropriation for the Board
- 11. of Regents and when it left the Senate and arrived in the House
- 12. it had a typing error in one of the line items on page 1,
- 13. line 25 and had happened, the typist had transposed two digits
- 14. in the one of the line item appropriations and what the House
- 15. amendment does is changes nine hundred and thirty-four thousand
- 16. nine hundred dollars to nine hundred and forty-three thousand
- 17. nine hundred dollars so I would now move that the Senate concur
- 18. to House Amendment No. 1 to Senate Bill 1527.
- 19. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 20. Is there discussion? The question is, shall the Senate
- 21. concur in House Amendment No. 1 to Senate Bill 1527. Those in
- 22. favor vote Aye. Those opposed Nay. The voting is open. Have
- 23. all those voted who wish? Have all those voted who wish? Take
- 24. the record. On that question, the Ayes are 51, the Nays are

- 26. Senate Bill 1527 and the bill having received the required

- 29. SENATOR BRUCE:
- Thank you...Mr. President and members of the Senate. The
- 31. amendment added by the House and which I think we...with which
- 32. we ought to concur adds back in the IBA rental. Senator Weaver
- 33. put an amendment on in the Senate to remove the retirement portion

- 1. of the Community College Appropriation. There was a typing error
- 2. and we removed Section VII rather than Section VI and when we
- 3. renumbered the sections of the bill we had removed the twelve
- 4. million six hundred thousand dollars to pay IBA rentals rather
- 5. than the section that we wanted to remove on the retirement.
- 6. The House corrected the error as removed the retirement money
- 7. that is now in another bill. This reinstitutes the twelve

- 24. SENATOR KENNETH HALL:
- 25. Thank you, Mr. President and Ladies and Gentlemen of the
- 26. Senate. I move to concur with Amendment 1 to Senate Bill 1534.

- Yes thank you, Mr. President. This is the Gas Curtailment
- 23. bill that came over with the House Amendment No. 2. I've
- 24. discussed this with the Chairman of the Agriculture and Energy
- 25. Resources Committee and the majority leader and I would move
- 26. that we nonconcur with Representative Levine's amendment.
- 27. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 28. Is there discussion? Senator Bloom moves to nonconcur
- 29. in House Amendment No. 2 to Senate Bill 15...Just a moment.
- 30. Senator Grotberg, did you wish to discuss this issue? Senator Grotberg.
- 31. SENATOR GROTBERG:
- 32. I appreciate the noncurrence but is it fair to ask you what
- 33. that amendment did to this concept, Senator Bloom?

- Senator Bloom.
- 3. SENATOR BLOOM:
- 4. Yes, I'm sorry, Senator Grotberg, the bill as it went out
- 5. spoke to...giving preference to essential human services. The
- 6. bill as it came out came back refers with more specificity
- 7. and omits schools or attendance centers which certainly would
- 8. provide essential human services.
- 9. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 10. Is there further discussion? Senator Bloom moves to
- 11. nonconcur in House Amendment No. 2 to Senate Bill 1546. All
- 12. those in favor indicate by saying Aye. Those opposed. The
- 13. Ayes have it. The motion carries and the Secretary shall so
- 14. inform the House. Senate Bill 1555, Senator Lane. Senate
- 15. Bill 1598, Senator Bloom. You may proceed.
- 16. SENATOR BLOOM:
- 17. Thank you, Mr. President. This is the appropriation for
- 18. the...ordinary and contingent expenses, the Office of the
- 19. Commissioner of Savings and Loans. Senate...or House Amendment
- 20. No. 1 as it came back deleted providing them funds for moving
- 21. expenses. As we learned in Appropriations Committee, Director
- 22. Puckorious is evicting them. I've discussed this with both
- 23. minority and majority appropriations staff and the Chairman
- 24. of Appropriation I and I'd move that we nonconcur so that we
- 25. could get them back their moving expenses. Thank you.
- 26. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 27. Is there discussion? Senator Bloom moves to nonconcur in
- 28. House Amendment No. 1 to Senate Bill 1598. Those in favor
- 29. indicate by saying Aye. Those opposed. The Ayes have it. The
- 30. motion carries and the Secretary shall so inform the House.
- 31. Senate Bill 1667, Senator Glass. You may proceed.
- 32. SENATOR GLASS:
- 33. Thank you, Mr. President and Ladies and Gentlemen. I move

- 1. to concur with House Amendment 1 and 3 to Senate Bill 1667.
- 2. This is...these are amendments both of which are virtually
- 3. identical to bills passed in the Senate but, apparently,
- 4. did not get out of the House Rules Committee. The first one
- 5. was put on by Representative Houlihan increasing from sixty
- 6. to eighty acres the size of property that can be in...annexed
- 7. by a park district when it is wholly bounded one or more park
- 8. districts, river, lake, railroad, et cetera. Amendment 3 was
- 9. put on by Representative Schneider and is the DuPage County
- 10. amendment that you recall that Senator Bowers sponsored the
- 11. bill over here. This is where a provision that a park district
- 12. located in a county of over four hundred and fifty thousand
- 13. population but less than a million population shall have
- 14. comdemnation and eminent domain powers as to all real estate
- 15. situated up to a mile outside the district and I...I move for
- 16. concurrence with these amendments.
- 17. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 18. Senator Rock.
- 19. SENATOR ROCK:
- 20. Yeah, just a question to the sponsor. As I read the
- 21. digest today I think the Calendar might be in error. It
- 22. appears that it's Amendment No. 2. Is that the way the
- 23. message reads?
- 24. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 25. Mr. Secretary.
- 26. SECRETARY:
- 27. According to the...to the record it is Amendment No. 1
- 28. and 3.
- 29. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 30. Senator Rock.
- 31. SENATOR ROCK:
- 32. I wonder then if we might take it out of the record. The
- 33. ...the digest says Amendment No. 2 and that's the one about

- 1. which Senator Glass just explained and further Senator Wooten
- 2. yesterday amended a bill...I'm trying to remember the number...
- 3. 1651 having to do with this same section and it concerned
- 4. itself with the Rock Island Park District to...they were
- 5. attempting to accommodate and I...this amendment would appear
- 6. to disaccommodate them. Maybe we can...if you just hold it...
- 7. maybe...I'm sure we can work it out.
- 8. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 9. Take it out of the record. Senate Bill 1723, Senator
- 10. McMillan. You may proceed.
- 11. SENATOR McMILLAN:
- 12. The amendment that was added in the House clears up some
- 13. language with regard to types of windstorms and makes it very
- 14. clear in this bill which deals with the regulation of ware-
- 15. houses, precisely, what kind of insurance a warehouse operator
- 16. has to have and I would move to concur with the House amendment.
- 17. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 18. Is there discussion? The question is, shall the Senate
- 19. concur in House Amendment No. 1 to Senate Bill 1723. Those in
- 20. favor vote Aye. Those opposed Nay. The voting is open. Have
- 21. all those voted who wish? Take the record. On that question,

- 8. SENATOR BERMAN:
- g. Mr. President, this is...shown on the concurrence but it
- 10. really should be on the noncurrence motions. Do you want to
- 11. proceed now or my motion is to nonconcur.
- 12. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 13. Well we...we've proceeded then this same basis
- 14. earlier in several noncurrences. Proceed. Is there discussion?
- 15. Senator...Senator Berman moves to nonconcur in House Amendment
- 16. No. 1 to Senate Bill 1790. Those in favor say Aye. Those opposed.
- 17. The Ayes have it and the motion carries and the Secretary shall
- 18. so inform the House. Senate Bill 1792, Senator Guidice. Proceed.
- 19. SENATOR GUIDICE:
- 20. Thank you, Mr. President. I move to nonconcur in House
- 21. Amendments 1 and 4 and that a Conference Committee be appointed.
- 22. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 23. Is there discussion? Senator Guidice moves to nonconcur
- 24. in Senate...House Amendment...Senator Rhoads.

- 31. The...the amendment gutted the original bill inadvertently
- 32. by the House. Is that good enough, Senator? Would you...
- PRESIDING OFFICER: (SENATOR DONNEWALD)

- 1. All right. The Senator...Senator Guidice moves to nonconcur
- 2. in House Amendments 1 and 4 to Senate Bill 1792. Those in favor
- 3. say Aye. Those opposed Nay. The Ayes have it. The motion
- 4. carries and the Secretary shall so inform the House. Senate
- 5. Bill 1798, Senator Carroll. Proceed.
- 6. SENATOR CARROLL:
- 7. Thank you, Mr. President. I would move that we nonconcur

- 18. Mr. President I am directed to inform the Senate
- 19. that the House of Representatives has refused to concur with
- 20. the Senate in the adoption of their amendment to a bill with
- 21. the following title: House Bill 2808 with Senate Amendment
- 22. No. 1.
- 23. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 24. On the Order of the Secretary's Desk on nonconcurrence
- 25. on page 13, House Bill 2648, Senator Demuzio.
- 26. SENATOR DEMUZIO:
- 27. Thank you, Mr. President. I move to recede from Senate
- 28. Amendment No. 1. Senator Moore put Senate Amendment No. 1 on
- 29. this bill which would have provided that the money that...was
- 30. to be obtained from the sale of the President's house at the
- 31. Illinois School for the Deaf be earmarked and allocated for
- 32. a television decoder for captioning TV stations at the school
- 33. for the deaf. Senator Moore has agreed to...to take that

- 1. amendment...recede from that amendment and he has found some
- other vehicle for his proposed amendment.
- 3. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 4. Is there...is there further...Senator Mitchler.
- 5. SENATOR MITCHLER:
- 6. Mr. President, just a question. I want to support you,
- 7. Senator...What is a television decoder that the deaf use? Just
- 8. for my information.
- 9. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 10. Senator Demuzio.
- 11. SENATOR DEMUZIO:
- 12. I would be delighted to yield to Senator Moore, the expert
- 13. in the area of television programs.
- 14. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 15. Senator Moore.
- 16. SENATOR MOORE:
- 17. In conjunction with a television broadcast someone is there
- 18. that on the screen it decodes what they can't hear so that they
- 19. can understand and read what is on the television screen.
- 20. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 21. If you don't understand that go back in the telephone booth.
- 22. Senator...Senator Mitchler.
- 23. SENATOR MITCHLER:
- 24. It's like when I go to these Spanish and Chinese movies
- 25. and they got the English printed underneath...
- 26. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 27. That's right. The question is, shall the Senate recede
- 28. from Amendment No. 1 to House Bill 2648. Those in favor vote
- 29. Aye. Those opposed Nay. The voting is open. (Machine cutoff)
- 30. voted who wish? Have all those voted who wish? Take the
- 31. record. On that question, the Ayes are 50, the Nays are None.
- 32. The Senate recedes from Amendment No. 1 to House Bill 2648 and
- the bill having received the required constitutional majority

- 1. is declared passed. House Bill 3351, Senator Kenneth Hall.
- Proceed.
- 3. SENATOR KENNETH HALL:
- 4. Thank you, Mr. President and Ladies and Gentlemen of the
- 5. Senate. Mr. President, I refused to recede and I would like
- 6. a Conference Committee to be appointed on House Bill... I mean
- 7. on House Bill 3351.
- 8. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 9. Is there further discussion? Senator Glass.
- 10. SENATOR GLASS:
- 11. Would...would you explain, Senator, what the amendment
- 12. is which you are moving not to recede from?
- 13. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 14. Senator Rock.
- 15. SENATOR ROCK:
- 16. Yes, I understand...I've been informed, reliably, by the
- 17. administration with whom I'm doing a lot of business allegedly
- 18. these days. This was a conveyance of some property in Ogle...
- 19. Ogle County and there was a technical error and so Senator
- 20. Roe has requested a Conference Committee to work out the
- 21 technical error.
- 22. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 23. Is there further discussion? Senator Hall moves that the
- 24. Senate refuse to recede from the adoption of Amendment No...
- 25. Amendment No. 1 to House Bill 3351 and that a Conference Committee
- 26. be appointed. Those in favor indicate by saying Aye. Those
- 27. opposed Nay. The Ayes have it. The Secretary shall so inform
- 28. the House. Further business to come before the Senate? The
- 29. Senate shall adjourn to ten o'clock tomorrow morning, June the
- 30. ^{26th}.
