- 10. Mr. President I am directed to inform the Senate
- 11. the House of Representatives has passed a bill with the
- 12 following title, in the passage of which I am instructed
- 13. to ask the concurrence of the Senate to-wit:
- 14. House Bill 3403.
- 15. PRESIDING OFFICER: (SENATOR JOHNS)
- 16. Okay, now for your information, please. All Senators
- 17. please pay particular attention. You have a handout on
- 18. your desk, a...synopsis of legislation, bills on concurrence.
- 19. The first one, Senate Bill 0082, June the 23rd, 1978. That
- 20. identifies it. The other one that you have with the orange
- 21. covering is obsolete, I repeat, obsolete. I just had the
- 22. question asked, they are being passed out and you'll have
- 23. them on your desk practically right now, Senator Coffey.
- 24. The one with the yellow...or orange covering is obsolete.
- 25. You have a new one with a white front sheet. It's being
- 26. passed out by the Pages at this time.
- 27. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 28. For what purpose does Senator Don Moore arise?
- 29. SENATOR MOORE:
- On a point of personal privilege, Mr. President.
- 31. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 32. State your point.
- 33. SENATOR MOORE:

- 1. Thank you, Mr. President and members of the Senate. I
- believe that all the members are aware that the State of
- 3. Illinois about two and a half or three years ago, established
- 4. an office in San Paulo, Brazil. I'm happy to have as our
- 5. guest here today, the man who assumed that position about
- 6. two and a half years ago, as the managing director of our
- 7. San Palo office, Mr. Henry Smallwood standing behind me.
- 8. Henry, would you stand and be recognized by the Senate.
- 9. PRESIDING OFFICER: (SENATOR JOHNS)
- 10. Mr. Smallwood, glad to have you with us, sir. Thank
- 11. you, Senator. Senator Don Moore again.
- 12. SENATOR MOORE:
- 13. In addition to Brazil, of course, there is...the office
- 14. for the edification of the membership consists of a staff
- 15. of three, Mr. Smallwood and two secretaries. He covers
- 16. twenty-two... Central and South American Countries and I'm
- 17. happy to announce that after two and a half years of
- 18. operation, for the last year, we have broken even and
- 19. showed a little profit down there in our San Palo office.
- 20. So it has been a success. Thank you, Mr. President.
- 21. PRESIDING OFFICER: (SENATOR JOHNS)
- 22. Very good, thank you. Senator Graham.
- 23. SENATOR GRAHAM:
- I think it would be the best, if we're going to proceed,
- 25. that the Chair either advise or do not advise the membership
- 26. if we are at ease or not at ease, because some Conference
- 27. Committees are getting ready to meet and I think we ought
- 28. to know where we are.
- 29. PRESIDING OFFICER: (SENATOR JOHNS)
- 30. I think by its natural stance today, we are at ease
- 31. and we will advise you of any impending procedures right
- 32. away. For what purpose does Senator Netsch arise, please?
- 33. Little order, please. Senator Netsch.

- 1. SENATOR NETSCH:
- Thank you Mr...while we're at ease, I wonder if I
- 3. might take care of a piece of housekeeping business which
- 4. I had promised members of the Special Joint Committee on
- 5. the Mental Health Code I would do a long time ago and
- 6. neglected to do. I will...
- 7. PRESIDING OFFICER: (SENATOR JOHNS)
- 8. State your business.
- 9. SENATOR NETSCH:
- 10. ...ask leave to add some people as joint and...and
- 11. cosponsors of those bills and then I'll give you a list
- 12. so that you can get your records straight, if you will.
- 13. On Senate Bill...
- 14. PRESIDING OFFICER: (SENATOR JOHNS)
- 15. Wait just a moment. Is leave granted? Leave is
- 16. granted. Thank you, Senator.
- 17. SENATOR NETSCH:
- 18. ...on Senate Bill 250 we would be adding Senators
- 19. Daley and Schaffer as joint sponsors. Senator Nimrod's
- 20. name is not on that list and so he should be added as
- 21. a cosponsor as should Senator Collins. On Senate Bill
- 22. 252 simply add as...which shows Senators Nimrod and Daley
- 23. as joint sponsors, add the other members of the Joint
- 24. Committee just as cosponsors, that would be myself,
- 25. Senator Schaffer and Senator Collins. On Senate Bill 253
- 26. add Senator Schaffer as a joint sponsor and add Senators
- 27. Netsch and Collins as cosponsors. I'll get this to you
- 28. in writing. And on Senate Bill 255 add Senators Schaffer
- 29. and Collins as cosponsors. May we have leave to make those
- 30. changes?
- 31. PRESIDING OFFICER: (SENATOR JOHNS)
- 32. Is leave granted? Leave is granted. Senator Bruce.
- 33. Senator Bruce. Will you take care of the measure you and

- I just talked about while ago. I cannot do it from here.
- 2. 1357, Senator Bruce.
- 3. SENATOR BRUCE:
- 4. I would ask leave to have Senator Johns added as a
- 5. joint cosponsor to House Bill 1357.
- 6. PRESIDING OFFICER: (SENATOR JOHNS)
- 7. Is there leave? Leave is granted. The Chair recognizes
- 8. Senator Hynes.
- 9. SENATOR HYNES:
- 10. Mr. President, there are a number of bills pending on
- 11. the...the Calendar on the Order of Concurrence or on the
- 12. Order of Nonconcurrence that members have indicated they
- 13. wish to move in order to get Conference Committees in
- 14. operation and I would ask they do that now. I know
- 15. Senator Regner has one. But we'd like to get some of
- 16. this paper work moving and then...and then in a...a brief
- 17. period of time we will recess so that some of these Con-
- 18. ference Committees can get under way.
- 19. PRESIDING OFFICER: (SENATOR JOHNS)
- 20. Senator Hynes.
- 21. SENATOR HYNES:
- 22. Mr. President, with respect to Senate Bill 1555 of
- 23. which I am a joint chief sponsor, I would move that the
- 24. Senate accede to the request of the House that a...a
- 25. Conference Committee be appointed. Senate Bill 1555.
- 26. PRESIDING OFFICER: (SENATOR JOHNS)
- 27. Senate Bill 1555. Senator Hynes moved to concur...
- 28. Senator Hynes. Mr. Secretary, do you wish to give him
- 29. that explanation? Oh, he's made his request, okay.
- 30. He moves to concur in House Bill...
- 31. SENATOR HYNES:
- 32. No...no...no...
- 33. PRESIDING OFFICER: (SENATOR JOHNS)

- No...to accede to the request.
- 2. SENATOR HYNES:
- To accede to the request of the House that a Conference
- 4. Committee be appointed.
- 5. PRESIDING OFFICER: (SENATOR JOHNS)
- 6. To...Senate Bill 15...5...55. All in favor say Aye.
- 7. All those opposed say Nay. The motion is adopted. The...
- 8. Senate...accedes to request to the House Conference Committee.
- 9. Senator Leonard, for what purpose you...arise?
- 10. SENATOR LEONARD:
- 11. I would like leave of this Body to correct a typographical
- 12. error. I had requested permission to be listed as sponsor
- 13. on 3279, House Bill 3279. I find I'm listed as sponsor
- 14. on House Bill 3270 and I'd like leave to change it.
- 15. PRESIDING OFFICER: (SENATOR JOHNS)
- 16. Senator Leonard...
- 17. SENATOR LEONARD:
- 18. Simply...simply asking leave of the Body that I might
- 19. be changed from being listed as sponsor of 3270 to 3279
- 20. which I believe is my original request.
- 21. PRESIDING OFFICER: (SENATOR JOHNS)
- 22. Does he have leave? Leave is granted. Senator Hynes.
- 23. SENATOR HYNES:
- 24. Mr. President, on the Secretary's Desk on the Order of
- 25. Concurrence, Senate Bill 1786 with House Amendment No. 1.
- 26. That amendment is technically incorrect and I would move
- 27. that the Senate nonconcur in the amendment so that we may
- 28. get it into a Conference Committee and rewrite the amend-
- 29. ment.
- 30. PRESIDING OFFICER: (SENATOR JOHNS)
- 31. You've heard the motion. All those in favor say Aye.
- 32. All those opposed say Nay. He will accede to the request...
- 33. we nonconcur...1786, Amendment No. 1. All those in favor

- 1. say Aye. All those opposed say Nay. The motion carries
- 2. and the Secretary shall...so inform the House. Senator
- 3. Hickey.
- 4. SENATOR HICKEY:
- 5. Thank you, Mr. President. I move that we accede to
- 6. the request for a Conference Committee from the House for
- Senate Bill 1562.
- 8. PRESIDING OFFICER: (SENATOR JOHNS)
- 9. The question is shall the Senate accede to the request
- 10. of the House that a Conference Committee be appointed. All
- 11. those in favor say Aye. All those opposed say Nay. The
- 12. motion carries and the Senate accedes to the request to
- 13. appoint a Conference Committee. What bill was that Senator,
- 14. Senator Hickey? Senator Hickey? 1562?
- 15. SENATOR HICKEY:
- 16. 1562. Thank you.
- 17. PRESIDING OFFICER: (SENATOR JOHNS)
- 18. It is not on the Calendar, just read it in. Senator
- 19. Ozinga.
- 20. SENATOR OZINGA:
- 21. Mr. President, on House Bills 2986 we...I believe on
- 22. the Secretary's Desk is a Message from the House wherein the House
- 23. does concur in an amendment, Senate Amendments 2, 3 and 4.
- 24. PRESIDING OFFICER: (SENATOR JOHNS)
- 25. Hold it, Senator. Forgive me, hold it. We have not
- 26. read that into the...
- 27. SENATOR OZINGA:
- 28. Oh, hasn't it been in there?
- 29. PRESIDING OFFICER: (SENATOR JOHNS)
- 30. No. Senator Hynes.
- 31. SENATOR HYNES:
- 32. Mr. President and members of the Senate. I have in my
- 33. possession three boxes of very fine cigars and I'm going

- 1. to ask the Pages to distribute. Senator Daley, who is not
- with us today, asked that they be given to...to the members

- 11. SENATOR GROTBERG:
- 12. A point of personal privilege.
- 13. PRESIDING OFFICER: (SENATOR JOHNS)
- 14. State your point please.
- 15. SENATOR GROTBERG:
- 16. I'm reminded of Senator Daley's baby, I would like to
- 17. announce this morning the...my fifth grandchild was born
- 18. last nite and I have no cigars, but... are you listening,
- 19. Howard Carroll? Would you...Howard Carroll and...and...and
- 20. others, I would like to welcome to the world, Joseph James
- 21. Weinberg, my newest grandson.
- 22. PRESIDING OFFICER: (SENATOR JOHNS)
- 23. Senator Coffey.
- 24. SENATOR COFFEY:
- 25. Mr. President and members of the Senate. I'd like to
- 26. move to concur with...on Senate Bill 1859 with amendments...
- 27. House Amendments No. 1 and No. 2. Amendment No. 1 is a...is
- 28. only a correction in the...in the bill. Amendment No. 2 adds
- 29. to that bill a transfer that one dollar cost of less than
- 30. one half acre of land back in St. Clair County for...to
- 31. the municipality and I'd like to ask this Body concur with
- 32. Amendments No. 1, No. 2 to Senate Bill 1859.
- 33. PRESIDING OFFICER: (SENATOR JOHNS)

- Any discussion? You've heard the motion. The...the
- 2. ...the guestion is shall the Senate concur in House Amend-
- 3. ments No. 1 and No. 2 to Senate Bill 1859. Those in favor
- 4. vote Aye. Those opposed vote Nay. The voting is open.
- 5. Gentlemen, the voting is open. All right. This is the
- 6. first one, I'm going to give you a little time. Have all
- 7. voted who wish? Have all voted who wish? This is the
- 8. first one, I'm giving you just a little leeway here. Let's
- 9. be in our seats. All right. Take the record. Have all...
- 10. on that question the Ayes are 43, the Nays are none, those
- 11. Voting Present, zero. The Senate does concur in House Amend-
- 12. ments No. 1 and No. 2 to Senate Bill 1859 and the bill having
- 13. received the required constitutional majority is declared
- 14. passed. Any other members? Senator Regner. All right.
- 15. Senator David Regner.
- 16. SENATOR REGNER:
- 17. Mr.President and members of the Senate. I move that
- 18. the Senate nonconcur in House Amendment, the House Amend-
- 19. ment to Senate Bill 1523. It's nonconcur.
- 20. PRESIDING OFFICER: (SENATOR JOHNS)
- 21. Senator Regner moves to nonconcur in House Amendments
- 22. No. 2 to Senate Bill 1523. All those in favor say Aye.
- 23. All those opposed say Nay. The motion carries and the
- 24. Secretary shall so inform the House. Senator...Nimrod.
- 25. SENATOR NIMROD:
- 26. Thank you, Mr. President. I would ask that we not
- 27. concur on Senate Bill 1861 on House Amendments 6, 7, 9,
- 28. 11, 12, 13 and 14. And the reason for this, there are
- 29. some technical changes that have to be made within that
- 30. bill and request a Conference Committee report.
- 31. PRESIDING OFFICER: (SENATOR JOHNS)
- 32. Senator Ozinga...I mean Senator Nimrod moves to non-
- 33. concur on House Amendments 6, 7, 9, 11, 12, 13, 14 to

- 1. Senate Bill 1861. All those in favor say Aye. All those
- 2. opposed say Nay. The motion carries and the Secretary shall
- 3. so inform the House. Senator Rock.
- 4. SENATOR ROCK:
- 5. Thank you, Mr. President, Ladies and Gentlemen of the
- 6. Senate. There are a number of Conference Committees now
- 7. beginning to assemble and it is my intent that to make a
- 8. motion the Senate will stand in recess until the hour
- 9. of two-thirty. At which time we will begin on the Order
- 10. of Concurrence and then hopefully have some Conference
- 11. Committee reports which can be addressed. So I would
- 12. ask the membership to attend to those Conference Com-
- 13. mittee meetings as soon as possible and please return
- 14. to the Floor promptly at 2:30 so that we may commence
- 15. to work on the Calendar.
- 16. PRESIDING OFFICER: (SENATOR JOHNS)
- 17. Senator Rock moves to stand in...
- 18. SENATOR ROCK:
- 19. Wait...do you have something you should read in.
- 20. SECRETARY:
- 21. No sir. I just wanted to know if you want those Con-
- 22. ference Committees that are finalized put on the Senators'
- 23. Desks.
- 24. SENATOR ROCK:
- Yes, that's...Gentlemen, if I can have your attention
- 26. for a moment, we...we have provided in the past and will
- 27. provide on a daily basis a Supplemental Calendar of Con-
- 28. ference Committee Reports that have been filed along with
- 29. copies of the reports. Now they will be placed upon the
- 30. Desk, but it seems to me the responsibility of each
- 31. member to kind of hang on to those until we get to them.
- 32. Hopefully in the next number of hours.
- 33. PRESIDING OFFICER: (SENATOR JOHNS)

- Senator Glass.
- 2. SENATOR GLASS:
- Thank you, Mr. President. I have a question of Senator
- 4. Rock or the Chair. I've noticed at least on one occasion
- 5. that there was a Conference Committee this morning where
- 6. notice had not been received by any of the Senate members.
- 7. Could you again announce the method by which notice of
- 8. these Conference Committees will be transmitted to the
- 9. members.
- 10. PRESIDING OFFICER: (SENATOR JOHNS)
- 11. Senator Rock.
- 12. SENATOR ROCK:
- 13. Well, we have provided, at least for Conference Com-
- 14. mittees on Senate Bills, as you know the Senate sponsor
- 15. is...is ex officio the Chairman. And we have provided
- 16. notice forms so that all members can be notified. Now
- 17. frankly, with respect to House Bills, we have asked
- 18. the House to do the same, but it appears that they are
- 19. doing it by telephone. I, frankly, have importuned the
- 20. House, but that's...I've been doing that for days and
- 21. it doesn't seem to work.
- 22. PRESIDING OFFICER: (SENATOR JOHNS)
- 23. Senator Shapiro. Senator Shapiro.
- 24. SENATOR SHAPIRO:

- 23. year in both this Chamber and the House bills were introduced
- 24. to alter the Memorial Day. The Senate bill did not get out
- 25. of Rules Committee. The House bill did get out of the House

 m 26.}$ Rules Committee, was referred to the House Executive Committee.
- 27. It was defeated on a vote of 20 to 2 when testimony was presented
- 28. before that committee. Now this is a devious tactic by a teacher
- 29. in the special interest of the teachers because it does not
- 30. change Memorial Day back to May 30 rather back to the Monday
- 31. holiday to conform with the Federal in its entirety. That
- 32. takes two pieces of legislation. Now this would confuse things
- 33. even more than they're confused now because you'd have your

- 14. told you many, many times they're out of step including the
- 15. Congressman who represents Senator Schaffer. Probably out of
- 16. step more than any of them. He's the one that originated it

- 17. with Veteran's Day. Finally after forty-six states changed
- 18. Veteran's Day back to November 11, did Congress finally wake up
- 19. to the fact what the people wanted back home and then it changed
- 20. it back and this year I might say will be the first year that the
- 21. Federal and the States coincide on Veteran's Day being on November
- 22. the 11th. It's a hard time. It is tough to get through to those
- 23. knuckleheads in Washington. You know it, I know it. Now there's
- 24. fourteen states that don't observe Memorial Day, the Southern
- 25. states, so President Carter he...he isn't concerned about this.
- 26. They lost that war because it was in 1868 on May 30 down in
- 27. Carbondale that they had the very first Memorial Day. That's why
- 28. it's sacred to the State of Illinois but the nationally chartered
- 29. veteran's organizations and other patriotic organizations are
- 30. working hard with Congress to get them to change. I have personally
- 31. contacted the twenty-four Congressmen, the two United States
- 32. Senators representing the State of Illinois and we have written
- 33. pledges from them that they will support that legislation. It has

- 15. Senator Buzbee. Your time is about up, Senator Weaver.

- 16. It does not require a referendum. What it is...and it's not a...
- 17. this is not an additional amount of money involved. They have been
- 18. paying this money for premium insurance...on the premiums on the
- 19. insurance. They have not been able to secure the insurance.
- 20. Now, what this does is to permit them to set up their self-
- 21. insurance or join a reciprocal and it's the same money that we're
- 22. talking about.
- PRESIDING OFFICER: (SENATOR DONNEWALD)
- 24. Senator Bowers.
- 25. SENATOR BOWERS:
- 26. Mr. President, I'd like to rise in support of this motion
- 27. by Senator Rupp. As he indicates, this is not a new tax. We
- 28. already permit the municipalities to tax for insurance. The point
- 29. is they can't get insurance so they can use that money for self-
- 30. insurance program and I think it's a good idea and I would ask
- 31. for a favorable roll call.
- 32. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 33. Senator Ozinga.

- 1. SENATOR OZINGA:
- 2. I, too, rise in support of this because I think all that this
- 3. does is legalizes what they're already doing.

- 19. majority is declared passed. A Message from the House.

- 21. A Message from the House by Mr. O'Brien, Clerk.
- 22. Mr. President I am directed to inform the Senate
- 23. the House of Representatives refused to concur with the Senate
- 24. in the adoption of their amendment to a bill with the following
- 25. title:
- 26. House Bill 3108 with Senate Amendment No. 3.
- 27. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 28. Senator Roe. Senator Roe.
- 29. SENATOR ROE:
- 30. Mr. President and members of the Senate. I move that the
- 31. Senate recede from Senate Amendment No. 3, which is the RV
- 32. amendment.
- 33. PRESIDING OFFICER: (SENATOR DONNEWALD)

- 1. Is there discussion? Is there discussion? The question
- 2. is shall the Senate recede from Amendment No....Senate Amendment
- 3. No. 3 to House Bill 3108. Those in favor vote Aye. Those
- 4. opposed Nay. The voting is open. Have all those voted who wish?
- 5. Have all those voted who wish? Take the record. On that
- 6. question the Ayes are 42, the Nays are 4, 3 Voting Present.
- 7. The Senate recedes from Amendment No. 3 to House Bill 3108
- 8. and the bill having received the required constitutional
- 9. majority is declared passed. On the Order of Secretary's
- 10. Desk on Concurrences on page 6 of your Calendar,
- 11. Senate Bill 1785, Senator Hynes.
- 12. SENATOR HYNES:
- 13. Mr. President, Senate Bill 1785, as it left the Senate,
- 14. provided that repair and maintenance, ordinary repair and
- 15. maintenance of residential property was not to be included
- 16. as an assessible item to cause an increase in assessed
- 17. valuation. At the time the bill was called up in the Senate,
- 18. there was some reference to the existing law downstate which
- 19. put a seventy-five hundred dollar limitation on the amount of
- 20. repair and maintenance that could be excluded. Many members
- 21. felt that it ought to be the same downstate as in Cook County

- 31. Excuse me. Move that we concur in Amendment No. 2.
- PRESIDING OFFICER: (SENATOR DONNEWALD)
- 33. Is there discussion? The question is shall the Senate concur in House Amendment No. 2 to Senate Bill 1785. Those in favor

- 1. vote Aye. Those opposed Nay. The voting is open. Have all those
- 2. voted who wwish? Take the record. On that question the Ayes are
- 3. 53, the Nays are 3. The Senate does concur in Amendment...House
- 4. Amendment No. 2 to Senate Bill 1785 and the bill having
- 5. received the required constitutional majority is declared
- 6. passed. Senator Kenneth Hall, for what purpose do you arise?
- 7. SENATOR KENNETH HALL:
- 8. I rise on a point of personal privilege.
- 9. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 10. State your point.
- 11. SENATOR KENNETH HALL:
- 12. We're honored this evening, Ladies and Gentlemen of the Senate,
- 13. by having the presence of Miss Michelle Caronis. She's
- 14. Executive Director for the National Conference of Black Mayors
- 15. who have been meeting here in Springfield. I'd like...she's
- 16. sitting here at my desk. I'd like for her to stand and be
- 17. recognized by the Senate.
- 18. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 19. Please stand and be recognized. The Senate will
- 20. stand at ease. Senator Lane, for what purpose do you
- 21. arise?
- 22. SENATOR LANE:
- Point...point of personal privilege, Mr. President.
- PRESIDING OFFICER: (SENATOR DONNEWALD)
- 25. State your point.
- 26. SENATOR LANE:
- Mr. President, and members of the Senate. Standing to the
- 28. right of me, is the good friend of mine and Mayor of
- 29. East Chicago Heights, Saul Beck.
- 30.
- 31. The following typed previously.
- 32.
- 33.

The point

- 1. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 2. Please stand and be recognized. Senator Savickas, for what
- 3. purpose do you arise?
- 4. SENATOR SAVICKAS:
- 5. Well, Mr. President, while we're in a lull here, I do have
- 6. a bill up there for concurrence that dates back to 1977 and
- 7. I would ask that you call it.
- 8. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 9. Senator Savickas, what's the number of the bill, please?
- 10. SENATOR SAVICKAS:
- 11. It's House Bill 168. There are Conference Committee Reports
- 12. that have been passed out to every member. House Bill 168.
- 13. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 14. Oh, this is a Conference Committee Report?
- 15. SENATOR SAVICKAS:
- 16. Yes, it's...
- 17. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 18. House Bill...you may...you may proceed.
- 19. SENATOR SAVICKAS:
- 20. Yes. Yes, Mr. President...
- 21. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 22. Just a moment. Just a moment. Senator Rock, for what
- 23. purpose do you arise?
- 24. SENATOR ROCK:
- 25. Thank you. Parliamentary inquiry, Mr. President.
- 26. Might I ask that the Secretary read the report in full so that
- 27. we're all sure we have the same report, including the date?

- 30. Conference Committee Report on House Bill 168.

- 32. SENATOR ROCK:
- 33. Thank you.

- 1. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Savickas.
- 3. SENATOR SAVICKAS:
- 4. Yes, Mr. President and members of the Senate.
- 5. We have found that due to inaction of the Senate on June
- 6. 29th, 1977, that House Bill 168 is still alive and active and
- 7. ready for final passage through our concurrence with the House
- 8. ...or with the committee report. The House has concurred.
- 9. All members...all ten members of the committee have concurred
- 10. in the Conference Committee Report which at this...for this
- 11. particular bill, was to remove the home rule amendment for
- 12. House Bill 168. So, at this time, I would ask...I would ask that
- 13. the Senate concur with the Conference Committee Report and those
- 14. that are concerned with home rule amendment, I would like to
- 15. remind you that just two days ago, Senator Clewis passed
- 16. his bill which would remove our concern about home rule amendments
- 17. on these...type of legislation. If there are any questions,
- 18. I'd be glad to answer them.
- 19. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 20. Senator Bloom.
- 21. SENATOR BLOOM:
- 22. Point of parliamentary inquiry. Assuming we nonconcur
- 23. in this, then this goes back to a Conference Committee, is that
- 24. correct, Mr. President? Which means that it could then...
- 25. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 26. His motion, as I understand, was to concur with Conference
- 27. Committee Report No. 1.
- 28. SENATOR BLOOM:
- 29. All right. But, let's...yeah, I'm asking ifowe don't,
- 30. then another Conference Committee is formed and it's Katy, bar the
- 31. door?
- PRESIDING OFFICER: (SENATOR DONNEWALD)
- This is the first...well, there would be...there would...if there

- is a request for a second, yes, there would be another Conference
- 2. Committee. Senator Grotberg.
- 3. SENATOR GROTBERG:
- 4. Question...question of the sponsor, if he'll yield.
- 5. Have we talked about what the bill does at all, Senator?
- 6. We're still talking about the Smoking Act...the Public Smoking
- 7. Act and if we vote this up, we can't smoke anymore and all those
- 8. things? The same idea? A year hasn't changed the body of
- g the legislation?
- 10. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 11. Senator Savickas.
- 12. SENATOR SAVICKAS:
- 13. Yes, Senator Grotberg, we're talking about concurring
- 14. with the Conference Committee Report for House Bill 168 which
- 15. would remove the home rule amendment provision for the City of
- 16. Chicago. You're right, this is the Act that creates the
- 17. Public Smoking Act and it would prohibit persons from smoking
- 18. in designated public places that are now...that are now, by
- 19. city ordinance, usually prohibited. We're talking about hospital
- 20. patient rooms, elevators, indoor theatres, libraries,
- 21. art museums, concert halls, buses and so on, and that
- 22. reasonable portions of a place to be designated as smoking
- 23. areas in other physical facilities. Yes, this is the bill
- 24. to allow those of us who do not wish to smoke, the enjoyment of
- 25. a free, clear atmosphere.
- 26. SENATOR GROTBERG:
- 27. Well, as long...I think I'm still turned on, am I?
- 28. Am I...
- 29. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 30. Senator...Senator Grotberg.
- 31. SENATOR GROTBERG:
- Well, I think this would be a good time, Ladies and Gentlemen,
- 33. if we nonconcur. We might be able...everything in this Act is now happening. Every year it gets better. The public is being

- 1. more attentive and public administration of public buildings
- 2. are being more attentive to designating spaces without this Act.
- 3. I think it turns out to be just too much medling around with the
- 4. administration of public space to create a law that you can
- 5. arrest people for such things and I think if we nonconcur
- 6. then maybe the bill will die a nice, natural death and we won't
- 7. have to kick it around anymore.
- 8. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 9. Senator Guidice.
- 10. SENATOR GUIDICE:
- 11. Will the sponsor yield to a question?
- 12. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 13. Indicates he will.
- 14. SENATOR GUIDICE:
- 15. Senator Savickas...Senator Savickas.
- 16. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 17. Indicates he will.
- 18. SENATOR GUIDICE:
- 19. I know he will, but he's...there we are. Senator Savickas,
- 20. you said that the municipalities are already doing this?
- 21. And you indicate that they were...that was previously by ordinance
- 22. and the like that they were already participating in these
- 23. type of programs? You said that the municipalities were already
- 24. participating in these types of program by passing ordinances
- 25. and the like. I think that's what Senator Savickas said in his
- 26. explanation. Is that correct? Senator Savickas hasn't answered.
- 27. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 28. Senator Savickas.
- 29. SENATOR SAVICKAS:
- 30. Yes, Senator Guidice, municipalities...there are some
- 31. municipalities that have instituted ordinances in the locations
- 32. that I have enumerated. Our concern is that this is being
- 33. done piecemeal and not for the benefit of the whole public and

- 1. at this time, I would appreciate that the whole State of Illinois
- 2. honor the commitment to those people who refuse
- 3. smoke or to enhale those obnoxious fumes that are distributed
- 4. through the tabacco industry.
- 5. PRESIDING OFFICER: :(SENATOR DONNEWALD)
- 6. Senator Guidice.
- 7. SENATOR GUIDICE:
- 8. Senator Savickas, do you know of any municipalities
- g. or villages or the like that do not have any of these
- 10. ordinances? You don't know of any? You're not doing this for
- 11. any particular village or town or anything like that, then?
- 12. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 13. Senator Savickas.
- 14. SENATOR SAVICKAS:
- 15. Well, I'm doing it for all of the people of the State of
- 16. Illinois and since I live in Chicago, primarily in the Chicago
- 17. area.
- 18. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 19. Senator Guidice.
- 20. SENATOR GUIDICE:
- 21. But Chicago has these type of ordinances, don't they?
- 22. I didn't hear you, Senator.
- 23. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 24. Senator Savickas.
- 25. SENATOR SAVICKAS:
- 26. I don't know.
- 27. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 28. Senator Wooten.
- 29. SENATOR WOOTEN:
- Thank you, Mr. President. I...it's been some time since
- we've discussed this bill. Senator Guidice...Senator Guidice,
- this simply gives the rest of the State the benefits of the protection
- now enjoyed in Chicago. It's quite a reasonable and limited

- 1. approach. The...the places that are enumerated by
- 2. Senator Savickas are the only ones affected and Senator
- 3. Grotberg, if you're concerned about a private restaurant, it
- 4. simply says you may designate such a space. So, it is a
- 5. minimal effort and I think quite a reasonable bill and now that
- 6. the City of Chicago has discovered that it will not really
- 7. change anything there, why I noticed that Senators Daley,
- 8. Savickas and Lemke signed the Conference Committee Report and
- g. I hope that we would concur in it.
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 11. Further discussion? Senator Netsch.
- 12. SENATOR NETSCH:
- 13. Thank you, Mr. President. I would like to rise strongly in
- 14. support of this bill and I do it even though I am myself
- 15. a smoker. I became conscious of the importance to those
- 16. who are nonsmokers and particularly to those who suffer really
- 17. very serious allergic effects to cigarette smoke sometime ago
- and I recall Senator Mitchler, I'm sorry you're not on the Floor,
- 19. the first time that you had this bill in the Senate. I cosponsored
- 20. it for you and I think it's fair to say that we were sort of
- 21. hooted and howled down. But I think what's happended in the
- 22. interim is that...and I also sponsored the bill myself the
- 23. following Session and it was amendatorily vetoed, I think
- 24. mistakenly so by the Governor and we were not able to rectify
- 25. that wrong. I think what's happeneddin the interim is
- 26. that a very substantial number of people have come to
- 27. recognize that the...the serious problem that cigarette smoke
- 28. presents to many people who are nonsmokers and particularly
- 29. to those who may actually have physical ill effects from it.
- 30. That is quite apart from the fact that many researchers in the
- 31. area have now indicated that even for those who do not smoke,
- 32. the inhalation of cigarette smoke can often present a health
- 33. hazard. This is now a very serious matter and it is a very

- 1. serious bill. It is modest. It doesn't prohibit smoking
- 2. in vast numbers of public places. But it does at least make a
- 3. reasonable beginning and I think all of us and perhaps particularly
- 4. those of us who...ourselves smoke, owe it to the rest of
- 5. humanity to try to recognize the severe problems that they
- 6. face from our terrible habit. I really would strongly
- 7. urge that we support this bill.
- 8. PRESIDING OFFICER: (SENATOR BRUCE)
- Further discussion? Senator Leonard.
- 10. SENATOR LEONARD:
- 11. Mr. President, I would ask the members of this Body to
- 12. consider how ludicrous we will appear if we can't take action
- 13. on this. Look it over. What we are saying is we would
- 14. prohibit smoking in a hospital patient's room, an elevator, in an
- 15. indoor theatre, in a library, or on a bus and I think most
- 16. of us would agree that those are areas that, that through the
- 17. decency to our fellow human, we shouldn't smoke. There is a
- 18. certain absurdity in not acting and I...I think society on this
- 19. has passed us by and I think the...the most prudent thing we can
- 20. do is kind of get in line and not be absurd by refusing to take
- 21. action on a very common thing.
- 22. PRESIDING OFFICER: (SENATOR BRUCE)
- 23. Further discussion? Senator Weaver.
- 24. SENATOR WEAVER:
- 25. Well, like Senator Rock, I just wonder where this Conference
- 26. Committee Report has been for the last year.
- 27. PRESIDING OFFICER: (SENATOR BRUCE)
- 28. Senator...I was told by the Secretary yesterday...
- 29. SENATOR WEAVER:
- 30. Seems like it was signed on the 29th of June, 1977 a year ago
- 31. today.
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- 33. I am told by the Secretary that it was filed in his office

- on that date and the Chairman of the Conference Committee
- never called it for a vote. And under our rules, that is not
- 3. barred. That is correct, Senator Weaver. It has been in the
- 4. Secretary's office since last June. For what purpose does
- 5. Senator Mitchler arise?
- 6. SENATOR MITCHLER:
- 7. Yes, Mr. President and members of the Senate.
- 8. PRESIDING OFFICER: (SENATOR BRUCE)
- 9. May we have some order, please.
- 10. SENATOR MITCHLER:
- 11. I don't recall the exact year or what Session it was that
- 12. I first introduced a bill relating to the rights of nonsmokers
- 13. to be protected but I do recall in the Senate Executive
- 14. Committee that there was a quite a bit of laughter and it was sort
- 15. of a joking atmosphere and it...it was going to be voted
- 16. unanimously Do Not Pass until Senator Fawell said wait a minute.
- 17. Let's...let's listen to the arguments that Senator Mitchler
- 18. may have for the reason for putting in this bill. And I
- 19. presented them to the Executive Committee. They gave me the
- 20. courtesy of doing that and at the time, Senator Fawell said
- 21. I think this bill is a little bit premature. It hasn't developed
- 22. enough among the public to be accepted. It's ahead of its time.
- 23. I don't recall exactly what year but that's many years ago.
- 24. Probably at least ten or twelve years ago. Now this bill has
- 25. been bandied around a number of different occasions. It's reached...
- 26. reached passage stage on a number of occasion. I recall when the
- 27. tobacco industry had their two lobbyists sitting in the center
- 28. up here when I had the bill on 3rd reading one time and I held them
- 29. up there for two weeks and I got quite a kick out of them.
- 30. They would sit up there and wait, the tobacco lobbiests.
- 31. PRESIDING OFFICER: (SENATOR BRUCE)
- 32. Yellow light, Senator.
- 33. SENATOR MITCHER:

I see it. The Chair can admonish me when I finish. You don't

- 1. have to give me the yellow light unless you give that to
- 2. everybody, Mr... Now, the time has come, if you want to listen
- 3. to what the public out there is saying, you know how it is on
- 4. the airlines and everyplace else. Vote the way the people
- 5. want that elected you, not the way your...some municipality
- 6. wants to tell you or...or in that direction. This is a good
- 7. bill and I ask for you to support the Conference Committee
- 8. Report.
- 9. PRESIDING OFFICER: (SENATOR BRUCE)
- 10. Further discussion? Senator Rock. Senator Nimrod.
- 11. SENATOR NIMROD:
- 12. Just one quick question. Reading the Digest, it just
- 13. comes to my attention that this calls, Mr. President,
- 14. attention...it says a hospital patient room and I don't know whether
- 15. the Digest is right or not. Doesn't a hospital usually regulate
- 16. that in a patient's room... I might ask of Senator Savickas?
- 17. PRESIDING OFFICER: (SENATOR BRUCE)
- 18. Senator Savickas.
- 19. SENATOR SAVICKAS:
- 20. Yes, it would be up to the hospital to designate
- 21. if that particular patient room should...should be a smoking
- 22. area or not. The hospital would have that discretionary
- 23. authority.

PRESIDING OFFICER: (SENATOR BRUCE) ١. Further discussion? Senator Rock. 2. SENATOR ROCK: 3. Thank you, Mr. President, Ladies and Gentlemen of the Senate. 4. I rise in opposition to House Bill 168 and the Conference 5. Committee Report thereon. This is, in my judgment, a terrible 6. bill and one that is, aside from the fact that it appears 7. on its face to be in the best interest of the people, it goes 8. a little deeper than that because there is no question in 9. my mind but that it is preemptive, constitutionally preemptive. 10. Under Section 6, Article VII of the Local Government section of 11. the Constitution of the State of Illinois, the General 12. Assembly may, by a law, approve, limit the power or function 13. of a home rule unit. This kind of restrictive power or function 14. belongs to each and every home rule unit in this State and I 15. would seek a ruling of the Chair, since, in fact, the Conference 16. Committee Report calls for us to recede from Senate Amendment 17. No. 1 which was, in fact, the home rule amendment and since the 18. passage of this Conference Committee would constitute final 19. action, I would ask the Chair for a ruling as to whether or 20. not the vote before us is preemptive under Section 6, 21. Article VII, Subsection G of the Constitution of the State of 22. Illinois and if it is, it will require, of course, a three-23. fifths vote. 24. PRESIDING OFFICER: (SENATOR BRUCE) 25. Under Section 6 of Article VII, paragraph (a), are set 26. forth the powers of home rule units and...in the Constitution 27. which it says "they shall have the power to regulate 28. for the protection of the public health, safety, morals and 29. welfare." It would be the ruling of the Chair that the power 30. to regulate for the protection of public health is delegated 31. to home rule units under the Constitution Section 6...Article...

Article VII, Section 6 and since this would be a limitation upon

34. that power, it will require a three-fifths vote as stated in

- 1. Section G of Section 6 of Article VII.
- 2. Further discussion? Senator Glass.
- 3. SENATOR GLASS:
- Mr. President...
- 5. PRESIDING OFFICER: (SENATOR BRUCE)
- 6. Senator Rock, did you wish to continue? The Chair did
- 7. not wish to preclude you. Senator Glass.
- 8. SENATOR GLASS:
- 9. Well, Mr. President, in debate on this issue...
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 11. May we have some order, please?
- 12. SENATOR GLASS:
- 13. In debate on this...this issue, I believe it's also
- 14. clear in the Constitution that unless there is a specific
- 15. preemption, and this is supported by court decision by our
- 16. Supreme Court, unless there is a specific preemption, that
- 17. there is not preemption by the...by the bill and I would just
- 18. ask if there is anything in this bill which specifically preempts

- 20. PRESIDING OFFICER: (SENATOR BRUCE)
- 21. For what purpose does Senator Rock arise?
- 22. SENATOR ROCK:
- 23. That was the point against which Senator Glass so eloquently
- 24. argued the other night with respect to Senator Clewis's bill,
- 25. 1468.
- 26. PRESIDING OFFICER: (SENATOR BRUCE)
- 27. Senator Glass, in the review of the bill, it seems that
- 28. this is a State Act involving the regulation of public
- 29. smoking and a finding by the General Assembly that they
- 30. may regulate it as to place, designated area and defining
- 31. smoking department and proprietor and since under the
- 32. Constitution...and there is nothing, I might add, saying that this is
- 33. not applied to home rule units, the assumption then under our

- 1. statutory construction is, in fact, it does apply to
- 2. home rule units and since the Constitution allows
- home rule units the right to regulate for the protection of
- 4. the public health and safety of its citizens, that this would
- 5 be preemptive and require a three-fifths vote.
- 6. Senator Glass.
- 7. SENATOR GLASS:
- 8. Well, Mr. President, it may be academic, the bill may
- 9. well get thirty-six votes, but I would take issue with you
- and...and point out that the Constitution does require
- the General Assembly, in order to deny or limit the power ll.
- to tax or any other power or function of a home rule unit,
- may take this action, but it...but the preemption must
- be specific and I would simply take issue with you.
- I don't think there's anything specifically stated in 15.
- this bill that does...does preempt home rule units. 16.
- But, if you have ruled, sobeit. I...I would suggest that 17.
- under the decision of the Supreme Court, more specific $18. \,$
- language would be required.
- PRESIDING OFFICER: (SENATOR BRUCE)
- Further discussion? Senator Netsch.
- SENATOR NETSCH:
- On your parliamentary ruling, I disagree, respectfully.
- There is no question, I think, that under the concurrent powers 24.
- section, which is Subsection I, that home rule units
- may exercise and perform concurrently with the State any 26.
- power or function of a home rule unit to the extent that the 27.
- General Assembly, by law, does not specifically 28.
- limit the concurrent exercise or specifically declare the 29.
- State's exercise to be exclusive. There is nothing in this bill 30.
- which declares the State's exercise of the function of ${\bf 31.}$
- regulating smoking in designated areas, to be exclusive. $\ensuremath{\mathtt{32.}}$
- It is, therefore, a concurrent exercise of power and by a simple 33.
- 34. majority, or constitutional majority vote, the General Assembly

v/2.

- 1. may enact a law on the same subject which partially limits
- 2. the...that which is to be done in this area of the...of
- 3. public health. But it is not, I repeat, it is not an
- 4. exclusive preemption by the State. The...the concurrent
- 5. exercise is clearly permitted within the confines of this
- 6. bill. So, it requires only a majority vote to pass it.
- 7. PRESIDING OFFICER: (SENATOR BRUCE)
- 8. Well, I have ruled and I would just conclude, Senator,
- 9. that if a city wished to allow smoking in a hospital room,
- 10. they would be precluded and that is not concurrent, but
- 11. exclusive jurisdiction of the State. And it is not concurrent
- 12. to say that they could allow smoking in a...I've made the
- 13. ruling that it requires three-fifths. Senator Knuppel.
- 14. SENATOR KNUPPEL:
- 15. Well, I'm glad that Senator Mitchler returned to speak.
- 16. I was afraid he was away celebrating Memorial Day and I'm
- 17. glad he's back here for the vote. But this doesn't really
- 18. involve public health. This involves the individual health of
- 19. a lot of people and for someone who has had a heart condition,
- 20. someone who doesn't smoke, for someone who is offended by
- 21. people who do drink and smoke and impose upon those of us who
- 22. do not, and who have endured it, I think that those of you who
- 23. do, would be courteous enough to want this to be passed and I
- 24. seldom disagree with...with Senator Rock, but when he puts the
- 25. interest of home rule above the individual rights of a citizen
- 26. of that...a citizen who may be suffering and who has tolerated
- 27. to the...with forebearance for years breathing the same
- 28. dirt that comes out of his lungs after he smokes a cigarette, that
- 29. it's time that this becomes legislation. And I don't...I just...
- 30. I just don't see it as a public health issue at all. I see it as
- 31. a personal one and I think it's a lot of trivia to argue at this
- 32. particular point whether the City of Chicago has the right to say
- 33. you do or don't smoke in an elevator or a hospital room

- of some patient who's suffering from an illness. That's just
- 2. a lot of bushwa.
- 3. PRESIDING OFFICER: (SENATOR BRUCE)
- 4. Further discussion? Senator Netsch, did I cut you off?
- 5. I'm...the Chair apologizes. Senator Netsch.
- 6. SENATOR NETSCH:
- Yes, you did. I...I was going to attempt to summarize.
- 8. PRESIDING OFFICER: (SENATOR BRUCE)
- Please accept the apology of the Chair.
- 10. SENATOR NETSCH:
- 11. I...I may not put you to the embarrassment of
- 12. protesting the ruling of the Chair, but I am very serious,
- 13. Mr. President. I think it is a very bad ruling and has very
- 14. dangerous implications in terms of future legislation. I
- 15. genuinely protest your ruling.
- 16. PRESIDING OFFICER: (SENATOR BRUCE)
- 17. Further discussion? Senator Savickas may close.
- 18. SENATOR SAVICKAS:
- 19. Yes, Mr. President and members of the Senate.
- 20. I don't think we should argue constitutional questions on a...
- 21. issues that affects our health, our own comfort, comfort of
- 22. our friends and relatives. This is a bill that was introduced
- 23. to alleviate the problem that the nonsmoker must contend with
- 24. constantly in our society and our smoking society and to give him
- 25. a reasonably free area where he can enjoy the social activities.
- 26. When we consider hospitals and we consider other public facilities,
- 27. these areas can be designated as smoking areas or not. It would
- 28. be up to each individual area. I would ask your favorable support
- 29. for House Bill 168.
- 30. PRESIDING OFFICER: (SENATOR BRUCE)
- 31. The question is shall the Senate adopt the Conference
- 32. Committee Report on House Bill 168. Those in favor vote
- 33. Aye. Those opposed vote Nay. The voting is open.

- 1. Have all voted who wish? Have all voted who wish?
- 2. Take the record. On that question the Ayes are
- 3. 38, the Naysare 15, 1 Voting Present. The Senate does
- 4. adopt the Conference Committee Report on House Bill 168
- 5. and the bill having received the required three-fifths
- 6. constitutional majority is declared passed. For what
- 7. purpose does Senator Guidice arise?
- 8. SENATOR GUIDICE:
- 9. Thank you, Mr. President. I have a Conference Report
- 10. I'm ready to go with 1792.
- 11. PRESIDING OFFICER: (SENATOR BRUCE)
- 12. Senator, I think there are some other Senators that
- 13. have sought recogition. There is a list that the Secretary
- 14. is preparing of Senators who are ready to go with their
- 15. Conference Committees. Senator Berman, are you prepared
- 16. on 393 and 395? Senate Bill 393, the Conference
- 17. Committee Report thereon. Senator Berman is recognized.
- 18. SENATOR BERMAN:
- 19. Thank you, Mr. President. Senate Bills 393 and
- 20. 395 are the last two of the five bills dealing with the
- 21. special education requirements to conform with the Federal
- 22. mandate under 94-142. There were some questions on both
- 23. these bills. On Senate Bill 393, the House had spelled out
- 24. the extent of the medical services for diagnostic and
- 25. evaluation purposes for special...for special education for
- 26. handicapped children. The Conference Committee recommends
- 27. that the Senate concur in House Amendment No. 2 which spelled
- 28. out the nature of the physicians that would be qualified to
- 29. give these diagnostic and evaluative tests. I move
- 30. for acceptance of Conference Committee Report on Senate Bill
- 31. 393.
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- 33. Is there discussion? Senator Buzbee.

- SENATOR BUZBEE:
- Thank you, Mr. President. First of all, parlimentary
- 3. inquiry. In the past it has been the tradition of this Body
- 4. that Conference Committee Reports be placed upon our desks before
- 5. we're asked to vote upon them. I am looking and I can find no
- 6. such reports nor can I find any kind of a legislative synopsis.
- 7. Well, Mr. President, all we have is, apparently, even though I
- 8. couldn't find it at my desk. It says we the undersigned committee
- 9. on the conference appointed to consider the differences between
- 10. the two Houses in relation to the House amendment to Senate Bill
- 11. 393 and recommend that the Senate concur in House Amendment No. 2.
- 12. Now I quite frankly don't know what House Amendment No. 2 is. We
- 13. have had it and I would like to...if the Chair would care to listen
- 14. to the parlimentary inquiry...
- 15. PRESIDING OFFICER: (SENATOR BRUCE)
- 16. Proceed, Senator Buzbee.
- 17. SENATOR BUZBEE:
- 18. ... If the Chair would listen to the parlimentary inquiry, my
- 19. inquiry is...
- 20. PRESIDING OFFICER: (SENATOR BRUCE)
- 21. May we have some order, please so that I might hear the
- 22. inquiry. Senator Buzbee.
- 23. SENATOR BUZBEE:
- 24. ...My inquiry is in the past Senator Regner's organization
- 25. of Legislative Information Service has put out...computer print-
- 26. outs on what we're voting on. Now, I think everybody in this
- 27. Chamber knows I've been opposed to this whole concept all along
- 28. and yet now we're asked to vote upon something and I don't quite...
- 29. quite frankly don't have the slightest idea what we're voting on
- 30. and I would ask the Chair to rule if we're going to be required
- 31. to vote on this till we know what the hell we're doing.
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- 33. Senator Buzbee, under our rules the only requirement is that

- 1. a Conference Committee be signed by six members, approved by
- 2. the majority leader, minority leader and be distributed to the
- 3. membership. Senator Buzbee, the rule is Rule 56 and no report
- 4. of any Conference Committee shall be considered unless the bill
- 5. report has been printed in its final form and placed on the
- 6. desks of the members.
- 7. SENATOR BUZBEE:
- 8. I'm sorry. I didn't hear you, Mr. President. Would you
- 9. mind to state that again.
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 11. The rule requires that no report of any Conference Committee
- 12. shall be considered unless the bill to report has been printed
- 13. in its final form and placed on the desks of the members.
- 14. SENATOR BUZBEE:
- 15. Has that been...has that obligation been met in this case,
- 16. Mr. President? Mr. President, let me make one more inquiry of
- 17. you.
- 18. PRESIDING OFFICER: (SENATOR BRUCE)
- 19. Are we on Rule 56, Senator Buzbee?
- 20. SENATOR BUZBEE:
- 21. Are we in the same book Mr. President?
- 22. PRESIDING OFFICER: (SENATOR BRUCE)
- 23. I...I believe you have the old book, Senator.
- 24. SENATOR BUZBEE:
- 25. As I read Rule 56 in the green book...
- 26. PRESIDING OFFICER: (SENATOR BRUCE)
- 27. That is our current rules.
- 28. SENATOR BUZBEE:
- 29. ...It says that no subject shall be included in any Conference
- 30. Committee Report on an appropriation bill unless such matter directly
- 31. ..
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- 33. Read the second sentence, Senator, I believe.

- 1. SENATOR BUZBEE:
- 2. No appropriation bill shall be passed and no report of any
- 3. Conference Committee in any appropriation bill shall be considered
- 4. unless the bill to report has been printed in its final form and
- 5. placed on the desks of the members of at least legislative days
- 6. prior to the final passage of the bill and the consideration of
- 7. the report. First of all, this is not an appropriation bill, Mr.
- 8. President and the rule is inoperative. I'd like to have you
- 9. rule on that.
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 11. You are correct, Senator. It only applies to appropriation
- 12. bills. I had...I had read it as if it applied to regular bills.
- 13. I thought there was an additional "or" and under our rules there
- 14. are no rules then attaching to Conference Reports although our
- 15. custom has been that...having had approval of the minority and
- 16. majority leader and the Conference Committee Report having been
- 17. distributed to the membership it at that point could be brought
- 18. up for consideration. Senator Buzbee.
- 19. SENATOR BUZBEE:
- 20. Mr. President, I'm not trying to be dilatory, obstreperous,
- 21. or iconoclastic, however, I would like to know...I would like to
- 22. know exactly what rule we operate under as to the Conference
- 23. Committee Reports. This is a subject in which I have a great
- 24. deal of interest and I have absolutely nothing to refer to as far
- 25. as I can tell at this point upon my desk to which to speak to the
- 26. subject matter.
- 27. PRESIDING OFFICER: (SENATOR BRUCE)
- 28. For what purpose does Senator Buzbee arise?
- 29. SENATOR BUZBEE:
- 30. Well, Mr. President, I really am quite serious. I'm not
- 31. trying to be dilatory...dilatory. I don't even know how to
- 32. pronounce the word, that's why I'm not trying to be that.
- 33. PRESIDING OFFICER: (SENATOR BRUCE)

- 1. Senator, the material in the...in Senate Bill 393 would
- 2. be in your bill book. All amendments attached thereto would be
- 3. in your bill book and any changes new to that would be contained
- 4. in the Conference Committee Report itself.
- 5. SENATOR BUZBEE:
- Roll call.
- 7. PRESIDING OFFICER: (SENATOR BRUCE)
- 8. The only difficulty would be is the adoption of House amend-
- 9. ments to Senate Bills in which the House...that we would not
- 10. necessarily have a House amendment. Senator Buzbee.
- 11. SENATOR BUZBEE:
- 12. Mr. President, may I now speak to the subject matter then?
- 13. PRESIDING OFFICER: (SENATOR BRUCE)
- 14. All right. I...perhaps...Senator Netsch on...on this question
- 15. then...we'll get back to Senator Buzbee on the subject of the
- 16. Conference Committee Report. Senator Netsch.
- 17. SENATOR NETSCH:
- 18. Thank you, Mr. President. A suggestion. I remember quite
- 19. distinctly that last year we did adopt something in addition to
- 20. what you read in Rule 56 dealing with appropriations bills that
- 21. governed the procedure on Conference Committees because it is
- 22. quite correct. Our rules do not cover very much about Conference
- 23. Committees generally and the procedures thereon. Unfortunately,
- 24. I do not have my complete set of the rules with me at the moment.
- 25. I think they're over in my office but I am reasonably certain that
- 26. they...that we did that, that it was part of our temporary rules
- 27. and should be continued since we are still operating under our
- 28. temporary rules.
- 29. PRESIDING OFFICER: (SENATOR BRUCE)
- 30. It is the recollection of the Chair that we circulated such
- 31. a rule but that it was not adopted. It was proposed by Representative
- 32. Shea and the rule was not adopted in the Senate. That was a detailed
- 33. proposal relating to new material, old material and agreed on material

- 1. and I do not believe that the Senate adopted that and it has not
- 2. shown up in our rule books.
- 3. SENATOR NETSCH:
- 4. My recollection is not the same, but I think it is an
- 5. extremely important matter quite apart from Senator Buzbee's
- 6. objection here. We...then we really do not have proper procedures
- 7. governing our Conference Committee.
- 8. PRESIDING OFFICER: (SENATOR BRUCE)
- 9. The Chair indicated that the rule on Conference Committee
- 10. relates to appropriation bills and...
- 11. SENATOR NETSCH:
- 12. I...I...
- 13. PRESIDING OFFICER: (SENATOR BRUCE)
- 14. ...and therefore this being a substantive legislative item
- 15. that rule 56 would not apply and we would go then to custom and
- 16. practice of the Body and that has been that once the minority
- 17. and majority leaders have approved and the Conference Committee
- 18. Report has been, in fact, distributed on the desks that the bill
- 19. can be called up for final passage. Now on the substantive issues
- 20. in Senate Bill 393 and that Conference Committee Report thereon.
- 21. Is there discussion? Senator Buzbee.
- 22. SENATOR BUZBEE:
- 23. Thank you, Mr. President. A question of the sponsor.
- 24. PRESIDING OFFICER: (SENATOR BRUCE)
- 25. He indicates that he will yield.
- 26. SENATOR BUZBEE:
- 27. You are moving that...that the Senate concur in House Amend-
- 28. ment No. 2 to Senate Bill 393. How would House Amendment No. 2
- 29. delimit Senate Bill 393 as we passed it from this Body?
- 30. PRESIDING OFFICER: (SENATOR BRUCE)
- 31. Senator Berman.
- 32. SENATOR BERMAN:
- 33. All right. Senator Buzbee, the Conference Committee Report

- 1. suggests that the bill, as amended, read as follows: That in the
- Section 14-108 of the School Code in which Special Education
- 3. facilities is itemized that the language that we passed out of
- 4. the Senate that said that added the provision medical services
- 5. only for diagnostic and evaluation purposes be further expanded
- 6. to provide so that it reads as...in total as follows: Medical
- 7. services only for diagnostic and evaluation purposes provided
- 8. by a physician licensed to practice medicine in all its branches
- 9. to determine a child's need for Special Education and related
- 10. services.
- 11. PRESIDING OFFICER: (SENATOR BRUCE)
- 12. Senator Buzbee.
- 13. SENATOR BUZBEE:
- 14. Thank you, Mr. President. I would point out to the Body
- 15. that once again we are implementing something that the Federal
- 16. Government has told us that we will do without the Federal
- 17. dollars following. The cost of this is probably going to end
- 18. up being somewhere and nobody knows exactly, as a matter of fact,
- 19. but somewhere in the neighborhood of fifty million dollars
- 20. minimum. There is not money, it's my understanding, in the
- 21. categorical grant bill this year nor was it in the Governor's
- 22. request...sufficient money to fund this. We are now saying that
- 23. it will be a function of the school system that we provide medical
- 24. care for all of those children who fit this definition. We'll
- 25. provide medical services for diagnostic and evaluation purposes
- 26. and including sign language interpreters and we're now going to
- 27. say that...that we're going to get the doctors involved in the
- 28. Special Education system that we provide to our children. I have
- 29. opposed this bill from the start and I continue my opposition.
- 30. PRESIDING OFFICER: (SENATOR BRUCE)
- 31. Further discussion? Senator Davidson. Senator Davidson on this.
- 32. Did you seek recognition on 393?
- 33. SENATOR DAVIDSON:

- 1. I did but I'll yield to Senator Berman because he's going
- 2. to make the statement in the closing argument in relation to
- 3. any other section of the Statutes.
- 4. PRESIDING OFFICER: (SENATOR BRUCE)
- 5. Is there further discussion? Senator Mitchler.
- 6. SENATOR MITCHLER:
- 7. Mr. President and members of the Senate. Senator Buzbee
- 8. just made a statement that this is a program mandated by the
- 9. Federal Government without money following. Are we mandating
- 10. this on the local school districts without providing the necessary
- 11. funding from the State?
- 12. PRESIDING OFFICER: (SENATOR BRUCE)
- 13. Senator Berman.
- 14. SENATOR MITCHLER:
- 15. ...you answer that, Senator Berman or Senator Buzbee?
- 16. SENATOR BERMAN:
- 17. Senator Mitchler, this bill being one of a package of five
- 18. bills has been worked out with the local school board association,
- 19. with local administrators, with parents of handicapped children,
- 20. with the handicapped children associations, with the whole
- 21. spectrum of the handicapped and non-handicapped education
- 22. community. They are all in agreement with and in support of
- 23. the passage of these bills, 393 included. As far as the funding
- 24. is concerned, in the categorical grant bill there is an
- 25. appropriation for thirty-six million dollars of Federal money
- 26. that will be coming into Illinois to fund this and it is the
- 27. estimate of IOE that that level of funding will be sufficient
- 28. to pay all of the costs imposed upon by the State and the formula
- 29. that has been worked out with the local school boards regarding
- 30. the obligations of this Federal program which we are required to
- 31. comply with.
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- 33. Senator Mitchler.

- 1. SENATOR MITCHLER:
- That's a very good explanation, Senator Berman. I appreciate
- 3. your explaining it to me and I'm...I'm going to understand that
- 4. the Federal Government is providing the necessary Federal funds
- 5. that will be coming into Illinois and we, in turn, for the
- 6. categorical grants are providing them to the local school
- 7. districts and therefore, this in no way will reflect a cost
- 8. burden on the local school districts that they have to pay through
- 9. their local real estate taxes. Now is that correct?
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 11. Senator Berman.
- 12. SENATOR BERMAN:
- 13. I'm not sure how to answer your question and let me tell you
- 14. why. It goes back to the basic explanation of what the Federal
- 15. Government has done and what we are required to do in order to...
- 16. provide an equal educational opportunity for all handicapped
- 17. children in Illinois. This morning we passed out of this Body...
- 18. I'm sorry, yesterday morning...three of the five bills involved
- 19. in this package. This bill probably has no cost or minimal cost
- 20. implications. I mean this is not one of the biggies. The biggies
- 21. have already gone out. As a matter of fact, the next bill up
- 22. is the one that helps the local districts in meeting the obligations.
- 23. Now if you want, I'll be glad to go into a full explanation of the
- 24. funding mechanisms of this package of bills but I'm not sure it's
- 25. really relevant to 393. I'll...I'll leave that up to you, Senator.
- 26. PRESIDING OFFICER: (SENATOR BRUCE)
- 27. Senator Mitchler: Further discussion? Senator Wooten.
- 28. SENATOR WOOTEN:
- 29. Senator Mitchler, I think there is... Senator Mitchler, I
- 30. think there's another answer to that. Congress has appropriated
- 31. no money for this program. None. We're supposed to be getting
- 32. some Federal money in here in a general sense, but no money and
- 33. further, I believe, that if they ever do get around to appropriating

- 1. money for this they'll pay up to fifty percent of the costs. That's
- 2. as I understand it, that's it. This is an enormous burden on the
- 3. State because now we will have to pick up one hundred percent of
- 4. the cost. Congress in its generosity mandated the program but
- 5. neglected to back it up with any money and until they do I think
- 6. we ought to just wait until they're ready to...to second their
- 7. words with some substantial financial deeds. Also I just wanted
- 8. to check that...2nd amendment says that I only have the digest
- 9. here that medical services and diagnostic programs must be
- 10. handled by doctors licensed to practice medicine and all of its
- 11. branches. Does that mean all diagnostic tests must be conducted
- 12. by doctors? All tests?
- 13. PRESIDING OFFICER: (SENATOR BRUCE)
- 14. Senator Berman.
- 15. SENATOR BERMAN:
- 16. The purpose of this bill is to indicate that when a child
- 17. is to be evaluated for placement in Special Education Services
- 18. that...diagnosis and evaluation shall be done by a physician
- 19. licensed to practice medicine in all its branches. Now the
- 20. purpose of this...this being put into our School Code is so that
- 21. if that is done that cost can be reimbursed under the other sections
- 22. and other obligations imposed on State...State agencies for the
- 23. handicapped children and while I've got the microphone, Senator
- 24. Wooten, your statement regarding no Federal money is absolutely,
- 25. positively false. I don't know where you've gotten your
- 26. information but last year Illinois got...fourteen million dollars
- 27. and this year we'll get thirty million dollars for funding under
- 28. 94-142. I don't know where in the world you come up with no
- 29. Federal money.
- 30. PRESIDING OFFICER: (SENATOR BRUCE)
- 31. Senator Wooten.
- 32. SENATOR WOOTEN:
- 33. I thought I got that information from you when we first debated

- 1. this bill. While...
- 2. PRESIDING OFFICER: (SENATOR BRUCE)
- 3. Senator...
- 4. SENATOR WOOTEN:
- 5. ... I have the mike, let me expand a little bit
- 6. on my question about the doctors. In the Evaluative Services
- 7. do you mean, for example, if such evaluation has to do with
- 8. things like hearing and vision and so on that a medical doctor
- 9. must conduct that evaluation or that a medical doctor is in charge
- 10. and farms this out to other specialists. How exactly is that
- 11. to work? Why is the medical doctor...precisely, why is he in
- 12. there? Is he to run the whole evaluation or must a medical
- 13. doctor conduct all evaluations including those that could be
- 14. done by a technician?
- 15. PRESIDING OFFICER: (SENATOR BRUCE)
- 16. Senator Berman.
- 17. SENATOR BERMAN:
- 18. I believe the last part of your question is the correct one.
- 19. This only indicates that if the services require a medical
- 20. diagnosis it must be done by a doctor. That doesn't limit the
- 21. usage of non-medical personnel in the...in the procedure. I...I'm
- 22. not sure...Is that your question? That...that's the answer if
- 23. that's your question.
- 24. PRESIDING OFFICER: (SENATOR BRUCE)
- 25. Senator Leonard.
- 26. SENATOR LEONARD:
- 27. I just had my question answered. Thank you.
- 28. PRESIDING OFFICER: (SENATOR BRUCE)
- 29. Further discussion? Senator Buzbee.
- 30. SENATOR BUZBEE:
- 31. Well, in response to Senator Mitcher's question earlier...
- 32. Senator Mitchler, in response...in response to your question
- 33. earlier concerning the costs, it's my understanding there are

- 1. some Federal dollars that will follow, however, not nearly sufficient
- 2. Federal dollars to fund these programs...to fund this program.
- 3. There will be a decided burden on the local school district, as
- 4. Senator Berman stated the next bill up in this package is the one
- 5. that puts the cap on how much the local school district has to
- 6. provide but they will have to provide quite a bit of money from
- 7. the local property tax and then on top of that the State is going
- 8. to have to provide one heck of a lot more money. There will not
- 9. be nearly enough adequate. There will not be nearly adequate
- 10. funds from the Federal Government to fund these required
- 11. programs. That has been my opposition to the...this legislation
- 12. which implements Public Law 94-142 all along. As the Feds tell
- 13. us what to do then they don't give us the money to do it and so
- 14. I have been opposed to this package from the very inception...from
- 15. its very inception and I continue my opposition.
- 16. PRESIDING OFFICER: (SENATOR BRUCE)
- 17. Is there further debate? Senator Berman may close...Senator
- 18. Berning.
- 19. SENATOR BERNING:
- 20. Yes, Mr. President, just one question to Senator Buzbee and/
- 21. or Senator Berman. What option do we have? Do we have any option?
- 22. Are we not under the gun? Have we not a Federal mandate over our
- 23. heads, despicable and reprehensible as it is, what is the end
- 24. result if we don't take this action, is what is concerning me
- 25. in my school districts who ask that we...that I support this
- 26. package of bills because they find themselves in the position
- 27. of a Federal mandate and they're concerned about how to meet it
- 28. without the implementing legislation here. Do we have an option?
- 29. PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Berman.
- 31. SENATOR BERMAN:
- 32. Do you want to respond?
- 33. PRESIDING OFFICER: (SENATOR BRUCE)

- 1. Senator Buzbee.
- 2. SENATOR BUZBEE:
- I would only say, Senator Berning, that Senator Berman andI probably disagree on the answer to that question. I think that
- 5. he would probably agree with the conclusion that you had already
- 6. reached even though you asked a question for information and then
- 7. reached your conclusion before you got the answer. His response
- 8. would probably be that he agrees with you. I say that we take
- 9. the stance of telling the Feds to go stick their programs. We
- 10. know how to run our educational systems in the State of Illinois.
- 11. We provide the money and we'll just fight it out in the courts.
- 12. Of course, what they've held over our heads is the threat of the
- 13. loss of all Federal funds and all educational programs, not only
- 14. because of the enactment of Federal Law, Public Law 94-142 but
- 15. also because of the Section 504 of the Civil Rights Act that they
- 16. say that we will be in noncompliance and therefore, they're
- 17. going to cut off of our Federal funds for education and perhaps,
- 18. even further and the fact...the fact is in the past the Feds have
- 19. threatened many times to withhold Federal funds from us including
- 20. the famous highway safety thing when they...they mandated the
- 21. wearing of helmets for motorcycle riders. When the State of
- 22. Illinois said we're not going to comply with your request they
- 23. did not withhold those funds. I submit that we ought to tell
- 24. the Feds you're not going to tell us how to run our State
- 25. educational system, especially when you don't provide the funds
- 26. to do it and, therefore, we be in noncompliance. Let them try
- 27. to withhold the funds and we can fight it out in the courts.
- 28. Otherwise we're going to be this is just a drop in the bucket
- 29. this year. Next year and...it's going to be a geometrical
- 30. progression. We're going to continue...it will go on and on and
- 31. on in...in having to pay for these programs and by the way, it's
- 32. not exactly as though we're not doing anything in Illinois for
- 33. the children who meet the...meet the definition of Special Education

- 1. because we're spending close to a quarter of a billion dollars.
- 2. Close to a quarter of a billion dollars by line item for Special
- 3. Education in the State of Illinois already. That's at the State
- 4. level. That does not include the local support that's provided
- 5. by the local property taxpayer. That does not include the amount
- 6. of monies that are provided by the State for...in the General
- 7. Distributive Formula which will be the supportive money that
- 8. goes underneath that whole educational system so I submit that
- 9. we ought to tell Congress and HEW that we'll run our educational
- 10. system. We'll provide the funding. We'll provide the mandates
- 11. if there's going to be any but Congress, you don't tell us how
- 12. to do it.
- 13. PRESIDING OFFICER: (SENATOR BRUCE)
- 14. Further discussion? Senator Berning. Senator Berning.
- 15. SENATOR BERNING:
- 16. My initial reaction is essentially identical with Senator
- 17. Buzbee's but I submit that unless we are willing to go all the
- 18. way, Senator, including every other kind of Federal fund
- 19. designation and I would be happy to join you. Title I, Title XX,
- 20. Motor Fuel, anything else if we, the...General Assembly of the
- 21. State of Illinois would stand up and say from here on out we're
- 22. going to run our own affairs and if the Federal Government is
- going to withhold funds on the basis of our own initiative sobeit.
- 24. We'll still run our own affairs. We might very well, Senator,
- 25. we might very well initiate the same kind of popular reaction and
- 26. popular support that...California has done with its Proposition
- 27. 13 and perhaps the time is here when we ought to be saying to
- 28. the Federal Government you run your affairs, we'll run ours.
- 29. Leave us alone. I'm willing to join you if you go that far.
- 30. PRESIDING OFFICER: (SENATOR BRUCE)
- 31. Further discussion? Senator Berman.
- 32. SENATOR BERMAN:
- 33. I think it's quite interesting, Mr. President, that Gentlemen

     like Senator Buzbee want to...take a stand in the courthouse
 2.
     door when it comes to a mandate that we have recognized since
 3.
     1969 and have done a very fine job in this State and that is
4.
     to provide an opportunity for handicapped children to get an
5.
     education. I didn't hear that argument when it came to turning
     down the Federal Government for road funds. I didn't hear that
6.
7.
     argument when it comes down to taking a stand on every other
     bit program that the Federal Government tells us to do.
8.
     quick to...to subcribe to their policies and to take their money
9.
     but Senator Buzbee and others want us to take the stand when
10.
     this is merely a recognition of something that Illinois is
11.
     already doing and that is to give an opportunity for an education
12.
     to our handicapped children. This is not a great new program.
13.
     This is a program that we've been doing for years and we've been

     doing it proudly. These are minimal changes in the program that

     Illinois has already undertaken. This package of bills, of which

     393 is one of them and three of which already were passed out
17.
     with votes and I believe there were over fifty votes on each

- 2. that the language that is in this Section, 14-108 and Senate Bill
- 3. ...393 is not to be construed as a precedent in this language
- 4. for any other section of the School Code. Accordingly, Mr.
- 5. President, I ask for an affirmative vote on Senate Bill 393.
- 6. PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Leonard.
- 8. SENATOR LEONARD:
- 9. Yes, you know I...I would like a...I'd like a chance to
- 10. speak.
- 11. PRESIDING OFFICER: (SENATOR BRUCE)
- 12. Wait a minute. Hold on now. Now just...let's have a
- 13. little order.
- 14. SENATOR LEONARD:
- 15. I've...
- 16. PRESIDING OFFICER: (SENATOR BRUCE)
- 17. ...Wait. Senator Leonard, if you'll hold one moment so
- 18. that the confusion can be erradicated. Senator Berning asked
- 19. a question and Senator Berman closed thinking that that was closing
- 20. argument as opposed to answering any question of Senator Berning.
- 21. To Senator Vadalabene, Senator Leonard has been on my list since
- 22. before Senator Buzbee rose to speak. You are on my list after
- 23. Senator Leonard. Senator... Vadalabene, for what purpose do you
- 24. arise?
- 25. SENATOR VADALABENE:
- 26. Senator Leonard said his question had been answered when
- 27. Senator Wooten got up.
- 28. PRESIDING OFFICER: (SENATOR BRUCE)
- 29. And he rose again, Senator, to speak.
- 30. SENATOR VADALABENE:
- 31. And I wanted to speak before Senator Berman closed.
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- 33. I did not know that Senator Berman was going to close. That's



- 1. what I tried to explain to you...
- 2. SENATOR VADALABENE:
- 3. 'Cause there's been some allegations made...Senator Berman
- 4. has done some hard work on this legislation and he wanted to know
- 5. where Senator Wooten got all his information which we said was
- 6. wrong. He said Senator Buzbee's information was wrong and I think
- 7. we who want to vote on this legislation should get the facts and
- 8. not what they think.
- 9. PRESIDING OFFICER: (SENATOR BRUCE)
- 10. Now, Senator Leonard.
- 11. SENATOR LEONARD:
- 12. Okay. I won't take long. I passed the time before because
- 13. my question had been answered. Another issue has arisen here.
- 14. This is not a question between the State and the Federal Govern-
- 15. ment. This is a question of Special Education and should we
- 16. require a medical diagnosis. That makes good sense. It's good
- 17. procedure. The easiest cases to solve are those we can solve
- 18. medically. Every child that comes in ought to be examined by a
- 19. physician because they can be treated medically. It's simple.
- 20. We don't have to keep them in Special Education. It is good
- 21. procedure and that's why we ought to support it.
- 22. PRESIDING OFFICER: (SENATOR BRUCE)
- 23. Further discussion? Senator Vadalabene. The question is,
- 24. shall the Senate adopt the Conference Committee Report to Senate
- 25. Bill 393. Those in favor vote Aye. Those opposed vote Nay. The
- 26. voting is open. Have all voted who wish? Have all voted who wish?
- 27. Take the record. On that question, the Ayes are 50, the Nays
- 28. are 6, none Voting Present. The Senate does adopt the Conference
- 29. Committee Report on Senate Bill 393 and the bill having received
- 30. the required constitutional majority is declared passed. Conference
- 31. Committee Report on Senate Bill 395. Senator Berman is recognized.
- 32. SENATOR BERMAN:
- 33. Thank you, Mr. President. I'm going to make my explanation

- 1. short because I think that roll call was in line with the votes
- 2. that we passed out yesterday. This is the bill that the school
- 3. boards in your districts are very interested in. It puts a cap
- 4. on their exposure for the costsof Special Education under these
- 5. programs. The only changes that the Conference Committee Report
- 6. made was in technical language concerning the...the Governor's
- 7. purchase of Care Review Board which is in this bill. The amend-
- 8. ments that are in here are in response. They were put on in the
- 9. House on response to requests that came from the Governor's Office.
- 10. We have complied with their requests. This bill is in...essentially
- 11. the same shape formula wise as it left the Senate and the changes
- 12. were in order to comply with requests from the Governor's Office
- 13. in order to smoothly operate the funding...proposals of 94-142
- 14. and this package of Special Education bills. I solicit your Aye
- 15. vote.
- 16. PRESIDENT:
- 17. Is there any discussion? Senator Davidson.
- 18. SENATOR DAVIDSON:
- 19. Yes, Mr. President and members of the Senate. I rise in
- 20. support of this Conference Committee Report. It was sent from...
- 21. when we had it here...sent it back to Conference Committee to
- 22. correct a technical error. The thing that most school districts
- 23. ...all school districts that communicated me are particularly
- 24. interested in this 'cause this puts a lid on and the amendment
- 25. in the House that was written was so that an audit could be
- 26. asked and required if the private facility was doing what they
- 27. were charging for. This allowed it to be done. It was in the
- 28. wrong order when it went in in the amendment. This is a good
- 29. bill. I'd recommend a Yes vote.
- 30. PRESIDENT:
- 31. Senator Buzbee.
- 32. SENATOR BUZBEE:
- 33. Thank you, Mr. President. I am being completely consistent

- 1. with what I did in the past when it became obvious to me that
- 2. the package of bills was going to pass. I did vote for 395 then
- 3. and I plan to now because as Senator Davidson just said and
- 4. Senator Berman this does put a cap on the local districts' costs.
- 5. The State is going to have to pick up the difference. I would
- 6. much prefer the State pick up the difference over the local...local
- 7. districts and even though I am still adamantly opposed to the
- 8. imposition of 94-142 on the taxpayers of Illinois this is a method
- 9. of putting a cap on what the local property taxpayers are going to
- 10. have to pay to provide those services and I do support this bill.
- 11. PRESIDENT:
- 12. Any further discussion? Senator Berman may close the debate.
- 13. SENATOR BERMAN:
- 14. Roll call.
- 15. PRESIDENT:
- 16. The question is, shall the Senate adopt the Conference Committee
- 17. Report on Senate Bill 395. Those in favor will vote Aye. Those
- 18. opposed will vote Nay. The voting is open. Have all voted who
- 19. wish? Have all voted who wish? Take the record. On that question,
- 20. the Ayes are 56, the Nays are None, none Voting Present. The
- 21. Senate does adopt the Conference Committee Report on Senate Bill
- 22. 395 and bill having received the required constitutional majority
- 23. is declared passed. If I may have your attention there is one
- 24. additional Conference Committee Report that a member has requested
- 25. that we call and then we will go to the two reports on the
- 26. Constitutional Amendments that we...that we adopted and approved
- 27. for submission to the voters and then we will adjourn. On the
- 28. Secretary's Desk is a Conference Committee Report on Senate Bill
- 29. 1792. Senator Guidice.
- 30. SENATOR GUIDICE:
- 31. Thank...thank you, Mr. President and members of the Senate.
- 32. I would move to accept the First Conference Committee Report
- 33. regarding House...Senate Bill 1792. What we did in the conference

- 1. was to put back the language we had in the original bill regarding
- 2. the number of members that would be on the Fair Plan Board. That it
- 3. would be a nine member board now with four consumer advocates on
- 4. that board. The House Amendments 1 and 4, 1 was cleanup language
- 5. and 4 was the adaptation of the availability of homeowners insurance
- 6. under the Fair Plan. I would move to adopt that report.
- 7. PRESIDENT:
- 8. Is there any discussion? If not, the question is, shall the
- 9. Senate adopt the Conference Committee Report on Senate Bill 1792.
- 10. Those in favor will vote Aye. Those opposed will vote Nay. The
- 11. voting is open. Have all voted who wish? Have all voted who wish?
- 12. Take the record. On that question, the Ayes are 51, the Nays are
- 13. 5, 1 Voting Present. .The Senate does...adopt the Conference Committee
- 14. Report on Senate Bill 1792 and the bill having received the re-
- 15. quired constitutional majority is declared passed. (Machine cutoff)
- 16. the Secretary's Desk is the report of the joint committee on the
- 17. proposed constitutional amendment regarding the...Personal
- 18. Property Tax, House Joint Resolution and Constitutional Amendment
- 19. 21. Senator Maragos.
- 20. SENATOR MARAGOS:
- 21. Mr. President and members of the Senate. Pursuant to House
- 22. Joint Resolution 94 which was adopted by this Body as well as the
- 23. House. A joint committee was created, one of which is for the
- 24. Personal Property Tax Amendment and there was...the report stated
- 25. there would be two committees and the resolution said there would
- 26. be two committees to proceed, study and give their reports as to
- 27. how this Constitutional Amendment No. 21 Resolution will appear
- 28. on the ballot in November. The report has been passed out to all
- 29. the members of this Body several days ago and it has fully been
- 30. adopted by the House and since there was a House Joint Resolution and
- 31. the report as it is on your desks and which gives both arguments
- 32. of the pros and cons and which also gives an explanation of the
- 33. proposed amendment as that is going to be on the ballot and the

- 1. actual proposed amendment to be voted on is all before you.
- 2. This Senate several weeks ago adopted several joint resolution
- 3. constitutional amendments that we withdrew that now we have
- 4. before us and they passed for November consideration and referendum
- 5. House Joint Resolution No. 21. I urge your support of the report
- 6. of the joint committee for both pro and con and ask for your
- 7. support at this time.
- 8. PRESIDENT:
- 9. Senator Glass.
- 10. SENATOR GLASS:
- 11. Thank you, Mr. President and members of the Senate. I'm
- 12. rising to speak in opposition to this report and before I do
- 13. it I would ask if each member would find his and her copy of
- 14. this report and look at it and in particular take a look at the
- 15. form of the ballot. Now we are placing before the voters of
- 16. Illinois a very important constitutional amendment. We're asking
- 17. them to vote on whether to abolish the requirement or...that the
- 18. Personal Property Tax on corporations be abolished and replaced
- 19. by other taxes. It's...it's an extremely important amendment and
- 20. I submit to you that the form of this ballot is not going to
- 21. inform any of the voters what they are voting on. First of all,
- 22. take a look at the vote itself. It says simply Yes or No for the
- 23. proposed amendment to Section 5 of Article IX of the Constitution.
- 24. If you will then look at the explanation that will appear above
- 25. that and read it you will not find out what you're voting on until
- 26. you get to third paragraph if you can understand that language.
- 27. Now I think this is much too confusing. That we can do a better
- 28. job of explaining to the voter what the issue is. I...I don't
- 29. think the voters are going to be informed at all on what they're
- 30. voting on with this explanation and this form of the ballot and
- 31. I would, therefore, urge a No vote on this motion and force the
- 32. committee to come up with a clearer explanation.
- 33. PRESIDENT:

- Senator Guidice.
- 2. SENATOR GUIDICE:
- 3. Thank you, Mr. President. Just a point of information regarding
- 4. this particular matter that I was the...the Chairman of the
- 5. opponents on this particular piece of...on this particular
- 6. resolution. According to the Constitution, what appears in that
- 7. box is what we have to put in the box. There were three different
- 8. versions that were submitted to both the...the pro committee and
- 9. the opponents. I think this is probably the worst of the three.
- 10. I think the second version which should be the one that we
- 11. adopt because it would make clear exactly what the people, in
- 12. fact, would be voting for so I, too, would ask as Senator
- 13. Glass asked to take a look at that and possibly look at the
- 14. second version there too.
- 15. PRESIDENT:
- 16. Senator Maragos.
- 17. SENATOR MARAGOS:
- 18. Mr. President, at this time...as each member arises to speak
- 19. on the report I would like to get...receive from them another...
- 20. a statement to the Body whether they are for the adoption of
- 21. the referendum and the constitutional amendment or not. I think,
- 22. therefore, we know where they come from and when they are speaking
- 23. on the issue and, therefore, we understand what their reasons
- 24. for the opposition may be. Do you understand me 'cause they're
- 25. like...I don't know whether Senator Glass is going to be...is
- 26. speaking eventually for the adoption...of the referendum and
- 27. adopting the constitutional amendment in...in November or not and
- 28. I think we...that's the basis upon which we can make a better
- 29. judgment.
- 30. PRESIDENT:
- 31. Senator Mitchler:
- 32. SENATOR MITCHLER:
- 33. Yes, Mr. President and members of the Senate. I'd like to have

- 1. a clarification if...if the language contained in the report is
- 2. contrary to what a member believes should be in the proposition
- 3. as it's put to the people...rather to the Secretary of State to
- 4. be put out to the people, is it proper to introduce an amendment
- 5. through the Secretary to the report? Is that done at this time?
- 6. We don't have these questions before us at all times but in the
- 7. event that a member objected to some language in the report which
- 8. is actually the language that we're going to transmit to the
- 9. Secretary of State to be printed and sent out to every registered
- 10. voter. Now, is it at this time that we should submit amendments
- 11. to the report and how is that done?
- 12. PRESIDENT:
- 13. Senator, the...the procedure that the Chair intends to follow
- 14. is that the report will be voted up or down as it is.
- 15. SENATOR MITCHLER:
- 16. Thank you, Mr. President. I...I just want to put that in-
- 17. to clarification. I certainly concur with the ruling of the
- 18. Chair in that respect. I am going to support the report of the
- 19. proposed constitutional amendment and this is the reason that I
- 20. am going to support it. I'm not really concerned about the
- 21. language in the arguments for and against unless there was
- 22. language in there that was absolutely in error but the arguments
- 23. for and against could be debated and debated and debated but the
- 24. whole idea of whether this proposition and the following
- 25. proposition that are going to be put to the electorate on
- 26. November 7 of this year is how the propositions are treated by
- 27. organizations throughout the State, how they're treated by the
- 28. news media and what support they garner between the time the
- 29. information is put out to the people and the time they vote
- 30. because just stop and think. How many people really knew what
- 31. they were voting on when they voted either for or against the new
- 32. 1970 Illinois Constitution? They bought a pig in a poke. That's
- 33. what they bought. Otherwise there wouldn't have been fifty-six

- 1. amendments introduced already in the House and the Senate during
- 2. this 80th Illinois General Assembly. I apologize and I would
- 3. reword my statement they bought a chicken in the poke so I think
- 4. we ought to adopt this and get on with the business and then go
- 5. out and either sell or defeat the proposition, however you or
- 6. your organization will see fit and it's going to be interesting
- 7. to watch again which of the State organizations are for and
- 8. which are against. I still got a record of those that were for
- 9. and those that were against the new Constitution and every now
- 10. and then I review them and chuckle. Thank you.
- 11. PRESIDENT:
- Senator Wooten.
- 13. SENATOR WOOTEN:
- 14. Mr. President and colleagues. I am not sure what other
- 15. language we should use but as one who has spend his adult years
- 16. in television and media work and I've done an awful lot of survey-
- 17. ing and I know that no matter how good a campaign you launch across
- 18. the State you're going to get a significant, a significant
- 19. proportion of people going to these polls knowing absolutely
- 20. nothing about these propositions. I submit that it is extremely
- 21. important that this thing pass and if we can put some language
- 22. that is just a little bit clearer than this for the proposed
- 23. amendment to Section 5 of Article IX of the Constitution, is there
- 24. not some language we could put there to give someone a hint as to
- 25. what this is all about? Some Constitutional lawyers are saying
- 26. that even if this doesn't pass we can still get that local tax
- 27. but you know darn good and well it's going to be tied up in court
- 28. cases. We could cripple our units of local government if this
- 29. doesn't pass and if there is some way to make it a little clearer
- 30. in what may be the only thing the voter will see about this, I'm
- 31. all for it. Quite frankly, I don't know what else we can do but
- 32. I would certainly like to be enlightened because I'm afraid for
- 33. a significant number of voters that will be the only thing they

- 1. see or know about this proposition.
- 2. PRESIDENT:
- Senator Rhoads.
- 4. SENATOR RHOADS:
- 5. Thank you, Mr. President and members of the Senate. First
- 6. of all, Mr. President, on a point of parlimentary inquiry, please.
- 7. PRESIDENT:
- State your point.
- 9. SENATOR RHOADS:
- 10. Mr. President, we have on our desks a report labeled MH-
- 11. 1316 from the Clerk of the House. It is a report that I did
- 12. not sign and there are no signatures on the report. Can the
- 13. Secretary inform us who signed the report and how many signatures
- 14. are necessary for this report to be...acted upon?
- 15. PRESIDENT:
- 16. Yeah, MH-1316 is a Message from the House. Senator Maragos.
- 17. A question has been asked of the Chair how many members of the
- 18. joint committee for the Personal...for in favor of the Personal
- 19. Property Tax Amendment, in fact, signed the report?
- 20. SENATOR MARAGOS:
- 21. The report before the Secretary Desk should show that. I
- 22. think there's at least seven...
- 23. PRESIDENT:
- 24. No. All the Secretary has on his Desk is a Message from
- 25. the House which does not contain any signatures.
- 26. SENATOR MARAGOS:
- 27. They all signed it to my knowledge.
- 28. PRESIDENT:
- 29. (Machine cutoff) I've got a copy at my desk. Senator
- 30. Maragos.
- 31. SENATOR MARAGOS:
- 32. I can verify that every member of the Committee for the...for
- 33. the proposition on this committee voted...signed it. I don't know

- 1. what the opponents to that did.
- 2. PRESIDENT:
- All right. Senator Rhoads.
- 4. SENATOR RHOADS:
- 5. Thank you, Mr. President and members of the Senate. As
- 6. Senator Maragos stated, I was on the committee in opposition
- 7. ...for writing the argument. I did vote against the bill. I
- 8. am in opposition to it and that, frankly, was our role,
- 9. Senator Maragos, to write the arguments in opposition. Now
- 10. I'm rising in opposition to this report at this time for the
- 11. same reasons stated by Senator Guidice and Senator Glass.
- 12. Number one is that the form of the ballot is misleading and gives
- 13. absolutely no information. Now I will agree with you, Senator
- 14. Maragos, that the Constitution and the Statutory Law which
- 15. governs this is rather vague and doesn't require us to put any
- 16. more information than what we have contained in this report.
- 17. But the second point that Senator Glass mentioned is even more
- 18. important which is that you have to read to the third paragraph
