- 3. Bill 339. Senator Nimrod.
- 4. SENATOR NIMROD:
- 5. Yes, thank you, Mr. President. I just wanted to say one
- 6. thing to both you, Senator Hynes and all of the Senators that
- 7. I did have a chance to speak on this bill and discuss some
- 8. of the very important issues and I want us to know that there
- 9. was not adequate debate and certainly the information that was
- 10. given was not accurate. There are some very serious consequences
- 11. which we are unaware of and, in fact, what we have done here is
- 12. put the trust fund into some forty million dollars further into
- 13. debt and...and what...and what's happened in this particular
- 14. area is that we not only have...and not only is the trust fund
- 15. going to go deeper into debt for another...about approximate
- 16. forty million but there are some very serious nonconformity
- 17. requirements that were put into this. I think we have done this
- 18. a very serious injustice and to cut off debate it takes two-
- 19. thirds of the vote of this Senate and you did not even acknowledge
- 20. that...to cut...to be able to cut off this debate. I think that
- 21. the information has not been disseminated. The facts are not
- 22. known about this and, in fact, there are some untruths that
- 23. have been said about this particular bill in its present...
- 24. posture.
- 25. PRESIDING OFFICER: (SENATOR ROCK)
- 26. All right. The Conference Committee Report with respect
- 27. to House Bill 3392. Senator Ziomek.
- 28. SENATOR ZIOMEK:
- 29. Yes, Mr. President, I move to have a second conference
- 30. committee appointed.
- 31. PRESIDING OFFICER: (SENATOR ROCK)
- 32. The question is, shall the Senate accede to the request of
- 33. the House that a second conference committee be appointed. All

- 1. in favor signify by saying Aye. Opposed. The Ayes have it.
- 2. The motion carries and the Senate does accede to the request.
- 3. Senator Rhoads, for what purpose do you arise?
- 4. SENATOR RHOADS:
- 5. Mr. President, I move that the Senate stand adjourned
- 6. until 10:00 a.m. tomorrow morning.

- 8. made the pay plan reduction of eight thousand two hundred dollars.
- 9. Number three, the council's appropriation be increased some
- 10. ninety thousand nine hundred...nine hundred dollars which consisted
- 11. of the following. Twenty-two thousand dollars for two new
- 12. positions. One thousand six hundred dollars for retirement. One
- 13. thousand three hundred dollars for social security and sixty-six
- 14. thousand dollars for printing of the House and Senate Calendars
- 15. next Session. Number four was to remove the fifty percent
- 16. limitation of the Amendment No. 1 from the equipment and I ask
- 17. that a favorable vote be had on that report.
- 18. PRESIDING OFFICER: (SENATOR ROCK)
- 19. Is there any discussion? The question is, shall the Senate
- 20. adopt the Conference Committee Report on House Bill 2851. Those
- 21. in favor will vote Aye. Those opposed will vote Nay. The voting
- 22. is open. The Chair would point out that it is after midnight and
- 23. ...three-fifths affirmative vote will be required. Have all
- 24. voted who wish? Have all voted who wish? Take the...take the

- 28. A Message from the House by Mr. O'Brien, Clerk.
- 29. Mr. President I am directed to inform the
- 30. Senate the House of Representatives refused to adopt
- 31. the First Conference Committee Report on Senate Bill 1672
- 32. and request a Second Committee of Conference to consider the
- 33. difference between the two Houses in regards to Amendments

- 1. Numbers 1, 2, 3, 4, 6, 7, 8, 9, 10, 11, 12, 13 and 15.
- 2. The Speaker has appointed the members on the part of
- 3. the House.
- 4. PRESIDENT:
- Senator Shapiro...moves to accede to the request
- 6. of the House that a Second Conference Committee be
- 7. appointed as to Senate Bill 1672. All those in favor
- 8. of the motion signify by saying Aye. Opposed. The
- 9. Ayes have it. The Senate accedes to the request of
- 10. the House that a Second Conference Committee be
- 11. appointed as to Senate Bill 1672. For what purpose does
- 12. Senator Harber Hall whistle?
- 13. SENATOR HARBER HALL:
- 14. Mr. President, I would...I would like the record
- 15. to show that at 3:20 a.m. on July 1st, at this time,
- 16. Mr. President, I make the point that I have just
- 17. returned from a Second Conference Committee in respect
- 18. to House Bill 3177. To my knowledge, Mr. President,
- 19. at this time there has not been appointed by the leader-
- 20. ship of the Senate a Second Conference Committee on
- 21. that bill. And I want that record to be noted.
- 22. PRESIDENT:
- 23. Well, the record will reflect that insofar as
- 24. your knowledge is concerned that it hasn't been appointed.
- 25. There may be others that have information to the contrary.
- 26. Senator Hall.
- 27. SENATOR HARBER HALL:
- 28. Well, I placed myself on record as saying this and if
- 29. ... I was on the committee that was called, but I don't
- 30. see any indication that I should be on the Second. Has that
- 31. been printed? Has it been read into the record that a
- 32. Second Conference Committee would be called?
- 33. PRESIDENT:

- Yes, it has:
- SENATOR HARBER HALL:
- 3. And have you issued those...
- 4. PRESIDENT:
- Yes, it has.
- 6. SENATOR HARBER HALL:
- 7. ...announcements of who would be on it?
- 8. PRESIDENT:
- 9. As I understand it, they have been...appointed.
- 10. SENATOR HARBER HALL:
- 11. As you understand it, Mr. President. Would I have
- 12. been on it?
- 13. PRESIDENT:
- 14. I don't recall the names of the members and I don't
- 15. appoint the members from your side of the aisle.
- 16. SENATOR HARBER HALL:
- 17. Well, there's no record that either of the Republican
- 18. members in the Senate were appointed.
- 19. PRESIDENT:
- 20. It may be that the paper work hasn't caughten up
- 21. with the activity...hasn't caught up with the activity
- 22. that is going on.
- 23. SENATOR PHILIP:
- 24. Thank you, Mr. President. Parliamentary inquiry.
- 25. I'm on a Conference Committee for Senate Bill 1725. If
- 26. we don't make any report, what happens to it?
- 27. PRESIDENT:
- 28. It's...it...it is in limbo.
- 29. SENATOR PHILIP:
- 30. Well, I...I would ask that would be put on the
- 31. fall Calendar then, if that's in order.
- 32. PRESIDENT:
- Well, it would...it would stay in limbo until the fall.

- 1. If you want to file a report then it would stay there.
- 2. SENATOR PHILIP:
- 3. If I were to file a report, it would stay where?
- 4. PRESIDENT:
- 5. It...it would then stay on the Secretary's Desk,
- 6. where you file the report. A Conference Committee is
- 7. a...a metaphysical being, insofar as the Legislature
- 8. is concerned, it's in existence, but it's...located in
- 9. any particular place, but it is still alive and...and
- 10. here.
- 11. SENATOR PHILIP:
- 12. All right, thank you.
- 13. PRESIDENT:
- 14. What purpose does Senator Lemke arise?
- 15. SENATOR LEMKE:
- 16. Well if we're in a lull, I have a House Joint Resolution
- 17. 99 of Boris Antonovych, could we move to have that adopted?
- 18. PRESIDENT:
- 19. ...Lemke, Senator Lemke, we will get to that...in
- 20. a moment if you don't mind. Senator Lemke on House
- 21. Joint Resolution 99. Would you explain the resolution,
- 22. Senator. On the Secretary's Desk.
- 23. SENATOR LEMKE:
- 24. What the resolution does is sets up a committee
- 25. called the Ethnic Heritage Festival Committee. And the
- 26. committee will have two House members from each side of
- 27. the aisle and two Senate members from each side of the
- 28. aisle. And three public members from each side of the
- 29. aisle in the House and from the Senate. No money.
- 30. PRESIDENT:
- 31. Is there any further discussion? Senator Rhoads.
- 32. SENATOR RHOADS:
- 33. Well, I have to speak in favor of this resolution.

- 1. Not because I'm convinced of the merits, but because I'm
- 2. in Representative Antonovych's tank and...I...I think we
- 3. all ought to vote for this, it's good resolution.
- 4. PRESIDENT:
- 5. Is there any further discussion? If not, Senator
- 6. Lemke moves the adoption of House Joint Resolution 99.
- 7. All those in favor signify by saying Aye. Opposed. The
- 8. Ayes have it. The resolution is adopted. On the Secretary's
- 9. Desk is a Conference Committee Report on House Bill 3276.
- 10. Senator Coffey.
- 11. SENATOR COFFEY:
- 12. Mr. President, I would like to ask the...members of
- 13. the Senate to concur with the Conference Report which
- 14. the House concurs with Senate Amendments 3 through 29.
- 15. The Senate recedes from Senate Amendments 1 and 2 and
- 16. the House further amends and adds back the operations
- 17. that was cut out originally and cuts...leaves a total
- 18. cut in operations of one million, four hundred and
- 19. seventy-eight thousand. Further it lump sums all the
- 20. Series B Fund Bonds and also adds one pork project for
- 21. twenty-nine thousand dollars back in the bill. I would
- 22. ask this Body to concur with this report. The Department
- 23. of Transportation...this is a Department of Transportation
- 24. Bill on...on House Bill 3276.
- 25. PRESIDENT:
- 26. Senator Carroll.
- 27. SENATOR COFFEY:
- 28. And that was...amendment.
- 29. SENATOR CARROLL:
- 30. ...Just to answer everyone's questions, Mr. President
- 31. and members of the Senate, this is as loaded with chicken
- 32. as you can get.
- 33. PRESIDENT:

- 1. Is there any further discussion? If not, the question
- is shall the Senate adopt the Conference Committee Report
- 3. on House Bill 3276. Those in favor will vote Aye. Those
- 4. opposed will vote Nay. The voting is open. Have all voted
- 5. who wish? Have all voted who wish? Take the record. On
- 6. that question the Ayes are 42, the Nays are 10, none Voting
- 7. Present. The Senate does adopt the Conference Committee
- 8. Report on House Bill 3276 and the bill having received the
- 9. required affirmative votes of three-fifths of the members
- 10. elected is declared...is declared passed and is effective
- 11. immediately upon its becoming a law. Secretary's Desk
- 12. and a Conference Committee Report on House Bill 3394.
- 13. Senator Shapiro. Department of Personnel and Business
- 14. and Economic Development. Senator Shapiro on the Floor?
- 15. Senator Regner asks leave to...move the adoption of the
- 16. Conference Committee Report. Is leave granted? Leave is granted.
- 17. SENATOR REGNER:
- 18. Mr. President...Mr. President and members of the
- 19. Senate. This contains Department of Personnel, it restores
- 20. from the original cuts taken, the Senate restores five-
- 21. hundred and twenty thousand dollars to the Department of
- 22. Personnel's Appropriation. The totals are hundred and eighty-
- 23. nine thousand .2 Personal Service, 15.8 Retirement, twelve
- 24. thousand Social Security and three hundred and three thousand
- 25. .3, restores fundings and various line items were deleted.
- 26. And I would move for the adoption of Conference...Conference
- 27. Committee Report Number 2 on House Bill 3394.
- 28. PRESIDENT:
- 29. Is there any discussion? If not, the question is shall
- 30. the Senate adopt the Conference Committee Report on House
- 31. Bill 3394. Those in favor will vote Aye. Those opposed
- 32. will vote Nay. The voting is open. ...wish? Have all

- 18. I would move to concur in all of the House Amendments.
- 19. And this is the new appropriation for Capital Expenditures.
- 20. PRESIDENT:
- 21. The question is shall the Senate concur in House Amend-
- 22. ments 1, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16,
- 23. 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 28, 30, 31, 33, 35
- 24. and 36 to Senate Bill 1601. Those in favor will vote
- 25. Aye. Those opposed will vote Nay. The voting is open.
- 26. ...voted who wish? Have all voted who wish? Take the
- 27. record. On that question the Ayes are 49, the Nays are 3,
- 28. 2 Voting Present. The Senate does concur in House Amend-
- 29. ments 1, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16,
- 30. 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 28, 30, 31, 33, 35
- 31. and 36 to Senate Bill 1601 and the bill having received
- 32. the required constitutional majority is declared passed.
- 33. And the bill having received the affirmative vote of

- 3. PRESIDING OFFICER: (SENATOR BRUCE)
- 4. The Senate will come to order. Conference Committee
- 5. Reports. House Bill 2981, Conference Committee Report.
- 6. Senator Nimrod is recognized.
- 7. SENATOR NIMROD:
- 8. Mr. President and Ladies and Gentlemen of the Senate.
- 9. This is the Illinois Arts Council and the Racing Board
- 10. Appropriation. Second...second report is the same as the
- 11. first and I would vote for a favorable roll call.
- 12. PRESIDING OFFICER: (SENATOR BRUCE)
- 13. Is there discussion? The question is shall the Senate
- 14. adopt the Conference Committee Report on House Bill 2981.
- 15. Those in favor vote Aye. Those opposed vote Nay. The
- 16. voting is open. Have all voted who wish? Have all voted
- 17. who wish? Take the record. On that question the Ayes

- 2. motion by Senator Rupp is to recede from Amendment No. 5.
- 3. The question is shall the Senate recede from Amendment
- 4. No. 5 to House Bill 2979. Those in favor vote Aye. Those
- 5. opposed vote Nay. The voting is open. ...all voted who
- 6. wish? Have all voted who wish? Take the record. On that
- 7. question the Ayes are 44, the Nays are 4, 1 Voting Present.
- 8. The Senate recedes from Amendment No. 5 to House Bill
- 9. 2979 and the bill having received the required constitutional
- 10. majority is declared passed. And the bill having received
- 11. the affirmative votes of three-fifths of the members elected
- 12. is effective immediately upon its becoming a law.
- 13. SENATOR KNUPPEL:
- 14. Now is the time to vote.
- 15. PRESIDING OFFICER: (SENATOR BRUCE)
- 16. ...Does Senator Sangmeister arise?
- 17. SENATOR SANGMEISTER:
- 18. I was wondering if we're ready to go to the Order of
- 19. Motions yet? Do you think that we could have motions here?
- 20. PRESIDING OFFICER: (SENATOR BRUCE)
- 21. We're...we're going to take that up in the next Fiscal
- 22. Year. For what purpose does Senator Guidice arise?
- 23. SENATOR GUIDICE:
- 24. Privilege, Mr. President. I think we ought to congrat-
- 25. ulate those fine people in the Gallery who stuck with us
- 26. all night, thus far, I think they've...they've got a record
- 27. here. And they should...
- 28. PRESIDING OFFICER: (SENATOR BRUCE)
- 29. And...and the people behind us. And our apologies
- 30. for waking you up. For what purpose does Senator Vadalabene
- 31. arise?
- 32. SENATOR VADALABENE:
- 33. Yes, I would like to recognize George, who's been here

- 1. for the entire Session. George, how far do you live from
- 2. here? Stand up and get a round of applause, George.
- 3. PRESIDING OFFICER: (SENATOR BRUCE)
- 4. ... Ready to go to the Order of Resolutions? Leave
- 5. is granted. Resolutions, Mr. Secretary.
- 6. SECRETARY:
- 7. Senate Resolution 471 offered by Senator Hynes and
- 8. all Senators.
- 9. (Secretary reads SR 471)
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 11. Senator Hynes.
- 12. SENATOR HYNES:
- 13. Mr. President and members of the Senate. I would
- 14. move to suspend the rules for the immediate consideration
- 15. and adoption of the resolution. Senator Smith is doing
- 16. very well, in fact, so well that he wanted to come down
- 17. yesterday and today. I think had he been here he would
- 18. have been very sorry that he did come, but Mrs. Smith
- 19. and his doctor prevailed upon him and he did not. So
- 20. he is doing well and I thought that this would be a
- 21. fitting testimonial from the Senate for his many, many
- 22. years of wonderful service.
- 23. PRESIDING OFFICER: (SENATOR BRUCE)
- 24. Senator Graham.
- 25. SENATOR GRAHAM:
- 26. Mr.President and members of the Senate. When I came
- 27. down here twenty years ago Fred Smith was here to talk
- 28. to us, reminisce, to tell us about the time that he
- 29. didn't...couldn't get a bed in the Abe Lincoln and he
- 30. and I were arch-rivals on many of his measures that he
- 31. felt strongly about. And our oratory became explanatory
- 32. many times. We each won some and we each lost some.
- 33. Fred Smith never failed to treat me as a gentleman,

- 1. never carried the animosity around in his heart. I'm
- 2. sure you remembered and I thank the...probably the
- 3. nicest thing that Senator Hynes has said tonight is
- 4. that it, probably the most restful thing that's happened
- 5. to him in the last ten years that he wasn't here tonight.
- 6. I think as I remember when I came down when there wasn't
- 7. name calling on the Senate Floor, we referred to our
- 8. colleagues as a gentleman from whatever town or whatever
- 9. county hecame from there was decorum and times have
- 10. changed. I don't know that Fred Smith and Frank Ozinga
- 11. and I are really ready to adjust to all those, however
- 12. I do remember one night when the Senate was in some
- 13. sort of a turmoil and made this little fiasco tonight look
- 14. like a Sunday school picnic. When Jimmie Lynch was
- 15. sitting back over there about where Senator Joyce is,
- 16. he threw a Digest at John William Chapman, who was
- 17. the Lieutenant Governor and presiding officer and hit
- 18. the front of the podium. John didn't see it coming, I
- 19. don't think. So we have gone through some of those times
- 20. of turmoil too, but those guys never forgot that each
- 21. antagonist, each adversary, was either a lady or a
- 22. gentleman. At that time we had a couple of gals down
- 23. here to kind of keep the act cleaned up too, Lillian
- 24. Schlagenhauf and Lottie Holman O'Neil and I don't
- 25. know if they could have gone through this tonight really
- 26. either. Times are changed and I certainly hope that
- 27. Fred Smith, who has been so concerned about so many
- 28. of us who have had similiar illness to him, as his.
- 29. Wanted him to know that this resolution is an expression
- 30. of the entire Senate. I want this fine old gentleman
- 31. to know that I share... I have a concern about his health,
- 32. as well as he had about mine. I'd like to...speaking from
- 33. our...from our side of the aisle to commend this resolution

- 1. to us for our adoption and I know he'll read it and cherish
- it for the rest of his life. Thank you, Mr. President.
- 3. PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Hynes asks leave of the Senate for the immediate
- 5. consideration and adoption of Senate Joint Resolution...Senate
- 6. Resolution 472. Is there leave? Leave is granted. Senator
- 7. Hynes moves the adoption of Senate Resolution 472. Those
- 8. in favor say Aye. Opposed Nay. The Ayes have it, the resolution
- 9. is adopted. On the Order of Resolutions is House Joint Resolu-
- 10. tion 82. Recognizing the lateness of the hour, Senator
- 11. Clewis is still desirous of passing House Joint Resolution
- 12. 82 which deals with the Energy Resources Commission and
- 13. requiring a study. We will go to this order of business and
- 14. ...only if there is no objection. Is...is there objection in
- 15. considering this resolution at this time? Senator Clewis
- 16. to explain the resolution. House Joint Resolution 82.
- 17. SENATOR CLEWIS:
- 18. Mr. President and members of the Senate. This resolution
- 19. merely directs the Energy Resources Commission to initiate
- 20. a study and conduct hearings to assist local school districts
- 21. in determining and implementing different cost saving
- 22. methods and programs in order to conserve fuel resources
- 23. in a daily operation through their school facilities. There's
- 24. no cost involved. The attractive point of the whole thought
- 25. of the resolution is that with this kind of direction it
- 26. could attract some Federal Funds. Senator Knuppel, who is
- 27. very much opposed to resolutions, talked to me earlier and
- 28. said that he would even vote for this resolution because
- 29. he thought it was a good idea in this area. And I would
- 30. appreciate a favorable roll call. Or adoption.
- 31. PRESIDING OFFICER: (SENATOR BRUCE)
- 32. Senator Knuppel.
- 33. SENATOR KNUPPEL:

- 1. I've reviewed this with the staff and we find nothing
- 2. objectionable in it and provided that they ever get their
- 3. act together down in Washington, there may be some Federal
- 4. Funds involved and I think based on that it could be a
- 5. good idea, so I would suggest we go ahead and vote for it.
- 6. PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Philip.
- 8. SENATOR PHILIP:
- 9. Yes, Mr. President, I'd just like to make this
- 10. observation. The sponsor says it isn't going to cost
- 11. any money on the first hand. The second hand, he says
- 12. it's going to attract Federal funds. Now if that isn't
- 13. a contradiction, I don't know what the heck is.
- 14. PRESIDING OFFICER: (SENATOR BRUCE)
- 15. Is there further discussion? All right. Senator
- 16. Clewis moves the adoption of House Joint Resolution 82.
- 17. Those in favor say Aye. Opposed Nay. The Ayes have it
- 18. the resolution is adopted. Is there leave to go to the
- 19. Order of...Conference Committee Reports? Leave is granted.
- 20. Conference Committee Reports, House Bill 3392. Senator
- 21. Ziomek is recognized on House Bill 3392.
- 22. SENATOR ZIOMEK:
- 23. Yes, thank you, Mr. President, Ladies and Gentlemen
- 24. of the Senate. I now move to adopt this Second Conference
- 25. Committee Report on House Bill 3392. And I ask for your
- 26. favorable roll call.
- 27. PRESIDING OFFICER: (SENATOR BRUCE)
- 28. Is there discussion? Is there discussion? ...does
- 29. Senator Walsh arise?
- 30. SENATOR WALSH:
- 31. Will the gentleman yield for a question?
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- 33. Indicates he will yield. Senator Walsh.

- 1. SENATOR WALSH:
- Senator I see that the...there is an appropriation in
- 3. here for the Illinois Racing Board. Didn't we...didn't we
- 4. have that appropriation in the...with the Arts Council?
- 5. PRESIDING OFFICER: (SENATOR BRUCE)
- 6. Senator Carroll.
- 7. SENATOR CARROLL:
- 8. On behalf of Senator Ziomek, that's a transfer
- 9. bill and that was one of the bills that apparently the
- 10. House had not dealt with. So it was put into the omnibus.
- 11. PRESIDING OFFICER: (SENATOR BRUCE)
- 12. For what purpose does Senator Graham arise?
- 13. SENATOR GRAHAM:
- 14. I'd like to know what the secret is about this little
- 15. gem. I don't have a copy of it. I'd like to see this
- 16. Christmas tree. I want to see how much turkey is in this
- 17. one.
- 18. PRESIDING OFFICER: (SENATOR BRUCE)
- 19. I think that Senator, if you'll wait just a second
- 20. you'll have a copy in your hands.
- 21. SENATOR GRAHAM:
- 22. I appreciate it very much. Thank you.
- 23. PRESIDING OFFICER: (SENATOR BRUCE)
- 24. Purpose does Senator Guidice arise?
- 25. SENATOR GUIDICE:
- 26. Thank you, Mr. President. I don't have a copy of
- 27. the report either, but I just wonder if you can tell
- 28. me if my purple light bill was in there?
- 29. PRESIDING OFFICER: (SENATOR BRUCE)
- 30. Don't believe it made this piece of legislation.
- 31. For what purpose does Senator Carroll arise?
- 32. SENATOR CARROLL:
- It was in an earlier draft, but no, it's not in this

- 1. one.
- 2. PRESIDING OFFICER: (SENATOR BRUCE)
- 3. Purpose does Senator Coffey arise?
- 4. SENATOR COFFEY:
- 5. Mr. President, is the Middle Fork Reservoir Project
- 6. in this?
- 7. PRESIDING OFFICER: (SENATOR BRUCE)
- 8. Senator Carroll.
- 9. SENATOR CARROLL:
- 10. No.
- 11. PRESIDING OFFICER: (SENATOR BRUCE)
- 12. Senator Maragos, on behalf of Mary Orkis.
- 13. SENATOR MARAGOS:
- 14. Then...as long as everybody is asking, is Mary Orkis
- 15. in this project?
- 16. PRESIDING OFFICER: (SENATOR BRUCE)
- 17. Senator Carroll.
- 18. SENATOR CARROLL:
- 19. I'm not sure, I better check. It is in.
- 20. PRESIDING OFFICER: (SENATOR BRUCE)
- 21. What purpose does Senator Mitchler arise?
- 22. SENATOR MITCHLER:
- 23. Well yes, Mr. President, up to this point we've all
- 24. had copies of these Conference Committee Reports. I don't
- know why we shouldn't have a copy of this. I'd like to
- 26. take this home and...and show it to everybody. And show
- 27. them just what you're doing in the last hours. And I'm
- 28. not joking. I'd like to have a copy of this here before
- 29. we vote on it. I think everybody should have a copy. Take
- 30. it home and frame it. Show the people what you're voting
- 31. on here. You're talking about a Christmas tree with turkeys
- 32. in it, these turkeys don't even have feathers, they have
- 33. plumes.
- 34. PRESIDING OFFICER: (SENATOR BRUCE)

- 1. I...I'm...for what purpose does Senator Mitchler
- 2. arise?
- 3. SENATOR MITCHLER:
- 4. Yes, thank you, Mr. President. Are we going to get
- 5. copies of this or there only just one or two be circulated.
- 6. Is the xerox machine broke down or what?
- 7. PRESIDING OFFICER: (SENATOR BRUCE)
- 8. Well, Senator, I...I am reliably told that because
- g of a massive amount of 4th of July speeches that were
- 10. reproduced earlier today that the...machine has taken
- 11. on a headache.
- 12. SENATOR MITCHLER:
- 13. Well, I hope you take those home and use those as
- 14. I'm going to use this. Thank you.
- 15. PRESIDING OFFICER: (SENATOR BRUCE)
- We are trying to circulate copies of this to...
- 17. SENATOR MITCHLER:
- 18. When I have a copy, I am very happy.
- 19. PRESIDING OFFICER: (SENATOR BRUCE)
- 20. ...each...each member that desires one. We have
- 21. tried to kind of cluster around the available copies.
- 22. The Chair is informed that the Pioneer Memorial Plaza
- 23 Commission is also in there, Senator Mitchler. Is
- 24. there further debate? Further debate? Senator Regner,
- 25. is there further debate? Senator Weaver? ...Purpose
- 26. does Senator Mitchler arise?
- 27. SENATOR MITCHLER:
- 28. I've had a...I've had an opportunity to look over
- 29. my copy of this bill, House Bill 3392 and I'm really
- 30. appalled. It has so many things of such a variety of
- nature that it's obvious that what this Legislative
- 32. Body has done is everything that hasn't gone through
- 33. committee or passed or somebody wants, they've combined

- it all in one and they're...if it passes it goes to the
- 2. Governor and the Governor will have to be the Legislative
- 3. Body of the State as he Vetoes through the Amendatory Veto
- 4. and...and pairs down and...and works on this, but to cast
- 5. a vote on this is irresponsible. I don't know how you
- 6. can go back and tell your people you voted for something
- 7. like this. I intend to vote No.
- 8. PRESIDING OFFICER: (SENATOR BRUCE)
- 9. Is there further discussion? Senator Weaver. Senator
- 10. Sommer, Senator Regner, further discussion? The question
- 11. is shall the Senate adopt the Conference Committee Report
- 12. on House Bill 3392. Those in favor vote Aye. Those opposed
- 13. vote Nay. The voting is open. Have all voted who wish?
- 14. Have all voted who wish? Thirty-six votes will be required
- 15. for passage. Have all voted who wish? Have all voted who
- 16. wish? Mr. Secretary, take the record. On that question
- 17. the Ayes are 39, the Nays are 11, 2 Voting Present. The
- 18. Senate does adopt the Conference Committee Report on House
- 19. Bill 3392 and the bill having received the required consti-
- 20. tutional majority is declared passed. And the bill having
- 21. received the affirmative votes of three-fifths of the
- 22. members elected is effective immediately upon its becoming

- 26. A Message from the House by Mr. O'Brien, Clerk.
- 27. Mr. President I am directed to inform the Senate
- 28. the House of Representatives has adopted the following
- 29. Joint Resolution in the adoption of which I am instructed
- 30. to ask the concurrence of the Senate, to-wit:
- 31. House Joint Resolution 103.
- 32. (Secretary reads HJR 103)
- 33. PRESIDING OFFICER: (SENATOR BRUCE)

- Senator Rock.
- 2. PRESIDING OFFICER: (SENATOR BRUCE)
- Adjournment Resolution.
- 4. SENATOR ROCK:
- 5. Thank you, Mr. President, Ladies and Gentlemen of
- 6. the Senate. This is the Adjournment Resolution, I
- 7. presume it calls for us to return on November the 14th at
- 8. the hour of 1:00 o'clock, is that correct? I would move
- 9. for the suspension of the rules and the immediate consider-
- 10. ation and adoption.
- 11. PRESIDING OFFICER: (SENATOR ROCK)
- 12. And...and alerting the membership that we have one
- 13. additional bill to consider, Senator Rock. This is
- 14. not adjournment, it's adoption of the Adjournment
- 15. Resolution. Is there leave to suspend rules for the
- 16. immediate consideration and adoption? Leave is granted.
- 17. Senator Rock moves the adoption of House Joint Resolution
- 18. 103. All in favor say Aye. Opposed Nay. The Ayes have
- 19. it. The resolution is adopted. Is there leave to return
- 20. to the Order of Conference Committee Reports? Leave is
- 21. granted. Conference Committee Reports. I would just
- announce to the membership that it appears that we have
- 23. one additional Conference Committee Report to adopt and
- 24. that will be considered momentarily. ... Does Senator
- 25. Nimrod arise?
- 26. SENATOR NIMROD:
- 27. Parliamentary inquiry, Mr. President.
- 28. PRESIDING OFFICER: (SENATOR BRUCE)
- State your inquiry.
- 30. SENATOR NIMROD:
- On a House Bill, as I understand, on a Second Conference
- 32. Committee Report that those Conference Committee Reports,
- they're not actually found that those bills, in fact, are
- 34. Tabled, according to the House Rules as I was told. What

- happens to that Conference Committee Report that's over here
- 2. in the Senate with no actions taken on it? I'm referring in
- a particular to reference to House Bill 3177.
- 4. PRESIDING OFFICER: (SENATOR BRUCE)
- 5. Well, there are two possible instances, one if a
- 6. Conference Committee Report is filed with the Secretary, he
- 7. Will keep it here until such time as the Senate wishes to
- 8. take action upon it. Senator Nimrod.
- 9. SENATOR NIMROD:
- 10. Except that it's a House...that's okay on a Senate
- Bill, as we've seen before, but on a House Bill, if in
- 12. fact, if it dies and it dies in one House, why would the
- 13. other House, which wasn't the house of origin, have any...
- any jurisdiction over that bill because it can't pass
- 15. at all:
- 16. PRESIDING OFFICER: (SENATOR BRUCE)
- Well, it...the...each House loses jurisdiction of the
- bill because it is in a Conference Committee. And if this...
- if the Senate...if the Senate has not considered the Conference
- 20. Committee Report and it's still outstanding, we can still
- 21. take action. There's also the possibility, obviously, of
- 22. moving to reconsider the vote by which the Second Conference
- Committee Report was lost and the House then could take
- final passage and action on the bill. Senator Nimrod.
- SENATOR NIMROD:
- You mean...you mean the House could reconsider by
- which it was lost or is it just Tabled? You see, if...if
- there's only One Conference Committee Report and it's
- failed in the other House then why would the second House 29.
- carry it, that's my parliamentary inquiry.
